

*The straps on the respirator are latex-free. Safe for individuals who are allergic to natural rubber latex.

DONNING & FITTING INSTRUCTIONS:

- 1. Hold the respirator in your hand with nose piece between index and middle fingers.
- 2. Position the respirator toward your mouth and nose. Pull the lower elastic strap over your head first, resting it below your ears. Then pull the upper strap over your head and position it above your ears. Adjust the elastic straps.
- 3. Press the nose piece according to the shape of your nose and cheek to ensure airtight closure of the mask.



PERFORM SEAL CHECK PRIOR TO EACH WEARING:

- Tightly cover the respirator with both hands
- Exhale sharply. Be sure not to disturb the position of the respirator while doing so.
- If air leaks around nose, readjust the nosepiece in step 4.
- If air leaks at the respirator edges, tighten the straps more.

The respirator must be used in accordance with OSHA regulations 29 CFR 1910.134 which includes the requirement for fit testing before use

WARNING: If you cannot achieve satisfactory fit, do NOT enter the contaminated area. See your supervisor.

CAUTION:

- 1. Failure to follow all instructions and/ or failure to wear this respirator at all times of exposure can reduce respirator effectiveness and may cause sickness or death.
- Before occupational use of this respirator, a written respiratory protection program must be implemented meeting all the requirements of OSHA 29 CFR 1910.134 such as training and fit testing and applicable OSHA substance specific standards.
- 3. The particles that are too small to be visible in plain sight can be dangerous to your health.
- 4. Leave the contaminated area immediately and contact your supervisor if dizziness, irritation, or other distress occurs.
- 5. Store the respirator away from contaminated areas when not in use.
- 6. Dispose of used product in accordance with applicable regulations.

USER LIMITATIONS:

- 1. Do NOT use the respirator or enter or stay in a contaminated area under the following circumstances:
 - environment that contains less than 19.5% oxygen.
 - environment that contains oil aerosols.
 - for protection against gases or vapors.
 - contaminants or their concentrations are unknown or immediately dangerous to life or health.
 - for sandblasting, paint-spray operations, asbestos.
- 2. Do NOT modify or misuse the respirator.
- 3. DO NOT use the respirator with beards or other facial hair that interferes with direct contact between the face and the edge of the respirator, or any other conditions that may prevent a good face-seal.
