## FITTING INSTRUCTIONS

Following instructions must be followed each time respirator is worn.



**Step 1:** Place the respirator in the palm of your hand with the nose clip closest to your fingers and the respirator opening facing you. Let the head straps hang in front of the respirator.



## Step 2:

Then position the respirator on your face with the bottom of the respirator under your chin. Pull the top head strap over your head and bring it to rest on the top or crown of your head. Then, pull the bottom strap up over your head and rest it comfortably around your neck below your ears. Adjust both straps as necessary.



## Step 3:

Place your fingertips from both hands at the top of the metal nosepiece. Using two hands, mold the nose area to the shape of your nose by pushing inward while moving your fingertips down both sides of the nosepiece. **WARNING:** Pinching the nosepiece using one hand may result in an improper fit and less effective respirator performance.



## Step 4:

Perform a respirator-to-face seal check before each wearing by placing both hands completely over the respirator, careful as to not disturb its position, then exhale. If air leaks around the nose, re-adjust the nose clip as described in step 3. Liquid or non-oil-based particles from sprays that do not emit oil aerosols or vapors.
