Donning & Fitting Instruction



1. Hold respirator in position over nose and mouth, with retaining straps around back of hand.



 Pull the lower strap over head and fit around neck.
 Pull the upper strap over head and fit above ears.



3. Adjust straps by pulling adjuster until respirator fits comfortably.



4. Place fingertips at the top of nose clip. Use both hands to mold the nose clip to the shape of nose by pushing inward while moving fingertips down both sides of the nose clip.

5. Perform a User Seal
Check prior to each wearing.
To check the
respirator-to-face seal, place
both hands completely over
the respirator and inhale
sharply. Be careful not to
disturb the position of
respirator. If any leakage is
detected, readjust the
position of respirator
according to Step #3 and #4.

Removal Instructions

Cup respirator in hand to maintain position of face and pull bottom strap over head. Still holding the respirator in position, pull top strap over head and remove respirator.

Dispose of used product in accordance with applicable regulations.
