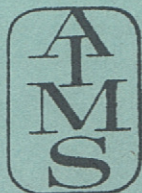

INTRODUCTION

This bibliography lists Shakespeare criticism and scholarship which has been done by Marxists, or which is of special interest to Marxists. It lists only that work which is available in English, and it is, thus, neither a full nor a necessarily balanced record of the relevant materials. A large body of work remains, especially in German, French, Russian, and Czech.

The American Institute for Marxist Studies (AIMS) is an educational, research and bibliographical institute. Its purposes are to encourage Marxist and radical scholarship in the United States and to help bring Marxist thought into the forum of reasonable debate to produce a meaningful dialogue among Marxist and non-Marxist scholars and writers.
