The Court instructs the jury-

THIS notable book is the result of an exhaustive investigation into the records of Abraham Lincoln as a lawyer, his views upon the subjects of universal suffrage, and the reconstruction of the Confederate State governments at the close of the Civil War, and his attitude toward the judiciary upon which there has been considerable misunderstanding in recent years. To these has been added a chapter devoted to a consideration of his standing as an orator.

Many biographies of Lincoln have been written, but no really adequate presentation of the legal side of his career has appeared, and as a result, much misinformation is current in

regard to his experiences at the bar. Indeed, statesmen and lawyers of renown, relying upon the erroneous statements of his contemporaries, have been led to underestimate greatly his standing as a member of the legal profession. The facts collected by Mr. Richards from the records of the courts before which Lincoln practiced, will remove this impression and convince even the most skeptical that Lincoln was one of the greatest lawyers of his generation.

Equally important is the author's analysis of the great President's attitude toward the southern states and toward woman suffrage; while his careful review of Lincoln's opinions on the independence of the courts is of especial interest in view of the use that has been made of Lincoln's name within the last few years by the assailants of our judicial system.

As a whole, the volume may be said to be among the most notable contributions to Lincolnia, disproving as it does many accepted traditions, and illuminating from a new angle the life and character of the real Abraham Lincoln.
