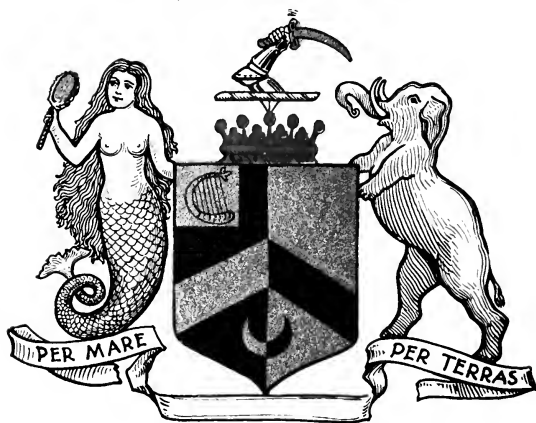

THIS little booklet is the result of long years of short work. Every little while during the past twenty years or more, I have spent some time in collecting and arranging the dates which follow.

This comes to you as a forerunner, and, as must be, there are many errors and omissions. It is my wish that any found by you will be noted and sent me at once. The references used are Burke's "British Peerage," Lyle's "Lords of Scotland and Ireland," Campbell's "History of the Families of Virginia," "Washington's Reports," the encyclopaedias and the records of the Land Registry Office of Virginia.

On the first page hereof you will find a chart of the line of descent from Alexander MacDonald of the Isles, to Esther Alexander, our maternal ancestor. Alexander MacDonald made war upon the kings of Scotland, and was banished about 1472; thus his son, Alexander, lost his surname and was known as Alex Alexander, the first Baron of Menstril, 1490. "The Standard" of July 24, 1880, connects this family with that of the noble house of Sterling in an article under title of "The Alexander Family of Scotland and America."

As to our Ancestors' record in the Revolutionary War, we have not taken steps to prove our claims; yet we know, to our own satisfaction, that William Austin of Augusta County, Virginia, was a Captain, and that the two John Thomsons served, one as Second Lieutenant in the First Virginia, the other as Second Lieutenant in the Seventh Virginia.

Of the Austin branch of the family little has been found further than the name stands on the pages of the English "Doomsday Book" as belonging to one of those who came into England with William the Conqueror. The name multiplies in Saxon, Norman, England, and some went into Wales, while others found homes in Germany. Of the ancestry back of William and Moses Austin (see record) I know nothing. As above stated, Captain William Austin served in the Revolutionary army. I have had the pleasure of holding his sword and canteen and hearing the history of his good deeds from his son, my uncle Alexander Austin.

Of the Arnolds I know little, other than that they are come of the "Heart of Oak" English Arnolds and are distantly related to Dr. Arnold of Rugby.

The first part of this history is the deduction of the eminent and accomplished antiquarian and genealogist, Alexander Brown, Esq., of Norwood, Nelson County, Virginia.

I am indebted for the direct arrangement of this history to my daughter, Mrs. Wesley Dunscombe Shanklin (*nee* Locké Ann Arnold), and to my grandchildren, the Rev. William Arnold Shanklin, D. D., Frances Shanklin and Arnold Shanklin. For much information and the picture of the coat-of-arms I am indebted to my niece, Mrs. William G. McCausland (*nee* Susan Austin Arnold).

ARCHIBALD ALEXANDER

AND HIS DESCENDANTS IN IRELAND AND AMERICA

The names Alexander and Allister are the same.

The clans McAlexander and McAllister are the same.

Archibald the I., the first of the family, lived and died in Scotland.

Early in the 17th century, probably in 1610, as that was the date of the great religious emigration, three sons of the above, namely: Strong, William and Thomas, emigrated to Ireland.

Thomas married and left a daughter and a son. The daughter married Joseph Parks and had a daughter, Margaret. The son, William, was "a very fat man." He left four sons:

1. Archibald. See Campbell's History of Virginia, p. 422.
2. William, who married a widow in Philadelphia and d. s. p.
3. Robert. See Campbell's History of Virginia, p. 429.
4. Peter.

(A biography of Archibald, by his son, James W. Alexander, a book which, although out of print, could probably be picked up by Scribner, refers to these four brothers as sons of Thomas.)

✓ Archibald Alexander, born in Ireland, manor of Cunningham, February 4, 1708, emigrated to Pennsylvania in 1737, and from Pennsylvania to then Augusta (now Rockbridge) county, Va., in 1747. He married first in Ireland, on the 31st of December 1734, his first cousin Margaret Parks. "She was of middling stature and rather inclined to be lean, with light hair and florid countenance; she was very pious." Their children were:

Robert Alexander, another of the brothers who came to America, locating in Augusta county, Va., prior to 1747, was a graduate of the University of Dublin, and taught the first classical school west of the mountains of Virginia, of which school the present Washington & Lee University is the lineal descendant. This Robert had a son Robert; his children were:

1. William, died in Rockbridge, January, 1829, aged about 85.
2. Robert, who was the first Clerk of the Court of Campbell county, Virginia, the office being located at his residence, "Rock Castle;" married Nancy Austin. Robert was succeeded in the clerkship by his son, John D. Alexander; the Alexander family, through father, son and grandson held the office of Clerk of the Court for nearly a hundred years.
 3. Archibald, a physician, lived in New Castle, Del.
 4. Thomas, moved to Galen county, Ohio.
 5. Peter, moved to Woodford county, Ky.; was alive in 1822.

23 6. Esther, married Capt. William Austin, up to the war of 1776 a loyal subject of His Majesty of England.

The following is a copy of William Austin's Commission to the Captaincy, the original of which has the royal seal affixed, and is in the possession of Mrs. Sarah Austin Rawlings of Bedford Springs, Virginia.

"His Excellency, John, Earl of Dunmore, Viscount Fin-castle, Baron Murray of Blair, of Monlin, and of Tillimot, Lieutenant and Governor General of His Majesty's Colony and Dominion of Virginia, and Vice Admiral of the same.

TO WILLIAM AUSTIN, ESQ.—By virtue of the power and authority to me given as His Majesty's Lieutenant and Governor General and Commander in Chief in and over this Colony and Dominion of Virginia, with full power and authority to appoint all officers, both civil and military, within the same, I, reposing special trust in your loyalty, courage and good conduct, do by these presents appoint you, the said William Austin, Captain of the Militia of the County of Bedford, whereof John Quarles, Esq., is Lieutenant and Chief Commander. You are therefore to act as Captain by exercising officers and soldiers under your command, taking particular care that they be provided with arms and ammunition as the laws of the Colony direct, and you are to observe and follow such orders and directions from time to time as you shall receive from me or any other superior officers according to the rules and discipline of war, in pursuance of the trust reposed in you.

Given at Williamsburg under my hand and the seal of the Colony, this Twentieth day of June, and in the Twelfth year of His Majesty's reign, Annoque Domini, 1772."

"Their father afforded them every facility for education in his power, and embraced every opportunity of sending them into pious, intelligent society, both at home and abroad. They were remarkable for their strength of character, candor, sincerity, generosity, hospitality, social, affectionate dispositions, and for their unsuspecting and confiding natures. In personal appearance Margaret, Archibald, Phoebe, Elizabeth and Nancy resembled their father—had dark hair and eyes; Andrew, Sarah, John and Martha had blue eyes light hair and fair complexion. Among

their descendants and those with whom they have inter-married, there are about twenty Presbyterian ministers."—N. R. G., 1857.

“Nine children of William and Agnes Alexander lived to be old; some of them very aged. All retained their faculties in full vigor to the last, and were beautiful examples of a happy and cheerful old age. They all connected themselves in early life with the Presbyterian church, and were remarkable for their devoted piety. A very large number of their descendants are also members of the church, thus verifying the promise: ‘I will be a God to thee and to thy seed after thee.’ They were much indebted to their pastor, Rev. William Graham, for their early piety, education and desire for knowledge.”

AUSTIN FAMILY.

William Austin I. emigrated from Wales to America long before the Revolutionary war, and settled in Hanover county, Va. He was twice married; by his first wife he had three sons—William, John and Thomas; by his second wife he had one son—James.

William Austin II. settled in Bedford county, Va. He also was twice married; his first wife was Hannah Glenn, of Hanover county; issue: Nancy, John, James, Sally, Thomas, Robert, Elizabeth and one who died in infancy.

Nancy Austin married Robert Alexander, the brother of her father's second wife; her husband was Clerk of Campbell county, Va., during his life; they had two sons—William and John, and eight daughters—Esther, Sally, Nancy, Betsy, Catherine, Charlotte, Mary, Glenn and Susan.

Esther Alexander married Micajah Moorman.

Sally Alexander married Nat. Manson.

Nancy Alexander married Adam Clement.

Betsy Alexander married Dr. Reed.

Catherine Alexander married Nat. Payne.

Charlotte Alexander,—

Mary Glenn Alexander married William Pendleton.

Susan Alexander married Dr. Robert Withers.

John Austin was lost at sea on his way to Edinburgh to complete his education.

Robert Austin was a physician; was educated in Edinburgh, practiced in Bedford county, Va. Died in his forty-first year.

Elizabeth Austin first married her cousin, Chapman Austin, of Hanover county, Va.; issue: Simeon, Constance and Hannah Glenn; she afterwards married — Armstrong; issue: Richard, —, Mary and Sarah. Some of the descendants of this family moved to North Carolina.

His second wife was Esther Alexander, daughter of Robert Alexander, of Augusta (now Rockbridge) county, Va., and niece of Archibald Alexander, author of "Outlines of the Evidence of Christianity," "A History of the Israelites," and "Outlines of Moral Science."
