# Pride & Loyalty 1893-1993

**N**early two decades after she graduated, Fodie Buie Kenyon '92 wrote in 1912 a note to the campus in Greensboro saying, "I shall always regret that I have no daughter to send to the Normal."

Our first graduates were fiercely proud of their school. Like them, it was filled with promise. Pride and loyalty led them in 1893 to form an organization to promote the well-being of their alma mater and its students. We don't know exactly what went on at the first meeting — records have been lost — but their actions showed that they recognized an obligation. They took steps to repay it by setting up a loan fund, the Alumnae Fellowship, for incoming students.

The fund — and the spirit that created it — lives today as the Alumni Scholars Program. Former Alumni Scholar Dr. William Welder '86 said after graduating from medical school at Johns Hopkins, "I'm enamored of UNCC; it's the only place I send money." Pride and loyalty. The debt is still being repaid.

The Association motto, "Service" — eventually adopted by the University as its





own — reflects our sense of indebtedness and obligation.

Today, a century after its founding, the Alumni Association of The University of North Carolina at Greensboro is reorganizing. We're celebrating our legacy of pride and loyalty as we prepare to begin a new and independent relationship with the University. The formal tie is changing, not unraveling. Our pledge in the University Song still holds, "Unfailing loyalty we bring, University, to you."

The sum was raised by cooperative effort in the form of a benefit bridge party, given April 10, in the newly decorated society halls of the Students Building.

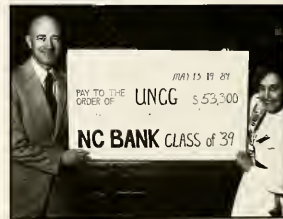

## The New Partnership

The Alumni Association chose in 1990 to maintain its integrity and viability as an autonomous organization. To do this, the Association will raise its own funds to cover staff, programs, services and operating expenses.

Although the Alumni Association is autonomous, it will not operate outside a relationship with the University. The Alumni House will be the Association's headquarters, the Director of Alumni Affairs may serve as its Executive Secretary, and the Association's programs may be conducted jointly with the University.

The Agreement marks a milestone in the life of the University and of the Association. It defines the relationship between the two while it stimulates cooperation.

The key to its success was finding common ground and reaffirming the commitment of the University and the Alumni Association to the support of the most treasured asset of both — the alumni.

### Convocation Ends Centennial Celebration

The 1992 Founders Day Convocation on October 5 honored William C. Friday with the McIver Award and concluded UNCG's Centennial Celebration.

Ann Heafner Gaither '53, chair of the Board of Trustees, presented the bronze medal to Mr. Friday, president emeritus of The University of North Carolina, citing his splendid record as president of UNC, his work to alleviate poverty and illiteracy, and his efforts toward athletic reform on the Knight Commission.

Past Alumni Teaching Excellence Award recipients were recognized by Dr. Donald DeRosa, UNCG's provost, and Anne Hayes Tate '68, president of the Alumni Association.

Senior Trey Sharp created the Centennial Time Capsule presented at the Convocation. It is filled with memorabilia and a letter from Chancellor William Moran to the Class of 2042.

Dr. Alice Chandler, president of the College at New Paltz (NY), gave the Founders Day address, stressing the challenges facing urban universities such as UNCG.

### Full-Time Director Joins Program In Its Twentieth Anniversary Year

Twenty years after its birth, the Women's Studies Program has its first full-time director. Begun in 1972, UNCG's program is one of the oldest in the country.

Dr. Katherine Wyly Mille, former assistant director of the Women's Studies Program at the University of South Carolina, succeeded part-time director Dr. Jodi Bilinkoff last fall.

Dr. Mille is excited about the interdisciplinary program's possibilities and potential. "Given UNCG's history as a women's college that is now a coeducational university, we have a unique environment to build on," she said.

The approximately twenty-five Women's Studies-affiliated faculty (both men and women) teach and/or do research with women's studies content. Courses range from history to management.

Women's Studies course work is stimulating for faculty and students. New ideas are shared — it's fresh material. The program looks at how women have been regarded, the roles they've played, and their past, present, and potential contributions to society.

Dr. Mille's goals for the program include persuading students and faculty to consider the marginalization of women and what they can do about it. She wants to promote and solidify community support through seminars and an endowment fund.

Including women in scientific research and as the subjects of research is another objective.

What job opportunities exist for a Women's Studies major? According to Dr. Mille, the field is wide open. "It's analogous to any liberal arts major as far as teaching, beginning graduate school, or entering other professions. But a WS major has special credentials — an edge. In today's society, companies are looking for people with expertise in this area."

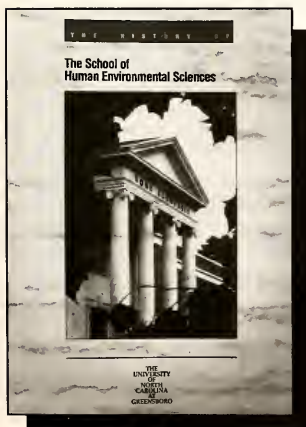
the Alumni Board, acceptance of the Class of 1993 into the Alumni Association, and President Anne Tate's comments.

## 70 Percent of Alumni Have Graduated Since '63

This year UNCG marks its thirtieth year as a coeducational, doctoral-granting institution. For nearly one third of its life, the University has worn its current moniker and enjoyed an era of enrollment growth.

You may be wondering, as we were, how the alumni numbers compare when using 1963 as a benchmark. The figures may surprise you.

As of last fall, alumni records total 64,144. Of these, only 30 percent graduated from our alma mater before it became UNCG. That means a whopping 70 percent graduated within the last thirty years. Amazing, but true.

When we eliminate from the total record the alumni who are deceased (4,786) or lost (8,957), the result is what we call the "valid" list — living alumni for whom we have valid addresses. That figure now stands at 50,401. Running the numbers on this group makes the UNCG graduates proportionally larger — 74 percent graduated

from UNCG, while 26 percent are from the Class of 1962 or earlier.

No matter when you graduated, you're in good company. But if you graduated since 1963, you can claim a place in the majority.

## Fifty Years Ago in *Alumnae News*

From the February 1943 issue: "The Woman's College of The University of North Carolina is this year the second largest college for women in the country, and the largest college where the majority of the students live in residence halls. The enrollment is 2247. Hunter College, New York City, is the only woman's college the enrollment of which exceeds the enrollment here. But Hunter is a college for day students. The large majority of students here come from North Carolina homes, the number of out-of-state students being limited. Of the present enrollment, approximately 302 students reside in other states. Even so, twenty-eight states and four foreign countries are represented. The following counties have the largest number of representatives in the student body: Guilford 363; Mecklenburg 82; Forsyth 80; Wake 58; Rowan 53; Wayne 43.

"Miss Mildred Newton, Secretary of Admissions, says that many of the students from other states have some connection with North Carolina. One or both parents may have lived here at one time. A relative may have received his college education in the state; the family may have business connections here. It is hard to rub the tar entirely off the heels of a native born son!"

## Can We Meet the Challenge By July 1, 1994?

Many of you will ask, "What challenge?" I hope you will take time to read the following. Since we are at the midpoint of the three-year transition period and will be independent on July 1, 1994, it is timely to report to you on where we stand. Your alumni Board encourages your approval of the bylaws so that we can move forward. (A ballot appears in this issue.) Committees have a variety of exciting ideas and programs planned to interest, involve, and serve all alumni. And there is a financial plan to support our needs and continue the Alumni Association as we know it after July 1, 1994.

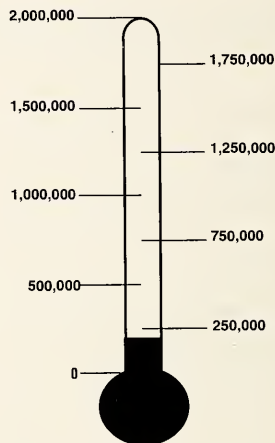
To support these needs of staff, programs, services, publications, communications, and general operations, we need endowment funds of at least \$2 million to supplement what we hope to collect in annual dues. All monies contributed to Life Memberships (\$350) and "One-in-a-Million" Club (\$1,000) go into this endowment fund.

We are halfway through the transition period, but we have only reached 10 percent of our fund raising goal. If we expect a viable and healthy Alumni Association in July 1994, then we need to take the challenge seriously now. If we want to perpetuate the Alumni Association to meet our needs and those of future alumni then we have to guarantee its financial security now. Besides joining the Association and contributing to the endowment

fund, you can help educate other alumni and encourage them to join. So far, out of roughly 50,000 alumni, more than 3,000 have joined the Association. (You are probably one of those members, although some of you are still receiving four issues of *Alumni News* following a contribution to UNCG. That will be phased out completely by July 1993.) If we want the Association to prosper, then we each have to assume some responsibility to support it as we are able, financially, and to encourage other alumni to join. (Are you beginning to understand the challenge?)

At our next annual meeting on May 15, 1993, during Reunion Weekend, we will celebrate the Centennial of the Alumni Association. In 1893, ten young graduates formed the Alumnae Fellowship and chose "Service" as their motto. In the one hundred years since then, our alumni have established a strong and distinguished tradition of service to others and to the University.

Let me focus on one collective effort of the alumnae that somewhat parallels our challenge now. Beginning in the mid-1920s and continuing until 1937, in the middle of the Depression and with only 4,839 alumnae to solicit, they were able to raise the funds to build and pay for the Alumni House. What a gift to all of us who have followed as well as to the University! It has truly been our home on campus. It is the place we gather when we return, and it is used extensively by the University for meetings, receptions, and social events. Its gracious charm is obvious to all who enter, and it has



been a source of pride for us all. Those alumnae who sacrificed and contributed in the '20s and '30s gave us a priceless gift.

It is time now to address our challenge. Can we collectively give as meaningful a gift to future alumni? Can we ensure a financial base of \$2 million in endowment money to perpetuate programs and services for alumni and the University as we enter our "Second Century of Service"? Can we meet the challenge and give future generations the gift of a strong, financially secure, independent Alumni Association? WE CAN, if we all work together and do whatever we are able. We have approximately eighteen months left to reach our target. Help accomplish our goals quickly so that we can focus again on our real business: "Service" to others and to the University.

# Your Vote Counts

## Proposed Bylaws Revisions

Your thoughtful consideration of the proposed bylaws of the UNCC Alumni Association is respectfully requested. Compare the 1992 version with the current bylaws as amended in 1978. If you approve the proposed bylaws, return your ballot (contained in the spine of this issue) by March 15.

The new bylaws are the result of long months of study, writing, discussing, rewriting, and editing. Numerous drafts were issued, each one improving its forerunner in the interest of strengthening the Association's structure.

The bulk of this hard work was shouldered by the Bylaws Committee, chaired by Rozelle Royall Wicks '53 of Maysville. Committee members were Betty Crawford Ervin '50 of Morganton, Alice Garrett Brown '65 of Greensboro, and Betsy Ervin '79 of Asheville.

Many, many other alumni added their input to shape the bylaws into its present form.

Several changes will take affect if the proposed bylaws are approved. Chief among them is the definition of membership. Heretofore members were alumni who contributed to Annual Giving; in the new structure, members pay dues to the Association.

Other changes of note:

- The Immediate Past President is to remain a member of the Board of Trustees and will chair the Past Presidents' Council.
- District representation in North Carolina will more fairly match the alumni population. Districts with larger numbers of alumni will elect more than one Trustee to serve on the Board. (See chart at right.)
- The standing committees have been reconstructed for better service to the Association and its members.
- Management of the Alumni

House is set forward in the bylaws as the responsibility of the Alumni Association.

- The Editorial Board is replaced by a Communications Council having broader authority for effective exchange of information.
- The formation of Alumni Association Councils is encouraged for promoting the interests of subsets of alumni, such as the Young Alumni Council. Their chairpersons are proposed to be voting members of the Board.

• Fiduciary responsibility of Association funds is placed with the Board of Trustees.

- The candidate for President-Elect receiving the second highest number of votes in the Association balloting will become the Second Vice President.

The presentation of the proposed bylaws marks a significant moment in the history of the Alumni Association. As the Association plans for its independent status, the new bylaws ensure a secure future. Your participation in this monumental task is vital.

**Article I. NAME**

The name of this organization, incorporated under the laws of the State of North Carolina in 1909, shall be The Alumni Association of The University of North Carolina at Greensboro, Incorporated, hereafter referred to as the Association.

**Article II. PURPOSE**

The purpose of the Association, as set forth in Section 3 of the Charter, shall be to promote education; to advance the interests of The University of North Carolina at Greensboro, hereafter referred to as the University; and to encourage the cooperation of the alumni in the work of the University and of the Association.

**Article III. MEMBERSHIP**

**Section 1.** As set forth in Section 4 of the Charter, any graduate of the University or former student in good standing may be a member of the Association.

**Section 2.** All alumni contributors to the Alumni Annual Giving Program shall be active members of the Association for one year following date of contribution and shall receive alumni publications and have voting, office-holding, and other privileges of active membership.

**Section 3.** The Association may elect alumni to life membership upon the recommendation of the Board of Trustees and by a majority vote of the members present at a regular meeting of the Association.

**Section 4.** The Association may elect non-alumni to honorary membership upon the recommendation of the Board of Trustees and by a majority vote of the members present at a regular meeting of the Association. An honorary member may have the privilege of the floor but may not vote or hold office.

**Article IV. OFFICERS**

**Section 1.** The officers of the Association shall be a President, a First Vice President, a Second Vice President, a Recording Secretary, and a President-Elect. Election of these officers shall be in accordance with Article XIII of these Bylaws. Officers may not immediately succeed themselves to the same office.

**Section 2.** The President shall serve as chief executive officer of the Association; preside at all meetings of the Association, the Board of Trustees, and the Executive Committee of the Board; unless otherwise specified, appoint all boards, councils, standing committees, and such special committees as may be necessary to carry out policies and expedite the work of the Association; and serve as an ex officio member of all boards, councils, and committees except the Nominating Committee.

**Section 3.** In the absence of the President, the Vice Presidents in their order shall fulfill the duties of the President. The First Vice President shall serve as chairperson of the Alumni Planning Council. The Second Vice President shall serve as chairperson of the Nominating Committee.

**Section 4.** The Recording Secretary shall record the minutes of the meetings of the Association, the Board of Trustees, and the Executive Committee of the Board and file them in the Alumni Office.

**Section 5.** The President-Elect shall serve as a member of the Board of Trustees for one year and, immediately subsequent to this service, shall serve as President of the Association for two years.

**Article I. NAME**

The name of this organization, incorporated under the laws of the State of North Carolina in 1909 and as amended, shall be The Alumni Association of The University of North Carolina at Greensboro, Incorporated, hereafter referred to as the Association.

**Article II. PURPOSE**

The purpose of the Association shall be to advance the interests of the University, to promote continued cultural and educational opportunities for alumni, to build ties and relationships among alumni, to provide alumni input on University concerns, and to link the University of today and tomorrow with its heritage of excellence, commitment, and service.

**Article III. MEMBERSHIP**

**Section 1.** A member of the Association is defined as an individual who has paid lifetime or annual Association dues as prescribed by the Board. Any graduate, former student, or current student having completed at least 30 hours of academic credit at UNCG is eligible for membership.

**Section 2.** An Associate member is a dues-paying individual who subscribes to the objectives and basic policies of this Association, who wishes to participate in the activities of the Association but who does not otherwise qualify for membership.

**Section 3.** Membership in the Association shall be available without regard to race, sex, color, creed, national origin, or sexual orientation.

**Article IV. OFFICERS**

**Section 1.** The officers of the Association shall be a President, a First Vice President, a Second Vice President, a Recording Secretary, a Treasurer, and in alternating years, either an Immediate Past President or a President-Elect.

**Section 2.** The President shall serve as chief executive officer of the Association; preside at all meetings of the Association, the Board of Trustees, and the Executive Committee of the Board; unless otherwise specified, appoint all boards, councils, standing committees, and such special committees as may be necessary to carry out policies and expedite the work of the Association; represent the Association (or designate a representative) on University committees and at specified functions; and serve as an ex officio member with voice and vote of all Association boards, councils, and committees except the Nominating Committee.

**Section 3.** In the absence of the President, the Vice Presidents in their order shall fulfill the duties of the President. The Vice Presidents may represent the Association at designated University functions. The First Vice President shall serve as chairperson of the Alumni Programming Committee. The Second Vice President shall serve as chairperson of the Nominating Committee.

**Section 4.** The Recording Secretary shall be responsible for the minutes of the meetings of the Association, the Board of Trustees, and the Executive Committee of the Board. Minutes shall be kept on file in the Alumni Association Office.

**Section 5.** The Treasurer shall have the custody of all funds of the Association and shall deposit and disburse them. The Treasurer and Executive Secretary shall give such bond for the faithful



accounting of all Association funds under their charge. The Treasurer shall chair the Financial Resources Committee and arrange for the annual audit.

**Section 6.** The President shall serve for a term of one year as President-Elect, for a term of two years as President and for a term of one year as Immediate Past President. The Second Vice President shall serve for a term of two years. The First Vice President, Recording Secretary, and Treasurer shall each serve for a term of three years. Officers, having served a full term, may not succeed themselves to the same position.

**Section 7.** The Immediate Past President shall serve as a member of the Board of Trustees for one year and serve as Chair of the Past Presidents' Cabinet for two years.

#### Article V. BOARD OF TRUSTEES

**Section 1.** The Board of Trustees shall consist of the President, who is chairperson; the First Vice President; the Second Vice President; the Recording Secretary; the President-Elect; and eighteen elected Trustees. Ex officio members shall be the chairperson of the Alumni Annual Giving Council; the chairperson of the Finance Committee; and the Executive Secretary, without vote. Fifteen of the elected Trustees shall be elected by the Association for terms of three years with five to be elected each year, and one shall be nominated by and from each outgoing senior class and elected by the Association at the annual meeting to serve for three years. Trustees may not succeed themselves to the same position.

**Section 2.** There shall be at least three meetings of the Board each year: one in the fall, one in the winter, and one within a week of the annual meeting of the Association. Special meetings of the Board may be called by the President or by any three of its members provided notice of such call is sent at least five days prior to the date of the meeting. Twelve voting members shall constitute a quorum.

**Section 3.** The Board shall administer the affairs of the Association between meetings as provided in Section 6 of the Charter; fill vacancies occurring among Officers and Trustees for the remainder of the term vacated (an ad interim appointment for a period of more than half of a full term shall be construed to be a term within the meaning of this provision); elect annually an Executive Secretary; elect the members of an Executive Committee; create additional standing committees as may be deemed necessary; approve annually a budget for the Association which shall be presented, in turn, to the Alumni Annual Giving Council for funding; and make recommendations regarding the allocation of the unrestricted contributions made to the Alumni Annual Giving Fund.

**Section 4.** The Executive Committee shall administer the affairs of the Board between meetings and shall serve as a Personnel Committee for the Association. The Committee shall consist of the President, who is chairperson; the Recording Secretary; three Trustees elected by the Board; and the Executive Secretary, ex officio without vote.

#### Article V. BOARD OF TRUSTEES

**Section 1.** The Board of Trustees shall consist of the President, who is chairperson; the First Vice President; the Second Vice President; the Recording Secretary; the Treasurer; and in alternating years, either the Immediate Past President or the President-Elect; three Representatives from the Constituent Groups; and twenty-one elected Trustees. The chairperson of the Communications Council, the chairperson of the Alumni House Committee and the chairpersons of Alumni Association Councils shall serve as ex officio members with voice and vote. The Executive Secretary and Editor of the designated official publication shall serve as ex officio members, without vote. Trustees of the Association shall be elected by the Association for terms of three years with one-third to be elected each year. Trustees, having served a full term, may not succeed themselves to the same position.

**Section 2.** There shall be at least four meetings of the Board each year. Special meetings of the Board may be called by the President or by any three of its members provided notice of such call is sent at least five days prior to the date of the meeting. A simple majority of the voting members shall constitute a quorum.

**Section 3.** The Board shall administer the affairs of the Association between meetings of the Association; fill vacancies occurring among Officers and Trustees for the remainder of the term vacated (an ad interim appointment for a period of more than half of a full term shall be construed to be a full term within the meaning of this provision); employ at least biennially an Executive Secretary; elect the members of an Executive Committee; create additional standing committees as may be deemed necessary; and approve annually a budget for the Association. The President shall appoint each Trustee to serve on at least one Standing Committee.

**Section 4.** The Executive Committee shall administer the affairs of the Board between meetings of the Board and shall serve as the Personnel Committee for the Association. The Committee shall consist of the President, who is chairperson, the Vice Presidents, the Recording Secretary, the Treasurer, three Trustees elected by the Board, and the Executive Secretary, ex officio without vote. The Executive Committee shall conduct an annual evaluation of the Executive Secretary and report to the Board.

**Section 5.** Should any member of the Board of Trustees absent herself/himself unreasonably from two consecutive meetings of the Board without sending a communication to the President or Secretary stating her/his reasons for so doing, or if the excuse should not be accepted by members of the Board, her/his seat on the Board may be declared vacant.

**Section 6.** Any Trustee may be removed, either with or without cause, at any time, by a vote of sixty percent of the members of the Board.

**Article VI. EXECUTIVE SECRETARY**

The Executive Secretary shall be the Corresponding Secretary and Treasurer of the Association and Director of Alumni Affairs. She shall be an alumna of the University, elected by the Board of Trustees with the approval of the University administration. She shall be an ex officio member, without vote, of the Board of Trustees and of all boards, councils, and standing committees except the Nominating Committee. As Treasurer she shall be bonded in a sum to be determined by the Board, and at the close of the fiscal year she shall arrange for an annual audit of the financial transactions of the Association. As Corresponding Secretary she shall send out notices of the meetings and shall keep in permanent form minutes of the meetings of the Association, the Board of Trustees, and the Executive Committee of the Board and annual reports of committees. She shall promote the work of the Association in general and shall perform such other duties as designated by the Board.

**Article VI. EXECUTIVE SECRETARY**

The Executive Secretary shall be employed by the Board with priority given to an alumna/us of the University. She/He shall be an ex officio member, without vote, of the Board of Trustees and of all boards, councils, and standing committees except the Nominating Committee. The Executive Secretary shall be the Corresponding Secretary for the Association; as such she/he shall send out notices of the meetings and shall keep in permanent form minutes of the meetings of the Association, the Board of Trustees, and the Executive Committee of the Board and the annual reports of committees. She/He shall promote the work of the Association, shall be responsible for hiring and supervision of Association staff and shall perform such other duties as designated by the Board.

The Association may choose to employ as Executive Secretary the University's Director of Alumni Affairs.

**Article VII. COMMITTEES**

**Section 1.** The standing committees of the Association, unless otherwise provided for, shall be appointed by the President for terms of three years. The term for committee services shall be from September 1 through August 31 except in cases in which the work of the committee dictates otherwise. Each committee shall be composed of at least three active members of the Association, one of whom shall be designated by the President as chairperson. The chairperson of each committee shall file an annual report of the committee's activities in the Alumni Office.

**Section 2.** There shall be nine standing committees of the Association.

- (a) The Alumni House Committee shall determine policies and direct the operation of the Alumni House.
- (b) The Commencement Committee shall be responsible for alumni activities during the University's Commencement weekend.
- (c) The Finance Committee shall prepare and present the annual budget of the Association to the Board of Trustees.
- (d) The Nominating Committee shall prepare a slate of nominees for each office to be filled in accordance with Article XIII and, when the ballots have been returned, shall serve as a tallying committee and report the results of the vote to the Board and to the Association at the annual meeting.
- (e) The Social Committee shall be responsible for all social functions sponsored by the Association.
- (f) The Undergraduate Relations Committee shall promote the interests of the University students in the Association.
- (g) The Alumni Scholars Committee shall select, as directed by the Board of Trustees, recipients of Alumni Scholarships.
- (h) The Alumni Service Awards Committee shall recommend nominees for Service Awards to the Board of Trustees for consideration and approval.
- (i) The Bylaws Committee shall advise the Board of Trustees on matters concerning interpretation and alteration of the Bylaws. The chairperson of the Bylaws Committee shall be selected from the Board of Trustees and shall be the Parliamentary of the Board and the Association.

**Article VII. COMMITTEES**

**Section 1.** The standing committees of the Association, unless otherwise provided for, shall be appointed by the President for terms of three years. The term for committee service shall be from July 1 through June 30, except in cases in which the work of the committee dictates otherwise. Each committee shall be composed of at least three members of the Association; at least one shall be a member of the Board and, unless otherwise designated, one shall be appointed by the President as chairperson. The chairperson of each committee shall report to the Board at its regular meetings and shall file an annual report of the committee's activities in the Alumni Association Office.

**Section 2.** There shall be ten standing committees of the Association.

- (a) The Nominating Committee, chaired by the Second Vice President, shall prepare a slate of nominees for each office to be filled in accordance with Article XV and, when the ballots have been returned, shall serve as a tallying committee and report the results of the vote to the Board immediately and to the Association at the next annual meeting. This Committee shall also make recommendations to the President for membership on standing committees.
- (b) The Investment Committee shall determine investment policies for the Association. The President shall appoint the chairperson.
- (c) The Financial Resources Committee, chaired by the Treasurer, shall prepare and present the annual budget of the Association to the Board and develop strategies for securing a sound financial base for the Association, enabling it to accomplish the goals set forth by the Board.
- (d) The Membership Benefits Committee shall actively seek and develop benefits of membership for the Association and shall recommend these to the Board for consideration.
- (e) The Policies and Procedures Committee shall be responsible for the preparation and updating of the Policy and Procedures Manual of the Association. The chairperson shall be appointed from the membership of the Board.
- (f) The Alumni House Committee shall direct management of the Alumni House (Article VIII). The chairperson shall be an ex officio member of the Board with voice and vote.

- (g) The Alumni Programming committee, chaired by the first Vice President, shall set programming goals and guidelines and assist the staff of the Board with voice and vote.
- (h) The Alumni Distinguished Service Awards Committee shall recommend nominees for the Distinguished Service Awards to the Board for consideration and approval.
- (i) The Alumni Scholars Committee shall serve as linkage between the Association, the University Financial Aid Office and the Alumni Scholars.
- (j) The Student Relations Committee shall be concerned with the quality of student life and shall promote the interests of the University students in the Association.

## New article added — 1992

**Article VIII. THE EDITORIAL BOARD**

**Section 1.** The Editorial Board shall consist of a least five alumni, a member of the University faculty, and a University student. At least one member of the Board shall be a member of the Board of Trustees. Ex officio members shall be the President, the immediate past chairperson of the Board, the Editor of the magazine, and the Executive Secretary. The representative from the Board of Trustees shall serve as chairperson, the term of service not to exceed the representative's term on the Board of Trustees.

**Section 2.** The Editorial Board shall be responsible for matters of content and personnel pertaining to official publications of the Association and with the Board of Trustees shall determine matters of publication policy. The Board shall be responsible to the Board of Trustees and shall file an annual report of the Board's activities in the Alumni Office. The Board shall prepare annually a budget for alumni publications and shall submit it by April 1 to the chairperson of the Finance Committee.

**Section 3.** The Editor of the magazine shall be employed by the Board of Trustees upon the recommendation of the Editorial Board and with the approval of the University administration. The Editor shall be responsible to the Editorial Board.

## New article added — 1992

**Article VIII. THE ALUMNI HOUSE**

Management of the Alumni House, delegated to the Association in 1939 by the Trustees of the University, includes (1) developing and implementing general policy and procedures for operation and use of the House for the Association and its members and University purposes and functions, (2) determining furnishings and interior decoration, and (3) determining space use within the House. The University provides upkeep and maintenance of the building. Management of the Alumni House shall be carried out under the direction of the House Committee.

**Article IX. THE COMMUNICATIONS COUNCIL**

**Section 1.** The Communications Council shall develop strategies for effective communication between the Association and its members. It shall be concerned with matters of content pertaining to the designated official publication of the Association, and with the Board, shall determine matters of publication policy. The Communications Council shall be responsible to the Board and shall file with the Alumni Association Office an annual report of the Communications Council's activities. The Communications Council shall prepare annually a budget for the designated official publication and shall submit it to the Treasurer.

**Section 2.** The Communications Council shall consist of at least five Association members, a member of the University faculty, and a University student. Ex officio members shall be the President, the Immediate Past Chairperson of the Communications Council, the Editor of the designated official publication of the Association (hereafter referred to as the Editor), and the Executive Secretary. The chairperson, appointed by the President, shall be an ex officio member of the Board with voice and vote.

**Section 3.** The Editor shall be employed by the Board upon the recommendation of the Communications Council. The Editor shall be responsible to the Executive Secretary and to the Communications Council who shall conduct an annual evaluation of the Editor and report same to the Board.

**Article X. ALUMNI ASSOCIATION COUNCILS**

Alumni Association Councils, formed under the auspices of the Association and representing major segments of the alumni body, shall be integral parts of the Association. Their chairpersons shall be ex officio members of the Board, with voice and vote. The chairperson of each council shall report to the Board at its regular meetings and shall file an annual report of activities in the Alumni Association Office. Their annual budgets shall be submitted for approval to the Board and made part of the Association's budget.

**Article IX. THE ALUMNI PLANNING COUNCIL**

This Article deleted — 1992

**Section 1.** The Alumni Planning Council shall consist of the First Vice President of the Association, who is chairperson; and at least five alumni. Ex officio members shall be the President, the immediate past chairperson of the Council, and the Executive Secretary. The term of service for members for the Council shall be three years and shall begin on September 1.

**Section 2.** The Council shall consider and recommend to the Board of Trustees plans for the Association and policies and programs for implementation.

**Article X. THE ALUMNI ANNUAL GIVING PROGRAM**

This Article deleted — 1992

**Section 1.** The Association shall join with the University in co-sponsoring the Alumni Annual Giving Program.

**Section 2.** The responsibility for the direction of the program shall be in the Development Office of the University.

**Section 3.** An Alumni Annual Giving Council shall work with the Vice Chancellor for Development in planning, setting up the necessary organization, and conducting an annual campaign for contributions from the alumni. The Council shall review the recommendations of the Chancellor of the University and advise with him in regard to the expenditure of the unrestricted funds received beyond the cost of the campaign and the approved budget of the Association.

**Section 4.** The Council shall consist of nine alumni appointed by the President of the Association, three members of the University faculty appointed by the Chancellor, and three students appointed by the President of the Student Government Association. The term of service for members of the Council shall be three years and shall begin following the first meeting of the Council after the close of the fiscal year.

**Section 5.** The chairperson of the council shall be elected annually at the first meeting of the Council after the close of the fiscal year and shall be an ex officio member of the Board of Trustees of the Association.

**Section 6.** There shall be at least two meetings of the Council each year: one as soon as feasible after the close of the fiscal year, at which time the recommendations for the allocation of funds received during the prior Annual Giving Campaign shall be received from the Board of Trustees and the Chancellor and acted upon, and one to finalize plans for the campaign for the ensuing year. Other meetings may be called by the Vice Chancellor for Development or the chairperson of the Council as needed.

New Article added — 1992

**Article XI. THE PAST PRESIDENTS' CABINET**

The Past Presidents' Cabinet shall be composed of all Past Presidents of the Association. The Immediate Past President shall serve as chairperson. The cabinet shall meet at least once a year on the call of the chairperson or at the request of the incumbent Association President and shall receive information on current Association affairs. The Cabinet shall serve in an advisory capacity to the Association.

New Article added — 1992

**Article XII. CHAPTER ORGANIZATIONS**

The Association shall sponsor local alumni chapters in North Carolina and other geographic areas. The Association shall support and cooperate with such local chapters in accordance with the Association's Guidelines for Chapter Organizations.



## New Article added — 1992

**Article XI. THE GENERAL FUND**

Funds in the amount of the approved budget shall be deposited to the General Fund of the Association and shall be expended for regular budget items as proposed annually by the Board of Trustees. The fiscal year of the Association shall be the same as that of the University: July 1 through June 30.

**Article XII. MEETINGS OF THE ASSOCIATION**

**Section 1.** As specified in Section 2 of the Charter, there shall be at least one meeting of the Association each year to be held within one week of the time of the annual Commencement at the University. Written notice of this meeting shall be sent to each active member of the Association at least two weeks before the meeting. The Board of Trustees may call a special meeting of the Association at any time and for any purpose mentioned in the call by written notice sent from the Alumni Office to each active member at least five days before such meeting.

**Section 2.** Only active members as defined in Article III, Section 2, may vote at meetings of the Association. By provision of Section 4 of the Charter, no votes may be cast by proxy.

**Article XIII. ELECTIONS**

**Section 1.** The names and addresses of the members of the Nominating Committee along with the list of offices to be billed shall be published in an official publication of the Association not later than August 1 of each year to provide an opportunity for names to be sent to the committee for consideration.

**Section 2.** Taking into account class and geographical distribution, the Nominating Committee shall prepare a slate of nominees in the following manner:

- (a) Officers shall be nominated according to a three-year sequence which shall begin in the 1979-1980 academic session. In the first year two nominees for Second Vice President shall be presented. In the second year two nominees for First Vice President and two nominees for President-Elect shall be presented. In the third year two nominees for Recording Secretary shall be presented.
- (b) For each office the nominee receiving the higher number of

**Article XIII. CONSTITUENT GROUPS**

Constituent groups, organizations of alumni generally tied to a specific academic unit or to a mutual alumni interest, shall receive support and cooperation from the Association in accordance with the Association's Guidelines for Constituent Groups. Three representatives from the Constituent Groups shall serve on the Board. The Presidents or their designees shall meet annually to elect one representative to the Board for a three-year term.

**Article XIV. ASSOCIATION FUNDS**

**Section 1.** Funds in the amount of the approved budget shall be deposited to the General Fund of the Association and shall be expended for regular budget items as proposed annually by the Board of Trustees.

**Section 2.** The Endowment Fund of the Association shall be comprised of gifts to the Association and Association lifetime membership contributions. Funds shall be deposited with a fiduciary agent as designated by the Board and administered in accordance with principles developed by the Board's Investment Committee.

**Section 3.** Other Association funds shall be kept in an account or accounts and expended as designated by the Board.

**Section 4.** The fiscal year of the Association and its committees shall be July 1 through June 30. At the end of each fiscal year an audit of all funds shall be prepared by a certified public accountant and presented to the Board.

**Article XV. MEETINGS OF THE ASSOCIATION**

**Section 1.** There shall be at least one general meeting of the Association each year to be held within one week of the time of the annual commencement exercises at the University. Written notice of this meeting shall be sent to each member of the Association at least one month before the meeting. The Board of Trustees may call a special meeting of the Association at any time and for any purpose mentioned in the call by written notice sent from the Alumni Association Office to each member at least five days before such meeting.

**Section 2.** Only members as defined in Article III, Section 1, may hold office and vote at meetings of the Association and in Association elections. No votes may be cast by proxy.

**Section 3.** At all meetings of the Association a quorum shall consist of twenty-five active members.

**Article XVI. ELECTIONS**

**Section 1.** The names of the members of the Nominating Committee and the name and address of the chairperson along with the list of offices to be filled shall be published in an official publication of the Association each year to provide an opportunity for Association members to suggest names to the committee for consideration.

**Section 2.** Taking the demographics of the alumni population into consideration, the Nominating Committee shall prepare a slate of nominees.

- (a) The First Vice President, Recording Secretary, and Treasurer shall be nominated according to a three-year sequence. One office shall be nominated in each year. Two nominees shall be presented each year for that year's office. Each member shall vote for one of the two nominees. The nominee receiving the higher number of votes shall be declared elected for the following three years.

votes shall be declared elected for three years.

- (c) Each year two nominees residing in each of five designated districts shall be presented. Each active member shall vote for one of the two nominees in each of the five districts. The nominee receiving the higher number of votes in each district shall be declared elected for three years.

**Section 3.** The ballot listing (alphabetically by original name) the names and biographical data of candidates shall be sent to active members of the Association at least sixty days before the annual meeting of the Association. In order to be counted, marked ballots must be returned to the Alumni Office by the date specified on the ballot.

**Section 4.** The Nominating Committee shall tally the votes and report the results to the Board of Trustees immediately and to the Association at the next annual meeting.

**Section 5.** The new Officers shall assume their duties at the next annual meeting of the Association following their election. New Officers and Trustees shall attend the meeting of the Board of Trustees which is scheduled within a week of the annual meeting of the Association.

- (b) One third of the twenty-one Trustees shall be elected each year from designated geographical districts based on alumni population distribution. Two nominees for each of seven Trustee positions shall be presented each year. Each member shall vote for one of the two nominees. The nominee receiving the higher number of votes shall be declared elected for the following three years.

- (c) The President shall be elected every two years and shall serve the first year as President-Elect, the next two years as President, and the fourth year as Immediate Past President. Two nominees for the position of President shall be presented and each member shall vote for one of the two nominees. The nominee receiving the higher number of votes shall be declared elected as President-Elect and President. The nominee receiving the second higher number of votes shall be declared elected as the Second Vice President for the following two years.

**Section 3.** The ballot listing the names and biographical data of candidates shall be sent to members of the Association at least sixty days before the spring meeting of the Association. In order to be counted, marked ballots must be returned to the Alumni Association Office by the date specified on the ballot.

**Section 4.** The Nominating Committee shall tally the votes and report the results to the Board immediately and to the Association at the next annual meeting.

**Section 5.** The newly-elected Officers and Trustees shall assume their duties on July following their election.

#### Article XIV. AMENDMENTS

Any amendment to these Bylaws must first be approved by the Board, who shall, in turn, specify the manner of voting: (1) by a majority vote of the members present at any regular or called meeting of the Association, provided a copy of the amendment has been sent to each member at least two weeks before the meeting, or (2) by mail ballot to all members.

#### Article XVII. AMENDMENTS

Any amendment to these Bylaws must first be approved by the Board, who shall, in turn, specify the manner of voting: (1) by a majority vote of the members present at any regular or called meeting of the Association, provided a copy of the amendment has been sent to each member at least two weeks before the meeting, or (2) by mail ballot to all members.

#### New article added — 1992

#### Article XVIII. DISSOLUTION

In the event of dissolution of this Association, after payment of debts, any remaining assets of the Association which are not held by the Association for the benefit of specific purposes shall be distributed, transferred, and paid over to the University or to such other organizations, corporations, or institutions organized and operated exclusively for scientific, educational, and charitable purposes that qualify for tax exemption under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, and that the Board selects. Should the distribution be made to more than one corporation or institution, the Board shall determine the proportionate share of each corporation or institution.

#### Article XV. RULES OF ORDER

The rules contained in *Roberts Rules of Order (Revised)* shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the Charter or the Bylaws of the Association.

#### Article XIX. RULES OF ORDER

The rules contained in *Robert's Rules of Order (Revised)* shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the Charter or the Bylaws of the Association.

# *Climbing the Ridge To Where the Sky Comes*

Drawn to Greensboro in the mid-1960s by the prospect of studying fiction with Peter Taylor, Kathryn Stripling Byer converted (in Taylor's absence) to poet under the tutelage of Allen Tate and Robert Watson. Her first published poems appeared in the early volumes of *The Greensboro Review*, along with the work of fellow student writers Harry Humes, Patricia Peters, and Robert Morgan.

Byer is now poet-in-residence at Western Carolina University, in Cullowhee. Her first collection of poetry, *The Girl in the Midst of the Harvest*, won an Associated Writing Programs' award in 1986, and *Wildwood Flower* has been named the 1992 Lamont Poetry Selection by the Academy of American Poets.

Alma, the speaker in these thirty-four poems, is a voice out of the wilderness, specifically the Blue Ridge Mountains at the turn of the century. Her life consists of the physical labor of tilling the earth, milking, washing, and cooking, set against a spectacular and spiritual landscape: "Once I climbed the ridge / to the place where the sky / comes. Beyond me the mountains continued / like God."

Byer's gift is divining the lyrical joy that Alma feels in the smallest detail and in the aftermath of great pain. In "Bittersweet," her infant daughter's rib cage becomes the "...frail / harp I stroke / as if I might make some lovely sound / of those bones." After a difficult birth she defies her midwife and ventures outside, where "...chastened / to such irreproachable sweetness / I knelt and drank gallons of sunlight."

Yet there is also intense solitude which Alma confronts stoically. Isolated from her family in the flatlands below, her husband away hunting, the wind rushing over the gap takes on character and speaks to her. And out of despair in winter ("Hauling my buckets / up this trail, my heavy / boots sliding on ice, / I have moved as a mule / moves, without joy...."), there comes the prospect

of trillium, columbine, and dogwood blossoms and memories of a spring courtship.

As a fictionalized and historical voice, Alma is timeless in the union Byer creates, in *Wildwood Flower* between love and loneliness, between sensual detail and the spirit of the Blue Ridge: "Who's to tell / me I should not have shouted for joy / on this hill? It's the wind I praise God for / today, how it lifted my hair like a veil."

## Linguist Helps Furniture Sales

At the semiannual International Furniture Market held in High Point, signed contracts are the goal in the complex of furniture showrooms. Subtle persuasion and intense negotiation may be necessary to close a deal. But, complications can occur when the buyer and seller don't speak the same language.

**Margo Bender**, a Spanish instructor at UNCG, is an interpreter at the Market's Foreign Information Center. Her fluency in Italian, German, Spanish, and French helps buyers and furniture manufacturers wade through the nuances of language.

"Americans can be unaware of cultural differences and the meaning of certain words or phrases in other languages," Dr. Bender said. "For example, the British never do business after 5 pm. Dinner is for socialization only. It would be a mistake to bring up business matters if invited to dinner."

US furniture manufacturers are targeting overseas markets to combat low domestic sales in recent years. More and more foreign buying organizations are coming to High Point. Last year a Japanese interpreter was added.

Dr. Bender received her undergraduate degree in French and Spanish from the University of Nebraska. Perhaps surprisingly, she went to work for the DuPont Corporation as an internal auditor after earning her PhD from UNC Chapel Hill. She says many corporations find it easier to train someone who speaks foreign languages in business than to teach an accountant another language.

She also interprets for the federal courts, where she acts as the voice of both prosecution and defense. "If a trial is long and involved, two interpreters are needed," Dr. Bender said. "It's mentally and physically tiring to speak for both sides of a case for hours and hours, but trial work is fascinating because of the verbal jousting that goes on."

## Search for Amelia Turns Up Clues To Crash Site



Searching the Phoenix Islands of the South Pacific for the crash site of aviatrix Amelia Earhart and her navigator, Fred Noonan, was an unforgettable experience for **Bill Decker '91 (MA)**.

In the fall of 1989 he was part of the land search team of The International Group for Historic Aircraft Recovery that used machetes and metal detectors to comb the island of Nikumaroro for evidence of the crash of the Lockheed Electra. Pan American Airways radio records, military records, and those of private sources show that the occupants of the aircraft radioed for help from that area for at least four days after they disappeared while trying to fly around the world in 1937.

Bill's group found various pieces of aircraft aluminum and similar artifacts. After investigation by FBI labs, this evidence led to a second expedition in the fall of 1991. The second search turned up scraps of shoes, more aircraft metal, and personal items which match what was known to be on Earhart's plane. Bill wasn't able to go the second time because of job commitments as a museum director.

In 1993 a third trip will attempt to find the main portion of the aircraft to confirm that it is the Electra. Bill said, "I give it an 80 percent probability."

A finance major, Bill received his bachelor's degree from the University of South Florida. His UNCG master's degree is in public history. Last fall he became executive director of the Allen County Fort Wayne Historical Society in Fort Wayne, IN. "The society runs a historical museum in the old 1893 city hall, a reconstruction of the old walled fort near the river, a Miami Indian chief's home, and a farmer's market," Bill said. "I invite all alumni to visit Fort Wayne."

## FACULTY



**Joseph S. Himes**, Excellence Fund professor emeritus of sociology, died September 4, 1992, in Greensboro. Dr. Himes earned his bachelor's and master's degrees from Oberlin College. After completing his PhD at Ohio State University, he was a post-doctoral faculty fellow at UC Berkeley. He joined the UNCG faculty in 1969 after teaching for twenty-three years at North Carolina Central University, where he received the Distinguished Teaching Award. He was a Fulbright Lecturer at Helsinki (1961-62) and Madras (1966-67). Dr. Himes received the ASA DuBois-Johnson-Frazier Award

and was the first black full professor in a state-supported, doctoral-granting institution in North Carolina.

Intellectually curious with a great zest for living, he exemplified the ideal of teacher-scholar. Joe lived up to his counsel never to admit to infirmity, only referring to his blindness — and then only rarely — as "visual impairment." His credo was, "It is the mind that sees."

Concerning racial discrimination, he goaded with persistent friendly militancy, consistently attacking injustice. To produce social change in the wider community — and also in a university — necessitated a tireless persistence: "Agitate, agitate, agitate, agitate — and then — agitate some more!"

## Frederick M. Rener

Dr. Rener is right where you might expect to find a former German professor — in Germany. After teaching at UNCG for twenty-four years, he moved to Germany upon retiring in 1986.

While retirement ended Dr. Rener's classroom career, it did nothing to slow his scholarly pursuits. In fact, his greatest accomplishment was attained after leaving UNCG — a highly acclaimed book on translation that, according to one reviewer, is a turning

point in this field of research.

*Interpretatio: Language and Translation from Cicero to Tytler* was published in October 1989 by Rodopi of Amsterdam. It is the result of ten years of intense research, using primary sources in all major European languages, to create an authoritative empirical account of the historic ideas and practice of translation. In the words of Dr. Anne Baecker, a colleague of Professor Rener's at UNCG,

"The study represents the first scholarly attempt to give a full and systematic coverage of the norms governing translation in Western Europe in the period between classical antiquity (Cicero) and the late eighteenth century (Tytler)."

In 1990, Professor Rener delivered the opening lecture at an international convention on translation held at the Sorbonne University of Paris.
