The purpose in classifying lebor surplus areas is to put the Fedural Government's precurement contracts into areas of ligh unemployment. Employers located in these labor surplus areas are eligible for preference in bidding on Federal contracts.

Eligible Labor Surplus Areas for Bidding On Federal Contracts

Background

Employers located in labor surplus areas, as classified by the Department of Labor, can be given preference in bidding on Federal procurement contracts. The purpose in providing such preference is to help direct the government's procurement dollars into areas where people are in the most severe economic need, i.e., areas with the highest rates of unemployment.

The concept of channeling Federal procurerant contracts into high unemployment stees dates back to the early 1950's. At that time, during the Korean conflict, there was concern among Government officials that high unemployment rates and low utilization of plants and outpurned in some areas would lead to erosion of the mobilization base and odversely affect the Nation's production capability. There was also the nation's production capability. There was also to continue the contract of the contract of recording workers would cause an unnecessary drain on the Nation's products.

The Office of Defense Mobilization studied this problem and in February 1952 Issued Defense Manpower Policy Number 4 (DMP-4). This policy implemented the idea of directing Federal procurement contracts to employers in labor surplus areas. However, the labor surplus area. program was not successful in directing Federal contracts to employers in high unemployment areas. largely because the program lacked a statutory base. This was changed with the enactment on August 4. 1977 of Public Law 95-89. The Act provided statutory authority for the labor surplus area program by amending the Small Business Act and authorizing Federal agencies to set-aside contracts to employers which agree to carry out a substantial portion of the contract in a labor surplus area. "Substantial portion" was defined as meaning over 50 percent of the value of the centract.

As a result of the Urban and Regional Policy Group's review of Federia programs in 1977-1978, additional support was given to the labor surplus area program because of its potential for providing assistance to distressed areas. In March 1978, the General Services Administration was directed to work with each Federia agency in setting targets for placing set-saled contracts in labor surplus areas. The General Services Administration was also directed to monitor the proferomasco of the Federial agencies in meeting the

agreed-upon targets and to submit a report to the President every 6 months concerning the progress of each agency in meeting its goals. These directives were later incorporated in Executive Order 12073 which was stoned on August 16, 1978.

Public Law 96-302 ("Small Business Administration") was enseted on July 2, 1889 and subtrized the labor surplus area program on a permanent basis. Section 1-103 of Executive Order 12073 assigned to the Department of Labor the responsibility for datassifying labor surplus areas. This represented a continuation of the Labor Department's designation responsibilities since the inception of the labor surplus area program in the early 1950's under DMP-4. Tha Labor Department also has responsibility for classifying labor surplus areas under Executive Order 10582 which implements the Buy American Act.

Procedures for Classifying Labor Surplus Areas

Labor surplus areas are destilled on the basis of civil jurisdictions rather than on a metroplitan erac or labor market area basis. By classifying labor surplus areas in this way. Facetra contracts can be directed to those specific localities with high unemployment rather than to all civil jurisdictions within a metropolation area, not all of which may suffer from the same degree of

OxII jurisdictions ere now defined as all citiles with a population of a least 25,000 and all counties. Townships of 25,000 or more population are also considered as oxivil jurisdiction in 4 States (Michigan, New Jersey, New York, and Perreylyaria). In Connactical, Messanchusette, Perro Pisco, and Pinode government functions, the classifications are done for individual forms. A civil jurisdiction is classified as a labor surplus area when its average unemployment rate was at least 20 percent above the average unemployment rate for all States (including the District of Columbia and Puerto Rico) during the previous 2 calendar years. During periods of high national unemployment, the 20 percent ratio is disregarded and an area is classified as a labor surplus area if its unemployment rate during the previous 2 calendar years was 10 percent or more. This 10 percent "ceiling" concept comes into operation whenever the 2-year average unemployment rate for all States was 8.3 percent or above (i.e., 8.3 percent times the 1.20 ratio equals 10.0 percent). Similarly, a "floor" concept of 6.0 percent is used during periods of low national unemployment in order for an area to qualify as a labor surplus area. The 6 percent "floor" comes into effect whenever the average unemployment rate for all States during the 2-year reference period was 5.0 percent or less

The classification procedures also amuide for the designation of labor surplus areas under exceptional circumstance criteria. These procedures permit the regular classification criteria to be waived when an area. experiences a significant increase in unemployment which is not temporary or seasonal and which was not adequately reflected in the data for the 2-year reference period. In order for an area to be classified as a labor surplus area under the exceptional circumstance criteria, the State employment security agency must submit a petition requesting such classification to the Department of Labor's Employment and Training Administration. The current conditions for exceptional circumstance classification are: an area unemployment rate of at least 6.6 percent for each of the 3 most recent months: projected unemployment rate of at least 6.6 percent for each of the next 12 months; and documented information that the exceptional circumstance event has already occurred. The State employment security agencies may file petitions on behalf of civil jurisdictions, as well as Metropolitan Statistical Areas or Primary Metropolitan Statistical Areas, as defined by the Office of Management and Budget. The addresses of the State employment security agencies are provided on the inside back cover.

The Department of Labor issues the labor surplus area listing on a fiscal year basis. The listing becomes effective each October 1 and remains in effect through the following September 30. During the course of the fiscal year, the annual listing is updated on the basis of exceptional circumstance netitions submitted by the State employment security agencies and approved by the Employment and Training Administration. The reference period used in preparing the current list was January 1988 through December 1989. The national average unemployment rate during this period (including data for Puerto Bico) was 5.5 percent. The new qualifying rate for labor sumlus area classification is therefore 6.6 percent (5.5 percent times 1.20 equals 6.6 percent). Areas are therefore included on the current annual labor surplus area listing, originally issued in October 1990, because their average unemployment rate during the reference period was 6.6 percent or above. Additional areas have been added to the list under the program's exceptional circumstance critoria

Newly Classified Labor Surplus Areas

No additional areas have been classified as labor surplus areas by the U.S. Department of Labor this month. The number of labor surplus areas remains unchanged at 1.603.
