## Eligible Labor Surplus Areas for Bidding On Federal Contracts

#### Background

Employers located in labor surplus areas, as classified by the Department of Labor, can be given preference in bidding on Federal procurement contracts. The purpose in providing such preference is to help direct the government's procurement dollars into areas where people are in the most severe economic need, i.e., areas with the highest rates of unemployment.

The concept of channeling Federal procurement occurrates into high unemployment areas dates back to the early 1950's At that time, during the Koroan conflict, there was occional manage downtered to ficialise that high unemployment rates and low utilization of plants and equipment in some areas would lead to arise on the mobilization base and solversity affect the Nation's production capability. There was also occident and the cost of constructing near plants and open and the cost of constructing near plants and on the Nation's productions.

The Office of Defense Mobilization studied this problem and in February 1952 issued Defense Mancower Policy Number 4 (DMP-4). This policy implemented the idea of directing Federal procurement contracts to employers in labor surplus areas. However, the labor surplus area program was not successful in directing Federal contracts to employers in high unemployment areas, largely because the program lacked a statutory base. This was changed with the enactment on August 4. 1977 of Public Law 95-89. The Act provided statutory authority for the labor surplus area program by amending the Small Business Act and authorizing Federal agencies to set-aside contracts to employers which agree to carry out a substantial portion of the contract in a labor surplus area. "Substantial portion" was defined as meaning over 50 percent of the value of the contract

As a result of the Urban and Regional Policy Group's review of Federia programs in 1977—1978, additional support was given to the labor surplus area program because of its potential for providing assistance to distressed areas. In March 1978, the General Services Administration was diseded to work with each Federal agoncy in asting largest for placing set-aside contracts Administration was also diffested to movinor the Administration was also diffested to movinor the performance of the Federal agencies in meeting the agreed-upon targets and to submit a report to the President every 6 months concerning the progress of each agency in meeting its goals. These directives were later incorporated in Executive Order 12073 which was signed on Jugust 16, 1978.

Public Lew 96-302 ("Small Business Administration") was entacted on July 2, 1980 and unbrorzed the labor surplus area program on a permanent basis. Like P. L. 95-89, the Act unbrorzed Federal agrences to sel-sack contracts when there is a reasonable expectation that offers will be obtained from a sufficient number of thress to ensure that awards are made at reasonable prices PL 65-022 data learned the prostrip of awards under the small business and labor seption area programs, and small business and labor seption area programs, and control to the small business and labor surplus areas programs.

Section 1-103 of Executive Order 12073 assigned to the Ospariment of Labor the responsibility for classifying labor surplus areas. This represented a continuation of the Labor Department's classification responsibilities since the inception of the labor surplus area program in the early 1950's under DMP4. #### Procedures for Classifying Labor Surplus Areas

Labor surplus areas are classified on the base of civil pundictions rather than on a metropotatian area or labor market area bases By classifying labor surplus areas in this way. Federal contracts can be directed to those in this way. Federal contracts can be directed to those in spacefs localities with in any unemployment rather than to all civil jundactions within a metropotation area, not all of which may sulfer from the same degree of

Civil jurisdictions are now defined as all cities with a population of at least 25,000 and all counties Townships of 25,000 or more population are also considered as civil jurisdiction in 4 States (Michigan, New Jersey, New York, and Pennsylvania) in Connecticut, Messachiusetts Puntris Rico, and Ribode. Island where countres have very limited or no government functions, the classifications are done for individual towns

A civil jurisdiction is classified as a labor surplus area when its average unemployment rate was at least 20 percent above the average unemployment rate for all States (including the District of Columbia and Puerto. Rico) during the previous 2 calendar years. During periods of high national unemployment, the 20 percent ratio is disregarded and an area is classified as a labor surplus area if its unemployment rate during the previous 2 calendar years was 10 percent or more. This 10 percent "cerling" concept comes into operation. whenever the 2-year average unemployment rate for all States was 8.3 percent or above (i.e., 8.3 percent times the 1.20 ratio equals 10.0 percent). Similarly, a "floor" concept of 6.0 percent is used during periods of low national unemployment in order for an area to qualify as a labor surplus area. The 6 percent 'floor' comes. into effect whenever the average unemployment rate for all States during the 2-year reference period was 5.0 percent or less

Immistration Under these procedures State piployment security agencies may life petitions on half of ovirt jursdictions, as well as Metropolisan attistical Areas or Primary Metropolisan Statistical views, as defined by the Office of Management and Judget. The addresses of the State employment eoutry agencies are provided on the inside back. The Denartment of Labor issues the labor surplus area listing on a fiscal year basis. The listing becomes effective each Oclober 1 and remains in effect through the following September 30. During the course of the liscal year, the annual listing is updated on the basis of exceptional circumstance petitions submitted by the State employment security agencies and approved by the Employment and Training Administration The reference period used in preparing the current list was January 1987 through December 1988. The national average unemployment rate during this period (including data for Puerto Rico) was 5.9 percent. The new qualifying rate for labor surplus area classification is therefore 7.1 percent (5.9 percent times 1.20 equals 7.1 nercent). Areas were therefore included on the current ennual labor surplus area listing because their average unemployment rate during the reference period was 7.1 percent or above.

#### Newly Classified Labor Surplus Areas

No additional areas have been classified as labor surplus areas by the U.S. Department of Labor this month. The number of labor surplus areas remains unchanged at 1,682.
