## Introductory Note

---

In this Part of a Bibliography of Virginia, the plan has been to include titles of the session acts and of the journals of the general assembly, 1619-1776, arranged chronologically. This is, therefore, a collection of titles of the printed official documents of the colony of a legislative nature, and forms a complement to Part II; which included titles of all printed official documents, 1776-1916. In the early assemblies "orders" were adopted which had all the force of law; for this reason, they are included in this Bibliography. "Papers" which were presented to be adopted by the assemblies are also included. As in Parts I and II of the Bibliography, it has not been the general purpose either to investigate or list manuscripts. In a few instances only, where it seemed most necessary, references have been made to manuscript material. For further information in regard to the documents of any date the reader is referred to the following: prefaces and notes in Hening's Statutes; prefaces in the Journals of the House of Burgesses, and of the Council, edited by J. P. Kennedy and H. R. McIlwaine; notes in the Virginia Magazine of History and Biography referred to in the reprinted journals, and notes of W. C. Torrence in his Trial Bibliography of Colonial Virginia. It was deemed superfluous to make references in all instances to these, when any needed information might be obtained by means of their indexes and chronological arrangement. Where new information has been found notes have been added. In order to provide means of permanent identification of the copies of the Virginia laws recently presented to the state library by the state law library, full notes have been made about them. The titles relative to the revolutionary conventions have been included, as each convention was a step in the transition from the old colonial assembly to the new assembly of the Commonwealth.

Announcement was made in Part II of this Bibliography that Part III would include titles of United States printed documents relating to Virginia. Due to my absence of three months from the library, the research required for such a compilation has been delayed, and the printing of the titles has been postponed, therefore, for Part IV. Acknowledgment is made to Morgan P. Robinson, of the state library, for suggestions.
