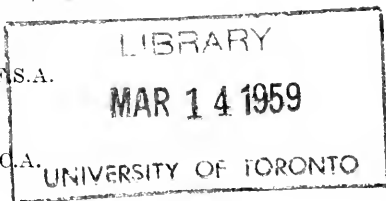

ANNUAL GENERAL MEETING, 1958

The Annual General Meeting will be held at 4 p.m. on Thursday, 4 December, at King's College, Strand, by kind permission of the Principal. Professor A. G. Dickens, M.A., will give an address on 'The Origins of the Reformation in the Diocese of York'.

THE REPORT

THE Council submits the following report and statement of accounts for the year ended on 30 June 1958.

The Annual General Meeting was held at King's College, Strand, on 5 December. An address written by the Rev. Professor David Knowles, O.S.B., Litt.D., F.B.A., F.S.A., on 'The English Bishops, 1066-1532', who was absent through illness, was read by Professor E. F. Jacob.

It is hoped that Part I of the Register of Roger Martival, Bishop of Salisbury (1315-30) transcribed and edited by Dr. Kathleen Edwards, will be sent out before the end of 1958. It will be issued for the years 1955-56 and 1956-57.

The Hon. Treasurer's Statement will be found on p. 4. The thanks of the Society are due to the British Academy for a further generous donation of £100 which has been allocated to the large publication of the Register of Bishop Martival.

The Library of Leicester University, Croydon Public Library, the City of Plymouth Public Library, the Société d'Édition et de Librairies, Le Penmon, Louvain, the Württembergische Landesbibliothek, Stuttgart, and Miss Susan Reynolds have joined the Society. One resignation has been received. There are now 65 individual members and 157 Libraries.

RULES OF THE SOCIETY

I.—The object of this Society shall be to print Copies, Abstracts, and Indexes of the Bishops' Registers and other Ecclesiastical Records in the Provinces of Canterbury and York.

II.—The Annual Subscription shall be thirty shillings, payable in advance on 1 July.

III.—Each member of the Society, having paid his subscription, shall be entitled to a copy of every work produced by the Society, and to vote at the general meetings, within the period subscribed for.

IV.—The management of the Society's affairs shall be vested in a Council consisting of the Presidents, the Vice-Presidents, Chairman of Council, Treasurer, Honorary General Editor, and one, or more, Honorary Secretaries, and twelve ordinary members, to be elected annually; but vacancies occurring between the general meetings shall be filled up by the Council. The Council may, if they think fit, elect a Chairman from outside their own body.

V.—A General Meeting of the Subscribers shall be held annually in the autumn to receive the Secretary's Report on the work and proceedings of the Society, and the Treasurer's Financial Statement; to elect officers for the ensuing year; and to transact the business of the Society generally. Notice of any business to be brought forward shall be given to the Secretary at least three weeks before the date of this Meeting.

VI.—The Council shall meet when necessary for the dispatch of business, three forming a quorum, including the Secretary. Presidents and Vice-Presidents shall not be summoned to meetings of the Council unless they shall have given notice in writing to the Secretary of their desire to serve upon it. The Chairman of the meeting shall have a casting vote.

VII.—Publications may be sold to non-members at a price to be determined by the Council of the Society.

VIII.—These Rules may not be amended or altered except at the Annual General Meeting, and notice of any proposed change shall be given to the Secretary at least three weeks before the date of the Meeting at which it is to be considered.
