

## **RULES AND REGULATIONS**

FOR THE

GOVERNMENT OF THE STATE LIBRARY.

RULE I.—No person except the Governor of the State, Judges and Reporter of the Supreme Court, and Attornies practicing in the same, and members of the General Assembly of the State, shall be permitted to take any book out of the State Library.

RULE II.—No person authorized to take out a book, shall keep the same more than six days, under a penalty of twenty-five cents, for each and every day, more than six, for each and every volume so kept out, until the penalty so accruing shall amount to twice the value of said book.

RULE III.—Any person who shall damage, deface or mutilate any book belonging to said Library, or who shall return any book so damaged, defaced or mutilated while in his possession, shall forfeit and pay the full amount of said damage; which amount is to be determined by the Librarian, but in no case to exceed double the value of the book.

RULE IV.—All fines and forfeiture accruing under this act, shall be sued for and recovered by the Librarian, in the name of the State, before any Justice of the Peace; and the Librarian shall be a competent witness to prove any fact, material to the issue. And all fines and forfeitures recovered under this act shall go into the funds for the increase of the Library.


