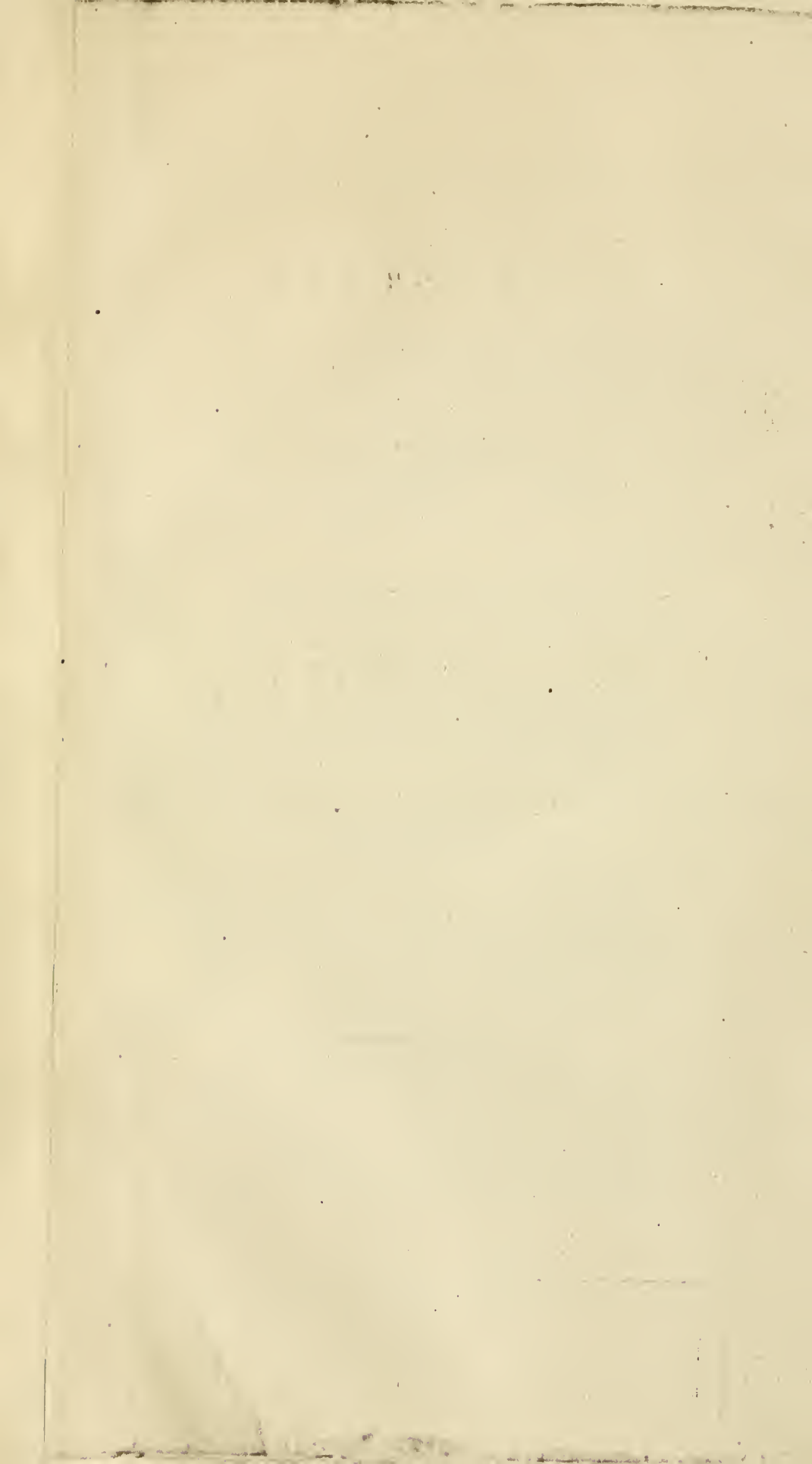

ABBREVIATIONS. S. H., South Hall. N. H., North Hall.

Admission.

1. Applicants for admission must furnish evidence of good moral character, and produce a certificate of honorable dismissal from the Institution of which they last were members.

2. No one will be admitted who shall fail, without reasonable excuse, to report himself to some member of the Faculty within twenty-four hours after his arrival in town.

3. Candidates for admission to the Freshman Class, must sustain a creditable examination in the Common English Branches, Latin and Greek Grammars, Cæsar, Virgil, Sallust or Cicero's Select Orations, the Greek Reader, and Davies' Elementary Algebra through Equations of the first degree, or what shall be equivalent thereto. The requirements for admission to the first year of the Scientific Course are the same as the above, excepting the Greek. For admission to advanced standing, candidates must sustain an examination on all the studies previously pursued by the class they propose to enter.

4. No one will be admitted to the Freshman Class until he has completed his fourteenth year, nor to advanced standing without a proportionate increase in age.

5. Students are admitted to pursue an irregular course, when in the judgment of the Faculty it may be advisable. Such students, however, are required to take a sufficient number of studies to occupy their time profitably, and recite in such regular classes as they are qualified to enter.

6. The attention of Parents, Teachers, and Candidates for admission is called to the fact that the courses of study are elevated, and that thorough preparation and a good degree of previous mental discipline is necessary, in order to pursue them with success.

THEOLOGICAL COURSE.

To those who have completed a College Course, or such literary studies as may have qualified them to receive it, instruction will be given in such a course of Theological studies as is usually pursued in Theological Seminaries, occupying three years. All others are expected to pursue either the Classical or Scientific course in preparation for the Theological, except that those whose circumstances demand it, are permitted to pursue a shorter course in Theology, as follows:

1. Ecclesiastical History.

2. In Systematic Theology.

1. Natural Religion; 2, Evidences of Revealed Religion; 3, The Trinity; 4, The Purposes of God, Election, &c; 5, Moral Accountability, Natural and Moral Ability; 6, Man as a Sinner, The Fall; Depravity; 7, Salvation by Grace; The Covenant of Redemption; Atonement; Regeneration; Justification by Faith; Perseverance of the Saints; 8, Resurrection; Future Rewards and Punishments; 9, The Church; Baptism, Communion, Officers and Discipline of the Church; Preparation of Plans and Criticism of Sermons; Pastoral Duties.

All Theological students have throughout their course an exercise in the preparation of Plans and Criticism of Sermons.

BUILDINGS.

The main College edifice contains a large Chapel, Library, Apparatus Rooms, Laboratory, Halls, Offices, &c.

The Dormitory Buildings, the North Hall and the South Hall, contain 44 Dormitories 18 ft. square, together with Recitation Rooms.

MERIT ROLL.

A daily record is kept of each student's punctuality and the character of his recitations, a summary of which is sent to the parent or guardian at the close of each month.

APPARATUS.

The Institution is in possession of an excellent Chemical and Philosophical Apparatus. More than \$3,000 have been already expended on these departments alone, and the College is now supplied with better and more extensive means of furnishing experimental instruction in the several branches of Natural Science than ever heretofore. Much of the Chemical Apparatus has been imported directly from Europe for the use of the College, and no pains or expense has been spared to supply the most abundant and valuable means for illustrating this important branch. Not only is the illustrative apparatus complete, but all the ordinary appliances for original research and practical investigation are now in the hands of the Professor of Chemistry.

The Philosophical Apparatus is inferior in quality to none in the country. Considerable additions are making in order that this department may vie with the other in the completeness of its equipments.

The Mathematical department is supplied with a superior Theodolite, Compass and the usual appliances.

The Astronomical Apparatus consists of such instruments as are ordinarily employed by Instructors in this branch. The Telescope, presented to the College by Ladies of Marion, is a refractor of six inches clear aperture, and eight feet five and a half inches focal length. It is mounted equatorially with finely graduated right-ascension and declination circles, and has a highly finished driving clock. It is to be placed permanently in an observatory building to be erected for the purpose with a revolving dome, &c. This Telescope both in size and quality is of the first class, and very few Colleges in the United States possess such an instrument.

The Geological and Mineralogical Cabinet is sufficiently ample for purposes of instruction, more than seven hundred carefully selected specimens having been purchased during the past year. A handsome series of Maps, Charts and Engravings has been procured to illustrate the Lectures on Geology.

LODGING ROOMS.

1. Rooms can be obtained, in connection with board, in good families. Students desiring to room in College, are allowed their choice of rooms, on application to the President.

2. Students are permitted to room only in College or private houses, and must not change their rooms except by permission.

THE SUB-FRESHMAN CLASS.

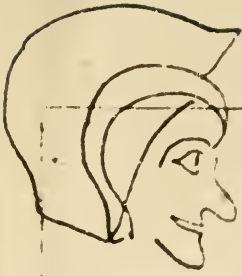
This class is made up of those who are preparing to enter upon the Classical Course. Attention is invited to the fact that they enjoy the instruction of the Professors and Tutors in College, and that their studies are directed with special reference to the course upon which they are to enter. Candidates for admission must sustain a thorough examination in the common English Branches, Latin and Greek Grammars, Latin Reader, Greek Lessons and four Books of Caesar.

COMMENCEMENT AND DEGREES.

1. The Annual Commencement is held on the last Thursday in June.
 2. No student is admitted to a Degree, or any part in the Commencement Exercises, unless he has creditably sustained all his examinations, and performed such other exercises as may have been assigned him; nor until all College dues have been settled, and he has paid the Treasurer \$5 as a graduating fee.
 3. Students who have completed the Scientific course, receive, on the same conditions, the degree of Bachelor of Sciences.

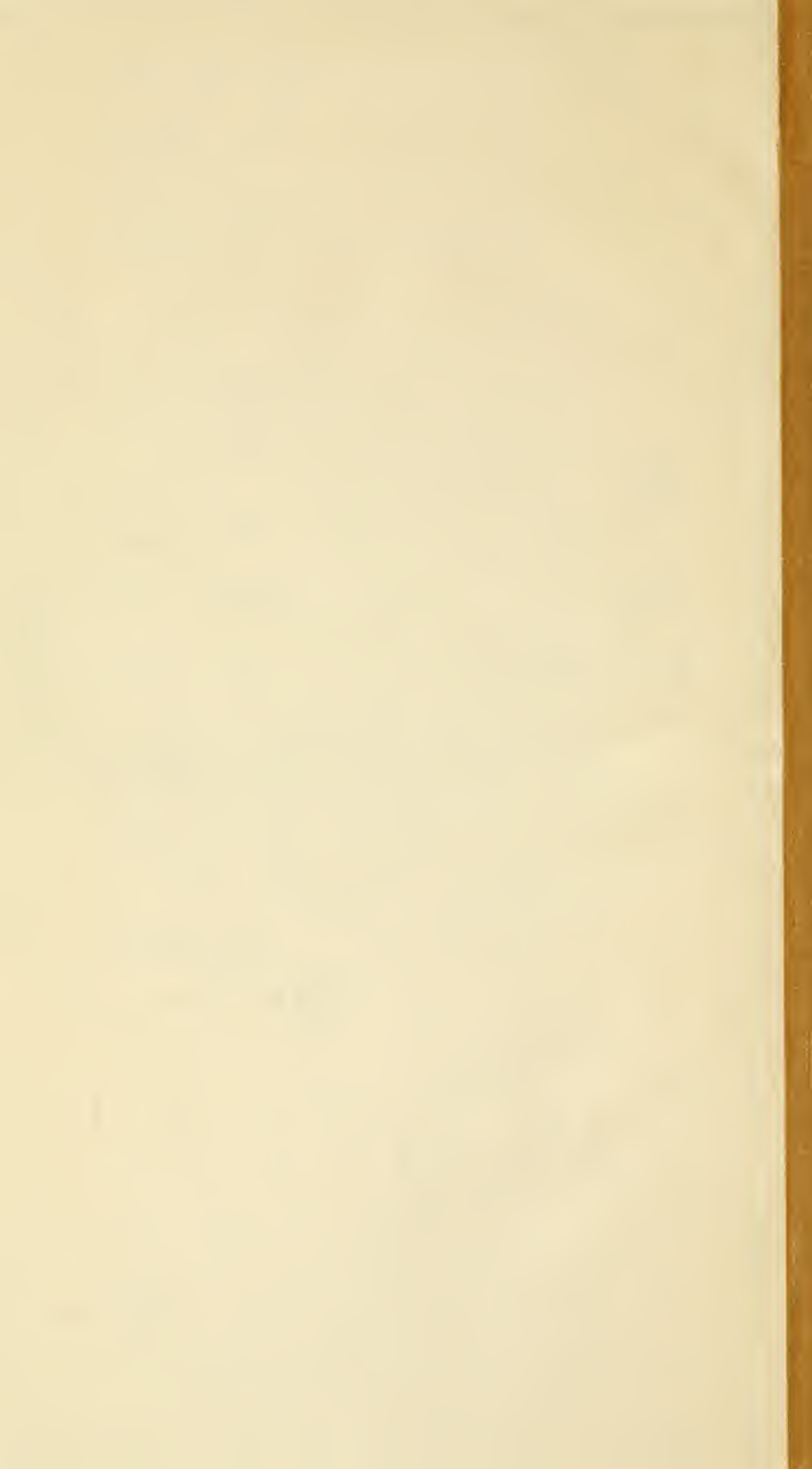
