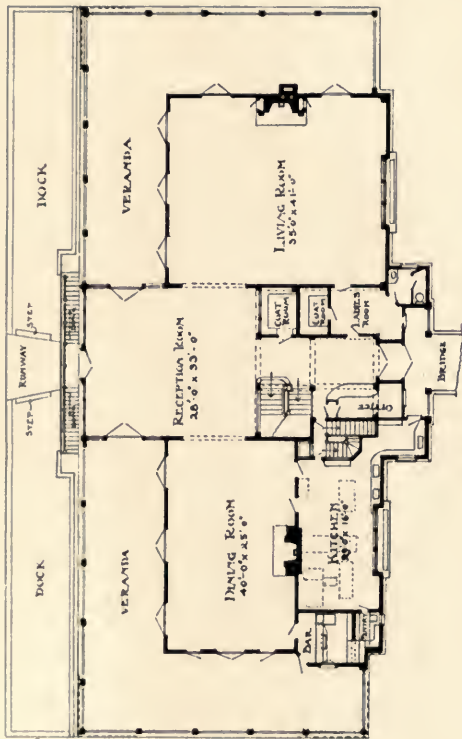






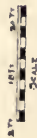

## History

**T**HE CHICAGO YACHT CLUB was organized at the Sherman House in the City of Chicago on the evening of August 7, 1875, with a membership of thirty-seven men.

The meeting was called by Mr. C. E. Kremer, who, with Mr. Harry Eilertson, then the owner of the yacht "Naiad," had brought about a yacht race, in which most of the yachts then at Chicago participated. This race proved most successful and interesting and resulted in the organization of the CHICAGO YACHT CLUB.

The first officers of the Club were John Prindiville, Commodore; William F. Higgin, Vice-Commodore; John A. Farrow, Rear Commodore; C. E. Kremer, Secretary, and F. W. S. Brawley, Treasurer.

The first race after the organization of the Club was held on August 24, 1875, and was participated in by the following yachts: Frolic, Anna S. Carey, Zephyr, Fleetwing, Dawn, Lucy, Lincoln, Lulu, and Naiad.

The next race occurred on September 25, 1875, and regattas were held in 1876 on June 17 and September 9; and in 1877 on June 23.

The Club continued in active existence, and was incorporated under the laws of the State of Illinois, on the 9th of January, 1882.

# The Charter

WE, THE UNDERSIGNED, Citizens of the United States, being desirous of associating ourselves together, and of being incorporated under the laws of the State of Illinois, for the purpose of encouraging and promoting Yacht Sailing and building, do hereby certify:

FIRST. That the name or title by which this Association or Club shall be known in law is CHICAGO YACHT CLUB.

SECOND. The particular business and object for which said Club or Association is formed is to encourage and promote the sport of Yacht Sailing and building.

THIRD. The principal office of said Club or Association shall be located in the City of Chicago, Cook County, Illinois.

FOURTH. The business affairs and funds of said Club or Association shall be conducted, managed and controlled by five trustees.

FIFTH. The names of the trustees for the first year of the existence of said corporation are: C. J. Duggan, W. D. Payne, Jacob Wilder, A. W. Cleaver, P. F. Pettibone, *Trustees*.

## House Rules

## House Rules.

During the season the Clubhouse will be open at 7 a. m. daily, and closed at such hour as the House Committee may from time to time determine.

Supplies from the buffet will not be served in the Library.

Books, journals, papers, pictures, trophies, works of art and similar articles, the property of the Club, must not be removed from the room in which they are placed.

Members will be required to sign a ticket for everything ordered in the Clubhouse.

For purposes of identification, membership cards must be shown upon request.

Applications for sleeping apartments must be made at the office, and rooms assigned to members will be charged to their accounts until surrendered.

Members or guests occupying rooms by the day must give notice of intention to vacate same before noon, or a charge will be made for an additional day.

Members desiring rooms will be accommodated according to priority of application, but a member cannot transfer his right to a room.

Members sending in supplies to be served to them will be charged the same as if furnished from the Club supplies.

None but members or guests, introduced by members, shall be admitted to the Clubhouse. A member may at any time introduce a guest, and shall register his name, residence and date of introduction in a book kept for that purpose, to which entry said member shall affix his own name. Such introduction shall not confer on such guest the privilege of the Club at any other time, but the Secretary may, upon written application of a member extend the privileges of the Club for two weeks to non-residents.

Members will be held responsible for the conduct of their guests and for all indebtedness to the Club incurred by them.

Any guest violating any of the laws or rules of the Club may be notified by the House Committee, through the member by whom he was introduced, that he shall no longer enjoy the privileges of the Club.

The privileges of the Club may, in the discretion of the Board of Managers, be temporarily extended to crews or members of other clubs while visiting the city.

All complaints against the management of the Club, or against any member, must be made in writing to the Board of Managers and signed by the complainant. No verbal complaints will be considered. Complaint against any employe of the Club must be made to the House Committee.

When any member's indebtedness, exclusive of dues, amounts to \$25.00, he shall not be allowed further credit until such indebtedness has been paid. Notice of the amount of such indebtedness shall be sent by mail every other Monday. A failure to pay such indebtedness by the next succeeding Monday will render such member liable to such penalty as the Board of Managers may see fit to impose.

The House Committee shall have direct charge of the restaurant, sleeping apartments, lounging rooms, library, office, the wine and cigar departments, and of the employes attached to all departments; also have charge of all supplies pertaining to all departments, and shall have general supervision of all parts of the house. The Chairman, or, in his absence, some other member of the committee responsible for the liability, shall audit all bills for supplies, salaries and renewals.

There shall be no gambling of any description in any part of the Clubhouse.

No subscription paper shall be circulated, or any article be advertised or exposed for sale in the Club rooms without permission of the House Committee.

No member or guest shall give any fee or gratuity to any employe of the Club, or join in any

subscription for the benefit of employes that has not been authorized by the Board of Managers.

No waiter or employe of the Club shall be sent on errands outside of the Clubhouse.

No dogs, or other animals, will be allowed in the Club rooms.

Members only will be permitted above the main floor of the House.

Crews can obtain meals in the basement and are not permitted on the main floor of the Clubhouse, excepting when it is necessary to communicate with their employers.

Meals will be served in the dining room and verandas only.

## Rules for Club Boats.

The four small fin-keel sloops, commonly called the "Pups," are the property of the Club, and are at the service of the members from colors to sunset.

There is a sailor in charge of the "Pups," who upon order from the office will make sail and have boats at landing at any time members so advise by telephone or otherwise within the hours so prescribed above.

All resident members may use the "Pups" before colors in the morning, but are required to take them from moorings themselves, and upon returning them leave them at moorings in the same condition as found.

Pups must not be taken from the harbor, except by consent of chairman of Regatta Committee.

## CLUB KNOCKABOUT RACES

Open free to any member of the Club making application shortly before the race. Prizes will be awarded at end of season on a percentage basis; each member of the different crews will be credited with points according to the finish of their boat. Courses and instructions will be given shortly before each race. All boats starting in each race must have an equal number of men aboard, but not to exceed three on each boat.

## ONE DESIGN RACES

A gold medal will be put up for competition, to be held by the winning boat until defeated, the boat winning the greatest number of races during the season in the scheduled events to become absolute owner of the medal. Previous to each race medal to be returned to Regatta Committee by holder. Two boats must start

to make a race. Each boat must not have more than three men on board during race. Races for the Vice Commodore Atkin Cup will be under following rules :

If two or three boats start : 1st boat will be given 30 points ; 2d boat 20 points and 3d boat 10 points.

If four boats start : 1st boat will be given 40 points ; 2d boat 20 points ; 3d boat 15 points and 4th boat 10 points.

If five boats start : 1st boat will be given 40 points ; 2d boat 25 points ; 3d boat 20 points ; 4th boat 15 points and 5th boat 10 points.

If six boats start : 1st boat will be given 40 points ; 2d boat 30 points ; 3d boat 25 points ; 4th boat 20 points ; 5th boat 10 points and 6th boat 5 points.

### ENTRIES

All entries shall be in writing and shall be signed by the owner or his representative, giving name of yacht, racing length, and must be lodged with the Regatta Committee not later than noon of the day before the race, exclusive of Sundays, unless otherwise ordered by the Committee.

The Regatta Committee may refuse to accept any entry made after the time of closing.

The same yacht shall not be entitled to enter for a race under different rigs.

The Regatta Committee may, if they consider it expedient, reject any entry.

On making the first entry, yachts can be entered for all the season's races by request of the Regatta Committee.

### STARTING

All starts shall be flying, and shall be a one-gun start.

For all races, special instructions as to guns will be issued by Regatta Committee before each race.

For all races, international signal code flags will be shown wherever gun is located as per instructions.

### COURSES

The course for each race will be issued with special instructions.

Courses may be changed by the Regatta Committee at their discretion.

A blue flag shown by judges will indicate that buoys must be left to starboard.

A red flag shown by judges will indicate that buoys must be left to port.

## Rules and Instructions

**First**—The Regatta Committee will have the power to alter any rules, should any circumstances arise which, in their opinion, makes such a course advisable.

**Second**—The decision of the Regatta Committee on races shall be final.

**Third**—The Regatta Committee will give direction of courses in all races by flags before the preparatory gun is fired.

**Fourth**—The international Code will be used exclusively.

**Fifth**—In Cruising races there is no limit as to the number in the crew. All boats must carry a dingy and be provided with the necessary outfit as when cruising.

**Sixth**—Yachts will not be received for entry unless holding a measurer's certificate.

**Seventh**—Any race over the Club's Regular Courses in which the first yacht has not finished in four and one-half hours after start, shall be declared no race.

**Eighth**—In case of measurement protest the yacht may be measured by any two members of the Regatta Committee not personally interested.

**Ninth**—The Regatta Committee requests that all yacht owners do thoroughly post themselves on racing rules, instructions, entries, time of starting, the international Code, etc. Errors arising through neglect of so doing will not be considered.

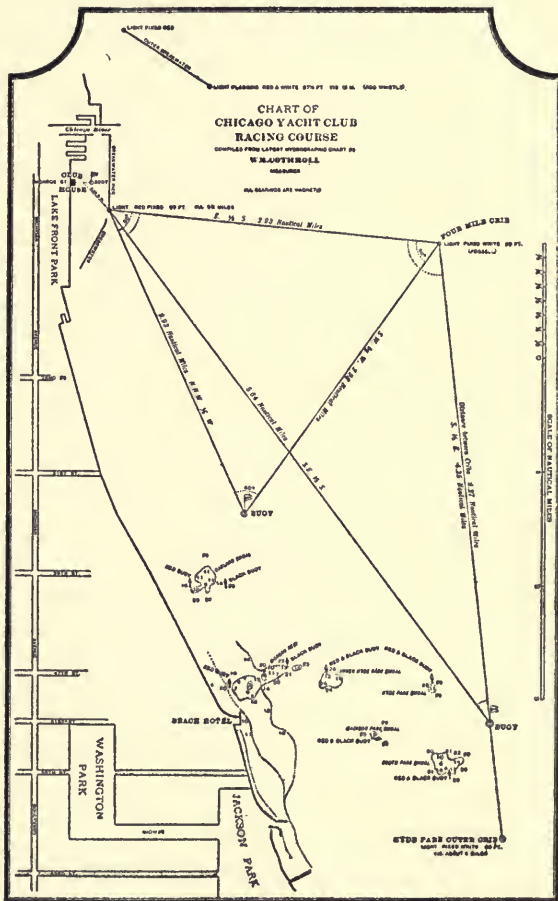
**Tenth**—Unless other instructions are given, all races will be sailed under the rules of the Chicago Yacht Club racing rules adopted for year 1904.

**Eleventh**—Two boats of each class must start in order to make a race. In giving prizes: If but two boats start—first prize only will be given. If 3 or more boats start—1st and 2d prizes will be given.

## Constitution and By-Laws

## Constitution

---

### ARTICLE I.

The name of this Club shall be the CHICAGO YACHT CLUB.

### ARTICLE II.

#### OFFICERS.

The officers of this Club shall consist of a Commodore, Vice-Commodore, Rear Commodore, (each of whom shall be a yacht owner,) Secretary, Treasurer, Fleet Surgeon, and Judge Advocate; and four Trustees, (two of whom shall be yacht owners,) who, together with the Commodore, Secretary and Treasurer, shall constitute the Board of Managers.

### ARTICLE III.

#### ELECTION OF OFFICERS.

**SECTION I.** The first election of officers shall take place immediately upon the adoption of this constitution—and thereafter at the last general meeting in each year, and said election shall be by ballot only, deposited by members in person at said meeting. Each officer shall be elected on separate ballot and shall hold office until adjournment of the last general meeting the following year, or until his successor shall have been elected, except the term of the officers elected immediately upon the adoption of this constitution, who shall serve until last general meeting in same year, or until their successors shall have been elected, except the Trustees, whose term shall be as follows:

At the first election following the adoption of this constitution, there shall be elected two Trustees (one of whom shall be a yacht owner) to serve until their successors are elected at the first general election following, and two Trustees (one of whom shall be a yacht owner) to serve until the second general election following thereafter. At each subsequent general election there shall be elected two Trustees (one of whom shall be a yacht owner) whose term shall be two years.

The ticket nominated by the nominating committee shall be posted on the bulletin board of the Club at least ten (10) days before the election. Voting members of the Club, not less than ten (10) in number, may nominate other candidates for the same office or offices. Such nominations shall be in writing, shall be signed by the members making them, and shall be placed in the hands of the Secretary, who shall attach his certificate that such nominations have been made by not less than ten (10) voting members, and shall post the said ticket, with his certificate, on the bulletin board at least five (5) days before the election. After the names shall have been posted as aforesaid, the Board of Managers shall cause the names of all legally posted candidates to be printed on one ticket, indicating thereon the offices for which the candidates are severally nominated. No other form of ticket than the one hereinbefore provided shall be voted or counted by the judges of election. Each member voting shall place a cross opposite the name of each candidate for whom he votes, for each of the various offices to be filled, and only the names so indicated shall be counted by the judges of election.

No member who is in arrears to the Club shall be entitled to vote.

**SEC. 2.** The Board of Managers at the last general meeting in each year, shall appoint three or more members, who shall not be members of the Board of Managers, to be judges of the annual election. Such

judges shall receive and count the ballots cast at such election, and certify the result to the Secretary, and the Secretary shall at once post the said result on the bulletin board of the Club. The persons receiving a plurality of the votes cast shall be declared elected.

SEC. 3. Vacancies may be filled at any general or special meeting, notice of such election having been sent to each member at least ten (10) days previous to such meeting.

## ARTICLE IV.

### DUTIES OF OFFICERS.

#### *Commodore.*

SECTION 1. It shall be the duty of the Commodore to take command of the squadron, and preside at all meetings of the Club and at all meetings of the Board of Managers. He shall perform such other duties as are usually incumbent upon such office.

He may call a special meeting of the Club at his pleasure, and he shall do so at written request of three (3) members.

The Commodore shall appoint a Fleet Captain to aid him in his duties.

The Commodore shall appoint a measurer, and his duties shall be to measure all yachts and calculate their measurement as prescribed by the By-Laws and sailing regulations, and make a return of same to the Secretary.

The Commodore, or, in his absence, the Vice-Commodore, shall be *ex officio* a member of all committees.

#### *Vice-Commodore.*

SEC. 2. It shall be the duty of the Vice-Commodore to assist the Commodore in the discharge of his duties, and in his absence to officiate in his stead.

*Rear-Commodore.*

SEC. 3. It shall be the duty of the Rear-Commodore to assist the Commodore and Vice-Commodore in the discharge of their duties, and in their absence to officiate in their stead.

*Secretary.*

SEC. 4. It shall be the duty of the Secretary:

To keep the various committees, delegates, etc., of the Club informed as to correspondence in reference to matters which concern them.

To keep a true record of the proceedings of all meetings of the Club and Board of Managers in books provided for that purpose.

To notify the Treasurer on January 1st and July 1st of each year, of the number of members then liable for semi-annual dues, and also during the year to notify him of the election of any new members.

To keep a correct list of the name, ownership, dimensions and rig of each yacht enrolled in the Club.

To file all documents, records, reports and communications connected with the business of the Club.

To notify each member elect of his election, and upon his becoming a member, to assign him a number in conformity with the date of his election, and furnish him with a copy of the Club Book.

To have books printed as provided by the By-Laws.

To call all meetings and notify each member of every meeting.

To carry on all correspondence on Club affairs.

He shall perform such other duties as are usually incumbent upon such office.

In case of inability to attend any meeting, to cause the necessary books and papers to be conveyed to the place of meeting.

*Treasurer.*

SEC. 5. It shall be the duty of the Treasurer to receive all moneys due the Club, and to pay all bills contracted by it when properly approved by the Board of Managers; keeping a correct account of the same in a book provided for the purpose.

To make a report at each general meeting of all his receipts and disbursements, with a statement of the amount of money then in his hands and the amount of dues collected.

He shall have custody of all the funds of the Club. He shall furnish such bond and sureties as shall be required by the Board of Managers.

He shall perform such other duties as are usually incumbent upon such office.

*Judge Advocate.*

SEC. 6. Shall act as the legal adviser of the Board of Managers and officers of the Club.

*Fleet Surgeon.*

SEC. 7. Shall perform such duties as may be assigned to him by the Board of Managers.

*Board of Managers.*

SEC. 8. The Board of Managers shall control and manage the property of the Club and the appropriation of its funds, and make all contracts and purchases, but unless especially authorized by the Club, they shall have no power to make the Club liable for any debt or debts other than the ordinary running expenses of the Club, beyond the amount of money which shall at the time of contracting such debt or debts be in the treasury and not needed for the discharge of prior debts and liabilities

For the better execution of their powers and duties, said Board shall appoint from their own number or from members of the Club, such committees as occasion may require and they may deem necessary, and shall define the duties thereof.

It shall be the duty of said Board to prescribe and publish rules regulating the use and occupancy of the rooms of the Club, the care and protection of its property, and defining the powers and duties devolving upon the committees of their appointment.

The Board shall meet for the transaction of business on the second Friday of each month, and at any other time, at the call, in writing, of the Commodore, or any three members thereof, provided notice shall be given to each member of the Board before the time appointed for said meeting. Four members shall constitute a quorum.

At the last general meeting of each year, the Board of Managers shall make a full report of their proceedings during the preceding fiscal year and recommend such measures as they may deem advisable.

Any member of the Board of Managers who shall absent himself from three consecutive monthly meetings of the Board, unless he shall have previously obtained permission so to do, or shall present at the next monthly meeting an excuse for his absence, satisfactory to the majority of the Board present, may be deemed to have resigned as a member of said Board.

In no case, when a resolution has been passed at a meeting of the Board of Managers affecting the relations of any member of the Club toward the Club, shall such resolution be reviewed at a subsequent meeting, without notice in writing being sent by the Secretary to every member of the Board of Managers, at least ten (10) days before the meeting, that such previous action will be brought up for review or consideration.

SEC. 9. The Board of Managers shall have power:

(a) To admit applicants to membership, and to suspend or expel members (but only for cause) by ballot, two adverse ballots in seven excluding an applicant, and two-thirds vote of those of the Board of Managers present expelling or suspending a member.

(b) To suspend or expel a member for any conduct not in special violation of the By-Laws or Rules, but improper or prejudicial to the interests of the Club.

(c) To make rules for the conduct of the members of the Club, and for their use of the Club property.

(d) To fix and enforce penalties for offenses against the By-Laws and Rules.

(e) To make, alter and amend the Rules for their own government, and to fix and enforce penalties for the violation of such rules.

## ARTICLE V.

### NOMINATING COMMITTEE.

At the fourth general meeting in each year there shall be elected by ballot a Nominating Committee.

As soon as possible after the general election in each year the Board of Managers shall appoint a Regatta Committee, a House Committee, an Entertainment Committee and a Librarian.

## ARTICLE VI.

### DUTIES AND NUMBER OF COMMITTEES.

#### *Regatta Committee.*

SECTION 1. The Regatta Committee shall consist of a Chairman and two members, not yacht owners.

It shall be the duty of the Regatta Committee to make arrangements for, to take charge of, and act as or appoint judges of, all races sailed by or under direction



of the Club. They shall decide all questions that arise in the sailing of such races. They shall have power to disqualify a yacht that shall have violated any rule of the Club, and to postpone any race or order it to be resailed, should either seem to them desirable.

There shall be no appeal from the decision of this Committee.

#### *Entertainment Committee.*

SEC. 2. The Entertainment Committee shall consist of a Chairman and two members. They shall promote and have charge of such dinners, smokers, or other entertainment as in their judgment, with the approval of the Board of Managers, will conduce to the Benefit of the Club and the entertainment of its members.

#### *Librarian.*

SEC. 3. The Librarian shall have charge of the charts, books and publications of the Club. Shall keep a correct list of same, arrange for their use by the members of the Club, and be responsible for their safe keeping and make additions to them when required.

He shall keep the log book of the Club in a book provided for the purpose.

#### *Nominating Committee.*

SEC. 4. The Nominating Committee shall consist of five (5) members. They shall nominate a ticket for officers and trustees to be voted for at the annual election.

SEC. 5. The House Committee shall consist of five members. They shall have the management of the Clubhouse and the Club employes, and shall perform such duties from time to time as will promote the comfort of the Club members.

### ARTICLE VII.

#### MEETINGS.

There shall be five general meetings in each year, and such special meetings as may be called.

## ARTICLE VIII.

## QUORUM AND VOTING.

Fifteen (15) members shall constitute a quorum for the transaction of business. Each member shall be entitled to one vote.

Yacht owners only, as defined in this Constitution, shall vote on any and all questions involving amendments to, changes and adoption of sailing rules, regulations and measurements.

## ARTICLE IX.

## ELECTION OF MEMBERS.

SECTION 1. Any person may be eligible to membership.

Each candidate must be proposed and seconded by two members over their own signatures on a printed form provided by the Secretary for the purpose. Every candidate for election to resident or non-resident membership must be personally known to three members of the Board of Managers and be proposed in writing by two resident members of the Club. The name, occupation and address of the candidate, the class for which he is proposed and his proposers' names shall be entered on the regular form which shall be accessible to members, and his application shall be posted on the bulletin board of the Club for at least two weeks prior to action by the Board of Managers. At the expiration of this time the application shall be transmitted by the Secretary to the Board of Managers, who shall elect or reject the applicant by ballot, as before provided.

SEC. 2. The membership shall be limited to 500 active members, except that at any time yacht owners desiring active membership shall not be subject to this rule.

SEC. 3. Any person residing at a greater distance than fifty miles from Chicago may be elected a non-resident member, and shall pay to the Club one-half of the entrance fee and dues of an active member; but such non-resident member cannot vote or hold office and shall forfeit such membership if he change his residence to within fifty miles of Chicago, but shall have precedence for a regular membership by paying the difference in the entrance fee and dues.

SEC. 4. Commissioned officers of the U. S. Navy and Revenue Service, on the active list, may upon application be given the privileges of the Club.

SEC. 5. Any woman owning a yacht is eligible for election to the Club as a *flag member*, and shall, upon election, pay annual dues but no initiation fee.

Such membership shall continue only during the period of yacht ownership, and carries only the following privileges:

The right to fly the Club Burgee. To have private signal registered with Secretary. To enter yacht in Club races and the use of Club stations and floats.

SEC. 6. Honorary members shall be proposed and elected at any regular meeting. They shall be exempt from payment of any fee, monthly dues or assessments, and shall be entitled to all the privileges of the Club except voting and holding office. Their number shall be limited to twenty-five (25).

SEC. 7. Fifty junior members, between the ages of seventeen and twenty-three years, may be admitted to membership for a period not exceeding one year.

SEC. 8. Application shall be made on a regular form provided for that purpose, signed by the applicant and also signed by a member in good standing, as sponsor, and endorsed by one or more additional members of the Club. Upon his admission to membership, the member so acting as sponsor shall become responsible for all indebtednesses to the Club of such junior member.

Junior members shall be entitled to all the privileges of the Club (except the holding of office and voting at meetings); subject to such regulations and restrictions as the Board of Managers may from time to time adopt.

## ARTICLE X.

### AMENDMENTS.

This Constitution shall only be amended as follows:

The proposed amendment must be legibly written or printed with the name of the member proposing the same, and a copy thereof sent to the Secretary of the Club, and another copy posted on the bulletin board at the Club House for at least one week previous to a general meeting of the Club. Any amendment must first be submitted at a general meeting, and shall be valid only when approved by a two-thirds vote at a subsequent meeting. If adopted at the general meeting it must be kept posted until the next meeting by the Secretary in a conspicuous place in the Club House. No amendment once rejected shall be reconsidered at any subsequent meeting within six months thereafter. There shall be no suspension of any article of the Constitution.

## ARTICLE XI.

While the Club is not in possession of or occupying a club house or quarters, the posting required above shall be omitted and a copy of such matter sent to each member in lieu thereof.

# By Laws

## CHAPTER I.

Each member on his election shall pay the sum of Fifty Dollars (\$50.00) as an entrance fee, and pro rata dues for the current period.

If said sums are not paid within thirty days from date of his election, the Treasurer shall notify the Secretary of the fact, and such election shall be null and void.

The annual dues shall be Twenty-Five Dollars (\$25.00), in semi-annual payments, in advance, which shall become due on January 1st and July 1st of each year.

Five Dollars (\$5.00) of the annual dues of each member paid to the Treasurer, shall be placed in a special fund, to be used only for the redemption of the Club bonds, until all of the bonds are redeemed.

The Treasurer shall furnish the Secretary with a list of names of members whose dues remain unpaid three months after they become due. The Secretary shall at once notify such delinquent members and report the names to the Board of Managers, who shall take such action as they may see fit.

No member in arrears to the Club shall be entitled to vote.

Junior members shall pay no initiation fee, but shall pay dues to the amount of ten dollars (\$10) for each year, one-half of which is to accompany the application, the remainder to be paid in advance, on July 1st of each year.

## CHAPTER II.

The five general meetings required by the Constitution shall be held as follows:

The first on the second Tuesday in February.

The second on the fourth Tuesday in March.

The third on the third Tuesday in May.

The fourth on the third Tuesday in July.

The fifth on the fourth Tuesday in November.

The election of officers and committees shall take place at the fifth general meeting in each year.

The following order of business shall be observed at all general meetings and shall not be departed from except by a two-thirds vote.

1. Roll call.
2. Minutes of previous meeting.
3. Election of officers.
4. Reports of committees.
5. Unfinished business.
6. Miscellaneous.
7. Adjournment.

### CHAPTER III.

Notices shall be sent to each member of all general meetings at least one week before such meetings; and of all special meetings at least three days before such meetings.

The business of any special meeting shall be strictly confined to the purpose for which it was called.

Any change in the residence or business address of a member shall be reported at once to the Secretary (who shall at once report same to Treasurer). Failure to make such report shall waive right of a member to notice as before provided.

A member chartering a yacht for not less than two months shall have all the privileges of the Club as a yacht owner during such period of charter.

### CHAPTER IV.

#### DISTINGUISHING SIGNALS, PENNANTS, ETC

SECTION 1. The Club signal shall be a sharp pointed pennant of red with a blue stripe, occupying

four-tenths of the hoist, and running diagonally across the pennant and bisecting the lower margin of same, with white letters, C. Y. C., in the center of and in line with the blue stripe.

The Commodore's signal shall be a rectangular pennant of blue ground, and a large white star in a diamond of twelve smaller stars.

The Vice-Commodore's signal shall be of the same shape, of red ground, and white star in diamond of twelve smaller stars.

The Rear-Commodore's signal shall be of the same shape, of white ground, and red star in diamond of twelve smaller stars.

The Acting Commodore's signal shall be of the same shape and color as the Commodore's, omitting stars.

The Fleet Captain's flag shall be a rectangular pennant with a large blue star on a white field.

**SEC. 2.** A member using a boat not enrolled in the squadron may carry the Clubflag or signal only by permission of the Commodore, previously obtained.

Every yacht owned in good faith to at least the amount of one-fourth thereof by some regular member shall be entitled to fly the Club signal.

**SEC. 3.** Each yacht is required to have a set of such signals as may be ordered by the Club, also a distinguishing signal flag, and to show it when signaled by another yacht. The flag of each yacht is to be in width two-thirds of its length, a description of which shall be filed with the Secretary.

**SEC. 4.** Every member buying or selling a yacht of the fleet shall give written notice thereof to the Secretary, who, if the purchaser be not a member of the Club, shall erase its name from the squadron and make report thereof to the Club.

## CHAPTER V.

## COLORS AND GUNS.

Yachts in commission shall make colors at 8 a. m. and haul down at sunset. From sunset until morning "colors" they shall fly night pennants. Time shall be given by the senior officer present.

No guns shall be fired on Sunday.

## CHAPTER VI.

## SENIORITY.

In the absence of the Commodore, Vice-Commodore and Rear-Commodore, the senior Captain present shall be acting commodore.

In case of resignation and re-election the date of membership shall be the date of re-election.

## CHAPTER VII.

## UNIFORMS.

SECTION 1. The uniform and dress shall be worn by the yacht members and crews of yacht and shall be as follows:

SEC. 2. The club button shall be of two kinds: black for members and gilt for sailing masters, etc., and shall bear as a device, Foul Anchor, surrounded by the circular inscription, "Chicago Yacht Club."

## CAPS.

SEC. 3. Caps of navy blue cloth; crown from eight (8) to eight and seven-eighths ( $8\frac{7}{8}$ ) inches in diameter, according to the size of cap; quarter of cap

from top of band to crown seam one and five-eighths ( $1\frac{5}{8}$ ) inches; band one and five-eighths inches of plain ribbed mohair; drooping visor, crescent-shape, two (2) inches at widest part, covered with blue cloth, bound with braid to match band of cap.

#### CAP ORNAMENTS.

SEC. 4. For Commodore, two crossed foul anchors, one and three-eighths ( $1\frac{3}{8}$ ) inches in length, with flukes down, embroidered in gold; at their intersection a raised disk nine-sixteenths ( $\frac{9}{16}$ ) of an inch in diameter, showing red ground with a blue stripe, three-sixteenths ( $\frac{3}{16}$ ) of an inch wide, running down across its center from left to right, at an angle of forty-five (45) degrees with the horizontal. The whole to be embroidered with colored silks. The disk to be surrounded by narrow gold bullion, and a star, one-half ( $\frac{1}{2}$ ) inch in diameter, at each end of and above the device, with space three-sixteenths ( $\frac{3}{16}$ ) of an inch between the device and stars, to be worn on the band.

(a) For Vice-Commodore—Same as for Commodore, omitting the star above the device.

(b) For Rear-Commodore—Same as for Commodore, omitting the stars at ends of device.

(c) For Captains—Same as for Commodore, omitting the stars.

(d) For Fleet Captains—Same as for Captain, with F. C. in silver, one-half ( $\frac{1}{2}$ ) inch long, in old English, over device.

(e) For Secretary—Same as for Fleet Captain, substituting letter S.

(f) For Treasurer—Same as for Secretary, substituting the letter T.

(g) For Measurer—Same as for Treasurer, substituting the letter M.

(h) For Fleet Surgeon—Same as for Measurer, substituting the letters F. S.

(i) For Judge Advocate—Same as for Fleet Surgeon, substituting the letters J. A.

(j) For Regatta Committee—Same as for Fleet Surgeon, substituting the letter R.

(k) For Members—Same as for Captain, omitting one anchor, and the remaining anchor to be upright.

(l) For Junior Members—Same as for members, omitting anchor.

#### CLUB RIBBON.

SEC. 5. The club ribbon shall be one and three-quarters ( $1\frac{3}{4}$ ) inches wide; of red ribbed silk with a dark navy blue stripe one-half ( $\frac{1}{2}$ ) inch wide, running through the middle, bordered with narrow white stripes one-sixteenth ( $\frac{1}{16}$ ) of an inch wide.

#### FULL DRESS.

SEC. 6. A plain dress suit, with double-breasted white dress vest, with fowl anchor buttons in gilt on same; white tie, and club ribbon worn across bosom of shirt.

#### UNDRESS.

SEC. 7. Double-breasted sack coat of blue serge, with vest of same material; each with the black club button. Trousers of the same material as coat, or of white duck.

#### DESIGNATION OF RANK.

SEC. 8. The designation of rank shall be worn on the sleeve as follows:

(a) By the Commodore—Four stripes of heavy black silk tubular braid, three-eighths ( $\frac{3}{8}$ ) of an inch wide, and one stripe of one (1) inch braid same description; the first below and joining the cuff

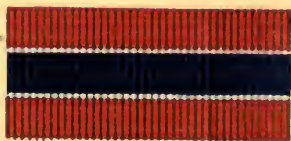

seams; the others above and one-quarter ( $\frac{1}{4}$ ) of an inch apart, the heavy braid being placed fourth; the upper stripe ending in a described trefoil on the outer side of the sleeve.

(b) By the Vice Commodore—Four stripes as above.

(c) By the Rear Commodore—Three stripes.

(d) By the Captains, Secretary, Treasurer, Measurer, Fleet Surgeon, Fleet Captain, Judge Advocate, Regatta Committee and Trustees—Two stripes as above, with the trefoil.

(e) By Members—One stripe as above with the trefoil.

(f) By Junior Members—No designation of rank.

## CHAPTER VIII.

There shall be printed each year, under the direction of the Secretary, upon authorization by the Board of Managers, books for the use of each member, containing the Constitution, By-Laws, Sailing Regulations, etc., of the Club, together with a list of all the members, specifying their names, residences, numbers and the dates of their election, and a complete list of the yachts enrolled in the fleet—giving size, rig, etc.,—and such other information as may be useful to the members and authorized by the Board of Managers.

## CHAPTER IX.

### RACING RULES

SECTION 1. The races of the Club shall be governed by the measurement rules of the New York Yacht Club, as in force at this date, February, 1904.

## CHAPTER X.

### SAILING REGULATIONS.

Extracts from the sailing rules of the United States under the Act of Congress, approved February 8, 1895:

## STEERING AND SAILING RULES.

*Sailing Vessels.*

RULE 16. When two sailing vessels are approaching one another, so as to involve risk of collision, one of them shall keep out of the way of the other as follows: Namely—

(a) A vessel which is running free shall keep out of the way of a vessel which is close-hauled.

(b) A vessel which is close-hauled on the port tack shall keep out of the way of a vessel which is close-hauled on the starboard tack.

(c) When both are running free, with the wind on different sides, the vessel which has the wind on the port side shall keep out of the way of the other.

(d) When they are running free, with the wind on the same side, the vessel which is to windward shall keep out of the way of the vessel which is to leeward.

## SAILING REGULATIONS.

SECTION 1. Yachts on the port tack must invariably give way to those on the starboard tack, and, in all cases where a doubt of the possibility of the yacht on the port tack weathering the one on the starboard tack shall exist, the yacht on the port tack shall give way. If the other yacht keep her course and run into her, the owner of the yacht on the port tack shall be compelled to pay all damages, and, if in a regatta or race, forfeit all claim to the prize.

SEC. 2. Any yacht bearing away or altering her course to leeward, and thereby compelling another yacht to bear away to avoid collision, shall forfeit all claim to the prize, except when two yachts are approaching a windward shore, buoy or stakeboat together, with a free wind, and so close to each other



that the weathermost cannot bear away clear of the leewardmost, and by standing on further would be in danger of running ashore or touching said buoy or stakeboat, such leewardmost yacht, upon being requested to bear away, is immediately to comply, and will forfeit all claim to the prize by not so doing. The weathermost yacht must, however, in this case bear away at the same time as the one she hails, if she can do so without coming in contact.

SEC. 3. When two yachts by the wind are approaching shore, a buoy or stake together, and so close that the leewardmost cannot tack clear of the windwardmost, and by standing on further would be in danger of running ashore, or touching such buoy or stakeboat, such weathermost yacht, on being requested to put about, is immediately to comply, and will forfeit all claim to the prize by not so doing. The leewardmost yacht must, in this case, however, tack at the same moment as the one she hailed, if she can do so without coming in contact.

SEC. 4. When rounding a mark, boat or buoy, the yacht nearer thereto shall be considered the headmost yacht, and should any other yacht that is in the regatta or race compel a yacht nearer any mark, boat or buoy, to touch the said mark, boat or buoy, the yacht so compelling her shall forfeit all claim to the prize, and her owner shall pay for all damages that shall accrue thereby. The yacht so compelled to touch a mark, boat or buoy, shall not suffer any penalty therefor.

SEC. 5. During a regatta or race under the auspices of the Club, all yachts not entered must invariably give way to those sailing in such regatta or race, without regard to the previous rules. Disobedience to this rule may be prosecuted under the Constitution.

SEC. 6. Any violation of these rules shall be reported to the Board of Managers and may be punished by them in their discretion

## CHAPTER XI.

## AMENDMENTS, ETC.

SECTION 1. These By-Laws may not be amended or altered except by a vote of two-thirds of the members present at a regular meeting, nor then, unless the amendment or alteration shall have been proposed and seconded at the preceding general meeting. When an amendment is brought up for adoption it may undergo only such minor changes as do not alter its original general character or intent.

SEC. 2. None of the By-Laws may be suspended except by unanimous consent of the members present, and such suspension must expire with the meeting in which it is ordered.

## Yacht Routine

# Yacht Routine

## UNIFORM WITH THE

### New York and Eastern Yacht Clubs

#### SECTION I

##### DISTINGUISHING FLAGS AND SIGNALS

#### 1 In Commission

The distinguishing marks of a yacht in commission, other than the yacht ensign, are a burgee and flag or private signal. When under way the yacht ensign should be displayed at the main peak of single and of two masted yachts, and at the mizzen-peak of three masted yachts, and of ketches and yawls. When at anchor, the yacht ensign should be displayed from a staff at the stern of all yachts, other than ketches and yawls, where it should be displayed at the mizzen truck. On a yacht with two or more masts the burgee is flown at the fore truck, and the private signal at the main, except in the case of a flag officer, whose distinctive flag is flown at the main. On a single-masted yacht see Section II., Paragraph 6. On a mastless yacht the distinguishing mark is flown at the loftiest or most conspicuous hoist.

#### 2 Distinguishing Signals, Pennants, Etc.

Distinguishing signals, pennants, etc., will be found described in the By-Laws, Chapter IV, and in the colored plates at the beginning of the book.

#### 3 Jack

When prescribed by routine a yacht should fly the national union jack.

#### 4 Absent Signals

The absent signal is a rectangular blue flag by day and a blue light by night.

#### 5 Owner's Meal Signals

The owner's meal signal is a rectangular white flag by day and a white light by night.

**6 Crew's Meal Signal**

The crew's meal signal is a red pennant.

**7** Absent flag and meal pennants are not considered to be "colors."

**8 Club Launch's Signal**

To call the Club Launch, the letter "T" should be hoisted from daylight until dark, and a red light should be shown at night. Three blasts on the fog-horn may also be sounded.

## SECTION II

## COLORS, ETC.

**1 Rank**

In making colors, salutes, etc., the yacht always represents the rank of its owner, whether he be aboard or not.

**2 Flag Officers**

A flag officer should always fly his flag while his yacht is in commission, except when he is on a cruise with another Club of which he is a member.

**3 In Commission**

A yacht in commission should make colors at eight A. M., and haul down at sunset, taking time from the senior officer present.

**4 In Company with a U. S. Vessel, Etc.**

When in company with a vessel of the United States Navy, or at anchor off a United States Naval Station, the senior officer should give the time for colors with such vessel or station.

**5 Entering Port Before or After Colors.**

When a yacht comes to anchor or gets under way her colors should be hoisted, although the time is earlier or later than that specified in Paragraph 3, provided there be sufficient light for the

colors to be recognized. On entering harbor under such circumstances the colors should be hauled down immediately after anchoring. At all other times a yacht should fly, between sunset and morning colors, a night pennant at the main, or, in the case of a mastless yacht, as provided for in Section I., Paragraph 1.

- 6 A single masted yacht should fly the owner's private signal when under way and the burgee when at anchor. (See Section VIII., Paragraph 6, "With the Squadron.")
- 7 Unless there are good reasons to the contrary, the ensign should when at sea be displayed on falling in with ships of war, and on approaching lightships, lighthouses, signal stations, military posts, or towns.

#### **8 Half-Mast Colors**

On occasions of national mourning the ensign only should be half-masted. On the death of a yacht owner the burgee and his private signal but not the ensign, should be half-masted. When mourning is ordered for the death of a member the burgee only should be half-masted. This rule should apply to a yacht both at anchor and under way, and to the Club stations.

#### **9 Colors: How Half-Masted**

In half-masting colors they should, if not previously hoisted, be first mast-headed and then lowered to half-mast. Before lowering from half-mast colors should first be mast-headed and then lowered. When the ensign is at half-mast it should be mast-headed before making or returning a salute.

#### **10 The Jack: When Displayed**

The jack should be set on Sundays, on all ceremonial occasions, and when the senior officer present has it set.

- 11 When displayed the jack should be set on a staff at the bow.
- 12 The jack should not be set when awnings are housed, when wash clothes are triced up, or when under way, except as provided in Section V., Paragraph 5, "Dressing Ship."
- 13 **Unofficial Presence of Flag Officer**

A flag officer embarked in a boat, not flying his distinctive flag, should be considered as present in an unofficial capacity.
- 14 The burgee and private signal should never be flown on the same hoist.

### SECTION III

#### ABSENT AND MEAL SIGNALS

##### 1 **Absent Signal**

When an owner is not on board, his yacht should hoist the absent signal at the starboard main spreader while at anchor, but not while under way. An absent signal does not exempt a yacht from the observance of the club routine. (See Paragraph 4.)

##### 2 **Owner's Meal Signals**

During an owner's meal hours his yacht should hoist the specified signal at the starboard main spreader. (See Paragraph 4.)

##### 3 **Crew's Meal Signal**

During the crew's meal hours the specified signal should be flown at the port fore spreader of a yacht with two or more masts, and at the port spreader of single-masted yachts. (See Paragraph 4.)

##### 4 **Square-rigged Yachts**

In a square-rigged yacht the owner's absent or meal signals should be hoisted at the starboard main yard arm, and the crew's meal signal at the port fore yard arm.

**5 Meal Signals Under Way**

Meal signals may be hoisted when the colors are not displayed, but never when under way.

**6 Mastless Yachts**

On a mastless yacht these signals should be shown as provided for in Section I., Paragraph 1, due consideration being had for the colors hoisted at the same time.

## SECTION IV

## LIGHTS

**1 Commodore**

From sunset colors until sunrise the Commodore should show two blue lights hung vertically at the stern.

**2 Vice-Commodore**

The Vice-Commodore should show lights as provided for the Commodore, substituting red lights for blue.

**3 Rear-Commodore**

The Rear-Commodore should show lights as provided for the Commodore, substituting white lights for blue.

**4 Absent Signal**

When a yacht is at anchor and the owner is absent, a blue light should be shown at the starboard main spreader in a fore-and-aft rigged yacht, and at the starboard main yard arm in a square-rigged yacht.

**5 Search-Lights**

A search-light should be carefully handled, and its beam should never be thrown on the pilot house or on the helmsman of a yacht or boat under way.

**6 Boat Booms**

Boat booms should be rigged in at night, but if rigged out a white light should be shown at the boom end.



## SECTION V

## DRESSING SHIP

**1 General Rule**

In dressing ship, rectangular flags should alternate with pennants on the distance lines whenever possible.

**2 Distinctive Flags and Foreign Ensigns**

Flag officers' flags and burgees should not be used in dressing ship, nor should the ensign of any foreign nation be displayed, except when the dressing is in compliment to such nation. On this occasion the foreign ensign should be displayed at the fore truck.

**3 Dressing Yacht Boats**

When a yacht is dressed the ensign should be displayed in lowered boats.

**4 National Anniversaries**

On the fourth of July, and when ordered on other National anniversaries, a yacht in commission, not under way, should, when the weather permits, dress ship at 8 A. M., and remain dressed until sunset. When said anniversaries occur on Sunday, all special ceremonies should be postponed to the following day.

- 5** On special occasions, such as marine parades, a steam yacht under way, or a sailing yacht under tow, may dress ship.

## SECTION VI

## SALUTES

**1 Steam Whistles**

Steam whistles should never be used in saluting.

**2 Guns**

Gun salutes should be avoided as much as possible.

**3 Ensigns**

All salutes, except as hereinafter provided should be made by dipping the ensign.

**4 Vessels of the U. S. Navy**

Vessels of the United States Navy should be saluted by dipping the ensign once.

**5 Commodore**

On joining the squadron at the beginning of a season the Commodore should, on coming to anchor, be saluted by the yachts present firing one gun or dipping the ensign once. On all other occasions, except as provided in Section VIII., Paragraph 1, "With the Squadron," the Commodore should be saluted on coming to anchor only by the officer in command of the anchorage, who will fire one gun.

**6 Junior Flag Officers**

A junior flag officer should be saluted only by the officer in command of the anchorage by dipping the ensign once, unless the latter be senior in rank, in which case he should be saluted.

**7 Captains**

A captain should salute the senior officer present by dipping the ensign once.

**8 Passing**

The salute for passing yachts is one dip of the ensign.

**9 Yachts Entering Port**

When entering port a yacht should salute by dipping the ensign once when the anchor is let go. A yacht entitled to a salute, entering port, should be saluted by dipping the ensign once when the anchor is let go.

**10 Committee Boat**

A committee boat should neither salute nor be saluted during a race.

**11 Saluting a Foreign Club**

On coming to anchor a yacht should salute a foreign club by dipping the ensign once.

**12 After Sunset, Etc.**

The salute to or from a yacht arriving after sunset should be made immediately after the next morning colors.

**13 During Official Visit of a Flag Officer**

When a flag officer makes an official visit his flag should be hoisted at the fore of a yacht with two or more masts, and at the main on a single-masted yacht, and be kept flying while he remains on board.

When a flag officer leaves, and is well clear of the yacht, one gun should be fired and his flag be hauled down.

**14 Saluting Quarter-Deck**

When a yacht is boarded or left, the quarter-deck should be saluted by touching the cap.

**15 Distinguished Visitors**

When a distinguished visitor of another nationality visits a yacht his national ensign should, if possible, be displayed at the fore on a yacht with two or more masts, at the main on a single-masted yacht, and on a mastless yacht as provided in Section I., Paragraph 1.

**16 Personal Flags of Officials**

A yacht may display the personal flag of a national, state or municipal officer, when such an official is on board. This flag should be displayed at the main for the President of the United States, and at the fore for all other officials.

## SECTION VII

## OFFICERS IN COMMAND OF ANCHORAGE

**1 Duties**

The senior officer present should command the anchorage, give the time for colors, make and return salutes, visits, etc.

**2 Station Vessel**

His yacht should remain the station vessel until a senior in rank arrives and assumes command of the anchorage.

**3 Transfer of Command**

A transfer of command should be indicated by firing one gun from the relieving yacht.

## SECTION VIII

## WITH THE SQUADRON

**1 Commodore's Salute**

On joining the squadron at the beginning of a cruise the Commodore should, on coming to anchor, be saluted by the yacht present firing one gun or dipping the ensign once. When the squadron is disbanded the Commodore should fire one gun, and be answered by the yachts present firing one gun and dipping the ensign once.

**2 Joining or Parting Company**

A yacht should report to the senior officer on joining the squadron, and should obtain his permission before leaving it.

**3 Gun and Other Signals**

When with the squadron guns should not be fired, except to call attention to signals or as provided for in other paragraphs.

**4 Squadrons Passing at Sea**

When squadrons of different clubs meet at sea, salutes should be exchanged by the senior officers alone.

**5 Salutes from Single Yachts**

Salutes from a single yacht at sea should be answered only by the flagship.

**6 Private Signals and Burgees on Single-Masted Yachts**

A single-masted yacht should fly the burgee both at anchor and when under way.

## SECTION IX

## HOME AND FOREIGN WATERS

"Home waters" should be understood to mean the waters of Lake Michigan in the vicinage of Chicago; all other waters are considered "foreign."

## SECTION X.

## FOREIGN YACHTS

When a foreign yacht arrives in home waters, the senior officer present should send on board, without regard to rank, a tender of the civilities of the Club.

## SECTION XI

## IN FOREIGN WATERS

**1 Salutes and Visitors on Entering Port**

A yacht should salute on entering a port in the home waters of a foreign club. (See Section VI., Paragraph 11.) After the tender of civilities has been made, the owner of the entering yacht should visit the officer in command of the anchorage. If the squadron of this foreign club be at

anchor the salute should be made to its senior officer, unless he is junior to the officer entering, in which case the actual senior should be saluted first. This salute should be returned in kind.

## **2 Colors**

The time for colors in the home waters of a foreign club should be taken from its senior officer present.

## SECTION XII

### BOAT SERVICE

#### **1 Precedence**

The order of entering and leaving boats is, juniors enter first and leave last.

#### **2 Boat Flags**

When in boats flag officers and the fleet-captain should fly their distinctive flags, captains their private signals, and members the burgee. The flag of the senior officer embarked has precedence.

#### **3 Hailing and Answering Hails**

Every boat approaching a yacht at night should be hailed, and this hail should be answered promptly. The answer of the Commodore intending to board his own or another yacht should be "Commodore"; of a junior flag officer, "Flag"; of the Fleet-Captain, "Fleet"; of a captain, the name of his yacht; of a member, "Aye, aye"; of a visitor, "Visitor"; of a sailing master or any other yacht officer, "No, no"; and of a member of the crew, "Hello." Passing boats should answer, "Passing."

#### **4 Boat Crews**

Boat crews should be dressed alike and in the prescribed uniform. Neck handkerchiefs should always be worn, knotted in front, and cap ribbons should not be tucked under.

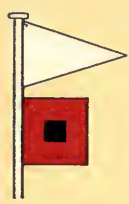

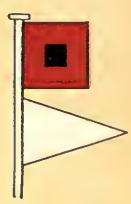

## EXPLANATION OF STORM, INFORMATION, AND HURRICANE SIGNALS.

---

*Storm Signal.*—A red flag with a black center indicates that a storm of marked violence is expected.

The pennants displayed with the flags indicate the direction of the wind; red, easterly (from northeast to south); white, westerly (from southwest to north). The pennant above the flag indicates that the wind is expected to blow from the northerly quadrants; below, from the southerly quadrants.

By night a red light indicates easterly winds, and a white light above a red light, westerly winds.

*Information Signal.*—(Red or white pennant displayed alone)—When displayed at stations on the Great Lakes indicates that winds are expected which may prove dangerous to tows and smaller classes of vessels, the red pennant indicating easterly and the white pennant westerly winds.

When displayed at stations on the Atlantic, Pacific, and Gulf coasts indicates that the local observer has received information from the central office of a storm covering a limited area, dangerous only for vessels about to sail to certain points, and serves as a notification to shipmasters that information will be given them upon application to the local observer. Only the red pennant is displayed on the coasts.

*Hurricane Signal.*—Two red flags with black centers, displayed one above the other, indicate the expected approach of tropical hurricanes, and also of those extremely severe and dangerous storms which occasionally move across the Lakes and northern Atlantic coast.

No night information or hurricane signals are displayed.



## Racing Rules

# Racing Rules.

## MANAGEMENT OF RACES.

The following Racing Rules shall govern all the races of the Club and any race sailed under its auspices unless otherwise specified between the parties making the race; but, as no rules can be devised capable of meeting every incident and accident of sailing, it shall be the duty of the Regatta Committee to decide any question which may arise, not provided for in these rules; and all attempts to win a race by other means than fair sailing and superior speed and skill are to be discouraged.

## DECISION OF COMMITTEE.

The decision of the Regatta Committee shall be final (Constitution, Art. X).

## RULE I.

### MEASUREMENTS FOR CLASSIFICATION AND TIME ALLOWANCE.

Yachts shall be rated for classification and time allowance according to the following formula:

$$\text{Rating measurement} = \frac{L \sqrt{SA}}{5.5 \sqrt[3]{D}}$$

{ Length multiplied  
 by square root of  
 sail area, divided  
 by 5 times cube  
 root of displace-  
 ment.

The result is the measurement for classification and time allowance.

The measurements shall be obtained as follows:

As prescribed in the measurement rules of the N. Y. Y. C.

## CLASSIFICATION.

The classification will be arranged by the Regatta Committee and published from time to time as required.

## COURSES.

*Course No. 1.*—Start across an imaginary line drawn between the outer corners of the opposite piers forming the Van Buren Street gap in the breakwater; around a triangular course formed by the four-mile crib and by a white spar buoy located off the Chicago Beach Hotel on a line between the four-mile and Hyde Park cribs. (For compass bearings and distances, see "Chart of Courses.")

*Course No. 2.*—Short Course. Same as the long Course, but with the south buoy located off 35th St., making an equilateral triangle. (For compass bearings and distances see "Chart of Courses.")

## RULE II.

## MIXED RACES. ALLOWANCE FOR RIG.

In races where different rigs sail together, schooners shall be rated for time allowance at eighty-five per cent. of their racing measurement; yawls at ninety-three per cent., and sloops and cutters at their actual racing measurement.

## RULE III.

## OWNERSHIP.

No member shall be interested in more than one yacht entered for a race in the same class.

## RULE IV.

## ENTRIES.

1. No yacht can be entered for a Club race unless her ownership, rig, tonnage, dimensions, and measurement for time allowance, as computed by the Measurer,

in accordance with the rules of the Club, are on record with the Secretary.

2. Entries shall be made in writing, and must be lodged with the Regatta Committee not later than forty-eight hours before the time of starting, unless otherwise ordered by said Committee.

3. The Regatta Committee may refuse or accept any entry made after the time of closing.

4. At least two yachts must start in each class to entitle a yacht to a prize.

5. Any yacht alone in her class may sail in the class next above, but in such case such yacht shall assume and be entered as of the minimum racing length specified for the class in which she so enters; but this shall not be so construed as to permit a single-masted vessel or yawl to enter in a schooner class.

## RULE V.

### SAILS.

1. Yachts in races may carry the following sails:

2. **SCHOONERS.**—Mainsail, foresail, forestaysail, jib, flying-jib, jib-topsail, fore and main gaff-topsail, main topmast staysail, and spinnaker.

3. **SLOOPS AND CUTTERS.**—Mainsail, forestaysail, jib, flying-jib, jib-topsail, gaff-topsail, and spinnaker.

4. **YAWLS.**—Same as Sloops and Cutters, with mizzen and mizzen-staysail.

### BALLOON SAILS.

5. Yachts may set light sails over working sails.

## RULE VI.

### BOATS AND LIFE-BUOYS.

1. All Yachts shall carry at least two serviceable life-buoys on deck ready for use.

2. The Regatta Committee will publish requirements governing the carrying of boats—in the various events of the season.

## RULE VII.

## BULKHEADS, BALLAST, ETC.

1. Floors must be left down and bulkheads and doors left standing; water tanks kept in place, and at least one bower anchor and cable kept on board. All yachts, except in Classes A of schooners and G of single-masted vessels and yawls, shall keep their galley fixtures and fittings on board and in their proper places. Trimming by dead weight shall not be allowed after the Preparatory Signal. Neither ballast nor water shall be taken in or discharged after 9 P. M. of the day before a race, but the above restriction may be waived as to water only by permission of the Regatta Committee.

2. A race postponed or resailed shall, so far as regards this rule, be considered a new race.

## RULE VIII.

## CREW.

The number of men permitted on a yacht during a race shall not exceed 1 man for every 300 square feet of sail area, or fraction thereof.

## RULE IX.

## AMENABLE TO RACING RULES.

1. Yachts shall be amenable to the Racing Rules from the time the Preparatory Signal is made.

## MEMBER ON BOARD.

2. There shall be a member of the Club on each yacht.

## PRIVATE SIGNAL AND NUMBER.

3. Each yacht shall carry her Private Signal at the main truck and display her racing number above the reef points at an equal distance from the luff and leach on both sides of the mainsail.

## LIGHTS AND FOG SIGNALS.

4. The Government regulations regarding lights and fog signals shall be observed.

## PROPULSION.

5. No means of propulsion other than sails shall be employed.

## ANCHORING, ETC.

6. A yacht may anchor, but must weigh her anchor again and not slip. A yacht shall not warp or kedge, or make fast to a buoy, pier, vessel, or other object, except as provided in Section 7.

## RUNNING AGROUND AND FOULING.

7. A yacht running aground or fouling a buoy, pier, vessel, or other object, may use her anchors, warps, boats, etc., to get clear, but may not receive any assistance, except from the crew of a vessel fouled.

8. Any anchor, warp, or boat so used must be taken on board again before continuing the race.

## MAN OVERBOARD AND ACCIDENTS.

9. Every yacht shall render all possible assistance to any vessel or person in peril, and if in the judgment of the Regatta Committee she shall have thereby impaired her chances of winning, they shall order the race resailed between such yacht and the winner in her class.

## DECLARATION THAT THE RULES HAVE BEEN OBEYED.

10. Before receiving a prize, the owner of a winning yacht, or the member representing him on the yacht in his absence, shall sign a declaration that all the Rules were complied with.



## RULE X.

## TIME LIMIT.

The time limit for each race shall be announced by the Regatta Committee before the start of each race.

## RULE XI.

## SOUNDING.

No other means of sounding than the hand lead and line shall be employed during a race.

## RULE XII.

## STAKE BOAT AT FINISH.

A competent person shall be placed on a stake-boat at the finishing line, who shall time the yachts in the absence of the Regatta Committee.

## RULE XIII.

## REMOVAL OF MARKS.

Should any stake-boat, buoy, or other mark be absent, or moved from its proper position, during a race, the race may be resailed or not, at the option of the Regatta Committee.

## RULE XIV.

## YACHTS NOT IN RACES.

All yachts not racing must be kept to leeward and out of the way of racing yachts.

## RULE XV.

## TIME AT START AND FINISH.

1. The time at the start and finish shall be taken when the foremast in schooners and the mainmast in single-masted vessels and yawls first crosses the line, after the starting signal has been given.

2. If this point in any yacht be across the line when the signal for starting is given, she must return and recross the line.

3. A yacht so returning, or one working into position from the wrong side of the line after the signal for starting has been given, must keep clear of and give way to all competing yachts.

## RULE XVI.

### RIGHT OF WAY.

1. When one yacht is approaching another yacht, so as to involve risk of fouling, one of them shall keep clear of the other as follows:

#### ON DIFFERENT POINTS OF SAILING.

2. A yacht free shall keep clear of one close-hauled.

#### ON SAME POINT OF SAILING, WITH WIND ON OPPOSITE SIDE.

3. When both yachts are close-hauled, or both free, or both have the wind aft, and have the wind on opposite sides, the yacht with the wind on the port side shall keep clear.

#### ON SAME POINT OF SAILING, WITH WIND ON SAME SIDE.

4. When both yachts are free, or both have the wind aft, and have the wind on the same side, the yacht to windward shall keep clear.

#### WIND AFT.

5. A yacht with the wind aft is deemed to have the wind on the side opposite to that on which she is carrying her main boom.

6. A yacht with the wind aft shall keep clear of a yacht on any point of sailing.

## OVERTAKING.

7. An overtaking yacht shall, in every case, as long as an overlap exists, keep clear of the yacht which is being overtaken.

## DEFINITION OF OVERLAP.

8. An overlap is established when an overtaking yacht has no longer a free choice on which side she will pass, and continues to exist as long as the leeward yacht, by luffing, or the weather yacht, by bearing away, is in danger of fouling.

## ALTERING COURSE.

9. When, of two yachts, one is obliged to keep clear, the other shall not so alter her course as to involve risk of fouling.

## LUFFING.

10. A yacht may luff as she pleases in order to prevent another from passing her to windward, provided she begins to luff before an overlap has been established.

## BEARING AWAY.

11. A yacht shall not bear away out of her course so as to hinder another in passing to leeward.

## RIGHTS OF NEW COURSES.

12. A yacht shall not become entitled to her rights on a new course until she has filled away.

## CONVERGING CLOSE-HAULED.

13. When two yachts, both close-hauled on the same tack, are converging by reason of the leeward yacht holding a better wind, and neither can claim the rights of a yacht being overtaken, then the yacht to leeward shall keep clear.

## PASSING AND ROUNDING MARKS.

14. If an overlap exists between two yachts when both of them, without tacking, are about to pass a mark on a required side, then the outside yacht must give the inside yacht room to pass clear of the mark. A yacht shall not, however, be justified in attempting to establish an overlap and thus force a passage between another yacht and the mark after the latter yacht has altered her helm for the purpose of rounding.

## DEFINITION OF MARK.

15. A mark is any vessel, boat, buoy, or other object used to indicate the course.

## OBSTRUCTION TO SEA-ROOM.

16. When a yacht is approaching a shore, shoal, pier, rock, vessel, or other dangerous obstruction, and cannot go clear by altering her course without fouling another yacht, then this latter shall, on being hailed by the former, at once give room; and in case one yacht is forced to tack or to bear away in order to give room, the other shall also tack, or bear away as the case may be, at as near the same time as is possible without danger of fouling. *But should such obstruction be a designated mark of the course, a yacht forcing another to tack under the provisions of this section shall be disqualified.*

## RULE XVII.

## DISQUALIFICATION.

1. Every yacht must go fairly around the course and must not touch a mark or force a mark-boat to shift its position, but shall not be disqualified if wrongfully compelled to do so in order to avoid fouling or being fouled by another yacht.

2. If a yacht, in consequence of her neglect of any of these rules, shall foul another yacht, or compel another yacht to foul any yacht, mark, or obstruction, or

to run aground, she shall be disqualified and shall pay all damages; and any yacht which shall wrongfully cause another to luff, bear away, or tack, in order to avoid fouling, or shall without due cause compel another yacht to give room or to tack (under section 16 of Rule XVI), or shall herself fail to tack or to bear away, as required in that section, or shall, in any other way, infringe or fail to comply with any of these Rules, shall be disqualified.

3. If a yacht, after having been officially measured, makes changes in her trim, causing an increase of L. W. L., or makes alterations in her sail plan, should enter a race without remeasurement or notifying the Regatta Committee in writing that alterations have been made, and a request for remeasurement, she shall be disqualified.

#### DISQUALIFICATION WITHOUT PROTEST.

4. The Regatta Committee shall also, without a protest, disqualify any yacht, should it come to their knowledge that she has committed a breach of these Rules.

### RULE XVIII.

#### PROTEST.

1. A yacht having cause during a race to protest against any other yacht for a violation of these Rules shall display Flag B, of the Club Signal Code, which shall be known as the Protest Flag, and keep such flag flying till answered from the Judges' Boat by the answering pennant. A protest must be supplemented by a written statement of the facts, which must be sent to the Regatta Committee before 6 P. M. of the day following the race.

2. If through protest the measurement of any yacht be called in question, the Regatta Committee shall direct the Measurer by whom such yacht was

measured, or, if in their judgment such Measurer is not available, then another Measurer, to remeasure the same, and the result, as reported by him, shall be final. The Treasurer shall collect the fee for measuring from the Club, if the measurement be found wrong; from the party protesting if the measurement be found right.

## RULE XIX.

### PENALTIES.

A yacht which shall be disqualified twice in one season may be debarred from sailing in Club races for the remainder of the season.

## RULE XX.

### AMENDMENTS.

1. These Racing Rules can be amended only at meetings in notice of which the proposed amendment shall have been stated in full.

2. An amendment to become valid, must have been passed at one meeting and approved at a subsequent meeting, one of which shall be a General Meeting.

3. And no amendments which have been rejected at one meeting can be again proposed at any subsequent meeting within six months thereafter.

4. There shall be no suspension of these Rules.

## Signal Code

## Signal Code

The International Code of Signals will be used by the yachts of the fleet.

Each yacht shall have on board a set of Code Flags and a Code Book, together with a copy of the Club Code without which the special Club signals cannot be read.

The signals given in the following list consist chiefly of sentences needed by vessels of the fleet. Such of these sentences as are covered by the International Code, have been given their proper signal as given in the Code Book. Sentences not covered by the International Code have been given a special set of four flag combinations, all of which begin with the letter C, and must be read from the Chicago Yacht Club Code.

A to Z—Meaning of flags and pennants hoisted with Code Flag. See page 7, International Code Book.

A to Z—Single letters are used only between vessels towing and being towed. See page 35, International Code Book.

A to Z—Also used as Alphabetical (spelling) signals when hoisted with Alphabetical Signal No 1. See page 13, International Code Book, and as Numeral Signals when hoisted with Numeral Signal No. 1. See page 32, International Code Book.

C A B D to C M A E—Are special C. Y. C. signals and will be found in the Club Code in the Year Book.

Signals should be acknowledged as soon as understood by hoisting the answering pennant, which should be kept flying until the signals are hauled down, when the answering pennant should be hauled down promptly.

When using the International Code, display the regular signals indicative of the International Code, namely, the ensign hoisted over the answering pennant.

When it is desired to signal to a particular yacht, her international number, or Club Code Signal, will be hoisted and she only should answer.

When it is desired to signal to the Club House or Station, the Club Burgee will be hoisted over the signal.
