#### PREFACE.

The following brief compilation has been made at the request of some of the descendants of Joseph Dart of Stratford, desiring in convenient form such particulars as might readily be collected. The name seems not to be a common one either in the "old country" or in the United States, and as in the case of most early New England families, the descendants are to be found scattered through many of the states and territories of the Union. We are indebted to M. L. Roberts of New Haven, Conn., and Mrs. M. M. Judd of Kanab, Kansas, for assistance in collecting material for the following pages.

#### DART.

The name is variously spelled Dart, Darte and Dort, but the first is the generally accepted form, the second appearing only in old English records and the third in the Dutch or German form. In the visitation of the County of Surrey, England, made in 1620, the name is spelled Darte. John Wallis al's Darte of Barstable m. Joane, dau. of Rob. Courtney of Molland in Devon. His son, Lewis Wallis al's Darte, of Meve, m. Eliz., dau. of Thos. Roscarrock. Children:

John, Charles, Jane, m. John Tremayne; Phillip, of Bohemia, had three sons; Lewis, bap. Dec., 1597.

The earliest mention we find in New England records is at New London. From there members of the family seem to have gone to Bolton, Middletown, Chatham, Hebron, Windham and Stratford, Conn., and to Gilsum and Surry, New Hampshire. At the latter place there were several families who held prominent positions in the community and whose name is commemorated in the local geographic titles.

JOHN DART, son of Wm. and Lydia, b. Nov. 11, 1809, m. Nov. 24, 1831, Lucy Ann Roberts, dau. of Julius and Polly Ann Roberts of Monroe, b. Nov. 7, 1814. He was a blacksmith by trade, removed to Groton City, N. Y., and kept a store until the fall of 1842; then returned to Bridgeport, bought a house of a Mr. Bruce near Stratford, where he lived seven years, sold out to a Mr. Gilbert April 14, 1849, and went West to join the Mormons; stopped a year at Council Bluffs, and in 1850 again took up his journey West. His wife and two children died with the cholera, his wife July 6, 1850, near Fort Laramie. He arrived at Salt Lake in the fall, moved to Parowan, Iron Co., Utak, where he stayed three years. He then went to California, where he remained until 1860, then went to Kansas and married Amanda Cogswell, living and keeping a store at Lincoln Center, Lincoln County, where he died Dec. 1, 1877, aged 67 years.

Judd learned the trade of tailoring, in 1846 enlisted in the U. S. A., served with the Mormon Battalion in the Mexican war, went to Utah in 1848, lived in Salt Lake City until 1850, went to Parawan, Iron county, Utah, m. Mary M. Dart Nov. 14, 1852, in March, 1856, moved to Santa Clara, in 1864 moved to Eagle Valley, in 1871 moved to Kanab, Kane county. At Kanab he took up a quarter section of land and got four city lots, planting orchards and vineyards. Was ordained a Mormon priest and acted as bishop of Santa Clara for seven years. His oldest son, Zadoc K. Judd, Jr., is a preacher of the "Church of the Latter Day Saints," leaving his home for that purpose in September, 1881, and three other sons are in the same occupation.
