To compensate the owners of the steamer *Phœnix*, impressed by military authority, and sunk as an obstruction in the harbor of Mobile, Alabama, August 7, 1864, six hundred and forty-four thousand three hundred and seven dollars and thirty-four cents.

HON. JAMES A. SEDDON,

*Secretary of War, Richmond, Va.:*

SIR: I have the honor to enclose herewith an estimate in triplicate for the steamer Phœnix, impressed by the military authorities, and sunk as an obstruction in the harbor of Mobile, Alabama, August 7, 1864. This vessel was purchased from the Navy Department by the claimants, and afterwards seized by a verbal order of Brigadier General E. Higgins, as appears from the statement of Major General D. H. Maury, telegram from Brigadier General Higgins, and statement of Lieutenant Colonel V. Sheliha, chief engineer district of the Gulf, and sunk as before stated. The amount claimed (\$644,307.34) was ascertained by the appraisers appointed by Lieutenant Colonel Sheliha, acting for the Government, and Julius A. Pratt, acting for the owners.
