## SHAW FAMILY.

ORIGINALLY ENGLISH FRIENDS, QUAKERS.

EARLIEST LOCATION, BUCKS COUNTY, PENNSYLVANIA.

## FIRST GENERATION.

JOHN SHAW m. Susanna. By deed dated July 7, 1697, he acquired from William Buckman of Newtown, Pennsylvania, title to 300 acres of land in the lower part of what is now Northampton, then in Southampton, Bucks County. Pennsylvania. This tract of land was patented to Buckman in 1686. In 1709 John Shaw is of record among the residents of Southampton. His name and that of his son James are among the petitioners, December 11, 1722, for the separate township of Northampton, and James signs the petition in 1725 for the township of Plumstead. John and Susanna Shaw, of Northampton, were members of the Middletown monthly meeting of the Society of Friends, and the names and dates of birth of their children are upon the records of that meeting. They had ten children.

#### SECOND GENERATION.

JAMES SHAW, d. December 3, 1761; residence, Plumstead, Bucks County, Pennsylvania; m. September 24, 1718, at Abington meeting house, Montgomery County, Pennsylvania, Mary Brown d. June 9, 1764, daughter of Thomas and Mary Brown. Thomas Brown b. 1666, immigrated from Barking, Essex County, England, and after living some time in Philadelphia and Abington located, probably as early as 1712, near Dyerstown, Bucks County, Pennsylvania. Thomas Brown conveyed by deed, dated June 18, 1724, to James Shaw, 200 acres of land in Plumstead. James and Mary Shaw had six children recorded in the records of the Buckingham monthly meeting of the Society of Friends.

#### THIRD GENERATION.

ALEXANDER SHAW, b. November 24, 1734, d. January 11, 1790; m. Sarah Brown, d. about 1812, widow of Moses Brown. All of their children were born on the Shaw homestead, devised to Alexander by his father James, about three miles northeast of Doylestown, Bucks County, Pennsylvania, in Plumstead Township. The homestead is easily reached by following the road that leads from Doylestown to Danborough until past Dyerstown, then follow the first road to the right until it ends in another road, and near where these roads join is the old Shaw homestead, now owned and occupied by Samuel W. Shaw b. March 24, 1858, son of Alexander b. April 9, 1815, son of Alexander b. September 6, 1767, son of the above Alexander and Sarah Shaw. Alexander and Sarah Shaw had eight children.

#### FOURTH GENERATION.

GEORGE SHAW, b. April 2, 1760; d. August 21, 1801; m. Mary Wilson; d. about 1828, at Evansville, Indiana; she married, second, Johnston Watson, and had Elizabeth Watson, who married first Sandy Rial, and second — McCoy. A deed dated April 1, 1797, recorded in Bucks County, Pennsylvania, Book 28, page 544, shows that Thomas Brown conveyed land in Plumstead, Bucks County, Pennsylvania, to his son-in-law, James Shaw, on June 18, 1724, and on December 14, 1759. James Shaw deeded part of it to his son, Alexander Shaw, who died intestate, and the Orphans Court adjudged this land to his eldest son, George Shaw, and April 1, 1797, George Shaw and Mary, his wife, of Plumstead, deed this land to John Fell, and in 1811, in Deed Book 40, page 121, Mary Watson and Johnston Watson, as administratrix and administrator of the estate of George Shaw, deceased, perfect the title in John Fell. By deed, Book 26, page 451, dated April 8, 1791, "George Shaw and Mary, his wife, of Plumstead, yeoman," convey land to his brother, "Alexander Shaw, yeoman."

Mary Wilson, wife of George Shaw, was born 1763. Her mother, Elizabeth, married first, John Wilson, of Nockamixon, Bucks County, Pennsylvania, d. December, 1773, and had John and Mary; second, William Keith, of Makefield, Bucks County, Pennsylvania, d. 1781, and had Samuel; third, Robert Gibson, d. 1788, and had Jean and Robert. This Robert Gibson was undoubtedly related to the James Gibson appointed guardian of David Shaw, minor son of George and Mary (Wilson) Shaw, on June 3, 1812, by the Orphans Court of Bucks County, Pennsylvania, to represent him in a dower claim forming part of the estate of his grandmother, Sarah Shaw.

The father of Mary Wilson was John Wilson, of Nockamixon, Bucks County, Pennsylvania, d. December, 1773. Her grandfather was Ralph Wilson, of Nockamixon, b. 1716, d. 1776. His sons were David, John, Samuel. Robert, Andrew, Francis and William. He was Scotch-Irish Presbyterian. George and Mary (Wilson) Shaw had:

About 1836 he moved to Madison, Indiana, where he purchased the dry goods store of John Lodge, and continued it until he retired from business a few years before his death. ## FIRST GENERATION.

SAMUEL AINSWORTH settled about 1736 in Hanover Township of Lancaster County, afterwards of Dauphin County and now of Lebanon County, Pennsylvania. His name appears in 1751 upon the first assessment list of that township. In the assessment list for 1756 it is noted that his son was taken captive by the Indians, and that he had fled from his farm. Little is known of him save that his wife was Margaret Young, daughter of John Young and Margery Stewart, of Hanover. Only two of his children are known.
