HOMESTEAD OF DEA. JOHN FARRINGTON.

Built in 1796. Meetings were held in the large kitchen, and school in the room at the right, for many years, till the school-house was built, near by.

P R E F A C E .

In Holden, Maine, on Friday, the 24th day of August, 1877, about forty of the grandchildren of Dea. John Farrington, one of the first settlers of the town, in 1786, assembled at the home of Mrs. Nancy Hart, his only surviving child. While together the subject of a family Reunion was discussed, and an organization effected, one prominent object of which was to collect and preserve records and incidents in the history of the Farrington family. A President, Vice President and Secretary were chosen, and it was proposed to hold a Reunion on "Wrentham Hill," Holden, in Aug. 1878. A committee of Arrangements was also chosen to designate the day, issue invitations, &c.

The result of the invitations thus extended, was a gathering, Aug. 27th, 1878, of more than eighty of the family, with a few invited friends. After an interchange of greetings, and enjoying a bountiful collation, the Secretary read a brief sketch of the Ancestors for more than two-hundred years, together with some genealogical facts of the past and present. Others added reminiscences and anecdotes of the Fathers, interspersed with singing. This reunion was so much enjoyed that it was voted to make the organization permanent, and to have the meetings continued annually.

The Reunion for 1879 held at the Oliver Farrington homestead, Brewer, Aug. 28th, was equally well attended and enjoyed. It was voted to have the Family records collected and printed; and a Committee for this purpose was chosen, consisting of

In fulfilment of this trust, your Committee hope their work may meet the approbation of all. It goes forth with the earnest desire that its circulation among the different families of the name, scattered over our broad land, may stimulate an interest, which shall result, ere long, in a complete work, embracing all of the Farrington name and Lineage in the Country.

As suggestive of sources of material for such work, we have added an Appendix, containing genealogical sketches, which we hope may prove not only interesting, but in other hands, under favorable conditions, may lead to more thorough and faithful research.

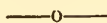

DEA. JOHN FARRINGTON.

JOHN⁴ (*Benjamin*,³ *Daniel*,² *John*¹), was left at 16 years of age, by the death of his father, with the care of his mother and sisters. Worked as carpenter in Wilmington, Vt. in 1781, and in Claverack on the Hudson in 1784. Served in the army during the latter part of the war of the Revolution. In 1786, in company with seven or eight others, emigrated to the District of Maine, and settled seven miles east of the Penobscot River, in what is now the town of Holden. Married July 14, 1788, in Wrentham, Cynthia,* dau. of Daniel and Abiah (Braman) Hawes, and went with her into a log cabin in the wilderness of Maine. Here he labored to support a large family and build up society. Represented his district in the General Court of Massachusetts, was deacon of the Church for many years, an exemplary Christian, a good husband and father. Died Sept. 30, 1843. She died Oct. 13, 1840. Their children were:

APPENDIX.

THE Farrington name dates far back in English history. First called in the old Saxon, Ferndon, signifying Fern hill. There is an ancient town called Farrington in Berks County, west of London. There is a township named Farrington in Lancaster County; and a parish of the same name in another part of England.

The name is also found among the nobility of the Kingdom. Ffarrington of Warden, and Ffarrington of Woodvale were lineal descendants of John de Ffarrington, in the time of Henry III. His will is dated 1549. The motto of his "Armorial Berings," was "*Domat Omnia Virtus*."

The name appears subsequently, knighted or ennobled: as Sir Anthony Farrington 1766: Sir Anthony Farrington son of Charles Farrington, was made Baronet 1818: Sir Henry Maturin Farrington, who inherited as third Baronet: Sir Henry Anthony Farrington, of Blackheath, County of Kent, fourth Baronet, Oct. 4, 1834.

In the list of passengers for New England on the ship *Hopewell*, London, April 1, 1635, is found the name of "Edward Ffarrington, aged 47, and his wife Eliza, 48, with their children, Sarah, 14, Matthew, 12, John, 11, Eliza, 8." These names appear in the Lynn records, "Edmund and Elizabeth." He was one of the projectors of a settlement on Long Island, 1740. And among "L. I. papers," leading the signers of a Declaration, is the name Edward Farrington, with—"his mark." He seems to have returned to Lynn, and d. Jan 2, 1671.

Matthew,² went with his father to L. I.,—there probably m. and had children,—names and number unknown. Returned to Lynn, and had;

Amos Farrington of Lynn, m. Sarah Upham of Chelsea, Sept. 26, 1788.
