FINANCE PROPOSITION.

In lieu of first six sections of committee bill insert.

- 1 Section 1. That on and after the first day of in
- 2 the year eighteen hundred and sixty-four, a tax shall be levied
- 3 on all treasury notes heretofore issued, not bearing interest,
- 4 which shall remain outstanding at the rate of one-sixth of one
- 5 per cent, per day until the tax shall amount to per cent,
- 6 and whenever any of such notes shall be offered in payment of
- 7 other taxes or to be funded or paid, the tax which then shall
- S have accrued thereon shall be deducted from the same.
- Sec. 2 That the taxes imposed for the year eighteen hundred
- 2 and sixty-four, by the act entitled "An Act to la tax's for the
- 3 common defence and earry on the Government of the Confele-
- 4 rate States," approved April 24, 1863, are hereby doubled for
- 5 said year eighteen hundred and sixty-four, so that twice the
- 6 amounts and rates of taxes imposed thereby as aforesaid shall be
- 7 levied and collected for that year; and the proviso of the
- 8 eighteenth section of said act is hereby suspended for that year

- 9 and the tax mentioned in sail proviso shall be levied and col-
- 10 lected for the year eight en hundred and sixty-four; bet the
- 11 amounts which farmers and planters may reserve out of the sub-
- 12 jects of the tax in kind for that year shall be twice the amounts
- 13 which said act permits them to reserve.
 - 1 Sec. 3. Every person who shall be liable to pay or deliver any
 - 2 tax in kind for the year cig'teen hun leel and sixty-four, miy, at
 - 3 his option, commute the same by the payment of coin or com-
 - 4 mutation bills as hereinafter provided.
- 1 Sec. 4 The Presid at shall cause to be made and issued bills
- 2 to be called "commutatation bills," which shall be of any of the
- 3 denominations heretofore authorized for treasury notes not bearing
- 4 interest and shall purport that the Confederate States of America
- 5 owe to the bearer the sums of money therein respectively speci-
- 6 fied, and that the bills are receivable in commutation of certain
- 7 taxes according to law. Such bills, when received into the
- 8 ticisury, may be re-issuel, or others may be issued, but the
- 9 whole amount of them outstanding shall not at any time exceed
- millions of dollars. Such of said bills as shall remain
- 11 outstanding at the conclusion of a definitive treaty of peace
- betweeen the Confederate States and the United States will be
- 13 paid or funded within one year thereafter.
 - 1 Sec. 5. The commutations here nbefore authorized to be male
- 2 shall, until otherwise provided by law, be made at the following

rates: for wheat, two dollars and fifty cents per bushel; for 3 corn, two dollars per bushel, for oats, two dollars per bushel; for rye, two dollars and fifty cents per bushel; for backwheat, 5 6 per bushel; for ric; twenty cents pr pounl; for 7 sweet potatoes. per bushel; for Irish potatoes, per bushel; for cured hay, 8 per ton; for fodder, 9 per ton; for sugar, per 10 pounl; for molasses. per gillon; for cotton, twenty-five cents per pounl; for wool, one dollar per pounl; for 11 tobacco, sixteen cents per pound; for peas, two dollars per 12 bushel; for beans, two dollars per bushel; for ground peas, 13 per bushel, and for bacon, sixty 14 cents per 15 pound. Sec. 6. Whenever the amount which any tax-payer is bound 1 to deliver of any crop, as tax in kind, for the year eighteen 2 hundred and sixty-four, shall be agreed upon between him and 3 the assessor, or shall be assessed according to law, or when the 4 tax-payer shall exhibit his account of higs shrightered, the 5 tax-payer, if he elects to commute the same according to this G act, shall notify the assessor thereof, in writing, and thereupon 7 the amount of money pigable on account of such commuta-8 tion shall be impoliately due, and shall be certified by 9 the assessor to the proper collector, and the amount due shall 10 11 be collected according to the laws relating to the collection of
