






KOLLOCK GENEALOGY.

I. 1. JACOB KOLLOCK was born 1657,* but where is unknown. His wife's Christian name was Mary. The first reference to Jacob Kollock in Sussex County, Delaware, is at the March Term of the Court of Common Pleas for that County, 1689, where he applied for a grant of land which was granted.† He is sometimes styled "Cooper" and sometimes "Merchant." He was quite a large landholder, both in Sussex County and also in Philadelphia, as appears from the records at both places.† He was executor of Jacob

Kipshaven,* to whom he was related. He frequently was a grand and petit juror.† June 7, 1697, he was selected "to keep watch for the enemy" at Cape Henlopen‡ with other citizens of Lewes.

Also the grant of a vacancy joyning on his land, formerly Capt. Avery's, in forked Neck, upon Rehoboth Bay, likewise if Samuel Davis do not hold the Island in Lewis Creek, for which he obtained a Warr't some time ago with condition to pay for the same within a small space of time, which he has not yet comply'd with, that he, the said Jacob, may have the same at a reasonable rate."

"Sir Edm'd Andros, by Pat. dat. 20th August, 1679, granted to Rob't Higenot and Jno. Crue 900 acres of land in Sussex Co'ty, which is now in the possession of Jno. Crue, Mary Dyne* and Jacob Colluck, but the bounds being uncertain and confused they crave a resurvey, which is granted."

Jacob Collock desires the grant of a small island in Lewis Creek, at the upper end of the Town, near to a lot of his son Jacob, for whom he intends it."

Jacob Kolluck, of Lewis, requests a warrt. to resurvey a parcel of land in the bottom of Angola Neck, containing about 80 acres, sold by W^m Clark, deceased, to Jno. West, and by to sd. Kolluck, with liberty to take up what vacant

land is bounding upon it, for which he is willing to pay a reasonable rate, also to take up on the same terms one hundred acres at the head of Stuckberry Neck, of both which the preference is granted him, but no warrt. as yet ordered nor agreement made."

Jacob Kollock, of Lewis, aforesaid, desires a resurvey on two tracts of land in the County of Sussex, and to add to them some vacant land joining to them, for which he agrees to pay $\pounds 10$ p. C., or in proportion, and usual quitrent of 1 bush. wheat p. C. Granted and warrt. ordered. Mentioned in Pag. 52 of these minutes."

Jacob Kollock died Feb. 25, 1720, and was buried in the Church Yard of the old Episcopal Church at Lewes, the following being a copy of his epitaph:

> "IN MEMORY OF JACOB KOLLOCK WHO DEPARTED THIS LIFE YE 25 DAY OF FEBRUARY ANNO DOMINI 1720 AGED 63 YEARS."

His will is recorded both at Georgetown and Philadelphia.* It is dated Dec. 30, 1720, and was probated March 14, 1720–1. He mentions his wife Mary and the children hereinafter named, to each of whom he left a house and lot.

"In memory of Col. Henry Neill who died Nov. 10, 1803, aged 61 years, who valued independence, who dared, scorning submission to a foreign yoke, to force deliverance from the oppressor's rod."[†]

Also my will is that the money arising from the sale of my estate and all debts due to me that shall be hereafter received be put out on interest for the use of my three children, to wit; Mary Edward & Fenwick Shephard Stretcher to be equally divided between my said three children, each to have their share as they arrive to age, and in case either of my said children should die under age then his or her part to be equally divided between the survivors. Also I order that my negro Ceasar be kept for the use of my children and each to have an equal part in him, and whereas my son Edward in right of his Des'd mother may claim Two Shares in a Tract or parcel of Land and Marsh Scituate on pothooks Creek my will is in case he do

it, that as much as one equal part of said land and marsh amounts to, be deducted out of his share of the other part of my estate and given to my Two other Children, And I make and ordain David Hall and Shepard Kollock joint Executors of this my Will for the purposes herein contained.

Jacob Kollock, William Armstrong and Caesar Rodney were appointed to superintend the printing of the twenty-seven thousand pounds, the bills varying from one to twenty shillings."

Margaret Ellis, the second wife of Col. Kollock, died at Lewes, 1790. Her will, dated Nov. 28, 1789, and probated Feb. 8, 1790, is recorded at Georgetown.* Col. Jacob Kollock died Feb. 7, 1772. His will, dated Feb. 17, 1767, with codicil dated June 4, 1771, was probated Feb. 21, 1772, and is recorded at Georgetown.[†]

He was buried at St. Peter's Church Ground, Lewes, and the following is a copy of his epitaph:

"Here lies the body of Jacob Kollock Sen^r Esq., who departed this life on the 7th day of February 1772, in the 80th year of his age. He was several years Speaker of the House of Assembly of which he was a member for the County of Sussex upwards of fourty years. His advanced age little assuaging the great loss sustained in him by his Family in a kind husband and tender father and by the Publick in a friend."

"On the 7th of last Month departed this Life, at Lewes-Town, in the County of Sussex, in the 80th year of his age, after a long and tedious illness, which he endured with great Fortitude, and Christian Resignation, Jacob Kollock, Esq.; who for upwards of forty years was annually chosen one of the Representatives in Assembly for said county; and, for the same length of time, he was President of the Court of Common Pleas, a Trustee of the Loan Office, Register of Wills, Clerk of the Orphans' Court, and Treasurer of the County; all which Offices he executed with great reputation: And in the various stations of private life his conduct was irreproachable; he was an affectionate husband and father, a faithful friend, and a kind master. His steady perseverance in a virtuous course of life, rendered him deservedly beloved by all his acquaintance."

"THE LOST OFFICERS.

SKETCHES OF THE BRAVE MEN WHO WENT DOWN ON THE AMERICAN VESSELS.

WASHINGTON, March 80.

Captain Cornelius M. Schoonmacher, commander of the Vandalia, who was drowned, was a New Yorker, and was born February 2, 1839. He was appointed an acting midshipman at the United States Naval Academy, Annapolis, on September 28, 1854, and graduated as midshipman June 9, 1859. He served in the squadron on the west coast of Africa in 1859-60, and from May to September, 1861, was on the steam frigate Minnesota, bearing the flag of Flag Officer S. H. Stringham, which participated in the fights with Forts Hatteras and Clarke and captured them. He was sailing-master of the Minnesota in August, when about 700 prisoners were taken. He was promoted to lieutenant on August 31, 1861, and was detached from the Minnesota in September. From November, 1861, to July, 1863, he was executive officer of the gunboat Wyandotte, of the South Atlantic Blockading Squadron, and from October, 1862, to March, 1864, held the same position on the steamer Octorara-one year in Rear-Admiral Wilkes' Flying Squadron and the rest of the time in the West Gulf Blockading Squadron, blockading off Mobile Bar. He was then transferred to the monitor Manhattan and was her executive officer from May to September, 1864. While on board this vessel he participated in the passing of the forts in Mobile Bay, in the fight with and capture of the iron-clad steamer Tennessee and other Confederate gunboats and the capture of Forts Morgan and Gaines on August 14, 1864. From September to December, 1864, he was executive officer of the gunboat Augusta, convoying Aspinwall steamers, and in March, 1865, he was ordered as executive officer of the Catskill, Charleston Harbor. In June, 1865, he was ordered as navigator of the steamer Juniata, at Port Royal, South Carolina, and sailed for the Brazil Squadron. He served one year as navigator and another as executive officer.

On December 24, 1865, he was commissioned as lieutenant commander, and in October, 1867, was ordered as navigator of the steam frigate Piscataqua, afterwards called the Delaware, bearing the flag of Rear-Admiral S. C. Rowan. They joined the Atlantic Squadron, and upon the arrival at the station he became the executive officer, and held the position until the end of the cruise. He returned to New York in November, 1870, and from January to May, 1872, was in charge of torpedo instruction at Newport, R. I. From May, 1872, to September, 1873, he commanded the steamer Frolic, bearing the flag of Vice-Admiral Rowan, U.S.N. In May, 1873, he went to St. Johns, New Foundland, and received and conveyed to Washington the part of the crew of the Polaris taken from an ice floe. From September, 1873, to October, 1874, he was navigation officer at the Navy-Yard, New York. He was commissioned as commander February 14, 1873, and in December, 1874, was ordered to duty as inspector of the Eighth Light-house District, with headquarters at New Orleans. On October 7, 1886, he was commissioned as captain. He took charge of the Vandalia on April 5, 1888, succeeding Captain Henry L. Howison."
