Plaintiffs object to the tactics of Defendants in seeking to impugn Robert
Warshaw, one of Plaintiffs' candidates for Monitor. Defendants' counsel were
provided the name of Mr. Warshaw four weeks ago as one of Plaintiffs' candidates, as
part of an attempt to find agreement on a candidate. Defendants informed Plaintiffs
that they were interested in the possibility of Mr. Warshaw serving as monitor and
would contact Mr. Warshaw as part of their diligence. Plaintiffs' counsel spoke with
Mr. Warshaw and he agreed to make himself fully available for discussion with
Defendants. Defendants put off two meetings with Plaintiffs on the ground that they
had not yet attempted to reach Mr. Warshaw. Defendants raised no negative
information about Mr. Warshaw, nor did they seek input on any of the news media
stories about Mr. Warshaw. Today, hours before the Court's deadline for submitting
written information on the candidates, Defendants present the Court with several news
media reports of unfounded accusations and allegations involving Mr. Warshaw and
family members. Mr. Warshaw will discuss all of these accusations and allegations
with the Court in his interview with the Court. Given the timing and circumstances of
this submission and that fact that Mr. Warshaw is presently out of the country, at this
time no other written submission will be submitted in response to these news media
reports.
