3 therefore, the Court issues the following Order:


4 1. Life Insurance Company of the Southwest's ("LSW") brief in

11 memorandum of law in support of their Class Motion shall not exceed **twenty**
12 pages in length, excluding indices and exhibits.

13 3. The hearing on Plaintiffs' Class Motion shall be set for Monday,
14 September 10, 2012 at 1:30 p.m.
