16 **NOTICE OF DEFAULT**

17 Defendant Obama was served with this legal action on 09.11.2012. Defendant
18 Obama was sued as a private individual, as a candidate for office. He was served
19 both at his residence and a courtesy service was made through the U.S. Attorney's
20 office.(exhibit 1)

21 In a Meet and Confer with the Assistant U.S. Attorney David DeJute and Roger
22 West, U.S. attorneys confirmed that the U.S. Attorney's office will not be
23 representing defendant Obama in this case, as he is being sued as an individual, a
24 candidate for office and not as a federal employee. Assistant U.S. Attorneys
25 advised undersigned attorney the Defendant Obama will have to hire his own
26 private attorney. Since Obama was sued as an individual, he was obligated to file
27 an answer within 21 days from the day of service, which means that he had to file
28

1 an answer by October 2nd. Defendant Obama did not file any answer for 34 days,
2 therefore he is in default for 13 days.


