The court has reviewed the applicable legal standards and, good cause appearing, 21 22 concludes that it is appropriate to adopt the proposed Findings and Recommendations in full. 23 Accordingly, IT IS ORDERED that: 24 1. The proposed Findings and Recommendations filed November 30, 2011, are 25 ADOPTED;

1	2. The Sheriff's Department and Zender's motion to dismiss, Dckt. No. 37-1, is
2	granted in part and denied in part, as follows:
3	a. Zender's motion to dismiss plaintiff's § 1983 Fourth Amendment
4	individual liability claims against him is denied;
5	b. The Sheriff's Department's motion to dismiss plaintiff's § 1983 Fourth
6	Amendment claims against it is granted, and plaintiff's § 1983 municipal liability claims are
7	dismissed with leave to amend;
8	c. The Sheriff's Department and Zender's motion to dismiss plaintiff's
9	conspiracy claim is granted with leave to amend;
10	d. The Sheriff's Department and Zender's motion to dismiss plaintiff's
11	racial profiling claim is granted without leave to amend; and
12	e. The Sheriff's Department and Zender's motion to dismiss plaintiff's
13	remaining state law claims under 28 U.S.C. § 1367 is denied.
14	3. The parties are instructed as follows:
15	a. If plaintiff seeks to amend his complaint to attempt to state a claim for
16	municipal liability under § 1983 and/or to attempt to state a claim for conspiracy, as provided
17	herein, any such amended complaint shall be filed within thirty days of this order and shall be
18	labeled "Fourth Amended Complaint."
19	b. If plaintiff elects to file a fourth amended complaint, the Sheriff's
20	Department and Zender shall file a response thereto within fourteen days from the date such
21	complaint is filed, and if plaintiff does not elect to file a fourth amended complaint, they shall
22	file an answer to the third amended complaint within fourteen days from the date plaintiff's
23	deadline for filing a fourth amended complaint expires.
