Plaintiffs have demonstrated that they are likely to succeed on the merits of their claim that
California Penal Code section 26820 violates their First Amendment rights. Plaintiffs have also
established that this harm is irreparable, the balance of equities weighs in their favor, and
injunctive relief will promote the public interest. Therefore, the Court finds that Plaintiffs' Motion
for a Preliminary Injunction should be GRANTED.

Because Defendants will not suffer monetary hardship by the issuance of the preliminary injunction and because the matter involves a constitutional violation, the Court will require a nominal bond in the amount of \$1.

IT IS THEREFORE ORDERED that Defendants are hereby enjoined from enforcing California Penal Code section 26820 until this Court orders otherwise.
