Pursuant to the Bankruptcy Code, the filing of a bankruptcy petition operates as an automatic stay of all judicial actions pending against the debtor. 13 14 See 11 U.S.C. § 362(a)(1). Accordingly, this action is STAYED pending resolution of Defendants' Petitions before the bankruptcy court. 15 16 To mange its docket, the Court finds good cause to administratively close this case while the stay is in effect. Any party may seek to lift the stay and reopen the case after the bankruptcy 17 18 proceedings have been resolved. In addition, the Court DENIES Defendant Power Ventures' First Motion for Reconsideration² as premature.
