1	Pending before the Court is Defendants' Motion for an Order Requiring the Government		
2	to Specify Key Documents. After considering the papers submitted by counsel, the applicable		
3	law, the relevant pleadings and papers on file in this action, and the arguments of counsel, and		
4	good cause appearing therefor, Defendants' Motion is GRANTED.		
5	The Court orders the Government, no later than thirty (30) days from the date of this		
6	Order, to produce and identify the key documents that the Government intends to use in its case-		
7	in-chief that are relevant to the current indictment. Thereafter, the Government is required to		
8	supplement its list of key documents on a rolling basis, within thirty (30) days of the production		
9	of new discovery.		
10	The Government's key documents production shall include at a minimum: (1) all		
11	documents defining the alleged trade secrets; (2) the USAPTI plans and documents alleged to		
12	contain trade secrets; (3) the contracts and other business documents defining the relationships		
13	between and among the parties; (4) documents demonstrating participation of a foreign		
14	government or instrumentality; and (5) documents that the Government contends show a		
15	conspiracy or wrongful intent on any individual's part.
