CASE MANAGEMENT CONFERENCE AND CORRESPONDING DATES

1 WHEREAS, on January 2, 2013, the Court continued the Case Management Conference
2 scheduled for January 11, 2013;

3 WHEREAS, on January 2, 2013, the Court further ordered counsel for Defendants to
4 meet and confer with the court-appointed lead counsel for lead plaintiff within fourteen days
5 after the Court makes its appointment to discuss a new case management conference date and
6 submit to the Court the proposed date, along with proposed dates for the filing of the
7 consolidated amended complaint and Defendants' response thereto;

8 WHEREAS, on January 23, 2013, the Court appointed David Fee as Lead Plaintiff and
9 approved Lead Plaintiff's selection of counsel, *i.e.*, Newman Ferrara LLP and Berman
10 DeValerio;

11 WHEREAS, between January 29, 2013 and February 7, 2013, Plaintiff's counsel and

14 THEREFORE, IT IS HEREBY STIPULATED AND AGREED among the undersigned


ORDER
