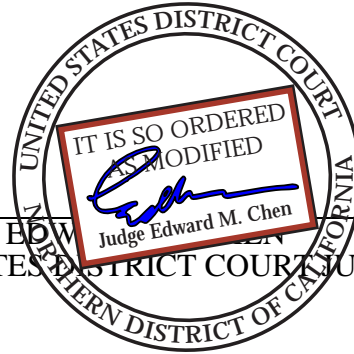
1 This matter comes before the Court on the administrative motion to seal Plaintiffs' Third
