

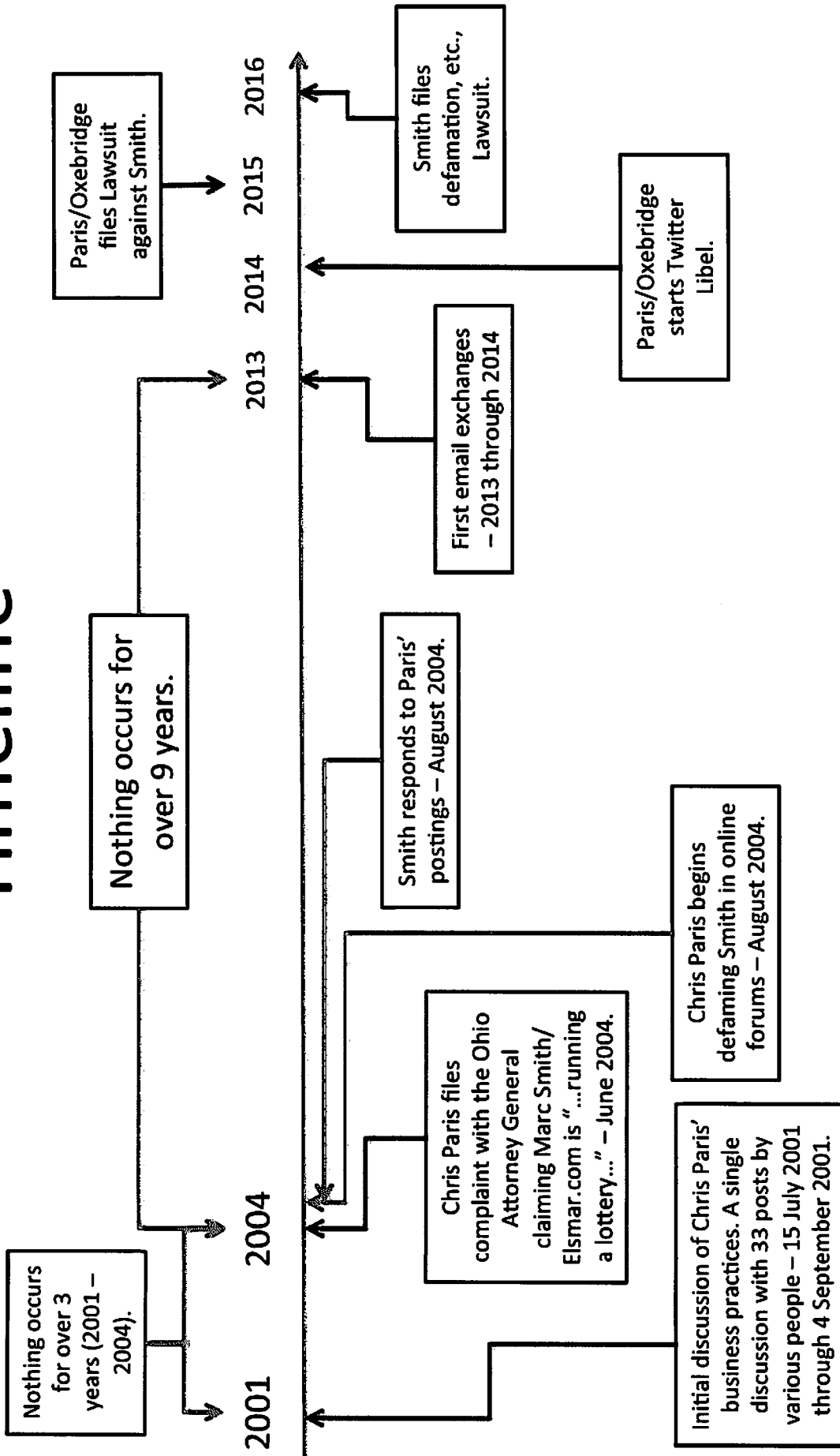

The following is a detailed official statement from Oxebridge regarding its extortion lawsuit against Marc Smith and Elismar.com. Oxebridge will be seeking its comments on the matter and the cost to be resolved. This started in 2001, and 1899. Prior to 2001, other fraud activities related to Marc Smith's work. Since 1998, Christian Business Systems owner Marc Smith has actively recruited Oxebridge and myself of fraud and Oxebridge advertising, among other false accusations. Throughout that time, we tolerated this, out of respect for Elismar's guests. However, in 2014, Smith began to exclude the fraud campaign after Oxebridge refused his demand to pay him \$150,000. Oxebridge views this as nothing less than fabric extortion. Worsening matters, a supporter of Elismar — who I heard is a convicted felon — had threatened to call an Oxebridge client with the intent of defaming us through that medium. In fact, these two actions concerned people we much for us to hear. I find of Oxebridge? You have got to be kidding me! Oxebridge has never posted a single word on the Elismar site, in the entire period. Any one would, in addition, we have never run a single article on Elismar news on the Oxebridge site, despite Elismar being central to certain investigations over Oxebridge with consultants. We have consistently worked to keep Marc Smith and Elismar at arms length, in the hopes that he would end his fraud campaign. It clearly did not work.

We understand the difference between defamation — which is illegal — and free speech and opinions, which are protected under the US Constitution. However, the posts made by Smith and his moderators breach the definition of free speech by being (a) false, (b) posted with malicious intent, and (c) intended to cause harm. **Who is this convicted felon?**

The combination of extortion and threats by a convicted felon against Oxebridge clients was too much. A cease and desist letter was sent to Smith, who responded — on his website — by raising the demand to \$2 million.

Over the years, the actions have not been called into question by any of Elismar's moderators, many of whom have actively participated in the defamation. Perhaps not coincidentally, these moderators are also authors or sales representatives of major ISO 9001 certification bodies who resent the reporting done by Oxebridge. These individuals include Harold Doby of IAT, Jennifer Riley of UL, Nancy Morris of DNV, and Andy Nichols of HQM-USA. Moreover, all four of these CD receive advertising space on the Elismar site, raising questions as to whether IAT, UL, DNV and HQM have breached the ISO 17021 prohibition against promoting one consultant, while actively denigrating and defaming activities against a consultant that did not offer them such perks. Oxebridge filed and seeking unbounded, chasteed accusations they need against the well to see what exists.

It is not our intent to shut down Elismar, which has served the quality profession well in the past decade, despite the misbehavior of its owner. However, potential federal felonies cannot go unpunished, and Oxebridge intends to ensure that this stops. We have exhausted all means of working with Smith on the issue, and have finally had to resort to using the courts.

Smith was forced to simply remove the offending materials and cease all such activity. The problem could be resolved quickly, and Elismar users would be entirely unaffected. Based on the past 15 years of behavior, we feel that is unlikely. **However, A very public offer to "settle" seems would only blindfold!**

In the coming days and weeks, Smith will no doubt return to his old habits, and post with increased frequency on unprecedented amount of new defaming material. We know this, and are ready to withdraw it. Predicting this, we have already begun to push for an immediate temporary injunction. The new material will be added to the existing court complaint.

We intend to push for a firm resolution to this problem, including the pursuit of criminal charges against Smith and his collaborators. We have already not ruled out actions against IAT, UL, DNV, and HQM-USA for allowing their representatives to contribute to defamation and extortion.
