- 5. The debtor shall immediately pay to the Clerk, U.S. Court, Flagler Waterview Bldg, 1515 N Flagler Dr, Rm 801, West Palm Beach FL 33401, \$306.00 for the balance of the filing fee as required by Local Rule 1017–2(E). Any funds remaining with the trustee shall be applied to this balance and the trustee must dispose of any funds in accordance with the Bankruptcy Code and, if a chapter 12 or 13 case, Local Rule 1017–2(F), unless otherwise ordered by the court. Payment must be made in cash, money order or cashier's or "official" check. The court will not entertain a motion for reconsideration of this order unless all unpaid fees are paid at the time the motion is filed.
