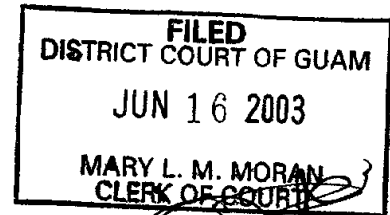

19 COMES NOW Plaintiff Shell Guam, Inc. and alleges as follows:

- 21 1. That on June 16, 2003, the above captioned case was filed to foreclose a maritime
- 22 lien.
- 23 2. Plaintiff Shell Guam, Inc. is entitled to an order for, and arrest of, the M/V Gyoko
- 24 Maru No. 18.
- 25 3. That the Vessel Gyoko Maru No. 18 is presently located in the Port Authority of
- 26 Guam, Piti, Guam USA.

5 WHEREFORE, Plaintiff Shell Guam, Inc. moves the Court, pursuant to Supplemental
6 Rules C(3) and E(4) and Local Admiralty Rule E(3) for an order as follows:

7 1. Authorizing and directing the Clerk of this Court to issue a Warrant for Arrest of
8 the Vessel Gyoko Maru No. 18.

9 2. Directing the United States Marshall to serve the Warrants for Arrest as provided
10 by law.

11 3. Appointing Captain Jurgen Unterberg to act as custodian and to take possession of
12 the Vessel Gyoko Maru No. 18.

13 4. Providing that the sole responsibility of the United States Marshall is to serve the
14 Warrant for Arrest and that the United States Marshall shall have no responsibility or liability
15 respecting the custody of the Vessel Gyoko Maru No. 18.
