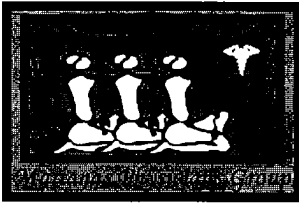
6 5. I underwent a biopsy on May 25, 2005. That biopsy revealed that I have
