I conclude that the following facts require the detention of the defendant pending trial in this case. Part I - Findings of Fact (1) I find that: ☐ there is probable cause to believe that the defendant has committed an offense ☐ for which a maximum term of imprisonment of ten years or more is prescribed in 21 U.S.C. § 841 or ______; ☐ under 18 U.S.C. § 924(c). (2) I further find that the defendant has not rebutted the presumption established by finding that no condition or combination of conditions will reasonably assure the appearance of the defendant as required and the safety of the community. **Alternative Findings** ☐ I find that the government has established by a preponderance of the evidence that there is a serious risk that the defendant will not appear. I find that the government has established by clear and convincing evidence that there is a serious risk that the defendant will endanger the safety of another person or the community. The defendant is committed to the custody of the Attorney General or his designated representative for confinement in a corrections facility separate, to the extent practicable, from persons awaiting or serving sentences or being held in custody pending appeal. The defendant shall be afforded a reasonable opportunity for private consultation with defense counsel. On order of a court of the United States or on request of an attorney for the Government, the person in charge of the corrections facility shall deliver the defendant to the United States Marshal for the purpose of an appearance in connection with a court progeeding.
