(d) Moreover, the prison is not making available (in the course of a considerable amount of time) components of typewriters to be purchased by Pro Se litigant inmates for their legal works. (c) The defendants counsel is not returning (as instructed by plaintiff) the "Affirmation of Service" forms joined to documents served by mail by the plaintiff, to be used as proof of service on the copies of the same documents to the clerk of this court. For, in Person Service of the plaintiff's litigation documents to the corporation counsel is necessary (while he is incarcerated).

2. EXPLAIN WHY YOU FEEL YOU NEED A LAWYER IN THIS CASE. (a) The plaintiff is incarcerated since August 22, 2007 under false accusations that had not been materialized after trial. However, under minor considerations he is still incarcerated; the release of Rodolphe Noguon and the release of the case (docket # 07 Cr. 814(JFK)) for which he had been incarcerated, from the district court to the court of appeals (for the minor considerations at issue) may be held for a long period of time. (b) At MCC-New York (the prison where Rodolphe Noguon is held) Pro Se litigant inmates must pay to make copies and type documents; the lack of income makes the production of litigation documents impossible for him.
