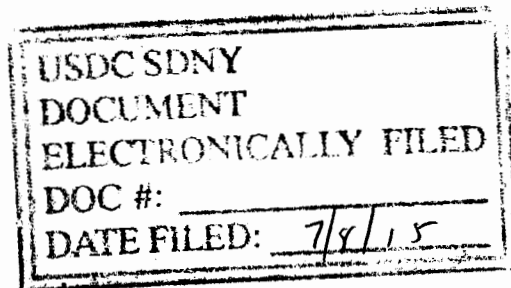

the following amended briefing schedule:


- The Republic shall have until July 17, 2015, to serve responsive papers.

We respectfully request that the Court so-order the proposed schedule.


