

# ORDER MODIFYING PLAN, AWARDING ATTORNEY COMPENSATION, AND RESOLVING THE CHAPTER 13 TRUSTEE'S MOTION TO DISMISS

Upon considering the Debtors' Motion to Modify Confirmed Plan and Request for Compensation filed in the above-captioned bankruptcy proceeding on April 10, 2017, the following findings of fact are based on representation of counsel:

- 1. The Amended Motion to Modify Plan was filed on April 10, 2017, and served on all parties in interest pursuant to Local Bankruptcy Rule 9007-1, as evidenced by the Certificate of Service filed that same day.
- 2. The last date for filing objections was May 1, 2017, which has passed with no objection to the Motion being served and filed.
- 3. As no objections have been served and filed within the prescribed time period, the motion should be granted.

Based on the above findings and for other good cause being shown, the following is hereby **ORDERED**:

1. Debtor is to be treated as current on her plan payments through March, 2017.

2. Debtor's plan payment of \$754.00 shall resume in April, 2017, and that further her Chapter 13 Plan payment be adjusted to \$27,100.00 in the month of December, 2017, and then readjusted to \$754.00 per month, beginning in January, 2018 and continuing for the remainder of the Chapter 13 Plan, to allow for the Debtor to pay 100% of the allowed unsecured claims in her case.

- 3. The base of Debtor's plan is to be reduced accordingly so that the plan remains feasible.
- 4. If Debtor's home is not sold by December 31, 2017, Debtor shall file a motion to modify to surrender her home or to withdraw funds from her retirement account.
- 5. Debtor's counsel will receive \$500.00 for services rendered in this matter, to be paid at the rate of \$75.00 per month through the plan pursuant to the Chapter 13 Guidelines and without the necessity of filing a fee application.
- 6. This Order further resolves the Chapter 13 Trustee's Motion to Dismiss, etc. filed as Doc. 49 on February 1, 2017.
