AMENDED PLEA AGREEMENT

General Provisions

This PLEA AGREEMENT is made this 2000 day of Amount,

Defendant, JOSEPH MEEK, and Defendant's attorney, Deborah B.

Barbier.

IN CONSIDERATION of the mutual promises made herein, the parties agree as follows:

The Defendant agrees to plead guilty to Count 1 and 2 of the Indictment now pending, which charges "Misprision of a Felony," a violation of Title 18, United States Code, Section 3 (Count 1) and "Making a False Statement," a violation of Title 18, United States Code, Section 1001 (Count 2).

In order to sustain its burden of proof, the Government is required to prove the following:

Count 1

- a. The principal committed a felony;
- b. the defendant had knowledge of the commission of that felony;
- c. the defendant failed to notify the authorities; and
- d. the defendant took did an affirmative act to conceal the crime.

The penalty for this offense is:

A maximum imprisonment of three years, a fine of \$250,000, supervised release of one year, and a special assessment of \$100.

Count 2

- a. The defendant made a statement;
- b. the statement was false;
- c. the statement was material;
- d. the defendant acted knowingly and willfully; and
- e. the statement pertained to a matter within the jurisdiction of the executive branch of the United States government

The penalty for this offense is:

A maximum imprisonment of five years, a fine of \$250,000, supervised release of three years, and a special assessment of \$100.

and agrees that monetary understands 2. Defendant The penalties imposed by the Court are due immediately and subject to enforcement by the United States as civil judgments, pursuant to 18 USC § 3613. The Defendant also in accordance with payments made understands that installment schedules set by the Court are minimum payments only and do not preclude the government from seeking to enforce the judgment against other assets of the defendant at any time, as provided in 18 USC §§ 3612, 3613 and 3664 (m).

The Defendant further agrees to enter into the Bureau of Prisons Inmate Financial Responsibility Program if sentenced to a term of incarceration with an unsatisfied monetary penalty. The Defendant further understands that any monetary penalty imposed is not dischargeable in bankruptcy.

A. Special Assessment: Pursuant to 18 U.S.C. §3013, the Defendant must pay a special assessment of \$100.00 for each felony count for which he is

- convicted. This special assessment must be paid at or before the time of the guilty plea hearing.
- B. Fines: The Defendant understands that the Court may impose a fine pursuant to 18 U.S.C. §§ 3571 and 3572.
- Defendant understands that the obligations of 3. Agreement are expressly the Plea Government within contingent upon the Defendant's abiding by federal and state laws and complying with any bond executed in this case. In the event that the Defendant fails to comply with any of the provisions of this Agreement, either express or implied, the Government will have the right, at its sole its obligations under this election, to void all of Agreement and the Defendant will not have any right to withdraw his plea of guilty to the offense(s) enumerated herein.

Cooperation and Forfeiture

4. The Defendant agrees to be fully truthful and forthright with federal, state and local law enforcement agencies by providing full, complete and truthful information about all criminal activities about which he has knowledge. The Defendant must provide full, complete and truthful debriefings about these unlawful activities and must fully

disclose and provide truthful information to the Government including any books, papers, or documents or any other items of evidentiary value to the investigation. The Defendant must also testify fully and truthfully before any grand juries and at any trials or other proceedings if called upon to do so by the Government, subject to prosecution for perjury for not testifying truthfully. the Defendant to be fully truthful and failure of forthright at any stage will, at the sole election of the Government, cause the obligations of the Government within this Agreement to become null and void. Further, it is expressly agreed that if the obligations of the Government within this Agreement become null and void due to the lack of truthfulness on the part of the Defendant, the Defendant understands that:

- a. the Defendant will not be permitted to withdraw his plea of guilty to the offenses described above;
- b. all additional charges known to the Government may be filed in the appropriate district;
- c. the Government will argue for a maximum sentence for the offense to which the Defendant has pleaded guilty; and

- d. the Government will use any and all information and testimony provided by the Defendant pursuant to this Agreement, or any prior proffer agreements, in the prosecution of the Defendant of all charges.
- such polygraph submit to 5. Defendant agrees to examinations as may be requested by the Government and agrees that any such examinations shall be performed by a polygraph examiner selected by the Government. Defendant further agrees that his refusal to take or his failure to pass any such polygraph examination to the Government's Government's will result, at the satisfaction discretion, in the obligations of the Government within the Agreement becoming null and void.
- self-incriminating 6. The Government agrees that any information provided by the Defendant as a result of the cooperation required by the terms of this Agreement, although available to the Court, will not be used against the Defendant in determining the Defendant's applicable guideline range for sentencing pursuant to Sentencing Commission Guidelines. The provisions of this paragraph shall not be applied to restrict any information:

- a. known to the Government prior to the date of this Agreement;
- b. concerning the existence of prior convictions and sentences;
- c. in a prosecution for perjury or giving a false statement; or
- d. in the event the Defendant breaches any of the terms of the Plea Agreement.
- the Defendant cooperates pursuant to 7. Provided the provisions of this Plea Agreement, and that cooperation is providing substantial by the Government as assistance in the investigation or prosecution of another person, the Government agrees to move the Court for a downward departure or reduction of sentence pursuant to United States Sentencing Guidelines \$5K1.1, Title 18, United States Code, § 3553(e) or Federal Rule of Criminal Procedure 35(b). Any such motion by the Government is not binding upon the Court, and should the Court deny the motion, the Defendant will have no right to withdraw his plea.

Merger and Other Provisions

8. The Defendant represents to the court that he has met with his attorney on a sufficient number of occasions and for a sufficient period of time to discuss the Defendant's case

and receive advice; that the Defendant has been truthful with his attorney and related all information of which the aware pertaining to the case; is his attorney have discussed possible and Defendant the Indictment any, to the charges in defenses, if including the existence of any exculpatory or favorable evidence or witnesses, discussed the Defendant's right to a public trial by jury or by the Court, the right to the assistance of counsel throughout the proceedings, the right to call witnesses in the Defendant's behalf and compel their attendance at trial by subpoena, the right to confront and cross-examine the government's witnesses, the Defendant's right to testify in his own behalf, or to remain silent and have no adverse inferences drawn from his and that the Defendant, with the advice of silence; counsel, has weighed the relative benefits of a trial by jury or by the Court versus a plea of guilty pursuant to this Agreement, and has entered this Agreement as a matter of the Defendant's free and voluntary choice, and not as a result of pressure or intimidation by any person.

9. The Defendant is aware that 18 U.S.C. § 3742 and 28 U.S.C. § 2255 afford every defendant certain rights to contest a conviction and/or sentence. Acknowledging those rights, the Defendant, in exchange for the concessions made by the

Government in this Plea Agreement, waives the right to contest either the conviction or the sentence in any direct appeal or other post-conviction action, including any proceedings under 28 U.S.C. § 2255. (This waiver does not apply to claims of ineffective assistance of counsel, prosecutorial misconduct, or future changes in the law that affect the defendant's sentence. This Agreement does not affect the rights or obligations of the Government as set forth in 18 U.S.C. §3742(b). Nor does it limit the Government in its comments in or responses to any post-sentencing matters.)

- 10. The Defendant waives all rights, whether asserted directly or by a representative, to request or receive from any department or agency of the United States any records pertaining to the investigation or prosecution of this case, including without limitation any records that may be sought under the Freedom of Information Act, 5 U.S.C. § 552, or the Privacy Act of 1974, 5 U.S.C. § 552a.
- 11. The parties hereby agree that this Plea Agreement contains the entire agreement of the parties; that this Agreement supersedes all prior promises, representations and statements of the parties; that this Agreement shall not be binding on any party until the Defendant tenders a plea of guilty to the court having jurisdiction over this matter;
