PRAYER FOR RELIEF

CiCi's denies that Plaintiff is entitled to any of the requested relief and denies any allegations and/or averments in Plaintiff's prayer for relief.

DEMAND FOR JURY TRIAL

CiCi's admits that Plaintiff has demanded a jury trial. To the extent that this paragraph contains any allegations and/or averments directed to CiCi's, they are denied.

CICI'S AFFIRMATIVE DEFENSES

Upon information and belief, CiCi's alleges and asserts the following defenses, affirmative or otherwise, without assuming any burden of proof that it would not otherwise have. In addition to the affirmative defenses described below and subject to its responses above, CiCi's specifically reserves all rights to allege additional defenses that become known through the course of discovery.

FIRST AFFIRMATIVE DEFENSE: Non-Infringement

CiCi's does not infringe and has not infringed any claim of the '474 patent, directly, indirectly, and/or in any alleged way.

SECOND AFFIRMATIVE DEFENSE: Invalidity

The claims of the '474 patent are invalid for failure to satisfy one or more of the requirements of Title 35 of the United States Code, including but not limited to §§ 101, 102, 103, and/or 112, *et seq*.

THIRD AFFIRMATIVE DEFENSE: Waiver, Acquiescence and/or Consent

Plaintiff's claims of infringement under the '474 patent are barred, in whole or in part, by the doctrines of waiver, acquiescence and/or consent.

FOURTH AFFIRMATIVE DEFENSE: Laches

Plaintiff's claims of infringement under the '474 patent are barred, in whole or in part, by the doctrine of laches.

FIFTH AFFIRMATIVE DEFENSE: Estoppel

Plaintiff's claims of infringement under the '474 patent are barred, in whole or in part, by the doctrines of estoppel.

SIXTH AFFIRMATIVE DEFENSE: Bar to Damages

Plaintiff's claims for damages are barred, in whole or in part, under 35 U.S.C. § 286 (six year limitation) and 35 U.S.C. § 287 (marking).

SEVENTH AFFIRMATIVE DEFENSE: Failure to State a Claim

Plaintiff's Complaint fails to state a claim upon which relief can be granted, including, but not limited to, because Plaintiff's Complaint fails to meet the standard for pleading set by the Supreme Court in *Ashcroft v. Iqbal*, *Bell Atlantic Corp. v. Twombly*, and their progeny.

EIGHTH AFFIRMATIVE DEFENSE: No Injunctive Relief

Plaintiff is not entitled to any injunctive relief as it has, at a minimum, an adequate remedy at law and no irreparable alleged injury.

COUNTERCLAIMS

Pursuant to Rule 13 of the Federal Rules of Civil Procedure, CiCi Enterprises, LP d/b/a CiCi's Pizza ("CiCi's") asserts the following Counterclaims against Plaintiff GeoTag, Inc. ("Geotag"):

THE PARTIES

- 1. Counterclaim-Plaintiff CiCi's is a limited partnership organized and existing under the laws of the state of Delaware with its principal place of business located at 1080 W. Bethel Rd., Coppell, TX 75019.
- 2. Counterclaim-Defendant GeoTag purports to be a Delaware corporation with its principal place of business in Plano, Texas.

JURISDICTION AND VENUE

- 3. Subject to its affirmative defenses and denials, CiCi's alleges that this Court has jurisdiction over the subject matter of these Counterclaims under, without limitation, 28 U.S.C. §§ 1331, 1367, 1338(a), 2201, and 2202, and venue for these Counterclaims is proper in this district.
 - 4. This Court has personal jurisdiction over GeoTag.

FACTUAL BACKGROUND

5. In its Complaint for Patent Infringement, GeoTag asserts that CiCi's has infringed the '474 patent. CiCi's denies GeoTag's allegations of infringement and further denies that the '474 patent is valid. Consequently, there is an actual case or controversy between the parties over the non-infringement and/or invalidity of the '474 patent.

COUNT ONE

Declaratory Judgment of Non-Infringement of the '474 Patent

- 6. CiCi's restates and incorporates by reference its allegations in paragraphs 1 through 5 of its Counterclaims.
- 7. An actual case or controversy exists between CiCi's and GeoTag as to whether the '474 patent is not infringed by CiCi's.
- 8. CiCi's seeks a judicial declaration finding that CiCi's has not infringed and does not infringe, directly or indirectly, any claim of the '474 patent.

COUNT TWO

Declaratory Judgment of Invalidity of the '474 Patent

9. CiCi's restates and incorporates by reference its allegations in paragraphs 1 through 8 of its Counterclaims.

- 10. An actual case or controversy exists between CiCi's and GeoTag as to whether the '474 patent is invalid.
- 11. CiCi's seeks a judicial declaration finding that the '474 patent is invalid for failure to meet the conditions of patentability and/or otherwise comply with the requirements of Title 35, including but not limited to, §§ 101, 102, 103, and/or 112.

PRAYER FOR RELIEF

WHEREFORE, Defendant / Counterclaim-Plaintiff CiCi's Enterprises, LP, prays for judgment as follows:

- a. A judgment in favor of CiCi's denying Plaintiff all relief requested in its
 Complaint in this action and dismissing same with prejudice;
- b. A judgment in favor of CiCi's on all of its counterclaims;
- c. A judgment in favor of CiCi's on all of its affirmative defenses;
- d. A declaration that CiCi's has not infringed, either directly or indirectly, any valid claim(s) of the '474 patent;
- e. A declaration that the '474 patent is invalid;
- f. An award to CiCi's of its reasonable costs and expenses of litigation, including attorneys' fees and expert witness fees; and
- g. Such other and further relief as this Court deems just and proper.

DEMAND FOR JURY TRIAL

In accordance with Rule 38 of the Federal Rules of Civil Procedure and Local Rule CV-38, CiCi's respectfully demands a jury trial of all issues triable to a jury in this action.
