18 The Grand Jury Charges:

19 **Count 1**

20 On or about May 16, 2013, in the Eastern District of Washington, the
21 Defendant LEONEL MICHEL VARGAS, being an alien illegally and unlawfully
22 in the United States, did knowingly possess in and affecting commerce, firearms,
23 to wit: a .22 caliber Savage Arms Stevens model 62 rifle, bearing the serial
24 number 0072019; a .22 caliber Herters Guide model revolver, bearing the serial
25 number 108095; a .22 caliber Colt Huntsmen semi-automatic model pistol, bearing
26 the serial number 95589-c, and a 9mm Taurus semi-automatic model PT 92 AFS
27 pistol, bearing serial number TSF71639; which firearms had theretofore been

1 transported in interstate and foreign commerce, in violation of 18 U.S.C. §§
2 922(g)(5), 924(a)(2).

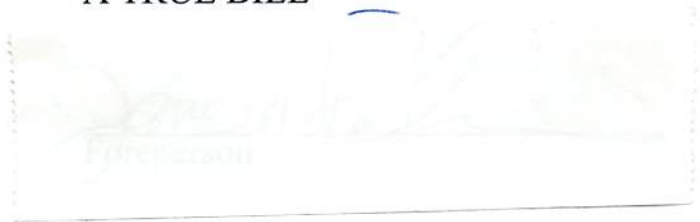
3 **Count 2**

4 On or about May 16, 2013, in the Eastern District of Washington, the
5 Defendant LEONEL MICHEL VARGAS, did knowingly and intentionally possess
6 with the intent to distribute 5 grams or more of actual methamphetamine, a
7 Schedule II controlled substance, in violation of 21 U.S.C. § 841(a)(1),
8 (b)(1)(B)(viii) and 18 U.S.C. § 2.
