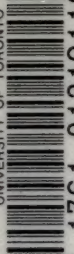

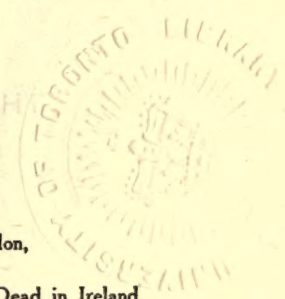

INTRODUCTORY NOTE

The chief object of the "International Genealogical Directory" is to bring into direct touch with one another the many students of Genealogy, Heraldry, Heredity and Topography.

In June 1907, the FIRST EDITION of this Directory was published. It was only a tentative work, intended to test the scheme of genealogical co-operation. It contains contributions from 1,387 students of family history, of whom about 800 will not be found recorded in the Second Edition or the Supplements. Of these 800, the majority dropped out through lack of interest or of the necessary time and in some cases through death. The First Edition should be consulted as it contains much information not to be found in the Second Edition (information which, for the above reason, it would not have been right to re-print), but naturally correspondents must not expect the same results from their communications with the 800, to whom reference is made above, as with those students whose names are recorded in the Second Edition and the Supplements. It was published at 10/6, but, on the publication of the Second Edition, the price was reduced to 3/10, post free. A few copies still remain and are available for contributors to the Second Edition, or its Supplements, at this reduced figure.

In March 1909, the SECOND EDITION was published. It contains the names, addresses and interests of 1,381 students, and should be in the hands of all who consult this present Supplement. In reply to numerous inquiries, I beg to state that there is no intention of reducing the published price (10/9, post free) of the Second Edition; in fact, it is doubtful whether any copies of it will remain soon for sale, as the type, unfortunately, was distributed before the full number of copies was printed, and it is not feasible to re-print it.

The FIRST SUPPLEMENT was published in April, 1909. It is an Index (compiled by Mr. Sherwood) to the Place-names in the Second Edition, and has proved itself already of great value to the few genealogists and topographers who have availed themselves of its help.

The SECOND SUPPLEMENT was published in February 1910. It will be found to be in many ways similar to this, the Third Supplement.

The present work needs no explanation, except that its publication has been considerably delayed through the troubles in the printing trade.

Paragraphs **1** to **1381** refer to the Second Edition. Paragraphs **1382** to **1505** refer to the Second Supplement. Paragraphs **1506** onwards are peculiar to this Supplement.

Thanks are due especially to Thomas Gurney Stedman who has been most energetic in bringing in new contributors.

Now that the Society of Genealogists of London has come into being, I feel that future Editions of this work will be unnecessary, but, if there is any one among my fellow-contributors possessed of an iron constitution who thinks the DIRECTORY might be usefully continued under his Editorship, would he kindly communicate with me. He will find few obstacles placed in his path but I warn my successor that his lot will not be a pleasant one. A tired brain and no spare time from one year's end to another is what he may expect. On the other hand, if he has my experience, he will make hundreds of good friends.

Before relinquishing the editorial pen, I wish to thank heartily the many who have made my task bearable by writing encouraging letters. Without their help this work would never have reached a Second Edition.

INTRODUCTORY NOTE

The following notes from the Second Edition are repeated for the benefit of fresh contributors:—

In the Index :—

Surnames commencing with *d'* (*de, de la, de St., di, du*), *Fitz, F, La (Le), Mac (M', Mc), O' (Ô), U, van (vom, von), zu (zur)* &c., will be found under *D, F, I, L, M, O, U, V, Z, &c.*

All *M'* and *Mc* surnames are arranged as if written *Mac*.

Hyphenated and Continental compound (not hyphenated) names are arranged under the initial letter of each surname, e.g. "*John Dunn-Smith*" would be indexed under *D* as "*Dunn-Smith*" and under *S* as "[*Smith*]."

Surnames commencing with *St.* will be found under *Saint*.

Following the example of the Post Office London Directory, names containing modified vowels are arranged as if the vowel were not modified, e.g., "*Düring*" will be found under "*Dur-*" and not under "*Due-*" as is usual in Continental works of reference.

Dark-type entries refer to the contributors' own surnames; ordinary-type entries refer to the families in which the contributors are interested.

In the Text :—

The * before a surname is an indication that the genealogist has requested that it should be noted that he possesses information which he is willing to impart, but that he does not wish for further data.

The † before a surname is an indication that the genealogist has requested that it should be noted that he desires information about the family, without being able to impart much or any.

The absence of both the * and the † indicates that the genealogist has made no such request, and that therefore he both possesses information about the family named and also desires to add to this data.

LINCOLN RECORD SOCIETY

1593 The Society was founded at a meeting on the 19th of October 1910, the Bishop of Lincoln being in the chair. Its object is to print records and documents relating to Church, parochial, manorial and family history. There is a vast mass of material available in the Diocesan Registry and the Muniment-room of the Dean and Chapter at Lincoln, in the Public Record Office, British Museum and Lambeth Palace Library, in London, and in the possession of various corporations and individuals. There are also the registers of important parishes which it is desirable to print, and there is much that is of interest in ancient wills.

The subscription has been fixed at a guinea a year, for which in return members will be supplied with the publications of the Society. One hundred and thirty-five members have been enrolled, and it is confidently expected that this number will be considerably increased. The larger the membership the more volumes the Society will be able to print. The present number will justify an annual output of two volumes. Since the number of copies printed will be limited, the books may be expected to increase in value as time goes on.

The chief part of the Society's publications will deal with Lincolnshire, but some of the volumes will include matter relating to the counties of Bedford, Buckingham,

Huntingdon, Leicester, and part of Hertford, which were until about 1840 included in the diocese of Lincoln.

The Rev. R. E. G. Cole has offered to edit Gervase Holles' Lincolnshire Church Notes for one of the early volumes of the Society; and an account of the Lincolnshire chantries at the time of their dissolution is nearly ready for the printer. Other volumes will, it is hoped, include ancient correspondence, parish registers, Bishops' transcripts, and calendars of episcopal registers, ecclesiastical visitations, institutions to benefices, final concords, wills, administrations, marriage licenses, charters, deeds, etc.

SUSSEX RECORDS SOCIETY

W.W. Davey, Barbican House, Lewes, sends particulars of this Society of which he is "Clerk and Collector". It was established in 1900 and has, during the ten years of its existence, published eleven volumes. Volume XII., which will be the Volume for 1911, contains the Chichester Marriage Licenses for the Courts of the Peculiars and the Deanery, by Mr. Dunkin. It is in course of being printed. A volume containing the Registers of Cuckfield Parish from 1598 to 1699, copied by Miss Cooper, daughter of the late Canon Cooper, and edited by Mr. Renshaw, will be issued to Members as an extra Volume, numbered Vol. XIII. For 1912 a Volume of Post Mortem Inquisitions is being prepared by Col. Attree.

The annual subscription is 21/-. The Secretary estimates that, in order to cover the expense of transcribing and printing sufficient materials for an annual volume, a sum of at least £100 *per annum* is necessary. With a membership of only about 90 this Society still manages to do excellent work, having received in 1910 donations totalling over £100 from three of its members.

THE BRADFORD HISTORICAL AND ANTIQUARIAN SOCIETY

John A. Chapman, (No. 1537), sends particulars of this Society, of which he is a Vice-President. It was founded in 1878 to promote the study of the Archaeology and History of Bradford and its neighbourhood. In furtherance of its aims the Society arranges—(1) A series of Lectures during the Winter Session. (2) During the summer a number of excursions under competent guides to places of historical interest. (3) The publication of *The Bradford Antiquary*. (4) For the acquirement and conservation of Local Documents, Books, Plans, Genealogical Charts, etc. The Annual Membership fee is 7/6 per annum. Members are elected by the Council. Any person desirous of joining should intimate his wish to the Corresponding Secretary, J. Langdale Gregory, 25, Cheapside Chambers, Bradford.

THE LANCASHIRE PARISH REGISTER SOCIETY

G. P. Townend, (No. 169), a Member of this Society, considers that the following particulars, compiled and issued by Henry **Brierley**, (No. 1408), as Hon. Sec. of the Society, should be given a wider circulation. As the exhaustive list of Shropshire Parish Registers, given in the Second Supplement to the Directory under paragraph No. 1478, appears to have been appreciated, the following is here reprinted with much pleasure:—

"This Society has for its object the publication of the *earliest* Registers of Lancashire. Of these commencing prior to 1700, one hundred and eight, counting Penwortham which has been lost by fire, are (or were) known to exist. Taking them in the order of their Hundreds they are as follows:

The sums set opposite each Register are the amounts necessary to print the particular Manuscripts in the Society's form. In cases where no asterisk is put against the Register the cost includes the Society's binding; probably several of the asterisked Registers would be bound in one cover and so save expense.

Having regard to the fact that eight of the Registers already published by the Society, and half of another, have been gifts to the Society by members or friends, it is frankly admitted that **the object of printing this statement is the hope of inducing other members to pay for the publication of any Register** in which they are especially interested.

It is confidently expected that transcripts of all the untranscribed early Registers, in the Salford Hundred at any rate, will be completed during the year 1911.

Of the 108 earliest Registers 43 have been printed and published, one is nearly printed, and 32 transcribed, leaving 18 in the West Derby Hundred and 14 in the remaining Hundreds untranscribed.

THE MANORIAL SOCIETY

Charles Greenwood, F.C.I.S., (No. 1577) sends the Fourth Annual Report (1910) of this Society, of which he is Registrar. With this Report the three previous Reports are reprinted together with a "Statement of the Constitution and objects of the Manorial Society." From this last we see that it is the only Society giving separate organised attention to Manorial records and institutions. Its objects are :—

- (a) The aiding and encouragement of the safe keeping and the study of Court Rolls and other Manorial Records, and the preservation and protection of Manorial rights and privileges.
- (b) The keeping of a Register or Roll of Manors, &c., and of Manorial Lords and Ladies and Stewards, or other chief officials.
- (c) To collect printed books, pamphlets, &c., concerning Manors, &c., and manuscripts, comprising Court Rolls, deeds, and other documents relating thereto : and, when necessary, to cause such manuscripts, &c., to be deciphered, translated, and reproduced ; and also to compile a bibliographical record of Manorial literature.
- (d) To render assistance in obtaining facilities for access to Manorial Court Rolls, with reference to their value as sources of genealogical information, especially as regards periods anterior to the establishment of parish registers.

As regards genealogical work, the Society hopes to compile alphabetical lists or indexes of persons whose names appear in Court Rolls.

Reviews of two publications recently issued by this Society will be found under paragraph numbered 1615.

THE SOCIETY OF GENEALOGISTS OF LONDON

George **Sherwood**, (No. 28), sends the following particulars of this Society, of which he is the Hon. Secretary, *pro tem*.

Until one of the contributors to the I.G. Directory in May, 1910, put forth in *Notes & Queries* his proposals for the formation of a SOCIETY OF GENEALOGISTS, few people suspected how ripe the time had become for such a scheme. This was followed by the meeting of a small Committee of five, who drafted a circular letter of invitation so that a body of fifty "Founders and Fellows" might be gathered together to provide a fund to incorporate the Society, and to ask the wider genealogical public to offer themselves for election as Fellows, Members or Associates. Soon after the issue of this circular letter fifty representative genealogists signified their hearty approval and contributed to the fund as Founders, and the Marquess of Tweeddale consented to act as President. The Society was accordingly incorporated, without the word "Limited" by licence of the Board of Trade, early in May, 1911, as an "Association not for profit" under the Companies (Consolidation) Act, 1908.

It cannot be denied that societies established for the purpose of printing and distributing record material fail to a large extent in their object, if that be taken to include the ready discovery and verification of facts. A large sum of money is expended, and the result, in printed books of collections and transactions, lies stowed away on dusty shelves to which few possess the key or knowledge requisite to ready access; the great majority has neither the leisure nor the opportunity to reach the vast stores of available material. **The function of The Society of Genealogists is to collect, index, and arrange historical, genealogical, and heraldic evidence for the use of its Members and Associates, and to notify to its Fellows, as it accrues, material of special interest personal to themselves.**

The Society is endeavouring to secure in London, in a central and easily accessible position, offices from which the labours of genealogists, local historians, students of heraldry, &c., in all parts of the country, and indeed in all parts of the world, will be consolidated and directed. The intention is to avoid that overlapping which is inevitable to isolated effort, as well as that somewhat unsatisfactory cultivation of detached fields of research so often pursued without any knowledge of what is being done and what has been done by others to the same end. By the formation of Committees to effect desired objects, and by keeping Members informed of what those Committees are doing, much unnecessary labour must be saved.

The chief object for which the SOCIETY OF GENEALOGISTS is established is—

To promote, encourage and foster the study, science and knowledge of genealogy and topography by all lawful means, and in particular—

- (1) By forming and carrying on a reference and lending library of printed and other works relating to genealogy, topography, history, biography, heraldry, heredity and allied subjects.
- (2) By forming and carrying on a permanent or temporary safe depository for pedigrees, grants of arms and other manuscripts.
- (3) By the preparation and use of indices, on the "slip" or "card" or other systems, to the printed or other collections of or in the possession of the Society, and public records, printed volumes generally, and to general sources of reference, particularly with regard to matters of genealogical, topographical or historical interest to Members and Associates of the Society, and also by the acquisition and use of Government publications, including indices and reports of the Public Record Office, and reports of Royal Commissions.

- (4) By supplying Fellows of the Society and others with advice and information from time to time respecting a limited number of families and places in which such Fellows and other persons may be personally interested.
- (5) By entering into friendly relations with other societies, whether within or without the United Kingdom, having objects wholly or in part similar to the objects of this Society.
- (6) By rendering assistance (other than of a financial nature) to genealogists, whether within or without the United Kingdom, in connection with genealogical, topographical and biographical research.

Ordinary and Life Fellows (whether "Founders and Fellows" or "Fellows by Election") are entitled—

- (1) To receive quarterly from the Society advice of any fresh information accrued respecting certain specified families and places in which they personally may be interested, the number of which is limited by the Executive Committee to ten.
- (2) To have access to all printed works, indexes, manuscripts or "documents" in the library of the Society.
- (3) To borrow printed works from the library of the Society.

SUBSCRIPTIONS

(Ladies may be elected Fellows, Members or Associates).

MEMBERS :—

The Society having been registered under the Companies (Consolidation) Act, 1908, as an "Association not for Profit" *limited by Guarantee* (without the word "Limited" appearing in its title), each Member's liability, in the case of the winding up of the Society, is limited to £2.

The *Members* of the Society consist of three classes :

- (A) "Founders and Fellows". Each of these is paying two guineas per annum, or a Life Composition of ten guineas. No further names can be added to the list of "Founders and Fellows".
- (B) "Fellows by Election" are elected, from among the "Ordinary Members," by the whole body of Fellows (whether "Founders and Fellows" or "Fellows by Election") and pay two guineas per annum, or a Life Composition of ten guineas.
- (C) "Ordinary Members" (called "Members") are elected by the Executive Committee and pay one guinea per annum, or a Life Composition of seven guineas.

ASSOCIATES :—

The *Associates* of the Society are elected by the Executive Committee, have no liability in the case of winding up, and consist of two classes :—

- (A) "Ordinary Associates" (called "Associates") who pay one guinea per annum, but unlike "Members" paying the same subscription, they cannot make Life Compositions for their subscriptions.
- (B) "Corresponding Associates," who must reside at least 25 miles from London. These pay half-a-guinea per annum.

APPLICATIONS FOR MEMBERSHIP

Every application for ordinary membership or for election as an Associate or a Corresponding Associate shall be made in writing, signed by the candidate and by his proposer and seconder, and addressed to the Honorary Secretary of the Society. An Application Form can be obtained from Mr. Sherwood.

- (13) " on Local Records.
- (14) " on Family Associations.

(THE MEASUREMENTS GIVEN ARE APPROXIMATE.)

Henry **Hartopp**, (No. 110), sends a copy of "Leicestershire Parish Registers." Index to the Bishops' Transcripts in the Registry of the Archdeacon of Leicester, 1561 to 1700, embodying the Leicestershire Transcripts in the Registry of the Bishop of Lincoln prior to 1700, Compiled by C. W. **Foster**, M.A., Canon of Lincoln and Vicar of Timberland, (No. 730), and also a List of Leicestershire Parish Registers prior to 1890: Compiled by Henry **Hartopp**, Member of Committee of the Leicestershire Architectural & Archæological Society, (No. 110)". xi, 52 pp., 6 x 10.

We have given the title of this excellent work of reference in full and feel now that it has left us very little more to say about the contents of the volume. To be brief: it is, of course, absolutely indispensable, and genealogists would be in clover if they could have a similar volume for each registry in the country. The arrangement is as clear as it is possible to make it. The work was published in 1910 by Messrs. Clarke & Satchell, 5, Gallowtree Gate, Leicester, at 5/-. Mr. Hartopp has had a few special copies bound in cloth gilt, with gilt top, 4 plates inserted, which he is willing to dispose of at 10/- each. Those who are interested in Leicestershire families would do well to get into touch with Mr. Hartopp. A professional searcher, who knows the Bishops' Transcripts of his locality thoroughly and is willing to search them and local parish registers on reasonable terms, is worth knowing. We are hoping that the new Society of Genealogists will make a list of such men all over the country, but we doubt if there are many who have mastered the subject as well as Mr. Hartopp, otherwise there might be more of these useful volumes on our shelves.

F. C. **Beazley**, F.S.A. (No. 283), sends Vol. LXI of the Historic Society of Lancashire and Cheshire, 1909, xxiii, 230 pp., 5½ x 8¾. This handsome volume makes us desirous of possessing Vols I. to LX. inclusive, though there would scarcely be room for them in our small flat. Judging from Vol. LXI., the whole Series must form an invaluable library for anyone interested in the history of either of these two interesting counties. Space does not permit of a detailed description of the volume sent by Mr. Beazley, but the Table of Contents includes:—"Some Notes on Billinge"; "The Tower of Liverpool, with some notes on the CLAYTON family of Crooke, Fulwood, Adlington, and Liverpool"; "Elizabeth FARREN, Countess of DERBY"; "The Poor Law in Liverpool, 1681-1834"; "Liverpool during the Civil War"; "Selections from the MOORE Papers", etc.

The volume is well printed on good paper and the illustrations are excellent. Above all, there is a perfect index.

F. C. **Beazley**, (No. 283), sends also "The Cheshire Sheaf, Third Series, being local gleanings historical and antiquarian, relating to Cheshire, Chester, and North Wales, from many scattered fields". Edited by him and Wm. Fergusson Irvine, M.A., F.S.A., Vol. VII. January to December 1909, published by the "Chester Courant", Chester, 1910; v, 123 pp., 7½ x 10¼.

This book, which consists of notes and queries reprinted, after revision and correction, from the "Chester Courant", is almost too well known to need mention here. The genealogist who attempts to trace a Cheshire pedigree without consulting the volumes of the "Cheshire Sheaf" should give up pedigree-hunting and turn his attention to some pursuit more adapted to his lack of intelligence. As usual, this invaluable work is splendidly indexed, and is indeed in every way a model of what such a volume should be.

The Rev. A. S. **Hartigan**, (No. 149), sends Number One of "Eyre Notes and Queries," printed in 1910, 4 pp. 8¾ x 11¼, with cover. This pamphlet is an excellent idea which other genealogists would do well to adopt. The Rev. A. S. Hartigan is evidently anxious to awaken an interest in genealogy among members of the EYRE family, and has chosen this method of drawing their attention to his researches. The charm of his scheme lies

in the small expense it entails. Here we have only four pages of family history, attractively arranged and printed, with a note in small type at the end of the fourth page stating that the next issue will contain various further notes about the family and that the compiler "would be glad to receive contributions for insertion in the next number." This is not only a call to other genealogists to help him by searching their notes and sending him any EYRE references they may find among them, but is a sure method of bringing him into touch with those bearing this surname. If a few issues of this pamphlet are sent by its compiler at regular intervals to every EYRE whose address he can find in the County Directories, it will be only a question of time before he receives all the information which it is in their power to send. We would describe the scheme as being a vast improvement on the inquisitorial documents which many genealogists have forwarded to bearers of those surnames in which they are interested. The long list of demands commencing with "*Your name in full*" and ending with "*Any further data you possess about your family*" is certain to annoy 99% of its non-genealogical recipients. On the other hand, a finely-printed pamphlet of the nature of "Eyre Notes and Queries," sent with its Compiler's compliments, should sooner or later result in the receipt of many of those much-desired letters commencing: "*You do not appear to have any details of my branch of the family. My grandfather, etc.*"

Charles Edwin **Booth**, (No. 950), sends "One Branch of the Booth Family, showing the Lines of Connection with One Hundred Massachusetts Bay Colonists"; Price \$ 5.00, post-free; 1604 Privately Printed, New York, 1910; xi, 259 pp. 6¼ x 9½; the index of Names of Persons covers 18 pp. and contains nearly 3000 entries.

Among the families prominently mentioned are the following names of well-known early Massachusetts and Connecticut settlers, viz.:

We offer Mr. Booth our heartiest congratulations on the successful completion of a volume which must take its place immediately as an indispensable work of reference for all who are interested in New England families. The discrimination in the choice of data, the arrangement of the material, the excellent references to "authorities," the thorough indexes, the paper, print and binding leave nothing to be desired. The title, however, does not do the work justice; Mr. Booth might well have called it "A Guide to the Genealogy of New England" as over 500 volumes are quoted in its pages. Certainly no genealogical library in the States would be complete without a copy of this volume.

Most reviewers have "a little way" of searching each page of a volume to find some small point that they can criticise adversely. It shows their own superiority. The writer has the same failing but must confess that a lengthy and microscopic examination of Mr. Booth's volume has resulted in the discovery of only one small point over which he may gloat, viz. the indexing of the "Earl of Warwick" under "E" as well as under "W." Surely this illustrates a reversal of the old adage from "Faint praise damns" to "Faint damning praises."

Byron Barnes **Horton** (No. 989), sends the "Horton Family Year-Book, 1910;" published by the Grafton Press, New York; 32 pp., 4 x 6. This pamphlet is issued for the descendants of Isaac HORTON, (b. 1780; d. 1855), of Liberty, N.Y. In it we find well-arranged particulars of Isaac's direct male ancestry back to his great-great-grandfather, Barnabas HORTON, of Southold, L.I., who was born at Mowsley, Leicester, England, in 1600. Isaac's children and all their living descendants, including his great-great-grandchildren, are then enumerated, and the small work closes with an "Address List." We notice that there is

a Horton Family Association, occasionally holding re-unions, the fifth since 1897 having been held in 1909. These Family Associations, of which there are many in the United States and only a few in Great Britain, are doing excellent genealogical work, and we learn with pleasure that the new Society of Genealogists has formed a Committee whose duty it will be not only to get into touch with the Historians of as many of these Associations as possible and thus preserve and place at the disposal of other genealogists much of the highly-valuable data they have accumulated, but also to aid these Historians in pursuing their investigations into the English descents of their ancestors.

Albert A. **Pomeroy**, (No. 1450), sends "Pomeroy: Romance and History of Eltweed Pomeroy's Ancestors in Normandy and England"; 1909; Price \$1.00; 81 pp., 6 × 9½.

1606 Mr. A.A. Pomeroy is Secretary of the POMEROY Family Association, an American Society for the descendants of Eltweed Pomeroy (b. 1585 at Beaminster, Dorset, England), who settled in America in 1630.

The Association has been successful in tracing the descent of Eltweed from the well-known Pomeroy family of the West of England, and this pamphlet gives in detail the evidences collected in support of this descent. It is described as being only a preliminary compilation but, as such, it is very well produced. The paper, print and illustrations are good, and the general appearance of the work raises high hopes that the promised "Pomeroy Family Book" may be one of the finest family-histories yet published. We trust that it will not be confined to American Pomeroyes and their English ancestors as many of these latter must now be represented by descendants in England, who should be glad to join hands with their Transatlantic cousins in the preparation of a complete history of this great family.

Charles E. **Lart**, (No. 937), sends the first volume of "Jacobite Extracts from the Parish Registers of St. Germain-en-Laye", published 1910 by the St. Catherine Press, Ltd.; Price 21/— per volume; xvi, 176 pp., 6½ × 9¾.

1607 We congratulate Mr. Lart on his "Introduction" which is a fine piece of literature in itself and shows how the dry bones of genealogy may be indeed clothed again with flesh for the searcher who can enter into the spirit of that past which he is investigating.

The work undertaken by Mr. Lart is one which must result in the filling in of many gaps in the pedigrees of Jacobite families. The extracts are, of course, in French and are arranged alphabetically. There is also an Index which, however, is very misleading as it ignores the surnames appearing alphabetically arranged in the work. The hasty searcher might consult this index about some special surname and put the book aside as being of no assistance to him when really it might contain the very information for which he is searching. In fact, not only are those names omitted in the Index which are arranged alphabetically in the text but also those of the female parties to the marriages which are not so arranged. We presume this serious defect will be remedied in the second volume by the inclusion of one complete index to every surname mentioned in the two volumes, but in the meantime it is necessary to warn the searcher that the present index is more likely to mislead than help him. For the same reason this index gives a very poor idea of the number of excellent references contained in Mr. Lart's invaluable work, which certainly should find a place in every genealogical library.

Emilia F. **Noel**, sends "Some Letters and Records of the NOEL Family;" published by the St. Catherine Press, Ltd., and James Nisbet & Co. in 1910; Price 10/6 net; x, 110 pp., 6 × 9½; with "Chart showing the principal owners of Exton since 1055" and seven chart-pedigrees giving the genealogy of the Noel family.

1608 This volume, which deals with the family of the Earls of GAINSBOROUGH, is unlikely to interest the general genealogical public. In support of this statement it is necessary only to quote the opening paragraph of the Preface: "After reading some old letters, written principally in the eighteenth century, the correspondence of three generations of the Noel family, it occurred to me that these letters if printed might afford some interest to other descendants of the writers."

The first 36 pages are devoted to the Records of the main branch of the descent, and the rest of the volume to the Letters. These latter appear to be of quite the usual type and not particularly interesting to the public.

Perhaps a close search through them might reveal many interesting references to historical personages and to old-world customs. Unfortunately there is no index of any kind, so that the reader cannot readily find whether the letters contain what might prove

of value to him. The illustrations, of which there are many, are good and so is the printing, a fact which it is hardly necessary to mention after having noticed that the book is issued by the St. Catherine Press.

The Rev. **Tho. Taylor**, M.A., F.S.A., (No. 1388), sends "A Life of Dr. Taylor;" Price 5/- net; xviii, 150 pp., $5\frac{1}{2} \times 8\frac{3}{4}$; published (? 1910) by the St. Catherine Press, Ltd., and J. Nisbet & Co.

From its title one would scarcely gather that at least two-thirds of this volume may be said to deal with genealogy. Chapter I. is intitled "Dr. Taylor's Parentage" and we all know what "parentage" means when an enthusiastic genealogist like the Rev. Tho. Taylor writes about it. In this case it means twelve pages crammed with genealogical data. Pages 13 to 72 describe Dr. Taylor's Life, Writings and Character. These, though very interesting, we will take leave to consider as the peg on which its author has hung the rest of the work. Pages 73 to 85 bring us back to the really important subject, for these give extracts from Dr. Taylor's will, and from then onwards to the last page (number 150) we have solid genealogy in the shape of an account of the Webster family, followed by a chapter on the arms of the Taylors and Websters and nearly fifty pages of "Appendix" (all pure genealogy, of course), a good "index nominum," and chart pedigrees of TAYLOR and WEBSTER. Excellent original genealogical research is evident throughout the whole work and we congratulate its author not only on this and on the clear manner in which he arranges the result but also on the way in which he has silvered his large genealogical pill by calling it a "Life of Dr. Taylor." By-the-way, before closing this brief notice we feel that we really ought to discover who this Dr. Taylor was. A closer examination of the Preface reveals the fact that he was a "divine who won and retained the friendship of Dr. Johnson." Clever man. He certainly deserves this tribute to his memory.

Elliot Stock, 62, Paternoster Row, London, E.C., sends "How to Trace a Pedigree" by H. A. Crofton; 2/- net; 67 pp., $4\frac{1}{4} \times 6\frac{3}{4}$.

1610

This small volume should appeal to the novice in genealogical research but is too restricted in scope to interest the more advanced students of the subject. To prevent disappointment we would suggest that its title should be changed to "First steps in Genealogy" and that the few obvious mistakes it contains (e. g. pp. 21, 31, etc.) should be corrected in a future edition. Its author evidently had the wish which is father to the thought when he wrote: "*Census Returns* may be consulted."

Wm. Jaggard, (No. 370), sends the "Dunbar Pedigree, a biographical chart tracing descent of the DUNBAR family, through fourteen successive centuries, from the early English and Scottish Kings," $31\frac{1}{2} \times 42$ ".

1611

We congratulate Mr. Jaggard on the very clear arrangement of the data in this chart and the attractive style in which he has produced it. Heading the chart are two views of Dunbar Castle and the Dunbar coat-of-arms, and at the end is a welcome list of "Authorities".

On one side we find the descent from Egbert (the first sole ruler of England, *d.* 839), of Cospatrick, first Earl of Dunbar, son of Maldred by Ealdgyth, grand-daughter of King Ethelred II, and on the other side the descent of Marjory, (who married John Dunbar, who received in 1371-2 the Earldom of Moray) through her father Robert II. from Aidanus, the first Scottish monarch.

In the middle the descent of Sir George Alexander Drummond Dunbar, eighth Baronet of Durn, *b.* 1879, from Cospatrick is clearly set forth.

Ernest Hampden-Cook, M.A., (No. 1455), sends a lithographed "Pedigree of the Hatch-Proctor-Gooch Family, of Norwich," compiled by him in 1910. $29\frac{1}{2} \times 23$.

1612

This pedigree clearly traces all the descendants of a Sarah HATCH (1797-1861) who *md.* John COOK; of her brother, Proctor HATCH; and of their uncle, William Proctor HATCH. It also gives the descent of this HATCH family from the PROCTOR family. There is not much to be found in it about the GOOCH family.

Intermarriages in the direct line are:—HATCH and PROCTOR, 1734; HATCH and Gooch, *abt.* 1790; COOK and HATCH, 1821; COOK and HAYWARD, 1846. Among other surnames appearing in this chart are:—CROSS, SYKES, KING, THORP, CURTIN, STACY, HAYDEN, SHAW and SAMPSON.

G. E. Congdon, (No. 739), sends "One Hundred Thirty-eight Generations from Adam, being a Pedigree traced from Adam to the present time," 1910; 55 pp., $5\frac{1}{2} \times 6\frac{3}{4}$; price 75 cts; 1613 Hiawatha, Kansas. Facing the title-page is a portrait of Mr. Congdon. When we

opened this pamphlet we gazed at his likeness more in sorrow than in anger, though both feelings were present. How could he be guilty of tracing a descent from Adam (!) and how dared he send it to us for mention in these pages? However, his Preface fully exonerates him as he is careful to inform us there that the pedigree from Adam to Kenneth I. of Scotland is presented simply as a matter of curiosity and that he would have no one suppose that he puts any faith in it.

If Mr. Congdon will permit, we will also "skip" from Kenneth I. of Scotland to Edward I. of England. We have no grudge against the good people in between these two, except that they figured in our history books at school. From Edward I. the descent of John WHITNEY, (b. 1592; d. 1673; emigrant to America in 1635), is traced through Agnes de Bohun (granddaughter of Edw. I), five generations of the DE FERRERS family, Katherine DEVEREUX, three generations of the BASKERVILLE family to Sybil Baskerville, who *md.* Sir Robert WHITNEY, and was the great-grandmother of the emigrant.

The grand-daughter of John WHITNEY (1592-1673), Elizabeth Whitney, *md.* Daniel WARREN, and their great-great-granddaughter, Sarah Forbush WARREN, *md.* Rufus ALLEN. Their daughter was Mrs. Laura Warner (Allen) YORK. Her daughter, Mrs. Augusta Alvina (York) CONGDON, is the mother of Mr. G. E. Congdon, the 138th from Adam. Allowing the usual 30 years average for each generation this gives us only, 4,140 years since the Creation. It is just as well that this pamphlet should remind us that Mr. Congdon's direct ancestor, Methuselah, was 187 years old when his son, Lamech, was born!

1614 George N. Mackenzie, (No. 1565), sends some proof-sheets ($6\frac{3}{4} \times 9\frac{3}{4}$) of "Colonial Families of the United States", now in the press. The families are arranged alphabetically. Each section starts with the present head of the family, giving his marriage and issue, with an illustration of his coat-of-arms. These particulars are followed by an account of his lineage. The work should prove a very useful one to Americans, but, as with all such works of reference, it appears to be "compiled from information supplied" by the various families themselves. As not everyone is a genealogist, information thus obtained frequently requires the proverbial grain of salt. It is, of course, impossible for the Editor of "Colonial Families" to verify every pedigree but from the proof-sheets before us we gather that Mr. Mackenzie has managed to avoid the inclusion of many of those fantastic, nonsensical "descents" from imaginary personages which mar some of our British genealogical annuals. There is, however, still room for his blue pencil, *e. g.*, on p. 348, if the words "descended from Alpin, King of Scotland, 834" were deleted, it would add dignity to the MAGRUDER lineage and tie the tongues of the scoffers. The Magruders may be descended from this remote worthy but anyone who has had only six months' experience of tracing pedigrees would say that the "odds" are against their being able to prove a descent of over 1,000 years thus briefly summed up in seven words. Putting such obvious absurdities aside, we may feel thankful to Mr. Mackenzie for preserving and arranging the useful information contained in his volume, which is certainly one which should find a place in every American library.

1615 The Manorial Society, (No. 1577), sends its Monograph No. 4, "List of Manor Court Rolls in Private Hands", Part III., 1910; ii, 23 pp., $8\frac{1}{2} \times 11$.

These lists form a series of indexes to the dates of such of those records as are in the possession of private individuals, or in the custody of the Stewards of the respective Manors, or in that of corporate bodies, and are compiled from information supplied to the Society by these custodians. The names of the Manors are grouped under Counties. To show the genealogical value of these lists we cannot do better than quote from one of the entries in it. On p. 19 we learn that the Manor of Newenham and Lindridge, situate in the parish of Lindridge, Worcestershire, of which Manor the Dean of Worcester was formerly Lord, has 24 Court Rolls (some being only copies) for the dates 1478, 1506, 1515 (2), 1523, 1531, 1556, 1572 (2), 1579, 1581 to 1583, 1586-7, 1589-90 (2), 1610 (5), and 1619, and that the following surnames occur in these Rolls:—

The same Society sends its "Publication No. 3", 1909, "A Mannor and Court Baron" (Harl. MS. 6714); 59 pp., $5\frac{1}{2} \times 8$; edited by Nathaniel J. Hone, with a Preface by J. Samuel Green, M.A., B.C.L., LL.B., Barrister-at-Law.

This is a work which would interest any lawyer or student of manorial customs but would scarcely appeal to the genealogist.

1616 The **South Carolina Historical Society**, Charleston, S.C., U.S.A., sends Nos. 1 and 3 of Vol. XI. of "The South Carolina Historical and Genealogical Magazine". Each number contains from 50 to 72 pp. $6\frac{1}{2} \times 9\frac{1}{2}$.

No. 1 contains:—"Evacuation of Charleston by the British in 1782", "Records kept by Colonel Isaac HAYNE", "Radnor, Edmundsbury and Jacksonborough", "Abstracts from the Record of the Court of Ordinary of the Province of South Carolina, 1692-1700", "Records from the ELLIOTT—ROWAND Bible, with an account of Thomas Elliott and his Descendants", "Historical Notes".

No. 3 contains:—"Colonel Robert GRAY's Observations on the War in Carolina", "Records kept by Colonel Isaac HAYNE", "Inscriptions on the Monuments in the Church Yard of the Parish Church of St. John's Berkley", "Historical Notes".

J. Horace Round M.A., LL.D., sends his two volumes on "Peerage and Pedigree", vol. I. xxviii, 362 pp., vol. II. 408 pp., $5\frac{3}{4} \times 8\frac{1}{2}$; published 1910 by James Nisbet & Co. Ltd., and The St. Catherine Press; 25/- net.

1617 These two handsome volumes of Peerage Law and Family History are remarkable if for nothing else for the excellent way in which the type has been set up and for the scathing sarcasms which pervade their pages. But for the latter blemish the arguments set forth in the exposure of spurious records and the substitution of fact for fiction in this realm of family history would carry the conviction to the mind of the reader which it is evidently the intention of the author to convey but the wholesale denunciation of Legal luminaries from Coke downwards (always excepting the author himself) seems to promote an unhealthy atmosphere which the mass of facts deduced fails to dissipate. The Lawyers however are not the only persons against whom Dr. Round's thnnderbolts are hurled, Collins, Burke and Lodge all have to meet the vials of his wrath. On the whole however it must be admitted that the strictures of the author are in most cases entirely warranted. In the Willoughby Case and The Rise of the Berties the claim of Bertie discribed as a limb of the law is conclusively disposed of. Referring to the Barony of Delawarr the author admits that one of its most perplexing features remains at yet obscure, and although on another point evidently less obscure the author is able to correct this accepted version, it is positively refreshing to find an admission to this effect. In Peerage Cases in the Court of Chivalry the object of the author is to establish the fact that under Elizabeth and James I the recognised form for the trial of claims to peerage dignities was the Court of Chivalry and not the House of Lords, but in the face of Sir F. Palmer's authority, which he quotes, we do not think Dr. Round in the cases he cites in support of his views does establish the fact of which this paper was the object; but even here the author cannot state his facts without an attack on poor Mr. Fox-Davies for asserting that "nothing can alter the fact that the officers of the College of Arms have the sole authority of control of armorial matters." In the Muddle of the Law the author falls foul of the lawyers for relying on "authority" of this or that writer, but surely if the lawyers are not to be guided by the decisions of eminent judges and authorities but on facts, the muddle of the law would be infinitely greater than that deplored by Dr. Round. If in every case the lawyers had to seek for these facts as he suggests the cases would never be heard, and the congestion in the Courts would be something terrible to behold. Juries as a rule deal with such facts as can be brought before them, and the lawyers deal with the points of law which depend upon authority either of Statute or decision but perhaps the author may not be aware of this. Lord Coke and other judges may have made mistakes and we do not know that authors are exempt from the same failing but we think the 180 pages Dr. Round devotes to the exposition of this Muddle of the Law leaves the state of the law little if at all the worse for his attack. It may, we think, be concluded that Dr. Round's contentions with regard to the Muddle of the Law would carry more weight if it were not so evident that he is holding a brief for the Historians.

The paper on Tales of the Conquest comes as a relief to the mind; previous chapters may be said to have been wholly devoted to the destruction of legal arguments and the consignment to Dr. Round's dustbin of eminent judges and jurists; but here he opens

with a story which he allows rather grudgingly perhaps in the main to be probably true and this is the story of the Sackvilles and Giffards which records a claim to certain liberties on the part of Bartholomew de Sackville who held of the Marshals, Earls of Pembroke in the days of Henry III. a Knight's fee at Fawley, Bucks, and traces the ancestors of the Giffards to the beginning of the 13th Century. But Dr. Round cannot apparently withdraw himself from the attraction of the tales which as he says belong to the realm of legend, and in three pages he is back again dealing death amongst a mass of concoctions and spurious tales and charters, as in the cases of Umfreville Mordaunt and the Honour of Richmond which he alleges will not bear the test of critical examination. The legend about the Kentish men coming with boughs in their hands and wresting from William a confirmation of their rights, the Kentish men being led by Stigand, is too good a mark to be missed by Dr. Round, and the representation of this scene by Mr. Louis Napoleon Parker in the Dover Pageant of 1908 is riddled by his bullets of irony. "Against such travesties of history I have ventured to raise my voice" he writes and it must be recognised that Dr. Round is justified in protesting against such an inaccurate method of teaching history. The author relates how he declined to aid and abet Mr. Parker in making history ridiculous by connecting himself in any way with the Colchester Pageant of 1909, a fact evidently much to be deplored, for his valuable assistance would doubtless have prevented these blunders to which he had to draw attention, but then this paper would not have been written, so we may say with Mr. Parker "Ex factis non ex dictis amici pensandi." In his paper on the origin of the House of Lords, (a very interesting subject at the present day), which was originally published some quarter of a century ago, Dr. Round disclaims at the outset for his conclusions any pretensions to finality especially where they are of an original character, based on his independent investigations but nevertheless after showing that Stubbs, Freeman and indeed every one else who has written on the subject is wrong, he arrives at finality when he writes:

"We have, then, in our House of Lords, an assembly of feudal derivation, springing from a court of vassals, which has been changed, by the force of circumstances, into an hereditary peerage still modified by the feudal principle; still reminding us, by the evidence of its nomenclature, of its origin in the Norman Conquest; and still retaining, down to our own days, representatives of the tenure element, whatever modern historians may say, in the non-hereditary bishops."

In "Some Saxon Houses" Dr. Round is in his element. As he very truly writes "Many absurdities and much fiction would be swept out of family history if only two elementary facts were clearly and firmly grasped. The one that hereditary surnames were not introduced in this country till after the Norman Conquest—and in most cases long after it: the other that owners of estates derived their surnames from them and did not as sometimes seems to be imagined give to a locality their own name." But we think the author is not quite correct in his latter elementary fact as we believe there are instances in which the surname has been given to the locality, and in referring to the Chad pedigree further on he does not traverse the statement that the names of many places were derived from St. Chad but why he should doubt the possibility of a Saint being the progenitor of a Family is not explained. Commenting on the absurd process of confusing christian with surnames the author adds an amusing story told him by an officer of the British Museum of how an American tourist specially desired to see a manuscript associated with St. Cuthbert and explained that it was of peculiar interest to him as he was a Cuthbert himself. Many legends of descent from ancestors of Saxon time receive their quietus from the pen of the author, who demolishes in the most unsympathetic manner, the wells of tradition to which the Traffords and many other families have looked for sustenance for many years. The great Carington Imposture occupies over 120 pages of this work and is well worth the reader's attention, although the author's poisoned shafts can too distinctly be seen winging their way to the target of his spleen. In the subject of Heraldry and the Gent, the criticisms of the author degenerate, we regret to find, into a wholesale abuse of Mr. Fox-Davies and "Armorial Families". We cannot but feel that there is much that is true in his strictures but why clothe his language in such vituperative garments? This work as a whole forms most interesting reading but would have proved the more pleasant had the tone of the writer been more felicitous.

PETERBOROUGH RECORDS

To the Editor of the I. G. Directory.

Dear Sir,

The following notes on the Peterborough Records may interest your readers :—

The Probate Court at Peterborough contains many valuable Records which are in exceptionally good order and preservation and they include,

Cambridgeshire Wills and Administrations including the Consistory and Archdeaconry Courts commence 1449 Administrations 1694. The Peculiar Courts include Thorney (which should be of particular interest as it was there the French Settlers came in 1652 at the invitation of the then Earl of Bedford to assist in draining the Fens).—A French Register of Baptisms is still extant (1654-1727) and contains 1710 entries—Many descendants are still in the neighbourhood.

The University Court wills also are there and extend from 1501-1765.

Inventories of the three Courts have been catalogued and many names appear which are not to be found among the lists of Wills and Administrations.

Huntingdonshire Archdeaconry Court Wills commence 1470 though no index exists in the Registry prior to 1615 but the British Record Society are about to publish one from the earliest period.

Northamptonshire (the Northern Division) covers the period from 1541 though many of the more modern ones are unregistered viz :—from 1719-1820.

The Diocesan Courts contain a miscellaneous collection of interesting books, which include entries of Marriage Licenses from 1572, Act. Books of Institutions, Presentation to Livings Consecrations and Court Proceeding, &c. these have recently been, catalogued at much trouble by A. P. Moore Esq. the Bishop's Secretary.

DATA INTERCHANGED SYSTEMATICALLY

To the Editor of the I. G. Directory.

Dear Sir,

The creation of a general genealogical society, with headquarters in London, as has been suggested, is a great desideratum. Such a body could acquire by gift or otherwise a large collection of genealogical material and make it accessible to its members, on reasonable terms. The society should not, perhaps, undertake to *publish* any of its material for that would quickly exhaust its available funds, but it might profitably issue at least a bulletin of *queries* from its members. This would stimulate research. The answers to such queries, when received by the society, should not be published but should be made available to interested members by such general system as the society may adopt.

There is one more suggestion, which I would like to submit, that might help to make such a society self-supporting to a considerable extent. The society, when established, should issue an invitation generally to all genealogists, local historians, *et al.*, to co-operate in the work by sending copies of their manuscripts or transcripts of records, inscriptions, *etc.*, written with India ink on tracing-cloth or oiled paper, so that the society could easily cause ordinary blue-prints to be made therefrom at small cost, to be sold to other inquiring members at a profit to the society. Such manuscripts can also be prepared on a typewriter by using a black "record" ribbon (non-copying) with a reversed sheet of *new* black carbon paper placed face-up under a sheet of strong tissue paper. Thus two "images" are made in juxtaposition, one on the face and one on the back, which causes the necessary opaqueness for making subsequent blue-prints. This saves all expense and labor of a camera, as well as all cost of printing, proof-reading, *etc.* Every member would know positively that he was buying a true facsimile of the compiler's manuscript. The latter could be divided into families, localities and periods of time, and each sheet numbered. The size (perhaps 8 x 11 inches) should be uniform, and a margin of one inch at left-hand side should be observed,—to permit of binding.

I have used this method advantageously,—also what are variously known, in America, as black-prints, brown-prints or Van Dyke prints, (positives) which are permanent and more pleasing in appearance than blue-prints. The society could keep such manuscripts in "loose-leaf" file-books, and on short notice could produce a facsimile of any desired sheet or sheets, at nominal cost. To secure uniformity and to encourage and facilitate the work, it might be desirable for the society to print a supply of sheets of strong and durable but translucent tissue-paper, with a heading somewhat as follows:

Notes on the family of.....
Locality.....
Period (time).....
Author (Compiler).....
Address.....
Dated..... *Sheet No.*..... *Whole sheet No.*.....

This plan may have several defects but some method should be devised for *conserving* and making *generally useful* the tremendous amount of time, labor and money expended by amateur genealogists in the compilation of their manuscript-records. Many of the latter never see the light of day, owing to the expense of printing. The plan outlined above could, no doubt, be made useful in other lines of international research, but that would naturally follow, if a successful start is made in creating a genealogical exchange.

CONVENTION INTERNATIONALE D'HÉRALDIQUE

PROCÈS-VERBAL

de la séance tenue le lundi 5 Septembre 1910,

au Grand Hôtel Richemont à Lausanne, sous la Présidence du Comte de Colleville, Président.

Le Président ouvre la séance à 5 h.s. et souhaite la bienvenue aux sociétaires présents. Il rappelle les raisons qui ont motivé la constitution de la C. I. H. et le but de celle-ci ; il expose la tâche que les fondateurs se sont donnée et les résultats qui ont été obtenus jusqu'ici.

Il passe ensuite à la question relative à la formation d'une " Association généalogique et héraldique internationale, "—question présentée l'année précédente au Comité.

Il s'agirait de faciliter les recherches généalogiques, plus spécialement celles qui ont lieu à l'Etranger. Les personnes qui font des enquêtes en dehors de leur propre pays se trouvent souvent dans l'embarras, ne sachant à qui s'adresser pour se procurer les renseignements qui leur seraient nécessaires.—La " Convention Héraldique " pourrait ici prendre l'initiative de la création d'un service spécial qui consisterait à avoir dans chaque pays un groupe de représentants se chargeant de faire les démarches et recherches désirées et de répondre aux demandes, ou bien de transmettre celles-ci à qui de droit. Ce service, qui recevrait la forme d'une " Association généalogique et héraldique internationale, " serait organisé par les " Délégations " que les membres de la " Convention " auraient à constituer préalablement entre eux, dans leurs pays de résidence respectifs. Les " Délégations " s'adjoindraient des collaborateurs, choisis dans les sociétés similaires existantes et autres milieux héraldiques et généalogiques, et, avec ces adhésions, formeraient ainsi des sections de la nouvelle " Association généalogique et héraldique internationale. "

La discussion ouverte sur le sujet, un long débat s'engage auquel tous les membres prennent part, Il porte principalement sur :

1. la coopération des sociétés généalogiques et héraldiques existantes ;
2. le fait que certaines de ces sociétés possèdent déjà dans leurs organes—sous la rubrique des " Demandes et Réponses "—un système d'informations d'une réelle utilité ;
3. le fonctionnement de l'organisation projetée.

La délibération donne lieu aux considérations essentielles suivantes :

A. Le résultat cherché pourrait être atteint par les " Délégations " de la " Convention " et leurs collaborateurs, sans qu'il fût nécessaire de recourir à la fondation d'une nouvelle association internationale. Le cas échéant, une " Section généalogique " spéciale pourra être formée dans la " Convention " même et s'occupera essentiellement des questions généalogiques.

B. L'action de la C. I. H. ne formerait pas une concurrence de l'œuvre analogue éventuellement déjà entreprise par les autres sociétés ; la " Convention " désirerait au contraire voir celles-ci devenir ses obligés auxiliaires dans le travail de coopération internationale projeté. Ces sociétés seraient sollicitées de se mettre en rapports avec les " Délégations " respectives de la " Convention, " afin d'examiner en commun l'opportunité et la possibilité de développer les systèmes de renseignements actuels.

La formation des " Délégations " de la " Convention " ne devrait pas avoir comme conséquence un éparpillement ou une dissémination des activités généalogiques et héraldiques. Au contraire, et ainsi qu'elle l'a souvent relevé, la C. I. H. cherche à centraliser et grouper ces activités ; elle désire être un lien et former une sorte d'office central servant d'intermédiaire entre les associations héraldiques et généalogiques.

Afin de donner plus d'efficacité à ce rôle, il serait désirable que les sociétés d'héraldique, soit adhérentes comme telles à la " Convention " (ou aux " Délégations " respectives),—soit y délèguent officiellement un de leurs membres.

Les Délégations auraient à se créer un cercle de Correspondants et Agents se recrutant parmi les héraldistes, généalogistes, archivistes, ecclésiastiques, officiers d'état-civil, instituteurs, etc., qui consentiraient à faire, sur les bases établies, les recherches qui leur seraient demandées.

Une discussion prolongée a lieu sur la question de savoir si les " Délégations " devraient se contenter d'indiquer simplement leurs agents aux intéressés qui s'adresseraient à elles, en laissant à ceux-ci le soin de correspondre directement avec les premiers,—ou si la correspondance devrait s'échanger exclusivement par l'entremise des " Délégations, " qui exerceraient ainsi un certain contrôle

sur les renseignements donnés. Il est finalement décidé de laisser momentanément la question ouverte.

Une condition absolue pour le bon fonctionnement de l'organisation proposée serait que les correspondants des Délégations fussent des personnes qualifiées, de toute confiance et d'entière probité. Pour le choix de ces agents, les sociétés héraldiques pourraient donner "Délégations" une aide précieuse, et le vœu est émis que ce concours ne ferait pas défaut à l'entreprise projetée ; l'œuvre de mutualité amicale et scientifique pourrait ainsi progresser et fructifier pour le bien et l'avancement des études généalogiques et héraldiques.

La discussion terminée, l'Assemblée :

1. Adopte, en principe, la proposition de la création du service généalogique qui vient d'être exposé, sous réserve d'un examen plus approfondi de la question.

2. Décide d'instituer une "Commission généalogique" qui devra entrer en relations avec les sociétés héraldiques et s'entendre avec elles sur la manière de donner suite aux propositions énoncées ci-haut, ainsi qu'au projet dans son ensemble. La Commission cherchera en outre à établir un tarif sur les bases duquel les agents auront à fixer leurs indemnités et frais de recherches ; elle étudiera aussi la question, laissée en suspens, relative au mode de correspondance entre les mandataires et agents des "Délégations" et les personnes recourant à leur aide.

L'assemblée élit comme membres de la Commission :

M. Jean Grellet, Président de la Société Suisse d'Héraldique, à Zurich, et

M. Henry de Mandrot-La Sarraz, Président de la Société Vaudoise de Généalogie, au Château de La Sarraz.

La Commission sera complétée plus tard par le Comité de la C. I. H. qui procèdera aux nominations utiles.

L'assemblée décide ensuite d'adopter comme organe périodique (dans lequel le Comité de la "Convention" fera paraître ses communications) les "Archives Héraldiques Suisses," la publication officielle de la "Société Suisse d'Héraldique." Cette décision est prise sous réserve de l'approbation et de l'accord du comité de la Société Suisse d'Héraldique. (Note : Cet accord a été donné et communiqué verbalement le 25 Septembre 1910.)

Plusieurs membres de la "Convention", empêchés de venir à Lausanne, ont envoyé des messages de regrets et de sympathie ; le Vice-Chancelier communique ceux du Baron Manno, Président du Conseil Héraldique d'Italie, du Comte Pasini-Frassoni, Président du Collegio Araldico de Rome, du Commandeur Portal, Membre du Conseil Héraldique d'Italie, du Prof. D^r de Mülinen, Vice-Président de la Société Suisse d'Héraldique, du Baron de Gaisberg-Schœckingen, Président de la Société "St. Michael," du Baron de Hornstein-Grüningen, de la Société "Roter Löwe" à l'Université de Leipzig, du Baron du Roure de Paulin, Chancelier de la "Convention" et Secrétaire de la Société Française d'Ex-Libris, du D^r Hoefflinger, Secrétaire de la Société Impériale Royale Autrichienne d'Héraldique "Adler", du Marquis de Liveri et de Valdausa, du D^r de Troostembergh, Membre du Conseil Héraldique de Belgique, de MM. le D^r Deonna, Th. Courtaux, J. de Bettencourt, Membre de la Section Héraldique de l'Association Royale des Archéologues Portugais.

Le Vice-Chancelier exprime à ces collègues absents les remerciements de l'assemblée.

Le Président clôt la séance à 7 $\frac{1}{4}$ h.
