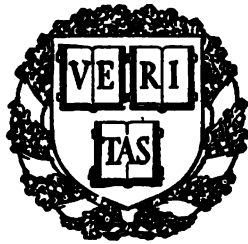

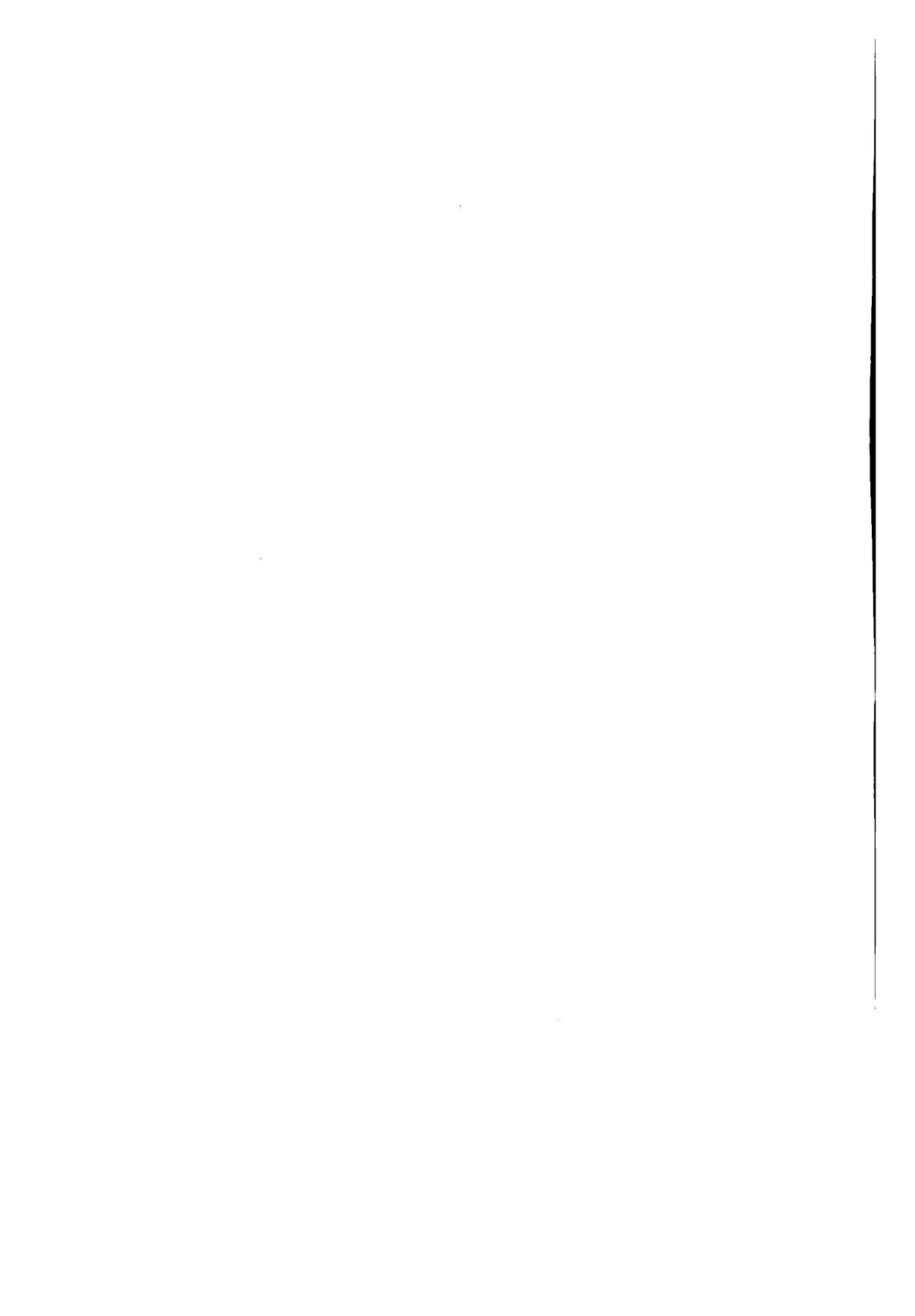

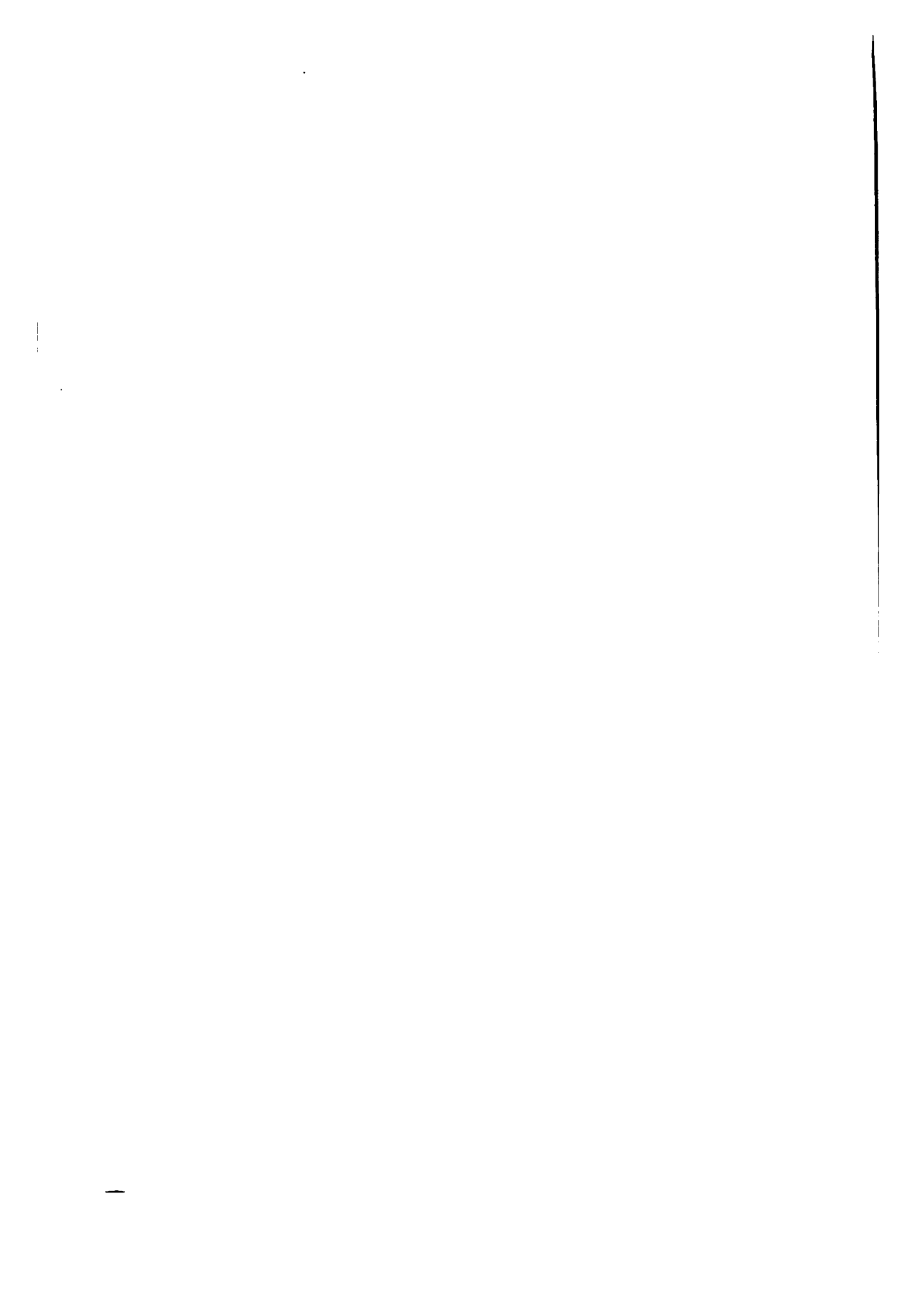

PREFACE

IN the present study an attempt has been made to illuminate certain aspects of the very complex relationship existing between England and her American colonies during the later colonial period. For this purpose the life of Jared Ingersoll of New Haven, Connecticut, has been selected as the central theme. Probably no one was more intimately identified with the last disastrous phases of the British experiment with a reorganized system for administering American affairs than was Ingersoll, and it is also probable that no one in America possessed a more intelligently sympathetic comprehension of what the home government had in mind or strove more earnestly and ably to persuade his fellow countrymen to accept the ministerial program in good faith. Judge Ingersoll stands as representative of a group, the importance and numerical weight of which has not, at least until very recently, been fully appreciated. He was no more a radical in his support of the crown than was John Dickinson in his support of the colonists. While he opposed the propaganda of the liberty group whenever the occasion seemed to demand it, his opposition never was manifested in violent reaction. In other words, he was a loyalist but a moderate; while at times he displayed great courage in defending his position he was characteristically cautious; he typifies the innate conservatism of the man of property who prospers and consequently is satisfied in the midst of discontent.

In interpreting the life of Jared Ingersoll I have sought to present as fully as space will permit what may

be called the environmental factors, and in this connection I have especially emphasized the drift of affairs and the ebb and flow of opinion in Connecticut and especially at New Haven, where Ingersoll throughout his public career, whether present or absent, had a powerful and not infrequently a dominating influence.

I first became interested in the life of Jared Ingersoll in 1910 in connection with a seminar conducted by Professor Wilbur C. Abbott of Yale University, in which certain British imperial problems of the eighteenth century were studied. At that time I prepared a paper upon the public career of Ingersoll and the present volume in a sense is an expansion of that paper. I desire to express my indebtedness to Professor Abbott for his encouragement and the help that he has so generously extended to me at all times. In returning to Yale University in 1917 as the Bulkeley Fellow in American History, I entered the seminar of Professor Charles M. Andrews in American Colonial Institutions and in this seminar I worked out the institutional problems bearing upon my subject and developed the volume along its present lines. Professor Andrews's deep knowledge of the institutional life of this period has been of the greatest value to me and has saved me from falling into more than one error. I am also under particular obligations to the Department of History of Yale University for making it possible for me to obtain transcripts of numerous documents in British archives, not otherwise accessible to me. The New Haven Colony Historical Society very generously allowed me to make use of the Jared Ingersoll manuscripts, although at the time Dr. Franklin P. Dexter was editing for publication a select group of the papers, and Mr. Albert C. Bates of the Connecticut Historical Society, among other courtesies, kindly permitted me to take notes from the manuscripts of the

Fitch Papers, which at the time he was editing for publication. Mr. Frederick Bostwick of the New Haven Colony Historical Society, Mr. George S. Godard of the Connecticut State Library, Mr. Gaillard Hunt of the Department of State, Mr. John C. Fitzpatrick of the Manuscript Division of the Library of Congress, Mr. John W. Jordan of the Historical Society of Pennsylvania, Mr. Samuel A. Green of the Massachusetts Historical Society, Mr. Robert H. Kelby of the New York Historical Society, Mr. Victor H. Paltsits of the Manuscript Division of the New York Public Library, Dr. Franklin B. Dexter of the Yale University Library, Professor Simeon E. Baldwin of the Law School, Yale University, Mr. Clarence S. Brigham of the American Antiquarian Society, Mr. George Pratt Ingersoll of Ridgefield, Connecticut, and Mr. William M. Meigs of Philadelphia, have all given to me valuable aid, as have also numerous Connecticut state, county, and municipal officials. Professor Rollo W. Brown of Carleton College, Dr. Alice Edna Gipson of New Haven, my sister, and Jeannette Reed Gipson, my wife, have assisted me in various ways in preparing the manuscript for publication.

CHAPTER I

EIGHTEENTH CENTURY COLONIAL NEW HAVEN¹

It is the purpose of this chapter to deal with the environment within which Jared Ingersoll, the subject of the present study, rose to prominence as one of the leading figures connected with the British colonial administrative system in America. This environment was the background of those developing forces in Connecticut which culminated in the dramatic appeal to arms against Great Britain on the part of the radical group within the colony in opposition to the conservative elements under the recognized leadership of Ingersoll.

Colonial New Haven of the eighteenth century, the home of Ingersoll, was a progressive town; not only Connecticut's cultural center, but, with Hartford, a joint capital, and one of the most populous and wealthy of the semi-agricultural, semi-trading communities within that colony, which, unlike Massachusetts and New York, possessed no metropolis. In 1756 it was third in population within the colony, but by 1774 had outstripped its rivals and taken first place, increasing from 5085 inhabitants

to 8022. These figures include the population not only of the town proper, but also of the outlying dependent parishes of Woodbridge, Hamden, North Haven, and East Haven, each with its own village church and school. The town proper numbered in 1760 only about fifteen hundred people; which shows how predominately agricultural were the interests of the township at this period.

According to early maps, New Haven must have been laid out with considerable care and was in marked contrast to what might be called the typical New England settlement by reason of its regular streets and equally regular and spacious town lots. In the '50's the town commons, known as the Green, seems to have been a wide expanse of boggy sward, where cart wheels had worn deep and unexpected ruts in the turf, horses, cattle and flocks of geese roamed at will, pigs "yoaked and ringed" rooted under the scrubby barberry bushes, and youngsters encased in leather breeches and splatterdashes sailed their boats on the commons pond. Then, as now, the Green was the center of the community's religious, intellectual, and political activities. Within it or in close proximity to it were located the three churches, Yale College, the Court House, the grammar school, and the jail with stocks, whipping post, and gibbet ominously advertised. In the early '50's a commodious brick state house arose on the Green, taking the place of the old court house.

Just as the Green was the center of the more spiritual activities of the community, so the harbor, especially after the French and Indian War, was the center of the growing commercial life of the town. Horses and oxen, barrels of pork, beef, tallow, with lumber, wheat, rye, Indian corn, flaxseed, pot and pearl ashes, were collected at the wharves to be carried by the diminutive brigantines, sloops, and schooners, either to New York

or Boston in return for the varied European manufactures which the people of New Haven seem to have used very extensively, or to the Caribbean Sea in exchange for cargoes of molasses, sugar, cocoa, and cotton.

In addition to the expanding commercial interests of the town, there was the distilling of rum made from molasses secured from the sugar islands and the manufacture of coarse linens and woolens "done in the Family way for the Use of the poorer Sort, Labourers, and Servants"; there was also an "iron mongery" where the more common iron implements appear to have been fashioned. However, a majority of the people living about the port of New Haven during this period were not concerned so much with shipping and manufacturing as they were with the absorbing occupation of extracting the more common farm products from the reluctant Connecticut soil. That this could be conveniently done while yet residing within the town jurisdiction can be understood when we realize that its limits included some eight square miles of land lying about the harbor and along the Quinnipiac, Mill, and West rivers which flow into it.

During the '50's, especially, there took place unmistakable signs of the expanding interests and growing importance of the community. Early in the decade an Anglican church was built close to the Green; in 1755 the first newspaper of the colony, the *Connecticut Gazette*, was established here by James Parker, and in that year "by authority of the King," a regular post office was opened; while in 1756 a custom house was erected, which became the port of entry and clearance for western Connecticut, with Nicholas Lechmere as the first collector.

These characteristically sober, church-going descendants of the early "Brahmins of Puritanism" who had

settled at New Haven, had developed by the middle of the eighteenth century a social system that would have seemed amazingly complex and binding to the men who, for instance, had been reared in one of the later western frontier communities of the United States. The keynote of western achievement was individual initiative; on the other hand organized action and organized responsibility and individual subordination was the keynote in colonial New Haven. This organized type of life expressed itself in many ways; there were the church communion and the ecclesiastical society, the freemen's meetings, those of the proprietors, those of the train bands, and perhaps the most important of all, the periodic gatherings of the inhabitants of the town. An examination of each of those forms of social expression will show how necessarily submerged was the individuality of the average townsman and yet, on the other hand, how thorough was the schooling that he received in serving in public affairs as a mere instrument of community action.

The church communion consisted of those in full Christian fellowship who had made a public profession of faith and had subscribed to the covenant. At first there was only one meeting house in New Haven; but in 1741 came the division brought about by the Great Awakening, with the result that the New Light or revivalist group organized a church of its own under the name of the White Haven Society, which was not, however, legally recognized as a distinct congregation until 1759. In the meantime, early in the '50's the Anglicans became strong enough to establish Trinity Church, made up largely, including its pastor, of those seceding from the Congregational communion; finally, in 1771, the Fair Haven Church was established by the separation of the minority group from the White Haven congregation. All of this represents, of course, the breaking up of the former

church unity of the town, a process that was going on in practically all of the Connecticut communities. While a great deal of intolerance and bitterness was shown at New Haven in the working out of this process, there is nothing in its annals that compares with the treatment accorded the Saybrook separatists, fourteen of whom in 1744, after being arrested for "holding a meeting contrary to law on God's holy Sabbath day," were herded through the deep mud to New London, twenty-five miles distant, and there thrown into prison without fire, food, or beds for refusing to pay their fines.

Normally the church communion was the inner circle of the ecclesiastical society in colonial Connecticut; but as the colony approaches the Revolutionary period this does not hold true. However, until 1746 the ecclesiastical society of New Haven legally comprehended all those living within the bounds of the New Haven parish and, unless especially exempt, all were obliged to pay the assessments made by the society for the maintenance of the pastor and for church building purposes as well as to attend the meetings of the church on pain of fine, imprisonment, or some other form of punishment. In that year the general assembly denied the privilege of voting in ecclesiastical society meeting to those—Anglicans, Quakers, and Baptists—who had been legally exempt from the paying of the taxes of the society. This marked the disappearance of the old unity and all-inclusiveness of the society. Within it there still remained, besides the covenanted, those who had never taken the covenant or made a profession of faith. If the latter possessed a freehold within the society limits rated at fifty shillings or were rated at forty pounds or more in the common list, they had the privilege of uniting with those in full communion in voting for officers of the society, in the calling of a minister, in the granting of church rates,

and in providing for the care and reconstruction of the church building as well as for the regulation of the school within the parish. After the White Haven and Fair Haven societies had been established within the old limits of the First Ecclesiastical Society, the general assembly provided that all the inhabitants who did not possess the special exemption accorded to Anglicans, Quakers, and Baptists, should decide in which of the three societies they preferred to be enrolled. There was, it should be understood, no place in colonial New Haven for the individual who could not support any of the organized churches with his presence and his money, for there was utterly lacking that spirit of kindly toleration regarding religious matters which is characteristic of people of intelligence in present-day Connecticut. The town, as it were, had grown out of the planting of a church, and its atmosphere was that of a church congregation.

While every endeavor was made to embrace all within the limits of the ecclesiastical society and to place upon them the privileges and responsibilities belonging to membership, no such endeavor was made to see that all men should share in the privileges and responsibilities of freemanship. For it was only the freemen in colonial Connecticut who could vote for the filling of the offices of the government as well as become its officers. To be made a freeman, one had to be twenty-one years of age, in possession of a freehold estate of the value of forty shillings per annum, or of forty pounds personal estate in the general assessment list for that year and to be "of a quiet and peaceable Behaviour, and Civil Conversation." An applicant not only had to secure a certificate of endorsement from a majority of the selectmen of the town but appear in a freemen's meeting and there take the prescribed oath; whereupon his name was enrolled by the town clerk among those admitted to freemanship.

In case, however, he should be guilty of "walking scandalously" he was to be disfranchised by action of the superior court.

Exactly what proportion of the adult male population in colonial Connecticut exercised a freeman's privileges in the decades just preceding the Revolution, is difficult to estimate accurately. However, in 1703 a list of the "freemen" living within the limits of New Haven contained the names of one hundred and fifteen persons; in 1784, at the time of incorporation, there were two hundred and fifteen freemen out of six hundred adult males then living within the limits of the town, which previously had granted East Haven, North Haven, and Woodbridge their freedom. In February, 1766, at an exceedingly important meeting held in the town regarding the affairs of the colony, it was stated that there were two hundred and seventy-four "voters" present and it is to be presumed that most of those qualified attended. Since the population of the town at that time must have been over six thousand, it would seem that about one in twenty of the total number of people or one in four of the adult males were freemen, which is probably a smaller proportion than in most of the towns of the colony and would indicate, if such is the case, certain conservative and aristocratic tendencies on the part of this community.

The freemen's meetings, which were held regularly on the Monday following the first Tuesday in April and on the third Tuesday in September, show how complicated was the political organism of the colony. At the September meeting two deputies were elected to represent the town at the approaching October session of the assembly and at this time each freeman gave his vote by written ballot for twenty persons whom he judged qualified "to stand in nomination for election in the month of

May following." These votes were then sent to the general assembly to be counted with the votes coming from the other freemen's meetings throughout the colony. The twenty persons getting the highest number of votes were thereupon nominated to stand as the candidates at the May election when all the elective offices of the colony were filled. At the April meeting, after the deputies had been selected to attend the May session of the assembly, the freemen then proceeded to ballot for the governor, deputy governor, the twelve assistants who acted both as a governor's council and as an upper house of the general assembly, and, also, for the treasurer and secretary of the colony. Unlike the meetings of the New Haven Ecclesiastical Society, which had to do only with the town proper, the New Haven freemen's meetings were for the entire township and it was the votes of this select group of men that determined the political tone of the community with reference to colonial issues. Only on the approach of the Revolution would it seem that the non-freeman element, certainly an overwhelming majority of the inhabitants, finally through violent and terroristic means wrenched political control from the hands of the more cautious, legally inclined, and propertied freemen.

The meetings of the proprietors of the common and undivided lands of the town were a type of local gathering very distinct from any of the foregoing. Prior to 1683 there does not seem to have been any well-defined idea that the proprietors of the unoccupied land within the town were to be distinguished from the inhabitants. The regular town meeting of the inhabitants from time to time had freely granted lands to individuals upon petition. But in that year a "division" or distribution of a portion of the common lands was made, which raised the issue as to ownership, and in 1685, in an attempt to

settle this, there was granted by the colony under the common seal to "the Proprietors and Inhabitants of the Town of New Haven all that certain tract of land known as New Haven then and for many years before in their peaceable and quiet seissen and possession being." The grant was so ambiguous that it only added to the keenness of the struggle between the old established families and the newcomers. The result was that on October 20, 1704, a confirmation of the land grant to New Haven was made, in which proprietorship in the lands was specifically limited to the two hundred and forty-eight persons who had been recognized as the proprietors in 1685 and to their heirs and assignees. From this time on, therefore, a sharp distinction was drawn between the proprietors' meetings and those of the inhabitants of the town.

In the drawing of lots for the fifth "division" in 1711, four hundred and twenty-two participated; which gives some idea of the number of the proprietors of the New Haven common and undivided lands in the eighteenth century. With the steady increase in population and the consequent rise in the land values the importance of the careful management of the common lands also increased. Frequent meetings of the proprietors were held. The actions of proprietors of common lands in the colony were carefully regulated by the general assembly, which provided that on the first Monday of March a special meeting in each town should be called to choose a committee to care for the lands during the year. This committee was empowered to choose fence viewers and haywards out of the number of the proprietors; those thus chosen who refused to serve were fined. The assembly also provided that at any lawful meeting of proprietors, taxes might be levied upon the members for making fences, gates, bridges, and that the collectors of these rates were to possess the same powers as the col-

lectors of the town rate. These proprietors' meetings, limited as they were in purpose, must nevertheless have been, just as the freemen's meetings were, centers of conservative influence.

The proprietors' meeting, freemen's meetings, and meetings of the ecclesiastical societies, of course, were but offshoots of the parent gathering, the meeting of the "inhabitants" of the town, which was by far the most comprehensive of all the local assemblages, recognized by law, in its scope of action and in respect of the number of dwellers within the town admitted to its privileges.

It should be understood that a man might be a dweller in a New England colonial town and yet, technically, not be an inhabitant, just as a man might be an inhabitant and not a freeman. In colonial New Haven three classes of individuals—transients or "single persons newly come," indentured servants, and slaves—"never were or are inhabitants in the Town." The code of 1750 declared brusquely that "several Persons of Ungoverned Conversation thrust themselves into the Towns in the Colony and by some Underhand way, as upon pretense of being Hired Servants, or of Hiring Lands or Houses or by Purchasing the same endeavor to become Inhabitants in such Towns"; to prevent which it was provided that no person should be admitted an inhabitant but "such of honest conversation," and that no stranger might have liberty to abide in the town without consent of the selectmen or the major part of the town; those warned out of town by the selectmen were to forfeit ten shillings a week or be whipped ten stripes if they did not leave.

But not even all adult male inhabitants were qualified to participate in the proceedings of the town meeting. One not only had to be a lawful inhabitant and to be twenty-one years of age, but, in addition, a householder

in possession either of freehold estate rated at fifty shillings in the tax list, or of personal estate rated at forty pounds. There was, however, one exception; no freeman could be debarred from voting in the town meeting. What proportion of the adult males were qualified to act in the town meeting is not clear. Ezra Stiles records the fact that at a New Haven town meeting in December, 1761, at which a close division took place, there were two hundred and thirty-four who cast votes. It is, therefore, probable that as a rule not more than one-fourth and possibly not more than one-fifth of the adult males of the town took part in the business proceedings of the community.

One of the most important functions performed by (this assembling) of the inhabitants was the selection of the local officials designated to carry out the multifarious activities of a Connecticut community of that period, where few matters were considered to be of so private a nature as not to be subjected to the inquisitorial scrutiny of those delegated for that purpose by the common authority. These officials were annually selected at a meeting held the last Thursday in December. It is illuminating to observe how comprehensive was this list of periodically chosen town dignitaries.

There were the seven selectmen who had the oversight of local affairs when the town meeting was not in session; a clerk to keep the minutes of the meetings and the other town records, and a treasurer who guarded and disbursed the funds of the town; in 1762, eight constables seem to have been needed to watch over the peace and quiet of the community and sixteen tithing men, for the maintenance of the ecclesiastical regulations, were commissioned faithfully to look after the moral welfare of the inhabitants during the week days, and on the Sabbath, to maintain order in the meeting houses through-

out the interminable sermons and, as the old formula reads, "to smite such as are unruly or of uncomely behaviour in the meeting." There were many other officials besides the above whose work was scarcely of less importance. At the same town meeting in 1762, not only were nine former key keepers, whose duty it was to empound stray animals, confirmed in their posts for another year, but four others were granted liberty to build pounds at their own cost and be key keepers of them; eight branders were made responsible for placing the brand on the horses owned within the town; twenty-eight surveyors of highways were named to care for the generally miserable country roads and to see that each man in the township, not otherwise exempt, did his share of the road work; and two fence viewers were given the general supervision of the fences and boundaries of the community. Then, there was appointed one gauger and packer to supervise the packing of beef, pork, and fish in casks by those preparing these articles for the market; a sealer of leather to prevent poorly tanned leather from being made up into articles and sold; a sealer of measures as well as a sealer of weights—one to see that standard measures were used by venders and the other to make sure of standard weights—and an excise master, who collected, for the support of colonial government, an excise of four pence on every gallon of rum, brandy, and other distilled spirituous liquors sold by any tavern keeper or retailer of liquor. These, together with twelve grand jurymen to make presentment of all misdemeanors, nine listers designated to prepare assessment lists, a collector of the rates or taxes of those living within the town proper, and one to collect the same of those living in the outer parishes, made up the impressive list of the community administrators in the '60's.

In other words, it was necessary to find those qualified

to fill over one hundred public posts in this little seaport which was a perfect network of officialdom. That it was sometimes considered a burden to hold an office is shown by the fact that the code of 1750 provided for a fine of twenty-six shillings from any person who refused to exercise the office to which he was elected, unless he could show that he was "Oppressed by such Choice," and that others were or are "Unjustly Exempted."

As might be anticipated, by far the largest share of matters that came before the town meeting were those logically springing out of the routine of the rather isolated life of a community that was, down to the Revolutionary War, in spite of its location, chiefly agricultural in character. Moreover, its scope of action was not infrequently limited by the restrictions placed upon it by the general assembly and a great deal of its work consisted in giving expression to the registered will of the higher body. Occasionally the assembly would pass an act, general in character, allowing to the local gatherings discretion as to whether or not it should be applied. For example, it was provided by law that no swine were to be allowed to go at large and that the town haywards were to empound such as did; but a clause was added which allowed the towns within their own precincts "to agree otherwise." As a result, with almost machinelike regularity the New Haven town meeting was accustomed to suspend the operation of the act, so that these "beasts" could roam on the commons if they were "yoaked and ringed from the 10th day of March to the 10th Day of November and ringed all the year."

While such things as the straying of swine had thus been regulated by the colonial government, other matters of a similar nature were left entirely to the discretion of the individual town meetings. The straying of geese, almost as great a menace to the peace and happi-

ness of colonial Connecticut as the straying of swine, was in this category. The New Haven town meeting, in an endeavor to placate everyone, arrived at the decision that owners of geese might have the privilege of grazing them on the commons from May to October but that should these errant birds be found doing damage in any particular field and, as a consequence, be empounded, they should be released only upon payment of two pence per head. Further to protect the crops of the inhabitants, the town meeting, of its own initiative, opened an avenue for an assault upon the town hoard by ordering four pence per head to be paid for crows by the collector of the town rate. But when it came to the destruction of barberry bushes, which were "thought to be very Hurtful by Occasioning (or at least Increasing) the Blasting of English Grain," the town was able to support its action by the express permission given to each community by the general assembly to deal with the problem as seemed best. At a meeting in December, 1763, it was, therefore, resolved after earnest deliberation that these noxious shrubs should be exterminated; and, as a result, the surveyors of the highways were instructed to "warn out" the inhabitants of their respective districts in the months of April and May to wage systematic warfare against them.

The preëminently pastoral and coöperative character of the community until well along in the eighteenth century, is further evidenced by the fact that as late as the '30's the selectmen were regularly called upon in town meeting to provide a sufficient number of bulls and boars for the town plot and to "assess the Inhabitants £8, if need be, for the use of Bulls and Boars, to be paid to the owners thereof." It was decided at another meeting that if any sheep in the several flocks in the town stray from the keepers, no man should empound these strays from

off the commons. To protect the larger, common, agricultural interests, individual members of the community were occasionally compelled by these public gatherings to make important concessions. As an instance of this, the raising of doves was placed under the ban when it was concluded that they were more hurtful than profitable, and the selectmen were instructed to inform the owners "that the town expects them to destroy said Doves." Also, those inhabitants who were husbandmen were required by the same authority to provide axletrees for their carts "5 or 6 inches wider than now," and those who possessed cows that "use the walk where there is a cow keeper" were ordered to pay by the week to the cow keeper what others were paying for the tending of their cattle. It was not until 1724 that the "wilderness of New Haven" was plotted and in the '30's the leasing and care of the "Town Farms" was a matter that deeply concerned the inhabitants. In March, 1763, embracing a policy of conservation of resources, the inhabitants voted to close the oyster beds for a year.

The New Haven town meeting of the eighteenth century also concerned itself with a variety of matters that had nothing to do with the economic side of life. The constables on one occasion were even directed by this body to take notice of people opening the windows of the meeting house in time of public worship; after complaint was made at another time that mischievous boys played in the market place and that, as a result, "the meeting house windows are often shamefully broken," it was determined to prohibit boys from playing within twenty rods of the meeting house on penalty of a fine of twelve pence and the cost of damages.

The appointment of committees was a favorite method employed for getting special things accomplished by the town meeting. As examples of this, on December 10,

1753, St. Joseph Mix, Jared Ingersoll, and Thomas Howell were selected as a committee to audit the accounts arising in connection with the building of a pesthouse; on December 14 of the same year St. Joseph Mix, Phinehas Bradley, and Jared Ingersoll were designated to advise with the selectmen concerning the maintenance of one Brighton, "a distracted man now in the town"; on December 19, 1754, Jared Ingersoll and two others were asked to join a committee from the Milford town meeting for the joint construction of a bridge over "Oyster river"; and on December 12, 1763, a committee including Ingersoll was desired to lay a plan for supporting poor persons.

Fairly trivial as many of these matters now appear to be, which occupied the inhabitants at these gatherings, they were, nevertheless, among the things that bulked largest in the eyes of the average man and really conditioned his immediate welfare far more than the weightiest imperial legislation. What is more, from many angles the town meeting served as an excellent school in which to gather political experience. No colony produced a shrewder group of politicians than those that sprang from the Connecticut town meetings.

The most notable issue which came before the New Haven town meeting prior to the Revolution, was that raised by the people of East Haven parish, known more commonly as the people of the "Iron Works" or the "East Farmers," who made an attempt to break away from the jurisdiction of the town in 1707, thus precipitating a struggle which at times was carried on with great bitterness and which lasted until 1785. It centered upon three issues: the right of East Haven to be represented in the general assembly, the right to raise and dispose of its own taxes, and the right to control the common lands within its bounds. In 1707 the parish

secured incorporation as a village, but the charter was very ambiguously worded and it is possible that Governor Saltonstall, as has been charged, used his influence against the little community because of a feud that had arisen between him and the East Farmers on account of the merciless war he waged upon their geese, which strayed into his near-by fields and resorted to his lake. From October, 1708, to October, 1710, the parish sent deputies to the general assembly, against the strenuous opposition of New Haven, which succeeded in that year in getting the assembly to deny them this right. In 1712 this body ordered that the East Haven assessment list be added to that of New Haven, and in 1716, that the care of the poor among the East Farmers belonged to the New Haven town meeting, not to East Haven. "Silenced by the terror of law suits and 'the powers that be,' East Haven submitted till another generation arose that had not known a Saltonstall." In 1752, at a meeting of inhabitants, called December 18, this plucky parish again renewed its fight for liberty. After resolving to take up the privileges granted by the general assembly in 1707, a group of town officers was selected and a committee was sent to the New Haven town meeting to give due notification, "in order that the said town of New Haven may hereafter exempt themselves from any further care or trouble respecting the said affairs of the said Town of East Haven, the regulations thereof or the Appointment of officers therein." But the mother town was inflexible in its opposition to this design and exerted so powerful an influence upon the colonial government that once again "the broad hand of the General Assembly" fell upon the people of the iron works. Not until after eighty years of conflict, not unmixed with disorders and violence, was the independence of East Haven finally achieved, two years after the peace which brought about

the legal separation of the colonies from the mother country.

Controlled largely by the same elements that directed the freemen's meetings and those of the proprietors, the New Haven town meeting appears to have been rather consistently conservative during the decades preceding the Revolution, standing generally for the maintenance of the old order of things and discountenancing the extreme policies of the radical group dwelling in the town. In this respect New Haven stood in marked contrast to its offspring, Wallingford, which had succeeded in detaching itself from the former before the beginning of the eighteenth century. In 1766, under control of the radical influence, the Wallingford town meeting did not hesitate, as will be seen, to set itself up as superior in authority, within its own boundaries, even to parliament. No such extravagance ever characterized the action of a New Haven colonial town meeting.

Over against these influences, which could be counted on to oppose hasty and violent political action within the community, stood the train bands. Under the law all males between sixteen and fifty years of age, except those holding posts under the colonial government, those connected with the "Collegiate School," masters of arts, justices of the peace, physicians, surgeons, schoolmasters, attorneys-at-law, one miller to a gristmill, constant herdsmen, mariners and ferrymen, sheriffs and constables, as well as lame and disabled persons, negroes and Indians, were required to attend musters and military exercises. Although it is true that, under ordinary conditions, these men gathered together but four days annually for training, yet in each town the military organization remained intact, all the while exercising an influence on the course of affairs which, it seems, has been too little appreciated by scholars up to the present.

It should be remembered that although the regimental officers were appointed by the Connecticut government, the officers of the train bands from captain downward were selected by the enrolled men and that, as the result of exemptions, the elections were controlled by the popular, more irresponsible elements which naturally put in command those who sympathized with their point of view. These popular officers, many of them adventurous characters, at times exercised, especially in eastern Connecticut, a degree of authority in political affairs which brushed aside any and all opposition. It was not until 1775, however, that the New Haven military group succeeded in acquiring any such influence; then, under the leadership of Benedict Arnold, it threatened to break open the door to the town powder house unless supplied with ammunition, and by a display of force thoroughly overawed the civil authority.

The radical tendencies of the train bands, which came to the surface when complications developed between the colonies and the mother country, seem to have been encouraged by the still more radical tendencies of traders and sailors clearing from this port, who were thoroughly aroused by the revenue acts of 1764 and 1767. Then there were the New Lights of White Haven and Fair Haven churches, both of which congregations were responsive to popular impulses, as well as the faculty and a majority of the two hundred students of Yale College, under the guidance of the acting president, Naphtali Daggett. These groups, as political agitation developed, stood in opposition, not only to the conservatively inclined merchants, who made up the membership of the First Congregational Society, but to the Anglicans of Trinity Church and the little body of loyalist Sandemanians. In the papers, first the *Connecticut Gazette* and later the *Connecticut Journal*, while much more

restrained in utterance than the *New London Gazette*, disseminated revolutionary ideas. The ten or fifteen taverns in New Haven seem to have been still more active agencies for their distribution; for the agitators appear to have made these resorts rallying centers and many of the more violent and terroristic acts preceding the actual outbreak of the war are almost inexplicable unless it be accepted that they were committed by men and youths made temporarily irresponsible by strong drink. This, in fact, was publicly charged by a writer in the local paper in 1768, after one of these scenes of wild disorder.

It should be appreciated that in regard to such a community as colonial New Haven, one is not dealing with a people possessed of democratic ideas in any modern sense of the word. Consistently enough, in the light of the prevailing strong predestinarianism, the blessing of liberty and equality which men had so much to say about in the '60's and '70's were not for all to enjoy, but, just as in the case of salvation, rather, for the elect. Even as late as 1777, a writer in the local paper bitterly complained of the treatment of the "separatists" or those of the Congregational communion who had repudiated the Saybrook platform. "They have been persecuted, oppressed and most cruelly treated, their property has most unjustly been taken from them to support ministers that in conscience they could not hear preach; and at the same time, they have had ministers of their own to support; they have been imprisoned for not paying the rates to the clergy and fined for not attending public worship with the standing churches." Unitarians, moreover, were struck at by a colonial law providing that those denying "any one of the Persons Holy Trinity to be God" or denying the Scriptural authority of divine authority should, on conviction, be incapable of enjoying any offices ecclesiastical, civil, or milita

a penalty of ten shillings as a fine was levied against any person daring to form a "separate Company for worship in a private House."

Nor were conceptions of liberty and equality more liberally interpreted in the fields of social and industrial activities. Until well past the middle of the eighteenth century it would appear that the majority of the leading religious lights of the colony failed to record any disapproval of the institution of slavery. So devout a man as Rev. Ezra Stiles, who later became president of Yale College, was guilty of sending a barrel of rum to the Arab slavers of Guinea for the purchase of a slave; a Connecticut clergyman, acting as governor, decided that the offspring of a negro bond woman was born in slavery; indented whites were gladly purchased by the well-to-do of New Haven and set to work beside the slaves in the fields; while the town paupers were put through what would now be called the degrading spectacle of being sold at auction from the steps of the state house on the Green, to such as could keep them for the year at the lowest rate. Only a community that was fundamentally aristocratic in structure could fail to detect the hopeless incongruity of publishing in the local paper, side by side with passionate exhortations to all freemen to struggle for their disappearing and precious liberties, equally fervent appeals to the public to assist in the capture of some runaway white or black attempting to escape from his servitude. In reality the broad humanitarianism and the generous idealism manifested in American life today found little lodgment in the mind of the typical, sturdy New England colonist, for these were largely the product of that great leveling movement which at a later date swept eastward from beyond the Alleghenies.

If one were to characterize in general terms the ten-

dencies at work in eighteenth-century colonial New Haven, it might be said that the town was going through a notable period of transition, often accompanied by rather violent manifestations. Although the multiplied restraints upon individual freedom of thought and action still largely remained, the old unity and homogeneity was fast breaking down. The immediate result of this centrifugal movement was a process of differentiation in the institutions that expressed the organic life of the community. The unified church communion of 1700, together with the all-embracing character of the ecclesiastical society, had disappeared, as had the earlier identity between the dwellers in the town, the inhabitants of the same, and the proprietors of the town lands. Caught by this outward swing, the outlying parishes began, one after another, to seek an independent life. The struggle of East Haven to obtain the right of self-taxation and self-regulation generally, undoubtedly epitomizes in many respects those impulses that led the people of the colony, in turn, to seek separation from the mother country.

CHAPTER II

EARLY DAYS. THE OFFICE OF KING'S ATTORNEY

JARED INGERSOLL came of the Ingersoll line of Bedfordshire, England.¹ His grandfather, John Ingersoll, left England in 1629, the fatal year when Charles I dismissed his third parliament, introducing thereupon a decade of unrestrained political despotism. Shrouded in obscurity as are the causes which led to John's departure from England, it is probable that he, then in his fourteenth year, had already identified himself with the Puritan opponents of the prerogative party in England and, not averse to a great adventure, together with his elder brother, Richard, became a member of one of the numerous groups of the discontented that left for New England at that period. Richard settled at Salem in Massachusetts Bay where, in 1644, he died.² John, after stopping for a time with his brother, pushed out into the west, locating successively at Hartford and Northampton; while at the former town, he married. In 1666, caught with the pioneer spirit, he and his family went with a group of settlers into the western wilderness of Massachusetts Bay, where they established the town of Westfield, and here John became one of the "seven pillars"

or foundation men in the local church.¹ He was married, in all, three times and became the father of fifteen children, the youngest of whom was Jonathan.² The latter, early left an orphan, went as a youth to Milford, Connecticut, where he took up the trade of a joiner. There is every reason to believe that he became a thrifty man as well as an efficient artificer, for he gradually accumulated substantial possessions in land and personal property; he even became the master of three slaves.³ At the age of thirty-one he married Sarah, the widow of David Miles of New Haven; their three surviving children were Jonathan, who graduated from Yale College in 1736 and became pastor of the Ridgefield church; Sarah, who married the clerk of the New Haven County Court, John Whiting; and Jared, the subject of this study, who was born in 1722.

Although nothing has been ascertained regarding his

earlier years, it is certain that Jared was allowed the leisure to prepare for college. What books came into his hands are unknown; the only works of any sort appearing in the inventory made of his father's estate at the time of the latter's death in 1761 were two Bibles and a Testament. However, the young man, after his matriculation at Yale, so distinguished himself that upon his graduation in 1742 he was awarded the much prized Berkeley scholarship, which opened the way for an additional year of study.¹ It is interesting to note, in passing, that the estimate which the college authorities placed upon the social standing of his father gave him ninth place in a graduating class of sixteen. That Jared was led early in life to the consideration of serious things is vouchsafed by the survival of a somewhat abstruse historical essay, which he prepared in his eighteenth year while at Yale, upon the cumbersome and all-inclusive topic of "An Historical Account of some affairs Relating to the church especially, in Connecticut, together with some other Things of a Different Nature."² In fact, a love of theological mysteries followed this busy, practical man through life.³ But, in spite of his studious habits and serious-mindedness, Ingersoll did not neglect the opportunity of cultivating warm friendships with his fellow students. That some, at least, of these attachments were firm is apparent from a letter which one of his classmates wrote from Elizabethtown, New Jersey, a score of years after separating at Yale: "It would

give me high satisfaction to take my worthy friend by the hand and I almost insist that if your affairs call you again to New York you come over and spend a day or two in my country cottage where you will meet with a most cordial reception from an old chum who frequently recollects with pleasure the many agreeable social hours spent with you at *alma mater*."¹

But that Jared by no means confined himself to the companionship of his Yale acquaintances and his books, is evidenced by the fact that when his academic career came to a close in 1743, he was very soon afterward married to Hannah Whiting of New Haven.² The young people decided to make their home in the college town, and here was born to them in 1748, Jared, Jr., the only one of four children to survive.³

Young Ingersoll, apparently very soon after leaving college, took up the 'practice of law.'⁴ How he received his preparation for this profession is not known. Undoubtedly much of the time as Berkeley scholar was

spent in reading law. At least, it is certain that he was sufficiently well trained to meet with almost immediate success. The prosperity enjoyed by the rising young lawyer was naturally reflected in his domestic life. The Ingersoll home maintained in the '60's on Chapel Street, facing the Green, must have been a commodious establishment. Like his father and many other well-to-do New Englanders, Ingersoll came to possess an apprenticed servant and negro slaves. Facts relating to these throw interesting light upon social conditions in New Haven at this period:

Two years after their marriage, the Ingersolls acquired Lucretia Smith, a white child of eight years, the daughter of William Smith, "a transcient person," and Ruth Smith, "who do not take care of their children." On May 20, 1745, the child was bound by her mother to serve Ingersoll until she was sixteen years of age; in consideration for which she was to receive "meat, drink, washing, lodging, and apparel." The agreement also provided that her master, in addition, was "to learn her to read English."¹ However, the following year, on March 3, "there was agreed an indenture by the selectmen of New Haven whereby Lucretia was bound to serve until she was eighteen years of age." According to the new indenture she was to be taught sewing, knitting, spinning, and household work, in addition to the reading of English. The document ends by reciting that when dismissed "she shall have 2 gowns (one for Sabbath Day; the other for week days' work), and give her a Bible." The last clause making provision for her spir-

itual welfare was apparently an afterthought, for it was written in another hand.¹

The records of the slaves purchased from time to time by Ingersoll have been preserved. On May 31, 1751, he bought from Stephen Alling, Cambridge, a boy of eight years, for whom he paid £320;² twelve-year-old Zilphie, owned by Thaddeus Cook, June 16, 1755, cost £550; Isban, thirty years of age, purchased from Christopher Kelley, November 2, 1761, cost £50; Damon, twenty years of age, the property of his friend, Joshua Chandler, was acquired June 27, 1764, for £80, and Rachel Hubbard Leah, a mature woman, cost him, November 7, 1765, £36. One is able to get a comparison of values by noting that May 9, 1764, he paid £17 for a black horse, presumably a first-

class animal, and two years previous, £100 for one and one-fourth acres of land bordering upon the Green.¹

That Ingersoll's position as a slave holder was not an isolated one and that the leading families of New Haven were not apt to forego the opportunity of enjoying the services of at least a black or two, is shown by the fact that in 1762, according to Rev. Ezra Stiles, there were eighty-three negroes among that part of the population living in the town proper; and according to an official report of that year there were four thousand five hundred and ninety blacks within the colony.² The strong financial standing of Ingersoll in the community is evidenced not only by the possession of slaves and numerous plots of real estate,³ scattered about the town, but also by the fact that in 1761 there was owing him £986.12.5, in that day a small fortune in itself.⁴

Paintings that have survived show Jared Ingersoll, in his maturity, to have been a man of solid build, well proportioned, with features of unusual regularity and a countenance expressing frankness and amiability.⁵ His natural dignity and assured culture were emphasized by his dress, which betokened that he was a man of taste and fashion, a gentleman of the old colonial school, as closely

akin in spirit to the Virginia cavalier as was likely to be found in New England.¹ In religious matters, like his father and grandfather, he remained a Congregationalist, a communicant in the First Ecclesiastical Society at the conservative Old Light meeting house, presided over, in his day, in turn by Rev. Joseph Noyes and Rev. Chauncey Whittelsey. Together with his friend, Joshua Chandler, who later became a Tory refugee, he was a veritable pillar of this church, which stood in sharp opposition to the more democratic and emotionally inclined evangelical New Light White Haven Ecclesiastical Society, which had come into existence in the '40's as a seceding and rebellious wing of the First Society.²

All of Ingersoll's interests had the effect of identifying him with the most conservative element in the town,³ and what undoubtedly added greatly to his growing prominence was that in 1751 he was appointed to the office of king's attorney for the county of New Haven.⁴

To appreciate the character of the public responsibilities thus laid upon Jared Ingersoll, there are certain facts regarding the historical significance of this post

of king's attorney which should be made clear.¹ The origin of the office in Connecticut, with its high sound of loyalty, harks back to the stirring events of the beginning of the century, when England and France were involved in the early stages of that titanic struggle for colonial empire which, beginning in 1689, was continued, with occasional breathing spells, until the Peace of Paris in 1763. In spite of certain advantages that England, with her sea supremacy, enjoyed, and in spite of the more solid character of her colonial settlements, it seemed at times as though the superior organization of the French, with a unified administration of their possessions in the New World, would more than offset these advantages. Those responsible for the guidance of England's affairs, especially the Board of Trade and Plantations under the successive presidencies of the Earl of Bridgewater, Lord Stanford, and Lord Dartmouth, had gradually reached the conclusion that it was imperative, not only for the establishment of an effective system of imperial defense but also for the proper expansion of trade and commerce within the Empire, that a centralization of colonial administration should be effected by placing all the colonies in America under direct royal control.²

Though bitter opposition to this plan for greater imperial unity and efficiency was not lacking, especially in the corporate and proprietary colonies, nevertheless, there were not wanting those established in America who came ardently to the support of the British authorities in their program. Edward Randolph, Joseph Dudley, Benjamin Fletcher, Jeremiah Basse, Robert Quary, and

Lord Cornbury, all enjoying public posts in the colonies, heaped up charges against the colonial governments.¹ In Connecticut the assault on the charter was led by Rev. Gershom Bulkeley² of Glastonbury, Major Edward Palmes of New London, and William Rosewell of Branford. Bulkeley, as early as 1692, penned a large folio work which he entitled, "Will and Doom, or a History of the Miseries of Connecticut under the arbitrary power of the present Government."³ In this he lamented the passing away of the Andros government, and "with great cunning and art" developed his case against the charter government of Connecticut. This able and extended philippic was placed in the hands of the board in 1703 by Lord Cornbury.⁴ Two years previous, a bill for "Re-

uniting to the Crown the governments of the several colonies and plantations in America" was introduced in parliament but failed of passage.¹ This, however, did not discourage the opponents of the charter, who, if possible, rather increased the keenness of their attacks. Governor Cornbury wrote from New York that the people of Connecticut "hate anybody that owes subjection to the Queen."² Sir Henry Ashurst, the London agent of the colony, warned Governor Fitzjohn Winthrop of the effectiveness of the "vipers among you that would destroy their own native country."³ The members of the board in their charges against the government of Connecticut specifically accused it of ignoring the acts of trade and navigation, and of actually countenancing illegal trade and, what is more, piracy. The colony was called a receptacle of pirates harbored by the government; she was charged with protecting fugitives from other colonies, of encouraging the migration of young men from Massachusetts Bay and New York to escape taxation for the prosecution of the war then being waged, and of refusing to do her part in colonial defense; nor would she allow her people to be sued by outsiders in her courts, nor the laws of England to be pleaded within the colony; nor countenance appeals to the Queen in Council; nor recognize the royal commissions relating to the vice-admiralty and the control of the militia; lastly she was charged with preventing Christians "not of their own community" to worship God without special license of

the assembly.¹ This resulted in an attempt to put through parliament a bill depriving this colony as well as Rhode Island of charter privileges.²

It was in the midst of this tense situation, when, for the preservation of the charter, it was vitally necessary to give the highest proofs of loyalty and good order, that the Connecticut general assembly, at its May session in 1704, shrewdly turned the tables upon those who were denouncing the colony's hatred of royalty and lawless turbulence by establishing the office of queen's attorney, and by directing the ministers in each ecclesiastical society, "in imitation of our nation," to excite and stir up their good people "in order to indeavour a reformation of what provoking evils are to be found amongst us."³ The wording of the act creating this office was in form a tactful confession of neglect to deal effectively with the general situation and an earnest of a more dutiful attitude in the future toward the mother country. The act, it is important to notice, met the demand, as far as Connecticut was concerned, that in all the colonies justice should run in the name of the sovereign.⁴ It reads as follows:

"Whereas we are often told from the public ministrie as well as from private discourses of the wise and pious persons of our age, that one crying sinne that may procure impending judgements further to come down on our

land as well as those that are already inflicted on us, is the neglect of putting good lawes in execution against immoral offenders, that therefore such neglect may be prevented for the future, It is ordered and enacted by this court, that henceforth there shall be in every county a sober, discreet and religious person appointed by the county courts to be attorney for the Queen, to prosecute and implead in the lawe all criminal offenders, and to doe all other things necessary or convenient to suppress vice and immoralitie."¹

The significance of this rather ostentatious move in the direction of loyalty can better be appreciated when it is realized that Connecticut alone, of all the colonies, thus followed the example set by Virginia, one of the favored royal colonies, where the office of king's attorney had come into existence as early as the middle of the seventeenth century.²

Emory Washburn, in his *Judicial History of Massachusetts* (p. 87), says

As a result of this action the Connecticut county courts were provided with a county prosecutor, and criminal indictments now ran, "By information of the Queen's Attorney in her Majesties behalf."¹ Jonathan Law of Milford, a staunch supporter of the charter, was selected in 1704 as the New Haven county queen's attorney.² He was followed successively by John Reedy, Lieutenant William Adams, also of Milford, Daniel Edwards of New Haven, and Elisha Hall of Wallingford.³ It was the latter that Ingersoll followed in office when, in his twenty-ninth year, he was appointed king's attorney for New Haven by the bench at the session beginning the second Tuesday of November, 1751.⁴ His brother-in-law, John Whiting, who was clerk of the court from 1742

to 1773, was doubtless influential in getting the appointment for him.

It would appear from the county court records that the occupants of this post, previous to Ingersoll, had generally forgotten the fact that criminal cases were to be prosecuted in the king's name. Indeed, efficient as many of these county prosecutors may have been, there is no evidence of the presence in the New Haven county court of any enthusiastic supporter of the royal prerogative up to the time when Ingersoll assumed office. Elihu Hall, Ingersoll's immediate predecessor as king's attorney, was a rather popular figure; he was sent by radical Wallingford to the assembly in 1743, was a captain of the militia in 1743, and in 1755 a major.¹ With the selection of Ingersoll, however, the office assumed a dignity and importance previously unknown to it. From this time on, until the outbreak of the Revolution, the New Haven county court register—in which previously the king's name never appeared—most punctiliously gave indictments in the name of "His Majesty." In the court proceedings themselves, instead of the cold formula, "By information of the King's attorney, on His Majesty's Behalf," which was introduced in 1704, although seldom employed in these records, actions now ran in the name of "The King, Our Sovereign Lord." Indeed, a reader of these proceedings can hardly avoid the impression, after coming to the records for the year 1751 and following, that he is surely in touch with some devoted supporter of those conceptions wrapped up in the idea of British sovereignty of which the king was the symbol;

in touch, in other words, with an American loyalist, the successor of the earlier "prerogative man."¹

It would be of value were we able to determine just what influences came into Ingersoll's life to produce this attitude of mind, for it seems hardly possible that he inherited it from the pioneer of Westfield who had left

What they wanted most of all was to be left severely alone by the king and his government. "They hate anybody who owes subjection to the Queen. That our people find every day," complained Governor Cornbury of New York in his indictment of the people of Connecticut in 1703. (*N. Y. Col. Doc.*, IV, 1070.) In other words, throughout the entire colonial period, two opposing tendencies seem to have been continually operating to shape and direct the thought of the body politic in America.

England when persecution was at its height. His father's intellectual interests, apparently, were very limited; it may be that his association at Yale with students such as his classmate, Samuel Fitch of Lebanon, of later Tory fame, produced an effect. The most plausible explanation, however, can be found in Ingersoll's taste for books, and among them, especially, English legal treatises; the Yale College library, meager as it was, doubtless had the same result in molding the political conceptions of the Berkeley scholar, as it had, some decades previous, in causing Rector Cutler to repudiate Congregationalism in favor of Anglicanism.

With great zeal young Ingersoll attacked the responsibilities of his office. At the very next session of the court, after his appointment, he arraigned, in the name of "Our Sovereign Lord the King," a group of Guilford men who had been acting in a riotous manner;¹ besides this, the grand jury seems to have been aroused into an astonishing state of activity in its search for criminals. So successful was Ingersoll in prosecuting those defying law and order in New Haven county that he was kept in office for over fourteen years.²

By far the most common criminal offense that came

before this tribunal for punishment was immorality. A study of the Connecticut codes¹ leaves the impression that the Puritan, by reason of the peculiar methods that he used in his strivings for community sanctity; by his suppression of sports and many wholesome forms of amusement, actually, though unintentionally, fostered vice. He, apparently, could not understand that life demands expression in ways other than the routine of daily material labor and that unfortunate consequences would be only too apt to ensue when the natural longing for joyous recreation was denied to youth.

The accused, after having been presented to a justice of the peace by the grand jury, were, as a rule, bound over, with "recognitions" amounting to from £3.6 to £15 lawful money, to make an appearance at the next session of the court.² These unhappy recreants found no sanctuary even in the subsequent establishment of a home, for the lynx-eyed grand juryman was almost sure to track them even there. During the years while Ingersoll was king's attorney, literally dozens of married couples were summoned to appear in open court to answer charges of pre-marital relations. The latter in their shame generally refrained from appearing, preferring to forfeit their recognition bonds. Occasionally, however, in a spirit of humility, the young couple would appear, humbly acknowledge their fault, and pay their fine.³

From the present-day point of view, there was something unwholesome, depressing, and reactionary about the whole procedure described above. The notoriety accompanying the judicial proceedings at every stage was such as could hardly do otherwise than take away the self-respect of penitent young people. This method of dealing with such cases could only lead to whisperings, retaliations, ostracisms, and to an atmosphere of suspicion and community scandal-mongering.

While Ingersoll and the other officers of the law may be blamed for their zeal in meting out punishment to these unfortunates, yet after all, the fault lay fundamentally with the law which they had bound themselves to see obeyed and it was inherent in the very conceptions of social control then prevailing in Connecticut. Still, taking all that into account, it must be admitted that Ingersoll's motto, like that of Strafford, was "thorough." Even his fellow office-holders found that they had to be on their guard against this champion of the law. In 1757, at the October session of the general assembly, in his official capacity he brought charges against Isaiah Tuttle, a New Haven justice of the peace, for having "grievously misdemeanored himself." Tuttle had been unscrupulously making capital out of the litigious spirit which at this period seems fairly to have carried away the people of this community.¹ This crafty justice of the peace, as the lawyer of one Elizabeth Ward of Wallingford, sued diverse persons whom he proceeded to summon before himself. No one else being present at these trials, he prosecuted the cases, gave judgments against the parties, and then coolly pocketed both his attorney's fees and the perquisites of his

justiceship. Through the efforts of the king's attorney he was dismissed from his office.¹

Until 1758, Ingersoll seems to have confined his efforts strictly to his legal practice, with the result that by that year, although but thirty-six years old, he had succeeded in reaching the top of the legal ladder within the colony.² Indeed, his powerful, disciplined mind and marked ability in pleading at the bar became a Connecticut tradition in after years. President Timothy Dwight of Yale College,³ with his strong Americanism, can be counted on to place a conservative estimate upon a contemporary who differed from him on the most vital questions relating to the welfare of America.

"Few men," declared President Dwight in later years, "have excelled him in clear and comprehensive thought and strong powers of reasoning and few men ever managed a case with greater skill. At his entrance upon the argument, he conceded everything to his antagonist which was not in his own view of serious moment to his client, and often conceded so much, that he was believed by men of less understanding to have given up his cause. But he always reserved the essential points, which he exhibited with the utmost strength and advantage. His eloquence was remarkably calm and dispassionate, but

was exhibited with so much candor and firmness as to be remarkably persuasive. Indeed of the eloquence which is designed to convince, it was almost a perfect pattern. The same candor and fairness appeared in all his deportment."¹

One of the first public functions of importance that Ingersoll was called upon to perform, outside of his work as king's attorney, was connected with a lottery. In October, 1754, he, with two others assisting him, was placed in charge of the affair which had been authorized for the purpose of raising £660 "for the finishing of said wharf at Ferry Point in New Haven which through the present unhappy circumstance of trade was stopped." The lottery in question was not a success for some reason; the speculative spirit of the people was at so low an ebb that only £150 was netted.² The next year Ingersoll is found acting as the agent for "the Proprietors of the Common and Undivided Lands in New Haven,"³ and in this capacity he petitioned the general assembly for permission to sell enough of the land to allow for the laying out of the "eighth division."⁴ In the same year, as "agent for the governor and company of the colony," he was called upon to take charge of certain important

financial matters in which the colony was involved.¹ That he had now begun in many ways to wield great influence in the affairs of the commonwealth is evidenced from a peculiar favor that Gurdon Saltonstall, son of the famous governor, and one of the most influential personages in the colony, besought of him in 1756.² The circumstance was as follows:

The previous year the last of the intercolonial wars broke out. For the successful termination of this struggle Great Britain was obliged not only to mobilize her resources but also to take steps to cut off the enemy from supplies. This last step necessitated, on the part of those in the colonies who had been plying a profitable trade with the foreign West Indies, a sharp readjustment in their commercial pursuits. Many colonial skippers, however, appear to have persisted in trading with the French Sugar Islands, in spite of the fact that the inhabitants were a hostile people. To check this tendency, at least on the part of Connecticut traders, the general assembly, loyally supporting the war, passed an act obliging all masters of vessels to give bond not to land provisions except in a British port, and also placed an embargo on shipping.³ At this juncture, October 25, 1756, Colonel Saltonstall wrote from New London ask-

ing Ingersoll to intercede with the governor; Thomas Fitch, to secure for him, if possible, a waiver of these trading restrictions. He desired to make a voyage to Surinam with a hundred barrels of beef and pork and a hundred barrels of flour, and in return for these provisions he planned to bring back forty Surinam horses. Saltonstall, however, was apprehensive regarding the attitude of the public toward his project, for he significantly begged Ingersoll not to "chose to ask it of the Assembly as there is danger they'd surmise I had some other design."¹

For reasons that are now obvious, Jared Ingersoll, with all his abilities, his sturdy uprightness, and high-mindedness in general, never won popularity with the people of the colony. Many of the more thoughtful men might confide in him and honor him, but his record of strict law enforcement, his early sympathy with the inherited order of things, his meticulous care that "the King Our Sovereign Lord" should be kept before the eyes of the people as plaintiff in all infractions of the peace, could not stir the imaginations of those industrious husbandmen who were so intent upon the task of digging the ever present glacial rocks from the Connecticut soil, and fashioning them into fences, in planting and reaping, in suing their neighbors, in quarreling over the Saybrook Platform, and in worrying over a multitude of small community interests and scandals, that the king and his law, the British constitution and British traditions were for most of them concerns of too remote a nature to appeal to their sympathies or to awaken their enthusiasm.²

It was probably due to this difference in point of view that the lower house of the general assembly, reflecting the popular impulses, rejected a bill passed by the conservative and aristocratic upper house in 1756, which provided for Ingersoll's appointment as the colony's agent in London.¹ Significantly, in his stead the lower house designated Jonathan Trumbull of Lebanon, later Connecticut's famous war governor, a man in sympathy with the democratic New Light faction, and with all his tact and judicial temper inclined to clash with the supporters of the crown's interests.² The upper house was finally brought to ratify this choice at the following session in May. But Trumbull, "as he had not had the small pox prevalent in London and considering the circumstances of his family," could not see his way clear to serve.³ Again, in 1758, Trumbull was selected to go to England but once more refused; the lower house thereupon gave way and agreed to the selection of Ingersoll, who after modestly "pleading his unacquaintedness with public affairs of the colony and total ignorance of the persons and manner of the British Court," accepted the post, with a yearly stipend of £150 and all expenses "except that of cloathing."⁴

In selecting Ingersoll for the London mission it is no exaggeration to say that the colony chose for this work her most able and distinguished advocate of that period, one who in the eyes of his contemporary, William Samuel Johnson, was by 1758 "particularly eminent in the practice of the Law."¹

CHAPTER III

INGERSOLL'S FIRST LONDON AGENCY, 1758-1761. THE AFFAIR OF THE *ST. JOSEPH* AND *ST. HELENA*. INGERSOLL IN LONDON

THE instructions that Jared Ingersoll received before leaving for England to represent the colony as its special London agent make clear the scope of the work that confronted him.¹ First and foremost, he and Richard Partridge, the regular agent, were to make plain to those in control the extent of the burden that Connecticut had so far sustained in the defense of the English colonies in the French and Indian War then in progress; in this connection they were to seek financial reimbursements for the colony. They were called upon to take "prudent care of the affair of the Mohegan Indians," which concerned the title of lands that had belonged to these natives. They were also to guard the colony's interests in the boundary dispute with Massachusetts Bay, which, like the Mohegan question, was a century old and had at last ended in a contest over the possession of the towns of Enfield, Suffield, Woodstock, and Somers, "which lye south of the line between the two governments." And finally, they were to protect the colony against the protests that the Spanish ambassador had been making to the British government regarding the plundering of the Spanish snow, *St. Joseph and St. Helena*, while in New

London harbor, "which doubt not when truly known will set us in a favorable light on that head."

This last-named matter, regarding the Spanish ship, so illuminates the actual workings of colonial institutions and the lack of any proper articulation of these with the institutions of imperial origin; so clearly exemplifies the extreme provincialism of the Connecticut townsman of that period in his extraordinary attitude toward the unfortunate "stranger within the gate"; and bears so intimately upon the purposes of this study, that more than a casual mention must be made of it. What, therefore, were the facts regarding it, that the assembly desired to be made "truly known" to Pitt through Ingersoll?

The Spanish snow, *St. Joseph and St. Helena*, under the command of Don Christoval de Urannago, and in company with three other large Spanish ships, left Havana, October 14, 1752, for Cadiz, with an exceedingly valuable cargo which had been placed on board at Honduras, and which consisted principally of gold, silver, indigo, sarsaparilla, and balsam, all together valued at about four hundred thousand Spanish dollars.¹ Some time after leaving Havana, it was found that the vessel was leaking and it seemed best to strike for some North American port in order to refit. While still on the high seas the snow encountered the brigantine *Susanna*, bound for New London, under the command of Captain John Simpson. At the request of the Spaniards, Simpson sent on board the *St. Joseph and St. Helena* Daniel Vosper, a pilot, and by this help the ship arrived, late in November, near the harbor of New London.

In light of the evidence, however contradictory some of it is, the conclusion can hardly be avoided that Vosper,

acting in conjunction with Captain Simpson, who had meanwhile reached New London, and with Andrew McKenzie, owner of the *Susanna*, and one James Gardiner, "the best pilot of that town," thereupon, for the sake of salvage, attempted to wreck the snow on the reefs that lie outside the harbor.¹ This outrageous plan was only partially executed, and the precious cargo was removed to New London by means of a schooner, belonging to Captain Richard Durfey, and a small sloop, after the great mast of the rudderless Spanish ship had been cut away in order to extricate her prow from a ledge. New London went wild with excitement and it would appear that almost everyone sought to profit in some form or other by the helpless situation of the Spanish crew, with the result that not only were many things appropriated outright, but immediately extraordinary claims were made against the cargo, then in the custody of the collector of

In October, 1750, the *Nuestra Senora Guadelupe* arrived in a helpless condition off the coast of North Carolina. The most valuable part of the cargo, according to the testimony of Don Manuel de Bonella, the commander, was placed on board two English vessels, which were fastened close to the side of the rudderless ship. On the twentieth of that month these ships suddenly sailed away. One of them, however, was stranded near by on the shoals and the crew was captured by the Spaniards and subjected to prosecution. the port, Joseph Hull.¹ Simpson brazenly demanded one-third the value of the entire cargo on the grounds that by his exertions the Spanish ship with its contents had been saved. In fulfillment of the design of this gentleman and his co-partners, an application was made to the judge of the court of vice-admiralty for this jurisdiction, who was Chief Justice Lewis Morris of New York, to come to New London for the purpose of granting salvage on a libel against the cargo of the *St. Joseph and St. Helena*. Early in December Judge Morris arrived and set up his court. To conduct the proceedings an interpreter was required, and the owner of the *Susanna*, McKenzie, was not slow in finding a friend who could carry through that delicate work. The supercargo, and, therefore, the one responsible to the owners for the safety of the ship's cargo, Don Joseph Miguel de San Juan, felt that he had fallen into a nest of near-pirates. He would have nothing to do with McKenzie's interpreter and sent to Boston for a reliable man. The idea that these men, who had attempted, according to his conviction, to wreck the vessel, should now be demanding salvage was intolerable to him. Even Colonel Gurdon Saltonstall of New London could not see how a judgment in favor of this libel could stand. The proceedings of the court, in fact, were somewhat in the nature of a farce. Captain Durfey, who rescued most

of the cargo with his schooner and who had quarreled with McKenzie, could not be brought into the scheme. Nevertheless, Morris actually awarded to Simpson, in whose name the libel ran, twenty-three thousand pieces of eight,¹ together with costs. Dark suspicion clouded the whole proceedings; Morris had not borne an enviable reputation. San Juan thought the affair an outrage and refused payment, whereupon thirty saroons of indigo out of the cargo were sold by the court marshal, Joseph Chew, to satisfy these claims.

Durfey, who apparently did not hold the favor of Judge Morris, started common law proceedings against the owners of the ship to satisfy his claims, which were more nearly justified but which to the Spaniard were exorbitant. In fact, Don Juan had one consuming anxiety and that was to get his cargo out of the clutches of New London as soon as possible. Although Saltonstall, a member of the governor's council, had been appointed the colony's agent to arrange either for the repair of the snow or the charter of a new vessel, the supercargo, distrusting everyone in Connecticut, refused his services. His request to the governor to be allowed to appoint an agent of his own preference was denied, with the result

that the contents of the Spanish ship was destined to remain in New London for over two years.

Hoping to find protection somewhere, Don San Juan went to New York and hunted up two merchants of that city, Henry Cuyler and Henry Lane, into whose hands he placed his interests. But Lane, through trickery and the connivance of certain parties in official life, got momentary control of the cargo and with a lavish hand settled the claims against the same. He now started to load the Spanish effects on the *Nebuchadnezzar*, which had been chartered when the *St. Joseph and St. Helena* had been condemned as unseaworthy. It was then discovered that a chest containing over £5000 in gold had been opened, looted, and stuffed with trash.¹ Moreover, Lane, after demanding for his services two and a half per cent of the value of the entire cargo, proceeded to abscond with four chests full of silver.² San Juan, after appealing first to Governor Wolcott, then to Governor Clinton of New York, and then to the Connecticut general assembly for relief and protection, feeling that he had been mercilessly plundered and thwarted for over a year, deserted his cargo and went to New York, after informing the Connecticut authorities that the whole case would be presented before the high court of admiralty in London and that the colony would have to pay all damages.

The situation had become serious for Connecticut. Although the colonial government was not responsible for the disgraceful admiralty decision, nor accountable for Lane's proceedings, which Wolcott denominated "an

atrocious crime,"¹ yet it had been, under the particular circumstances, lax, especially when the collector of the port refused to receive back into his custody the cargo, after it had once been released through Lane's duplicity. In fact, series of looting expeditions were carried out against these treasures, which were stored in buildings and on board the *Nebuchadnezzar*.² At first there had been an armed struggle between the collector of the port and the colony's agent for control of the cargo; later, when the scandal of the thing filled the air, the responsibility was tossed back and forth in the most extraordinary manner.³ The conscience of the colony, however, had at last become awakened, especially when the conviction came home that the people of the colony would pay for the orgy. The governor, who was furiously assailed, at last asserted his authority and called upon the civil authorities of New London to bring to justice those who were guilty. "What a shame will it be to this Governm^t to have the ship burnt the stores stolen and embezled and such vilanies nether prevented nor pun-

ished. If such thing shall escape with impunity there will be no living for any man much longer in this colony.'"¹ Reports were spread that Governor Wolcott himself had been a leading beneficiary in the Spaniard's misfortune, with the result that in the May election of 1754 he was "thrown down with a vengeance,"² although the king's attorney for New London county "had succeeded in bringing to justice some of the guilty parties."³

But the matter did not stop there. As early as the spring of 1753, the Spanish ambassador had protested against the salvage award.⁴ In January, 1754, Antonio and Rogue Aguado of Cadiz, chief owners of the cargo, sent their London legal representative, Jacob Franco, to call upon the Connecticut agent, Richard Partridge, and to inform him that the people of Connecticut were expected to make good the damage.⁵ In June the English government decided to take cognizance of the affair, with the result that Sir Thomas Robinson, principal secretary of state for the southern department, wrote to the governor of Connecticut commanding him in the name of the king to see that the cargo was completely restored to its owners.⁶ Thomas Fitch, now governor in place of Roger

Wolcott, proceeded to appoint Jonathan Trumbull and Roger Wolcott, Jr., to take charge of the remaining effects of the Spaniards and to see that they were safely loaded on board ship. This was done and, thereupon, Captain Whitwell of His Majesty's Navy, who had been sent to New London with the *Triton*, convoyed the *Nebuchadnezzar* in safety to Cadiz.¹

However, Secretary Robinson again wrote to Fitch, in November, 1755, informing him that the Spanish minister, d'Abreu, had complained to the government that, according to the proprietors of the treasure, nearly all of their money and part of their goods were detained within Connecticut. Sir Thomas sharply reminded the governor that it was the king's intention that entire restitution should be made to the merchants, and added that another ship of war had been ordered to repair to New London to take on board the remainder of the Spanish property.² Soon after writing this letter Robinson resigned from the secretaryship and was succeeded by Henry Fox,³ and to the latter Fitch addressed himself late in the spring of 1756, in an endeavor to clear the colony and to explain why the *Syren*, after arriving in Connecticut waters, had found nothing to carry to Spain.⁴

This was the status of the Spanish affair when Ingersoll's instructions were drawn up. Taken all in all, it was a shameful episode, streaked through and through with dark designs, avarice, knavery, blind suspicion, distortion of evidence, and eleventh-hour efforts at restitu-

tion and fair play; it showed that a Spanish treasure ship was almost as much a temptation to the dwellers of a colonial seaport in the eighteenth century as to the buccaneers of the days of Elizabeth. That those who had taken a leading part in the proceedings connected with the ship in no wise felt secure in 1758, is shown by a letter which Joseph Chew, who had acted as marshal in the vice-admiralty court proceedings, wrote to Ingersoll, the latter part of September of that year, upbraiding the latter for neglecting to come to New London and, as his attorney, help him in his affairs. Chew appeared to be very nervous and declared that his own deposition was ready and that the other depositions would soon be prepared.¹ He, of course, had hired Ingersoll to protect him in any proceedings that might take place in London over the matter.

Before leaving for England, Ingersoll was not only

That which made the situation even more grave regarding Spain's attitude toward the whole affair was that the privateer *Peggy*, commanded by Richard Haddon, committed certain acts of violence in 1756, against the ship of Don Felique D'Frances, who was also a subject of the king of Spain. But in this case the colony acted with decision, when notified by the English government. Fitch, on October 15, 1757, called upon the sheriffs in Connecticut to seize the vessel should she arrive. given the joint instructions, previously considered, but he also was specially instructed "considering Mr. Agent Partridge's advanced age and the probability that the colony may have occasion to appoint another person to transact our affairs in his stead . . . therefore, to make a prudent enquiry after some proper person of known ability, skill, and Disposition, who, when occasion shall call upon it, may be appointed our Agent."¹

With these instructions, Ingersoll sailed to England late in the fall of 1758. Not long after his arrival, Partridge passed away and he was thereupon left in sole charge of the colony's affairs, not the least pressing of which, for the moment, was to rescue the Connecticut interests from the insolvent estate of his late co-partner in the agency.²

During the period that Ingersoll was accredited to the court of Great Britain as agent, by far his most important work lay in urging the claims of Connecticut to compensation for the expense she incurred at various times during the years from 1757 to 1760 inclusive, in maintaining bodies of her militia in the field.³ According to a circular letter sent out by Pitt to the colonial governors, early in 1757, the home government agreed

to furnish the troops raised by the colonies with ammunition, tents, and subsistence. All that the colonies were to do was to levy, clothe, arm, and pay the men.¹ In later circular letters, the secretary of the southern department offered not only to take from the shoulders of the colonies the expense of providing arms but, regarding the clothing and pay of the soldiers, assured the colonies that strong recommendations would be made to parliament at its next session to grant a proper compensation for such expenses as above, "according as the active rigor and strenuous efforts of the respective Provinces shall justly appear to merit."²

Upon the basis of this encouragement, Connecticut sent repeated reënforcements to the relief of Fort William Henry which, however, was captured by Montcalm, August 9, 1757, resulting in serious losses to the colony. Early in 1758 she voted to put at the service of Abercrombie five thousand men,³ in order to help make up the quota of twenty thousand that Pitt expected New England, together with New York and New Jersey, to furnish for the mismanaged Ticonderoga expedition and the other immediate military enterprises. In order to meet the extraordinary expenses, bills of credit were issued by the colony, with the provision that the reimbursement secured from England should be applied to discharging the same.⁴

As early as 1756 parliament granted to New England, New York, and New Jersey, as a "free gift and reward for their past services and an encouragement to them to continue to exert themselves," the sum of £715,000, out of

which £26,000 was apportioned to Connecticut.¹ After the fees at the exchequer and the treasury office, and the cost of insurance, carting, and shipping, amounting to £1098.15, had been paid,² the remainder of the money, made up principally of Spanish milled pieces and Portuguese gold coins, was packed in twenty-five chests and eighteen bags and sent to America.³ This appropriation was the beginning of a series of grants to the colonies during the period of the war. In order to facilitate repayment, Pitt had impressed upon the governors the importance of having in the hands of duly authorized agents in London, the necessary documents relating to the colonial military expenditures.⁴

The part played by Ingersoll and his fellow agents in securing reimbursement was, in fact, very important; they laid before the Board of Trade and other departments and branches of the government statements of expenses when desired; they actively urged the claims of the colonies with those in positions of influence; they saw that the various fees, for sign manuals and warrants, for orders and the writing of bonds, as well as the other charges against the colony at the exchequer, were met after parliament had acted; they took charge of the money, deposited the same in some bank of standing and drew upon it at the order of the colonial governments.⁵

During the later period of the war, instead of sending to America chests of gold and silver, as was the case in 1756 and in 1758,¹ the Connecticut agents were instructed by the general assembly to leave the specie in England "on account of the price that foreign coins bear" in London. Bills of exchange signed by the governor were thereupon issued against these funds, after the specie had been purchased by the highest bidder.²

The only serious difficulty that Ingersoll met with in his efforts to secure reimbursements was in connection with the expenses entailed by the colony in the billeting of the militia sent to the relief of Fort William Henry. Although the general assembly had appointed two different committees to prepare "the most material facts attending the affair," with authenticated evidence,³ although the committee of the pay table forwarded a statement of the number of troops employed and the amount of rations consumed, with their affidavits attached thereto, on account of the lack of the necessary vouchers, claims to the amount of £912.8.7 were left unpaid.⁴ Govtation as the Bank of England." ernor Fitch, in fact, was so concerned lest this sum should slip through the hands of the colony, that late in 1761, after Ingersoll's return to New Haven, he sent to the latter his stallion from Norwalk with an appeal to ride the animal to New York in haste in order to see Lord Amherst, who was in charge of the military affairs in America, and bring the negotiations to a settlement before the latter left that city.¹

The other matters referred to in the joint instructions dragged along beyond the period of Ingersoll's agency.² However, by that time the affair of the *St. Joseph and St. Helena* had lost its serious aspect for the colony, since Pitt was urging war against Spain on account of the so-called Bourbon Family Compact. Ingersoll's other leading activities in England at this time, in connection with the effort to get a vice-admiralty court for Connecticut, his contract with the Navy Board for masts, and his

work in behalf of the Susquehanna Company, will be dealt with in succeeding chapters.

The period of almost three years that he spent abroad afforded him, on the whole, a most delightful and profitable experience. He established himself in North Palace Yard, near Westminster Hall, in the lodgings of one Ann Davies, proceeded to get in touch with leaders in governmental affairs, became the friend of prominent Englishmen and colonials, busied himself with various Connecticut matters that took him to Whitehall, not a great distance away from his lodgings, where the Treasury Board, the Board of Trade, and the Lords of the Admiralty sat, and where in the Cockpit were the offices of the secretary of state for the southern department and the chambers of the Privy Council; he also attended sessions of parliament and spent much of his leisure time in Westminster Hall, where the common law courts and the court of chancery were established, listening to the arguments of the leading British advocates, and for entertainment of a lighter sort he attended the theater, when Garrick was acting.¹

The man of the hour in England in 1759 was, of course, William Pitt. Ingersoll early had the opportunity of meeting the latter at his home, and also from the visitors' gallery of the House of Commons listened to his oratory.

The quaint description that he has left of this popular leader is not entirely flattering. According to him Pitt had a "thin face, somewhat pale, a Roman nose, his legs pretty small and almost all the way of a bigness—his ankles being swelled with gout, which makes him hobble rather than walk when he goes. If he had any fault, it is his language being a little too much swollen, seeming to border on bombast and fustian. I believe he is a greater speaker than reasoner."¹

If the great commoner failed to captivate Ingersoll, it is nevertheless certain that he was deeply and happily impressed with the new king, George III.

"As to news," he wrote to Ezra Stiles in 1761, "I know of nothing remarkable. The Parliament was dissolved yesterday. I had the pleasure of being present in the House of Lords when the young King in his Regalia, attended by a numerous and most brilliant assembly of nobility, Ladies and Gentry, received the farewell speech of that venerable Personage, Mr. Onslow, speaker of the House of Commons. . . . The scene closed with the King's speech delivered, I do assure you, with all the grace or beauty of an accomplished speaker. He is certainly not only as a King disposed to do all in his power to make his people happy, but is undoubtedly of a Disposition truly religious and to those more noble accomplishments has the at least desirable additional circumstance of a good Person and fine Elocution."²

It might be mentioned at this point that among the circle of friends and acquaintances that Ingersoll made during his sojourn in England there were two who were destined to play important parts with him five years hence in the Stamp Tax crisis; these were, Thomas

Whately, counselor-at-law, a student of finance and later a secretary to the Treasury, and Benjamin Franklin, the colonial agent for the Pennsylvania Assembly.¹

It should be borne in mind that in sending Ingersoll to England, the Connecticut government had not expected that he would become the permanent agent, in view of the important interests he had within the colony. In fact, after settling the amount of his salary, which was £150 sterling, as was stated, the assembly cautiously empowered the governor "to draw a bill of exchange on Richard Partridge of London, Esq., for such sums as his Honor shall think needful not exceeding £300 sterling payable to Jared Ingersoll for his expenses during his stay in Great Britain to transact our affairs as agent there." At that time he was particularly instructed to find, before returning to America, someone who was suitably qualified to represent the colony as permanent agent. Early in 1760 he decided to recommend to the general assembly, his friend, Richard Jackson, commonly dubbed among his acquaintances, "Omniscient" Jackson, because of his extraordinary stores of knowledge, who was, in fact, a most distinguished barrister, and later not only the standing counsel for the South Sea Company and for Cambridge University, and the legal adviser of the Board of Trade from 1770 until its dissolution in 1782, but also, from 1762 to 1784, a member of

parliament and in 1782 a lord of the Treasury. This nomination was ratified by the assembly in March.¹

While accepting the appointment, Jackson apparently was unable to give the time necessary to care for the more routine matters of the colony. Therefore, later in the year, upon the recommendations of both Ingersoll and Jackson, Thomas Life "of Basinghall St., London, Gentleman," was designated by the assembly as joint agent,² with the provision "that Mr. Jackson's salary be £100 sterling a year and Mr. Life's £50."³

The circumstances which led Jared Ingersoll, after thus providing for the interests of Connecticut, to tarry for an additional year in England without pay, will be considered in the following chapter.

CHAPTER IV

THE CONNECTICUT VICE-ADMIRALTY JURISDICTION. THE PRESERVATION OF THE KING'S WOODS IN CONNECTICUT. THE STRUGGLE FOR THE MASTING TRADE OF NEW ENGLAND

LATE in the spring of 1760, Jared Ingersoll, who was still in London, received a communication from Governor Fitch, which contained a request, in the form of a resolution of the general assembly, that the home government be asked to create a court of vice-admiralty exclusively for Connecticut.¹ In light of the traditional unpopularity of the admiralty authority in America,² this is a surprising, if not a unique, colonial document. However, before dealing with the conditions that gave rise to this, it would be well to examine briefly the situation within the colony at that period.

When admiralty courts were erected by the crown in America, at the end of the seventeenth century,³ under

The complete personnel of a vice-admiralty court was a judge, a register, a marshal, and an advocate.⁴ The judge, by the terms of his commission, possessed very wide powers in dealing not only with maritime cases,⁵ but also on the basis of a law passed in the eighth year of the reign of George I, with cases arising out of trespasses committed against the king's woods.⁶

As far back as 1699, when William Attwood was selected as the first judge of vice-admiralty for the northern jurisdiction, the practice arose of making the chief justice of the province of New York also an admiralty judge.⁷ In 1760 Colonel Lewis Morris was serving in

this double capacity, although apparently holding his vice-admiralty post under a clouded commission.¹ As was noticed in the preceding chapter, whenever it was necessary for Judge Morris to take cognizance of cases that arose in Connecticut or New Jersey, instead of summoning the parties to appear before him in New York, he was obliged, according to his commission, to go into the colony in question and there hold court, a practice that involved delays and considerable expense, which had to be borne by those who called upon him, unless it so happened that the costs were saddled upon the defendants.²

While important cases occasionally arose within this jurisdiction, it would appear that Judge Morris's court was not pressed with the sort of business, as a rule, requiring the services of an advocate, whose work was to prosecute cases in this court in the name of the king. In 1730 Richard Bradley, attorney general for the province of New York, had been given a commission also as advocate; which was co-extensive with the jurisdiction of the court of vice-admiralty.³ However, according to information furnished the Board of Trade in 1760, Bradley

had been dead for years and there had been no renewal of the office.¹ The reason then assigned was that there was little occasion for the office, since the work of the admiralty court, when sitting at New York, consisted largely of determining questions relative to prizes brought into New York in time of war.² So little, in fact, was known about this post of king's advocate, pertaining to this jurisdiction, in 1753, that the surveyor general of the king's woods in America, Benning Wentworth, in urging the appointment of a Connecticut "Judge Advocate," by the general assembly, that year, contended in a letter to the governor that the king's advocate for New York had no jurisdiction in Connecticut.³ In reply to Wentworth, Governor Wolcott was forced to confess that "A Judge Advocate being an officer wholly New to us, it will be proper for you in your Answer to this to enclose me a form for his Appointment or Commission with advice of the duty and business of this post."⁴

In fact, Connecticut had had very little experience with the operation of a vice-admiralty court and this experience had not been of a happy nature. At the very time that Wentworth made his request, the colony was still discussing the scandal arising out of the admiralty proceedings at New London in December of the previous year, in connection with the Spanish ship affair, and there is every reason to believe that the Connecticut gov-

ernment was anxious to have just as little contact as possible with this particular type of court. Not only had there been an armed conflict between the guards appointed by the colony's agent, Gurdon Saltonstall, and the admiralty marshal, Joseph Chew, over the possession of the Spanish treasure,¹ which certainly did not spread good feeling, but Judge Morris had seen fit to write a very threatening letter to the governor. "What treatment," he declared, "I have met with myself, I shall take some other opportunity to acquaint your Honour, at the same time I must acquaint your Honour that I shall represent the affair to His Majesty and his Ministers in the strongest Terms Imaginable at the same time I hope your Honour and the Government by your future Conduct will mitigate the just Resentment of the British ministry."²

But, in spite of this unhappy experience in 1752, which for years plagued the colony; in spite of the open hostility of Massachusetts and of Rhode Island in 1760 toward the vice-admiralty jurisdiction,³ the Connecticut general assembly in March voluntarily appealed to the crown to establish a court of vice-admiralty exclusively for the colony. This resolution, it may be suggested, before going further, represents perhaps the most notable reversal of public policy, the most radical change of attitude toward the direct interference of Great Britain with the administration of affairs in Connecticut, in the entire history of that colony. It can, indeed, be ventured with little fear of contradiction that the expectations of gain from this move must have been very large to have led these representatives of the people to swallow their

inherited distrust and dislike of this civil law court,¹ operating without jury, under an autocratic and sometimes venal judge and deriving its authority and vitality solely from the British crown.

The reasons for this, as set forth by the assembly, were that it was believed necessary to begin getting masts by way of the Connecticut River; this would be of some advantage to the people of the colony as it would enable the importer to make remittances for his goods, in place of draining the colony of its cash; since this was so, it was felt that effectual care should be taken to preserve the woods,² which protection could be provided for by the erection of a court of vice-admiralty within the colony.

In dealing with this question of timber preservation, the fact cannot be overlooked that efforts previously made to preserve the king's woods in Connecticut had not been at all popular. In 1747 Governor Jonathan Law, in addressing the general assembly, took occasion to refer to the appointment of a deputy surveyor of the woods for Connecticut, remarking that he should like to know the sentiment of the deputies, "I know its neither silver

or gold.”¹ Both in 1753 and 1755 the colony had treated with extreme coolness the appeals of Surveyor General Benning Wentworth and those of his deputy, Daniel Blake, that action should be taken (for the sake of the preservation of the woods) to make the vice-admiralty jurisdiction effective within the colony. January 17, 1753, Wentworth wrote to Governor Wolcott apprising him of the fact that his deputy had met with resistance in the execution of his duty within Connecticut, and asking him to publish the surveyor general’s commission and to issue a warrant to all civil officers to aid those in charge of the king’s woods in the performance of their duties; in addition he requested, as was noticed above, the appointment by the colony of a judge advocate to prosecute trespassers against the king’s woods, in the court of vice-admiralty.² This last request was repeated June 25 of the same year, when Wentworth complained of the shocking treatment of Blake, who, while in the execution of his office of deputy surveyor, had been hurled into a mill pond by his fellow townsman, Daniel Whitmore of Middletown. The surveyor general warned the governor that “these are offenses of a Dangerous nature & upon a due Representation thereof by me to His Majesty may be injurious to your colony.”³ Although Wolcott had promised to lay before the general assembly at its May session the question of appointing a Connecticut “Judge Advocate,”⁴ although Daniel Blake had petitioned the assembly in its October session to appoint Samuel Johnson, advocate general, Samuel Merriman, registrar, and William Wright, marshal for the vice-admiralty court, when sitting in Connecticut,⁵ the depu-

ties were cold to all suggestions. As a result, two years later Wentworth again wrote to the governor of Connecticut in a spirit of loud complaint, demanding that Whitmore, the assailant of Blake, be punished, and threatened to take the case through the Connecticut courts and then appeal to his majesty the king, in case ample satisfaction were not given to him; he also significantly gave notice that he had applied for the establishment of a court of vice-admiralty for Connecticut.¹ But the menacing letters of Wentworth seemed to fall on deaf ears, with the result that the unfortunate Blake, after being subjected to other indignities, among which was "unlawful imprisonment by William Pitkin," in despair resigned this office, and in 1759 wrote a pathetic appeal to the Board of Trade asking for redress against the people of Connecticut for the hostility shown him while trying to care for the king's woods.²

The question, therefore, immediately arises, How did it happen that the people of Connecticut, previously so utterly indifferent to the preservation of his majesty's woods, came suddenly to appreciate the advantages that might flow from it, with such ardor that they were now anxious to see established in their midst a court foreign to their most cherished political ideals?

Connecticut, it should be remembered, had always labored under the serious handicap of lacking an important export staple which New Hampshire with its timber, Massachusetts with its fish, Rhode Island with its rum, New York with its furs, Virginia with its tobacco, North Carolina with its naval stores, and South Carolina with its rice and indigo, fortunately possessed. These export staples naturally served not only to keep within the favored colonies the specie circulating there, but also to provide the means for an important direct commerce with England and the outside world under the more or less formal restrictions of the navigation and trade acts—thus adding greatly to the wealth of the people. But Connecticut was unhappily situated, hidden behind Long Island and close to the most superb harbor of the North American coast. She, therefore, had been obliged to witness the practical monopolization of the direct foreign trade to England and the other parts of the Old World by New York and her New England neighbors, with the consequent economic subjection of her people to outside commercial interests. Although it would appear that in the '50's, before the outbreak of the Seven Years' War, the colony had been fairly prosperous, the tide, by 1760, had turned against her, steeped as she was in debt,¹ and a truly alarming decline in the value of Connecticut lands took place, as people began streaming away to newer and more hopeful sections of the country.²

Now, however, a way seemed to open for clearing away

this economic depression and placing the colony on a permanently prosperous basis. No wonder, under the circumstances, that the chance of bringing this about made an irresistible appeal to the public.

What was known as the great New England pine belt of that day extended from Nova Scotia west and southwest beyond the Connecticut River. The British government had early grasped the importance of preserving this virgin forest from waste, as an inexhaustible source of masts and other naval supplies, which it had been compelled to draw principally from Sweden and other foreign parts. It would appear that as early as 1692, Edward Randolph was acting as surveyor general of his majesty's woods in America,¹ an office created for the protection of the timber; he was followed in turn by Jahleel Brinton,² John Bridger, Charles Burniston, Charles Armstrong, and David Dunbar, which latter, in 1744, surrendered his office to Benning Wentworth,³ who retained this post until, in 1767, he turned it over to his nephew, John Wentworth. The surveyor general was charged with the responsibility of encouraging, by all legal and proper methods, the production of naval stores, of preventing the destruction of trees fit for masts, and of bringing to justice violators of the law regulating the use of the pine woods. For, by a series of parliamentary acts, the timber of North America, and especially the white pine belts, had been placed under the special protection of the king.⁴ An act passed in the second year of

the reign of George II provided that, without special license from the crown, no white pine trees, except the property of private persons, should be cut within Nova Scotia, New England, New York, and New Jersey. The surveyor general was aided in his work of executing these laws and other regulations, by deputies, who went about, placing the king's broad arrow on the finest and most accessible trees measuring over twenty-four inches in girth three feet from the ground. The struggles of these deputies with the loggers of New England is a very dramatic phase of colonial history.¹

The chief logging centers in North America, in 1760, were in New Hampshire and Maine. By far the most important of these was the Piscataqua River district, which for over a century had maintained its supremacy in spite of the transference to Maine, in 1727, of important mast contracts for the royal navy, by the agent, Colonel Westbrook. Along the banks of the Piscataqua and its tributaries scores of sawmills were located, and ships, large and small, were built. At its mouth were Portsmouth and the custom house, the former the most important shipping and commercial center north of Massachusetts Bay, where the headquarters of the surveyor general of the king's woods in America were maintained and whence, according to his energy and motives, the surveyor general carried on a more or less continuous struggle with the New England lumbermen, who were inclined, as a rule, to pay but scant respect to the timber regulations.

The constant activities, legitimate and otherwise, of the loggers had resulted in the clearing away of the pine woods from the most easily accessible regions along the northeastern New England coast, so that by 1760 it had become more difficult and costly to procure from these

parts logs that were suitable for ship masts.¹ The idea was then conceived by Connecticut parties of tapping the New England white pine belt by way of the Connecticut River and, by this means, of building up for Connecticut an export staple of great value and importance.

In order to realize this ambition, however, two things appeared to the promoters not only desirable but necessary. One was to prove to the Navy Board that the Connecticut River was now the logical avenue for the tapping of the great pine belt for that portion of the masts and other ship timber which the British government was drawing from America for the use of the royal navy. The other was to secure the erection of a vice-admiralty court. There were two reasons why a court seemed imperative for the success of the enterprise. In the hands of strong friends, it would take active steps to deal with the constant and unlawful timber deprecations carried on by parties living in these sections along the river where good masting could be obtained.² It would help to protect the contractors, also, from the hostility of the settlers in those localities where the trees were to be cut. While Connecticut contained some little timber suitable for masting,³ yet the white pine trees for this purpose,

significantly, were, according to the plans of the promoters, to be procured farther north along the river, in Massachusetts and in the wilderness beyond the northern boundary of that colony. The people living in these upper sections would not be apt to submit tamely while their country was being denuded of its wealth and the benefits were flowing into Connecticut coffers. Not only would the court help crush this opposition but would stand out against the even more dangerous hostility that was almost sure to come from the powerful interests centered at Portsmouth, in the person of Benning Wentworth.

Probably no one living in America during the later colonial period occupied a more semi-regal position than did Wentworth down to the date of his retirement from public life. For he was not only the surveyor general of all the king's woods in America, but also governor of New Hampshire. It would be little exaggeration to say that for a generation he held the political and economic destinies of that province in the hollow of his hand. His father, John Wentworth,¹ who for years was the acting governor of New Hampshire, under the title of lieutenant governor, was a man of wealth and influence, and it was he who established the Wentworth régime within the province. Benning, before attaining high station in political life, became exceedingly wealthy through commercial activities which frequently carried him to England and to Spain. What New Hampshire had to offer above everything else was lumber, and it appears that he was principally interested in the exportation of this article. In 1734 he entered his father's council, together with his

brother-in-law, Theodore Atkinson. In 1741, upon the death of the lieutenant governor, that office was abolished and Benning was commissioned to the governorship. In consolidating his power, he pursued his father's policy of filling up the important provincial offices, as far as possible, with near relatives; his brother-in-law, George Jaffrey, at one time was president of the council, also treasurer and chief justice; Jotham Odiorne, Henry Sherburne, Ellis Huske, Samuel Solley, and Thomas Parker, all closely connected with the Wentworth family by birth or marriage, were awarded important public posts.¹ Although by 1760 most of these men had passed away, the lack of their presence and support in political life was made up by their successors in office and by the entrance into the council in 1768 of Mark Hunking Wentworth, the governor's brother.² Some idea of the commanding position of Benning Wentworth in 1760 may be gained by the fact that his home at Little Harbor was a palatial mansion of fifty-two rooms, containing a pretentious council chamber, with its armory and guards in times of danger. It was here at Little Harbor that much of the provincial business was disposed of; here, also, the councilors and other men of influence were entertained in the great billiard room with its inviting buffet.³

Now there were two reasons why the Wentworth group that gathered at Little Harbor would be hostile to this Connecticut plan. First of all, it was well known that Benning Wentworth, at that moment, was getting control of the pine and other lands north of Massachusetts, lying on either side of the Connecticut River, and it was natural to expect that if anybody was to secure an ad-

vantage from the exploitation of the timber of that river, the governor would see to it, if possible, that Portsmouth parties should be the beneficiaries. As early as 1750 he had laid claim, in the name of New Hampshire, to the region west of the Connecticut, after having secured a special commission from the crown to grant lands within that province upon a quit-rent basis of one shilling sterling per hundred acres;¹ and, in spite of the protests of New York, he was, in 1760, in the midst of a gigantic scheme of granting away to New Hampshire people and others, the Connecticut River lands, after they had been surveyed and laid out in townships six miles square, modestly reserving for himself, as a fee, a block of five hundred select acres in each township.²

But a far more direct reason for expecting hostility from Portsmouth lay in the fact that in attempting to supply mast contracts, it would be necessary to come into direct competition with the governor's brother, Mark Hunking Wentworth, one of the wealthiest men in New England, whose great commercial interests were centered in the Piscataqua and whose warehouses stood at Portsmouth, where he resided, in a home only less magnificent than that of his brother.³ For Mark Hunking Wentworth, in 1760, was in control of the American mast trade, drawing his logs from the Piscataqua region and adjacent parts.⁴ There was also a suspicion that Ben-

ning Wentworth, on becoming governor in 1741, had not gone out of the lumber business. In fact, it was asserted that in order to obtain the office of surveyor general, which was in the hands of Jeremiah Dunbar, he paid the latter, in 1744, £2000 to get him to relinquish his commission, although the office carried with it a stipend of but £200 a year.¹ As time went on, it became increasingly apparent that the surveyor general was not a disinterested guardian of the king's woods.

No one who knew the Wentworths would be disposed for a moment to imagine that these subtle, far-reaching, grasping, and influential colonial magnates would allow, without a struggle, the people of Connecticut to build up an industry that would strike at their own prosperity and that of New Hampshire. For the complete success of this move might well mean, by reason of the lower cost of production, the transfer not only of the mast contracts, but also of the lumber trade, from the Piscataqua region to the Connecticut, with the rise of New London into great importance as a shipping center and the consequent decline of Portsmouth, unable to meet the destructive competition of the newer section.

To combat the Wentworth and other influences that could be counted on as hostile, a vice-admiralty court, established by the royal authority, presided over by a judge favorable to Connecticut, and employing a fearless and capable king's advocate, was the ideal weapon for those desiring to draw the masting business to the Connecticut River.

Who was the instigator of the plan so eagerly embraced by the Connecticut general assembly? Circumstantial

evidence of the strongest sort, as will be seen, points to Jared Ingersoll. This evidence also leads one to feel that he conceived the plan after leaving America, and after coming in touch with the mast trade situation, in his association with British government officials, and those interested in the importation of lumber into England. There is evidence, moreover, to show that he had a very definite notion as to the person who should be appointed judge of the court that the assembly asked to have erected. In fact, it may here be confidently suggested that, if every phase of his carefully framed project could have been carried through successfully, there would have arisen in Connecticut a group of interests, under the control of Ingersoll, as powerful as those identified with Benning Wentworth of New Hampshire. To work out his plans, he long deferred his departure for home, after turning the business of the agency over to Richard Jackson.

On June 2, 1760, from his lodgings in North Palace yard, Ingersoll addressed a letter to John Pownall, secretary to the Board of Trade, in which he pointed out the fact that in eastern New England the pine woods had become scarce, and that "with cost and difficulty the masting is got down the river"; but as to the Connecticut River, "trees or sticks for the largest masts may be conveniently brought down the said River from the parts above as has appeared from experiments made and 'tis I believe, generally thought by those who are acquainted with that country that the masting from New England must be obtained by the way of this River, in a very considerable measure, at least after some little time longer." Then, turning to the question of the vice-admiralty court, he directed the attention of the board to the fact that it was impossible for the deputy of the surveyor general in Connecticut to hinder "private persons dwelling near

the river from conveying down the said River much of his Majesty's valuable masting timber and when attempts were made to seize said logs there had been a failure of carrying the matter through for want of a Court of Vice Admiralty and of the proper officers belonging to such a court." He thereupon urged the appointment of a judge of vice-admiralty, a king's advocate, and the other necessary officers for constituting a Connecticut court, supporting this by the letter from Governor Fitch in which the desire of the general assembly was set forth.¹

The letter was read to the board at its meeting, Friday, June 13, and was then laid aside until there could be a report from the attorney general and solicitor general relative to the preservation of his majesty's woods in North America.² For over a year Ingersoll exerted himself, but without success, to bring the Board of Trade to the point of making a representation in favor of a vice-admiralty court for Connecticut; he was also busy with other plans, and, before the spring of 1761, had succeeded in persuading the Navy Board to give him a contract for a shipload of masts to be procured by way of the Connecticut River,³ to try, as he later wrote the board, "whether the Navy may not be supplied with that article from that part to better advantage than at pres-

ent from the several places there;”¹—a statement clearly disclosing the great scope of his plans. With this initial advantage gained, he now, once more, attempted to move the Board of Trade to action regarding the vice-admiralty court; this time, by getting the commissioners of the navy interested in the plan. March 27, 1761, he addressed a letter to them reminding them that he had agreed to get a load of masts by way of the Connecticut, and emphasizing the fact that it was very important to have established a vice-admiralty court for the purpose of carrying into execution the contract, offering the same reasons that he had to the Board of Trade, and closing with the argument that “transgressors are with difficulty convicted by trials at common law.” He then tactfully suggested that since they were about to write to the lords commissioners of the admiralty for obtaining permission to cut the timber required to fulfill the contract, they would also suggest at the same time the establishment of a Connecticut vice-admiralty court.² This the Navy Board proceeded to do, at the same time forwarding not only Ingersoll’s letters but also copies of letters that Ingersoll shrewdly had obtained, which Benning Wentworth had written to the governor of Connecticut in 1753 and in 1755, urging the necessity of effective admiralty jurisdiction within that colony. The Lords of the Admiralty received the suggestion with such favor that they instructed their secretary, John Cleveland, to lay the matter before the Board of Trade, with the suggestion that if the plan met with its approval, fit persons should be recommended to act as judge and register. The project seemed on the point of consummation; but Ingersoll’s hopes were dashed for the second

time. Some unknown opposition at the Board of Trade seems to have nullified his efforts.¹

The unwillingness of the Board of Trade to seize this opportunity to aid in vitalizing the royal authority within Connecticut, at this time, is enough to excite attention. From the days of its establishment in 1696, with remarkable consistency the board had upheld a policy in favor of subjecting the colonies to much greater direct control on the part of the home government; it had desired the placing of a crown attorney general within each colony;² for years it had sought the recall of the charters and the destruction of the proprietary control in America; when that had failed, it had attempted to compel Connecticut, Rhode Island, and Maryland to submit their laws to England for ratification as was the practice of the other colonies. But it did not seem at all disposed to encourage Connecticut's application. Ultimately the board was to commit itself to the reorganization of the vice-admiralty jurisdiction in the colonies; yet it was not Ingersoll's plan that was to meet with favor but, significantly, the

one urged as a substitute by Benning Wentworth, who suddenly was awakened to the conviction that, after all, it would be poor policy on the part of the English government to establish an independent vice-admiralty court for Connecticut.

Probably realizing how futile it would be longer to delay his departure from England in the hope of procuring action regarding the court, and being under the necessity, moreover, of applying himself to the task of fulfilling his contract, Jared Ingersoll sailed to America in the *Calcide*, about the middle of 1761.¹ It may be said with a good deal of certainty that he never again was so popular with the people of Connecticut as at the time of his home coming. To show its appreciation of his efforts in behalf of the colony, the general assembly appointed a committee of its leading men to wait personally upon him and to congratulate him on his safe arrival, at the same time thanking him "for the good services he hath done for this Colony, during his agency at the Court of Great Britain."² In fact, no one, in 1761, was considered to be a firmer friend of Connecticut interests than Jared Ingersoll.

By November Ingersoll was prepared to take active steps regarding the procuring of the white pine sticks. On the fourteenth he dispatched Captain Willis to the surveyor general at Portsmouth, bearing a copy of the mast contract and a letter requesting Wentworth to appoint some proper person to designate the trees to be

appropriated. Willis was also authorized to acquaint Wentworth "more particularly when & where it will be needful to have the Service performed."¹ A month later he was able to inform the surveyor general that he had agreed with Willis and Matthew Talcott, both of Middletown, Connecticut, to procure the stipulated "stores" which would be secured along the Connecticut "from Deerfield & the Cowhees' Inclusive"; at the same time he asked for the customary licenses.² Everything appeared to move smoothly. That he was strongly entrenched at this time with the Navy Board, is vouched for by the receipt of a request in January, 1762, from that body that he should inform it as to the possibilities of an early delivery of the masts, in order that a time might be fixed upon "for coming to a new contract for supply of American Masts,"³ in reply to which he stated his hopes of having the timber delivered at Portsmouth by the following Christmas.⁴

However, Willis and Talcott, who by this time were up the river in Massachusetts with their loggers, were encountering difficulties and unusual expense.⁵ There

apparently was quite a search for suitable trees. After these had been selected, it was necessary to "blaze" the way to them from the river by cutting down the obstructing trees. The contract called for eighty sticks suitable for masts; but to provide for contingencies, eighty-nine of the white pine giants were felled, some, unfortunately, breaking in the fall; eighty-four of those that were down appeared sound. After this work and the blazing had been finished, it was found that besides the big trees, sixty-three smaller ones, together with a number of defective trees, were down.¹ Then came the task of "balking" the trees to the river, which had to be done at that period by the use of numbers of oxen.² The men succeeded in getting one hundred and forty-seven of the pines to the water's edge. One suitable tree, alone, was left lying in the wilderness; this was on account of the opposition shown from the beginning by the people of the neighborhood, which reached such heights toward the end that, according to Willis and Talcott, Captain Zedekiah Stone of Petersham went to their camping ground in their absence and carried away their hay, which necessitated giving up the plan to "balk" the remaining tree.³

The log drive that thereupon ensued down the Connecticut River was not very successful by reason of the low state of the water. Twenty-one of the trees, among them one of the finest of the masts, got lodged on a rapid and had to be left there for the high spring

waters.¹ Another magnificent thirty-seven-inch stick was broken in the drive. Less than the contract number of logs reached the lower river, with the result that drivers had to go up the river in low water to get down the necessary number. By January, 1763, a shipment might have been made, although a good many trees were still held up the river.

It is not apparent that Ingersoll ever ventured, himself, into the logging country. He, however, wrote the commissioners of the navy, in October, 1762, that the work was progressing hopefully and that it was receiving his closest attention "from views not only of discharging my present Obligations but also of future benefits as well to the public as to myself."² The following January he informed them that the logs were down and that he had sent for an experienced lumber liner to give expert judgment and proof regarding them.³

Up to 1763 the Wentworth group made no outward attack, although they seem soon to have come to a complete comprehension of the scope of Ingersoll's plans, and, in alarm, to have sent John, the talented son of Mark Hunking Wentworth, who was associated with his father in his commercial enterprises, to England, as early as 1762, for the protection of the family interests.⁴ Each side was playing a deep game for great stakes, and every move was a studied one. Ingersoll would win the mast trade by getting his white pine sticks more cheaply and quickly than the same could be procured along the New Hampshire and Maine rivers. Moreover, to protect his

enterprise, he had now conceived of the idea—since his original plan for a district Connecticut court of vice-admiralty had come to naught—of securing something almost as desirable: an appointment as deputy judge of vice-admiralty for the colony of Connecticut. It happened that Judge Lewis Morris died, July 3, 1762; his son, Richard, thereupon fell heir, as it were, to his post. In fulfillment of this new plan, Ingersoll not only wrote to Richard Morris regarding his desires, but even to his college friend, William Livingston, also of New York, asking him to use his influence in furtherance of this end. When Livingston waited upon Morris, the latter declared that he was not in a position to make any answer to the proposal, owing to the fact that he had only up to that time received an appointment as judge of admiralty for New York. However, the latter part of December the judge wrote to Ingersoll, stating that he had received notice that his warrant for a commission as judge of admiralty “for the three provinces” had been made out, and that when he came into Connecticut to publish his commission he would “be proud” to appoint Ingersoll his deputy.¹ Clearly Jared Ingersoll’s fortunes were mounting. To crush him, the Wentworths felt themselves under the necessity of raising up such a storm of disapproval against his enterprise and his ambitious plans as would condemn it in the eyes of the home government. This they now proceeded to do.

Late in January, 1763, Willis and Talcott wrote from Middletown, Connecticut, where most of the logs were being held, saying that a Colonel Symes, who claimed to be a deputy under the surveyor general, had come to

inspect the logs, saying that he had been informed that they had been destroying timber. They declared that upon conversation with Symes they found out that his coming "was wholly by Mr. Mark Wentworth's Motion." Symes, they also informed Ingersoll, proceeded to measure some of the smallest sticks and they suspected from the proceedings "that his coming was to furnish Mr. Mark Wentworth with a pretense to Inform the Commissioners that they had not or would not get Timber to answer the purpose."¹ A month later they wrote Ingersoll again, in haste, informing him that Colonel Symes had received orders to seize all of their logs under contract length; they were persuaded, they informed him, that this proceeding was "owing to Mark Wentworth on purpose to embarrass and bind us."² Ingersoll immediately took alarm. The day after getting the report, he addressed a letter to the Navy Board, informing them of this new development. He insisted that the only sticks sent down the river under contract size were those that had to be felled to blaze a way to the large timber; he presumed, however, that Wentworth would communicate with them regarding the matter and he desired to present it in its true light.³ That he realized the seriousness of the situation is shown by a second letter, addressed to the commissioners that same day, in which he declared that "if things succeed according to Expectation tis not unlikely I may think of going over to England myself with the Masts."⁴ He also immediately set out to Hart-

ford, where he was able to get in touch with Governor Fitch, and from that place wrote to Colonel Symes, expressing his surprise at the surveyor general's order, and protesting that the extra number of logs was only designed to cover losses of sending them down the river.¹

Wentworth now waited until early in July, when he addressed a letter to Governor Fitch, complaining of the "uncommon waste made in the King's woods in the hinter part," stating that, notwithstanding the vigilance of his officers, this timber so wasted had been transported into Connecticut; he then declared, "I must apply to you for your Protection and Countenance to my officers in proceeding against the offenders in case they may be found," and ended by demanding a proclamation to the civil and military officers to aid him in the preservation of the king's woods.² Fitch coolly proceeded to send a copy of this letter to Ingersoll and needlessly warned him that he had reason to believe that Wentworth had his timber in mind and, thereupon, suggested that "it may be expedient, for political ends at least, (if his case be as I guess) for me to grant his request. I acquaint you with the thing in order for your advice with Respect to the Care and Caution it may be proper to be used in drawing the Proclamation."³

It seems to have been Wentworth's desire to let the clamor against Ingersoll, which he had raised and was feeding gradually, take effect in London before proceeding further. However, the latter part of October he was again ready to attack. On the eighteenth, he addressed a communication to the Board of Trade in which he advo-

cated the appointment of a judge of vice-admiralty whose authority should extend over all the colonies in matters relating to the woods set apart for his majesty's use.¹ He, of course, was not only aware of Ingersoll's efforts to secure the establishment of a court of vice-admiralty for Connecticut, but, it would appear, was acquainted with the attempts that the latter had been making to have himself appointed deputy judge of vice-admiralty for Connecticut. By securing the creation of a court possessing superior jurisdiction with reference to the king's woods, Governor Wentworth must have realized that he and his brother could, with the aid of a friendly superior judge, keep control of the New England timber situation, even with Ingersoll presiding over an admiralty court in Connecticut.

What is more, Wentworth probably acquainted Judge Richard Morris with the fact that Ingersoll had been exerting himself to detach Connecticut from the New York admiralty district. This, at least, is by far the most plausible explanation for the reason why Judge Morris apparently failed to make Ingersoll, who desired to supplant him in Connecticut, his deputy, after he had written to him that he would be proud to do so; that Judge Morris, by 1764, had joined hands with the Wentworths against Ingersoll can hardly be questioned, in light of the fact that in April of that year Gideon Lyman, of Northampton, Hampshire County, Massachusetts, appeared before him and signed a deposition directed against Ingersoll in which he asserted that although the mast contract had called for only eighty sticks, Ingersoll's men had cut down one hundred and sixty, "to the great waste of the King's woods." Lyman then very significantly went on to say that for this reason, in spite of his

high opinion of Mr. Ingersoll's character, he conceived him to be "an Improper person to set as the Judge of the Vice Admiralty Court in the Colony of Connecticut concerning or relating to any pine Logs or Masts that may be seized or Libelled in the said colony as forfeited for the use of his Majesty for having been cut without License therefor being first obtained."¹ Lyman, it may be added, was one of Wentworth's deputies. The deposition of course was designed to be used against Ingersoll by the representatives of the Wentworth interests who were in England.

Ingersoll, meanwhile, was getting very impatient over the unaccountable delay there had been in sending a suitable ship from England for transporting the masts. Early in February, 1764, he wrote to the commissioners of the navy, voicing his disappointment, while giving his opinion that the masts could hardly be delivered before midsummer. He, however, emphasized the fact that he had spared neither pains nor expense to fulfill properly his contract, and he therefore asked that the board would not take any steps which might prejudice his affairs or disappoint his future hopes until his arrival; he was planning, he further declared, to bring to England with him, Captain Willis, experienced in the mast business, who could give information as to the practicability of securing in the future masts from the Connecticut, and he trusted that the board would receive "better information

from him in these matters than from any Vague Accounts which they may have from others, whose knowledge may perhaps be justly Suspected and as it may happen, their motives too.”¹

That Ingersoll's fears as to the type of war being waged against his enterprise were by no means unfounded, is shown by a letter which some months later he received from his friend, Eliphalet Dyer,² who wrote from London the middle of April. Dyer had gone to England from Connecticut in a mast ship, and he said that while on board he had gained “Considerable Intelligence of what might be Expected to hinder Success in your Scheme & plan about the Mast affair, . . . ” He went on to inform Ingersoll that he had disclosed this information to Richard Jackson, the Connecticut agent, and continued, “was in hopes you would not have waited for the arrival of your Mast Ship before you had set out for England, if you had a design still to prosecute that affair, for I have the greatest reason to believe that Mr Hennika & others in Contract with Mr Wentworth are Determined to break all your measures & frustrate your designs as they have allready Indeavourd to propagate an Opinion that the Masts you have got & prepared to send here are good for Nothing for that purpose, & will not half pay the freight, and doubt not that they will Indeavour to procure the Inspecters here, who are much under their influence, even to say the same when they arrive, let them

be ever so good; this I mention that you may be sufficiently guarded against all these Vile Attempts etc.”¹

Why the English government took over two years to send a mast ship to New London, especially since the Navy Board sought an early delivery, can probably only be conjectured.² At last, in the fall of 1764, the ship, *Prince Henry*, arrived, and by the latter part of October the timber was loaded, and Ingersoll and Willis were able to begin the slow voyage across the ocean, which consumed over two months.³

By the time, however, that Ingersoll arrived in London, the Wentworth group seems to have gotten in firm control again of the ship mast situation.⁴ John Wentworth, in fact, so ingratiated himself with the ministry, that in 1766, while still in England, he was appointed not only to the governorship of New Hampshire in place of his uncle Benning, who was becoming infirm and desirous

of retiring from public life, but also to the latter's post of surveyor general of his majesty's woods in America.¹

In line also with the desires of the Wentworth family was the establishment, in 1764, by the royal authority, of a vice-admiralty court for all America, sitting at Halifax, with a concurrent jurisdiction in all matters with each and every other admiralty court that had been or might be set up in America.²

Ingersoll, probably realizing that he had been hopelessly outreached in this struggle for power and wealth and the control of the American mast trade, turned his attention to other issues soon after his arrival. Connecticut, therefore, was compelled to forego the pleasures of a vice-admiralty court and an export staple, and also was forced to wait patiently for the coming of prosperity. Ultimately, the Connecticut River became, as Ingersoll had predicted, the masting center of the New England white pine belt.³ But this did not occur until after the collapse of the Wentworth interests at the outbreak of the Revolutionary War.⁴

CHAPTER V

THE PASSING OF THE STAMP ACT

THE successful conclusion of the Seven Years' War, in 1763, brought to the British ministry the necessity of organizing for administration and defense the newly acquired territory of the empire. That such organization was highly important, especially at this time, seemed patent to thoughtful and well-informed Englishmen, who were keenly aware of "how refractory was the conduct of the Colonies in the matter of trade and defense during the French and Indian War."¹

While the prestige of England had been greatly increased as a result of the war, she was "reeling under a national debt of nearly 140 millions." At the instigation of Charles Townshend, president of the Board of Trade, the Bute ministry had come to the conclusion that no greater immediate service could be rendered to the empire than the development of additional sources of revenue. One important way of doing this appeared to be through the strict enforcement of the trade and navigation acts; for the ministry was convinced that a vast volume of trade was being carried on by Americans who

were evading the customs.¹ Now that the colonies were prosperous, it did not seem fair that they should be allowed to escape their just share of responsibility in financing the imperial administration in time of peace as well as in war—more particularly in light of the fact that no small part of the peace footing expense would go to maintain garrisons along the western American frontier to guard against any repetition of the disasters that had befallen outlying communities, due to the inability and neglect of the colonial legislatures to provide adequate protection.

Bute, however, did not remain in office long enough to accomplish anything in this direction, for in April, 1763, the ministry was reconstructed with George Grenville at the head of affairs. Grenville, a hard-working, conscientious, and loquacious little man, had been in the former administration, and approved heartily of the Townshend program. This he immediately set to work to carry out. His first task was to tighten up the vice-admiralty courts and the colonial customs service for a rigid execution of the navigation and trade acts.² In this connection he began the effective enforcement of the Molasses Act of 1733, which, at least as far as Connecticut and Rhode Island were concerned, had been rather a dead letter, in spite of the fact that "of all the Northern Provinces their industries were most dependent upon intercourse with the French sugar Islands."³ The news

of this determination of the ministry threw the Connecticut importers into a panic. But the impetus to action came from the Merchants' Society at Boston, which had been established in 1763 for the express purpose of preventing the renewal of the Molasses Act.¹ The society drew up a "state of the Trade" showing the conditions of commerce in New England, and early in 1764 transmitted copies of this to the Massachusetts London agent and to the leading merchants of the neighboring colonies.² As a result, "Gurdon Saltonstall, Esq. & other merchants and traders" in Connecticut called upon Jared Ingersoll to draw up a memorial to the general assembly in which it was pointed out that "his Majesty had been pleased, of late, to enforce the execution of the Sugar Act, so called, in these parts of his Dominion, by which it is generally supposed, by persons acquainted with the trade of the Northern Colonies will very much Distress the Inhabitants of said Northern Colonies, & that without Serving the essential Interests of the mother country; and, as the said Sugar Act expires about this time, and will probably be again revived, unless prevented by seasonable remonstrances, it was desired that the Connecticut Government should join with other colonies in remonstrating against it, and that the Assembly should appoint some persons in behalf of this colony to collect and transmit to the agent in London material Documents and Information relative to the mat-

ter, or in some way exercise the paternal care in the matter.'"¹

However, in March, 1764, before any effective opposition could be raised against it, the famous Sugar Act was passed, providing, as is well known, for substantial duties upon various articles of common consumption, while lowering to a revenue level the duty on foreign raised molasses.² A system of bonding shipmasters and the issuing of cargo certificates was also added, to put an end to lawless trafficking.

The opposition that this measure aroused in Connecticut was reflected by an item in the *Connecticut Gazette*, published at New Haven, which spread the intelligence that the local people had taken practical steps to defeat the revenue plans of the British government by putting themselves to making their own grape and currant wines and "also enough for the Gentlemen of the College," who, as a lofty rebuke to those disturbers of the old

colonial régime, had determined "to confine themselves to liquors of our own produce."¹

Jared Ingersoll's attitude toward the Sugar Act is expressed in an important letter that he wrote July 6, 1764, to his old friend, Thomas Whately, in reply to a communication from the latter, then one of the joint secretaries to the Treasury under Grenville.² "I think Parliament," he declared, "have overshot their mark & you will not, in the Event, have your Expectations in any measure answered from the provisions of the late Act . . . I am of opinion that the Foreign Molasses will bear a Duty of One penny half-penny at most,³ the raw or brown Sugar 2/6 & the Clayed 5/ pr Ct."⁴ Ingersoll then assured Whately that the trade to the French and Dutch West Indies was decaying very rapidly and that there was not a single voyage undertaken to these parts "with the most Distant intention to pay the Dutys." Indeed, as to the practice of smuggling, it could not easily be prevented; "a Seizure will be made of perhaps one Vessell in a Hundred"; in fact, to attempt to put an end to it under present conditions would be like "burning a Barn to roast an Egg."⁵ If, however, the duty were

lowered to the level just suggested, he was of the opinion that the merchants would pay it without the use of men-of-war; "you may think me mad for saying it, but I do say, that tis my opinion the Parliament of the two had better have given a Premium than to have imposed the Duty they have laid upon that branch of trade."

The revenue prospects of the Sugar Act, however, by no means satisfied the ministry. Other avenues for drawing on the financial resources of the people in the colonies must be opened up.¹ One very obvious way was to extend to America the system, successfully applied in England, of levying stamp duties. In 1722 Archibald Cumins made this suggestion² and Sir William Keith put forward the idea in 1743.³ Both in 1754 and in 1757, the Treasury Board under Newcastle had thought to utilize it in solving the problem of financing the colonial administration; in 1754 there was prepared "An Act for Granting to His Majesty Sev^l Duties upon Vellum Parchment and Paper for two years towards Defraying the Charges of the Government of Massachusetts Bay,"⁴ which provided for seventeen groups of articles that would bear stamps, and in 1757, "An Act for Erecting and Establishing a Stamp Office in New York," with fourteen groups of dutiable articles.⁵ Soon after enter-

ing upon his new office, Grenville's attention had been called to its possibilities by Henry McCulloh who, on July 5, 1763, addressed a letter to Secretary Jenkinson of the Treasury, suggesting that "A stamp duty on vellum and paper in America, at six pence, twelve pence, and eighteen pence per sheet, would, at a moderate computation, amount to upwards of sixty thousand sterling per annum, or, if extended to the West Indies, would produce double that sum."¹ McCulloh's advice, it is not unlikely, carried some weight, for in 1739 he had gone to America as a "Commissioner for Supervising, Inspecting and Controlling His Majesty's Revenue and Grants of Lands," and his continued interest in the revenue possibilities of the colonies was shown in a statement that he drew up and incorporated in his letter to Jenkinson, regarding "such taxes as are usually raised in His Majesty's old settled colonies on the continent of America, viz: North and South Carolina, Virginia and Pennsylvania."²

However, in considering the extension of stamp duties to America, it is a matter of surprise, not that the attempt was made at this time, but rather that it was not earlier considered as a legitimate source of revenue, especially during the periods of great financial pressure when England was at war, largely to save her colonies from

destruction. Ever since 1694, when, under William and Mary, the first stamp act was passed, stamp duties had been a very fruitful and not unpopular source of revenue in England.¹ In 1760 £290,000 had been raised through this means and this was increased in 1765 by a slight extension of duties.²

By September, 1763, Grenville had arrived at a definite decision regarding the American revenues, and in March of the following year, the month of the passage of the Sugar Act, he was ready to announce to the Commons his intention of introducing an American stamp bill at the next session of parliament and he secured the approval of the house to a resolution to that effect.³ In conformity with this vote, the Board of Trade, now under the Earl of Halifax, sent out formal requests to each colonial governor to transmit to England the various forms of writs, deeds, and similar legal instruments in use within the colony.⁴

Eliphalet Dyer, a member of the governor's council and one of the leading men of Connecticut, was in London at this time in the interests of the Susquehanna Company's enterprise. About the middle of April, he wrote to Ingersoll laying bare the purpose of the ministry to bring forward a bill imposing a stamp tax, which was, he wrote, "to fix upon us a large Number of regular Troops under pretense of our Defence; but rather designed as a rod & Check over us." Dyer, in his anger,

however, was not oblivious of the services that Richard Jackson, the Connecticut agent, was rendering to the colonies, "you are sensible he is in the Interest of the present Ministry, & as such by his Influence the propos'd Stamp duty is at present postponed."¹

Meanwhile, the British Stamp Commissioners had been directed by Grenville, in the fall of 1763, to draw up a tentative stamp measure. Indeed, the Stamp Office had become interested in this project even earlier than this. From Trinity vacation of that year on, it would appear that Henry McCulloh was in frequent consultation with them. He drew up a plan which he entitled, "Proposals with respect to a Stamp Duty in America," which, in October, was embodied in a formal bill.² To what extent, however, his ideas found expression in the final act, is hard to say, for it appears certain that his plan was rejected in 1764, in favor of one which Secretary Thomas Whately of the Treasury had drawn up.³

Early in the spring of 1764, Whately wrote to Ingersoll acquainting him with the plans of the ministry. In this letter he showed his hearty accord with Grenville's position that the colonies ought to share in the payment of the "American expense" for imperial defense. He pointed out that since the amount to be raised from the colonies by the late revenue act was doubtful, some other means for making up the deficiency must be devised. A stamp act, he declared, had been proposed, but had not been carried into execution "out of Tenderness" and also from a desire to allow the colonies either to furnish the necessary information for it or to suggest a better mode of taxation. A tax on the importation of negroes had been suggested, but a stamp tax was considered preferable, because it would not bear more heavily on the southern colonies than the northern colonies. On the other hand, a stamp tax would be less easy to collect and more liable to evasion. The revenue from a stamp tax should be great on account of the numerous suits continually pending. Whately thereupon asked Ingersoll pointedly, "Would it yield a considerable Revenue if the Duty were low upon mercantile Instruments, high upon gratuitous Grants of Lands, & moderate upon Law Proceedings?"

THE PASSING OF THE STAMP ACT 121

The true attitude of the Grenville administration toward America seems to be fairly reflected in this letter. Whately, it should be borne in mind, was perhaps the most ardent and able advocate of the financial policy of the ministry.¹ How foreign to this program was the idea of flying blindly in the face of American interests and of needlessly disturbing colonial tranquillity and legitimate prosperity, is shown by the solicitous desire of the man who was responsible for framing the bill, to know the truth about American conditions. Before concluding his letter to Ingersoll, he declared: "I should be happy to know the genuine Opinion of sensible Men in the Colonies upon Subjects equally interesting both to them & to us: You know I always from Inclination interested myself in their Prosperity: My present Situation necessarily employs me often in their Affairs; & I, therefore, am anxious to get all the Information I can in Relation to them." And he thereupon besought Ingersoll in case either of his suggestions regarding a tax should be found "very exceptionable," to suggest some other type of revenue bill for the colonies.²

Ingersoll's reply to this letter, which was in a friendly but candid spirit, came in July. It gives one an intimate insight into his attitude of mind at this period. "You

may depend," he declared, "upon the Strictest truth Even tho' it should offend. . . . You say America can & ought to Contribute to its own defense. . . . we only differ about the means; we, perhaps should first of all Rescind great part of the present Expense & what remains should difray by the Application of our own force & Strength." He reminded Secretary Whately that the people of Connecticut—"who besides their Charter of Priviledge granted by K. Ch. 2^d have . . . subsisted hitherto without one farthing's Expense to the Crown, except what the Nation was pleased to give to them in Common with their neighbours in the late war"—did not believe as yet that the British Parliament really meant to impose internal taxes upon them without their consent. There must be no disguise, he continued, "as to the feeling of colonials. If the King should fix the proportion of our Duty, we all say we will do our parts in the Common Cause, but if Parliament once interpose & Lay a tax, tho' it may be a very moderate one, & the Crown appoint officers of its own to Collect such tax & apply the same without Acc^o., what Consequences may, or rather may not, follow? . . . The peoples minds not only here but in the neighbouring Provinces are filled with the most dreadfull apprehensions from such a Step's taking place, from whence I leave you to guess how Easily such a tax of that kind could be Collected, . . ."

It seems very odd, indeed, that the man who had so clear an understanding of the temper of the people allowed himself, later on, to become responsible for the execution of the Stamp Act in Connecticut. But, to do him justice, Ingersoll was of a very open mind, and in this same letter to Whately confessed that he might "be

Convinced of the propriety as well as necessity of such a Step." "I long to see you & please myself much in the Expectations I have, that you & my friend, Mr. Jackson, & other Gentlemen on y^r Side the water will be able to tell me Some Facts & acquaint me with some reasonings upon these Subjects which I am at present a Stranger to, & that will dispell those Clouds of Darkness that now hang over my mind. . . ." But at present he was far from convinced, and in reply to Whately's desire for advice as to the most feasible plan for raising a revenue in America, he made clear that he was prevented from suggesting which of the several methods of taxation mentioned would be best, for it was plain that "every one of them or any supposable one, . . . would go down with the people like Chopt hay." However, the close intimacy between the two was shown in Ingersoll's statement, "as I expect to see you soon in London, I shall hope for the Pleasure of having an opportunity to say a Thousand Things to you on the Score of Friendship & which I will therefore pass by at present. . . ."

Ingersoll's warmth for the colonial cause at this time is also shown by the fact that immediately upon receipt of Whately's letter, he copied the most essential portions of it and dispatched them to Governor Fitch.

When the Connecticut general assembly met for its May session in 1764, Governor Fitch submitted to its consideration a letter from Richard Jackson, which acquainted the colony with the parliamentary resolution favoring a stamp tax. As a result, a committee was appointed by the assembly with the governor as its head "to collect and set in the most advantageous light all such arguments and objections as may justly and reasonably be advanced against creating and collecting a revenue" in the colony, and "especially against effecting the

same by stamp duties."¹ Although not a member of the assembly, Jared Ingersoll was asked to serve on this committee. The result of its efforts was a very carefully framed document entitled, "Reasons why the British Colonies in America should not be charged with Internal Taxes by Authority of Parliament."² Governor Fitch seems to have taken the leading part in drafting this,³ although the mere fact that the assembly went outside of the governmental circle to procure Ingersoll's services would seem to indicate a feeling that, by reason of his eminence as an advocate and on account of his experience as London agent, he was peculiarly qualified to marshal against the ministerial plan the most effective arguments. That he was the best constitutional lawyer of the group can scarcely be doubted. His share in the work, therefore, must not have been unimportant.

With great skill, facts were brought forward to show how ready Connecticut had been at all times to respond to the financial needs of the home government and with what willingness and celerity she had sent her men on numerous occasions, at the call of danger along the frontier. What she had done in the past through the free action of her own assembly she would gladly do again. No reasonable cause, therefore, could be urged which would justify the denial to her people of the liberties and privileges which as Englishmen and as freemen they so highly valued. If, however, it was absolutely necessary to levy a permanent and regular charge upon America it would be better to place a duty on the importation of negroes and also to tax the fur trade rather than to impose a stamp tax; for, with regard to the negroes, a

lessened importation might be attended with many salutary effects and, as to the fur trade, since its protection was one of the chief sources of expense in America, it surely should be charged to support itself.

It should be noticed that while Ingersoll, in his personal letter to Whately, refused to give the slightest endorsement to either of the proposals which he put forward, the "Book of Reasons,"¹ prepared after Ingersoll's reply, retreated somewhat from the high constitutional ground of the latter by confessing that if the British government was determined to raise a revenue in the colonies by the direct action of parliament, it might get it out of negroes and furs—a revenue scheme which would hardly affect Connecticut of the '60's. It is important, in the light of such pronouncements as came from James Otis and Patrick Henry, to appreciate the exceedingly cautious position assumed by Connecticut at this juncture, under the control, as she was, of the more conservative elements in the colony. In a letter written to Ingersoll, in December, 1764, Governor Fitch, in referring to the remonstrance drawn up by the committee, gave his views of the constitutional position which it embodied. "In these Reasons," declared Governor Fitch, "we have avoided all Pretense of objection against the Authority or Power of the Parliament as the supreme Legislature of all the King's Dominions to tax the Colonies and have therefore Endeavored only to show that the exercise of such Power in that Particular Instance or in like Cases will take away Part of our Antient Privileges, etc. (which it is presumed the Parliament who are also Guardians of our Liberties will not do). . . ."²

Late in the month of October, 1764, Ingersoll, as was noted in an earlier chapter, sailed from New London for England on the ship, *Prince Henry*, which was loaded with masts that he had contracted to deliver, while in London in 1760.¹ While he was yet at sea, the general assembly desired the governor to write to him requesting him again to assist Richard Jackson in the London agency "in any matters that may concern the colony," for the people were "convinced of his skill, ability and good disposition to serve the interests of this Colony."² By the time that he arrived in England, which was about the tenth of December, the stamp bill had been drafted and lay at the Treasury for objections and adjustments.³ Ingersoll, it would appear, took steps to oppose it some weeks before he received the news of his reappointment to the agency.⁴ One of his first acts was to distribute, among the ministry and members of parliament, over a hundred copies of the Connecticut "Book of Reasons." He submitted a copy to Grenville, who, while admitting that it was written in good temper and that it contained good arguments, considered that it failed in its principal premise, which was that the colonies should not be taxed by parliament since they were not represented there.⁵

Numerous meetings and conferences were held among the colonial agents both before and after Ingersoll's arrival. Montague, Charles, Franklin, Garth, Jackson, and,

later, Ingersoll probably made up the circle,¹ though there were other colonial agents in London at that time. The London merchants engaged in the business of trading with America also went into opposition to the program of the ministry. They appointed a committee which was to exert itself to that end. This committee of merchants invited the agents to a joint conference. According to Ingersoll, they were frequently together, working hand and glove, and several times the two groups went before the ministry upon the pending issues relating to America.² The principal spokesman of the merchants on these occasions was Barlow Trecothick, who had been raised in Boston and had moved to London, where he acquired "a great estate with the fairest character" and became an alderman.

At one of these gatherings of the agents it was decided that Franklin and Ingersoll should wait upon Grenville, together with Jackson and Garth, who were members of parliament. As a result of this and other conferences, if his own statement can be accepted without reservation, Ingersoll's entire attitude was altered regarding the justification of the stamp measure. It is certain that a change of view took place. Was the prospect of an office accountable for it, or was it a change of conviction? While it is clear that Ingersoll was a seeker after preferment, he was, at the same time, a man of strong character and high ideals, with very liberal opinions and with unusual openness of mind. The explanation would, therefore, appear to lie in the fact, as he himself suggested to Whately in his letter of June, 1764, that in the end he was "Convinced as to the propriety as well as necessity of such a Step." It is safe to say that there exist nowhere else such full and faithful accounts of

the conferences with Grenville as in Ingersoll's letters, written to Governor Fitch and to the Connecticut general assembly.¹ The emphasis that he placed upon Grenville's arguments would seem to indicate the weight and importance that he felt they deserved. Grenville's statements must, therefore, be followed with care as offering an explanation for Ingersoll's conversion. "Mr. Grenville gave us a full hearing," wrote Ingersoll to Governor Fitch, February 11, 1765, "told us he took no pleasure in giving the Americans so much uneasiness as he found he did;—that it was the Duty of his Office to manage the Revenue;—that he really was made to believe that considering the whole Circumstances of the Mother Country & the Colonies, the latter could and ought to pay something,² & that he knew of no better way than that now pursuing to lay such a Tax; but that if we could tell of a better he would adopt it."³

In reply to this, Jackson urged that the measure in question, "by enabling the Crown to keep up an armed Force of its own in America & to pay the Governours in the Kings Governments, & all with the Americans own Money, the Assembles in the Colonys would be subverted. . . ." But Grenville rejected the idea warmly.

When Franklin pleaded that the old method by king's requisition should be followed in the present case, the minister asked in return if they could "agree upon the several proportions Each Colony should raise?" To which the agents were forced to confess that they could not; which gave Grenville the upper hand in the discussion, and he thereupon pointed out that he did not think that anybody in England was furnished with the materials for that purpose, and what is more, there would be no certainty that every colony would raise the sum enjoined. The colonies, moreover, by their increase, he suggested, would be constantly varying in their proportion of numbers and ability to pay, which a stamp bill would keep pace with.¹ Completely baffled by these arguments, the protesting committee withdrew.

At a later conference with these spokesmen for America, Grenville urged the necessity of the act. He asked them to lay aside all considerations of past services on the part of the colonies, on the one hand, and on the part of England, on the other. There was an immense national interest-bearing debt of not less than £140,000,000 lying heavy on the nation. By the best information that he could secure, the whole public debt of all the colonies together was £800,000,² yet the annual civil establishment in England required £800,000, while that of all the colonies "we find to be about £40,000." In addition, the military and naval establishments were immense, but without considering that, the annual amount of the expense of the army now placed in America, "as well on Account of the Troubles with the Indians as for the general Defense against other Nations & the like in so Ex-

tensive a Country," amounted to about £300,000. Yet he would be glad, he informed the agents, if he should find that the stamp duties would bring in forty or fifty thousand pounds, so that the entire revenue from America, including that from the duty on molasses and from the post office and other sources, would amount to £100,000, which would be but one-third of the cost of maintaining the army in America.

Evading the financial question, which was of such serious moment, the agents placed before Grenville the proposition already brought forward in colonial protests that it "will be for ever inconvenient; 'twill for ever be dangerous to America, that they should be taxed by the Authority of a British parliament," urging at the same time the great distance, the want of mutual knowledge and acquaintance with one another and the want of personal friendship between England and America.¹ But Grenville was not to be drawn away from what to him were the practical issues. He proceeded, therefore, to point out the difficulties of leaving the colonies responsible for the supply of the military forces; "don't some of you Complain," he asked, "& perhaps very justly, that in the late War, while some of you did much, others did but little, or perhaps nothing at all—and would not that be the Case again, was you left to Defend yourselves?"

In answer, the agents set forth the prevailing American apprehension, saying that "without any Persons . . . to speak for us in the great Council of the Nation,—we fear a Foundation will be laid for mutual Jealousy and ill Will, and that your Resentments being kindled, you will be apt to lay upon us more & more, even to a Degree that will be truly grievous. . . ." But Grenville replied that the colonies had never intimated that they desired representation in parliament, and that there were "many

Reasons why they should not desire it"; since members received no pay, the expense would be very great to the colonies in sending representatives and already they were pleading poverty; again, the influence of these representatives would not be dominant; the colonies appreciated that they could not hope to have a majority of members in the House of Commons; colonial representatives would also be confronted by many inconveniences, by reason of the great distance and want of connection with England. If it were not feasible to introduce such representation, "What then? Shall no Steps be taken & must we and America be two distinct Kingdoms, & that now immediately, or must America be Defended entirely by us, & be themselves quite excused or left to do just what they shall please to do? Some, perhaps, will do something, & others Nothing."¹ He then made an interesting and prophetic admission, that perhaps "from the nature of our Situations, it will happen & must be Expected that one Day we shall be two distinct Kingdoms"; but he trusted that the colonies did not consider themselves "ripe for that Event as yet." Let those possible events, he counseled, be left to the disposal of Providence. For his own part, he declared that he did not choose to predict nor yet to hasten the time of this supposed period and thought that a separation would be mutually disadvantageous. And in conclusion, he urged, "Let mutual Confidence and mutual Uprightness of Intention take Place & no considerable Ills can follow."²

These statements attributed to Grenville—after due allowance is made for the inaccuracy of his information

respecting the colonial financial situation, regarding which the agents themselves seem to have been ignorant—tend to soften the charge that he was simply a reactionary, narrow-grooved, mechanistic type of closet politician. While it is true that during his political career he occasionally showed a lack of finesse in dealing with men and measures,¹ yet in the main, his ideas on government were not unsound. In justice to him, it should be pointed out that he was capable of something that few men in his age had the vision to appreciate; he could think in terms of imperial welfare; he sought what in our present political parlance is termed a mobilization of the imperial resources, through a proper articulation of every unit in the empire with the central authority. The ministry, of course, was unfortunately obliged to rely upon an antiquated and inflexible parliamentary system, due to the innate conservatism of the English-speaking people; still more unfortunately, it was forced to encounter the extremely particularistic spirit that prevailed in the American colonies, the weight of which at that time was not suspected by even so close an observer of American conditions as Benjamin Franklin. Nevertheless, casting aside inherited prejudices and the political opportunism of the older historians, both British and American, who demanded a scapegoat in order to interpret the history of this period, it is not clear how the Grenville program can be regarded as other than a sincere and not unenlightened attempt to accomplish something of vast importance to the nation, which would have gone far toward making the British people, scattered as they were even in 1765, ready to face any emergency.

Indeed, as has been pointed out, the hard experiences of the Seven Years' War seemed to have proved the need of some such reorganization as was now sought. Might not the Grenville program of centralization and unification be regarded, in other words, as a premature step, taken in good faith, in the direction of realizing a federal system for the British empire; something that men to-day are demanding? For, surely, where the great common affairs of the nation were decided, there the different units of the empire would inevitably, before long, have secured a voice.¹

But it should be pointed out that the colonies were not asking or desiring representation in the British parliament and this scheme would have suited them as little as Grenville's. The fourth resolution of the Stamp Act Congress reads, "that the people of these colonies are not, and, from their local circumstances, cannot be, represented in the House of Commons in Great Britain."

It can now be appreciated that the colonial problem of the period subsequent to 1763 was, in truth, a glowing ember ready to sear the hand of any British statesman who attempted to carry it to a solution. No one better understood this than Grenville's opponent, the great Pitt.

In studying the cause for the failure of this taxation experiment, it must be done in light of the causes for the failure of the confederation of the United States, established in 1781. In each case, there was an unwillingness on the part of the American people to think in terms other than that of local welfare, which culminated in bitter interstate conflicts; in each case, it was the unwillingness of the people to surrender the notion that a group of detached, practically independent political units could serve the interests of all effectively; in each case, it was an attachment to the requisition idea, which caused Patrick Henry, even in 1788, to maintain, in opposing the Constitution,—which had been submitted to the states for ratification,—that he could never give up his “darling requisitions,” unjust and hopelessly defective as the idea was in practice. If the American people were suspicious of giving to parliament the right of taxation in 1765, they were hardly less willing to entrust it to their own congress of the Confederation, which pleaded for it in vain in 1781, in 1783, and in 1788. Indeed, there is abundant evidence to show that almost from the very beginning of English colonization in America, conceptions of local autonomy had been gradually developing; in 1765 these conceptions overshadowed all other political ideas. Admitting that Grenville failed because his program did not take into account the strength of these conceptions, there is at least a certain rationality about his theory of government. It may be summarized as follows:

There must be obedience to law on the part of all within the British domains. If, as in the case of the trade and navigation laws, particular measures occasionally had borne more heavily upon some than others, it had been inevitable and was truly characteristic of all legislation, although justice, as far as possible, should and would be done to all.¹ Not only must there be general obedience to the law, but a general sharing of the vast expense of the national administration; the old policy of allowing the local, subordinate assemblies to decide how far they were willing and obligated to contribute had not proved satisfactory; there must, in other words, be exercised somewhere a more effective control, without which the empire could never properly function in the interests of all groups within it. Parliament, in the light of its historic position and in the exercise now of so many of the ancient sovereign prerogatives, was the only agency competent to do this work. While it was true that parliamentary representation was not a fully realized thing for all, either in England or elsewhere within the empire, there were vast difficulties in the way of bringing about a representation which would be more satisfactory for America. But, in all fairness, it must be conceded, that, although the colonies had never had members in parliament and had never expressed a desire to assume the expense of sending them, yet for the lack of them they had never been treated oppressively, but, on the other hand, had greatly developed and prospered. This would con-

tinue in spite of the necessity, for the common welfare, of so reorganizing the colonial administration as to allow America to bear a more just, definite, and responsible part in the general affairs of the empire.

In writing to Governor Fitch regarding the outcome of these conferences, Ingersoll said that "to do Justice to the Minister, Mr. Grenville as to the Comparative few who have interested themselves in the Concerns of America, I beg leave to say that I think no pains have been spared, on the one Side in behalf of America, to make the most ample & strong representation in their favor, & on the other, on the part of the Minister to bear patiently, to listen attentively to the reasonings & to Determin at least seemingly, with coolness & upon principle upon the several Measures which are Resolved on."¹

Apparently, Ingersoll, in his capacity of Connecticut agent, did his utmost to divert Grenville from this policy and in the last of the interviews, according to Jackson, he took an especially prominent part.² However, the more he studied the whole situation and analyzed the motives of the ministry as well as its practical program, the less he saw to fear in the proposed revenue bill, and the more heartily he came to sympathize with the idea of an efficiently organized British administration extending throughout the empire. The phrase, "Taxation of the Colonies," would sound very different to a colonial of broad views, conversing familiarly

each day in the government offices and the halls of parliament with men of influence in the administration, some of whom were old acquaintances, who laughed at the idea that there was the slightest intention on the part of England to treat America unfairly or to deny to its people the essential rights of Englishmen, from what it would to the same person living far away from the seats of power in the atmosphere of a Connecticut seaport. In like manner, the British constitution would easily come to mean something quite different to the man listening to the argument of the head of the ministry and to the speeches in the House of Commons, from what it would to the same man deliberating in a New Haven town meeting three thousand miles away from London. "I went to England last winter," Ingersoll confessed later on to his friend, William Livingston of New York, "with the strongest prejudices against the Parliamentary Authority in this Case; & came home, I don't love to say convinced but, confoundedly begad & beswompt as we say in Connecticut."¹

In other words, while he disliked to see the colonies disturbed with additional taxation, while he realized the possible dangers that lurked in the situation, where the colonies would be under the full control of parliament, yet the reasons in favor of such taxation appeared to outweigh the arguments that could be urged against it. There seemed to be no other solution of the problem to one thinking in terms of imperial welfare. "No man sees in a stronger light than I do," Ingersoll declared upon his return to America, and when writhing under the lash of public opinion, "the dangerous tendency of admitting for a principle that the Parliament of Great Britain may

tax us *ad libitum*—I view it as a gulph ready to devour, but when I look around I am at a loss for a plan.”¹

After the conferences with the minister had failed, the agents sought to get the issue discussed in an open session of the Commons, in a full debate. But as Ingersoll wrote to Fitch, “The Point of the Authority of Parliament to impose such Tax, I found on my arrival here was so fully and Universally yielded, that there was not the least hopes of making any impressions that way.”²

If the passage of the measure could not be prevented, the colonial cause, nevertheless, might be served in another way. The bill was still resting at the Treasury, and Ingersoll’s friend, Secretary Thomas Whately, was at work on its final revision.³ If the principle of colonial freedom from parliamentary taxation could not be saved, the same might be applied in such a way as to make the added burden comparatively light and inoffensive. A favorable casting of the measure then became the chief object of Ingersoll’s exertions.

It was now that Ingersoll’s fundamental honesty of

purpose, sense of fairness, judicial temper, conciliatory attitude, together with his wide knowledge of colonial conditions and grasp of specific American legal practices made him an asset of value to the colonies. For Whately seems to have recognized these qualities and eagerly sought confidential information from him. Ingersoll declared that, as a result of frequent conferences with the secretary, he was able to bring about a material lessening of the duties in general, and in the case of three important instruments—marriage licenses, commissions of the justices of the peace, and notes in hand—he gave the secretary no rest until the latter dropped them from the bill.¹ “Mr. Whately to be sure tells me,” wrote Ingersoll, “I may fairly claim the Honour of having occasioned the Duty’s being much lower than was intended.”²

When at last the stamp bill was ready for presentation in the Commons, it had been so modified that a careful study of its schedules shows that in the framing of it there was a serious appreciation of the complexities of the economic situation in the colonies. While it was the most compendious and comprehensive taxation measure

of its kind that hitherto had issued from the Treasury, it bears every mark of being carefully worked out.

Early in February, the first debate took place in the House of Commons over the bill. Ingersoll said that Grenville, on this occasion, dealt with the proposal "in a very able and, I think, in a very candid Manner."¹ The bill passed through its first reading with a ministerial majority of five to one. According to Ingersoll, Colonel Barré, Richard Jackson, and Sir William Meredith were among those who replied to Grenville. Alderman Beckford, a member from London, who was a West India planter, was the only one at that time to deny absolutely the authority of parliament to tax the colonies.² At this session Ingersoll was very greatly impressed with the forceful reply that Colonel Barré made to Mr. Townshend, when the latter was urging the ministerial project. Barré was bitterly opposed to the government, which may have added fire to his famous apostrophe beginning: "They planted by your Care! No! your Oppressions planted 'em in America."³ In describing the

speech, Ingersoll wrote: "These Sentiments were thrown out so entirely without premeditation, so forceably and so firmly and the breaking off so beautifully abrupt, that the whole house sat a while as Amazed, intently Looking and without answering a Word. I own that I felt Emotions that I never felt before & went the next Morning & thank'd Coll Barre in behalf of my Country for his noble and spirited Speech."¹

At the second reading of the bill, an unsuccessful attempt was made, by members of parliament, to present various petitions against it. But all efforts were useless, for the ministerial party urged that there was a long standing rule of parliament against petitions upon revenue bills. It is interesting and important to notice that the opponents of the bill denied that the so-called rule was an order of the house, but on the other hand, merely a practice founded on experience and maintained to prevent inconvenience. The opposition urged that, unreasonable as it would be to admit English subjects, upon every imposition of a tax, to come in and be heard upon

petitions against the same, there were precedents which could be produced to show that when any new species of taxation had been designed, petitions had been admitted against the measure, as in the case of the Funding Bill and on "other particular and extraordinary Occasions formerly; & that this Case, as to America was quite new & particularly hard as they had no Members in the House to speak for them."¹ However, in spite of a vehement speech by General Conway,² the measure was carried smoothly through this and its subsequent reading with overwhelming majorities.

Ingersoll explained this result by reason of the fact that "The Parliament & Even the whole Nation, as far as I could collect their Sense of the matter, seem to be fixt in the following points, viz. first that America is . . . become too important to itself, as well as to the Mother Country & to all foreign powers to be left to that kind of Care & protection that was Exercised heretofore by Each independent Province in the Days of their Infancy: that there must be some one Eye to oversee & some one hand to guide & direct the whole of its Defense & protection. In the Second place that America is able & ought to contribute Something toward this general protection, over & above the Advantages arising from the American trade; the Advantages of trade simply Considered, they say, are mutual. To give authority to America, to provide for these things, there would be the liability of giving umbrage to the Mother Country and the many jealousies

that would surely arise among the colonies as to proportioning the parts of this common power. And so, taking everything into consideration, it was generally felt, Parliament should assume the entire responsibility of the protection of British possessions.’¹

Speaking of the character of the opposition against the ministerial policy, Ingersoll pointed out that “Except the Gentlemen Interested in the West Indies & a few Members that happen to be Particularly connected with some of the colonies & a few of the heads of the minority who are sure to athwart & oppose the Ministry in Every Measure of what Nature or kind soever, I say, Except those few Persons so Circumstanced, there are Scarce any People here, Either within Doors or Without, but what approve the Measures now taking with Regard America.’”²

The ministers had been given a certain discretion as to the particular time the act would go into effect. The agents, defeated in their larger objects, exerted themselves to have the date changed, and it was Ingersoll, apparently, who finally prevailed upon Whately to set the date of enforcement as late as the first of November following.³ The particular means of enforcement had

also been left to the ministry. Whately's plan called for two head distributors in each province, one of whom should be the clerk of the provincial council, and the other, an eminent merchant and planter.¹ It was also contemplated to make the governor and council a kind of board of commissioners, to superintend the whole arrangement,² but for some reason, probably that of expense, it was finally decided that a prominent colonial in each province should be selected to have charge of the work of enforcement; he would be able to determine "where it pinches & will certainly let us know it, in which Case it shall be Eased."³

When the plans were completed for carrying the act into effect, there had been provided an American stamp office in London, with five commissioners of stamps, each drawing £500 apiece, per annum, and with the necessary staff of clerks.⁴ Below these were the American inspectors, who were to receive a salary of £100, besides 20 shillings per diem while on their tours of inspection—for purposes of inspection, the colonies were grouped into districts, with Massachusetts Bay, Rhode Island, and Connecticut as one, under Robert Warter.⁵ Then came the distributors, who were to be awarded eight pounds for every one hundred pounds worth of stamps that was disposed of within the colony constituting the particular district of each.⁶

It happened that there were only three Americans in England at that time who appeared to be qualified for so important a post as that of distributor and who were so situated as to take the office: Colonel Mercer of Virginia, George Meserve of New Hampshire, and Jared Ingersoll.¹ All three had gone to England on private business; none of them apparently sought the place,² but each, after being recommended, decided to accept office. Ingersoll disclaimed any previous thought of obtaining such a post before his services were solicited by Secretary Whately, after the passage of the act. Franklin, it would seem, especially urged Ingersoll to assume the responsibilities of this work.³ In doing so, little did he, or Benjamin Franklin, or the other colonials in London,

or the ministry, realize the extent of the storm brewing in America. In fact, 'as late as August 9, Franklin had such a contempt for the radical, anti-ministerial element in America that he wrote from London, to John Hughes, who was appointed the Pennsylvania stamp distributor, "that a firm Loyalty to the Crown and faithful Adherence to the Government of this nation, which is the Safety as well as the Honour of the Colonies to be connected with, will always be the wisest course for you and I to take, whatever, may be the Madness of the Populace or their blind Leaders, who can only bring themselves and Country into Trouble, and draw on greater Burdens by Acts of rebellious Tendency."¹ This view may well be taken as an epitome of the opinions of moderate Americans generally at this stage of the crisis. They all contemplated that there would be some opposition to enforcement of the Stamp Act, but thought nothing serious could come out of it. Ingersoll himself saw the solid advantage of having a strong friend of the colony acting in the capacity of distributor of stamps. "Upon my honor, I thought, I should be blamed," he pleaded later on, "if I did not accept the Appointment."²

After accepting office,³ in order to obtain "a full and beneficial Construction of the Several Articles of the Tax," Ingersoll lengthened his stay in England an additional month, which gave him the opportunity to consult with the board of commissioners and with Doctors' Commons in reference to many of the terms and words used in the act expressing different ideas in England than in the colonies.⁴ At this time, also, he put up a bond of

£3000 for the faithful performance of his office, getting James Brown of Lombard Street, banker, and his friend, Thomas Life, the Connecticut London solicitor, to join him as bondsmen.¹

Before leaving England, Ingersoll apparently rendered very valuable service to the colonies in two matters not related to the Stamp Act. One was "in the matter of the Mutiny Act in preventing the Bill passing, to quarter soldiers in private Houses, as was intended";² the other was, "in assisting to get passed the Act granting a Bounty on timber" shipped from America. "I had the Honor," he declared, "to be often with the Minister and Secretary at War, together with Mr. Franklin and other gentlemen, upon these subjects." In May he took passage on a ship bound for the port of Boston.⁴

CHAPTER VI

OPPOSITION TO THE STAMP ACT IN CONNECTICUT

ONE of the most difficult tasks that confronts the student of American colonial history is to approach the study of the Stamp Act agitation and the agitation that followed the passage of the Townshend measures from a viewpoint so thoroughly detached that it is possible to give a sufficiently sympathetic emphasis to the motives and acts of the opposing groups as to do full justice to each. In making an analysis of the Stamp Act crisis, it becomes clear that there were at least three distinct issues involved in the same, and that each of these has had to some extent its counterpart in later American history.

There was the constitutional issue, put forward to a place of first prominence. However, in view of the fact that the colonials between 1764 and 1776 felt compelled radically to shift their ground regarding the unconstitutionality of the efforts of the British government in attempting to regulate American affairs,¹ it would hardly

seem that this issue, in truth, can be considered more fundamental as the real basis for resistance than the constitutional arguments advanced by New England secessionists, previous to and during the War of 1812, against the "usurpations" of the central government then in the hands of the "Virginia dynasty"; or those put forward by that erstwhile ardent nationalist, Calhoun, through the medium of the South Carolina Ordinance of Nullification, against the unconstitutional procedure of Congress in passing the tariff act of 1828. But once having sought this means of defense the colonials found it the most powerful and effective of weapons.

Another issue had to do with the idea which had taken root in the colonies that, on the one hand, an American was not an Englishman and, on the other hand, that English institutions were un-American; in other words, that there were two peoples instead of one, with distinct and divergent interests. This attitude is clearly presented in a letter which Jared Ingersoll wrote in 1764 to Thomas Whately, secretary to the Treasury Board, who had twitted him about his Puritanism of an "Oliverian descent." In reply, Ingersoll proceeded to make clear that on the contrary "being so much an Englishman, so much

of Connecticut, and elsewhere in America, had advanced to the point in their constitutional theorizing that they were now prepared to brush aside the distinction that they had made between "external" and "internal" taxation and to deny the right of parliament to secure a revenue from America by any means whatsoever. Before the outbreak of the Revolution, so far had American political theory swung from its standpoint of the early '60's that the doctrine of the coördinate authority of the colonial assemblies with parliament had become the chief reliance of those who were in opposition to the parliamentary program. Many went still further. "The idea of inalienable allegiance to any prince or state is an idea to me inadmissible," declared Samuel Holden Parsons, writing from Connecticut to Samuel Adams, in 1778, "and I cannot see but that our ancestors when they first landed in America were as independent of the Crown or King of Great Britain as if they had never been his subjects." an advocate of you on your side of the water, so unhappily void of all Puritanism . . . I have very much bro't upon me the jealousy of my own countrymen; they suspect me being too much a favorer of court interest."¹ This feeling of separateness, as a social group, gave rise in America to the idea that no interests so vital to the people of the colonies as that of taxation and the garrisoning of the frontier forts could be entrusted to the hands of "foreigners," as Englishmen were freely denominated by the American press of 1765.² Similar ideas, of course, took root in the South, coming into full bloom during the decade preceding the Civil War; Southerners had become impressed with the notion that they were a distinct people with respect both to constitutional conceptions and social order and possessed of interests which were not to be entrusted to any governmental body that their votes could not control. Both in 1765 and in 1860 one is confronted by certain powerful anti-nationalistic tendencies expressed in the form of the most extreme particularistic theory and in each case this particularism sought shelter behind a wide mantle of sectionalism.

Finally, there was the issue which had to do with the question of increased taxation. This, in itself, coming from whatsoever source, would not have been welcomed

by the colonials. The farmers of Somersetshire and Devon, it should be kept in mind, resisted in 1763 Lord Bute's cider tax with almost as much bitterness and violence as the people of the American colonies did the Stamp Act.¹ Had so sweeping a measure in 1765 emanated from a legislative body made up even of representatives from the different colonies, it would have been intensely unpopular with those very elements stirred to violence against the upholders of the Stamp Act. Indeed, the Whiskey Insurrection in western Pennsylvania in 1794, precipitated by the internal revenue law of 1791, brought forth a series of denunciations of President Washington's administration that bear, in many respects, a remarkable resemblance to the denunciations that filled the colonial press in 1765 against the Grenville ministry; both in 1765 and in 1794 unconstitutionality of action and usurpation of power formed the basis of violent charges against the central government.²

In following the course of the resistance to the act in Connecticut, it is hardly necessary to point out that lawlessness of the terrorist type was in no way sanctioned by such intelligent and large-minded opponents of the Stamp Act as Ezra Stiles, William Samuel Johnson, Roger Sherman, and probably a majority of educated people, who preferred to follow the footsteps of these champions of popular rights that relied strictly upon a constitutional form of resistance. If, therefore, the words and actions of the supporters of the Stamp Act contrast more than favorably with those of the opponents of the same, it should in all fairness be remembered that

the rather slow-moving moderates were pushed aside by radicals who insisted on dealing with the problem in hand according to their own peculiar notions as how best to settle a large question of state.

On July 28, 1765, Jared Ingersoll landed at Boston. He immediately sought the Bernard residence and spent the day closeted with the governor.¹ The conference was undoubtedly held for the purpose of discussing the problems sure to arise in connection with the enforcement of the Stamp Act. According to Ingersoll, everything was quiet in Boston at the time of his arrival, and from information that he then received from Connecticut he "had no Reason to expect any other than a Submission to the Act . . . tho much against the People's Inclinations."²

The news of the home-coming of Ingersoll aroused various conflicting emotions in Connecticut, although as early as May 24 information had reached the colony of his appointment as stamp distributor.³ On the one hand, he was greeted by a crowd of would-be assistant stamp distributors burning with a solicitous desire to supply the people of each community with this novel stamped parchment. Even little Windham, a veritable hotbed of radicalism, furnished her candidate for this somewhat dubious honor in the person of the venerable Nathaniel Wales.⁴ Charles Phelps of Stonington, John Coleman of Hartford, Daniel Lathrop of Norwich, and Andrew Adams of Litchfield wrote urgent letters to Ingersoll im-

pressing him with the fact that nothing would give them greater pleasure than to have the privilege of distributing stamps in their respective townships.¹ Adams's letter was typical. "I should Esteem myself honoured [he wrote] to be thought Worthy your Service; and would Receive the Favour with Gratitude . . . and hope I shall be able to Convince you—as much as the Difference of station will admit,—how much I am your sincere Friend and Obedient Servant."²

On the other hand, a feeling of profound indignation was not slow in manifesting itself within the colony, both against the Stamp Act and the Connecticut stamp distributor. Ingersoll attributed this to the excitement caused by the Virginia Resolves, introduced by Patrick Henry in the House of Burgesses, May 30. He declared that Boston, which he had found quiet the latter part of July, was thrown into a flame when these resolves "took air." As a consequence, this intense feeling soon spread to Connecticut.³ What undoubtedly added acuteness to the situation was the fact that the colony was going through something of an economic crisis. In fact, it was very difficult for the colonial government to collect its taxes, "on account of the poverty of the people."⁴ Although many delinquents were committed to jail, the tax

arrears of the colony, by the end of 1765, amounted to some \$80,000 in uncollected rates and taxes laid for calling in and sinking the bills of credit issued as the result of the Seven Years' War.¹ To the debtor class, the thought of being required to assume additional burdens could only seem intolerable. As early as July the question was propounded through the columns of the *Connecticut Gazette*, "whether the Americans were going to allow themselves to be burdened";² for the sad condition of the colonials appealed to writers as strikingly analogous to the Israelites in bondage. "The Egyptians paid dear for their oppression and the Israelites were removed from their governments; these and other statements carried with them an almost pungent odor of disloyalty ten years before the usual outbreak of the Revolution. In August, the *Gazette*, which was published in New Haven, in giving a list of persons appointed as distributors of stamps in America, significantly printed beside it certain extracts of late intelligence from England," which read as follows: "I must take leave positively to declare that all measures prejudicial to the interests of America, ever yet taken, have not only been proposed but even warmly recommended by mean, mercenary Hirelings, Parricides among yourselves, who for a little filthy Lucre would at any time betray every Right, Liberty and Privilege of their fellow subjects."³

To give cohesion, direction, and force to this spirit of resistance, there appeared among the northern colonies in the spring of 1765 a rather loose form of organization under the name of the "Sons of Liberty." It is said to have originated in eastern Connecticut and to have been especially fostered by that fiery agitator, Isaac Sears of New York.¹ There is some irony in the fact that Ingersoll apparently furnished these agitators with their name, in transmitting to Connecticut early in the year his version of Barré's speech in which Americans were lauded as "sons of liberty."² The members of the organization were pledged to take any step that might be necessary to prevent the enforcement of the Stamp Act. If the occasion so demanded, even violent means were to be resorted to, for above everything else, the law should be resisted to the last extremity. As a practical program they were not only to see that no stamps were employed, and at the first opportunity to seize and destroy them, but also to compel, by force, if need be, the resignation of all stamp officials. It was this group of Connecticut men,—said to have numbered, before the repeal of the Stamp Act, as many as ten thousand, under the leadership of that romantic character, Colonel Israel Putnam of Pomfret, and possessed of a magazine of arms and ammunition,³—

which, before many months, was to come into virtual control of the colony.

Dr. Benjamin Gale, a man of patriotic tendencies and yet an acute, frank, and independent critic, in a letter to Jared Ingersoll, written from his home at Killingworth in Windham County, in the heart of the radical section of the colony,¹ declared that the men who were identified with it were the offspring of "several factions which have subsisted in this Colony, originating with the New London Society,²—thence metamorphosed into the Faction for paper Emissions on Loan, thence into the N. Light,³ into the Susquehannah and Delaware Factions,⁴—into 'Orthodoxy'⁵—now into Stamp Duty opponents." The actors, he insisted, were the same, but that they succeeded through each change in drawing in some new members.⁶ While it is probably true that the Sons of

Liberty were largely made up of discontented elements always ready to fly in the face of any settled policy and correspondingly quick to embrace new and radical causes; while as a class they could hardly have been called the special guardians of good and stable government, yet there were many men, such as Roger Sherman, who gave the movement their support, at least in the early stages, and who were incontestably devoted to law and order and to sober social control.

Needless to say, Jared Ingersoll was filled with amazement to find himself suddenly enveloped in this bitterly hostile atmosphere. He had anticipated some opposition to the act, but had not expected that he personally would become the object of hostility. He found, early in August, the majority of people in such a tremor of excitement that they could not hear calm, dispassionate statements of fact; and when it was discovered by some ingenious patriot that J. I. were also the initials of Judas Iscariot, the more religiously emotional found gloomy significance in the fact.¹

The first attack launched against Ingersoll seems without doubt to have come from the pen of Naphtali Daggett, professor of divinity at Yale College.² But the basis of this hostility of Professor Daggett toward Inger-

soll probably goes back as far as 1756, when the former, against the bitter opposition of the First Ecclesiastical Society, was appointed the first professor of divinity, as well as college preacher, at Yale College, an appointment which allowed President Clap to withdraw the students from the latitudinarian atmosphere spread by the society's pastor, the Rev. Mr. Noyes.¹ Ingersoll, as was stated in an earlier chapter, was a leader at the brick meeting house and became very active in the controversy. Clap was accused not only of holding New Light views but also of corruption,² and in 1763 Jared Ingersoll and William Samuel Johnson appeared before the general assembly in support of a memorial to the effect that the colonial government, as founder of Yale College, should now assume the right to appoint visitors and to reform abuses. The general assembly, however, was in control of the New Light faction and upheld President Clap, who made an able defense of the college administration.³ Therefore, in attacking Ingersoll, Daggett was settling old scores.⁴

That the spirit of faction was running high in Yale College circles in 1765 seems to be shown by the records of a trial which took place in New Haven on August 27, before the superior court. On this occasion Elihu Hall, king's attorney, presented "William Nickells, Ralph Romnay, William

The Connecticut stamp master, according to Professor Daggett's implication, had asked his indignant neighbors, "But had you not rather these duties should be collected by your brethren than by foreigners?"¹ To which Daggett, sheltering himself behind the *nom de plume*, "Cato," replied, in the columns of the *Connecticut Gazette*: "No, vile miscreant! Indeed, we had not. That same rapacious and base spirit which prompted you to undertake the ignominious Task will urge you on to every Cruel and oppressive Measure. . . ."

But Jared Ingersoll was not without loyal friends. The gauntlet was hardly thrown down when it was snatched up by one who, under the name "Philopolitus," rivaled "Cato" in the violence of his language. "Cato's face," he wrote, "appeared through his veil and *he*, was the real enemy of his country in desiring a foreigner, rather than a brother, to execute the laws. But as either the Love or Hatred of such a conceited Upstart is not worth the Notice of any but his Fellow Fools, I shall say no more."²

“Civis,” in the same issue of the local paper, with a fine dignity remonstrated with “Cato.” “I would ask the favour of the letter-writer to lay his hand on his heart, and ask himself whether the personal abuses he has dealt out so freely and so bitterly are becoming a Christian or Gentleman; whether he has any Evidence to warrant such gross imputations to particular characters!” He proceeded in justification of the Stamp Act to point out that Great Britain felt obliged to maintain along the frontier some seven thousand men to protect American interests from the lately subdued French. The cost of this would be over £300,000, and, including the West Indies, America was expected to raise only £100,000 of this sum by stamps and other duties. On this basis it would take from Connecticut only about three or four thousand pounds. “Civis” then made clear that there would be no drainage of currency from America, that all sums raised in the colonies would be spent in the defense of America, besides the annual sum of £200,000 coming from England, which would be a benefit.¹ It must not be

That which adds significance to this statement of “Civis” is the fact that he, according to the evidence presented below, was none other than Jared Ingersoll himself, who was probably the best informed man in America regarding the plans of the Treasury Board with respect to America.

Chauncey Whittelsey, a shrewd business man, in writing to Ezra Stiles, April 16, 1765, expressed his fear, which seems to have been commonly held and which Ingersoll combated, that the specie would be drained from the

that of Parliament can enforce such Equitable and fair contribution of the whole; this, they say, the Stamp Act will do, and, at the same time will lay the burden principally upon Luxury, Law-Suits, etc. where it ought to fall."¹

The "Civis" replies written at this period in defense of the Stamp Act and those that later appeared in the *Pennsylvania Journal* in defense of the special and newly created vice-admiralty courts seem to have been inspired by Ingersoll, if not actually written by him. The sentiments expressed, the air of authoritativeness with which information regarding Great Britain is presented, and the striking similarity of style with his acknowledged writings creates a very strong presumption, in itself, that they came from Ingersoll's own pen.²

The reply of "Civis" had the effect of chastening "Cato's" spirit. Apologizing for his previous violence, Cato now made a restatement of his position against the Connecticut stamp master. "If every American bravely refused to become instrumental in enslaving his country, it would have given all sensible and Free Britains an exalted Idea of our Patriotism and so would have been the most effective Means to influence them in our Favour. But, on the Contrary, when the Ministry saw how greedily *some* of those who has sustained the highest Character in the Colonies caught at the Bait, what must have been

their Sentiments? . . . However, neither the Sum to be raised nor the Pay of the Officers give us so much Uneasiness as the Manner of laying this Tax and the strange Design *they say* it is to support; namely, '*to Keep a Body of Troops, viz., about 7000 Men upon the frontier of America to preserve the People from the Violence of the bordering Indians.*' Truly, Mr. 'Civis,' we tremble at the Prospect of this.'"¹

"Civis," not to be outdone, again came to the defense of the measure. First of all, turning his attention to "Cato," he declared, "I would have his Heart warm so long as his Head is cool, on a subject so important as the Stamp Act. He supposes the Act being unconstitutional as a Matter determined . . . 'Tis doubtless a Principle of the English Constitution that the People are not to be taxed but by their Representatives in Parliament; 'tis also as much a Principle that the People are not bound by any laws but such as are made by their Consent in the same Manner. Perhaps we shall find, upon these Principles, that the Parliament has no Authority over us in any Case. This, I believe, would be proving a little too much. . . . The favourite Col. Barré in that speech of his, delivered with so much Warmth in our Favour, said expressly that no man in his senses would deny the Authority of Parliament to tax America, and he was pleased to add that he did not believe the more sensible People of America thought otherwise." Then, taking up the general situation, "Civis" deprecatingly remarked, "Alas a perfect Frenzy seems to have seized the Mind of the People and renders them deaf to all Reason and Consideration. . . . I wish we may not by our Imprudence precipitate ourselves into greater Troubles than that which the Stamp Act would occasion."²

A "frenzy" had, in fact, taken possession of rich and poor people of almost every type and description, not only in Connecticut, but elsewhere in America. The existence by August, 1765, of what psychologists might call a "mental wave of high tension," extending along the whole Atlantic seaboard and into the back country, is a fact that offers a field of study for the student of mass psychology, as interesting as that wave, which, under the name of the Great Awakening, had swept, in the form of religious emotionalism of an extreme type, through the colonies three decades before.¹ The press, of course, took a most active part in stirring up resentment of an unthinking sort by giving greatest prominence to inflammatory denunciations and thus engulfing the more thoughtful contributions that came to them.² In

an open letter to the public, Ingersoll dealt with this situation. "And here," he said, "I cannot but take notice how unwilling some News Writers seem to be to publish any thing that serves to inform the minds of the people of any matters which tend to abate their Prejudices. They even make use of some kind of Caution, I observe, to prevent the people from listening to any such cool and dispassionate dissertations and remarks which at any time they happen to publish, and, at the same time deal out their personal abuses in the most unrestrained manner, repeating, with pleasure, the accounts of the most extraordinary libellous exhibitions and practices."¹

The results of this steady feeding of the flames of passion were not slow in appearing. On August 15, 1765, Andrew Oliver, the Massachusetts stamp distributor, was forced to resign.² In a letter to Ingersoll he said that after having stood the attack thirty-six hours, "a single man against a whole People," he had been forced to yield.³ James McEvers of New York, who seems to have been a leading merchant, received and accepted the appointment as distributor for that province. McEvers,

however, was forced out of office August 22.¹ He informed Ingersoll that when he accepted the post there was little or no clamor about it; but when the news spread of Oliver's treatment at Boston and the "Cato" letter from New Haven had been published in the *New York Gazette*,² the agitation commenced. He was threatened, he said, with a fate worse than Oliver's, and therefore wrote out his resignation "& have Been Inform'd you have Done the Same; . . . if you have not should be Glad to Know how you Purpose to Act, as it may be some Government to me in Case I Can't Procure a Release."³ Soon after Ingersoll had received this letter, there came the news also of the resignation of Augustus Johnson, the Rhode Island distributor.⁴

Ingersoll now realized how uncomfortable his situation was. Although he had experienced no violence, as yet, nevertheless the temper of the radical group was reaching a high pitch. "A Friend of the Public and no Enemy of the Stamp Act," through the columns of the *Gazette*, predicted that "if the Assembly shall think it necessary and prudent . . . to submit to it [the Stamp Act] and to practice upon it, I conclude every Member of the House who is of that Sentiment will be voted an Enemy of his Country by the Mob, be burnt in Effigy and stowed away with the Stamp Officers."⁵ Terror, in fact, struck into the hearts of timid supporters of the home government. Nathaniel Wales of Windham, who had solicited from

Ingersoll the office of assistant distributor of stamps, wrote to the stamp master, August 19, to the effect that he had first written "without much Consideration and while matters were much indigested," both in his own and other people's minds. He asserted that a thousand pounds annexed to the trust would not tempt him to act as assistant stamp distributor.¹

There was every reason why Wales should feel as he did, for on August 21 Ingersoll was burned in effigy at Norwich, and the following day the proceeding was repeated at New London.² The ceremony at the latter place was elaborate and carried out with great care for all details. At six o'clock in the evening there was exhibited on a gallows erected in the most public part of the town, the effigy of the stamp master, "with a Boot placed a little back of his right shoulder wherein was concealed a young Imp of the D——l peeping out of the same in order to whisper in his ear."³ On the breast of

the effigy was a copy of the Stamp Act and an inscription in praise of liberty. When the crowd had assembled, the effigy was pulled from the gallows, mounted on a pole and carried through the main street, "attended by the people of all Professions and Denominations," with music, the firing of guns, the beating of drums, and the acclamations of the crowd. After "arriving at the place of Assignation, a Halter was placed around the neck of the Effigy which was again suspended in the air, on a gallows, and a bonfire being erected under it, the same was consumed. his neck shall suddenly be destroyed, and that without remedy! Therefore take care of Mr. St—pm—n, alias the molten calf."¹

On August 26, both at Windham and at Lebanon, the effigy ceremony was reënacted.² At Lebanon, the home of Jonathan Trumbull, effigies of Ingersoll and the Devil were bundled into a cart, taken to trial, found guilty and "miserably executed," amidst the wild plaudits of the onlookers.³ On that same day a Boston mob wrecked the home of Lieutenant Governor Hutchinson and destroyed other property. The proceedings at Lyme, Connecticut, on the twenty-ninth, were characterized by such studied efforts to work the people into a state of blind fury that it will be necessary to give some account of them, in order to show the character of the forces that were arrayed against the Connecticut stamp distributor.

These proceedings were called the "Tryal of J—d Stampman, Esq., before the Proctors of Liberty." The accusations against him were, "That not having the fear of God before his eyes, but being moved thereto by the instigation of the Devil, he did, on the 29th of Sept., 1764, Kill and murder one of his own Bretheren, of the same family to which he belonged; and that still further pursuing his wicked designs, he did, on the first of June, 1765, enter into a Confederacy with some other evil minded, wicked, and malicious persons, to kill and destroy his own mother, Americana, . . . And urged on by Satan with the warmest Zeal to perpetrate this wicked Crime, he by the help of those designing Persons, in Confederacy with him, obtained a weapon wherewith to commit the horrid Fact. The Weapon he obtain'd was called a

Stamp, which came from an ancient and lately Butefied Seat in Europe: With this Weapon his intent was on the 1st of Nov. following, to have Stamp'd his languishing Mother till she becoming unable to resist, and incapable of supporting the Grievous Burthen; should expire." The counsel for the defense, which was "Scroggs and Jeffries," urged that the person murdered September 29, 1764, was not his brother "but a Servant of his Father's Family, and that the pride of his Heart had prompted him to take many unjust Measures to raise his Fortune above the proper bounds of his station in Life." As to the part of the indictment charging him with a design against his mother, Americana, it was urged in defense that "as her fate was absolutely determin'd, and could not possibly be avoided, he had good right himself to be the Executioner, since he should by that means save 8 per c't out of her Estate, to himself, (which probably would be a living worth 5 or 600 per ann.) which might as well be put into his Pocket as another's." Upon mature deliberation the court found the prisoner guilty, and gave sentence against him, "That he should be forthwith tied to the tail of a Cart, and drawn thro' all the principal streets in Town, and at every Corner and before every House should be publicly Whip'd; and should be then drawn to a Gallows erected at least 50 feet high, and be there hanged till he should be dead, and then cut down by the common Hangman, and buried at the meeting of three Roads and a Monument erected over him, shewing the Cause of his ignominious Death, that the infamy of his Crime might be perpetuated to after Generations." The sentence was thereupon put into execution.¹

Such demonstrations as these cannot but impress one with the feeling that the people concerned in them, prob-

ably kindly and generous-hearted enough under ordinary conditions, were so caught in the swirl of this tidal wave of apprehension and resentment sweeping the country, that they lost the power of using rational means in defense of their cause, and sank back to the mental levels of the emotional primitive.

On the tenth of September George Meserve, the New Hampshire distributor, was frightened into a resignation. Jeremiah Miller of New London wrote a letter of warning to Ingersoll, also on the tenth. "I really believe," he said, "that your Person and Estate will be greatly endangered if you continue in this office"; Miller also informed him that the people were in a great rage against the governor for not calling the assembly, and he hoped that Ingersoll would use his interest that it might be done.¹

While no effigy was prepared by New Haven people, it would appear from the *New London Gazette*² that one evening a crowd gathered about Ingersoll's home, and demanded that he should resign, threatening to tear down the building should he attempt to act. He told them of his inability to resign until the colonial government had taken some stand in the matter, and promised either to keep the stamps out of the colony or, should the parchments be sent to his home, to throw open the doors to the public so that the people might make a bonfire of them, if that continued to be their demand. This promise seems to have satisfied them.

However, at West Haven, on the night of the tenth, there appeared "a horrible Monster, or Male Giant, twelve Feet high, whose terrible Head was internally

illuminated. He was mounted on a generous Horse groaning under the enormous Weight. This Giant seemed to threaten Destruction to every Person or Thing around him, which raised the resentment of a Number of stout Fellows, who constantly pelted him with Stones till he fled. The Assailants pursued and soon took him Captive, and triumphantly drove him about a Mile in the Town, attended with the discordant Noise of Drums, Fiddles, and taunting Huzzas. The People then directed their Course toward a Hill called Mount Misery. There the Giant was accused, fairly tried and Condemned by a special Jury and Impartial Judge as an unjust Intruder, a Patron of Ignorance, a Foe of English Freedom, etc. and was sentenced to be burnt. The Sentence was accordingly executed, amidst the joyful Acclamations, of near three Hundred *Libertines*, Men, Women and Children. It should be mentioned that, through the whole of this Raree show, no unlawful Disorder happened, as was the Case in the last truly deplorable and truly detestable Riot in Boston.”¹

For months Governor Fitch had resisted the demands of the radicals that a special session of the general assembly be called in order to decide whether or not Connecticut should send delegates to the Stamp Act congress, which was to assemble in October in New York. Fitch, unable longer to delay matters with safety to himself and property, now gave way and issued an order for a gathering of deputies at Hartford on September 19. Ingersoll personally was gratified to hear of the special session, for he felt, as things became more and more critical, that it was imperative for him to find out, as soon as possible, the attitude of the Connecticut government toward the enforcement of the Stamp Act. However, until there was a decision in favor of the act, he was not

at all disposed to admit into the colony for bonfire purposes any of the stamped parchments. He therefore wrote to Lieutenant Governor Colden¹ of New York, requesting him to hold in New York, until further notice, all stamped paper designed for Connecticut.² He also, once again, appealed to the people of the colony, through the *Gazette*, to be calm; they could be assured, he wrote, that he would not serve against their wishes; the assembly should decide whether or not the act was to be obeyed; in closing this exhortation, he declared with fervor, "I believe you will have very different Sentiments a few Months hence of who are the true Friends and who the Enemies of their Country."³ But, in spite of this conciliatory statement, he did not hesitate, a week later, to come strongly to the defense of the unfortunate McEvers of New York, who had been appointed distributor of stamps without his own knowledge, through the recommendation of Alderman Barlow Trecothick of London, who was the leader of the London merchants in opposition to the passage of the Stamp Act.⁴ Also, at

a meeting of freemen held at New Haven, on September 17, he showed his courage. When called upon to resign immediately, he refused and defended his position in a vigorous speech, in which he emphasized the fact that the general assembly of the colony at its May session had not been averse to the enforcement of the Stamp Act,¹ and for that reason, it was quite necessary for him, before deciding upon any course of action, to ascertain the will of the approaching assembly, which was called to meet in special session at Hartford. His position upon this point was sound, especially in the light of the conservative tendencies displayed by the Connecticut government during the summer months, when the Massachusetts assembly, through a circular letter of June 8, to all the colonial governments, was striving for the calling of a colonial congress.² The freemen, it appears, subdued by Ingersoll's logic, eloquence, and determination, adjourned without taking any further steps against him, after having appointed Roger Sherman and Samuel Bishop as deputies to the general assembly.³

For some unknown reason, the Connecticut Sons of Liberty were slow in attempting to carry out the plan

they seem to have devised in August for putting an end to the office of stamp distributor for the colony. However, the news of the special session seems to have brought them to a resolve to compel Ingersoll to follow in the footsteps of Oliver, McEvers, Johnston, and Meserve, in resigning, thus relieving the general assembly of the weighty responsibility of taking any official step against the act. By the middle of September well-confirmed reports came to Ingersoll that there were gathering in eastern Connecticut at certain points bands of men who were making ready to march upon New Haven. It would appear that this news brought about a decided reaction in the town in favor of the stout-hearted stamp master. His position on the matter of enforcement had been such as to do away with considerable prejudice. Moreover, the more law-abiding elements resented the idea of having the town invaded by men "from the eastern parts," with lawless designs. The more "loyal" people even began gathering arms in the determination that their fellow townsmen should be defended. The local militia also seemed disposed to put down any attempts at disorder.¹ New Haven, in spite of the previous gathering about Ingersoll's home, was in a conservative mood, and it is not unlikely that there would

have been bloodshed if any such violent measures had been attempted in New Haven as were carried out in Boston.

On the seventeenth of September, Governor Fitch arrived in New Haven on his way to the general assembly, which was to sit in Hartford. Ingersoll thereupon not only delivered to him written information which acquainted him with the intelligence just received from the eastern part of the colony, but also requested his aid in as far as the emergency demanded it. The two men were firm friends, and it is unnecessary to say that Fitch felt disposed to do everything within his power to aid Ingersoll at this juncture. Yet there was very little that Fitch could do, for a Connecticut colonial governor had scant power except as the instrument for putting into effect the will of the general assembly.¹ It was agreed, however, that the bands must be diverted from their purpose of entering New Haven, and there was no better way to accomplish this than for the stamp master to go to Hartford, where he would be able to meet the assembly.²

On the morning of the eighteenth, Ingersoll set out with Fitch and certain members of the assembly. For eighteen miles the group rode along the Hartford road without disturbance. There then appeared two horsemen "with pretty long and large new made white Staves in their Hands." These proved to be the advanced guard.

for one of the main bands of the Sons of Liberty, sent out to reconnoiter and see who would join them. While the remainder of the party rode on to Bishop's tavern "at the Stone House [Meriden]," Ingersoll stopped short to ask the strangers if he were not the man they were "in pursuit of." When they answered in the affirmative, he told them that he was not disposed to avoid a meeting with "the People." Nevertheless, he asked the riders to accompany him to the tavern in order that they might together confer with the governor. One of the two consented to do so, while the other went on about his mission of beating up recruits.¹

In the conference that ensued at the tavern, the stranger frankly informed the governor as to the purpose of this march upon New Haven. When the latter solemnly charged him to go back to his fellows with a message to disperse immediately and return home, the bold spirit replied to this mandate by saying that the project was looked upon as the cause of the people, and he further assured his excellency that "they did not intend to take Directions about it from any Body."² He was not, however, averse to disclosing the fact that the Sons of Liberty were coming from the eastern parts in three divisions with eight days' rations in their saddlebags. One of these, starting from Windham, was approaching by way of Hartford, gathering recruits along the way; to

this band he himself belonged; another division, starting from Norwich, was approaching New Haven by way of Haddam; while a third, from New London, was moving westward through the towns along the Sound. Branford was to be the general rendezvous, whence on the morning of the twentieth it was planned that the force should enter New Haven, which was close at hand.¹

When Ingersoll understood that two other bodies of riders, besides the one approaching from Hartford, were moving toward New Haven, he immediately wrote to each a letter for the purpose of checking them, in which he declared that he would certainly give up his office if he found it generally disagreeable to the people; he also agreed to meet them in Hartford, if this promise did not satisfy them. After dispatching a Son of Liberty with these messages, he took the precaution to send the proprietor of the tavern posthaste to New Haven with a letter to his family "that they and my house might be put in a proper state of defence and security, in case the people should persist in their first design."² When those labors were finished, it was so late that he determined to tarry for the night at the tavern. Meanwhile, the governor, bearing a letter which Ingersoll had addressed to the general assembly, rode on with the assemblymen, in order to be at Hartford at the time set for the opening of the general assembly the next day.

The Windham-Hartford band soon received the intelligence that Ingersoll was on the way to Hartford "to apply to the Assembly for their protection,"³ and the determination was reached that he should not be allowed to appear before that body until the Sons of Liberty had

settled with him. As a precaution, one guard was placed around the state house at Hartford, where the legislature was to meet, and another stood in front of Ingersoll's "usual lodgings," when in that town. The stone bridge on the road from Wethersfield and the approaches by way of the road from Farmington were also made secure. With this accomplished, early on the morning of the nineteenth, the main body of Windham-Hartford men rode forward in search of their victim.

About seven o'clock Ingersoll, accompanied by Bishop, the tavern keeper, started for Hartford. The two soon overtook Major Elihu Hall of Wallingford, who was on his way to the assembly, as one of the deputies.¹ The three rode without incident until, within two or three miles of the town of Wethersfield, they perceived four advancing horsemen. When Ingersoll acknowledged his identity, they wheeled about and attached themselves to the stamp master and his acquaintances. About half a mile farther on there appeared a group of some thirty riders, who likewise fell in behind the Hartford party, and shortly after this the main body of the Sons of Liberty were seen advancing in a truly imposing array.² Three trumpeters were in the lead; then came two dignitaries of military rank dressed in red, and wearing "laced hats," and behind them a cavalcade of about five hundred moving along two abreast, each carrying in military fashion a "stout clean-shaven, willow wand." The uniforms of some betrayed the fact that they were militia officers.

Without uttering a word, the squadron wheeled about and just as silently escorted Ingersoll to an immense elm

at the lower end of Wethersfield which stood in front of the mansion of Colonel Chester.¹ The plan, apparently, was to take him into a house and there come to an understanding agreeable to the Sons of Liberty. Objection was raised to this, with the result that a great circle was formed with Ingersoll, Major Hall, Bishop, and two or three of the leaders in the center. Ingersoll started to address his audience, but stopped, declaring that he did not know why he should say anything, for he was not certain what they wanted of him. They then told him that they wanted his resignation. He replied that he had already declared that he would not exercise the office against the general inclination of the people, and that he had given orders to have the stamped paper held at New York, where it should remain until he was able to learn from the assembly that it was their desire to have it come. He reminded them that he was under bonds to the stamp office in England and he therefore did not think it either safe or proper to resign the office "to every one that should ask it" and that he only wished to get the sense of the government whether or not to conform to the act in order to get dismissed from his office properly. It had been asserted that the assembly would say nothing about the matter; in that case, the speaker said, he would hardly think it safe to suffer stamps to come into the colony or to take any steps in his office. Moreover, as to resignation, the governor had the power to appoint another distributor.

In reply to this expressed desire of Ingersoll to gather the sense of the government came the answer, "Here is the sense of the government, and no man shall exercise that office." Ingersoll thereupon asked if they thought it was fair that the counties of Windham and New London should dictate to all the rest of the colony. Upon this one of the band said, "It don't signify to parly—here is a great many People waiting and you must resign." Ingersoll retorted that he didn't think it proper to resign until he met one authorized to ask it of him, and then added: "What if I won't resign? what will be the Consequence?" Some one said, "*Your Fate.*" Ingersoll turned upon him, looked him full in the face and said, with some warmth, "My FATE, you say." Upon which a person just behind said, "*The Fate of your Office.*" Ingersoll was in a fighting mood and answered that he could die and perhaps as well now as another time; that he could die but once.

At this point, the commandant, who was Major John Durkee of Bean Hill, near Norwich, a veteran of the French and Indian War,¹ suggested that the matter would be concluded at a near-by tavern a few rods north of the Chester home. The crowd then moved along until opposite the hostelry and the riders began to dismount. Ingersoll thereupon declared to them, "You can soon tell what you intend to—my business is at Hartford—may I go there or Home?" and made a motion to go. The reply was, "You shan't go two Rods from this Spot, before you have resigned," and his bridle was seized. Seeing that nothing could be accomplished by remaining in the

saddle, Ingersoll dismounted and went into the tavern, accompanied by the "committee" of the Sons of Liberty, who were—besides Major Durkee—John Burrows and Jonathan Sturgis of Fairfield and Captain Hugh Ledlie of Windham.

It was possible now for Ingersoll to talk over matters generally with these representatives of the popular side. First of all, he disabused their minds of the idea that he was in England when the first leading vote of parliament was passed regarding the Stamp Act and failed to advise the governor regarding the same.¹ The strength of character displayed by the stamp master evidently overawed these men, who treated him not only with "moderation and civility," but were even inclined to accept certain proposals which he made. When these, however, were referred to the people who crowded the streets, they were rejected—nothing would do but an absolute resignation.

While Ingersoll was being detained in the tavern, several members of the general assembly happened to pass by on their way to Hartford. Ingersoll saw them from the window and hailed them, calling out that he was being held a prisoner and asked their assistance and that of the assembly to effect his release. The assemblymen halted and began to remonstrate with the Sons of Liberty, who treated them with as scant respect as they had treated the governor the day before, telling these lawmakers that they had better go along to the assembly "where they might possibly be wanted." As there was nothing to be done, the assemblymen took the hint and were accompanied to Hartford by Ingersoll's companions, Major Elihu Hall and the tavern keeper. The latter carried a message at the stamp master's request to the governor and assembly.

Ingersoll now made other fruitless proposals. The committee then informed him that he must bring the matter to a conclusion, threatening to carry him to Windham as a prisoner. In reply, the stamp distributor expressed his willingness to go. As this was not what they wanted, they resorted to other tactics. He was warned to keep away from the front window, as the sight of him enraged the people; now and again the populace would even burst into the tavern room in great numbers, "look pretty fierce" at him, and upon the desire of the committee withdraw. This sort of thing went on for three hours. The committee then frankly informed Ingersoll that certain of their sympathizers in the general assembly had told them that the matter must be concluded before the assembly could take any action; they accused him of artifice and of wheedling so as to get the assembly ensnared. At that stage of the discussion, Major Durkee entered the room and with much concern told him that he was unable longer to keep the people from him, and that, if they once began, he could not promise where they would end. It was high time to submit, and Ingersoll, thereupon, went to the front window and made known to the crowd below that he would comply with their desires and would sign whatever paper was drawn up. He then set to work and drafted a statement regarding his resignation, but this was rejected in favor of one prepared by the committee, which, when completed, Ingersoll signed.¹ He was then informed that the people insisted on his swearing never to execute the duties connected with the office. This Ingersoll peremptorily refused to submit to on the ground that it would be a profanation of an oath and, before the

people could come to a decision in the matter, he left the tavern and entered the street in the midst of them. Mounting a chair, removing his hat and beckoning silence, Ingersoll then read the signed declaration and afterwards addressed them in a short speech in which he told them that in some measure he could excuse them, for he believed they were actuated by a real, though, he feared, a misguided zeal for the good of their country. He added that he wished the transactions of that day might prove happy for the colony, though he confessed that he very much feared the contrary. Then, upon being requested, he gave "Liberty and Property, with three cheers," throwing his hat into the air in the conventional manner,—all of which was greeted with loud huzzas; many now crowded about the chair to grasp the hand of the ex-distributor of stamps and to tell him that he was restored to their friendship. These protestations were cemented at a dinner in a near-by house.

Meanwhile, the general assembly had been notified of the riotous proceedings at Wethersfield. A discussion at once took place as to the best policy to pursue under the circumstances. The lower house came to the conclusion that it would do more harm than good to send a force to the relief of the stamp distributor. At last it was decided that a group of influential men should go to Wethersfield and try the power of persuasion. This easy solution was accepted by the upper house and the delegation was about to set out when the news arrived that "the matter" had been amicably settled.

But the incident was not ended. Ingersoll was informed, when he had dined, that the Sons of Liberty would accompany him to Hartford in order to be present when he read his declaration before the general assembly. By this time, it would appear that the Norwich and New London bands had joined the Windham-Hartford band at Wethersfield, for the number of horsemen which started for Hartford was estimated at about a thousand.¹ This journey seems to have been a good deal of a frolic. The story has been handed down that the ex-distributor of stamps, who was riding in advance on a white horse, cleverly retorted, when asked how he felt to find himself attended by such a retinue, "that he had now a clearer idea than ever he had before conceived of that passage in Revelations which described Death on a pale horse and Hell following him."²

When the company reached Hartford, they boldly came within some twenty yards of the state house,³ where the legislature was sitting, and thereupon dismounted. While Ingersoll was escorted to a near-by tavern, the Sons of Liberty, four abreast, in military formation and preceded by the three resounding trumpets, brazenly marched around the state house. This, it is presumed, had the effect of clearing that building of its occupants. After the march, a great semi-circle was formed about the tavern and Ingersoll was then called upon to reread the Wethersfield declaration, to cheer again for liberty and property, and, according to the Rev. Samuel Peters, to throw into the air not only his hat, but also his wig.⁴

The Sons of Liberty had now fulfilled their mission. They therefore turned their backs upon Hartford and took the road to the eastern counties. At Windham they spent an evening of great hilarity. A fire was kindled on the village green and the boisterous crowd could not refrain from burning again the hapless Ingersoll in effigy.¹

After quiet had been restored in Hartford, and the sitting of the assembly resumed, Jared Ingersoll appeared before the united membership of both houses and, in an address of some length, made clear the history of his relations to the passing and enforcement of the Stamp Act. Ingersoll was, of course, a powerful speaker and his record was clear; moreover, he was heartily supported by Governor Fitch. Probably by reason of the address the assembly was brought into such an attitude of mind that it was disposed to take cognizance of the riotous actions of the Sons of Liberty, which, indeed, had put the loyalty of the colonial government in a bad light. It seems that, as a body, the deputies favored an opposition to the Stamp Act along lines that were strictly constitutional and, as men of property, were not a little concerned with these lawless manifestations within the colonies. As a result of this reaction, the general assembly, cautiously waiting until the eastern bands had dispersed, repudiated the recent coercive act of the populace and authorized the governor to issue a "proclamation" calling upon the officers, civil and military, to suppress all riotous proceedings, which he proceeded to do.² This placed Ingersoll in such a predicament that, viewing things from his legal standpoint, he felt obliged to with-

draw his resignation extorted by force, justifying himself upon the ground that his bond, under the circumstances, would be forfeited.¹

The special session of the general assembly had been called to decide whether the colony was to be represented at the approaching Stamp Act congress. While Eliphalet Dyer, William Samuel Johnson, and David Rowland were appointed commissioners to the congress, the conservative element in the assembly was so far in control that these commissioners were not allowed in any manner to bind the colony. "In your proceedings, you are to take care that you form no such juncture with the other Commissioners as will subject you to the major vote of the Commissioners present." The Connecticut delegation, therefore, was unable to sign the petition to the crown adopted by the congress. The general assembly, however, drew up a memorial in which it endorsed the principles laid down in the petition.²

Although Ingersoll was now allowed to remain in New Haven without being subjected to physical violence, it may be surmised that this ordinarily genial man was far from happy. He seems to have been oppressed with a sense of isolation. A letter which he wrote to his friend, William Livingston of New York, at this period, shows his state of mind. "It is much if you dont by this time paint me out in imagination as a kind of fiend with a cloven foot and fiery-forked tongue—a Court Parasite and a Lover of the Stamp Act; and yet, the truth is that I love the

Stamp Act about as little as you do and remonstrated to the late Minister against it, all in my power.—What! and Accept of the Office of Distributor of Stamps when you have done? impossible!”¹

The way in which he was regarded at New Haven and elsewhere in western Connecticut is probably reflected pretty faithfully in a communication to the *Gazette* by a local correspondent who wrote, September 27, that “Patriotic writers in the Boston and other News Papers still propagatè their Abhorrence of a late Stamp-Master in this Town. They call him a Dictator, a Negrosoul, a voracious, mad Creature, a Hero and a G——n. They treat him and his Writings with the utmost Contempt and Detestation, it seems, chiefly owing to the Weakness of his Cause, and because he seem’d and still seems to think that a tame Obedience to the oppressive Stamp-Act would benefit this Country. . . . It ought to be mentioned that the intelligent Freemen of this Town, almost unanimously contemplate with Horror, the dreadful Consequences of being (internally) taxed by any other Power than that which is given to their own undoubted Representatives.” If Ingersoll thought, the writer went on to say, that in accepting office he did the colony a service, he must now be sensible of the contrary. “If he did really abandon the Cause of his Country, and do any Things towards encouraging, wilfully, the late destructive Measures, I wish it may be proved. In the Mean Time, I think it cannot serve the Common Cause to treat him with scurrility; for there are a great many brave Hearts in this Colony that hate a stamp-man, but love Mr. Ingersoll.”²

The general assembly met for its regular fall session at New Haven, October 10. Governor Fitch was fast losing in popularity, but was still influential. Ezra Stiles declares that the first thing which "really lost him with the people" was his urging the assembly to prosecute as rioters the five hundred that coerced Ingersoll at Wethersfield. Stiles affirms that the people could have forgotten this had not Fitch, in the October session, held back when it came to passing resolves and "talked of the public spirit in the Language of Enemies, said that the Act must go down, that forty men, regulars, could guard the stamp papers and that the American conduct would bring violent measures from the home government & particularly the loss of the Charter."¹ Fitch, under the terms of the instructions he had received from the home government, was obliged to take an oath, before November 1, that he would uphold the Stamp Act. Had he refused to do so, he would have been liable to the loss of £1000 sterling and his office, and would have put the colony in danger.² The governor delayed taking any action until the very last. He appeared before the lower house of the assembly and sought its advice, but it was disinclined to commit itself. Therefore, in light of this undecided attitude on the part of the deputies, he felt constrained, on the last day of October, to call together the assistants in order that the oath should be administered in their presence. A long debate ensued among them, with the result that "finally the Gentlemen on the East side of the River refused and withdrew,"³ declaring that in conscience they could not be present since they

esteemed the oath unconstitutional, together with the provisional oath that the governor had taken. Elisha Sheldon, another assistant, "twisted and nestled about but finally staid in the Council Chamber."¹ The oath was administered by Assistants Silliman, Hamilton, Chester, and Hall. Some of the assistants from the eastern parts, according to Ingersoll, took the ground that they should not scruple as judges, which all assistants were, "to declare the act of Parliament, ipso facto void."² When the news spread that the oath had been administered, the four assistants, who were present at the time, together with the governor, were "threatened in the highest manner with political Death."³ Ha

On that very day a ludicrous incident took place. While the governor and the assistants were debating the question of the propriety of administering the oath, Ingersoll received a letter from Lieutenant Governor Colden of New York. In this, the latter desired him most earnestly to take care of the stamps which he had received and which were for distribution in Connecticut. Ingersoll thought it proper to inform the assembly of the situation; but, according to Dr. Leverett Hubbard, a prominent citizen of New Haven, when that august body heard that he was approaching, they shut the door and the

“East side of the Upper House run away which made Mr. Ingersol Laugh very Hartily.”¹

The morning of November 1, 1765, the bells of New Haven, in the belfries of the State House, Center Church, and Yale College “continued tolling and mournfully saluting each other at suitable intervals and a fast was proclaimed in all the churches”: this was the day when the Stamp Act was legally to take effect.² On this day, at New Haven, it is also related, a large number of the “lower sort of people—Captain Wolcott at the head”—made a coffin about two feet long, put a copy of the Stamp Act in it, and then buried the same, leaving the king’s colors flying over the grave.³ At Hartford, it is said that the Sons of Liberty not only buried the Stamp Act “but the governor also.”⁴

The following day Ingersoll wrote to Thomas Whately and made clear the formidable aspect of the opposition to

the act. He suggested that in case parliament could be brought to modify the measure, it would be advisable to free all probate-testamentary matters from the tax, a modification which would take away "the Cry of the Widows and the Fatherless"; he also suggested that the tax on the registry of deeds should be given up, as it would amount to but little and yet be burdensome, for it was customary to register them in books; and lastly, that processes before single justices to the amount of forty shillings, should be freed, as they generally were concerned with debt and would fall principally upon the poor.¹ However disposed Whately might have been to aid in the modification of the act, he was now without influence or standing in the ministry, which had been reorganized in July under the young Marquis of Rockingham. It is doubtful, moreover, if any such concessions would have reconciled Connecticut to the Stamp Act. The assembly endorsed petitions of the Stamp Act congress and the lower house, with only five dissenting voices,² voted the act of parliament unprecedented and unconstitutional and resolved to let the ensuing winter pass without transacting any business requiring the use of stamped paper.³ "You will easily see," wrote Ingersoll to Richard Jackson, "by everything we say and do on this side the water that our notions of our Constitution and rights are such as I suspect you on your side will call notions of independence."⁴

CHAPTER VII

THE SONS OF LIBERTY AND THE CONNECTICUT GOVERNMENT

AFTER November 1, 1765, the date set for the Stamp Act to go into effect, the government of Connecticut virtually passed out of the hands of the legally constituted authorities; in place of these was substituted a species of control in public affairs essentially revolutionary in character.¹ This was made possible by the general "uneasiness and resentment" aroused by the attitude of Governor Thomas Fitch and his supporters in the council toward the enforcement of the Stamp Act. In attempting to explain to Thomas Whately the gravity of the situation, Jared Ingersoll affirmed that "no one dares, and few in power are disposed to punish any violences that are offered to the Authority of the Act—In short, all the springs of Government are broken and nothing but Anarchy and Confusion appear in Prospect."² The

utter helplessness of the Connecticut governor to perform his constitutional functions is clearly shown in the account given by a close friend of Israel Putnam of a famous interview between Fitch and that doughty leader. Putnam, it seems, went to the governor, and threatened that, unless the stamp paper, which might be entrusted to the latter's safekeeping, were locked in a room and the key turned over to the Sons of Liberty, his house would be "levelled with the dust in five minutes."¹

On November 11 there was convened at Windham a meeting of the Sons of Liberty, who, from this time on, saw fit to refer to themselves as the "Respectable Populace of the Colony." At this gathering resolves were voted and plans for future gatherings were made. The significance of all this is such as to call for a careful examination of the proceedings of the assemblage. In turning to the resolutions, the first thing that attracts attention is the statement, "We now, as the representatives of the people of the several towns to which we belong, recommend union, harmony and good Agreement in and Among us." In other words, those who came together at Windham at this time did so in a representative capacity and we have here, it would appear, a Stamp Act congress in miniature. There then followed in the resolutions the announcement that "We hereby do declare and publish this, as our settled and deliberate purpose as a free people, that we will, by all due and effectual means, prevent the use, distribution, or receiving of said papers stamped according to said act, in any branch of business or trade, either foreign or domestic by any member or members of this colony." However commendable the impelling motive, this was, of course, nothing else than a challenge thrown down to the regularly estab-

lished colonial authority when taken in connection with the governor's oath to uphold the act. In the concluding resolution, which presented a plan of organization, the determination of the Sons of Liberty to be in thorough control of every portion of the colony was set forth in the following words: "We, further, recommend it to the several towns in this colony that they meet by their representatives chosen for this purpose once in every month or oftener, if need be, until we have intelligence whether the united request of the united provinces on the Continent, at the Court of Great Britain be granted, and that the method of meeting be for each County to Associate and each immediately to send a Report and a copy of their Conclusions to the other counties and, if thought proper, at any time, the counties agreeing, to have a general meeting."¹

These resolutions were "signed in behalf of the respectable populace of this Colony," by "Philo Patria" and were subsequently published in the *New London Gazette*, which now became the official organ of the Connecticut Sons of Liberty. Before the meeting adjourned, it was voted that in the county of New London there would be a meeting at the court house in Norwich on Tuesday, the nineteenth of November, at which time and

place "deputies" from each town of this county were desired to meet and afterwards to publish the proceedings of the gathering in the *Gazette*; the deputies in Windham county were to meet on Tuesday the twenty-sixth of November, at the Windham court house; they also were to publish their proceedings in the *Gazette*. The Windham meeting of November 11 must have been limited almost entirely to "the representatives" from communities in these two eastern counties, in light of the fact that no definite steps were then taken to attempt to organize the western counties. There is further indication of the inability of the Sons of Liberty up to that time to swing the western section of the colony into line with their purposes; for, appended to the published report of the gathering, was a statement to the effect that the inhabitants of any town in any county would be welcomed at either of the meetings "as they in all the counties in this colony have not yet commenced; but it is undoubted, that when the general principles of these proceedings are fully known the same measures will be adhered to through the whole colony and there will be a connection and correspondence between the meetings of the several counties and their constituents."¹ Only grad-

ually were the people living in the remaining counties drawn into the movement, and from beginning to end it was those living in "the eastern parts" who formed the dominating and aggressive element. ✓

For months, following the first of November, no courts of justice sat in Connecticut except for criminal matters, since, according to the law, no civil case could be settled in court without the use of stamps. Naturally, the man, symbolizing in his empty office the obnoxious legislation, did not escape abuse. Writing to his friend, William Samuel Johnson, at this period, Ingersoll declared that mankind seemed to think it had the right not only to shoot at him with the arrow that flies by day but to assassinate him in the dark.¹ His every act was watched with suspicion and he suspected that his mail was tampered with,² although this was not true. It was ascertained that he

was carrying on a correspondence with England and the report spread in this connection that among other things he had advised the British government to take away the admiralty courts and to alter in one or two respects the Stamp Act, by way of concession, after which it should be "crammed down."¹ As a result, Colonel Israel Putnam of Pomfret, acting as head of the Connecticut Sons of Liberty, called for a gathering at Windham late in November. Evidently between three and four thousand men answered the summons.² Perhaps by reason of the governor's proclamation no effort was made to go in force against Ingersoll as was previously done; instead, the much more rational plan was followed of sending a committee of three of the leaders, Captains Hugh Ledlie, Aaron Cleaveland, and Asel Fitch, to wait upon the stamp master for the purpose of demanding an explanation regarding the rumors.³ The committee came to New Haven, and, in its meeting with Ingersoll, informed him that it had with considerable difficulty obtained leave to give him a chance of clearing up the charges.⁴ The latter, while admitting that he had written letters to England, not only denied the accusations that he had been acting unpatriotically but, feeling that the fullest possible publicity would only vindicate him, allowed the committee to read copies of the letters he had sent abroad, as well as the letters he had received. The men were friendly, behaved with candor, and declared themselves satisfied with

what Ingersoll had written.¹ They, however, asked permission to take the entire correspondence back to Windham, which was granted. There, at a later meeting of the Sons of Liberty, the letters were repeatedly read. Unfortunately for Ingersoll, some of the statements, after being twisted and distorted, were printed in the *New London Gazette*.² This had the effect of inflaming further

General Silliman, writing to Ingersoll from Fairfield, on March 1, 1766, shed light upon the cause of the reluctance of the radicals to have the correspondence published at any early date. In urging an early publication of the letters he said that "it seems not right that a small number of zealous People in the Colony should have them as long as they please and publish such parts of them as they think proper with their own Comments on them, and that a full Publication of them should be suppressed by means of those very People or rather only one of their number. Now pray, Sr., what is the Language of this their Conduct? is it not this? that they know they have published such things of your Letters, that their own Conscience tell them your Letters will, when published, shew them to have no other real Foundation than Malevolence? if this is a Cause of their desiring a Suppression of them, I think it is & ought to be the strongest Reason for publishing them." "I have one piece of news from the East," wrote Roger Sherman, "which a little surprises me, that is, the publication of some exceptionable passages extracted from Mr. Ingersoll's letters after all the pains taken by the Sons of Liberty to prevent them being sent home to England." Roger Sherman to Matthew Griswold, January 11, 1766, printed by L. H. Boutell in his *Life of Roger Sherman*, p. 52. Joseph Chew, writing from New London to Benjamin Franklin, after speaking of the increased confusion of the times, declared that Ingersoll was so far intimidated as to give up his letters, public and private. Chew confessed that he himself

the public mind against him and he was compelled to promise not to write anything in the future to England without express permission of those in authority among the Sons of Liberty.¹

Jared Ingersoll, however, was not the only one to be visited at this time. Chauncey Whittelsey, writing from New Haven, the latter part of December, to Ezra Stiles, said: "Political affairs with us are still unsettled. Mr. Ingersoll has been visited by committee after committee from the Eastern uneasy part of the colony and they have the Assurance (or may I not say, Impudence) to go and catechise Mr. Silliman and even the Govern^r. I am much concerned about the state and issue of public affairs, especially on Acc^t the Vileness committed among ourselves; but I hope for Light to arise out of darkness."² How estranged Governor Fitch was from this rebellious attitude of mind within the colony, is revealed by a letter written by him at this period to Charles Lowndes, secretary to the Treasury Board, in reply to circular instructions which that board had sent to the colonial governors in September, and which had to do with the enforcement of the Stamp Act: "In answer I must request you to acquaint their Lordships that at present there is no one

exercising that office within the colony. The Person who was appointed to that office and gave security for it hath publicly declared his Resignation of his office and that he will not officiate therein. . . . If the Distributor had Received and Undertaken to Distribute the Stamps and had accordingly executed that office, I should have carefully attended to the Practice under the Act and in Every Particular endeavored to Discharge the Duty which appertains to me agreeable to the Intentions of the Act of Parliament, and this I shall endeavor whenever there shall be opportunity and occasion for it."¹

How far from unanimous was the dislike and suspicion manifested against Ingersoll, during this period, is evidenced by a letter which he wrote to Thomas Whately. He was not only able to declare that "the governor is my fast Friend, as I am his, and can only wish he had that countenance and Approbation which his Conduct and Behaviour upon all occasions well deserves," but could assert that his friends in Connecticut were those that Whately could consider "the better people of the colony."² His philosophical attitude of mind is better brought out in a letter to Richard Jackson, the Connecti-

cut agent in London, to whom he wrote from a lofty view: "I hope you will be the Colony's friend whatever some people may think of me. . . . Whatever errors I have committed in public life, I have always loved my country. . . . Whatever usage, I have received from my country, it shall never make me break with her. . . . I have received much undeserved favor and good at the hands of my country and shall I not bear with a little abuse, especially, upon so irritating an occasion as the Stamp Act."¹

The Connecticut general assembly, as has been stated, voted, at its October session, that no business requiring the use of stamps should be transacted in the colony during the following winter. This was a legitimate and constitutional method of protest against the actions of the home government. The Sons of Liberty of eastern Connecticut, however, had gone so far that they were disposed to ignore not only the laws of parliament but also the measures of their own colonial assembly.

At "a large Assembly of the respectable Populace" at New London, December 10, 1765, resolutions were passed to the following effect:

"That every officer in the Colony duly execute the Trust reposed in him, agreeable to the true Spirit of the English Constitution, and the Laws of this Colony.

"That every Officer neglecting the Exercise of his Office may justly expect the Resentment of the People, and those who proceed may depend on their Protection.

"It is presumed that no Person will publicly, in the Pulpit, or otherwise, inculcate the Doctrine of passive Obedience, or any other Doctrine tending to quiet the

Minds of the People, in a tame Submission to any unjust Propositions."¹

This program comprehended, of course, not only the repudiation of the authoritative action of the general assembly, but the open violation of the Stamp Act as well, since the colony was still provided with a stamp distributor and could readily obtain a supply of stamps. The people of Connecticut, as a whole, were not as yet prepared for any such advanced step as this.

The next important gathering of the Sons of Liberty occurred at Pomfret, on Christmas Day. The resolutions which were there adopted were even more extraordinary than those of the New London meeting. After affirming their loyalty to the king and stating that they would "bear the highest Indignation to any that shall take Advantage of our present situation to oppose the lawful Authority of this colony, to obstruct . . . justice, or to injure any man in Person or Property," they went on to proclaim "that God and Nature brought us into the World Freemen, and by solemn Charter Compact and Agreement we came into the English Constitutions." They then asserted "that we have ever unmolestedly enjoyed (except some grievous Acts of Trade, etc.) our just Rights and Privileges, as the true born Sons of Liberty, until the oppressive and detestable Stamp Act was deeply formed and fatally levelled at the very Root and Foundation of our dearest Rights and enjoyments in Life, that's worth living for," and that "all those who were accessory in framing said Act are unfriendly to the Constitution." Then they began formal indictment of Jared Ingersoll.

"That, whereas, our stamp master was appointed Agent for this Colony . . . nevertheless he returned the executioner of those Evils he was sent to defend us from, And, notwithstanding his solemn Resignation . . . still

obstinately Persists to plot the ruin and total overthrow of his native Country by all the ways and means his Malice and Craft suggests or his unbridled Audacity can attempt. And thereby has . . . forfeited all privileges in and protection from the same; is no longer to be believed, his Friendship no more to be trusted, nor his malignant Designs any longer to be endured; and that assuredly, unless he instantly desist plotting our ruin, writing anything prejudicial to the Government, or even relative to the same, he shall forthwith feel the weight of his Injured Country's righteous indignation and know by sad Experience all the Horrors of falling a defenceless Prey into the Hands of a free and enraged Populace. As to the matters of charge . . . we challenge him to deny and vindicate himself against them in any of our public meetings."

Moreover, they resolved: "That Mr. Ingersoll's Letters be read publicly in Every County in the Colony in their public Meetings, if they see fit; That copies of Mr. Ingersoll's Letters be given out to some one Person in each County to be by him kept for the benefit and use of the People in the same."

Then after announcing "That we will most critically inspect every avenue by which the Stamp Papers may be introduced into the Colony," they recommended that the colony "proceed in business as usual as our cessation of Business will be construed an implicit acknowledgment of the validity of the Stamp Act," and to that purpose they gave their endorsement of an article advocating such a step, written by a "Friend of Liberty" in Pennsylvania, which had been published in the last number of the *New London Gazette*.¹

Dr. Benjamin Gale wrote to Ingersoll soon afterward regarding this meeting, which he called the "Babel Convention." He assured Ingersoll that he had done what he could, by sending "Messengers" to it, "to Mitigate their Rage and Folly. . . . A more wicked sceem, I think, never was on foot in this Colony to destroy us."¹ Even such a sturdy opponent of the Stamp Act as Roger Sherman became alarmed at the ominous character of the political activities in eastern Connecticut. His apprehensions were expressed in a very cautiously framed letter which he addressed to Matthew Griswold early in January. Sherman said that there were taking place "some things which appear to me a little Extraordinary and which I fear (if persisted in) may be prejudicial to the interests of the Colony—more especially the late practice of great numbers of people Assembling and assuming a Kind of legislative authority, passing and publishing resolves, etc." Then with manifest deep anxiety, he asked, "Will not the frequent Assembling such large bodies of people without any laws to regulate or govern their proceedings tend to weaken the authority of the government and . . . tend to such disorders and confusions as will not be easily suppressed or reformed?"

In spite of the undoubted sympathy that many in the colony had for Ingersoll, it is not surprising that at last the strain of bearing so great a weight of odium and positive hatred became too great for even so determined a

man. Early in January he received two letters, both anonymous, but supposed to have been sent from "A Considerable Number of People in the Colony," which "threatened very high" in case he would not take an oath to give up the empty office.¹ No longer willing to risk his property, not to speak of his life and the safety of his family, and convinced that it was folly for one man, as it were, to attempt to stand out against so decided a public sentiment, he took an oath before a local justice of the peace never to exercise his stamp office, forwarded his resignation to the stamp commissioners in London,² and made public these facts in the columns of the *Gazette*.³ In this manner, there was terminated a truly memorable struggle between Ingersoll and the Connecticut Sons of Liberty, which Alexander Johnston likened to the striking of flint against steel.⁴

At a meeting of the "respectable Populace," held at

Lyme, in New London County, on the second Tuesday of January, the reconciliation of the radicals with Ingersoll was confirmed by a resolution to the effect that "tho' we had reason heretofore to distrust his veracity yet we do rely on his said oath."¹ It was then voted that the papers and letters which Ingersoll had been compelled to deliver over should be returned after copies were made of the same. That the resignation of the Connecticut distributor, however, had not quieted the fears of the Sons of Liberty lest some attempt should be made to enforce the Stamp Act, is shown by a further resolve passed at this time.

"Whereas, it is believed that the Stamp Papers for this Colony are hovering about on our coast on board the *Cygnat* man-of-war stationed at this colony, it is resolved that the Sons of Liberty keep a vigilant watch and in any attempt to land the same, we engage our united assistance to take and secure them for his Majesty's use."² Nevertheless, it is clear that the Sons of Liberty, after Ingersoll's oath of resignation, became slightly more temperate in their position. This is indicated by the following final resolution adopted at Lyme, which, while similar to the Pomfret resolution, shows a disposition to get results by petitioning, rather than through the defiance or coercion of the authorities within the colony. "Whereas, the adjacent colonies proceed in business without regard to the Stamp Act, 'tis earnestly desired that the civil authority in this colony do follow their laudable example, as the delay of business will be construed an implicit acknowledgement of the validity of the Stamp Act and a

practical contradiction of the principal arguments urged in our petitions at home for the repeal of the same, and for that purpose the eyes of all are on the Superior Court of this colony, to give the example to the Subordinate Authority.'"¹

By January, western Connecticut, through persistent propaganda from the east, was also becoming "organized" in the popular cause. At Wallingford, in a meeting of the "inhabitants," on January 13, 1766, at which Elihu Hall, king's attorney for the county, acted as moderator, resolutions of a most unusual character were passed; in these the authority of the town meeting was actually made to transcend the authority of parliament; they read as follows:

"Whereas, it appears from antient Records and other Memorials of Incontestible Validity, that our Ancestors with a great Sum Purchased said Township, at their only Expence Planted, with great Peril possessed, and Defended the same, we are Born free (having never been in bondage to any) an Inheritance of Inestimable Value. Voted and Agreed that if any of the said Inhabitants, shall Introduce Use or Improve any Stamp Vellum Parchment or paper, for which tax or Tribute is or may be Demandable, such Person or Persons shall Incurr the Penaltie of 20s. to be recovered by the Select men of said Town for the Time being for the Use of the Poor of the said Town. This order to continue in force until the next meeting of said Inhabitants in Town Meeting.'"²

There was also, during the evening of the thirteenth, a meeting at Wallingford "of a number of the true Sons of

Liberty." They were clearly ready for a rebellion, according to their recorded attitude. The resolutions which they passed rivaled anything that emanated from the eastern communities, and are as illuminating as those of the town meeting. These resolutions propounded:

"1. That the late Act of Parliament called the Stamp Act, is unconstitutional and intended to enslave the true subjects of America.

"2. That we will oppose the same to the last extremity, even to take the field.

"3. That we will meet at the Court House in New Haven on the third Tuesday of February next; And we desire all the Sons of Liberty in the County would meet then by themselves or representatives. There to consult what is best to be done in order to defend our liberties and properties and break up the stop to Public Affairs."

There is something significant in the fact that the general meeting for New Haven County was announced so far in advance. For it would argue that certain communities in the county had not, as yet, absorbed the ideas laid down in the Windham program of November 11, and, therefore, needed to be put through a preliminary course of instruction. What is still more significant is that the Wallingford resolves apparently were so coldly received in other portions of the county that no general meeting was ever held.² John Hubbard, who for years had been

chosen a deputy for New Haven to the general assembly, wrote to Ezra Stiles in no uncertain manner regarding his attitude toward this outburst of radicalism. "The Stamp Act," he said, "has drawn a gloom over every Face, and sowered the Temper of not a few, and all that don't run the extravagant Length of a giddy and distracted Mob are looked upon as Enemies to their Country and Betrayers of its Liberties. Among other fine Devices to set People together by the ears a Man's religious Principles are made the Test, or shall I rather say the badge of his political Creed. An Arminian, and a Favourer of the Stamp Act signify the same Man; think then in what a Situation some of your friends are."¹ Indeed, there were to be found in New Haven County, at this time, even those who openly supported the Stamp Act.² Deacon Jonathan Mansfield had the courage to

tween the conservatives and the radicals over the following resolutions submitted for approval or rejection:

“Taking into Consideration . . . that for several Months past there has been a total Suspension of the Execution of the Laws in Civil and Probate Matters in this Colony, the Courts, Magistrates, justices of the peace and other Officers in their respective Departments having (for some reason) wholly declined proceeding therein which Obstruction of Business has been attended with Considerable Inconveniences and if much longer continued ('tis apprehended) will involve the people in great difficulties prejudicial to their interest and be attended with very bad and dangerous Consequences.

“Therefore, voted, that the said respective Courts, Magistrates and Justices (particularly the Hon^{ble} Superior Court by Way of Example to the others) be desired and they are thereby humbly requested to proceed in and transact the usual Business. . . . Agreeable to the Laws of this Colony.”¹

The opponents of the resolution attacked it from four angles. First, “they apprehended that the courts proceeding to do Business, at present, in opposition to the Stamp Act, was not consistent with the humble Petition of the Colonies to King and Parliament, for Relief under their present Grievances”; second, “that a Cessation of Law-Suits, for a while, would greatly conduce to People’s working themselves out of Debt, and so be a public Benefit”; third, “that, lands will be greatly undersold, for want of a certain and indisputable title, by legal Convey-

The *Gazette* of January 31 printed an extensive address to the inferior court of common pleas of Providence, Rhode Island, by an attorney of that court in which the latter urged the legality of resuming the civil business of the court without the use of stamps.

ance on Stamp Paper"; fourth, "that when Persons come to feel themselves crowded and pinched by Executions, they will be exacting, apt to *squirm* in every possible Method, to be likely to object against the Legality of the Process, that 'tis not on Stamp Paper, and so, in Hopes of a temporary Relief will become Friends of the Stamp Act which may tend to introduce the use of the Paper."¹ These arguments, however, could not prevent the passage of the resolutions; but out of the two hundred and seventy-four "voters" present, forty-eight arrayed themselves against the same.

In spite of this declaration of New Haven, coupled with similar requests from other towns, the superior court could not be brought to endorse a position having so many elements of danger, especially for a colony which so often had been threatened with the loss of its charter.² After holding a three days' session at New Haven "for the trial of criminal causes only," the court adjourned on February 27, until the last Tuesday in August.³ Yet a correspondent to the *Connecticut Gazette*,

writing as early as December 30, declared "that the Custom House in New London was opened last week, and that vessels are cleared out there as usual without *Stamps*—and that the Justices and Lawyers in the County go on with Business in the old way."¹ While the New Haven custom house began granting clearances to vessels as early as the beginning of January,² the officials of the town and the county scrupulously refrained from carrying on any business that required the use of stamps.³

At a meeting of the county court, the second Tuesday of November, 1765, with Roger Newton as judge and John Hubbard, Thomas Darling, and Roger Sherman, justices of the quorum, it was voted that the court, without transacting any business, should adjourn to the third Tuesday of March, 1766.⁴ At this adjourned meeting the court readjourned "without day,"⁵ but reassembled the first Tuesday of April, when, after inflicting punishment

upon nine people convicted of immorality,¹ again adjourned to the third Tuesday of June; and then by a series of adjournments held off the transaction of business, for reasons that are not clear, until the first Tuesday in July. The first civil action in the court came in its July session.² The court of probate for the district of New Haven met on the third Monday of November, 1765;³ at this session Joshua Munson of Wallingford, executor of the estate of the late Caleb Munson, was allowed to add certain items to the inventory of the estate of the deceased and Ezra Ives of New Haven also was permitted to appear in order to petition that he be relieved of the guardianship of Samuel Hitchcock.⁴ The next meeting of the court was the third Monday of February, when matters relating to the division of four different estates came before the court.⁵ Nevertheless, it was apparent that there was little desire on the part of the people of this section to make efforts to proceed with probate matters; but one case for settlement came before the court at its session held the first Monday of April and this case also was the sole subject for consideration at the session of April 9,⁶ while on April 14 there was but one application for the settlement of an estate. There was no meeting of the court then, until the third Monday

of May. In the court records between these two latter dates the following comment was inserted:

“N. B. No Business having been done at this Court or any other Court, since the last day of October last that required Stamp'd Paper and having now the news that the Stamp Act was repealed by Parliament on the 18 day of March last—Business goes on again as formerly.”¹

An examination of the New Haven land records, which were kept by the town clerk, who also attested all deeds, shows that the last deed recorded in 1765 was on October 31, and that it was not until July 23, 1766, that the next transfer of real estate was recorded, involving the exchange by Joshua Chandler, of five and three-fourths acres for £80 lawful money, paid by Hezekiah Sabin.²

✓ This repudiation of the demands of the Sons of Liberty represents a substantial victory of the conservative forces within the colony and especially within New Haven County. Of course this did not necessarily mean an endorsement of the policies of the British ministry, but rather a manifest determination on the part of those in control of affairs to protect themselves, as well as others, by confining their opposition to the Stamp Act to methods not inconsistent with the policy formulated by the general assembly the preceding November. For on March 25, a “General meeting of the Delegates of the Sons of Liberty, from a great majority of the Towns,” was held at Hartford. Their proceedings have an extraordinary interest for the student of American

political institutions. In accordance with the desire of the New York Sons of Liberty, expressed through the agitator, Lamb, they adopted a declaration in favor of keeping up a friendly correspondence with the Sons of Liberty in the neighboring colonies "for the purpose of perpetuating Union and Harmony so happily established and maintaining common Liberty."¹ A committee of correspondence was thereupon established, consisting of Colonel Israel Putnam, Major John Durkee, Captain Hugh Ledlie, Thaddeus Burr, John Sturgis, Samuel Bradley, Jr., John Brooks, and LeGrand Cannon.² Yet, what is most noteworthy in connection with the proceedings is the fact that soon after the meeting was called to order and business of a general nature had been transacted, the delegates went into secret session, the spectators having been requested to withdraw. Upon a motion inquiring the purpose of this, the reply was made that "as there was a Dissatisfaction in the Colony, it was proposed whether a Change in the 'Ministry,' as it was termed, might not be necessary among us." Those in charge then explained that they "ment to collect the Minds of the People, for Unity, and by that Means be able to give the Freemen a Lead in the ensuing election, since, should they run upon different Men, the Persons desired might not be elected, by the Freemen."³

The idea of turning this meeting of delegates of the Sons of Liberty into a nominating convention was received with amazement by some, who were completely taken off their feet. A lively debate ensued. The opponents of this scheme urged that no such plan was comprehended in the public warning of the meeting, that, as delegates, they were not properly instructed to proceed in this matter, and that such a procedure would be highly unconstitutional, since it would in an undue manner influence the minds of the freemen and be "fraught with the worst of Mischiefs, as it would tend to produce infinite Disquietude among the People, and lay a Foundation for perpetual Feuds and Animosities in every future Election; especially as a Step of this Kind would . . . be establishing a pernicious precedent, unknown to and unpracticed by the virtuous Founders and supporters of the Colony"; finally, it was represented that the meeting was "but a partial, or rather, no just Representation of the Freemen."

The promoters of the nominating convention plan, according to the *Connecticut Courant*, made no solid answer to these arguments. The meeting was adjourned until the next day. It was soon apparent that those in favor of the innovation were in control of the situation. Without renewing the discussion the delegates divided into groups according to counties, and went into deliberation. The contemporary account of the meeting says that as a result it was "agreed that most of the Freemen would—vote for — to be Governor, and for — to be Deputy Governor." The county of Litchfield dissented from this procedure by a vote of nine against four; the Hartford County delegation was also divided. After the question had been settled regarding the two leading offices within the gift of the people, the filling of the governor's council was then taken up for consideration. But the propo-

sal to nominate men for the council met with such opposition that it was finally deemed imprudent "to make too great an Alteration in the Body Politick at once." From beginning to end the gathering was apparently controlled by the men from the eastern section, for the "two Eastern Counties were much more generally attended than any other part of the government."¹

The results of this nominating convention—doubtless the first political party nominating convention held in Connecticut—were all that the heartiest Son of Liberty could desire. When the general assembly met at Hartford the second Thursday in May, and the votes of the freemen were counted, it was found that William Pitkin was chosen governor and Jonathan Trumbull, deputy governor.²

Fortunately for the colonies, during the period of the Stamp Act crisis the Rockingham ministry was weak and half-hearted in all its efforts, for it had come into power upon a program of opposition to the work of the previous ministry.³ The news of the tumultuous condition of affairs in America served only to widen the breach between the different parliamentary factions. The Grenville group favored a strong policy in dealing with the lawless manifestations in the colonies, and secured one hundred and thirty-four votes as against two hundred and seventy-four,⁴ on Grenville's motion made December 17, "to express our just Resentment and Indignation at the outrageous Tumults and Insurrections which have been excited and carried on in North America, and at the Resistance given, by open and rebellious Force, to the

Execution of the Laws in that Part of His Majesty's Dominions," and "to assure His Majesty that His faithful Commons . . . will firmly and effectually support His Majesty in all such Measures as shall be necessary for preserving and securing the legal Dependence of the colonies upon this their Mother Country; for enforcing their due Obedience to the Laws, for maintaining the Dignity of the Crown, and asserting the indubitable and fundamental Rights of the Legislature of Great Britain."¹

Persistent rumors spread through London of the fitting out of ships of war and the gathering of soldiers for the purpose of upholding the authority of the government.² On March 3 Charles Antrobus, who was in charge of his majesty's sea forces stationed upon the coast of New England, wrote to Governor Fitch, from on board the *Maidstone*, in Rhode Island waters, that, according to the king's command, "in case the exigency of affairs should make it necessary for His Excellency to procure the aid of the military in support of the Civil," he should apply to the commanders of the British land and sea forces respectively, as the occasion might require. Antrobus then went on to say: "I am to acquaint you that His Majesty's Sea Forces stationed upon the Coasts of New England under my Command will at all times concur and assist you to the utmost of their power for the Support, Honor & Safety of Government and for the Preservation of Peace and good Order in His Majesty's Colony under your command, for which purpose I have dispatched an Order to Captain Durell, Commander of H. M. Frigate, the *Sygnel*, stationed at New London, but

should the exigency of affairs make a further aid necessary on Application to me at Rhode Island, I shall dispatch such additional Assistance as the nature of the Affair may require and His Majesty's other services shall admit."¹

The ministry, however, was in a state of hopeless indecision. Much as it asserted its dislike of the Grenville policies, it did not want to be convicted by the country of timidity and weakness. Friends of the colonies emphasized the fact that, under the most favorable conditions, the duties provided for in the Stamp Act could not be collected without the greatest hardship. "So great is the scarcity of cash in the colonies," they declared, "that we are assured taking all the Plantations together, they could not raise three hundred thousand Pounds."² A proposal, it was reported, was made that the sums provided for in the act should be paid in produce.³ On January 11 Richard Jackson, the London agent of Connecticut, wrote to Governor Fitch, telling of his efforts to get a repeal of the measure. "I am informed," he said, "by the best Intelligence I can procure that the Stamp Act will not be repealed; every other Relief may be, I think, expected & even this Law will probably be reduced to nothing more than a Proof of the Power of Parliament to impose Taxes as well as make other Laws for America. Something to assert this Power is judged necessary by leading men in both Houses."⁴ On January 17 the London merchants trading in America presented their famous petition asking for a repeal of the troublesome law;

their efforts were seconded by the English mechanics and resident Americans.¹ In March came the repeal and the Declaratory Act.² On the thirty-first Secretary Conway, in a circular letter sent from St. James to the colonial governors, recommended that they should exert themselves to make full and ample compensation to those who "from the Madness of the People have suffered for their Deference to Acts of the British Legislature." At the same time, he transmitted copies of the two acts.³

20th - Early on the morning of the nineteenth of May an express arrived at New Haven "with the charming news that the obnoxious Stamp Act had been repealed by Parliament." The inhabitants were soon awakened with the banging of flintlocks throughout the town, bells rang madly, cannon volleyed; in the afternoon the people gathered in their churches where the clergy returned thanks for the blessing, after which the militia, under the command of Colonel Wooster, appeared on dress parade; in the evening the rejoicing was concluded with illumina-

tions, bonfires, and dances—all, as the chronicler carefully recorded, “without any remarkable indecency or disorder.”¹ The celebration at Hartford, on the twenty-third, if more dramatic, was less happy in its termination. According to the account left by Ezra Stiles, “the large Brick School house was blown up with twenty-four white persons, two molattos, & two negro Boys. There were 22 of the Persons aforesaid in the Chamber, two of which were blown out of the window.”²

While these events, during the fall and winter of 1765 and the spring of 1766, were transpiring in Connecticut, one may ask what was happening to the parchments which the American Stamp Office had forwarded for the use of the people of that colony.

There were five separate consignments of stamps to Ingersoll. The first was sent the twenty-ninth of July, in care of Captain William Davis, commander of the *Edward*;³ on August 5 Captain Joseph Haveland sailed in the *Polly*, with the second allotment; the third left England August 15, on the *Minerva*, Captain Thomas Tillet; the fourth, instead of being sent by way of New York, as was the case with the three preceding consignments, was placed on board the *John and Sukey*, Captain James Bruce, on September 18, and was carried to Boston; the fifth was entrusted to the care of Captain James Chambers, in charge of the *Waddel*, which cleared for New York October 22.⁴ The reason why no further shipment

of stamps was made to Connecticut probably lies in the fact that on October 22 the news reached London of the resignation of Ingersoll.¹

On October 22 the *Edward* reached New York with ten packages of stamps, a part of which were intended for the province of New York. Previous to the arrival of the *Edward*, Ingersoll had written to Lieutenant Governor Colden not to forward any of the Connecticut stamps until conditions were more settled. Although Colden thought that it was best to have the consignment for that colony on board a man-of-war ready to proceed to New Haven, on receiving Ingersoll's request he lodged them in the fort,² together with the New York stamps. The Sons of Liberty at that port took such violent measures as not only to intimidate Colden but also to alarm the conservative elements.³ The result was that the lieutenant governor, with the advice of General Gage, turned over the New York stamps to the city council, by whom they were lodged in the city hall. Whether the Connecticut stamps also were transferred to that place, left in the fort, or returned to the *Edward* is not clear.⁴ Governor Moore arrived in New York in November,

superseding Colden. He at once proceeded to write to Governor Fitch requesting him to take charge of the Connecticut stamps. Fitch replied late in December: "I need not, I suppose, acquaint you that the gentleman appointed Distributor of Stamps for this Colony hath been, as well as those in the other governments, compelled to Resign and that he was the proper and only Person to Receive those papers."¹

When the *Polly*, under Captain Haveland, put in her appearance at New York, it was decided to leave the stamps on board. However, early in January, at midnight, a number of armed men boarded her and, having overawed the crew, secured the keys to the lockers, searched the vessel, and carried away to the shipyards ten bales of parchment designed for New York and Connecticut, and then made a patriotic bonfire of them.² Also, on the night of the eleventh, armed men boarded Captain Tillet's vessel, the *Minerva*, lying off Rotten Row, in the same harbor, and demanded the stamps which Tillet had brought for Connecticut. But this time they were disappointed; they were assured by those on the vessel that the stamps that same day had been deposited in Fort George.³

The Connecticut stamps, sent by way of New York, had been consigned to Theophylact Bache, a leading New

York merchant, to be sent on by him to Connecticut. After these episodes, Bache wrote to Ingersoll requesting that no more stamps be entrusted to him.¹ When Captain Chambers of the *Waddel* arrived in New York, late in the winter, the Connecticut parchments which he carried were taken without delay to the fort;² there they reposed until the summer of 1766, when Governor Moore, at the request of Ingersoll, placed on a ship of war all of the stamped paper designed for Connecticut that had been deposited in this stronghold, and sent it back to England.³

CHAPTER VIII

A NEW HAVEN COUNTY JUSTICE OF THE PEACE. THE PASSING OF THE TOWNSHEND ACT

At its May session in 1765 the general assembly appointed Jared Ingersoll, together with thirty-three others, a justice of the peace in and for the county of New Haven, for the year ensuing.¹ This was done before the receipt of the news of his acceptance of the post of Connecticut stamp distributor. During the month of August he does not appear to have attended to this office. However, on September 16, just two days previous to starting on his memorable journey to Hartford, he issued a summons requiring the sheriff of New Haven County to bring one John Smith, who "had made an assault upon the body of Edward Allen, June 20, 1764," before the general assembly to show reason why the judgment of the superior court should not be set aside and a new trial awarded.²

The chief business of a Connecticut justice of the peace was to give judgment in civil cases involving such matters as debts of small amounts, etc., and to take cognizance of breaches of private conduct, in the interests of public morals and public order generally. He might do this upon his own initiative or upon information that was furnished to him, either by the grand jury of the county or by a constable. The less serious misdemeanors he

was competent to determine definitively; in the case of grave offenses the parties were bound over on a recognizance to appear before the judge and justices of the quorum in the county court. An examination of the record book kept by Ingersoll while justice of the peace shows that when acting in this capacity he was chiefly occupied in drawing up acknowledgments of judgments for debt and with cases involving violations of the ancient ecclesiastical code of the colony.¹ The most common of these violations was neglect of public worship; fines of three shillings—which went to the town—and costs, amounting to six shillings, were levied against those with godless tendencies. The “profane swearer” was also constantly falling under Justice Ingersoll’s censure; as may be suspected, the profane swearer was apt to be the chronic Sabbath breaker. The following entry in Ingersoll’s record book shows the patriarchal character of his office:

“Joe Potter, fined March 21, for profane swearing, on March 24 was brought before Jared Ingersoll on charge of neglecting to attend public worship. Pleaded not guilty, urging for reasons of neglect a wound and lameness in one of his legs, which is judged sufficient reason by the Court.”²

It often happened, of course, that these petty offenders were without means. When, therefore, the fines could not be collected, other penalties were applied. On one occasion, for example, Curtiss Clemens, “a transient person,” was unable to pay the six shillings levied against him for profane swearing, and the eight shillings for drunkenness, plus the eleven shillings, the cost of prosecution; as a result, he was sentenced to sit in the public stocks “by the space of one hour for each of said

crimes."¹ However, offenders were not always given the option of paying a fine. Where questions of private morality were involved, the suspect was bound over to appear before the county court, as was shown in a previous chapter;² in cases of petty larceny, the guilty party was sent to the whipping post. Isaac Tomlinson, a free negro, charged before Ingersoll with stealing a pair of silver shoe buckles, even after making restoration, was mulcted £1 19s. 2d. for damages, 6s. 2d. for costs and 5s. for a fine, and was in addition given ten stripes on the naked body at the whipping post. Failing to pay these fines, he was then given four months' imprisonment.³

It must not be supposed that Ingersoll, during the years that he acted as a justice of the peace, gave his entire time to that work. As will be noticed in the progress of this chapter and the following, he was engaged in a variety of activities and especially was occupied in taking care of the interests of numerous clients.¹ For

little as most Connecticut people appreciated Ingersoll in his attempted rôle as stamp master, they nevertheless still eagerly sought him whenever they felt in need of legal assistance of a high order—and could pay for it. So early as February, 1766, while still under the fire of the agitators, he became identified with a case which clearly shows some of the direct results flowing from the attempt on the part of the Sons of Liberty to override their legally constituted authority. This was the notorious Peter Boles incident.

Benedict Arnold, during this period, was not only the proprietor of an apothecary shop in New Haven but also had gone rather extensively into the business of trading with the West Indies as well as with Newfoundland. He exported a good many "large, genteel, fat horses," also pork, oats, and hay. Besides the products of the West Indies, he imported salt and cotton.¹ It seems apparent that he was accustomed to smuggle. For some unknown reason, Boles, who had been one of his sailors, determined to lodge information against him with the local customs official and in fact went to the customs house but did not find the collector in.² Arnold was apprised of his intention, chastised the man, and threatened him with

dire calamity should he persist in his design. Boles, according to the testimony, then left town as ordered, but, it would seem, thirsting to get even with his master, returned; whereupon he was immediately seized at one of the taverns and compelled to sign an oath to the effect that "being instigated by the Devil" he attempted to give information against Arnold for importing contraband goods, and he even acknowledged that he "Justly deserved a halter."¹ Again, he was ordered to leave town; he failed, however, to do so and remained such a source of uneasiness to Arnold and his friends that, on January 29, they broke into a dwelling house where the hapless Boles was stopping, fell upon the man, stripped him of his clothing, dragged him to the whipping post on the green, and, having bound him to the same, in the presence of the spectators gave him forty lashes, "in a shocking, cruel and dangerous manner." He was then chased out of town.²

The conservative element in New Haven, which had been pretty thoroughly cowed for some time by the prevailing mob rule in the colony, now took alarm at the growing contempt of law and order. At a town meeting, held February 3, this element took control and passed the following resolution:

"Whereas, the growing disorder and violence and breaches of law in this town are become very threatening to the public peace and even dangerous to civil society and at which we are justly alarmed,

"Therefore, voted, that the informing officers and Civil Authority in this town be desired . . . to be espe-

cially watchful and painful in bringing to proper punishment all such disorders, and we do hereby declare as we think it our duty so we will mutually assist one another and particularly the Civil Authority in the due execution of their office."¹

But the aroused conservatives did not stop with words. The grand jurors made an investigation, filed a complaint with Roger Sherman, who, like Ingersoll, was a justice of the peace. Sherman issued a warrant for the arrest of the offenders, who were brought before him and bound over for trial.² As was stated, Ingersoll took an active part in the judicial proceeding, apparently in Arnold's behalf.³ The unsettled condition of the community is shown by the fact that a mob, on the thirtieth of January, made "two certain Images or Figures habited with Cloathes" representing the two most aggressive of the grand jurymen, Tilley Blakeslee and John Wise, which "said Images or Figures did hang upon a gallows with a Rope by the Neck and the mob then burnt the same, and all in open view of the People thereby openly casting contempt upon . . . the good and wholesome Laws of the Colony."⁴

As for Benedict Arnold, this adventurous gentleman took the position publicly that he was being persecuted by his misguided neighbors for performing a patriotic act. In a protest published in the local paper he spoke

rather scornfully of the law-abiding tendencies of New Haven. "Is it good policy," he asked, "or would so great a number of People in any trading Town on the Continent (New Haven excepted) vindicate, protect and caress an informer—a character, particularly at this alarming time, so justly odious to the Public?"

Such an open statement placed the local customs house in a very bad light and its officials felt called upon to make a reply to Arnold. "It might have been imagined," they declared, "that private resentment had urged the man on to seek revenge by informing of trifling things had not Mr. Arnold's publication given reason to think differently. As he suggests, there is a beneficial illicit trade carried on, contrary to what we really imagined to be done, in any considerable degree. . . . We think ourselves in honor bound to acquaint the publick, that we require an oath of every master or other person having charge of a vessel, to the truth of his manifest at entry. . . . When any vessel enters from a foreign port with goods subject to duties, a waiter is sent on board to see that the cargo agrees with the manifest, to attend the unloading and see the weight and gauge of sugar and molasses.'"

How near to anarchy the radicals had plunged the colony in working up a spirit of resistance to the Stamp Act, is evident from an attempt made, on June 14, 1766, to terrify the judges of the county court, by Wallingford men, "who having not the fear of God before their eyes and with intent to disturb the Peace and prevent the execution of the good and wholesome Laws of the Colony . . . made and subscribed a Certain Scandalous and menacing writing, and on the 17th day of June did

cause the same to be forwarded and published in the County Court then setting."¹

In fact, it was not until November of 1766 that the reaction was strong enough to give the conservative group the courage to take things in hand. Early in that month, James A. Hillhouse, who had succeeded Major Elihu Hall as king's attorney of the county,² arraigned eleven of these Wallingford men before the county court. The defendants pleaded not guilty; the case was then submitted to a jury, which also returned a verdict of not guilty; the court, not to be defeated, penalized them to the extent of £58 19s. 3d. as "cost of prosecution."³ For some reason, upon this action, Hillhouse saw fit to withdraw from the not too comfortable responsibility of acting as county prosecutor. At the next meeting of the county court, held the second Tuesday of November, Jared Ingersoll was again back at his old post of king's attorney,⁴ and his first act was to arraign the leading New Haven rioters who the preceding January had burned in effigy the grand jury men. One may imagine, by reason of his own late experiences, that he took a certain grim satisfaction in doing so. The case appears on

the records as "Our Sovereign Lord the King by Jared Ingersoll, Esq. his Attorney vs. Lyman Hitchcock, Robert Townsend, Samuel Center, Thomas Levoke, Stephen Bradly, Stephen Gorham and Caleb Ford." The defendants pleaded not guilty; the jury returned an equivocal verdict to the effect that Levoke and Ford were not guilty. The two were dismissed upon paying the cost of prosecution. At the January, 1767, session of the court, the five others pleaded guilty, and for some reason the court let them off with fines of but five shillings apiece and costs.¹

This effort to restore to the county an orderly and legal procedure in the conduct of affairs is also illustrated by the case of Thomas Strong of Durham. On February 3, 1767, the grand jurors of the county made a presentment against him "for putting in more than one vote at a time for choosing Town officers, etc." Strong was bound over with a surety of £30 to appear before the county court. When the case came up for trial, Ingersoll prosecuted him and he was found guilty and was fined £30 plus £2 6s. 10d. as costs.² In 1768 the case was taken on appeal to the superior court under title of "John Whiting, Esq. vs. Thomas Strong, et al," with Ingersoll and Hillhouse representing the county.⁴ Failing to secure proper settlement there, Whiting, who, as county treasurer, appeared in behalf of the county as plaintiff, petitioned the general assembly.⁵

While things were thus moving along smoothly enough for Jared Ingersoll,⁶ the same could not be said for his

friend, Augustus Johnston of Newport, who, unfortunately, had accepted the appointment of stamp distributor for Rhode Island. During the summer of 1767, this gentleman wrote a letter to Ingersoll which was full of discouragement. He complained that the rage of the people of Rhode Island against him on account of this acceptance still continued and he had become convinced that it would never end. He therefore declared his intention of moving to England at the earliest possible moment.¹

In Connecticut, as has been noticed, the repeal of the Stamp Act brought about a sharp reaction against the anarchic tendencies of the Sons of Liberty.² There appeared to be a disposition, especially on the part of those in authority, to show to the British ministry, under the nominal leadership of the invalid Earl of Chatham, that Connecticut had not been surrendered to the rule of the mob but was loyal to the empire. For example, early in January, 1767, General Gage, in charge of his majesty's

forces in America, wrote to Governor Pitkin requesting him to make provision, under the terms of the quartering act, passed by parliament in April, 1765,¹ for two officers and one hundred and thirty-four German recruits who were unable, on account of the winter weather, to reach the battalions to which they had been assigned and which were located, one at Quebec and the other in the Great Lakes country. Pitkin proceeded to call, first, a meeting of the council for January 20, and then a special session of the general assembly, which convened January 29, and passed, apparently without much opposition, the legislation necessary for making suitable provision for the soldiers.² However, instead of quartering the troops at Stamford, Norwalk, and Fairfield, as Gage had desired, it was decided since these towns had been "heretofore burthened with a great number of his Majesty's forces quartered and billeted on them during two winter

seasons," that they should be provided for with quarters at New Haven, Wallingford, and Branford.¹ At the same time, while complying with this request, the assembly called upon the governor to ask General Gage to issue orders to the soldiers against carrying their arms at any time except on duty, since it had been found by experience that this "hath been the occasion of notorious breaches of the peace, to the terror and disquiet of his Majesty's good subjects."²

There were, however, those who felt that this billeting of soldiers in time of peace was an ill omen. "Our Assembly have agreed to billet 136 of the Troops," wrote John Devotion of Saybrook. "The Wedge has entered, and I expect Glut upon Glut."³ Yet, to most men in Connecticut, there had come a feeling of confidence, it seems, that the period of strained relations with the mother country was becoming a thing of the past. But Connecticut's neighbors—Massachusetts and New York—failed at this period to show the tactful spirit of compliance which she herself displayed. In the former colony the struggle went on between the governor and the house of representatives and, what is more, an act of general pardon and indemnity was passed in connection with the measure, to grant compensation to the sufferers in the late Stamp Act riots.⁴ The New York assembly, when re-

quested in June, 1766, to make provision for troops, adopted, instead, a set of resolutions declaring that the character of the request was "unprecedented"; and though it later was brought to approve a plan which would at least partially meet the requirements of the Quartering Act, there was a feeling in the province that the people had already been to greater expense, in supporting regular troops, than any other colony, and that the charges were bound to become "ruinous and unsupportable."¹

The news of this recalcitrant attitude on the part of two of the most important colonies had a very disturbing effect upon England. In the House of Lords, speeches were delivered dealing with the ingratitude of the American provinces;² many of those who, during the Stamp Act crisis, had opposed Grenville, now spoke severely against the colonies in general; and especially against New York.³ "The spirit is greatly changed with respect to America," wrote the Connecticut agent, William

Samuel Johnson, "last year they were all for favoring and relieving us; now they are as much engaged to lay burdens upon us, and reduce us to subjection."¹ George Grenville, from his seat in the House of Commons, demanded that all Americans, before they would be allowed to sit in their local assemblies, or to exercise office, should give a political test in the shape of a declaration acknowledging the sovereignty of Great Britain and the right of parliament to tax America. Although this was lost by a vote of forty-three to one hundred and forty-six, through the exertions of the Chathamites and the other opponents of Grenville, yet the ministry was becoming more and more impressed with the fact that a firm hand should be placed upon the colonies and that they should be required to share in the expense of the imperial upkeep.

Pitt, undoubtedly a great war minister and a man who could incite others to action, was, irrespective of his physical disabilities, not so well qualified for the solution of the tremendous financial problems which confronted parliament. He had brought to a successful conclusion the Seven Years' War, but in doing this he had spent with a lavish hand; how the nation's obligations were to be met, he seemed disposed to leave to others to suggest. Even the Rockingham Whigs, who had joined with him in opposing the Stamp Act, now upbraided him with great warmth for his "profusion of the public treasure and disregard to the means necessary to increase the reve-

nue."¹ The war had cost, over and above the amount necessary to maintain the military and naval peace establishment, about eighty-two million pounds, and left Great Britain with a debt of more than one hundred and thirty millions. Over one hundred and twenty-four millions of this had accrued during the series of wars with France and Spain, which the nation had fought for the preservation and building up of the growing empire, and for the securing of the right to navigate freely the highways of the great seas.² Even before the Seven Years' War, the interest charges on the debt, including the terminable annuities, amounted to over two and one-half million pounds. Not including the civil list, there was an annual cost of over two million pounds for the maintenance of a military and naval establishment sufficient to insure all parts of the empire proper protection. Not only the prosperity but the very existence of the American colonies, it must be borne in mind, had depended upon the successful outcome of this struggle, which had lasted for almost a hundred years. Subsidy upon subsidy was piled on the shoulders of the English people and, while they had long been accustomed to heavy taxation, the feeling had spread among them that their brothers, who had slipped over to the colonies by the tens of thousands, were unfairly leaving those who stayed at home to groan under

the weight of crushing national obligations and were not doing their share.¹ "I have been alarmed," wrote William Samuel Johnson to the governor of Connecticut, "with assurances that something very striking must be and will be done, and that the anxious spirits of this country can no longer brook the impositions upon them without some similar impositions upon America." When Hillsborough, in speaking to Johnson regarding the situation of the colonials, said that, as to taxes, they were infinitely better off than any of their fellow subjects in Europe, the latter made no attempt to deny it, but answered in a way that had become characteristic of Americans and that carried a warning. "I replied," wrote Johnson concerning the interview, "that if we paid less, we had less ability, and fewer advantages; and, all circumstances considered, our burdens were truly very great, and even more than we knew how to bear, and I hoped that this country would

Writers have been too prone to overemphasize the exclusive benefits that accrued to Great Britain under the highly protective navigation and trade acts. not add to them, as they would certainly find it would eventually redound to their own prejudice, at the same time that it effectually ruined us.”¹ However, the following year in referring to those burdens which were more than his fellow countrymen “knew how to bear,” Johnson declared in a confidential communication: “I am glad to find the colony is so nearly out of debt. . . . You are aware that our being so little in debt is earnestly urged here as a reason why we should acquiesce in the impositions laid upon us by Parliament; for which reason, as well as others, I wish them to know as little as possible of our internal circumstances and policies, especially in point of taxation, which they will never clearly understand and which may be liable to misconstruction.”²

Regarding the question of taxation in Connecticut the writer “Civis,” in the *Connecticut Gazette* of August 16, 1765, who manifestly was none other than Jared Ingersoll,³ quoted with approval the estimates made in England that, should the colonial pay the stamp duty, his contribution would not be more than one-tenth of that paid by his brother in England “in the general defence of the Kingdom.” In the “Answers to the Board of Trade,” made in 1756, Governor Fitch stated that the revenue by direct taxation—practically the only revenue the colony had—amounted to about £4000 sterling;⁴ in 1764 it was estimated that a tax of one penny on the pound would produce £5000.⁵ In 1774 Governor Trumbull, in his “Answers to the Board,” stated that “the ordinary annual Expenses are near four thousand

Pounds Sterling, exclusive of the schools: there hath been no extraordinary expenses since the last war & the Burden of that is felt to this day.”¹ As to this “burden,” it is by no means certain that Trumbull stated the matter with frankness. On October 25, 1769, the auditor for the colony reported that the preceding May £45,369.7.10 was due from the “collectors of the Colony Taxes,” and that “there was in the Hands of the late Treasurer Talcott £21,995.19.11.3 not accounted for, which made in the whole the Sum of £67,365.7.10 $\frac{1}{4}$ in favor of the Colony.”² As to what was then due from the Colony it was reported to be viz. £31,713.8. $\frac{3}{4}$ in Bills of Credit outstanding, interest thereon added made the Debt due from the Colony on outstanding bills about £39,641.15. $\frac{3}{4}$.³ Thus the assets of the colony without resort to additional taxation were, in 1769, more than sufficient to meet its obligations, which certainly rested lightly upon the shoulders of the people. In fact, it seems to be true, as was commonly boasted, that between the years 1766 and 1770 no colony taxes were collected,⁴ which accounts for the large sum

of £45,369.7.10 due from the collectors of the rates. Indeed, through the aid of the large sums of money received from England for reimbursement for expenditures during the late war,¹ Connecticut had practically freed herself from debt by 1770 and the late emissions of bills of credit from May, 1770, to October, 1774, can hardly be regarded in any other light than an effort to meet the demands of the Connecticut inflationists.

In other words, the situation of the people of Connecticut, with reference to public burdens, was, in reality, in spite of their customary complaints, vastly different from that of the masses in England. Connecticut naturally appreciated her advantages, and it is not strange that she was extremely anxious to preserve them, and as Hillsborough in 1768 pointed out to Johnson, the colony kept herself in the dark; her correspondence with the home government was very deficient, and whenever it took place, a very incomplete idea of the state of affairs was rendered.

It should be observed in this connection that although Governor Fitch had instructed the London agents of Connecticut, in 1764, not to deny the constitutional right of parliament to tax America, but to plead rather its inexpediency, the colony, in order to maintain its privileged situation regarding the national burdens, felt

obliged to repudiate this position and to take advanced grounds with reference to the legal competency of parliament to make revenue plans that would comprehend and bind the colonies.

Faced by this general situation, what was left for any British ministry to do? National repudiation of the great debt with its interest charges was not to be considered and yet it seemed as though something must be done to give relief to the English people. To lower the prices on food, the exportation of corn was prohibited and the protection of the British farmers against the cheaper wheat and Indian corn from America was swept away. To Johnson, who had been raised in the midst of the rude plenty of the little agricultural community of Stratford, Connecticut, the sight of the misery he found in England was shocking. "Notwithstanding all they have done," he wrote in 1767, "the distress of the poor for want of bread is terrible and affecting."¹ In 1768, in a letter to his father, Dr. Samuel Johnson of New York, he said: "we seem here to be almost in a state of anarchy, there being beside this of Wilkes's five other mobs assembled, viz., the sailors (who in a body of six or eight thousand went down on Wednesday and delivered a petition to Parliament, but behaved with much decency), the coal-heavers, sawyers, journeymen hatters, and weavers, all complaining of the excessive price of provisions, and insisting upon an advancement of their wages. By this rising of the seamen, the maritime trade of London has been several days totally stopped, and no ship can go down the river. These several mobs are yet independent of each other, but a general discontent is visible among the people, and if government cannot discover some

method to quiet them before they unite, the most fatal consequences may be apprehended."¹

It was in the midst of this situation in England that Charles Townshend, chancellor of the exchequer in the Pitt-Grafton ministry, early in 1767, gave expression to the almost universal demand in England, that a means should yet be found whereby the people of the colonies be brought to contribute a more reasonable share toward the maintenance of troops along the American frontier,— a measure of precaution and an aid to the rapid settlement of the hinterland which every conception of statesmanship pointed to as wise and necessary. Townshend declared, in a speech delivered January 26, that this could be done without disturbing the sensibilities of the colonies regarding what they claimed to be their right of "internal" taxation, little as that right was admitted by the government.² As a result, on June 29 an American revenue act was passed, providing for certain import duties on glass, lead, painted colors, tea, and paper.³ The proceeds, however, arising from this act, estimated at some £40,000, were to be applied, not to the upkeep of an

American military establishment, the support of which had been the first objective of the ministry earlier in the year,¹ but to "defraying the charges of the administration of justice, and the support of the civil government, within all or any of the said colonies or plantations." An act was also passed for establishing an American board of customs commissioners.² This clearly showed the determination of parliament to get control of the American situation before taking up the question of the military establishment. For in spite of the fact that that body was cut up into "bitter political factions," "all were agreed in having an ill opinion of the Colonies and in a Resolution to assert the supremacy of this country."³

CHAPTER IX

CONNECTICUT HARD TIMES; NON-IMPORTATION; THE TRIUMPH OF RADICALISM

It is undeniable that the American colonies were confronted, during the '60's and '70's, with a long period of financial stringency accompanied by an economic crisis.¹ Lands that had sold in Connecticut in the '50's for £30 an acre old tenor, in 1762 were selling at £19; and other lands that had sold for £4 proclamation money, were only bringing £3.² "This colony is Eighty Thousand Pounds in Debt, Arrears of Taxes, that Cannot be collected, by Reason of the Poverty of those on whom they are laid," wrote Jared Ingersoll to Richard Jackson, in November, 1765.³ In the April session of the New Haven County Court, in 1761, there were two hundred and sixty-five suits, mostly for book debts.⁴ During the year 1761

twenty suits were brought by New York parties, four by Massachusetts parties, and one each by Pennsylvania and New Jersey parties, against inhabitants of the county;¹ in the November session of the court in 1766, John Hotchkiss of New Haven was plaintiff in no less than twenty-six suits;² one is amazed at the amount of litigation in which the people were involved. Such prominent men in the colony as Jonathan Trumbull of Lebanon, Benedict Arnold of New Haven, Benjamin Gale of Killingworth, and Joseph Chew of New London were loaded with debts in the late '60's. In 1771 Chew petitioned the assembly, stating that from prosperity he had been reduced to poverty "by reasons of many misfortunes sustained in the course of . . . trade and business:"³ he had accumulated debts amounting to £15,406. The assembly, after ordering him to turn over his remaining property, freed him from arrests. In 1769 Gale, who, among other activities, was interested in manufacturing steel, wrote to Ingersoll about his vain efforts to pay a certain debt; he had a negro couple, he admitted, but they were lawfully married, and he did not want to separate them through a sale.⁴ Benedict Arnold, in 1767, was owing London merchants over £1700 and was compelled to make a conveyance to them in that year of his sloop, *Sally*, and her cargo.⁵ Jonathan Trumbull, in 1766, found himself, upon the failure of the partnership of Trumbull, Fitch, and Trumbull, with debts that must have totaled between ten and fifteen thousand pounds, most of which was owing

to British merchants.¹ In a letter to Ingersoll, Trumbull described his pecuniary embarrassments as "shocking."² In 1768 a London gentleman directed inquiries to be made regarding the possibilities of opening up certain business relations with the colony. He received the following reply from his friend: "Without mentioning names, I have consulted Mr. — about the American affair, who says it will not do: he says he would not give £800 for the whole Province; that he has been all over it at New Haven and New London; that they are all mortgaged to the full to the Bostonians and New Yorkers; that they have all their goods from those two places, and import very little; very few merchants, chiefly farmers, all upon a level, labor very dear, spirit Oliverian, but very great rogues, no money amongst them, and nobody would live amongst them that could possibly live anywhere else!"³ "Cash is so very scarce," wrote Trumbull to Lane, Son and Frozier of London, to whom was owing a debt of over £3000, "that it is almost impossible to collect it for outstanding debts, or by sale of lands."⁴ To soothe his anxious creditors, his son Joseph went to England, carrying with him "Kind letters from Jared Ingersoll, whose acquaintanceship in England . . . was quite

extensive, and who cheerfully endorsed all the statements of Trumbull, and employed his influence in soothing his Creditors to lenity."¹

The reasons for this period of general financial embarrassment still await investigation before other than tentative conclusions can be drawn. Trumbull was convinced that, if parliament would grant leave for the colonies to enjoy a good paper currency, thus affording relief to specie, Connecticut merchants might easily pay their debts to England. Undoubtedly scarcity of specie was a very important factor. As Professor Andrews has pointed out, the movement of specie was prevailingly toward England, so that the colonies were kept pretty well drained of hard money.² There were times, of course, when that was not true. During the latter years of the late war, the price of bullion (that is, the value of an ounce of silver) was so enhanced in London as compared with its value in America, that the colonies found it to their advantage not to ship the money paid for reimbursement, as had been the practice, but to sell it to those desiring London bills of exchange.³ It is undeniable that the rapid increase of population in the colo-

nies required, for the best interests of business, a stable currency, which, at the same time, should be capable of expansion according to the needs of commerce. From 1756 to 1762 the population of Connecticut, according to the "Answers to the Board of Trade," was increased only about eleven thousand, on account of "losses sustained during the War and frequent and numerous emigrations from hence to his Majesty's newly conquered or evacuated countries in America";¹ but from 1762 to 1774 there was an increase of over fifty-two thousand, although "within this Time, there have been frequent and numerous Emigrations from hence, to settle on new Lands in His Majesty's other colonies in America."² To meet the enlarged demands for money, there was issued, after 1770, for circulating purposes, £10,000 in bills of credit, bearing two and a half per cent interest, and £39,000 without interest. But this paper money was only adapted, naturally, to meet the local requirements. The result was that hard money, by reason of the growing demand for it in the colonies, as the only medium for international exchange, and for carrying on business with the mother country, was driven as completely from circulation as was gold during the economic crisis of the '70's and '90's of the following century. This was unfavorable to a developing international trade.

But there were other causes for the economic depression of the colonies during the decade preceding the

Revolution, which rightly called for measures of economy. There are evidences that the earlier habits of frugality and conscientious meeting of obligations had been gradually cast aside by too many of the people living in the colony. "The great folly that the Americas are running into is luxury," declared "Common Sense," in the *London Chronicle*.¹ William Samuel Johnson, writing to Governor Pitkin in 1767, regarding the purchasing of English manufactures by America, referred to the colonists' "natural propensity to luxury."² In 1769 Johnson declared that the non-intercourse agreements might be effective were "the prudent spirit of frugality and industry once diffused through the bulk of the people of America."³ "Natural Wealth increases in our Land greatly," asserted John Devotion of Saybrook, in 1767, though it is important to notice that he went on to say that "Luxury & Pride eternally cry Poverty & bad Times."⁴

This tendency to live above one's means, so characteristic of America of this period, was aided by the general practice of extending credit for long periods of time. Everybody sought to buy on credit, and, on the other hand, when it came to meeting these obligations, it was done, as a rule, in a most unwilling spirit. In going over the county court records for this period, one is led to wonder, in view of the astounding number of cases of book debts that came before the tribunal at each session, whether men, as a rule, would pay any indebtedness without taking a chance of relief through the technicalities of the law. In 1769 Green and Watson, editors of the *Con-*

necticut Courant, printed at Hartford, addressed the public through the columns of the paper, declaring that upon an average they had not received, since beginning their partnership, two shillings out of every six shillings due for the yearly subscription of the paper. "We beg leave," they wrote, "to address our delinquent Customers in the Language of Civility and with a Deference due to the Character of Persons, either of Probity, Honesty and Veracity, or of Humanity, Honor, and Ingenuity; in either of which, we are assured they will take no Offense at our once more calling upon them for a settlement." They announced that by reason of the "unexpected & Perservering Negligence of far the greater Part" of their customers, they were obliged to think of discontinuing the paper.¹ The *Connecticut Journal* of New Haven was apparently no more fairly treated by the public. There was something that almost approached eloquence in the announcement made by this paper early in 1773. "The printers are sorry, they can with truth inform the public, that they have not for this year past received from all the customers for this journal so much money as they have expended for the blank paper on which it is printed."² "Gentlemen and Ladies," wrote Leverett Hubbard of New Haven, in an open advertisement in the local paper in 1774, "you may remember, I have several times desired in this paper that you would settle accounts with me. I suppose . . . you thought I was in jest. I have you now take me in earnest. I have a large number to settle with. . . . I shall employ an attorney."³ Yet a writer in the *Journal*, in 1770, spoke of "lately walking thro the Town, & Contemplating its great Increase, within those few Years past, by the many new and Ele-

gant Buildings erected in it";¹ while Hugh Finlay, who traveled through the northern colonies in 1773, and stopped at New Haven, was impressed with the fact that this was a "flourishing sea Port Town."²

If the means for investigation were at hand, it would doubtless be found that a large part of the difficulty which merchants and others experienced in coming to settlements with English creditors was due to an over-willingness to allow great numbers of people with careless habits, which had dulled the keen ethical edge of their Puritanism, to run up bills which they either could not settle or would not, without the burdensome expense of a lawsuit.³

The litigious spirit which ran riot among the people of Connecticut at this period⁴ gave the appearance of dis-

Moreover, it should be borne in mind that the decline of land values in Connecticut in the early '60's was probably due not so much to the poverty of the people as to the excessive appreciation of money, brought about, among other causes, by the desire of large numbers of the inhabitants at that time to sell their property in Connecticut immediately in order to settle upon the new lands opened up by New Hampshire on the upper Connecticut.¹

It appears to be a fact that the people of Connecticut were living in the midst of abundance. A Boston correspondent to a London paper, writing early in 1769, declared that he was surprised when he went westward the preceding fall, as far as Connecticut, and rode one hundred miles up the banks of "the river," to find that the people were increasing as rapidly to the westward as they were to the eastward. He found that many of the towns had two, three, four, and some five parish churches. Most couples, he stated, after they had been married from sixteen to twenty years, had from eight to twelve children, who in turn married, as a rule, when twenty-one years of age, and "almost all before they are 25." The parents were able to make provision for them by purchase or grants from the government, and in addition to the land, started them out with a cow or two, a horse, a yoke of oxen, and some swine. "It is remarked

that those who are industrious, provide themselves with provisions after the first year."¹

What has been said goes to show that in 1767 the people of Connecticut, in spite of appearances to the contrary, were comparatively free from burdens other than those they had, as individuals, placed upon their own shoulders. The opposition, therefore, that developed against the Townshend Acts in the colony was fomented by those who, as a body, were most happily situated, in comparison with the majority of their kinsmen in England.

In fact, it is not at all certain—putting aside for the moment the political phase—that the payment of the Townshend duties would have seriously and permanently affected the prosperity of America.² Dr. Benjamin Gale took the view that “the Dutys laid on Paper may be justly reputed a premium upon the very branch of Manufacture in the Country. I am amazed,” he added, in referring to the ministry, “at their Stupidity, when I reflect.”³ In October, 1767, Ezra Stiles was informed that the “Paper Mill at Norwich is plentifully supplied with

Rags and has full Demand for its Paper. . . . The Duties on Paper will give it Advantage, I imagine. They have two other Manufactories there, one in the Cutlery Way, the other what is usually called Stone Ware.” “There has lately been discovered within three Miles of this Town,” announced the *Connecticut Journal*, in its issue of July 22, 1768, “a prodigious quantity of a brown Species of Paint. It is nearest the Colour of a dark Spanish-Brown, and may with a little Preparation, answer all the Purposes of common Painting—and is as yet entirely unpolluted with any Duty. "I am sorry," declared John Devotion, in 1768, "that Boston & other Places vapour so much about their *posse*. Should be much more pleased if they and all others would be content with *agendo* and Reflection upon it—privately, or without Noise increase our own Manufactories. . . . Had once the Fav'r of Conversation with Dr. Franklin upon this Topic. Manufacture as much as possible, but say Nothing—was his Remark."¹ William Hart of Saybrook was impressed with the fact that the proposal to garrison the frontier with regular soldiers would benefit America rather than England. "If the Ministry continue sending and stationing their troops in our Provinces," he wrote in 1769, "our Country will fill up very fast; they will increase and improve our Manufactures, and help to ruin their own; and their wealthy people growing poorer, will come over by and by. If they dont alter their measures they will defeat their own designs, and in the end make America great and Britain small."²

The people of the colony, it is hardly necessary to say, were not disposed to think of the opportunities now afforded America to establish manufacturing, for they gradually fell under the spell of those who appealed to their apprehensions. "They are ever jealous of their liberty, and fear every innovation," wrote Jonathan Trumbull of them in 1768.³ This revenue measure by the central authority was pictured to them as the be-

ginning of their bondage. It was novel, and they were devoted to the old method of contributing to the needs of the central government; in fact, it took them twenty years to realize what the ministry, by 1765, had come thoroughly to appreciate: that the requisition system was a broken reed for any government to be obliged to rely upon. "Have there not been methods and ways of treatment from the Crown by the way of requisitions made many times in consequence of addresses from Parliament, which always succeeded and answered the ends of government, and the Colonies were thereby treated as children, and not as slaves? Why is the method changed?" asked Trumbull.¹ "I think," he declared at another time, in pointing out what was a tender spot with the colonial, "it may be truly said there is no disposition in the Colonies to contend with Great Britain but for what they look upon to be their sacred Constitutional rights and privileges. . . . The keeping on foot a body of troops in the Old Colonies, where they serve no other utility but only to overawe the inhabitants into compliance with something they think grievous and burdensome, is what they are uneasy with."² One may be sure, in this connection, that the sensational and almost fanatical attacks of Wilkes and others against the government did not aid in reassuring Americans, for the colonial papers were filled with the inflammatory articles that had been published in the *North Briton* and other papers of that type. "The Americans are now groaning under all the horrors of a military government," declared the *North Briton*; "and nothing but the terrors of such a government could oblige them to submit to the unconstitutional taxes we have imposed upon them. And to talk

of tranquility being restored in America is just as good sense as it would be to talk of an angry man's being pacified, when his mouth was gagged, and his feet and hands shackled."¹ The psychological effects of this ardent sympathy, expressed by the followers of Wilkes, must have effectively nursed the conviction that the mother country was engaged in the insidious design of subjecting the colonials to a species of servitude.

When the news arrived in Connecticut that the revenue bill had become a law, there took place among leading men considerable discussion as to how the measure would be applied to the colony. The latter part of July, 1767, Jared Ingersoll addressed a letter of inquiry to Johnson, asking, among other things, "whether the Parliament means to pay salaries to *our* governor and the *Judges* and let *us* choose them at the same time?"² Letters from London to people in the colony bore the information that the home government would appoint a Connecticut superior court.³ This was in line with the warning that Richard Jackson, the London agent of Connecticut, had privately sent to Governor Pitkin, the preceding autumn, apprising him of the fact that the colony had many enemies to her charter privileges, and that they were not only men living in England, but among those who had come to America; it was very unfortunate, he considered, that the charter of the colony was so similar to that of Rhode Island, where the people had made them-

selves more obnoxious to the home government than Connecticut people were ever likely to become.¹ William Samuel Johnson, writing to Governor Pitkin from London, in July, 1767, said that although the act in question was penned in general terms and equally included all the colonies, yet he could not find that any use was intended to be made of the power of appointment with respect to the charter colonies. They, however, would be subjected to pay their full proportion of those duties by which the civil establishments of the other colonies would be supported, while maintaining their own officers, "which, in event, amounts to the payment of a tax to the other Colonies."²

There was at first, it appears, little excitement regard-

ing the act, as far as Connecticut was concerned. "It seems to me," wrote Ingersoll, during the summer of 1767, "the Duties intended to be levied are as well chosen as any could be—what effect they will have I cannot say—I don't hear of any grumbling about the matter as yet."¹ But, as in the movement against the Stamp Act, Boston took the lead in stirring up the rest of New England through an aggressive committee of correspondence. In October, 1767, her people in town meeting entered into a non-consumption agreement with regard to a large number of articles of luxury, as well as certain products that could be produced in America, but which, as was the case of the luxuries, were drawn from abroad; they also passed resolutions in favor of non-importation and the encouragement of American manufactures.²

As would be expected, the eastern Connecticut towns were the first in this colony to fall into line with the Boston merchants. Windham held a meeting as early as December 7 to consider the proposal. But it was not until February 8 that the friends of this movement were able to get the New Haven authorities to call a meeting of the inhabitants to determine whether or not the town was disposed to adopt similar measures. At this gathering, called to consider an urgent communication from "the selectmen of Boston, respecting some measures of economy," the whole matter was referred to the civil

authority and the selectmen, who were asked to bring in a report. After deliberating two weeks, a second meeting was called, by the selectmen, on February 22; it was not, however, until March 4 that the inhabitants were disposed to fling aside their conservatism and to vote that, beginning with March 31, there would be no purchasing of the "enumerated Articles, imported from abroad."¹

The news of the activities of the Boston agitators at first caused great indignation in England. Friends of the colonies attempted to put the whole matter in a favorable light, urging that this non-consumption movement was founded simply upon the necessities of the people, the want of trade, scarcity of specie, and the inability to pay debts without greater frugality than formerly. To the criticism that the agreement was entered into with other motives, especially to show resentment against England and the laws and regulations of parliament, colonial supporters replied, it is to be feared not very ingenuously, "that there is no clear ground for this position and that it is a harsh, uncandid construction, which ought not to be made."² Johnson, writing to Pitkin in December, regarding the activity of Boston, laid bare his

real feelings. "I must own, indeed, that our best friends do rather condemn the time and manner of doing it, and hope the example will not be followed in other towns and Colonies."¹

As was stated above, the resistance against the Townshend Act, starting from Boston, spread from town to town in New England and southward. In other words, it was essentially, although not exclusively, a town movement and was promoted in the official gatherings of the inhabitants. The report of the American Board of Customs Commissioners sent to the Treasury Board from Boston early in February, 1768, was not such as to reassure the ministry regarding the official activities of the New England towns. In these popular governments, they declared, there were frequent assemblies of the people at large under the name of "town meetings," which were originally instituted to regulate the prudential concerns of the towns, but had been converted to answer political purposes. "At these meetings the lowest Mechanics discuss upon the most important points of government, with the utmost freedom, which being guided by a few hot and designing men become a constant source of sedition. Men of character avoid these Meetings and the strongest have generally the best of the argument, and they could not oppose any popular measure without being exposed to insult and resentment."²

There is little doubt that a change was taking place in New England, which warrants much that the commissioners had to charge against this section. The conservative group was slowly losing its grasp. Opposed to changes as New Haven had been, even she was now under the domination of that religio-politico, radically inclined

faction known as the New Lights.¹ Such an unusually able and solid man as Judge Ebenezer Silliman of Fairfield, Connecticut, was retired from public life for a time for opposing the appointment to a town office of one of the local Sons of Liberty, "which raised great indignation."² "Political Orthodoxy, I think is dying in this Government," lamented John Devotion, "could we but recover Gov'r Fitch & the Old Senators, methinks there might be better times."³ The change was, of course, reflected in the attitude of the men who were now sent to the general assembly. At the May session of 1768, that body passed the famous Connecticut Import Duty Act, which levied a duty of £5 for every £100 worth of goods, wares, and merchandise, except lumber, brought into the colony by all those who were not inhabitants therein. This struck at English importers as well as those of New York, Massachusetts, and Rhode Island.⁴ Furthermore, the assembly came to the resolution to petition, from now on, only the king, "because to petition Parliament would be a tacit confession of its right to lay impositions upon us; which right and authority we publicly disavow."⁵ Acting upon this, a petition to the king against the taxation by parliament was drawn up and signed by Governor Pitkin, June 10, 1768.⁶

The superior court of the colony, which in 1766 showed its independence of the radicals, now, with Jonathan Trumbull as chief justice, threw its influence into the balance of the popular cause. Both in March, 1768, and in April, 1769, Duncan Stewart, collector for the port of

New London, applied to this court for writs of assistance. The court submitted the matter to the general assembly at its May session in 1769; the assembly appointed a committee to consider the issue, and this committee advised the assembly to take no notice of the affair one way or the other, and also "*as individuals*, not as members of the assembly, they advised the court *not to grant* such Warrants, which seemed to be the universal opinion."¹ Trumbull, writing to Johnson, June 14, informed him of the determination of the court to grant only such warrants as were "at the same time consistent with the liberty and privilege of the subject, and made returnable to the Court."²

Indeed, affairs in the corporate colonies by 1768—according to a memorial of the American Board of Customs Commissioners—had taken on a very discouraging aspect for those endeavoring to uphold the king's authority. "Though smuggling has been carried to very great height, yet six seizures only have been made in New England provinces within the course of two years and a half, & only one prosecuted to effect, the second was rescued out of the custody of our officers at Falmouth, who were at the same time attacked by a mob, a third was carried off clandestinely at New London while under prosecution, the fifth and sixth were acquitted at Rhode Island through the Combination and influence of the people."³ William Hart, writing from Saybrook, Connecticut, Au-

gust 12, 1768, and in touch with the situation, was filled with foreboding. "We are in a strange, dangerous, unsettled disposition, meditating great changes in all respects, in America and in Brittain. I suspect things are ripening for some great revolution."¹ "It seems pretty probable," said William Samuel Johnson gloomily, in a letter from London to Dr. Gale, the following year, "that we shall go on contending and fretting each other till your prophesy shall, as it certainly will be, fulfilled, and we become separate and independent empires. . . . If we were wise and could form some system of free government upon just principles, we might be very happy without any connection with this country. But should we ever agree upon anything of this nature? Should we not more properly fall into factions and parties among ourselves, destroy each other and become at length an easy prey of the first invader?"²

That the attitude of the colonies was giving the Grafton ministry no little concern is shown by the creation, in 1768, of the office of secretary of state for the colonies, and the appointment of the energetic, well-meaning, but tactless Earl of Hillsborough to this post. Hillsborough sought to get control of the situation. As for Connecticut, he was convinced that the colony was "in danger of being too much a separate, independent state, and of having too little subordination" for the mother country.³ The treatment at this time accorded to Connecticut communicants of the Church of England was one, among many things that may be cited, which, in the minds of contemporaries, justified this attitude.⁴

Not many weeks after taking office Hillsborough had a memorable interview with William Samuel Johnson, who was still serving the colony as its London agent. He complained to Johnson that Connecticut had been negligent about sending over her laws. He declared that he had requested a copy of them and "had known the like demand made when he was at the Board of Trade, and had been informed that it had been repeatedly made long before that, but he could not find that any obedience had been paid to the requisition."¹ Johnson replied that he believed the colony had several times sent over copies of the printed law books; and that he thought there was one or more of these at the Plantation Office.² The secretary, however, went on to state that, as his was a new office, it would be necessary to lodge a copy of the laws with him; he also thought it was the duty of the colony to transmit, from time to time, not only the laws that should pass, but all the minutes of the proceedings of the governor's council and the general assembly, that it might be known what lines the colony was pursuing and how the government was administered, in order that whatsoever was amiss might be rectified.

The Connecticut agent did not hesitate to reply to this sweeping request that "if his Lordship meant to have

the laws now in force there and those which should hereafter pass, transmitted (as from the Colonies immediately under the Crown) for the inspection of the Ministry, as such, and for the purpose of approbation or disapprobation by his Majesty in Council (which I saw very plainly was what he was driving at), it was what the Colony had never done, nor thought themselves obliged to do, and I was persuaded would never submit to."

Hillsborough informed Johnson that he had read with some attention the charter, and knew what powers had been exercised under it. There were, however, he insisted, such things as extravagant grants, which were, therefore, void; there were many things which the king could not grant as the inseparable incidents of the crown and it might deserve consideration whether some things which King Charles had pretended to grant to the Colony of Connecticut were not of that nature, particularly the power of absolute legislation, "which tended to the absurdity of introducing *imperium in imperio*, and to create an independent state." The laws of the colony, he concluded, ought, therefore, to be regularly transmitted for the inspection of the Privy Council, "and for *disapprobation*, if found within the saving of the charter, *repugnant to the laws of England*." Johnson, however, boldly retorted "that the Colony did not apprehend that any extra judicial opinion of his Majesty's Ministers, or even of the King's Privy Council, could determine whether any particular act was within that proviso or not; that this only could be decided by a court of law; having jurisdiction of the matter about which the law in question was conversant . . . that this might be done in the courts of law in the Colony, and . . . very fairly decided there, and have no room for an application here." It is needless to say that Hillsborough was given the impression that this little Puritan colony had cultivated a very inde-

pendent frame of mind and was disposed to stand firmly for the retention of every special exemption and privilege.

In entering into the non-consumption agreement, the Connecticut townsmen had been led to believe that by this means so many interests in the mother country would be injured that sufficient pressure could be brought to bear upon the ministry, as was the case in the Stamp Act crisis, to result in the repeal of the Townshend revenue measure, which they now had come to consider a distinct violation of charter privileges. Undoubtedly the majority of the freemen in the town subscribed to the agreement in good faith. As the weeks and months passed by, however, the loyalty of many to the plan seems to have been badly shaken, especially when brought face to face with personal interest. Local merchants kept stocking up with supplies of the prohibited articles. A Son of Liberty, early in 1769, lamented the visible failure in Connecticut of this method of opposition against the distasteful acts of parliament. "Notwithstanding all the Talk, and the Resolves upon the Subject, 'tis an incontestable Fact," he declared, "that all our Trading Seaport Towns are stored full as ever with British goods."¹ Clearly non-consumption of enumerated imports could not stand without the aid of a non-importation agreement. As early as March 1, 1768, the Boston merchants came to a realization of the necessity for this step;² the New York merchants, in April, arrived at a similar decision,³ and in the latter part of August adopted certain resolves which New Haven was ultimately pre-

vailed upon to accept, without much modification, but not, however, until the month of July, 1769.¹

Officially New Haven remained cautious and conservative in action. However, as time went on, the temper of many of the people, and especially the mercantile element, in their opposition to parliamentary control, rose to a new level. This is evidenced by the punishment inflicted upon a fellow townsman, Nathan Smith, late in the summer of 1769. It seems that Smith lodged with the customs officials information against one of the "first merchants" of New Haven, whom he accused of smuggling rum into the colony by landing it at a cove some distance away from the city. The customs officials went to the designated spot but failed to find there the vessel that Smith alleged was used for this illicit traffic. The merchant in question asserted that she was at that time in the West Indies and was not taking rum on board.

The wrath of the community now descended upon the head of the unfortunate Nathan. "Being caught he was advanced to the command of a cart, suitably dressed out for the voyage, on whose deck no one except himself and his musicians appeared, and thus equipped he took his land tacks on board and made the most public ports of the town, proclaiming himself a liar, an informer and a pest to society, until he got safe moored on a stand in the market place. When, on assuming those ludicrous and opprobrious attitudes suited to his character for a proper space, he was conducted down and pay'd well with so much tar, feathers and infamy as he could wag home."² The writer of this narrative was careful to mention the fact before concluding that "the whole being conducted by the principal merchants not the least violence or dis-

order was committed, but after the bonfire of a tar barrel, suitably elevated, all was quiet."

The pronounced determination to terrorize those who might be disposed to assist in the enforcement of the trade laws by reporting smugglers to the customs officials was also manifested the following week, when a crowd set upon Adonijah Thomas, another resident of the town. "In the Presence of the Gentlemen Merchants, and Inhabitants" he was compelled to declare, "I have attempted to inform against Mr. Timothy Jones, Junr, for running of Goods, for which I humbly beg the pardon of the whole inhabitants of this Colony, and this Town in particular and hope the said Inhabitants will receive me into their former Favor and Esteem: And acknowledge that my Punishment is far less than the Demerit of my heinous Crime deserves." After this confession had been publicly read, the frightened man was forgiven and the crowd dispersed, but not before declaring "that whosoever attempts to do the like, or to support or encourage any of those mean Wretches, who may be hardy enough to attempt any Thing of the like Nature, that they may expect to receive a Reward adequate to their Crime." It is easy to perceive that New Haven, by 1769, had become, as a community, much more radical than it was in 1766, when, in the affair of the informer, Peter Boles, the leading townsmen turned sternly against mob rule and terrorism.² This attitude, which appears to have been generally manifested throughout the colony, placed the people in a most contradictory position. On the one hand, through their agents, they were demanding a most punctilious observance on the part of the central

government of every established legal relation between themselves and the mother country; they insisted that harmony and happiness alone could come through the careful respecting of every customary right. On the other hand, the inhabitants of one of the soberest and best regulated towns of the colony were most flagrantly repudiating this very position by sternly suppressing those who were disposed to help in the maintenance of the trade and navigation acts, which, it must be remembered, had long been accepted as binding.

To maintain the non-importation agreement meant no little sacrifice on the part of the people. But even this willingness to dispense with English products was not considered to be sufficient; manufactures, within the colony, and elsewhere in America, must be promoted. The latter part of February, 1770, a meeting was called at Middletown, which was attended by the principal merchants and traders of the colony; it was presided over by Gurdon Saltonstall, with Silas Deane acting as clerk. The list of articles that might be imported into the colony was increased over the list published by New Haven, July 10 of the preceding year, but it is to be noted that these additions included such things as powder, shot, saltpetre, brimstone, and bar lead; all of which gave an ominous appearance to the proceedings of this meeting. Articles necessary to promote fisheries, and the manufacture of paper, shoes, clothes and hats were also to be allowed ready entrance into the colony. It was voted, also, that no dealings should be had with inhabitants of neighboring colonies who did not adhere strictly to the non-importation agreements of their respective colonies. For the encouragement of "Arts, agriculture, manufactures, trade and commerce," it was further recommended that the people of the colony form themselves into a "resultary society," and that a committee be appointed to take

the subscriptions of such as should think proper to join the same and to receive donations, with the understanding that those who contributed twenty shillings should be admitted to vote in the society at all times thereafter. To further this end, there was collected among those present over £100 lawful money, and a meeting of the society was called for May 22, at which premiums of various kinds for the promotion of industry were to be agreed upon and published.

Before the adjournment of the Middletown meeting, four additional resolutions were adopted. One, to the effect that a committee, appointed for the purpose, should propose to the general assembly at the May session that a bounty of six pence per hundred be given on all flour manufactured in the colony, and exported out of the same in bottoms belonging to the colony, to any market south of Pennsylvania and east of Connecticut; and that to raise a fund to provide the bounty there should be levied a duty of six pence a pound on all tea to be consumed in the colony. Again, in order to bring "great and extensive benefits" to the colony, by developing the cod and whale fishery, the same committee was also to petition the assembly that all vessels owned in the colony and employed in the cod and whale fishery for the space of four months in any year should be free from any tax and left out of the ratable list, and that the persons likewise employed in this enterprise should be exempt from a poll tax, and from working on the highways for the year in which they should be so employed. Further, in consideration of the extreme scarcity of cash in the colony and the many frauds and the inconveniences arising out of the fact that notes in hand were not negotiable in the colony, as they were in Great Britain and in some of the other colonies, it was voted that all present should use every proper means to obtain an act making notes in

hand negotiable. Lastly, the gathering pledged itself to obtain, if it could, proper encouragement for the erecting within the colony of works for the making of window glass.¹

It would appear that an attempt was made, in a more or less tumultuous way, to carry the above proposals through the general assembly in May, but that body, representing especially agricultural interests, was not disposed to yield to all of the demands of the trading and commercial elements even in such a crisis. Instead of providing for bounties and exemptions, it passed a ringing resolution that "for the future no petition brought to the assembly and to be heard upon the merits of the cause . . . shall have a public hearing of the parties before the assembly, *viva voce*; but every petition . . . shall be determined upon the pleas and exhibits made in writing only . . . any law, usage, or custom to the contrary, notwithstanding."² Unwilling as it was to burden the people of the colony with a tea tax to encourage the exportation of flour, the assembly, however, at its October session, extended the desired encouragement to those who would engage in the cod and whale fisheries.³

That there was much genuine determination on the part of the people of New Haven, in common with other American seaports, to make effective the non-intercourse measures against England was shown when, on June 12, 1770, it was resolved, on a meeting of traders and tradesmen, held at the state house in that town, that all commercial intercourse with the inhabitants of Rhode Island, "who have most unaccountably violated their Non-Importation agreement," should be discontinued, until they

returned to their duty. More than that, a committee was appointed to wait upon the captain of a trading vessel from Rhode Island, which had arrived in Stratford River, and to desire him to depart from the colony immediately. This was done, and the captain gave his promise to leave as soon as he had cleared his vessel at the custom house.¹

There were, of course, many living in this community who could not easily sacrifice personal comforts to promote the general cause. Great pressure was brought to bear upon local traders to violate the agreement, especially with reference to such highly desired articles as tea. One skipper claimed that he was beset by ladies to furnish them with "that expensive herb called Bohea tea." When he urged that the duties were not taken off, the ladies, according to his statement, answered that they would keep the matter secret or lay those whom they told of their good fortune under obligation not to tell.² It was charged in the papers that a quantity of tea and sundry other things had been spirited into the colony from Boston, and that there was such a longing for these things that there was little real opposition against the bringing of them in, in spite of the agreements and the fact that the Sons of Liberty took the matter of these violations in hand and "partly made the importers promise not to sell, which sufficed." But sales apparently went on.³ Indeed, some of these very Sons of Liberty

were accused of buying the prohibited articles, which brought forth a stinging rebuke from a correspondent to the local paper, who declared that "a snake in the grass had a better advantage to bite than in a plain open field."¹ It is not, of course, surprising that some of those who had, for the sake of self-interest, been violating the trade laws of the nation, failed to find it any easier to abstain from violating the non-importation agreement made with their fellow townsmen, when they found that this, likewise, conflicted with notions of personal benefit; it was all, largely, a habit of mind with them. What undoubtedly encouraged this practice was the assurance received from England that the ministry had decided to give up and to bring about the repeal of the Townshend Act.

The ministry, in fact, was sailing through rough waters, in the warring of the parliamentary factions. Whichever way it proceeded, it was sure to be bitterly assailed by those within and without parliament. The Grenville faction took no little satisfaction in the writhing of those former opponents of the Stamp Act who had started out so confidently to prove how it was possible to equalize, in a measure, the crushing burdens of the state, due largely to the national debt and the cost of the necessary military and naval protection; but Grenville would not vote to repeal the revenue act. The opponents of the act, however, were gaining in strength day by day, as the realization came home to members that nothing was being accomplished by the measure, except the further irritation of the colonies. On April 19, 1769, ex-Governor Pownall moved the repeal of the act, offering as the basis for this his reasons that it was universally held to be anti-commercial, prejudicial to the manufac-

tures of Great Britain, and even unjust, as it imposed duties for the support of government equally upon those who had and those who had not provided funds for that purpose. In the same debate Burke vigorously declared that he believed all parties were now pretty well agreed that it was in vain to think further of any real practical plan of raising a revenue in America, and he hoped that it would never again be attempted; the money of the colonies must be drawn from them in another way, and that was by commerce alone. On the other hand, Lord North pointed out that for parliament to give way upon this issue would be practically to signify to the colonies their independence of the mother country; that members would find in the future whenever any act of parliament was made not perfectly agreeable to the Americans, they would again go into the same measures to obtain a repeal, and, in the end, get rid of all acts of parliament, "Even that essential one, the Act of Navigation, the basis of the wealth and power of Great Britain."¹ After several meetings, the English merchants agreed to apply to parliament for a total repeal of the act, although there was no such anxiety displayed as during the Stamp Act crisis.² At length, on March 3, 1770, by a vote of 244 to 142, the ministry carried a motion through the House of Commons that all dutiable articles in the Revenue Act should be withdrawn from the schedule with the exception of tea. When the news of this reached America, it had a decisive influence in breaking down the non-importation agreements. New York, up to that time, had shown a most enviable determination to refrain from importing until the total repeal of the act. From December 25,

1767, to December 25, 1768, the value of goods that she had received from England had amounted, according to the custom house entries, to £482,000; between 1768 and 1769, the total dropped to £74,000.¹ "How forcible would the commercial agreement have appeared, had all the colonies abated in the proportion New York has done, who seems to have imported only the articles by the agreements," wrote William Samuel Johnson from London, to Jonathan Trumbull, early in March, 1770.² Her spirit, however, had been greatly weakened as the reports came in from the North and the South about the breaking of the agreement, and it was, at last, decided, at a merchants' meeting, held in June, to take the sense of the city whether it was in favor of holding out or of modifying the agreement. After two canvasses were made, which seemed to show the community in favor of modification, the merchants gave their orders for British goods, with the exception of tea.³ "I cannot express to you with what astonishment and confusion, on the one hand, and with what exultation and triumph on the other, the news that the merchants of New York have agreed to open trade has been received here,"⁴ wrote Johnson to Governor Trumbull from his London lodgings. In Connecticut, great bitterness of feeling immediately manifested itself against New York. A New Haven meeting of merchants, traders, and other inhabitants was called

on July 26, at which Roger Sherman presided. There was laid before the gathering a letter from the merchants of New York to those in Philadelphia, acquainting them with their plan to import. The New Haven assemblage thereupon expressed its "surprise and astonishment at the defection of New York. Is it possible? She who made the greatest professions of patriotism, and stood foremost in the glorious cause of American liberty, should suddenly break that very agreement she so zealously affected to accomplish! . . . Is it for a few months' commerce, for which they . . . sacrifice liberty, not only theirs, and their posterities', but of their countrymen in general; and give them over to vassalage and slavery?" It was thereupon resolved to withdraw the New Haven trade—"so far as not to purchase any goods imported from Great Britain"—from such persons in New York who should import goods contrary to the agreement, even though the act should be repealed, unless these individuals would speedily return to their agreement.

In a letter addressed to the merchants of other towns in Connecticut, the feelings of the New Haven traders and merchants were even more freely expressed. "The time is now come for us to determine whether we will be freemen or slaves: . . . whether we will tamely coalesce with the measures of our backsliding brethren of New York, who by resolving on importation at this Juncture have meanly prostituted the common cause to the present sordid prospect of a little pelf. . . . There is no time to lose and can we hesitate a moment in choosing whether we will continue our connection with those degenerate imposters, and with the prospect of a little temporary wealth bequeath infamy, poverty and slavery to our posterity?"²

Similar indignation meetings to that at New Haven were held at Hartford on August 13, at Norwich on August 23, at Farmington and Middletown on August 30. In fact, "a great Majority of the Towns" of the colony held gatherings of a similar type. In the August 17 issue of the *Connecticut Journal*, published at New Haven, there appeared an announcement on the part of the "Merchants and Traders of the Colony of Connecticut," calling upon the New York importers "to draw out their accounts immediately," as they were determined to have no further dealings with them. Those who had balances in their favor with Connecticut merchants were desired to apply personally in order that an opportunity might be given "to show them every mark of respect which their late patriotic conduct entitles them to"—for this reason no money would be paid to their attorneys. The same issue of the *Journal* also conveyed the news that "The tavern keepers throughout Connecticut, it is said, have posted up a list of names of New York importers and have determined not to give them shelter or entertainment." What is more, by concerted action the different towns selected representatives to go to New Haven for a meeting on September 17, and it is important to notice that these delegations were made up of both the mercantile and the landed interests. The meeting was held as scheduled and again Gurdon Saltonstall presided and Silas Deane acted as clerk, as was the case at the Middletown gathering in February. The "Middletown Agreement" was reaffirmed as "founded on free, virtuous, peaceable, manly and patriotic principles," and it was voted that by action of New York, "the union of Colonies . . . is greatly weakened, our enemies abroad rather animated against us, and our friends in a degree discouraged," and it was therefore decided not to purchase

from New York merchants any merchandise imported from Great Britain directly or indirectly.¹

It is interesting to note that, in spite of this developing hostility to the mother country, Jared Ingersoll appeared to have grown in favor with the people of his community and the colony generally. In September, 1768, he was recompensed, rather tardily, it is true, to the amount of fifty pounds for his special exertions as colonial agent in England at the time of the passing of the Stamp Act,² and in addition received the thanks of the general assembly for making the colony a present of some £110 sterling still due for past services.³ In 1770 the selectmen of Wallingford, the center of radicalism within the county, employed him as special counsel,⁴ and on September 18, the day after the general meeting of the mercantile interests of the colony, he was delegated at a town meeting to act as one of a committee "to take into consideration the present state of the commercial interests of this place."⁵ It is significant that Ralph Isaacs, who was also identified with the most conservative group of the town, and who later became a pronounced Tory, was likewise on the committee. This shows that either there had taken place a reaction in New Haven in the direction of its earlier conservatism, or that the non-trading, agricultural element, which was opposed to the extreme position of the traders, was powerful enough to dictate the personnel of the committee. Nothing apparently came of its activities, unless it was that the report which it made tended to discourage the maintenance of the non-importation

agreement. The year 1771 was destined to witness the collapse of the non-importation program in Connecticut.¹

Early in 1771 there began to appear in Connecticut papers attacks against this program, which was now held up to be an imprudent and injurious measure. It was freely asserted that if all who had signed the subscription had religiously adhered to it, bankruptcy would have faced every merchant in New Haven who was not independently rich, and the distress which came to the poor, now deprived of cheap clothing, was emphasized.

“But, alas!” mournfully wrote one townsman, “we see no more patriotic resolves of our merchants in the papers since the arrival of the ships at New York with goods. Our towns are already filled with the manufactures of Great Britain—how cheap they are sold and how much preferred to our own manufactures I will leave the purchaser of experience to say.”² By May every pretense of maintaining non-importation seems to have disappeared. The whole first page of the May 31 issue of the *Connecticut Journal* was taken up with an elaborate advertisement by John and James Morton, New York merchants, who had just imported from London quantities of the very goods barred by the Middletown and New Haven agreements. “Altho the perfidious and avaricious conduct of New York” was not forgotten entirely by the people, yet in their weakness, “like sheep led to the slaughter,” they fell to buying the coveted articles.³ But, broken as the agreement was, Connecticut had now learned to walk in the ways of radicalism and those ways led straight to political revolution.

CHAPTER X

THE SEARCH FOR PREFERMENT. JUDGE OF THE COURT OF VICE-ADMIRALTY FOR THE MIDDLE COLONIES

JARED INGERSOLL became a place hunter. In fact, soon after the excitement had died down over the attempt to enforce the Stamp Act, not to be discouraged, he sought to secure some new appointment in connection with the British administrative system in the colonies, through the influence of his friends, Richard Jackson, the Connecticut agent in London, and Thomas Whately, the ex-secretary to the Treasury Board, whose efforts were supplemented by those of William Samuel Johnson of Stratford, Connecticut, who was sent to England in 1766 in connection with the Mason appeal regarding the Mohegan Indian lands. Ingersoll had certainly suffered financial loss and the loss of prestige by assuming the post of stamp distributor for Connecticut in 1765, and it is clear that he felt that the home government was under certain obligations to those who had supported it during the late crisis. And he was not alone in that opinion.

In February, 1767, Jackson wrote to Ingersoll, "I heartily wish you may meet with a proper token of regard from the Government here"; although on friendly terms with almost all those in the administration, Jackson confessed that he had not been able to discover what plan would be adopted in America "that will open you a Door." He had already, he said, proposed something of

benefit for ex-Governor Fitch of Connecticut, who, with Ingersoll, had been, as it were, a victim of Stamp Act agitation, with the request that if Fitch did not accept it, the same should go to Ingersoll; but he went on to remark that if Grenville should come back into power, he would not ask him for anything, "but," he declared to Ingersoll, "you have an Interest with him through Whately, who, I believe, sincerely wishes to serve you. . . ." For a time, however, nothing came of these efforts.

During the spring of 1767 Grenville made a speech in parliament defending the right of that body both to legislate for and to tax the colonies, and in this connection offered two resolutions, one of which demanded that all the officers of the colonial governments, before entering upon their duties, should take an oath in which they should acknowledge the full supremacy of parliament over the colonies. Although this resolution was lost by a large majority, Grenville then moved that those in America who stood by the government during the late events should be mentioned for favor in a humble address to be presented to the king. This was passed.² Johnson,

writing to Ingersoll in May, said regarding this note, "You have only to regret that it came from Mr. Grenville and proceeded from his Motion, which must be very odious in Am^a and may seem to be the immediate reward of supporting his measures, which produced so much Indign^a in that Country."¹ There was certainly a feeling within the administration that something should be done for Ingersoll, who had shown the greatest courage in his efforts to give force to the Stamp Act in Connecticut. This is evident from the fact that Whately made known to Johnson that there was talk of giving the ex-distributor of stamps the chief justiceship of New York, "if it can be genteel'y disengaged from another person. . . ."²

Ingersoll's receptivity to any good offer is indicated in a communication that he wrote to Johnson the latter part of July. He referred to the fact that parliament had mentioned him as one particularly deserving of recognition and reward and said that he had to thank Whately for that. Turning to the suggestions that had been made in his favor, he then declared, "I will form no objections to the Chief Justiceship of N. York, if obtainable, nor to a Seat at the New Board of Revenues, nor to any other that you shall approve of, as I still have a full confidence

both in your Judgment & friendship.”¹ The new board of revenues here mentioned was of course the new American Board of Customs Commissioners provided for, in June, by the Townshend Acts, which was to sit in Boston. Jackson, writing in September, assured Ingersoll that he would not forget to further his interests whenever possible. “I think you will not want much Assistance, but will infallibly sometime or other be somehow remembered to your advantage.” He further declared that he had recommended both Fitch and Ingersoll for places on the American customs board, but had been met by the objection that the measure, which provided for these commissioners, might be rendered obnoxious if “unpopular People” were named; this, he thought, was “the ostensible Reason only.”² Johnson, in a letter to Ingersoll, the middle of November, said that it was confidently expected that both he and Fitch would be appointed to the board of customs; he was sorry to announce, however, to his friend that these lucrative places were filled without paying regard to the address to the crown in favor of the Stamp Act sufferers. As to the chief justiceship of New York, it had been hinted that it also had now been “reserved for a certain Gentⁿ now in Am^a & to a particular purpose which I durst not mention unless I could whisper it in yr Ear.”³

Ingersoll's disappointment in thus being passed over must soon have disappeared; for, not long after receiving Johnson's discouraging letter, there came the news of his appointment as judge of one of the four special courts of vice-admiralty that had been created by letters patent under the great seal in 1768. The district within which the jurisdiction of this new court ran embraced the colonies of New York, New Jersey, Pennsylvania, the lower counties on the Delaware, Maryland, and Virginia.

It seems that Lord North, who was now a leading member of the Grafton ministry, had made up his mind, apparently uninfluenced by anyone, that Ingersoll, whose great abilities as a lawyer were appreciated in England, should be given the refusal of one of these important judgeships. Knowing of Whately's intimacy with the latter, he sought information from him as to whether such an appointment with a salary of £400 per annum and a residence at either Philadelphia or Virginia or South Carolina would be agreeable to him. Whately immediately sought Johnson, and after the two had discussed the matter, the former waited upon Lord North and accepted for Ingersoll, under the condition that he should not be sent to South Carolina, which was considered to be too far south "for a Northern Constitution."¹ In congratulating him upon this appointment, Johnson wrote, "The office is Honore, & lucrative & I hope will be agreeable to you"; he also took occasion to emphasize the fact that since Ingersoll had a large district, in time of war, especially, he might find it more lucrative than a chief justiceship at common law even

with its proposed salary of £500, and also "from the diff^e of Fees in these two kinds of Courts, probably not inferior in time of Peace."¹

As Whately informed Johnson that he did not choose "to be seen in the affair," the latter took charge of the work of suing out Ingersoll's commission, settling the fees, which amounted to £5 7s. 6d., at the Admiralty, and £12 9s. 4d. at Doctors' Commons.² The commission reached New Haven early in 1769.³

For some unaccountable reason it was over two years before Ingersoll took up his residence at Philadelphia and actually entered upon the duties of his office. That his continued residence in Connecticut became indeed the subject of adverse comment in England, is evidenced by a letter which Johnson wrote to him early in December, 1769. He declared that there was some surprise in London that the latter was still in Connecticut and also that Mr. Sewall, appointed judge of the Halifax court, was still in Boston; there was still more surprise to hear that Ingersoll was yet in the practice of the law. "Do those Gent^l Imagine, say they, that this Office is to be a sine Cure, Are they to be Non resident Judges, or is it

Consistent with the Dignity of a Judge to Cont^e in the Pract^e of the Law?"¹ In reply to a suggestion from Ingersoll in a previous letter that he also might secure certain good things from the home government, Johnson now took occasion to say that he did not expect any of the good things mentioned "if indeed they are good things," but would return to the practice of law. Even this rather cutting communication from a friend so thoroughly respected did not lead Ingersoll into any precipitate closing up of his law practice. "I am very glad to find," wrote Whately to Judge Ingersoll, the following year, in October, "that you are at last determined to settle at Philadelphia; it was a necessary Precaution; tho' at present I do not hear any Talk of the Admiralty Courts; & I suppose we have too much Business on our hands to take them into consideration."²

Ingersoll congratulated him on his new post. Oliver, in answer to this, said: "I wish I may enjoy this new appointment with more ease and quiet than the other some years past . . . your friends here wonder at your not having taken the previous measures requisite in order to receive the benefit of your appointment."

This unaccountable delay in setting up the court may possibly be explained upon the grounds that the home government delayed taking certain necessary steps; it may also be that Ingersoll was indisposed to suffer financial losses by precipitately closing up his law practice. It is interesting and surprising, and in a sense represents a serious indictment of the efficiency of the British colonial administration, to know that he later received his salary for this period of sojourn in Connecticut, which was between October, 1768, and the spring of 1771. Whether or not he sought payment for this period is not known. The fact that it was granted in 1772 was probably due to a desire on the part of the ministry to compensate in some tangible way one who sacrificed not a little to support the home government during the Stamp Act crisis.¹ But it does not alter the fact that for a time the ex-stamp distributor *did* enjoy a sinecure.

By the spring of 1771 Ingersoll was prepared to take

up his new duties. Leaving his son Jared, who had graduated from Yale College in 1766, to settle up his remaining accounts at New Haven, he and Mrs. Ingersoll sailed for Philadelphia. Soon after his arrival, he set up his court of vice-admiralty for the middle colonies and thereupon, it seems, settled down to a very comfortable, enjoyable and not exceedingly strenuous routine of life. For Ingersoll was well and favorably known in the American metropolis of that day,¹ and among other old friends he found there was the delightful and fashionable James Hamilton of Bush Hill, who had twice acted as governor of the provinces and who enjoyed considerable popularity, especially among the leading people of the city.² Indeed, Ingersoll, from a hard-working lawyer in a small Connecticut town, became now one of the leading dignitaries of this aristocratic center. His salary of £600 per annum looked impressive beside the £200 granted to the chief justice of the province of Pennsylvania, and the £100 which the assistant judges of the superior court

were paid.¹ The mere fact that his jurisdiction included both the ports of Philadelphia and New York may be said to have made his district perhaps the most important of the four that had been established. It is unfortunate that the records of the tribunal over which he presided until the outbreak of the American Revolution have disappeared. Yet there is every indication that he was fairly busy with judicial duties. Not only did the new court immediately absorb practically all of the business which previously had gone to the Pennsylvania provincial vice-admiralty court, but it must have drawn to itself either through appeals or through the exercise of original jurisdiction many of the vice-admiralty cases arising in other parts of the district.² "I am at present pretty full of business at my Court," wrote Ingersoll, in 1773, to his brother Jonathan, who was pastor of the church at Ridgefield, Connecticut.³ However, this did not prevent the judge from maintaining the closest connections with New Haven, where his extensive law practice was being continued by his nephew, Jonathan Ingersoll; he made extended visits in Connecticut during the sum-

mer vacation of the court, and his continued influence in the affairs of the colony was more than once displayed after taking up his residence in Philadelphia; for the conservative element had not ceased to look to him for leadership. The character of his popularity at New Haven is shown by the fact that in the summer of 1772 the New Haven county court gave a dinner at which Judge and Mrs. Ingersoll were the guests of honor. It apparently was somewhat of an event, for a gentleman by the name of Wyly Elliot besought Ingersoll to use his influence that his son might be one of the speakers on that occasion.¹ It is, indeed, most curious to find this high official of the British government in such favor in a community that, together with the other towns of the colony, was slowly drifting in the direction of open revolt against the authority of the mother country.

As has been evidenced in so many ways, Jared Ingersoll's attachment to Great Britain was not limited, by any means, to a formal and official loyalty to the crown; it was something deep and sincere. His experience in England had been, on the whole, of a most delightful character; he highly esteemed the English people and this was reciprocated by those with whom he had become acquainted during those years of his residence in the mother country.² This probably had much to do with the

decision to send his son to London, where he would be able to complete his legal studies and at the same time be removed from influences in America which warred against a hearty loyalty to the British administration. As a result, early in 1773, Jared, Jr., who was now twenty-four years of age, took passage for Europe; but not before successfully passing his bar examinations and securing admission to practice in the supreme court of the province of Pennsylvania.¹ It may here be added that after traveling on the Continent for a short time, the young man settled down to study at the Inns of Court in London and not until 1779, toward the latter end of the Revolutionary War, did he return to America. Yet, as will be seen, the experience in England did not have the effect of uprooting certain ardent American sentiments which probably had taken root long before his journey abroad.

Comfortably situated as he was in Philadelphia, Ingersoll was made to feel, as time went on, that there were troubled waters ahead. On November 23, 1771, not many months after the opening of the new court of vice-admiralty, there occurred an incident which must have impressed him with the seriousness of the task that confronted him in judicially enforcing the trade and navigation acts within his district. It seems that the collector of customs at the port of Philadelphia, John Swift, had been provided with a schooner, which, under the command of Thomas Musket, coasted for smugglers,

much as our present revenue cutters are accustomed to do. One night the schooner overhauled a pilot boat which was moving up the Delaware. When ordered to open the hatches the crew of the boat refused. The result was that this vessel, which was found to contain a cargo of wine and thirty-six boxes of tea, was seized and conveyed by the captain of the schooner up the river some distance, whereupon the anchors were cast. While the ships were thus resting, a second pilot boat appeared, containing thirty men, all with blackened faces and "disguised in sailors' dresses," who sprang aboard the schooner with clubs, muskets, and cutlasses, "most cruelly and inhumanely beat, cut and wounded" Musket and two of his assistants, overwhelmed the crew and threw its members into the hold of the ship; the schooner was then run on a bar and left to its fate after the sails and rigging had been cut up. While the perpetrators of this bold act must have been known to many of the people of Philadelphia, it was impossible to secure an information against them, although Lieutenant Governor Penn offered a reward of £200 for their apprehension and conviction.¹

The year following the incident just described, there came the news of the burning of the *Gaspee* and the futile appointment of the commission of inquiry regarding this incident; and in 1773 there appeared in the Philadelphia papers accounts of the Virginia Resolves and of the destruction of the tea at Boston. Ingersoll's growing apprehensions regarding the general situation are shown in a letter written at this time to his brother. He begged that "if anything . . . remarkable should turn up in the political world, I must desire speedy information; for

you must know that I have as much and as anxious care about the state, upon me, as by your letter to son, it appears you have."¹ Things, however, moved along quite smoothly for the new court of vice-admiralty until early in the year 1774, when a series of burning attacks were commenced against Judge Ingersoll in the Philadelphia papers. These and the replies made to them, irrespective of the personalities involved, throw such a flood of light upon the peculiar position that the new vice-admiralty courts occupied in the developing issue between the colonies and the mother country that an analysis of the arguments employed by the writers cannot be neglected.

The occasion of the attacks, it seems, was the seizure of a shallop owned by one David Van Dyke, who had attempted to carry a cargo from Philadelphia to Newcastle County on the lower Delaware, without securing clearance papers at the Philadelphia customs house. The case came up in Ingersoll's Court.²

It is interesting to note that the first writer to assail Ingersoll was one who signed himself "Cato," just as was the case when, nine years earlier, he was first assailed for accepting a commission as stamp distributor. In each case the language was highly inflammatory.

"Ever since the arrival of our Commissioner at Boston,"¹ declared "Cato," "these lawless vultures placed over us in an unconstitutional manner have been giving us renewed instances of their designs by throwing every possible obstacle in the way of trade, leaving no device untried to distress us. The more effectually to succeed in these enterprises, they first sought out men to place under them who had given to the world sufficient proofs of their being enemies to their country."²

The following week there appeared in the *Journal* another arraignment of the new vice-admiralty court by one signing himself "Russel," but who, according to Ingersoll, was none other than Jacob Rush, a brilliant young Philadelphia lawyer, who was a brother of Dr. Benjamin Rush, and who later became chief justice of the state.³ "Russel" came forward to prove that the pow-

ers Judge Ingersoll exercised in his court "vastly exceed those of the Grand Court of Admiralty in England." In this connection he cited Coke and Blackstone¹ to support his contention that the English High Court of Admiralty could have no jurisdiction in cases arising over bills of exchange, bills of lading, bottomry bonds, charter parties, policies of insurance, freights of ships, or any contract or any other thing done within the body of any English county, nor concerning any wreck—all of which matters, however, were given over to the jurisdiction of the American vice-admiralty courts. "Russel" further insisted that in England cases of mayhem happening in rivers and ports were under the jurisdiction of the coroner,² while in America the new courts were given power "to search and enquire of and concerning the bodies of persons drowned, killed or by any other means coming to their death" in the seas, ports, or rivers. Then in personally addressing Ingersoll, "Russel" declared: "I cannot help thinking and I hope you will excuse me from telling you so, that the execution of the office *you* hold must wound every feeling of honor and delicacy. You know what I mean. Your salary of £600 a year is to be paid, in the first place, out of the moiety of money arising

from condemnations made by yourself as a Judge. This, sir, people will think looks too much like being party, judge and jury. The administration of justice should not only be pure, but like Cæsar's wife, should be above suspicion."¹

A reply to "Russel" was not long forthcoming, by one employing the pseudonym, "Civis." The latter came to the defense of the British administration of colonial affairs in the same measured language and judicial temper that had characterized the utterances of "Civis," who in 1765 endeavored, in the *Connecticut Gazette*, to vindicate the propriety of the Stamp Act in replying to "Cato." In fact, as was pointed out in the chapter on the Stamp Act, the similarity of these "Civis" writings of both periods with the publicly acknowledged work of Ingersoll is so very striking that were other evidence lacking one would still be justified in attributing these productions to this source. However, in the case of the letters of 1774, Ingersoll privately acknowledged his authorship, which, of course, gives a special significance and interest to this controversy.

"Civis" began the defense of the new American vice-admiralty courts by denying that they had jurisdiction over treason, robbery, and murder committed on the high seas; he also denied that British vice-admiralty courts did not have authority over bills of exchange and like matters "of a maritime nature"; he called "Russel's" attention to the fact that in every case where a power had been granted to the new American courts it had been qualified by the words "according to the civil and mari-

time laws and customs of our High Court of Admiralty in England"; finally, with reference to the question of the salary he pointed out the fact that it was an advantage to everyone concerned that the judge should have a definite, guaranteed salary for he "neither adds to his salary by condemning nor lessens it by acquitting." He moreover pointed out that it was "no uncommon thing for the common law judges to be paid out of the gross sums arising in part from fines and mulcts of their own imposing."¹

When "Russel" returned to the attack he boldly accused Judge Ingersoll of writing the defense by "Civis." "There is no occasion," he said, "to make any apology for considering you as the writer of a piece published in the *Pennsylvania Journal* last week under the signature of 'Civis,' in which an attempt is made to vindicate your commission . . . the stile and matter as effectually betrays the author to the public as if his name had been subscribed to it."²

Again taking up the salary question, "Russel" pointed out that the old naval stores did not constitute a dependable fund. "I have been well informed," he declared, "that it has already failed more than once." The judge, therefore, must make sure of his salary by way of penalties and forfeitures. A more serious thing than the salary situation, however, according to "Russel," was the power of the new court to summon those accused, together with witnesses from the farthest parts of New York, New Jersey, Pennsylvania, the lower counties in Delaware, Maryland, and Virginia, with authority to fine, imprison, and strip them of their estates for want of

obedience. "You may harass the whole country at your pleasure. . . . It is impossible, we can ever be a free people while such a Commission as yours is held over our heads, which alone with the Stamp Act or Revenue Act is sufficient to prostrate all the liberties of America at your feet."¹

When "Civis" made his second reply to "Russel," naturally enough he did not attempt to clear himself of the charge of being the judge of the very court then under fire. However, he did his best to refute the other charges. As to the old naval stores, he had never known of an instance where they had failed as a source of revenue for the payment of judges' salaries; in fact, he was able to state that for several years past the judge in question had received a great part of his salary from that source and he denied that the salary of the judge could be affected by failure of both sources.² As to the size of the judicial district of the particular court under discussion, he maintained that it was not so large as the district of the High Court of Admiralty in England, and also that if experience should prove the new court "either inconvenient or useless, it was to be hoped that

the same power that created it would abolish it." "Civis" then declared that "notwithstanding all the town meetings have voted or other persons have said or wrote to the contrary, the commissions of the Courts of Admiralty in America of one kind or another were the same as they had always been from the time of their first establishment in America and were not furnished with any new or unusual powers."¹ The clamor against the vice-admiralty courts that had lately been created in America, he claimed, proceeded from hostility to certain acts of parliament which were very obnoxious to the people, who would avoid them, if possible. There was a popular feeling, in other words, that if the prosecution for breaches of these unpopular laws took place in courts of common law there would be a better chance of evading them, "the reason for their thinking so may easily be guessed." If the offenders were sure that the prosecutions would be carried through in the common law court, they would not be very anxious to which of the courts they were brought. While trials by jury were an eligible mode of trial, yet "Civis" desired to point out that the people were not necessarily devoted to them; for there had never been any objections to having captures in time of war determined in a court of admiralty.²

But "Russel" was not to be outdone or driven from his ground. In a third attack he maintained steadily the proposition that Judge Ingersoll had jurisdiction to try

persons and causes which in England would be tried in a court of common law and further that there was no power in the province to stay proceedings in a court of admiralty. That the jurisdiction of the court of admiralty in England was as extensive as that of the new courts in America even Ingersoll, himself, according to "Russel," could no longer assert. From this judge's own confession, under signature of "Civis," the courts of vice-admiralty were created to enforce certain obnoxious acts of parliament. "Are you not," the writer then asked, "a mere creature of the Crown appointed to execute the laws that your country is anxiously struggling to get rid of? Nothing can be more absurd," he continued, "than the supposition that a man has any real love for his country who accepts a place which lays him under the official obligation of acting contrary to its interests. . . . Are you not, therefore, a dangerous judge? . . . Will it not do you honor to throw up your commission immediately?"

This series of attacks and replies was concluded by a semi-editorial reply to "Russel" in the March 30 edition of the *Pennsylvania Journal*. In a review of the arguments pro and con it is clear that the main criticisms of "Russel" against the court of vice-admiralty remained unshaken throughout the controversy. That Ingersoll was a dependent judge; that his salary, when regular sources would not suffice, must be supplied by the crown; that the home government, under the circumstances, would be likely to support him in any interpretation that he might be disposed to put upon the limits of his jurisdiction; that he certainly could determine causes that in England were always decided in courts of common law; were contentions that "Civis" did not succeed in

overturning, although with great skill he attempted to shift the basis of controversy. However, there were not lacking those in America who were disposed to justify the British government in the measures that it had taken to develop the jurisdiction of the vice-admiralty courts in America to the widest limits. The situation was succinctly summed up by Joseph Reed, a leading Philadelphia lawyer possessed of a large point of view, who later became president of the provincial council of Pennsylvania. Writing to the Earl of Dartmouth, who was secretary for the colonies,¹ Reed declared, "It is to be wished that the mode of trying revenue causes in this country were more agreeable to the English practice and the English Constitution, but at the same time, I acknowledge that, at present, there seems little probability of justice being done to the Crown by an American jury." Although devoted to American interests, he could not but admit that "the due observation of the laws of trade is so essential to the interests of the mother country that nothing tending to weaken or enforce them is beneath notice."² He was convinced that a project was unfolding to distress and harass the vice-admiralty courts so as to make all the offices in them "odious and disgraceful"; the attacks, moreover, were leveled against the new courts, while the old courts of vice-admiralty passed unnoticed "though there is no difference as to the objects of their jurisdiction and the extent of it is not novel." The reason for this, according to Reed, was on account of the personnel of the officers of these courts. The judges had made themselves obnoxious by their conduct at the time of the

Stamp Act. As to the under officers of these courts, "absurd conduct" had been shown in their appointment; for the holders of these posts were allowed to live in England and the commissioners of customs at Boston appointed their deputies. As a result, when Judge Ingersoll opened his court every officer in it was some "underling" of the custom house: the register of the court was customs gauger and surveyor, and the court marshal was one of the principal tide waiters.¹ This could only have one effect upon the public mind, for these vice-admiralty officials were frequently interested as customs officials, by reason of their fees, in cases which were carried before the court. Indeed, Reed asserts that Ingersoll had in his presence lamented his "unfortunate situation" in this respect.²

The confirmed attitude of mind of a majority of Americans in 1774 regarding the existence of the vice-admiralty courts was without doubt expressed by "America Solon," who, in a communication to the *Connecticut Gazette and Universal Intelligencer*, published in New London, wrote: "I could at this time call the attention of my countrymen to a most glaring and capital instance of tyranny which ought to make every villain blush and every free mind kindle with indignation against the abandoned herd of tyrants and their Tools, viz. the *hydra* Courts of Admiralty. By the commission of a judge of one of these courts . . . it appears they were calculated not only to annul the American charter, but *Magna Charta*, and to overturn the whole constitution of the nation. . . . These unconstitutional and most abominable Courts of Admiralty, are a clear demonstration, that a

system of tyranny has been formed to enslave the Americans."¹

Extremely unpopular as was undoubtedly the tribunal over which Ingersoll presided, it yet managed to survive after a fashion, in the midst of this hostility, until the outbreak of the Revolution. The presence of these special courts of vice-admiralty was held to be, it is clear, one of the most glaring evidences, presented to the excited imagination of people, of an intention on the part of the home government to rule the colonies, if need be, through a highly developed system of administrative coercion.

CHAPTER XI

INGERSOLL AND THE SUSQUEHANNA DIS- PUTE. THE SUBMERGING OF THE INGERSOLL GROUP AT NEW HAVEN

CONSERVATIVE New Haven, as was previously pointed out, had learned the ways of radicalism. This had come hand in hand with the growing importance of the mercantile and shipping interests dominated by those, among whom was Benedict Arnold, who were known among the ancient settler families as the "interlopers." From 1764 on this group had so thoroughly inculcated among the people hostility against those new measures of the British government which had to do with the colonies, that it found itself in the possession of a dangerous weapon which it used on more than one occasion. That weapon was the mob spirit.

How far the contempt of law and order had gone among the "liberty" element in this community, before the outbreak of the Revolution, is evidenced by a report of Hugh Finlay, made in connection with his official survey of the post roads in North America. In November, 1773, he went to New Haven to investigate conditions, and put the deputy of the local post office, Christopher Kirby, under a sharp examination. Kirby especially lamented the fact that he could not enforce the acts of parliament. He declared that if every vessel arriving at the port were to send the mail which it carried to the office, the income would be doubled and the revenue increased in other

respects. But he affirmed that when he sent to the shipmasters for the letters, the latter were accustomed "to insult and threaten his messengers"; he also complained that the "portmanteau" containing the mail seldom came locked, with the consequence that the post riders "stuff them with bundles of shoes, stockings, canisters, money, or anything they get to carry, which tears the Portmanteau and rubs the letters to pieces." Moreover, Kirby said that these postmen were accustomed to "ride off the road to deliver summons and buy oxen on commission and drive them while they have his Majesty's mail under their care."

However, it should be kept in mind that the majority of the enfranchised group—a decided minority of the inhabitants of the town—and especially those who dominated the freemen's meetings and the meetings of the town were of a decidedly cautious and slow-moving temper, as men of landed property are always apt to be; and it was with this group that Jared Ingersoll, as the old recognized leader of the conservatives, although officially and professionally identified with Philadelphia after the spring of 1771, continued, until the outbreak of hostilities with the mother country, to exercise a powerful influence. This was made possible by reason of the protracted visits he made each year to New Haven during the summer recess of the court over which he presided. In fact, he was fated to be intimately involved as a foremost figure in practically every crisis that confronted Connecticut from 1760 down to the date of his death in 1781.

Hardly had the excitement caused by the Townshend revenue acts died down than Connecticut was thrown

into a perfect whirlwind of controversy over the Susquehanna question. This had arisen out of the organization in 1753 of the famous Susquehanna Company by parties living in and about Windham, for the purpose of occupying lands in the Wyoming Valley country in northern Pennsylvania.¹ The enterprise, in itself, would have been of the most laudable character had it not as its leading motive the design of taking from out of the jurisdiction of the government of Pennsylvania these lands and of denying the proprietary claims to them of the Penn family, in spite of the fact that they were clearly included within the bounds of Pennsylvania by the royal patent granted to William Penn in the year 1681. But the Susquehanna Company proceeded to put forward the charter of 1662 with its indefinite sea-to-sea grant, contending that no later royal patent could in any way impair the validity of that document. As one writer expressed it, the territory lying within the bounds of the charter claims was "a very fine Tract of Land, comprehending the present inhabited Part of Connecticut, a great Part of the Province of New York, the whole of the Province of East and West Jersies; the greater part of the Province of Pennsylvania! . . . being above a degree in width North and South in the West part and about 5000 miles in Length, East and West."²

The weakness of the Connecticut claim manifestly lay in the fact that the Connecticut authorities acquiesced, at the time, in the establishment by royal authority of those governments within what it later claimed were the limits of its western extension; in 1680, in answer to the

queries of the Board of Trade, the statement was returned by the colony that it was bounded on the west by the province of New York;¹ no one in Connecticut in 1681 dreamed of questioning the validity of the grant of Pennsylvania to William Penn and his heirs. The claim also displayed a fatal inconsistency in that while it was made for the northern two-fifths of Pennsylvania, there was no demand for any part of the province of New York that intervened between Pennsylvania and Connecticut. The movement grew out of the unsatisfied land hunger of the population of Connecticut and is a striking episode in the truly romantic history of the exploitation of the domain of the North American continent; a history unfortunately replete with acts transcending, or in overt defiance of, laws, treaties, and prescriptive rights.

In 1755 the Susquehanna Company, with a membership of eight hundred and fifty, succeeded in getting the endorsement of their enterprise by the governor and assembly, in a formal resolution.² In 1758 Ingersoll, in accepting the London agency, was called upon by the company to exert himself in its behalf. He carried to England a copy of the resolution of the assembly, canvassed the views of those in authority with regard to the possibility of vitalizing the dormant claims of Connecticut to the Pennsylvania lands, and in 1761, upon his return to America, wrote to the officers of the company fully and frankly regarding the issue. As everything he

had to communicate "wore a discouraging aspect," he advised them to give up a project "which in the end must prove abortive."¹

Not discouraged by this report or by the proclamation of Lieutenant Governor Hamilton of Pennsylvania of February 20, 1761, warning "the persons settled at Wyoming off the Lands,"² the company, which had rapidly increased its membership, determined to send to England as its special agent, Eliphalet Dyer; and at a meeting in Hartford, held early in 1762, it is interesting to note that Jared Ingersoll was asked to serve as a member of the committee to draw up the case which Dyer was to present.³ It would appear that Ingersoll, on that occasion, counseled strongly against the prosecution of this endeavor. Joseph Chew of New London, in writing to him later, could not refrain from saying: "Your Behaviour at Hartford has answered my Expectations. I have on all occasions asserted you were two Honnest and had two great a regard for truth than to say one thing and mean another—in short that you would not Cringe, Twist and Turn Twenty ways to get into any post the Colony had to give."⁴ That Ingersoll's position on the matter won adherents among those more conservative people of the colony who feared the consequence of this daring attempt to overthrow the Pennsylvania patent of over eighty years' standing, is shown by the fact that on June 8 Governor Fitch issued a proclamation against the Susquehanna Company, "warning all Persons, Inhabitants of this Colony to forbear making entries on

said Lands.”¹ Soon after the Fitch proclamation, Lieutenant Governor Hamilton wrote to Ingersoll, expressing his pleasure at the action of the Connecticut government and pointing out how it would be necessary to oppose the attempt of forcible settlement by all the means within his power.² Moreover, the following January, the Earl of Egremont, secretary of state for the southern department, who had been informed of the proceedings of the company, wrote to the Connecticut governor, saying that “the King has commanded me to express to you His surprise at this Behaviour as well as His Displeasure to find that any of his subjects . . . should persist in an undertaking of this Nature.”³

The Dyer mission to England was without results. In fact, during the next four years the Wyoming Valley project, while by no means dead, was subordinated to the issues that arose out of the Sugar Act of 1764, and the Stamp Act of 1765. It was not until 1768 that the company was prepared to push aggressively its plans, in the face of all opposition.⁴ In that year a small body of set-

tlers was sent to the lands in question, under Captain Zebalon Butler and the famous Major Durkee, who led the five hundred Sons of Liberty against Ingersoll in 1765. The proprietors, in turn, sent men to resist the intruders and after some fighting of rather a bloodless kind, known as the first Pennamite War, in which an old four-pounder cannon played a decisive rôle, the "Yankees" were expelled; in fact, the Connecticut men were driven from the country six times by Ogden, Penn's lieutenant. In June, 1769, Governor Pitkin of Connecticut published a proclamation warning the people of the colony against participating in these attempts at settlements. Nothing daunted at this, in support of the movement Dyer and his associates went into that county in July, actually stopping at Philadelphia on the way, and in September great efforts were made to sell the lands; John Parker, Jr., of East Windsor offering for sale 20,000 acres, through the columns of the *Connecticut Courant*. In fact, such an impetus was given to the enterprise that by 1770 the company had succeeded in erecting forts and in repelling the forces which the proprietary government sent against them. necticut agent in London, wrote to Governor Trumbull about this time, strongly advising against the colony appearing before the Privy Council with a demand for these lands, as he was of the opinion that the establishment of the New York line would be considered a "derelection" of the Connecticut western claims.¹

The attitude of the home government, while these things were transpiring, was one of uncertainty. But on June 7, 1771, the Privy Council approved a report of its committee, which had taken into consideration a petition of Thomas and Richard Penn against the forcible seizure of their lands by the inhabitants of Connecticut; this report was to the effect that "this forceable intrusion is a matter entirely within the jurisdiction of that province and that it is unnecessary and improper for your Majesty to interpose your authority therein."²

In 1774 Connecticut took the next step in asserting its jurisdiction over the western lands by erecting the Susquehanna district into a Connecticut township under the name of Westmorland and deputies from it were invited to take seats in the assembly.¹ In turn, the Pennsylvania House of Assembly passed resolutions that the province use all of its power "to suppress acts of violence and illegal attempts to dispersing the peaceful inhabitants of this province." The indignant assembly went on to relate "that a number of persons emigrating from the Colony of Connecticut have, under a pretense of right to lands within the limits and boundaries of the royal grant to the proprietors of this province, without prosecuting their claim before His Majesty in Council, the only proper place of decision, in a riotous and tumultuous manner taken possession of a tract of country within the said known limits and boundaries and have held and still retain their said possession in a hostile manner to the great disturbance of the peace of the province."²

It was at this critical juncture that Ingersoll became the storm center of the controversy. During the summer of 1773, while he was at New Haven, there happened to fall into his hands a pamphlet which strongly favored the Connecticut claims. In this, he found mention of certain "ancient memorials" respecting the history and titles of the colony, "some of which were quite new" to him. This led him to investigate with great thoroughness the whole subject. As a result, he seems to have become more convinced than ever of the groundlessness of the Connecticut pretensions. The results of this investigation he drew up in the shape of a survey of the subject, a copy of which he handed to a member of the Susquehanna Company. However, as it was not his idea to become once again personally involved in the quarrel between the two colonies, he refrained from publishing broadcast his views.

Although Ingersoll claimed to have said nothing to anyone in Pennsylvania about this work in which he had been engaged, the report spread abroad that he had written a treatise favorable to the Penns. Thereupon Provost Smith of the College of Pennsylvania, and others, waited upon him with a request to see the manuscript. "I was told," he declared, "that the Colony's claim to the western lands was now become a serious affair to this province—that every material paper of a public nature ought to be known to both parties and that I ought to consider myself in my present situation as equally the friend of both."¹ As a result, he was led, after declining at first to do so, to deliver over for publication not only the survey but also the corroborative documents which he had collected in Connecticut. By means of this material,

Provost Smith prepared and published anonymously, in January, 1774, his pamphlet, *An Examination of the Connecticut claim to Lands in Pennsylvania*,¹ in connection with which he printed as an appendix the body of papers, twenty-seven in all, that Ingersoll had collected. His dependence upon these documents for presenting the Pennsylvania case is shown by the fact that every important assertion he made in the text was reënforced by a sidenote reference to them. This pamphlet was distributed broadcast, especially in Connecticut, and was undoubtedly one of the most decisive factors in the ultimate vindication of the rights of Pennsylvania to the limits provided in her patent.²

The appearance of this crushing reply to the Connecticut pretensions raised a storm of denunciation against Ingersoll, who was accused of being the author. One of the most bitter of the attacks against him was from the pen of an anonymous writer signing himself "Brutus Americanus," in the local New London paper. He rather inconsistently accused Ingersoll of cowardly conduct for fearing to publish under his own name the article in question that Provost Smith, as a matter of fact, had prepared. "Now I am not about to blame you," he wrote with biting sarcasm, "for writing or acting on the side inimical to this Colony—were it the first instance I might possibly expostulate with you, but somehow it is not very strange nor very disagreeable to see men act with uniformity of character. Though I confess, I could not so easily pass over your thus acting under cover were it not that I know you to be one of the most timorous men alive and from the remembrance of past scenes, and at

least a possible anticipation of future, may often be and are I am told 'most tremblingly alive all o'er.'"¹

As an answer to this, Ingersoll made a dignified statement of his position, setting forth at length the history of his connection with the dispute; this he published in the *Connecticut Journal* at New Haven. "I will leave time to discover," he declared, "who have been the Colony's best friends, those who have urged or those who have dissuaded from these measures. A defeat would be very detrimental but a victory must be absolute ruin to the Colony, at least I think so." To the charge of working in the interest of Pennsylvania, he answered, "I am not in the secret of the Council of this province nor am I actuated by any lucrative or sinister views." He then skillfully turned the tables upon those who were upbraiding him for furnishing all possible light upon this serious matter. "And will any of these people openly avow to the world that they would willingly, if they could, attain a cause of this magnitude and complexion by the suppression of records which from the circumstances their antagonists could not come at?"²

This reply called forth a retort from Ingersoll's old New Haven acquaintance, Roger Sherman. He took up Ingersoll's statement, "A defeat will be very detrimental but a victory must be absolute ruin." "But he gives no reason," declared Sherman, "for his opinions and can his bare assertions make the people of this Colony who are a company of farmers believe that to be quieted in their claims to a large tract of land would ruin them? I know some gentlemen," he continued in a satirical vein, "who love to monopolize wealth and power, think it best for lands to be in a few hands and that the common people should be their tenants, but it will not be easy to persuade

the people of this colony who knew the value of freedom and of enjoying fee-simple estates that it would be best for them to give up the lands acquired for them by their ancestors for the privilege of enjoying the same lands as tenants, under the proprietors of Pennsylvania."¹

However, the conviction seems to have taken hold of the majority of the conservatively inclined Connecticut people, who paid attention to the discussions of such men as Ingersoll and Provost Smith, that the colony was committing itself to a policy which could not succeed and that would, as a result, unhappily and deeply involve not only the Susquehanna speculators but the generality of the people in Connecticut also. Not long after the publication of Ingersoll's reply to "Brutus" the New Haven town meeting appointed a committee to meet with other towns to be similarly represented at Middletown for the purpose of drawing up a remonstrance against the prosecution of the claims to the western lands. The meeting was held, and, on its return, the committee reported that twenty-two towns were represented at the gathering and that as a result of their deliberations a petition had been prepared in remonstrance "against certain doings of the late Assembly and measures taken in favor of the Susquehanna Company."² When the question came before the

The petition recited the fact that the general assembly had been brought to act in favor of the western claims through the influence of deputies who were heavily involved financially in the success of the enterprise. It was apprehended that great numbers of the people of the colony, "taught as they are from their youth to place the highest Confidence in the Legislature will be by the Acts of the last Assembly tempted to transport themselves and their effects and settle on said Lands, pending the Controversy about

town meeting whether or not New Haven should indorse or reject the remonstrances there were polled one hundred and two votes in favor of it as against ninety-nine votes cast by the Sherman group. This is interesting testimony as to the comparative strength of the conservative and radical elements in community at this time, for, as Dr. Benjamin Gale pointed out to Ingersoll, it seems to have been true that the Susquehanna faction in the colony was almost identical with the "liberty" group.¹

In spite of the Middletown remonstrances, the general assembly, still dominated by the Susquehanna interests, maintained the western claims; in 1775 the district of Westmorland was established and was provided with a court of probate. Over three thousand people migrated to this region, the men were enrolled as members of the Twenty-fourth Connecticut regiment; a powder mill was authorized by the assembly to be established there, and it appeared as though the settlement were permanently established. However, in 1778 there took place the Wyoming Valley massacre and "the Connecticut pos-

sessions vanished into thin air." In 1782 a court of arbitration, under the confederation, was appointed to settle the dispute between the two states. After a hearing covering forty-two days, a unanimous decision was rendered in favor of the contentions of Pennsylvania.¹

While the conservatives and radicals of Connecticut were contending in the spring of 1774 over the Susquehanna policy, there arrived the news that the British ministry, in order to bring Massachusetts to submission, on account of the tea riot of December 16, 1773, had closed the port of Boston. The Massachusetts committee of correspondence, hastily summoned together, addressed a letter to the different colonies, calling upon them to suspend all trade with Great Britain, on the ground that Boston was suffering for the common cause; the next day the Boston town meeting addressed a similar appeal to the other colonial ports and assured them that if by a policy of non-intercourse, "the Act for Blocking up this Harbor be repealed, the same will prove the salvation of North America and her Liberties."

A town meeting was called at New Haven, May 23, to consider the Boston letter. As a result, it was voted to defend to the utmost "the liberty and immunities of British America."² A standing committee was also appointed to keep up a correspondence with other towns. However, it should be noted as a significant fact that the one named chairman of the committee was none other than Ingersoll's friend and supporter, Joshua Chandler, an ultra-conservative, who at the outbreak of the war became one of the most uncompromising Tories in Connecti-

cut.¹ New Haven also sent him to the general assembly, both in 1774 and in 1775, and in December, 1774, installed him as a selectman of the town. In fact, it was not until November, 1775, that public sentiment finally forced the town authorities to place him under arrest and in confinement on parole at his home in North Haven.

On May 27, the Virginia House of Burgesses, meeting unofficially at the Raleigh Tavern, adopted resolutions in favor of an annual congress of all the colonies. By June 20 New Haven was ready to take action regarding this proposal and gave it a hearty endorsement. As during the Stamp Act crisis, the controlling authority of the colony was fast passing into the hands of an extra-constitutional organ of government; in place of the officers of the Sons of Liberty of the '60's, it was now the central committee of correspondence. Not only was it to this body that the New Haven town meeting reported its approval of the plan for a congress, but it was to this body that the Connecticut deputies deferred when finally the colony come to the question of choosing the delegates.

Ingersoll apparently exerted himself both in New Haven and in New York, as well as in Philadelphia, to prevent the sending of delegates to the congress. A New York correspondent to the *Pennsylvania Journal* has the following to say about his activities: "It will no doubt give you pleasure to be assured that this city will be firm in the cause of liberty and will be ready to come into any measure the colonies in general shall adopt. J. In——l from your place has taken great pains here to prevent anything being done, by asserting to all with whom he conversed that they might be assured Philadelphia would do nothing and in Connecticut he has been doing the same."²

In fact, at the very time that the above item was printed, Ingersoll was in New Haven trying to enhearten the ranks of the conservatives. The news of this reached the eastern section of the colony, with the result that early in July he received from New London a most ominous and menacing letter. "After your solemn assurance in Sept. 1765," declared the unknown writer, "confirmed by oath that you would no more take any Post inimical to the country which gave you birth, which nourished you, and raised you by her favors to undeserved honours, we had right to expect you would at least not have taken an active part in the ruin of your country and its Liberties; but when we find you openly avowing and publishing principles subversive of our rights and vindicating the arbitrary measures of a corrupt British Ministry we conclude honor and conscience have left your breast and you are become a determined enemy to your country and as such ought to be cast out from among us.

"We inform you that you have only ten days from the receipt of this to put your house in order and if you do not leave this Colony by that time depend proper care will be taken to remove you to a place fitted for your reception where all such villains and traitors ought to be.

"This is the voice of multitudes who will not suffer the free air of this Colony to be polluted by your poisonous breath—to prevent trouble you'l notice your departure in the N. Haven paper—you may depend if you do

upon the proposed congress in no very friendly light. "I was called upon to attend the proposed Congress as one of the Delegates from the Colony, my previous engagements were such as to render it highly inconvenient for me to undertake it and I declined the office, *inter nos*, I did not think it advisable either on my own acct or, on account of the Colony to make one of that Assembly, though it is very unpopular at present to doubt in any measure either the legality, or, expediency of the measure." not comply directly, you will hear from the enraged Inhabitants."¹

Instead, however, of taking fright and leaving the colony as ordered, Ingersoll, upon receipt of the letter, made a copy of it, which he enclosed in a letter to Governor Trumbull.² He well knew that the colony could ill afford to allow an outrage to be committed upon one who stood so high in the British colonial administrative system and apparently paid little attention to the threat, for he continued in residence at New Haven until early in the fall.

Although, as it has been stated, Ingersoll was unable to keep New Haven from taking a stand in favor of a Continental Congress, it seems that his presence there during the summer of 1774 prevented any display of radicalism on the part of the people. Indeed, it is singular how powerful an influence he seems to have had in the affairs of this community during this period. This is particularly well illustrated by the control that he and his friends exercised over the people on August 16,

when the Boston delegates to the congress arrived in the town en route to Philadelphia. They were met at North Haven "by a grand parade" and escorted into New Haven in the midst of the firing of cannon and the ringing of bells. John Adams, however, writing about the incident, declared that he found out from his landlord while at New Haven, that the parade "was a sudden proposal in order to divert the populace from erecting a liberty pole," and that "Ingersoll's friends were at the bottom of it."¹ Adams also has left testimony as to the hospitable attitude of the Ingersoll group. "Nothing shows to me the spirit of the town of New Haven in a stronger light," he wrote, "than the politeness of Mr. Ingersoll, Judge of Admiralty for the Pennsylvania Middle District, who came over with his neighbors this evening and made his compliments very respectfully to Tom. Cushing, Sam. Adams, John Adams and Bob Paine."²

In spite of the fact that Ingersoll had been the recipient of a threatening letter just referred to, no attempt seems ever to have been made during the revolutionary crisis to subject him to personal violence. It is really surprising, considering all the circumstances, that he was able to escape, during the troublous times that now came to America, with so little molestation on the part of the radical element, when other loyalists in Connecticut en-

joyed no such immunity.¹ For the days of real persecution had come, and the truth of this must have been deeply impressed upon him in the light, especially, of the treatment meted out to his cousin, David Ingersoll, a graduate of Yale College in the class of 1761, who had settled at Great Barrington in Berkshire County, Massachusetts, as a lawyer, and who, from 1770 to 1774, had represented his town in the general assembly. The Berkshire mob, after driving the judges of the court of common pleas from their seats and after having shut up the court house in 1774, turned upon Ingersoll, who had signed the complimentary address to Governor Hutchinson early in that year. Not only was his property laid waste but he himself was seized and carried over into Litchfield County in Connecticut, where, among other outrages inflicted upon him, before his release, not the least was a coat of tar and feathers. The hounded man thereupon determined to move to England.² In sailing for there, late in 1774, he carried with him an interesting letter of introduction written by Captain Evelyn of the Kings Own Regiment, stationed in Massachusetts, who, while referring to the actions of the mob within that colony, gave his opinion of the populace in no uncertain terms. "I firmly believe," he wrote, "that so execrable a set of sanctified villains never before disgraced the human species."³ As for the wretched David Ingersoll, in April, 1776, the British government came to his assist-

ance with a grant of £100 in compensation of the losses that he had sustained, "on account of his Majesty's government."¹

Upon his return to Philadelphia early in the fall of 1774, Jared Ingersoll found the Continental Congress in session. While it is not probable that he made any further open attempts to work against the forces of radicalism, yet the attitude he had been displaying down to that time toward public issues did not escape unfavorable comment; this feeling against him on the part of political opponents found an echo in a letter penned by Silas Deane of Wethersfield, one of the Connecticut delegates. "In conversation last evening at the coffee house," he wrote, "with gentlemen of the first character in the province and of Mr. Ingersoll's acquaintance, I find his conduct very much condemned in this city even by Prerogative men themselves or those who might be titled such."²

One of the principal achievements of the congress was the famous "Association," according to which, among other things, it was agreed that after December 1, 1774, nothing should be imported from Great Britain; that after March 1, 1775, no East India tea should be purchased, and no article should be used which was on the prohibited list; that after September 10, 1775, no goods should be exported to Great Britain. The Association was ratified at the October session of the Connecticut

general assembly and on November 14 New Haven, in conformity with the general practice in the colony, as well as elsewhere, selected a committee of thirty-one to see that no one should violate the terms of the agreement.¹ On account of dissatisfaction with the unequal distribution of the membership of the committee among the different parishes, it was enlarged to include fifty-one members.² Radicalism was clearly on top. In January, 1775, a new military organization was established; in February, as a token of her sympathy, the town loaded a ship with all manner of supplies for the needy at Boston, and in the following month a still more advanced step was taken by voting in town meeting that "It is the opinion of this Town that if any Inhabitant thereof shall Entertain any inhabitant of the towns of Ridgefield and Newtown, that opposed the acceptance of the doings of the Continental Congress he will be guilty of a Breach of the Association of said Congress." By April, according to one writer, the New Haven committee of inspection had "proceeded to very unwarrantable limits." "What! do you drink tea?" demanded one of its members of a non-conformer, who was probably Joshua Chandler, an ardent loyalist. "Take care what you do,

Mr. C—, for you are to know the committee commands the mob and can in an instance let them loose upon any man, who opposes their decree, and complete his destruction.”¹

What now had become of the Ingersoll group, so powerful the previous year in the councils of New Haven?

CHAPTER XII

OUTBREAK OF HOSTILITIES, NEW HAVEN PATRIOTS AND LOYALISTS. INGER- SOLL A PRISONER ON PAROLE. CONCLUSION

THE news of the battle of Lexington, which arrived at New Haven April 21, 1775, stirred the community profoundly. The result was that a town meeting was called at the "Middle Brick" Church to determine what action, if any, should be taken. It appears that the group which for years had followed more or less consistently the leadership of Jared Ingersoll lacked only one vote of defeating Roger Sherman, the choice of the radicals, for moderator,¹ and in spite of this, finally succeeded in getting not only the appointment of a committee of strong conservative tendencies to care for the town interests in this crisis, but also a decision against taking up arms, at least for the present, against the king. But the radicals were not to be outdone, for they had found a leader in the impetuous Benedict Arnold, captain of the local militia company, known as the Second Company of the Governor's Guards. Arnold called out his company and proposed that they should march to the aid of the Massachusetts Minute Men. About fifty volunteered. However, in order to equip themselves for the journey it was necessary to have ammunition. When requested to furnish this from the town supply, the New Haven authorities at first refused; not until Arnold had drawn his men up

before the tavern where the town fathers were deliberating and threatened to break down the door of the powder-house, unless the keys were delivered up, did the over-awed conservatives give way.¹

For months now after the Lexington alarm, there was comparative quiet in the town, although soldiers in goodly numbers were enlisted and sent on to Boston or into the Lake Champlain country.² Most of those in New Haven who were not in sympathy with the activities of this revolutionary program were discreetly keeping their peace and abiding quietly at home.³ But the case of

Abiathar Camp, Jr., shows that some, at least, felt deeply about the turn of affairs even if they did not act.

Abiathar, whose parents lived at New Haven, was a student at Yale College. He had, it seems, discussed freely and unwisely, among his fellows at the college, the pending issues. As a result, the members of his class appointed a committee to address to him a letter, "inquiring about his political principles, and asking him to clear up his character." His reply could hardly be called a dignified one: "New Haven, June 13, 1775: To the Hon. and Resp. Gentlemen of the Committee now residing at Yale College: May it please your honors, ham—ham—ham. Finis cum sistula popularum gig. A man without a head has no need of a wig." After this counterblast, a committee of the whole college met and prepared a statement against Camp. It was charged that he had stated before the beginning of hostilities that not only would he not stand by the doings of the Continental Congress but "that all those who did so or justified the destruction of tea at Boston were a pack of d—Rebels." He was further accused of saying that if he were at home and "the Liberty Pole Men should rise against the Administration, he would fight on the ministerial side till he had killed a number of the Rebels." He was thereupon advertised as an enemy to his country and his name as such was posted upon "the Hall Door" of the college.¹

To be able to determine more accurately who were for and against the cause of the colonies, the town meeting in September, 1775, unanimously voted in favor of the formation of an "Association" by the general assembly which should supplement the non-importation, non-ex-

portation, and non-consumption association already adopted at the request of the Continental Congress. By this plan, there were to be sent to the different Connecticut towns papers to be signed by all the inhabitants which would allow the friends of American freedom to be distinguished from its enemies.¹ The action of the town meeting would seem to indicate that while this body had surrendered to the popular influences there were nevertheless a good many living in the community who had not placed themselves on record as yet, as to their political principles. But, for the time, it seems that nothing further was done to draw the lines between the loyal and disloyal.

What thoroughly aroused the town to a sense of peril in its situation was the wanton bombarding and subsequent burning of the little unfortified seaport of Falmouth on the Maine coast by an English fleet in October. As a result steps were taken to guard against danger both from without and from within. Among other things, steps were taken at a town meeting, held November 6, to erect a beacon of warning on Indian Hill in East Haven, and to provide the means for receiving the earliest possible warning of the appearance of any hostile fleet in the sound; arrangements were made with Captain Isaac Sears of New York to establish "a mode of intelligence in case of any danger by way of New York"; it was ordered that a fort should be erected at Black Rock; an artillery company was organized, the citizens at large were summoned to military drill, Yale College library was turned into an armory and a committee of public safety with large and indefinite powers was appointed. Before adjourning the town meeting also

appointed a special committee, the members of which were empowered "to call before them all those who might be disposed to give aid to the enemy and who harbored unfriendly sentiments."¹

This committee, it appears, in the course of its duty called upon Richard Woodhull and the other local Sandemanians, who, after having given a tentative answer, as a reply to the question of their allegiance, forwarded a letter to the committee in which among other things they declared, "We hold ourselves bound in conscience to yield obedience to the commands of his Majesty, King George III, so far as to take up arms against New Haven or the United Colonies." According to the report of the committee, the Sandemanians went on further to state in the letter that "in avoiding a plain answer to so plain a question at a time when the town and country were disavowing their allegiance to the king and were going into open rebellion against God and the king was evidence to them that they were influenced in their first answer by fear of man and not of God."²

Nothing, apparently, was done to molest Woodhull and his friends in spite of their highly unsatisfactory reply. There probably was a feeling that these men in reality were not dangerous but were desirous of living peacefully with their fellows; the committee must also have realized that many at heart felt as the Sandemanians did. Once local persecution was started where would it end? New Haven, however, was soon to come into the limelight as a harrower of Tories.

It seems that Isaac Sears, referred to above, had taken up his abode in New Haven some months previous and had been most active in stirring up a martial spirit among the people. Sears was a native of Norwalk, Connecticut, but had gone to New York City to live and there had gained some reputation as a trader. At the time of the Stamp Act he had become zealous in the defense of the colonial claims and seems to have been especially active in organizing the Sons of Liberty, first in eastern Connecticut and later in New York. James Rivington, who in 1775 was the loyalist editor of the *New York Gazette*, it appears, had in September, 1765, lampooned Sears in a burlesque poem, entitled, "Loyal York," to celebrate the refusal of New York to send delegates to the Stamp Act Congress. The first verse of the doggerel runs as follows:

"And, so my good master, I find 'tis no joke,
For York has stepped forward and thrown off the yoke,
Of Congress, Committees and even King Sears
Who shows you good nature by showing his ears."¹

Sears never forgot the insult and seized the first opportunity to repay it. This opportunity came in 1775.

On November 20 he left New Haven, on horseback, with a party of bold spirits who were increased by recruits from other Connecticut towns until they numbered about one hundred. The riders first made their way to Westchester, New York, where they made prisoner three of the most prominent men of the town, who were reputed to be ardent Tories, the Rev. Samuel Seabury, Judge

Jonathan Fowler, and "Lord" Underhill.¹ The main body then proceeded to New York City to execute a still more daring plan. On November 23 they suddenly rode into the city with fixed bayonets and drew up in close order before the printing office of Rivington, whereupon a small detachment entered the building and after demolishing the printing press loaded the type into bags prepared for the purpose, offering to pay the astonished proprietor for the same, by "An order on Lord Dunmore," who, at Norfolk, Virginia, had recently made way with the outfit of a patriotic printer there. Sears and his men having accomplished this, rode slowly out of the city to the tune of Yankee Doodle, cheered by a "vast concourse of people assembled at the Coffee House Bridge."² The party, in returning to New Haven, not only brought along Rivington's type but the Tories that had been apprehended on the way.³

The feeling against Rivington among the people of the seaport of New York was reflected in an appeal, December, 1774, to Silas Deane, of the Connecticut committee of correspondence, on the part of the "Friends of Liberty" of that city to boycott both the *Gazette* and those who advertised in it. *Correspondence of Samuel Blachley Webb* (ed. by W. The importance of the incident, for the purpose of this study, is to show that erstwhile ultra-conservative New Haven, now under the inspiration of such leaders as Arnold and Sears, had become to all appearances most aggressively active in support of the revolt.

As for Jared Ingersoll, during the first two years of the war, he was well satisfied, by reason of the antagonism that he had aroused in Connecticut, to remain away from New Haven, continuing therefore to abide within the limits of the Quaker City. As soon as the revolutionary government assumed control in Philadelphia, upon the outbreak of hostilities, it was necessary, of course, for him to suspend the business of the vice-admiralty court for the middle colonies; but it should be understood that technically the court did not go out of existence until 1783, although there was no incumbent of the judgeship after the death of Ingersoll in 1781.¹ In spite of the sittings of the Continental Congress at Philadelphia, that place was by no means an uncomfortable one for those of loyalist leanings; men of conservative tendencies, such as John Dickinson, were placed in positions of responsibility; the Quakers "publicly dis-

avowed all *unwarrantable Combinations*'';¹ and when the committees of the several counties of Pennsylvania, early in 1775, met to consider the question of arming the province, it was found that this measure was opposed by so many people of weight and influence that it was dropped.² How tolerant men were there of loyalist opinions is shown by the fact that Galloway did not hesitate to declare in the Provincial Congress that Rivington, the ardent Tory editor of the *New York Gazette*, was an honor to his country.³ It is therefore not surprising that Ingersoll wrote in October, "I enjoy, thank Heaven, an undisturbed repose & have good reason to believe the same may Continue."⁴ But it should be observed that he was exceedingly circumspect and quiet now that the crisis had arrived. He confessed that after his experience with his "pretty little stamp office," he had become careful about writing letters;⁵ however, it is to be observed that he went so far on one occasion in writing to his nephew Jonathan, who was living, as has been noticed, in New Haven, as to counsel him that "in Case the Connecticut forces should be called forth against the Kings Troops, that you will not degrade yourself by going in a Character below that of a Colonel."⁶ While he was not clear whether New Haven would be a "proper asylum next summer for a Tory," he did not fail to inquire both regarding the

terms of the Connecticut loyalty test act¹ and the fate of the Westchester Tories who had been brought to New Haven by Sears and his followers. As to the alarm beacon, set up by the town on a near-by hill, he facetiously asked of his nephew "how far by the light of it you can discover a real patriot from a false?"²

As it became apparent that the country was destined to face the rigors of a long and bloody struggle, Mrs. Ingersoll, it seems, could no longer bear separation from the home ties of New Haven. It was, therefore, decided in the spring of 1776 that she should proceed to Connecticut; the house therefore that she and the judge had occupied in Philadelphia was given up and the furnishings, probably for precautionary reasons, were carted to Burlington, New Jersey, about twenty miles away from Philadelphia. The judge's desire to accompany Mrs. Ingersoll to New Haven in the family "chariot" found expression in a letter written some few weeks previous to her setting out, which also set forth his determination to do nothing that would hazard his various interests. "May I come & live at N. Haven or may I not?" he asked. "It is not very likely to me that I shall ever again officiate in the office I hold, but I think I shall by all means Choose to draw the Salary until I shall be able to part with it upon some Composition with Government.—by the late law of Connecticut a person, I think, forfeits his Estate by taking refuge on Board a Man of War.³ I think it must be rather hard for a Man who has an Estate in that Colony,

not to be allowed to live on it nor yet to leave it."¹ In spite of assurances given to him by Roger Sherman, Colonel Eliphalet Dyer, and others, that he might return to New Haven without difficulty, Ingersoll prudently chose to remain in Philadelphia. That he felt the growing isolation of his situation is evidenced by a line in one of his letters. He was now, he declared, "like a Saint of old, as a Pilgrim and Stranger in the Earth having no Abiding City."² Not until the fall of 1777 did Ingersoll return to New Haven,—when he arrived he was a prisoner on parole.

While in the name of liberty the New Haven "liberty" group took much satisfaction in rounding up prominent Tories, such as Rev. Samuel Seabury, the exultation of many of them was not unalloyed. They had gone into the struggle for freedom—freedom from all that seemed oppressive or onerous. To the chagrin of many of them the courts continued to grind away and the most "vociferous patriots" on various pretexts were rudely dragged before the bar of justice. Prosecutions for debt seem to have been especially frequent, even in a colony famed for its spirit of litigation. For, in spite of the war, numerous creditors were seeking payment of old debts, such, for example, as John Hotchkiss, who claimed to have among the people of New Haven several thousand pounds owing him and some of these obligations, he complained, had been neglected for ten or fifteen years, "an unremitting indulgence," as he called it. Very naturally, a cry was raised the moment that legal pressure was applied. Indeed, these exciting times did not offer an opportune moment for the settlement of accounts, when men were

especially liable to neglect personal affairs. But in vain, appeals—prepared by both “Rusticus” and “Legion”—were sent forth by means of the press “that law suits, which threaten to overwhelm the province be discontinued.”¹

If the courts were active in harassing financially embarrassed Sons of Liberty, those who refused to support the popular cause were not, on the other hand, entirely neglected. During the years 1775 and 1776 especially, the “Association” was evidently enforced rather effectively and offenders against it were disciplined. For example, in March, 1776, William Glen and Freeman Huse were convicted of buying tea and selling it at an extortionate price and also of refusing the paper currency of the colony. The offenders accordingly were “advertised” so that no patriot should have any further dealings or inter-

course with them;¹ whether the guilty purchasers of this high-priced tea were likewise suitably punished is not recorded. It is to be noted that Glen, soon after being "advertised," begged the pardon of the public for his offense.

While the town proceeded against such petty traders as Glen and Huse, it seemed more reluctant to take any steps against men of prominence who were reported to be disloyal. As a result, one Lamberton Smith and others of New Haven, in 1776, were impelled to complain to the general assembly against the disloyal practices of Ralph Isaacs and Captain Abiathar Camp, two of the leading New Haven loyalists. It was declared against Isaacs that he had sent "some fine black fish" to Governor Montford Browne² and "tea and other luxuries" to Governor William Franklin,³ who as Tory prisoners had been brought to Connecticut and were at that time confined at Middletown.⁴ Camp, according to Smith and his friends, had used his vessels in a suspicious manner and had gen-

erally shown disloyalty. As a result the two were declared by the assembly enemies of the state and imprisoned within the limits of Glastonbury.

In studying the revolutionary movement in a local way, it must not be forgotten that news of the military operations was continually coming to encourage or depress the public mind. With intense interest the tidings were received of the successful fighting about Boston, of the failure of the Canadian expedition and of the shifting of the struggle to the middle colonies, especially about New York. Although New Haven continued to contribute her quota of men and money, there was, nevertheless, a feeling abroad that the town was not as whole-souled as she might be in supporting the war against Great Britain. This was reflected in 1776 in a letter written by Joseph Webb of Wethersfield to Silas Deane. "Our people," declared Webb, "are afraid you adjourned to N. Haven. They do not think that N. Haven [h]as been Hearty eno[ugh] to deserve it."¹

Whether or not there was any basis for the charge of lukewarmness against New Haven in 1776, there nevertheless seems to be little doubt that during the spring of 1777 the patriotic fervor of the town sank to a low level. It is probably no exaggeration to say that every community in Connecticut, during the late months of 1776 and the earliest months of 1777, had searchings of heart after learning of the defeats at Long Island and White Plains, and the surrender of Forts Washington and Lee

on the Hudson, as well as of the exciting pursuit of Washington southward to the Delaware. The occupation of New York, so short a distance to the west, by the British and the news that New Jersey was returning to the king's allegiance, must have sounded very ominous. For it seemed logical that Connecticut would be the next colony to be overrun by the royal grenadiers. The conviction that the cause of independence, in spite of declarations and resolves, was doomed, took possession of the more timid. Even the general assembly could not escape the charge of weakening in its enthusiasm for American freedom. It is true that among other things the assembly called upon every male between the ages of sixteen and sixty, not otherwise exempted, to procure arms and enroll in a company "for an alarm list," yet when it came to exacting the oath of allegiance already provided for there was a strange hesitation. This oath had been prepared by the authority of the assembly during the fall of 1776; the act stated that all freemen should be enjoined to take a prescribed oath of fidelity and that after January 1, 1777, no person should execute any office or have the right to vote until he had taken the oath.¹ The assembly, however, at an adjourned meeting, held in November, in the midst of the general gloom of disaster, decided to suspend the operation of the law until April; and then in December, when the cause seemed still more hopeless, the act was repealed in its entirety.² The formal reason assigned for the repeal was that "the separatists could not in conscience subscribe to all the laws of the state (which would include those ecclesiastical) as was enjoined

by the oath."¹ Apparently, for the first time in their lives, many of the members of the general assembly had become profoundly impressed with the unfortunate situation of the separatists.²

However, there was a minority group in the assembly made up of ardent "liberty men," which was anxious to put everyone on record so that the friends of independence might be made known to all. These members prepared a new bill to meet the religious objections but it was vigorously and successfully opposed. According to an anonymous writer, signing himself "Plain Dealer," the majority took the ground that now was no time for such an act. "Our affairs are in a fluctuating, unsettled state—We know not what the event of War will be—We had better wait until the Articles of Confederation are agreed upon. When the war is over we can make one at our leisure that will give general satisfaction." "Plain Dealer" declared that translated into plain English the argument of the majority meant: "It is quite probable that we shall be conquered. General Howe is already in possession of New Jersey, and I expect he will be here next, and then those of us who have taken the test oath adjuring the authority of the King and swearing to support the independence of this State will lose our estates and it's five to one our heads also."³ Such men in the assembly as endorsed these views, according to this New Haven critic, could never be expected to push the war

vigorously, nor could they be depended upon to make decisions for the people of the state. "Seclude them from your councils," he appealed, "avoid them as you would a cockatrice den—they will desert your cause at the first approach of danger." What was the actual situation in New Haven and elsewhere in Connecticut? he asked. In reply, he affirmed that Tories who were freemen had as good a right to vote as other freemen. The consequence was that in some towns the Tory influence was such as to allow them to send to the general assembly, "Either men of their own Kidney, or at best half saved Whigs who in Council and everywhere else are as bad as Tories." He then concluded significantly, "And in our town they actually do send Tory representatives."¹

Both "A Freeman" and "Junius" used the local New Haven paper to express similar views. "I have long wanted," said the latter ironically, "to have stated to the public the very great advantage of that extreme timidity which has for some time actuated every movement of this state."² On the other hand, contributors, under the pseudonyms "M. M.," "Aristides," and "Medicus" vied with one another in castigating the one who had written the communication signed by "A Freeman." He was accused of wanting to get his New Haven friends into the legislature. "Medicus" even compared him to a mad dog.³

The situation certainly appeared so full of peril for the commonwealth that many only looked for an opportunity to make peace with the enemy and thereby secure themselves from the impending ruin. Not only is it clear

that large numbers of Connecticut people at this time "absconded" and fled to New York, but three of the most prominent men in the state, General Erastus Wolcott of East Windsor, William Hillhouse of New London, a member of the council of safety, and Thomas Seymour, a leading financier of the general assembly, were publicly accused of securing "protections" of General Howe in command of New York. General Wolcott was defended both by General Parsons and by the writer "Aristides." But in reply the editor of the *Connecticut Journal* said: "The character of Mr. Wolcott I have ever esteemed. Whether he has been unjustly aspersed or not I am ignorant. It is, however, certain that no person who opposes the existence of an oath of fidelity to his state can be head and heart a sincere friend of its interests."¹

It may be pointed out in this connection that General Parsons, the defender of General Wolcott, was himself in after years accused of inclining to the enemy in the year 1781 (see Justin Winsor, *Narrative and Critical History of America*, VI, 460). This charge is based upon General Sir Henry Clinton's "A Record of Private Intelligence" (edited by E. F. DeLancey and printed in the *Magazine of American History*, vols. X, XI, and XII), which contains a series of secret communications from the loyalist, William Heron of Redding, Connecticut. Whether or not these gentlemen really secured "protections" has never been determined. They continued in their offices and appeared to have the confidence of people rather generally in the state. That this latter fact might not argue necessarily in favor of their unswerving devotion to the idea of American independence is shown by the case of such men as William Heron of Redding, Connecticut, who, although in the assembly, "was an enemy to the Declaration of American Independency," and George Wyllys, who was secretary of the colony and later secretary of state. "It is a significant fact," writes Dr. Franklin B. Dexter, concerning Wyllys, "that, though his tenure of office was not interrupted at the Revolution, he was in active sympathy with the loyalist element."¹

While this conservative reaction was taking place in Connecticut, Jared Ingersoll was living in seclusion in Philadelphia. In fact, after the outbreak of the war almost nothing is known of his activities until the summer

of 1777. Early in 1776 he wrote of riding into the country and of stopping for an hour at the home of his loyalist friend, ex-Governor James Hamilton.¹ John Adams, attending the Continental Congress, found him the following year living at a family hotel, which was presided over by a buxom Mrs. Cheesman. It is of no little interest to note that the fiery Samuel Adams was also stopping there and that the two seemed to be living together on the best of terms. Indeed, the year 1777 was no time for baiting the Tory element. John Adams whimsically describes his cousin's situation:

"Mr. Adams has removed to Mrs. Cheesman's in Fourth Street, near the corner of Market Street, where he has a curious group of company consisting of characters, as opposite as North and South. Ingersoll, the stamp man and Judge of Admiralty; Sherman, an old Puritan, as honest as an angel and as firm in the cause of American Independence as Mount Atlas; and Col. Thornton, as droll and funny as Tristan Shandy. Between the fun of Thornton, the gravity of Sherman, the formal toryism of Ingersoll, Adams will have a curious life of it. The landlady too, who has buried four husbands, one tailor, two shoemakers and Gilbert Tenant, and still is ready for a fifth and still deserves him too, will add to the entertainment."²

In the summer of 1777 Ingersoll emerged from his obscurity. For, the early part of July the British fleet, loaded with soldiers, sailed from New York, and the Continental Congress anticipating that a blow might be delivered against Philadelphia resolved, on July 31, that it was expedient to arrest all late proprietary and crown

office holders, and all other disaffected persons in and near that city. In fulfillment of this policy, on August 4 a warrant was issued by the supreme executive council of Pennsylvania for the arrest of "certain persons."¹ According to this warrant, Judge Ingersoll was to be arrested and was thereupon to be sent "on his parole to Winchester in Virginia there to confine himself within six miles of that town or at his option to be sent to Hartford in Connecticut under like restrictions." However, this warrant was countermanded on August 8, when the supreme council sent to Ingersoll a request by its secretary that "from the present situation of affairs as well on your own account as from other considerations, it will be most proper for you to remain in this city for a few weeks and they [the council] recommend it to you to do so."² For about a month longer, therefore, the judge continued to reside in Philadelphia. However, early in September, when Howe's plan to capture the city was clearly evident, the decision was reached to rid it of the Tory element; in accordance with the determination the more aggressive loyalists were confined under guard in the Free Mason's Lodge,³ and later were transported to Staunton, Virginia; Ingersoll, on the contrary, and probably by reason of his intimate relations with such men of influence in revolutionary circles as Joseph Reed of Philadelphia, was allowed his freedom until September 4, when he was instructed to depart immediately for Connecticut in conformity with his parole.⁴ Arriving in this

state he was granted the privilege by the authorities of settling down once again at New Haven, where he and Mrs. Ingersoll reestablished themselves in their old home near the green.

Meanwhile young Jared, who was residing at the Inner Temple in London when the Revolution began, found his sympathies enlisted on the side of the colonies. "I am now suffering," he wrote to his cousin Jonathan, in August, 1775, "the most humiliating News of a Defeat of the Provincials by the King's Troops." Nevertheless, he was not prepared to sacrifice the family interests and apparently continued his residence in London, where his uncle David was a Tory refugee, until late in the spring of 1777. The latter part of February of that year he is found petitioning Lord North and the rest of the Commissioners of the Treasury, in behalf of his father, for two years' arrears of salary that became due October 17, 1776.² Sometime after this event it seems that he passed over to the Continent in order to secure a passage to America. In April, 1778, he wrote from

Calais to Silas Deane asking his "advice respecting a continued residence" at that place,¹ and at last succeeded in reaching America and joining his parents at New Haven in September of that year.²

In returning to New Haven, Judge Ingersoll by no means found himself in a hostile atmosphere—in spite of the fact that he was a declared political enemy. The general reaction that took place in Connecticut during the winter of 1776-1777 quite naturally operated with peculiar force at New Haven by reason of her traditions. The lukewarmness of the authorities of the town was repeatedly held up to criticism. In February, 1777, an "impeachment," signed by about thirty inhabitants, was presented to the selectmen, charging William McCracken, John Miles, Jr., Ralph Earle, and Nicholas Calahan with having positively declared "that they were friends of George III and would not take up arms against him and his troops." Calahan even declared, according to these protestators, that he would take arms for the crown. The town authorities were accused of ignoring not only this but the actions also of Joshua Chandler, Ingersoll's old friend, who was one of the most prominent freemen of the town, and who, as was previously stated, had represented the town in the general assembly in 1774 and in 1775, but had become a pronounced loyalist. Chandler, it seems, was summoned in March to appear before the authorities as a delinquent. He was charged not only with refusing to appear when summoned but also with threatening to go among those who had smallpox, and then in case the constable attempted to force him from

his home in North Haven, to go without changing his clothes with the idea of spreading the infection, which at that time was a serious menace to Connecticut.¹ Chandler, it would appear, was left unmolested at his home until his departure with the British troops the following year.

Another incident that took place the latter part of March, 1777, throws additional light upon the conservative attitude of the New Haven authorities. Three soldiers belonging to an artillery battalion stationed within the town, according to the account, "committed a riot" at the expense of Archibald and Elijah Austin, who were reputed to be unfriendly to the cause of American freedom. These soldiers were promptly ordered to be punished and, in order to escape imprisonment, they disappeared. This led to a public protest from their sympathizers on the ground that "the most trivial complaints against the Whigs are taken up by the authorities and vigorously carried into execution and no notice taken of enemies when complaints of the most flagrant breaches of the law . . . are exhibited."² In April, the *Connecticut Journal* was constrained to publish an indictment against a New Haven justice of the peace, whose name is not disclosed, for absolutely refusing, and that with impunity, to grant to one of Washington's cou-

riers,—carrying dispatches to Governor Cook and General Spencer at Providence,—a warrant to impress a horse in order to proceed on his journey.¹

For almost a year after the arrival of Ingersoll, in the fall of 1777, there is little to record respecting the affairs of the community which is other than prosaic and unromantic in the extreme. The writhing of the people in their efforts to rid themselves of the pressure of taxation is the one thing that is reflected in almost every page of the annals of the town during the year 1778;² the revenue features, alone, among the proposed Articles of Confederation could awaken discussion in town meeting.³ The members of the general assembly were loudly accused of supporting methods of taxation for personal advantage, the press was full of bitter complaint and the New Haven freemen, after choosing deputies, gave them “particular instructions” regarding the manner in which they should vote on the financial issues in order to remedy a situation where “poor men with large families paid greater taxes than some of the most affluent families” and as a result would “soon be obliged to sell their estates and become tenants of their rich neighbors; thus one main part of that slavery against which the present war was professedly undertaken will be established among us.”⁴ It was even maintained that this inequitable financial drain was ruining more than one-third of the families of the state.⁵

Yet with all the discontent, New Haven, by the spring of 1778, had recovered a good deal of its zeal for the cause of American independence which had been at so low an ebb, especially during the winter and spring of 1777. The news of Burgoyne's surrender at Saratoga, late in the fall of that year, naturally inspired the doubting, lagging ones. In March, 1778, there was organized "by a large number of respectable inhabitants" a society "for the promotion of friendship and unanimity, in order to strengthen the hands of the civil authority in the execution of the laws; and to detect and frustrate the designs of enemies in their midst";¹ in April, when the news came of the recognition of the independence of America by France, the town gave itself over to rejoicing, the bells were rung, the "respectable inhabitants" met for a big dinner, and people generally gathered together to drink "thirteen toasts";² while in May, upon his arrival home, Major General Arnold was met on the road by continental and militia officers and the cadet company, as well as by a number of the "respectable inhabitants," to testify their esteem, and upon entering the town he was greeted by a salute from thirteen cannon.³

On the other hand, it is worthy of notice that Jared Ingersoll, in October, was, it seems, allowed to entertain at his home ex-Governor William Franklin⁴ and other

prisoners who were on their way to be exchanged.¹ On this occasion Ingersoll made out a writ of attorney empowering his old friend, Richard Jackson, and James Brown, a banker, who also was living in London, to act as his agents and to collect his salary as judge of vice-admiralty. Franklin and one Joseph Webb signed the writ as witnesses and upon the former's arrival in New York he took care to see that it was properly recorded.²

As was previously noticed, the younger Jared had reached his home in New Haven in September and was stopping with his parents, when in December, Joseph Reed, president of the supreme executive council of Pennsylvania, wrote to Judge Ingersoll, his "ancient and valued friend," in reply to a communication from the latter. In this letter Reed declared that his election to office had left a vacancy in Philadelphia to be filled by some gentleman who would consult the interests of his clients and upon whom he could depend for that assistance which a young man of parts could give to one in his station. He also went on to make the interesting remark that "Our lawyers here, of any considerable abilities, are all, as I may say, in one interest, and not the popular one."³ Reed, therefore, bade the young man hasten to Philadelphia, promising that he would receive "every assistance and advantage . . . which his merit and my sincere esteem for him will justly claim." Needless to say, young Ingersoll, who was now twenty-nine years of age and well qualified to undertake the work in hand,

accepted the flattering offer and it was not long before he had achieved great eminence at the Philadelphia bar.¹

The war had been going on now for three years, and New Haven had been left in undisturbed peace. The fear of invasion subsided as time went on. During the dark hours of 1777 little real interest had been taken in the plans that previously had been laid for repelling the British, and it is probable that little resistance would have been made. Apparently, even the fort at Black Rock, with its cannon, was left for a time in a deserted, neglected condition. However, the latter part of 1777 the town meeting plucked up sufficient energy to vote that ten men be hired, six for the purpose of taking care of the fort, four to look after the cannon and other military equipment "in the town Platt," until the assembly should furnish guards for these tasks;² in the spring of 1778 additional measures were taken to provide for the security of the town.³ In spite of this, New Haven was in no position to sustain the attack which came at last in the month of July, 1779.

On the morning of the fifth of that month, a British fleet, consisting of some forty-eight vessels, including transports and tenders, appeared off the coast and came to anchor close to the shore line of West Haven. This armada was under the command of Sir George Collier

and carried three thousand troops under Major General Tryon. It would seem that the purpose of the visit was to attempt to win the town back to the king's allegiance, for reports had been repeatedly carried to the British commanders respecting the pronounced loyalist leanings of many of the people. Clinton, in his instructions to Tryon, had declared "the country is populous and there are many friends there."¹ In conformity with this plan an address to the people of New Haven was drawn up and printed. "We offer you," ran the declaration, "a refuge against the distress which you universally acknowledge broods with increasing and intolerable weight over your country. . . . Leaving you to consult with each other upon this invitation, we do now declare that whoever shall be found and remain in peace at his usual place of residence shall be shielded from any insult either to his person or his property."²

Needless to say, the town was thrown into great confusion at the sight of the British ships. Men were confronted with the problem of making a decision as to which side to support; many in the dilemma remained in a state of total indecision. About five o'clock in the morning boats laden with troops from the ships put off to West Haven and it was not long until some 1500 soldiers, under the command of Brigadier General Garth, began their march around the cove in the direction of the town by way of the Milford road. "All then knew our Fate," wrote President Stiles of Yale College, a witness of the scene. "Perhaps one Third of the Adult male Inhab. flew to Arms & went out to meet them! A quar-

ter moved out of T^o doing nothing, the rest remained unmoved partly Tories partly timid Whigs. Sundry of the Tories armed & went forth. About 90 or an hundred Men finally stayed in T^o.¹

At West Bridge the British were checked by a small body of determined militia-men under Captain James Hillhouse. Uncertain of the strength of the latter force, the invaders, guided by William Chandler, son of Joshua Chandler, now made a wide detour to the west until they came to the Derby road, which they then followed toward New Haven. Meanwhile, most of the women and children had betaken themselves to the two high promontories beyond the town known as East Rock and West Rock. Some of the women, however, bravely insisted on remaining at home in order to help in the work of casting bullets. Over seventy Yale College students, under their leader, George Welles, a member of the senior class, joined in the fray. The defenders were, it is interesting to note, assisted by Aaron Burr of New York, who happened to be in New Haven at the time and who was placed in charge of a portion of the troops. The spirit of the occasion has been well preserved in a pen picture which Ezra Stiles has left of old ex-President Naphtali Daggett of Yale College, with his gray hair flying, mounted on his faithful black mare, with a fowling piece across the pommel of the saddle, riding out to meet the enemy, followed by Welles and the student volunteers.² What made the task of resistance utterly hopeless was that while General Garth was approaching the town from the west, General Tryon landed another large division

of troops at East End near Morris Cove and marched upon the town from that direction. In fact, the only real resistance to Tryon came from the fort at Black Rock, held by nineteen men and three cannon, and even this was soon evacuated, when it came under fire of the enemy's gunboats.

About noon Garth's troops, after some skirmishing, brushed aside the raw levies and entered the town, firing by volley as they marched down the streets. Then followed plundering and a certain amount of wanton violence and bloodshed. In spite of the address that had been issued, promising that those who should be found at their usual place of residence should be shielded from insult either in person or property, many peaceably inclined people lukewarm toward the cause of independence were made to suffer indignities. The fact that the soldiers found in the town a large store of Santa Cruz rum did not improve the situation, for it is related that the royal troops on that hot July day "sweated, swore, fought and got dreadfully drunk." While this was going on, the Connecticut troops took an advantageous position on the outskirts of the town from which point they continued to annoy the enemy throughout the remainder of the day. The attempt to restore New Haven to the loyalist fold had clearly failed. How near the town came to being delivered over to the torch can now be appreciated, for at half past one in the afternoon General Garth reported to Tryon, who was encamped to the north of the town across the neck of water, that as soon as the bridge connecting the two forces had been secured he would begin burning the town.¹ He was, however, led

to desist in this plan, probably through the influence of local loyalists and, it is alleged, especially through the intercession of Edmund Fanning, a Yale graduate who was on Tryon's staff.¹ Garth is said to have been taken to the top of the state house and, after surveying the scene, was heard to remark that it was too beautiful a town to burn. The quiet behavior of the local militia on the following day, it would seem, also helped to save the town. "The next morning," General Tryon reported, "as there was not a shot fired to molest the retreat, General Garth changed his design and destroyed only the public stores."² The British troops were not only guided into New Haven by William Chandler, who showed the way for Garth, and by Thomas Chandler, who aided Tryon, but were, according to accounts, entertained by Joshua Chandler, by Madam Hillhouse, an ardent loyalist, although the foster mother of Captain Hillhouse, and by one Ogden, the proprietor of a coffee house that bore his name. The Chandlers, the Camps, the Botsfords, and also a few others went much farther in their devotion to the empire and determined to tie their fortunes irrevocably to that of the king and to desert their homes.³

The enemy, who had entered the town on Monday, quietly departed the next day about nine o'clock in the morning, taking with them not only the group of Tory families just mentioned, but some thirty or forty other residents of the town, mostly as prisoners, among them John Whiting, Jared Ingersoll's brother-in-law, who was judge of probate and clerk of the county court. It appears that Whiting was asked, previous to the entering of the town by the royal troops, whether he would flee. He is said to have replied that not only had he not borne arms but that he was loyal to the king, and pointing to an engraving of King George which hung on the wall of his home, said, "This will protect me." But it seems that his loyalty was suspected by reason of the fact that he was holding office and was a leader in the Congregational church, and he was taken away from home so quickly,

according to reports, that the astonished man did not have time to put on his wig.¹

An amusing account has come down from that period of the reoccupation of New Haven by the fugitives after the departure of the British. It seems that crowds of curious-minded country people flocked into the town, in order to view the havoc wrought by the enemy. Suddenly a report was circulated that the British army was surrounding the place. In an instant the multitude stampeded, fleeing into the country at breakneck speed; it is chronicled that "their progress could be traced for miles by the immense clouds of dust which arose in all directions."²

As was previously pointed out, among the things which the British soldiers either consumed or carried away was most of the town's abundant supply of rum. It would appear that this put the sturdy New Haven fathers in a position of most extraordinary inconvenience, so much so that in town meeting it was voted, shortly after the invasion, to "treat with proper contempt all persons who either would refuse to sell their rum or would sell it for more than \$32.00 per gallon by retail."³

After quiet had been restored and the civil authority was again in control, the town meeting appointed a series

of committees to readjust affairs; one was entrusted with the responsibility of procuring an exchange of those who were taken as prisoners from the town during the invasion; another was delegated to call upon certain people who stayed in town when the others had fled; while still another was to question those who had neglected to oppose the enemy in the defense of the town. At this same meeting, moreover, it was thought necessary to appoint a fourth committee to wait upon Judge Ingersoll in order to ascertain the reason "why he entertained the prisoners who were lately in this town."¹ This, without doubt, had reference to the loyalist prisoners, among whom was ex-Governor Franklin, who, as has been noticed, were in New Haven the preceding fall en route to be exchanged. It probably was felt that there was some connection between Franklin's meeting with Ingersoll and this rather extraordinary attempt to win back New Haven to the royal allegiance, especially since Franklin, after going to New York, had become president of the Board of Associated Loyalists, which set on foot the expedition against New Haven. It would appear that Ingersoll was able to make a satisfactory explanation to the committee.

The British invasion not only failed of its objective but undoubtedly resulted in a reaction in the direction of greater opposition to a reconciliation with the mother country. The town had for years been the center of conflict, as has been seen, between the conservative and the radical elements, with the balance under normal conditions inclining strongly in favor of the former, and it is a fact worthy of notice that at this crisis apparently only about one-third of the men of the town were disposed to resist the approach of the British by force of arms. To such patriots as President Ezra Stiles of Yale College this was a source of surprise and disappointment,

for it goes without saying that the approach of an enemy such as a body of Indians would have seen every able-bodied man on the outskirts of town, musket in hand. Yet, on the other hand, it would appear that there were not many of these townsmen sufficiently devout in their loyalty to the empire to leave their homes and go aboard the royal fleet. To most of the conservatives of New Haven, who were as a rule men of some wealth, especially in landed property, such a step was not to be contemplated; even Jared Ingersoll found the disadvantages too great. While these mild loyalists were not at all disposed to risk their lives in fighting in the cause of American independence, they were, on the other hand, not disposed, in following their sentiments and convictions, to sacrifice their property and stations in life in overtly supporting the king. The men who made up this group—and the number must have been large in every colony—had not started the war; personally they had no deep-laid grievances; they had in fact been living happily under colonial conditions, and, in spite of the taxation controversy, had not favored rebellion, and contemplated with great uneasiness the idea of seeing the extreme anti-British radicals in charge of the destinies of the commonwealth. Even after the signing of the treaty of peace and the successful termination of the war, a feeling of distrust of the liberty group continued to be manifested. This came to the surface in 1784, in New Haven, when that city, having secured incorporation, held its first city election. Ezra Stiles, an eyewitness, writes regarding this:

“The City Politics are founded in an endeavor silently to bring the Tories into a Equality & Supremacy among the Whigs. The Episcopalians are all Tories but two, and all qualified on this occasion, tho’ dispisg Congress gov^t before—they may perhaps be 40 Voters. There may be 20 or 30 of Mr Whitty’s Meets added to these. Perhaps

one third of the Citizens may be hearty Tories, one third Whigs, one third Indifferent. Mixing all up together, the election has come out, Mayor and two Aldermen, Whigs; 2 Ald. Tories. Of the Common Council 5 Whigs, 5 Flexibles but in heart Whigs, 8 Tories."¹ Although

Roger Sherman was chosen mayor at this election by a vote of one hundred and twenty-five, there were one hundred and twenty-four votes cast against him.

The conservatives, swept along in the train of revolution, at last had come to a point where there appeared to be no turning back to the old order of things. They therefore had come to accept the new situation as inevitable while never ceasing to oppose what seemed to them an irresponsible popular element, and its leaders, who had helped to plunge the country into war. In this general shifting of ground, it appears that even their old leader, Jared Ingersoll, gradually came to accept the idea that the separation of America from Great Britain would be for the best, and what is more, actually gave his aid secretly, in 1780, in bringing this to pass. In that year, in spite of the fact that he was enjoying his vice-admiralty commission and through his agents in England was soliciting his pay of £600 sterling, in spite of the fact that he was an acknowledged Tory prisoner on parole, he actually prepared a treatise, according to his son, upon the perplexing question of the proper solution of America's financial problem which the Continental Congress was hopelessly struggling to solve. This he forwarded to Philadelphia with the expectation that it would be given publicity in the papers,—anonymously, of course,—as was his confirmed practice in getting his ideas before the public. The treatise, however, according to the younger Ingersoll, was too extensive to publish; it was, however, privately circulated among some of the influential men then in Philadelphia, such as President Joseph

Reed, and the suggestions contained in it seem to have made a favorable impression upon them.¹ Although, unfortunately, it is not possible to speak with any certainty regarding the contents of the manuscript in question, for the purpose of this study the most important thing is the knowledge of the fact that one of the most highly paid and important officials in the British colonial service in America should have become so vitally interested in the welfare of the revolutionary government as to offer a plan whereby it might survive in its struggle against the authority of the government which he was supposed to be serving. Ingersoll's position in 1780 was, to say the least, an anomalous one.

It is indeed food for thought that by the beginning of 1780, Benedict Arnold, the former leader of the extreme pro-liberty radicals at New Haven, was secretly serving against the cause of American independence, while Jared Ingersoll, the former leader of the extreme pro-loyalist group within the same community, was as truly secretly serving against the cause of loyalism and the continued unity of the British empire. In the case of Arnold, personal ambition and pique and an untamed individualism seem to have been the mainspring of his action; in the case of Ingersoll, it was undoubtedly the result of solicitude for the welfare of all that was most dear to him, the upwelling of a deep-seated Americanism which now warred against his old imperial conceptions, as well as against his personal interests. At the parting of the ways

he sought the impossible—to go in both directions. A lonely and repudiated champion of the old order of things which was passing away before his eyes never to return, he yet sought to adjust himself to the new conditions. "But all this made him unhappy," in the words of his friend, Ezra Stiles;¹ his soul had become a battle ground and he wearied of life. He did not see the outcome of the struggle which terminated in October, 1781, at Yorktown, for on August 25 of that year he passed away. Paradoxical as it may seem, it was perhaps not entirely unfitting that revolutionary New Haven paused for a moment in the conflict then raging to pay her respects to one who had stood for so many years in her midst as a foremost American representative of the British imperial administrative system and that there gathered to the funeral sermon "the Gentlemen of the town and a very large Assembly with much decency and respect."

On October 8, 1779, Ingersoll's wife, Hannah, died; on January 6, 1780, he married Hannah, the widow of Enos Alling, who had been a prosperous merchant. In the *Connecticut Journal* for March 8, 1780, there appeared the following interesting notice:

"All persons indebted to the estate of Enos Alling Esq., late of New Haven, deceased, or have demands on the same, are desired to apply for settlement unto the subscriber, administrator in right of his wife."

The question arises, How could Ingersoll perform this office of administrator, not having taken the oath of fidelity provided for in October, 1777, and enjoined upon those who could act in the capacity of administrators? Professor Simeon E. Baldwin of Yale University Law School takes the view that probably Ingersoll claimed that the statute as to the oath of fidelity did not apply to a case where the widow was entitled to administration by another statute and her husband simply qualified in her right. As the probate court, which could rule upon this, was presided over by Judge Whiting, Ingersoll's brother-in-law, who was a mild loyalist, it is not likely that the question of Ingersoll's ability to act in this case was called in question.

GUIDES AND OTHER BIBLIOGRAPHICAL AIDS

Among the most important bibliographical aids that have been employed in the preparation of this work are C. M. Andrews's *Guide to the Materials for American History to 1783 in the Public Record Office of Great Britain*, C. M. Andrews and F. G. Davenport's *Guide to the Manuscript Materials for the History of the United States to 1783 in the British Museum, in minor London Archives, and in the Libraries of Oxford and Cambridge*, Charles Evans's *American Bibliography*, A. P. C. Griffin's "Bibliography of American Historical Societies" (*Amer. Hist. Assoc. Report*, 1905, vol. II), A. R. Hasse's "Materials for a Bibliography of the Public Archives of the Thirteen Original Colonies" (*ibid.*, for 1906, vol. III), N. P. Mead's "Public Archives of Connecticut. County, Probate and Local Records" (*ibid.*), together with the "Guide to Items relating to American History in the Reports of the English Historical Manuscript Commission and their Appendices" (*ibid.*, 1898), the "List of Printed Guides to and Descriptions of Archives and other Repositories of Historical Manuscript" (*ibid.*, 1896, vol. I), and a "Report on the Public Archives of Connecticut (*ibid.*, 1900, vol. II).

BRITISH MANUSCRIPTS

Among the materials in the Public Record Office many of the Colonial Office Papers, Treasury Board Papers, Admiralty Papers, and Audit Office Papers covering the late colonial period have been found exceedingly valuable. Of the Colonial Office Papers, the most important for my purpose are those in Class 5; among the Treasury Papers, a number of the "In-Letters" are of especial importance, while among the

Admiralty Papers certain of the "Out-Letters" and admiralty warrants, and among the Audit Office Papers certain of the warrants and declared accounts are of the highest value. In the British Museum, among the Additional Manuscripts are two collections—the Newcastle Papers and the Hardwicke Papers—which have shed much light upon certain of the activities of Ingersoll.

AMERICAN MANUSCRIPTS

The most important body of manuscript relating to the life of Jared Ingersoll is the collection of Ingersoll Papers in the possession of the New Haven Colony Historical Society. These papers are divided into two groups, one, a chronologically arranged body of documents, mostly letters to or from Jared Ingersoll; the other, a large number of miscellaneous papers, mostly of a legal nature, gathered into bundles. A few Ingersoll letters are in the possession of Mr. George Pratt Ingersoll of Ridgefield, Connecticut, and in the Emmett Collection of manuscripts in the New York Public Library, while the Yale University Library possesses two of Jared Ingersoll's account books.

I also found that the Fitch Papers and the William Samuel Johnson Papers in the Connecticut Historical Society archives, and the Trumbull Papers in the Massachusetts Historical Society archives contain highly important unpublished materials. In the Connecticut State Library are the Connecticut Archives, a veritable mine of useful information, although I have found especially illuminating those volumes classified under the titles, "Foreign Correspondence," "Crimes and Misdemeanors," "Revolutionary War," and "Towns and Lands." In the office of the Secretary of State the records of the Superior Court of the Colony of Connecticut (vols. XIII to XVIII, inclusive) have yielded much valuable data. Several collections that are preserved at New Haven have also been very serviceable: in the office of the Clerk of the Superior Court the New Haven County Court Records, the first seven volumes of which cover the colonial period; in the office of the Judge of the Probate Court, the Dis-

trict of New Haven Probate Court Records, dating from 1719; in the office of the Town Clerk, the New Haven Town Records, dating from 1638; and scattered through these volumes the records also of the Freemen's meetings as well as the records of the Proprietors' meetings; there are, in addition, two separate volumes of Proprietors' Records.

BRITISH OFFICIAL DOCUMENTS, PRINTED

Among the most useful of the printed sources for my purpose are the *Acts of the Privy Council of England, Colonial Series* (1908-1912), the *Statutes at Large* (London, 1762-1800), *The Journals of the Lords* (vols. XXX-XXXIV), *The Journals of the House of Commons* (vols. XXIX-XXXV), Cobbett-Hansard's *The Parliamentary History of England from the Earliest Period to the Year 1803*, *The Annual Register* for the years 1760 to 1780, and the *Historical Manuscripts Commission Reports*. Among the latter the calendar of the Marquis of Shelburne Manuscripts (Appendix to the Fifth Report), the calendar of the Lord Lecomfield Manuscripts (Appendix to the Sixth Report), and the calendar of the Earl of Dartmouth Manuscripts (Fourth part of Appendix to the Eleventh Report and the Tenth part of the Appendix to the Fourteenth Report) shed a good deal of light upon certain of the questions herein considered.

AMERICAN OFFICIAL DOCUMENTS, PRINTED

Among printed documents bearing upon Connecticut colonial history, none are more important than the *Public Records of the Colony of Connecticut*, compiled by J. H. Trumbull and C. J. Hoadly (Hartford, 1850-1890). For my purpose the first two volumes of the *Public Records of the State of Connecticut* are also useful, as are the *Acts and Laws of His Majesty's English Colony of Connecticut, 1750*, with the revision of 1769, and the *Acts and Laws of the State of Connecticut, in America, 1784*.

Outside of the Connecticut documents, mentioned above, none of the printed colonial official documents have been of greater

general service to me than the *Documents Relative to the Colonial History of State of New York, Procured in Holland, England, and France*, edited by E. B. O'Callaghan (Albany, 1856-1861). To these should be added *Documents and Records relating to the Province of New Hampshire*, edited by N. Bouton and others (Concord, 1867-1907); *Archives of the State of New Jersey*, edited by W. A. Whitehead and others (Newark, 1880-1906); *Minutes of the Provincial Council of Pennsylvania*, followed by the *Minutes of the Supreme Executive Council* (Philadelphia, 1852-1853); *Pennsylvania Archives*, compiled by Samuel Hazard and others (Philadelphia and Harrisburg, 1852-1899); *Colonial Records of North Carolina*, edited by W. L. Saunders (Raleigh, 1886-1890), which, as in the case of the *New York Colonial Documents*, contain much useful material bearing upon general colonial conditions and are especially valuable for this study because they include certain representations of the Board of Trade.

CORRESPONDENCE, MEMOIRS, PAPERS, PRINTED

In 1766 Jared Ingersoll published for private distribution a collection of twelve letters written between the spring of 1764 and the spring of 1766, under title of *Mr. Ingersoll's Letters Relating to the Stamp Act*; the explanatory footnotes that accompany these letters are illuminating. These letters were included in the *Jared Ingersoll Papers*, edited by Dr. Franklin B. Dexter, published in 1918 in volume IX of the *Papers* of the New Haven Colony Historical Society, and since reprinted as a separate volume. These *Papers* represent a selection from the correspondence and miscellaneous papers of Jared Ingersoll and show the result of painstaking and discriminating editing. Some one hundred and sixty-four documents are printed in this collection.

Several collections of printed correspondence have been published, for the most part by the Connecticut Historical Society, which are of the highest value in studying the late colonial period of Connecticut history. Among these are *Letters from English Kings and Queens to the Governors of the Colony of Connecticut*

together with the Answers thereto from 1635 to 1749, collected by R. R. Hinman (Hartford, 1836), "Correspondence of the Connecticut Governors with the British Government, 1755-1758" (Conn. Hist. Soc. Collections, vol. I, Hartford, 1860), "Roger Wolcott's Memoir" (Conn. Hist. Soc. Collections, vol. III, Hartford), *Talcott Papers: Correspondence and Documents (chiefly official) during Joseph Talcott's governorship of the colony of Connecticut, 1724-1741*, edited by M. K. Talcott (Conn. Hist. Soc. Collections, vol. V, Hartford, 1892-1896), *Law Papers, correspondence and documents during Jonathan Law's Governorship of the Colony of Connecticut, 1741-1750* (Conn. Hist. Soc. Collections, vols. XI, XIII, XV, Hartford, 1907-1914), *Wolcott Papers. Correspondence and Documents during Roger Wolcott's Governorship of the Colony of Connecticut, 1750-1754*, edited by A. C. Bates (Conn. Hist. Soc. Collections, vol. XVI, Hartford, 1916), which includes a large number of documents of great importance for the purpose of the present study, as do the *Fitch Papers, Correspondence and Documents during Thomas Fitch's Governorship of the Colony of Connecticut, 1754-1766*, I, edited by A. C. Bates (Conn. Hist. Soc. Collections, vol. XVII, Hartford, 1918), which is to be followed by a second volume, the manuscript of which Mr. Bates kindly allowed me to examine.

Several of Jared Ingersoll's contemporaries, besides those previously mentioned, have left correspondence, memoirs, or diaries which have been published and which in varying degree are useful in this connection. The recently printed *Extracts from the Itineraries and other Miscellanies of Ezra Stiles, D.D., LL.D., 1755-1795, with a Selection from his Correspondence*, edited by Dr. F. B. Dexter (New Haven, 1916), although almost a wilderness of unrelated observations recorded by the learned divine, is really invaluable; less important has been the more pretentious and logically developed *Literary Diary of Ezra Stiles*, also edited by Dr. Dexter (New York, 1901), as well as the *Diary of Joshua Hempstead of New London, Connecticut* (New London, 1901), another literary wilderness, and the "Letters of William Samuel Johnson to the Governors of Connecticut" (Mass. Hist.

Soc. Collections, fifth series, vol. IX). The *Writings of Benjamin Franklin*, edited by A. H. Smyth (10 vols., New York, 1905-1907), *The Grenville Papers*, edited by W. J. Smith (4 vols., London, 1853), the "Letters of Charles Garth" (*Maryland Hist. Magazine*, vol. V), the *Correspondence of William Pitt*, edited by G. S. Kimball (3 vols., New York, 1906), *The Montresor Journals*, edited by G. D. Scull (New York Hist. Soc. Collections, second series, vol. XIV, New York, 1881), the *Memoirs and Letters of Captain W. Glanville Evelyn*, also edited by G. D. Scull (Oxford, 1879), the *Journal Kept by Hugh Finlay* (Brooklyn, 1867), the *Familiar Letters of John Adams*, edited by C. F. Adams (Boston, 1876), and the *Collection of . . . Papers Relative to the Dispute between Great Britain and America . . .*, made by John Almon (London, 1777), should be especially mentioned.

CONTEMPORARY TRACTS AND BOOKS

The *Tracts and other Papers*, collected by Peter Force (Washington, 1836-1846), as well as the John Almon *Collection of the most interesting Tracts* (London, 1766-1767) contains useful material. In connection with the Stamp Act crisis, among the vast number of pamphlets issued at that time, I am most indebted to Thomas Whately's (?) *Considerations on the Trade and Finances of this Kingdom and on the Measures of Administration with Respect to those great National Objects since the Conclusion of the Peace* (London, 1766), Samuel Cooper's *The Crisis* (London, 1766), Timothy Cunningham's *The History of our Customs, Acts, Subsidies, National Debts and Taxes* (London, 1761), J. Cunningham's *An Essay on Trade and Commerce Containing Observations on Taxes as they are supposed to affect the price of Labour in our Manufactories: Together with some Interesting Reflections on the Importance of our Trade to America* (London, 1770), Henry McCulloh's *Miscellaneous Representations relative to Our Concerns in America*, Thomas Fitch's *Some Reasons that Influenced the Governor to Take and the Councillors to Administer the oath required by Parliament, commonly called the Stamp Act* (Hartford, 1766), the famous Con-

necticut *Reasons Why the British Colonies should not be charged with Internal Taxes* (New Haven, 1764), and Benjamin Church's (?) *Liberty and Property Vindicated and the St—pm—n burnt* (New London, 1765).

Regarding the political and social conditions in Connecticut of this period, much valuable information can be gleaned from Timothy Dwight's *A Statistical Account of the Towns and Parishes in the State of Connecticut* (New Haven, 1811) and his *Travels in New England and New York* (New Haven, 1821), Benjamin Gale's *The Present State of the Colony of Connecticut* (New London, 1755), and *Doctor Gale's letter to J. W. Esq.* (Hartford, 1769), Eliphalet Dyer's *Remarks on Dr. Gale's letter to J. W. Esq.* (Hartford, 1769), and Thomas Clap's *Answer of the Friend in the West from a Gentleman in the East* (New Haven, 1755); the principal sources of information relative to these conditions are of course the private correspondence and the newspapers of that period.

In studying the Susquehanna controversy, I have found especially useful *The State of the lands said to be Once within the Bounds of the Charter of the Colony of Connecticut, west of the Province of New York, Considered. By the Public's humble Servant* (New York, 1770), Dr. William Smith's (?) *An Examination of the Connecticut Claim to the Lands in Pennsylvania, with an Appendix Containing Extracts and Copies taken from Original Papers*, by Jared Ingersoll (Philadelphia, 1774), the *Report of the Commissioners Appointed by the General Assembly of Connecticut to Treat with the Proprietors of Pennsylvania respecting the Boundaries of this Colony* (Norwich, 1774), Barnabas Bidwell's *The Susquehanna Title Stated and Examined* (Catskill, N. Y., 1796), and the *Charge of Judge Paterson to the Jury in the Case of Van Horne's lessee vs. Dorrance* (Philadelphia, 1796).

NEWSPAPERS

The *Connecticut Gazette*, established in New Haven in 1755 and published until 1786 by J. Parker & Co. and Benjamin Mecom, successively, is a source of first importance; this paper

was followed by the *Connecticut Journal* and *New Haven News Boy*, published by Thomas and Samuel Green, which is also invaluable; hardly less so are the *New London Gazette*, which became, in 1763, the *Connecticut Gazette and Universal Intelligencer*, and the *Connecticut Courant*, established at Hartford in 1764 by Thomas Green. Outside of Connecticut, the Philadelphia newspapers have been the most helpful; the files of the *Pennsylvania Journal or Weekly Advertiser*, published by William and Thomas Bradford, contain the significant "Russel" letters and Ingersoll's replies, while the *Pennsylvania Gazette*, controlled during this period by Hall and Sellers, and the *Pennsylvania Chronicle and Universal Advertiser*, shed additional light on Ingersoll's activities while in Philadelphia. Serviceable but of less importance have been the *Boston Evening Post*, the *Boston Gazette and Country Journal*, the *Boston Post Boy and Advertiser*, and the *Massachusetts Gazette and Boston News Letter*, the *New Hampshire Gazette and Historical Chronicle*, the *Newport Mercury or Weekly Advertiser*, the *New York Gazette or Weekly Post-Boy*, the *New York Mercury*, which was changed to the *New York Gazette and Weekly Mercury* in 1768, *Rivington's New York Gazetteer*, which appeared in 1777 as *Rivington's New York Loyal Gazette* and later as the *Royal Gazette*, the *Providence Gazette and Country Journal*, and the *Portsmouth Mercury and Weekly Advertiser*.

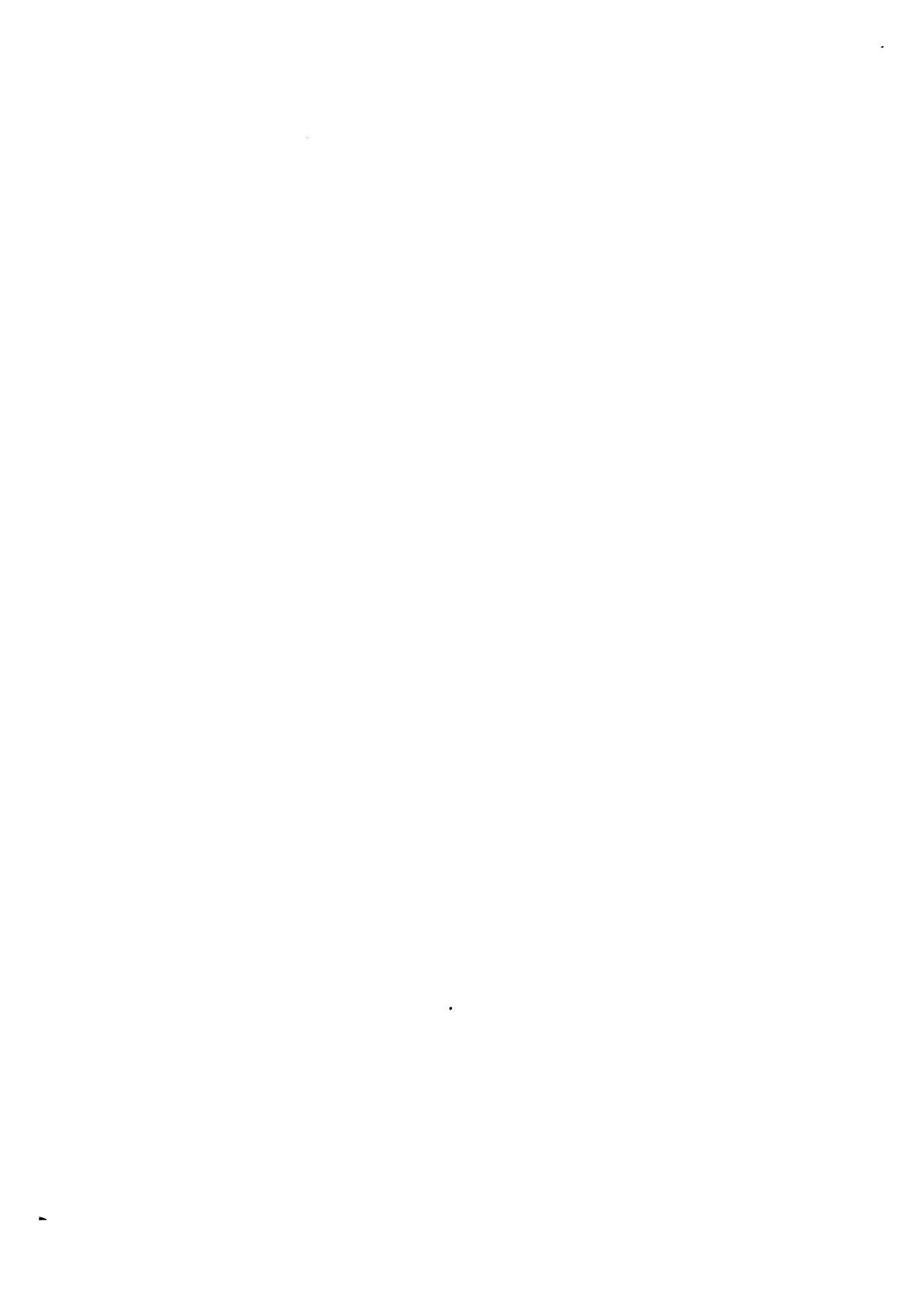
