JOURNAL.

ST. LUKE'S CHURCH, SALISBURY, WEDNESDAY, MAY 27, 1857.

This being the day and place for the meeting of the 41st Annual Convention of the Protestant Episcopal Church in the Diocese of North Carolina, the Bishop, with the attending Clergy and Laity, assembled in St. Luke's Church, Salisbury.

Morning Prayer was said by the Rev. J. B. Cheshire, assisted by the Rev. R. B. Drane, D. D.; the Ante-Communion Service was read by the Rev. R. S. Mason, D. D.; a Convention Sermon was preached by the Bishop, from the 2d verse of the 4th chapter of St. Paul's first Epistle to the Corinthians.

The Holy Communion was administered by the Bishop to the Clergy, and by the Rev. Drs. Mason and Drane, and the Rev. J. B. Cheshire, to a large number of recipients.

The Bishop read his Annual Address to the Convention, which, on motion, was referred to the Committee on the State of the Church:

Brethren of the Convention:

Scattered as we are over this wide commonwealth, it is a source of great consolation and strength, that we meet together in these Annual Councils, to communicate to each other our labors and their results, and to consult on the best means of advancing that great cause to which we are vowed.

During the past year, I have visited every part of the Dio-

cese, except three or four parishes in the North-West, which I was hindered from reaching by the approach of the General Convention, and I have been able also to perform services in several extensive regions of the State into which neither I nor my predecessors in office had ever before found access.

During the last Convention, I confirmed at Washington twenty persons, and received to Deacon's Orders Messrs. Thos.

G. Haughton and Daniel Morrelle.

May 27th, at Union Chapel in Beaufort county, I preached, confirmed five persons, and administered the Holy Communion, assisted by Mr. Hughes.

28th, at St. John's, Durham's Creek, I preached, baptized two infants, and administered the Communion. This Church is in bad repair, and has very seldom services performed in it.

On the same day, at Mr. Crawford's, I baptized three negro

children.

June 1st and 2d, at Elizabeth City, I preached three times, confirmed ten persons, and administered the Lord's Supper.

During the latter part of June I performed various services in Wilmington, preaching repeatedly, baptizing an infant, and burying a person.

July 6th, I preached, morning and evening, at Smithville, and in the morning administered the Communion.

13th, at Warrenton, I preached twice and confirmed one person.

15th, at Williamsborough, I preached in the morning and administered the Holy Communion, assisted by Messrs. Sutton and Hines. In the afternoon, Mr. Sutton preached, and I confirmed five persons.

16th, I baptized a sick child in private.

17th, I preached, morning and evening, at Oxford.

18th, I preached at Bethel in Granville county.

20th, at Henderson, I preached twice, made an address to the slaves after a sermon to them by the Rev. Mr. Hines, administered the Holy Communion, and confirmed eight persons. The labors of the zealous Minister of this Parish are beginning to be rewarded by much fruit.

22d, assisted by Mr. Cheshire, I performed service twice at Louisburg, preaching on both occasions, administering the Communion, and confirming one person.

26th, at Chapel Hill, service was held and Mr. Bronson preached.

27th, in the morning, in the same Church, I admitted to Deacon's Orders Samuel S. Barber, preaching on the occasion, and administering the Communion,—Messrs. Hubbard, Wheat, Lee and Bronson taking part in the services. In the evening, I again preached, and confirmed two persons.

28th, at Salisbury, Mr. Wetmore read Evening Prayer and I preached; and on the next day, I administered the Holy Communion to my beloved brother, the Rector of the Church, in his sick chamber, he then, as indeed almost ever since, suffering from a broken limb.

30th, at Lincolnton, I read Prayers, preached, and baptized an infant; and the next day, at the same place, another.

August 2d and 3d, I preached three times at Rutherfordton, administered the Holy Communion, assisted by Messrs. Bland and Mason, and confirmed four persons.

4th, I preached at a School House in Polk county.

7th, 9th and 10th, I preached four times at Asheville, and confirmed five persons.

August 11th, I set off, in company with the Rev. Mr. Prout, on a Missionary tour to the South-Western part of the State,the Cherokee country as it is called,—where our Church has hitherto been scarcely better known than the Greek or Armenian. During the previous winter, however, and in its most inclement season, Mr. Prout's adventurous and self-denying Missionary spirit had led him to this remote and secluded region, and had produced a favorable impression in behalf of the Church on all whom he had reached. During our tour we stopped and held services at Waynesville, Webster, Franklin, Valley River, Murphy, and Fort Hembey. At these various places, going and returning, I preached eight times and Mr. Prout once, and we likewise administered the Holy Communion at Murphy, where we have a small place of worship and three Communicants. The country is a mountain region of surpassing beauty, of great mineral wealth as yet almost altogether undeveloped, with valleys of uncommon fertility; and with perhaps the finest climate in the Union, cooler than that of New England in the summer, and free from the intense winter rigors of the latter, and the chilling damps of its spring.

With such advantages, and immediately contiguous to the vast hot plains of the Southern and South-Western States, this region of country must become before very long highly populated and very prosperous. To it is due the earliest care of the Church; and that the more, because its spiritual destitution is greater perhaps than can be observed elsewhere in the State, great as it is in many other quarters. Besides the ordinary elements of population calling for ministerial labor in their behalf, there is a very interesting settlement of Indians at a place called Qual-Here it is said that between one and two thousand of the Cherokees are congregated; and I was greatly pleased to hear an unvaryingly favorable account of their morality, their advance in steady industry, and other tokens of improved civilization. The Methodists have a Missionary among them, who preaches by means of an interpreter. Surely we too are their debtors for that Gospel which God has entrusted to us. Knowing but little previously of the topography of the country, I had made appointments, the keeping of which made it impossible for me to visit them. I requested Mr. Bronson, however, who afterwards went over the same region of country, to visit them, which he did, and preached to them by the medium of the interpreter.

August 24th, I preached in the morning at Flat Rock, and confirmed two persons, and in the afternoon again preached at Hendersonville.

26th, I preached at Mr. Frank Johnston's, on the French Broad River.

This congregation is a new and promising one, consisting mainly of gentlemen and their families from South Carolina, who have been attracted to the locality by its possession of such advantages, and so combined, of health, fertility, and magnificence of scenery, as I certainly have never seen paralleled elsewhere.

The congregation differs from that at Flat Rock in that its members generally are, by birth, or have become, permanent residents of the State, instead of merely occupying summer homes in it. On this account, they of course offer better hopes of increasing the strength of the Church. During the past summer, they enjoyed the very acceptable and useful services of the Rev. Stuart Hanckel of South Carolina. They have de-

termined to build a Church, which they hope to have ready for consecration if Providence should permit me to visit them again this ensuing summer or autumn. While here I baptized an infant.

August 31st, at Morganton, I read Prayers and preached twice, baptized an infant, confirmed one person, and administered the Holy Communion.

September 7th, I preached at Roxborough in Person county, the first time, I understand, at which the Service of the Church has ever been heard in that county. Indeed, Person and Caswell counties have both been greatly neglected by us, although one of the most flourishing parts of the State,—the latter especially, I believe, being distinguished for successful agriculture and an intelligent population. Although, indeed, wherever I turn my eyes in this Diocese, I see wide fields, and sometimes few and sometimes alas! no laborers.

From this neighborhood I went on Northward, and attended the meeting of the Trustees of the General Seminary, in New York in the last days of September, and of the General Convention, in Philadelphia, during the greater part of October.

The proceedings of the former body were marked by nothing of importance, except the indefinite postponement of the election of a Professor of Pastoral Theology, which postponement was considered necessary because of heavy demands upon the pecuniary resources of the institution, in consequence of certain improvements to their property which the authorities of the city required to be made.

The proceedings of the General Convention were published at the time, and are no doubt well known to you. They were conducted with such harmony, dignity and ability, as to elevate the Church in the judgment of the people of the country, and still more to endear it to their affections. Its entire abstinence from irritating and unprofitable political discussions; its unanimous purpose not to meddle with the things of Cæsar, but to give itself to the cares and interests which belong to God; these characteristics served to show more plainly than before, that it is qualified to be, and therefore likely to be, the Church of the Nation, being itself National, as opposed on the one hand to that which is extra-national, having its life and power in a foreign land, and opposed on the other hand to those which are

sectional and thereby sympathizers with and fomentors of the passions and prejudices of men, the very elements which it is the office of the Church to calm and to moderate.

One of the most important subjects which came before the General Convention, was that presented by the memorial of certain Presbyters, addressed to the House of Bishops, seeking such modifications of the Service as would promote the greater efficiency of the Church. The House not considering any change in the Law of the Church desirable, expressed their judgment as to what was allowable, under the existing law, to adapt our Services to different occasions and varying circumstances. In this judgment I was able to concur with the great body of my brethren, and anticipate happy results from the greater flexibility of our admirable Liturgy, thus authorized.

Another subject of great importance engaged the attention of some of the Bishops assembled in Philadelphia, and deserves I think, the careful consideration of this Convention. It was the establishment of a Southern University under the care of the Church. That the interests of Education at the South, especially in the higher and most advanced studies, require development, no one will deny. That our Church especially needs Educational Institutions of character and efficiency will be painfully apparent when it is remembered that of the few Church Colleges in the country, all are North of this State. Colleges where the Church is not recognized, ought surely not to be the sole educators of the youth of the Church. The Colleges already existing at the South are of great value to our people and deserve their encouragement, but they are not sufficient for the wants of this great section of the Union, and still less can they supply the peculiar wants of the Church. An University such as is contemplated, where the highest and most varied culture might be obtained, where strict discipline might be enforced, where a definite religious Faith might be inculcated, and that too the very Faith of the Gospel, as ever held in the Church, and where moreover a decided religious influence might be exerted over the minds of the pupils, -such an University at the South would be one of the greatest conceivable blessings for this region of country. It would go far to remove one of the most crying evils now pressing upon us, that of an undisciplined, irreligious and consequently immoral

youth. I believe this blessing to be attainable. No single Diocese nor perhaps two or three united can attain it, but if all the Dioceses whose Bishops recommend this measure, shall unite heartily in its prosecution, it will succeed; I refer it to

you for your further consideration.

In Philadelphia, at the Church of St. James the Less, I confirmed, by the request of Bishop Potter, a class of five persons. In the same city, I celebrated one marriage, and in Baltimore two, there being in each case special reasons for my officiating. In Baltimore, I also baptized three children whose parents belonged to this Diocese. In the same city, I took part in the consecration of Grace Church, preaching at the instance of Bishop Whittingham the Sermon on that occasion, made more interesting to me withal, by having been myself active in the erection of the noble and beautiful edifice thus set apart for the worship of Almighty God.

Nov. 8th, at Trinity Church, Scotland Neck, I preached, and confirmed seven persons, Messrs. Cheshire and Haughton as-

sisting in the service.

9th, at Tarborough, I preached, morning and evening: Mr. Cheshire in the afternoon. I also administered the Holy Communion and confirmed four persons.

10th, at Hamilton, we had service in the evening, and Mr.

Cheshire preached.

11th, at the same place, I preached, and confirmed one person. This is a growing village, and there is a desire felt by some of the residents to have a Church built and more frequent services performed. The Rev. Mr. Watson officiates here once a month, in the evening, an advantage which is appreciated, but is, of course, insufficient to secure the rapid progress of the Church. Aid in the erection of a house of worship would be very valuable.

12th, I read Prayers and preached, morning and evening, at Williamston. Much of what I have said of Hamilton applies to this place, only that here we have a Church building. Frequent and regular services would be, I am persuaded, fruitful in much good, among a people not unfavorably affected to the Church, and much needing its sound teaching, and sanctifying

influence.

14th, I consecrated Zion Church, in Beaufort County, at the

same time preaching, confirming twelve persons, and administering the Holy Communion, Messrs. Hughes and Geer assisting in the services. This Church, itself pretty and convenient, reflects more credit on those who contributed to its erection, and particularly on some two or three who especially exerted themselves for that object, than many a stately Temple erected at great cost, but requiring far less sacrifice on the part of its builders, than this simple and inexpensive structure.

15th, I preached, morning and evening, at Washington.

16th, A. M., I preached at Trinity Church, Beaufort County, confirmed one person, and administered the Lord's Supper to a large congregation, deeply moved by the knowledge that it was perhaps the last service, and certainly one of the last, in which their beloved Minister, Mr. Hughes, would officiate to them as to his own flock.

In the evening, I preached at Washington, and confirmed two persons.

18th, at Pugh's Chapel, I preached, confirmed one person, and administered the Holy Communion, Mr. Hughes assisting me.

19th, at Greenville, I performed the same services, again confirming one person.

In the evening, I confirmed another person in private, and the next morning administered to him the Holy Communion. He was then ill and has since died.

20th, being Thanksgiving Day, I officiated at Marlborough, preaching, confirming one person, and administering the Eucharist. It was the first occasion on which these latter services had ever been performed there.

29th, at Fayetteville, in the evening I preached, and confirmed fifteen persons.

30th, in the morning, at the same Church I preached, and administered the Holy Communion.

In the evening I preached at Rockfish.

Dec. 2d, I preached, morning and evening at the Gulf, in Chatham County.

3d and 4th, I preached three times at Pittsborough, and confirmed two persons.

7th, at Raleigh, in Christ Church, I confirmed fourteen persons, of whom twelve were from St. Mary's School. At the same time, assisted by Drs. Mason and Smedes, I administered

the Holy Communion. In the afternoon, I held a service and preached to the inmates at the Lunatic Asylum.

9th and 10th, I preached twice, and confirmed one person at

Halifax.

11th, P. M., I preached, and confirmed one person at Wilson; on the next morning, after again preaching, I administered the Holy Communion.

21st, at St. James's Church, Wilmington, I preached, and admitted to Deacon's orders three persons, viz: John V. Stryker, Silas D. Davenport and Israel Harding, and administered the Holy Communion,—Dr. Drane, Dr. Curtis, and Mr. William Murphy assisted in the services.

During the remainder of the winter, I officiated in Wilmington, mainly in a building belonging to the Methodist Protestants then vacant, and which had been very kindly offered for my use. Here a number of persons attended, both white and black, who had heretofore been strangers to our services. I had reason to hope that good was done.

During this time I celebrated one marriage of colored per-

sons, and baptized ten colored children.

March 12th, at Gatesville, I held three services, in the morning preaching, confirming one person and administering the Holy Communion. In the afternoon the Rev. J. W. Murphy preached, and in the evening the Rev. Mr. Hilliard. The Church was ready for consecration, but for the absence of the deed of gift and the late arrival of the Clergymen, detained by an accident to the steamer in which they had taken passage.

15th and 16th, I preached three times at Edenton, administered the Holy Communion, and confirmed fifteen persons.

17th, I preached, morning and evening, at Hertford, confirming eight persons, and administering the Holy Communion.

On the 18th I preached at Woodville, in Perquimons County,

and twice on the 19th at Elizabeth City.

21st and 22d, preached three times at Plymouth, confirmed three persons and administered the Lord's Supper.

24th, preached and administered the Communion at St. Luke's

in Washington County.

25th, at Pettigrew's Chapel, I preached, consecrated the building, confirmed three persons, admitted the Rev. Francis W. Hilliard to Priest's Orders, and administered the Commu-

nion. In these varied and interesting services, I enjoyed the assistance of my Reverend Brethren Johnston, Watson, J. W. Murphy, Patterson and Hilliard; Mr. Johnston presenting the Candidate for Orders.

The consecration of the building had been long delayed because of a provision in the will of the original grantor, the first Bishop-elect of this Diocese, by which in certain contingencies, services other than those of the Church might be performed there. These contingencies seemed now to be removed by the change of circumstances, and it was thought that the consecration had become proper. The Church itself has lately been enlarged and in every respect improved, and a neat parsonage built and furnished, and the services are as likely to be permanent as in other rural congregations in the Diocese. These benefits are due mainly to the liberality of Mr. William Pettigrew and Mr. Josiah Collins.

26th, in the evening, at the Lake Chapel, Mr. Watson preached, and I confirmed twenty-six persons, all of them slaves of Mr. Collins, or Mr. Charles Pettigrew.

27th, at the same Chapel, I preached and administered the Communion. Those who partook of it, exceeding probably a hundred in number, were the families of these gentlemen and mainly their slaves. And I think it right to say here that the more I have seen of the effects of the system pursued in that congregation, the better am I pleased with it.

28th, P. M., at Windsor, Mr. Patterson preached.

29th, I preached twice, and Mr. Patterson once in this congregation, and assisted by its Minister, Mr. Bronson, I administered the Communion.

30th, at a house in the same Parish, I confirmed four persons.

31st, I preached at Woodville, in Bertie County.

April 2d, at Murfreesborough, there were three services, at which Messrs. Hilliard, Bronson and I preached, and I administered the Communion and confirmed one person.

4th, at Jackson, Mr. Haughton preached, and baptized an infant.

5th, I preached, and administered the Communion in the morning at Jackson, and in the evening, preached again at Mr. H. K. Burgwyn's Chapel.

7th, at Rocky Mount, I preached, and administered the Lord's Supper.

8th, P. M., at Kinston, I preached, and confirmed two persons, and on the next morning again preached, and administered the Lord's Supper.

10th, 11th and 12th, being Good Friday, Easter-Even and Easter Day, I preached five times, administered the Communion, and confirmed twenty-five persons, at Newbern.

14th, I laid the corner-stone of a Church at Beaufort, by the name of St. Paul's, Messrs. Greene and Van Antwerp taking part in the service; on this occasion I delivered an Address, and in the evening preached, and confirmed four persons.

Mr. Van Antwerp, our diligent and unwearied Minister at Beaufort, deserves not only our commendation, but our aid in his efforts to build a Church and establish a congregation in a place where he found but one communicant, much ignorance of the Church, and much prejudice against it, and very little sympathy or co-operation at home or abroad except at Newbern, where he has received kind, timely and effectual aid. The importance of Beaufort in the future makes it very desirable that he should be sustained, and I must request the aid now of all throughout this Diocese, who love the Church, and are able to do any thing in its behalf, in furtherance of a cause so urgent and so deserving.

April 15th, I set off, accompanied by Messrs. Greene and Van Antwerp, for Swansborough and Jacksonville, in Onslow County. The former place we were prevented from reaching in time for service, by a high and adverse wind. By great efforts we fulfilled the appointment at Jacksonville. There we found a good congregation, to which I preached, perhaps the first time that a Bishop had ever entered their county. Had we the man and the means, much good might be done among this people.

April 21st, I baptized, and on the next day buried a colored child in Wilmington.

26th, I confirmed at St. James's Church, Wilmington, twenty-four persons, and May 1st, one in private, of the congregation of that Church.

April 30th, I baptized a white adult in the Chapel in which I had been officiating during the winter.

May 2d, P. M., I preached at Goldsborough.

3d, I preached, morning and evening, at the same place, at the first service administering the Holy Communion, and at the second confirming two persons. All these services were held in the new Church at that place, not yet completed, but which had been fitted up for the occasion. I could not but warmly congratulate the Minister and congregation on this successful result of much labor and considerable sacrifices, in bringing to that stage, a house for the Honor of God, and the spiritual nurture of souls, the beauty and convenience of which strike every eye that beholds it.

May 6th, I preached at Warrenton.

May 7th, A. M., I preached at St. Mary's, Raleigh, and confirmed ten of the pupils, besides twelve in December, and others on my visitation elsewhere.

Great as have been the benefits heretofore rendered by this School, to the sacred interests of Education and Religion, improvements and enlargements are now making in it, which promise for it in the future, a wider sphere of utility and prosperity. It has especially deserved well of this Diocese, and is justly dear to it.

In the afternoon of the same day, I confirmed a person in private, belonging to Christ Church, and at night, preached to a large congregation in that Church, and confirmed nine persons, being the second confirmation held in it during the year. 8th, P. M., I preached at Chapel Hill, and confirmed one

person.

9th, P. M., at Hillsborough, Mr. Hubbard who had accompanied me from Chapel Hill, preached.

11th, A. M., I preached at St. Mary's, Orange County, and confirmed six persons, and in the evening, preached and confirmed the same number at Hillsborough, one of them in private. The Diocese generally will be gratified to know that the present Rector of this Parish, is the Rev. Dr. Curtis, who after many years of labor in South Carolina, has returned to his attached congregation in Hillsborough, having oversight therewith of St. Mary's, and of a Missionary Station at Graham.

May 11th, P. M., I preached at this Missionary Station, and on the twelfth and thirteenth successively at Greensborough and Lexington. At these last two points the Rev. T. G. Haugh

ton has been laboring acceptably since January, and as one of the fruits of those labors, the long desired Church in Lexington is about to be commenced.

May 15th, I preached, morning and evening at Mocksville, confirming two persons, and administering the Holy Communion.

May 17th, I consecrated St. James's Church, in Iredell County, a service so unusual in that region of country as to attract an immense concourse of persons. There were present the Rector, the Rev. Mr. Wetmore, to whose unwearied efforts its erection is mainly due, the Rev. Mr. Prout, who had come sixty miles over bad roads to attend this service, and the Rev. Mr. Haughton. I preached, confirmed five persons, and administered the Lord's Supper. In the afternoon, Mr. Wetmore baptized an Adult, and Mr. Haughton preached.

May 18th, A. M., at Christ Church, Rowan, I preached, confirmed twelve persons, and administered the Holy Communion. In the afternoon I administered both of these ordinances in private to a sick person; while in Church Mr. Prout, at the instance of Mr. Wetmore, baptized an Adult, and preached.

May 19th, at St. Andrew's, in the same county, I preached, confirmed two persons, and administered the Lord's Supper. Here I witnessed a pleasing, and it is a shame to add in a Christian country, a rare sight, a great majority of the adults present receiving the Lord's Supper, and of these, the larger part being men.

20th, P. M., at Charlotte, the Rev. Mr. McCulloh, of South Carolina, preached.

21st, in the morning at this place the corner-stone of a new Church was laid by me, and a beautiful and appropriate Address delivered by the Rev. Dr. Hawks, of New York. In the evening the Rev. Mr. Gibson of South Carolina, preached.

22d, I preached, morning and evening, at the last service

confirming four persons.

23d, P. M., Lincolnton. The Rev. William Murphy preached. 24th, I preached in the morning, confirmed eight persons, and administered the Lord's Supper. In the afternoon, there was a Sermon by the Rev. J. W. Murphy, and in the evening, a service for the colored people, at which I preached to them.

I have thus during the past year preached in the Diocese up-

wards of a hundred and seventy times, and administered the Holy Communion forty-two times, consecrated two Churches, and laid the corner-stones of two others; confirmed three hundred and thirteen persons in the Diocese, and five out of it, baptized ten white infants, one white Adult, and fifteen colored infants, the whole number of Baptisms performed by me being thus twenty-six. I have married five couples, only one however in this Diocese, and that a colored one, and I have performed two funeral services.

I have ordained six persons to the Diaconate, viz: Messrs. Haughton, Morrelle, Samuel S. Barber, Stryker, Davenport and Harding; and one, the Rev. F. W. Hilliard, to the Priesthood. I have transferred four Clergymen to other Dioceses, viz: the Rev. C. M. Parkman to Maryland, the Rev. John T. Wheat, D. D. to Tennessee, the Rev. A. F. Olmsted to South Carolina, and the Rev. James T. Pickett to the Diocese of Tennessee. And I have received three by Letters Dimissory, viz: the Rev. Dr. Curtis from South Carolina, the Rev. T. S. W. Mott from Mississippi, and the Rev. John T. Wheat, D. D. from Tennessee. Dr. Wheat never changed his actual residence, finding that his health did not qualify him for the duties of the charge he had at one time agreed to undertake.

The changes which have occurred in the Parishes are these: Louisburg is now under the charge of Mr. Sutton, together with Oxford. The Rev. William Murphy performs the duties of the Church at Halifax. Pittsborough, which has lost the services of Mr. Olmsted, has obtained those of the Rev. N. C. Hughes. Of the congregations heretofore under Mr. Hughes's care, Zion Church, Beaufort County, is served by the Rev. Israel Harding; Pugh's Chapel, in Pitt County, by the Rev. S. S. Barber; Trinity Church, Beaufort County, and St. Paul's Church, Greenville, are still vacant. The Rev. Mr. Parkman's place as Assistant Minister at Christ Church, Elizabeth City, is not yet filled. The Rev. Mr. Haughton, after serving the Church at Jackson for some months at my request, was placed by me as Assistant to Mr. Parker at Salisbury, during what it is hoped is a temporary disability of the latter. Mr. Haughton has been also performing Missionary duty at Greensborough and Lexington. The Rev. Mr. Morrelle has charge of a School at Goldsborough, and renders, when he can, aid to the Rev. Mr. FitzGerald. The Rev. Mr. Stryker is officiating as Assistant Minister at Christ Church, Newbern, and also conducting a School there. The Rev. Silas D. Davenport is officiating at Wadesborough. The Rev. Mr. Bland has resigned the charge of the Church at Rutherfordton, and accepted that of the Church at Lincolnton. The Rev. R. H. Mason has succeeded him at Rutherfordton. The Church at Morganton is now vacant.

There are at present eight Candidates for Holy Orders in the Diocese, viz: Stephen C. Roberts, Henry A. Skinner, Reginald H. Murphy, Walter Weir, Luther Eborn, Lucian Holmes, Geo.

W. Whitfield, William C. Hunter.

In this connection, I must request Candidates for Orders to give me at least three months notice of the time when they wish to apply for Ordination. Examinations are frequently so hurried, just before Ordination, as to be unsatisfactory.

As one very important means of advancing the growth of the Church, I desire to urge on the Clergy and Laity the importance of vigorously sustaining the Society for Church Extension, established at the last Convention. Our weak Parishes, and they are the most numerous with us, must be aided in building their churches, and this can best be done by general collections for that purpose and systematic distribution of what is thus collected. These are the objects of the Society.

And now, Brethren, with humble thanks to Almighty God for His past undeserved favors, and with earnest prayers for their continuance and increase, I commend you to His directing and sustaining grace, for wisdom to know His will and strength to do it.

Morning Prayer was said by the Rev. E. M. Forbes, assisted by the Rev. G. B. Wetmore, and a Sermon by the Rev. W. E. Snowden, from the 16th chapter of St. John's Gospel, 15th and 18th verses.

The Convention met according to adjournment.

Certificates of Lay Delegation from the following Churches

were read, and the following had elected Delegates to this Convention:

REPORT of Rev. J. S. Hanckel, officiating temporarily in Buncombe County.

Although my Canonical residence and Pastoral charge be in South Carolina, it is only proper that I should report services rendered during last summer within the Diocese of North Carolina.

The scene of my labors was the Valley of the French Broad, in a settlement of Episcopalians from South Carolina, near Dennis' Rock. My duties commenced early in June and terminated the 2d Sunday in November. On each Lord's day (with one exception) I preached to the Episcopalians of the neighborhood, at a Carriage Shed of Mr. F. W. Johnstone.

Every Sunday afternoon a second service was held at the Methodist Camp Ground. Upon both these services other denominations attended in considerable numbers, with a regularity and apparent interest in the Word preached that was sustained to the last.

On two Sundays in each month a third service was held at an early hour of the morning in a Baptist Church near Cathey's Creek.

In July a Congregation was duly organized in conformity with the Canons of the General Convention and of North Carolina, under the name of "St. Paul's in the Valley," and a Vestry (consisting of 5,) elected.

A site, central and well adapted to Church and Parsonage, (of 15 acres) was given by the Chairman of the Vestry.

A subscription for a Church was raised among the members of the Parish and neighbours, that was almost doubled by the liberality of the Episcopalians of Flat Rock. With additional aid promised by the Episcopalians of Charleston, we hope to have a plain but commodious Church ready for Consecration before the close of the current year.

The Rectorship was tendered to me, but as I already sustain that relation to a Parish in South Carolina, my connection with "St. Paul's in the Valley" is only temporary, (it being possible for me to render them service only from the middle of May to the middle of November,) until such time (we trust not remote,) as the Congregation shall be able to sustain and secure a permanent Pastor.

In addition to the above, I have Baptized 5 white and 8 colored children in neighboring Parishes, all of which, it is presumed, will be reported by the Rectors of those Parishes in which these Baptisms were administered. I have also married one colored couple in the Parish of St. Paul's, Edenton.

During the greater portion of the past year I have been able, by God's help, to say "Daily Morning and Evening Prayer." The Morning service is attended by the family, the negro children, and those servants who are not employed in the fields. The Evening Service (which is held at night) has been mainly attended by the servants upon this and the estate of Charles L. Pettigrew, Esq. The Holy Communion has been duly celebrated by me at stated times; and it is to be remarked, that whilst attendance by the adult servants upon these services is entirely voluntary, still the congregations have in all cases been very good.

I have instructed the children of the servants in the Catechism daily, unless prevented by some unavoidable circumstance. There are about 100 children of both sexes who attend this School. Beside this, there is a School held each Sunday morning by the Master, which is attended by the children of the Day-School, and about 126 of the older servants, who are all faithfully instructed by him in the Doctrines and duties of our most holy Faith.

Those who are immediately engaged in the work of imparting religious instruction to the slaves in this place, are more and more convinced that the system of the Church, as set forth in the Word of God and in the Book of Common Prayer, is the best system for their spiritual improvement, and indeed is the only one, to lead them to Him who is "the way, the truth, and the life," and who is "the Head over all things to the Church, which is His body, the fulness of Him that filleth all in all."

During the past year the experiment has been made of a quarterly collection at the public Offertory for the support of the Rector, with the result thus far of a larger income than before.

In addition to the offerings reported above, a subscription has been opened for the erection of a new Church. With respect to this, some statements are perhaps due for the information of contributors in other parts of the Diocese. The enlargement and repair of the present wooden edifice were contemplated and funds collected for the purpose, when it pleased God to put it into the heart of a Layman in a neighboring Parish to offer voluntarily a contribution of \$1000, towards a new edifice of brick.

This was responded to in the Parish itself by an additional subscription of between twelve and thirteen hundred dollars. As however, there was still needed a considerable additional sum to make up the requisite amount, and as

the case did not seem to come within the present reach of the Diocesan Church Building Society, the Rector undertook to make the circumstances known by private circulars. In doing so, he endeavored to avoid any thing like importunity, (except perhaps to a few personal friends,) and to confine himself to a statement of the facts, for the information of those who having laid by them in store for religious purposes might be looking for appropriate objects. This circular was kindly responded to, four hundred dollars being contributed by two other members of the Church in a neighboring Parish, and about three hundred being received from other parts of the Diocese.

The Rector takes this public mode of thanking those friends who have aided the work thus far, and acknowledging His goodness by whose grace it has been begun and carried on.

The Committee on the subject of the Works of Bishop Ravenscroft made the following Report:

The Committee charged with the sale of the Works of Bishop Ravenscroft report: That since the date of the last Report, they have made sales of the Work amounting to the sum of \$306 04.

Of this sum they have paid, on freights and insurance, \$10. The remainder, \$296 04, has been paid to the Treasurer of the Convention.

There are, at various points within the Diocese, 22 copies in sheep and 3 copies in cloth, and on sale at Messrs. Hooker & Co., Philadelphia, 20 copies in sheep and 5 copies in cloth, from which no returns have been received.

The remaining bound copies, together with 250 copies folded and collated but not bound, are in possession of the Committee, and are insured.

It will appear from the above statement, that of the amount advanced by the Convention in aid of this publication, viz: \$631 78, \$353 04, more than half, have been refunded.

It is the desire of the Committee to refund the whole amount as soon as possible; and they believe that if the same effort were made by the Clergy generally as has been made by a few,—if those, whether Clergymen or Laymen, who love the memory of Ravenscroft, or who sympathize with the Missionaries, would exert themselves in this behalf, this result, and, indeed, much more, might easily be accomplished.

By comparing this statement with that made to the last Convention, it appears that the balance now in hand is larger by \$718 20 than that then reported; while at the same time the amount paid out for Missionary services is greater than that for the previous year by \$1019 00.

This result is owing mainly to increase in the collections made by the Bishop and to interest on monies loaned, and interest on the Permanent Missionary Fund transferred.

The Committee notice also with pleasure that the amount paid on the Assessment is increased by \$297.78. While they rejoice to see this fund, so important to the interests of the Church, increased in any way, they consider punctual payment of the Assessment as the most certain sign of a proper interest in this subject. Because, it shows that Parishes are acting upon principle—upon a settled determination to support and extend the Church. We count upon Parishes that pay their Assessments with a feeling of assured confidence, because we know that by the very fact of regular giving, they acquire an interest in this department of the Church's work. We do not care so much about fitful and spasmodic efforts; but we look with pleasure upon true Christian liberality founded in principle—in a sense of the obligations under which we lie to Jesus Christ, the great Benefactor—a liberality, we are happy to say, exemplified in certain Parishes, the names of which would not be hard to find on the Journal.

There are Parishes that pay their assessments nobly, even though hard pressed with other pecuniary obligations. There are others that do what they can, though not able to meet the assessments in full. There are "other some" that strangely neglect the whole subject. Your Committee are not authorized to teach or reprove, but they hope it will be no harm to express the charitable wish, that all such Parishes may soon be converted to a deep interest in so noble a work as the Church is now striving to accomplish through this fund, and may thereby partake of that profit and pleasure, which the rest of their brethren reap from the discharge of duty.

The Missionaries receiving aid from this fund are mentioned in the Treasurer's Report, to which the Convention is respectfully referred.

The changes that have taken place since the last Convention are as follows: Mr. Bland has removed from Rutherfordton, to Lincolnton; Rev. Mr Mason has taken charge of Rutherfordton; Rev. Mr. Curtis has returned to the Diocese and taken charge of Hillsborough; Rev. Mr. Pickett has removed from the Diocese, and thus left Morganton vacant; Rev. Mr. Gallagher has left the Diocese.

REPORT of Committee on Unfinished Business.

The Committee on Unfinished Business would report, that it finds on the 331st page of the Journal of the General Convention of 1856, "Proposed" Articles Nos. III and VI, containing Amendments of the Constitution for the Government of the Protestant Episcopal Church in the United States of America, which are to be "made known to the several Diocesan Conventions before they shall be finally agreed to or ratified in the ensuing General Convention," according to Article IX of the said Constitution. The Committee would respectfully call the attention of the Convention to these two "Proposed" Articles, leaving to its discretion any action upon them at this present time.

"ARTICLE III.—Whenever General Conventions are held, the Bishops of this Church shall form a separate House, with the right to originate and propose acts for the concurrence of the House of Deputies, and all acts must pass both Houses."

"ARTICLE VI.—The mode of trying Bishops shall be provided by the General Convention. The Court appointed for that purpose shall be composed of Bishops only. In every Diocese the mode of trying Presbyters and Deacons may be instituted by the Convention of the Diocese, but the General Convention may establish a Court of Appeals for the revision of the decision of Diocesan Courts. None but a Bishop shall pronounce sentence of admonition, suspension, or degradation from the Ministry, on any Clergyman, whether Bishop, Presbyter, or Deacon. Such Court of Appeals not to revise the determination of any question of fact."

The Committee on the Relief Fund made a Report, which was withdrawn.

On motion,

Resolved, That the Resolutions of 1848, and that of 1856, be referred to a Committee of three persons.

The Bishop appointed the Rev. N. Collin Hughes, and Messrs. Henry A. London and E. L. Winslow.

On motion, the Convention adjourned to 9 o'clock, Saturday morning.

Evening Prayer was said by the Rev. A. A. Watson, and a Sermon preached by the Right Rev. James H. Otey, from the 44th chapter of Jeremiah, 16th verse.

SATURDAY, MAY 30.

The Convention met pursuant to adjournment.

Prayers were said by the Rev. Dr. Mason, who, in the absence of the Bishop, took the Chair.

REPORT of the Standing Committee.

The Standing Committee of the Diocese of North Carolina respectfully report: That during the past Conventional year they have performed the following acts:

On the 23d of May 1856 testimonials for Deacon's orders were signed on behalf of Thomas G. Haughton.

On the 23d of June 1856 testimonials for Deacon's orders were granted te Samuel S. Barber.

On the 13th Nov. 1856 testimonials for Deacon's orders were granted to Israel Harding and to John V. Stryker; also to Luther Eborn, desirous of becoming a candidate for Orders.

On the 3d of Dec. 1856 testimonials for Deacon's orders were granted to Silas D. Davenport.

On Feb'y 6, 1857, testimonials were granted to George W. Whitfield, desirous of becoming a candidate for Orders.

On Feb'y 26, 1857, testimonials were granted to Lucian Holmes, desirous of becoming a candidate for Orders.

On the 11th March 1857 testimonials for Priest's Orders were granted to the Rev. F. W. Hilliard and the Rev. Wm. Murphy.

On the 11th April 1857 testimonials were presented of the election of the Right Rev. William Ingraham Kipp to be Diocesan Bishop of the Diocese of California. To which election the Committee gave their consent, as required by the ninth Canon of 1856 of the General Convention.

On the 25th May 1857, testimonials for Priest's Orders were granted to the Rev. Thomas G. Haughton. At the same time, the Committee declined granting testimonials on behalf of the Rev. Benj'n S. Bronson, as the testimonials presented by him to the Committee, were imperfect.

During the present Convention, testimonials have been granted to the following persons: To the Rev. Benj'n S. Bronson, for Priest's Orders; to the Rev. George B. Wetmore, for the same; and to Wm. C. Hunter, desirous of becoming a Candidate for Orders.

For the greater facility and certainty in the transaction of their business, the Standing Committee, besides their annual meeting at the Convention as determined by Canon, have resolved to hold the following stated meetings at

Raleigh, namely: On the fourth Saturday of February, August and November respectively; and particularly request of all who may be concerned, that hereafter all papers requiring their action be sent to them in due time before one or other of these stated meetings.

The Committee of Finance made their Report, as follows, which was accepted, and the resolution accompanying the same was adopted:

REPORT of the Committee of Finance.

The Committee of Finance respectfully report: That the several accounts of the Treasurer of the Convention submitted to them have been carefully examined and are believed to be correct, with the exception of one small payment made by the Treasurer, as the Committee suppose, under a misapprehension of the Revenue Laws of this State. The error, if it be one, will doubtless be promptly corrected on application to the proper officers. The Committee are gratified to find the Finances of the Diocese to be, on the whole, in a healthy condition, though at the same time, they observe with regret that a number of Parishes are more or less delinquent in the payment of their assessments. They earnestly request the attention of the Ministers and Vestries of delinquent Parishes to this subject, and hope that suitable efforts will be made in future to meet their obligations. With a view to secure increased punctuality, the Committee have carefully examined the former scale of assessments, and have made a few changes which they believe to be just and proper, and which they hope will be acceptable to the Convention. These changes are indicated in the accompanying scale of assessments, which the Committee wish to be regarded as a part of this Report.

The Committee would further state, that they have examined the accounts and vouchers of the Treasurer of the Education Committee and find them correct. As the several accounts are usually printed in an appendix to the Journal, further details are deemed unnecessary.

The Committee will barely add, in conclusion, that in their opinion there is a sufficient balance in the hands of the Treasurer to meet the requisitions of the Resolution of the last Convention for the payment of the travelling expenses of the Clergy attending this Convention, and recommend that the acting Treasurer pay the same.

The Committee to whom has been referred that portion of the Bishop's Ad-

dress which relates to the establishment of a University in the Southern and South-western States, have had the same under consideration, and beg leave to submit, as the result of their deliberations, the following resolutions:

First: That in compliance with the suggestion of the Address of the Bishops of the Southern and South-western Dioceses, this Convention will now proceed to elect one Clergyman and two Laymen to represent this Diocese in the meeting to be held in reference to the proposed Institution, at or near Chattanooga, on the fourth day of July next.

Secondly: That in taking this step this Convention does not intend to commit this Diocese to the action of the said meeting, but expressly reserves the same for the decision of the next Convention.

All of which is respectfully submitted,

Resolved, That the expenses of the Clerical Delegate to the meeting of the

friends of the Southern University, from this Diocese, be paid by the Treasurer of the Diocese.

On motion, the Convention proceeded to appoint the Clerical Delegate, under the Resolutions adopted.

Rev. Mr. Van Antwerp and Mr. Kemp P. Battle were appointed Tellers, who reported that the Rev. M. Ashley Curtis, D. D., was duly elected.

On motion, the Convention then proceeded to elect the two Lay Representatives. The Rev. Mr. Geer and Mr. Collins were appointed Tellers, who reported that Hon. Thomas Ruffin was elected.

Charles T. Haigh was elected Treasurer of the Diocese for the ensuing year.

On motion,

Resolved, That the Secretary cause 1500 copies of the Journals to be printed and circulated.

The Committee on the Resolutions of 1848 and the Resolution of 1856, on the subject of the Relief Fund, made a Report, which was accepted:

REPORT of the Committee on the Relief Fund.

The Committee on the Relicf Fund respectfully report: That during the past year, there has been paid into the Treasury the sum of \$503-81, which added to a balance of \$58 on hand at last Convention, makes a total of available funds for the past year of \$561-81. Of this, \$276-03 have been paid to each of the ladies entitled to its benefits, leaving a balance in the Treasury of only \$9-75. By a comparison with the scale of assessments it appears that there has been a deficiency in the contributions amounting to \$106-49, and in consequence of the small balance on hand at the present Convention as compared with that of the last, the disbursements of the present year must be quite inadequate to supply the wants of the beneficiaries of this fund, unless greater exertions are made by delinquent Parishes to meet the demands made upon them.

Rev. Mr. Parker baptized an Adult.

Convention met pursuant to adjournment.

The unfinished business of the morning, when the Convention adjourned, being the election of the Delegate to represent the Diocese at the meeting of the friends of the Southern University, was resumed, and, on counting the ballots, Dr. Thomas D. Warren of Edenton was elected.

The Representatives from the Diocese of North Carolina consist of: The Rev. M. Ashley Curtis, D. D., Hon. Thos. Ruffin and Dr. T. D. Warren.

The Committee on the State of the Church made the following Report, which was accepted:

REPORT of the Committee on the State of the Church.

The Committee on the state of the Church, respectfully report: That from the Bishop's Address and the Parochial Reports, they find that during the past Conventional year there have been three hundred and twenty-seven white Infants, and two hundred and twenty-eight colored Infants baptized; that there have been sixty-two baptisms of white Adults, and twenty-five baptisms of colored Adults; that the rite of Confirmation has been administered by the Diocesan to two hundred and forty white persons, as appears in the Parochial Reports, to which ten must be added from the Bishop's Address, and sixty-three colored persons; that there are reported two thousand three hundred and forty-one white Communicants, and three hundred and forty-five colored Communicants; and eleven hundred and five white Catechumens, and four hundred and eighty-eight colored Catechumens. Contributions are reported to the amount of \$25,160 88. Whole number of baptisms reported, six hundred and forty-two; whole number of Confirmations reported, three hundred and thirteen, being an increase of forty-one over the number re-Whole number of Communicants reported, two thousand six ported last year. hundred and eighty-six; being an increase over last year of one hundred and eleven. Whole number of Catechumens reported, fifteen hundred and ninetythree, being an increase of two hundred and forty-nine over the number reported last year.

Three Churches have been consecrated and the corner-stones of two others have been laid. There are eight Candidates for Holy Orders in the Diocese. The Committee are gratified to learn that increased attention has been paid to providing Rectories for the Clergy. There is a gratifying increase in the amount of the general contributions and also in the contributions to the Missionary fund. It is hoped that those Parishes which have been at any time delinquent, will hereafter be more exact in the payment of the assessments.

The Committee beg leave to express the opinion, that considering the opportunities of the Church, the number of colored Catechumens reported is smaller than might reasonably be expected from the zeal of the members of the Church.

They trust that the members of the Convention will in their several spheres, urge forward the christian instruction of the colored class, so entirely committed by Providence to the superintending care of the educated members of the Church, and so dependent upon their benevolence and christian love.

In conclusion the Committee beg leave to express their deep sense of gratitude to God for the numerous blessings vouchsafed to the Church in this Diocese during the past year, and for its present peace and prosperity.

The following persons were admitted to the Order of the Priesthood: Rev. William Murphy, Rev. George B. Wetmore, Rev. B. S. Bronson, and Rev. Thos. G. Haughton. Rev. Mr. Cheshire presenting Rev. Messrs. Murphy and Wetmore, and Rev. Mr. Prout presenting Rev. Messrs. Bronson and Haughton.

After which the Holy Communion was administered by the Bishop, assisted by the Rev. Dr. Drane, to the Clergy; and by the Rev. Messrs. Cheshire and Prout, assisted by the Rev. Messrs. Bronson and Haughton, to a very large number of recipients.

Afternoon, Prayers were said by the Rev. Mr. Patterson, and a Sermon by the Rev. Mr. Bronson, from the 17th chapter of Revelations, 22d verse.

Four Children were Baptized.

Evening Prayer was said by the Rev. Mr. Cheshire, and a Missionary Sermon preached by the Rev. M. Ashley Curtis,

D. D., from the 10th chapter of the Gospel according to St. Mark, 21st verse.

A collection for the Missionary operations of the Diocese, amounting to \$119 08, was made.

CONSTITUTION

OF THE

Protestant Episcopal Church in North Carolina.

ARTICLE I.

The Protestant Episcopal Church in this State, accedes to, recognises and adopts, the General Constitution of the Protestant Episcopal Church of the United States, and acknowledges its authority accordingly.

ARTICLE II.

There shall be an Annual Convention of the Church in this Diocese, at such time and place as may be fixed by the next preceding Convention.

ARTICLE III.

The Convention shall be composed of Clergymen and Laymen. Each regularly ordained Minister, of either order, being settled with a parochial charge in this State; or being a President, Professor, or Instructor of youth, in any Seminary of Learning in this State; or being a Missionary of the Protestant Episcopal Church, acting under the direction of the Ecclesiastical authority of this Diocese, shall be entitled to a seat and a vote in the Convention; provided he shall have been actually and canonically a resident of the State, or shall have been a Candidate for Orders belonging to this Diocese, for the space of twelve calendar months next before the Convention. Each Church or Congregation in this Diocese, which is now a member, or shall hereafter be admitted a member of this Convention, shall be entitled to send to the Convention one or more Lay Delegates, not exceeding four, to be chosen by the Vestry or by the Congregation, from among the members of such Congregation. Provided, however, that no one person shall be the Delegate of more than one Church or Congregation at the same Convention. Provided, also, that this Article shall not exclude from the Convention any Clergyman who is now and shall continue to be a resident in this State, and who is now a member of this Convention. Provided further, that the Lay Delegates of no congregation which is formed after a vacancy has occurred in the office of Bishop, by death or otherwise, shall vote in the election of the next successor in the office, or upon any question touching such election.

ARTICLE IV.

Every Convention shall be opened with Prayer, and a Sermon, which shall be delivered by some Clergyman who has been nominated by the Ecclesiastical authority of the Church.

ARTICLE V.

A President shall be annually appointed, who shall preside in all meetings of the Convention, except when a Bishop shall be present, when he shall, *ex-officio*, be President.

ARTICLE VI.

A Secretary shall be annually chosen, whose duty it shall be to keep a record of the proceedings, and to give timely notice to each Minister and Vestry, of the time and place of each meeting of the Convention in this Diocese.

ARTICLE VII.

A Standing Committee, of not less than three nor more than seven persons, shall be annually chosen by ballot. They shall have power to admit Candidates for the Ministry, and when there is not a Bishop, they shall examine and pass on the testimonials of foreign Clergymen. They may call special meetings of the Convention; and shall transact all other business as they are empowered to do by the Constitution and Canons of the General Convention. They shall also have power to fill any vacancies that may occur in their own body by death, removal, or otherwise, during the recess of the Annual Convention.

ARTICLE VIII.

A majority of the Standing Committee of this Church shall at all times be Clergymen of this Diocese; and no Laymen shall be appointed a member of said Committee, except he be a Communicant of the Episcopal Church.

ARTICLE IX.

In all questions which shall come before the Convention, when it shall be required by the Delegation of one Church or Congregation, or by any one Clerical member, the Laity shall vote by Congregations. And when it shall be so required, the two orders shall vote separately, and in the latter case, the concurrence of both orders shall be necessary to make a decision of the Convention. When no such division of the Convention shall be required, each member of the Convention, both Clerical and Lay, shall be entitled to one vote.

ARTICLE X.

The election of a Bishop in this Diocese shall be made in the following manner: The order of the Clergy shall nominate and appoint by ballot, some fit and qualified Clergyman for that office, and if this appointment be approved by the Lay order, he shall be declared duly elected. In the above-mentioned nomination and appointment a majority of each order shall

determine the choice—provided that two-thirds of all the Clergy entitled to votes be present; and two-thirds of all the Congregations entitled to votes be represented; otherwise two-thirds of the votes of each order shall be necessary to determine the choice.

ARTICLE XI.

This Constitution shall not be altered or amended, except by the concurrent votes of two-thirds of the attending members at an annual meeting of the Convention—such vote being taken in accordance with the preceding provisions of this Constitution.

ARTICLE XII.

Each Church or Congregation in this Diocese, which is now a member, or shall hereafter be admitted a member of this Convention, shall be entitled to elect by its Vestry, in addition to those authorized by the third Article, four Alternate Delegates, to fill any vacancy in the delegation elect in the order of their election.

CANONS

OF THE

Protestant Episcopal Church in North Carolina.

CANON I.—Passed April 1817.—Of Presentments.

Every trial of a Clegyman in this Church, for misbehaviour, shall be on presentment, made to the Bishop by the Convention, by the Vestry of the Parish to which the Clergyman belongs, or by three or more Presbyters of the Church. In every presentment the charge or charges shall be distinctly specified.

CANON II.—Passed April 1817.—Of the Trial of a Clergyman.

For the trial of a Clergyman, the Bishop shall appoint three Presbyters, who shall be constituted a board for trying the accused person. The Bishop shall fix the time and place of trial; of both which at least a month's notice shall be given to the party accused; and should he neglect or refuse to attend, the trial shall proceed. The Board thus constituted, shall examine

fully, the charges alleged, and keep a minute and accurate record of the testimony of the witnesses, and of every question and proceeding that comes before them. No charge shall be substantiated on the testimony of less than two witnesses. On the examination of any witness, should the accused party require it, an oath or affirmation shall be administered by a magistrate. In all questions, a unanimous vote shall be necessary to a decision. Having come to a decision on the charge or charges respectively, the Board shall communicate their decision to the Bishop—and also, in case they have found the accused guilty, the sentence which, in their opinion, should be pronounced. A certified copy of the record of their proceedings shall be laid before the Bishop, and his judgment in the case be final.

CANON III.—Passed April 1817.—Of the sentence to be pronounced upon a Clergyman found guilty of Misbehaviour.

This sentence may be admonition, suspension, degradation from the ministry, or excommunication; and shall be pronounced by the Bishop and communicated to every parish in the Diocese.

CANON IV.—Passed April 1819.—Respecting the call of a Special Convention.

When a Special Convention is called, it shall be the duty of the Secretary in issuing the notifications, to specify therein the business and purposes for which the Convention is to be assembled.

CANON V.—Passed April 1819.—Concerning Parochial Registers and Reports.

In order to give effect to the 40th Canon of the General Convention in 1808, it is hereby required that each minister of this Church shall keep a register of all the Baptisms, Marriages, and Funerals, solemnized by him in the discharge of his Ministry; specifying the names of the parties married, the name and time of the birth of the child baptised, with the names of the parents, and the name of the person buried, and the time when each rite is performed; which register shall be transcribed, at least once in every month, in a book to be kept for that purpose belonging to the Vestry of each Church. He shall also keep a register of the names of the Communicants within his care. And it shall be the duty of each Minister to report annually to the Bishop, at the meeting of the Convention, the amount or sum total of said registers, and also the amount of the register of adults required to be kept by the aforesaid Canon of the General Convention, together with a written account of the state of the Parish. Which reports shall be by the Bishop communicated to the Convention, and read in their presence, in order to promote a general knowledge of the state of the Church; and shall afterwards be preserved by the Secretary among the records of the Convention.

CANON VI.—Passed April 1819.—The Clergy required to attend the Meetings of the Convention.

Whereas the regular attendance of the Clergy at the meetings of the Convention, is of essential consequence to the interest of the Church, this duty is hereby enjoined on them. At the opening of each Convention, the names of the Clergy entitled to seats therein shall be called over, the absentees noted, and at the ensuing Convention they shall be called upon for the reasons of their absence.

CANON VII.—Passed May 1842, instead of the one passed May 1821.—Of the forming of a Congregation.

Any ten or more Adults may form themselves into a Congregation of this Church, and be received into union with this Convention, by consenting to be governed by the Constitution and Canons of the Church in these United States, as set forth in General Convention, and by the Constitution and Canons of the Church in this Diocese; by assuming a name to designate such Congregation; by electing a vestry of four or more persons, not exceeding twelve; and by subscribing the following form of Certificate, to be presented to the Convention of the

Church in this Diocese:

We, the undersigned, being assembled for the purpose of forming ourselves into a Congregation of the Protestant Episcopal Church in these United States, do certify that we have consented to be governed by the Constitution and Canons of the Church, as set forth in General Convention, and the Constitution and Canons of the Church in this Diocese; that we have assumed the name of —, [here should follow the name and place;] and have elected the following persons Vestrymen, towit: [names of Vestrymen.] In witness whereof, we have subscribed our names, this —— day of ——, in the year of our Lord ——.

CANON VIII.—Passed May 1824.—Respecting Annual Contributions.

An Annual contribution shall be made by each Congregation in this Diocese, to defray the necessary expenses of the Bishop's visitations, and the contingent charges of the Convention, and likewise to furnish our quota to the contingent expenses of the General Convention, which sums shall be remitted to the Treasurer of the Convention as they shall be received.

CANON IX.—Passed May 1824.—Respecting the Bishop's authority to change the place of holding the Convention.

In all cases where a contagious disease, or any other sufficient cause, shall render it necessary, the Bishop may change the place of meeting appointed by the Convention.

CANON X.—Passed April 1825.—To appoint a Treasurer and to prescribe his duties.

A Treasurer of the Convention shall be appointed annually. He shall have the custody of all moneys belonging to the Convention, and shall render to the Convention an annual account of all moneys so entrusted to him. The said Treasurer shall, ex-officio, receive all money from the Trustees or General Agent of the Fund for the Episcopate as it may be collected, and vest the same, and all interest and dividends thereon, in the Capital Stocks of some one of the Banks of the State.

CANON XI.—Passed May 1827.—Authorizing the Treasurer to invest the Money belonging to the Convention.

The Treasurer of the Convention shall, from time to time, invest in stock, or put out to interest on good security, as he may deem most advantageous, all moneys in the Treasury not especially appropriated, and all sums received for the use of the Episcopate.

CANON XII.—Passed May 1830.—Pointing out the additional duties of the Secretary.

It shall be the duty of the Secretary to preserve for the use of the members of the Convention, during its Sessions, six copies of the Constitution and Canons of this Church; and each year to preserve for the same purpose, six copies of the printed Journals of Convention. These papers the Secretary shall cause to be present at each Convention.

CANON XIII.—Passed May 1841.—Relating to the Standing Committee.

It shall be the duty of the members of the Standing Committee to hold meetings for the transaction of business at every Convention of the Diocese; and this Canon is hereby declared to be due notice to each member of the same, to assemble at the time and place of the meeting of each Annual Convention.

RULES OF ORDER.

1. The organization of the Convention by the President.

2. The Convention shall then proceed to appoint a Secretary

by ballot.

3. The Committees on the State of the Church, and of Finance, and the Committee on New Congregations, each consisting of five, and the Committee on Unfinished Business, consisting of three, and all special Committees, shall next be appointed.

4. The Bishop's Annual Address.

5. Parochial Reports to be presented to the Convention.

6. Report from the Standing Committee.

7. Report from the Treasurer.

8. Reports from Committees appointed by the last Convention.

9. Reports from Special Committees.

- 10. When the President takes the Chair, no member shall continue standing, or shall afterwards stand up, except to address the Chair.
- 11. Every member who shall deliver his opinion, or speak in any debate, shall, with due respect, address himself to the President, and confine himself strictly to the point in debate.

12. No motion shall be debated, or shall be considered as before the Convention, unless seconded; and, if required, re-

duced to writing and read by the Secretary.

13. When a question is under consideration, no motion shall be received, unless to lay it upon the table, to postpone it to a certain time, to postpone it indefinitely, to commit it, to amend it or to divide it; and motions for any of these purposes shall have precedence in the order herein named. The motion to lay upon the table, and to adjourn, shall always be in order.

14. A question once decided, shall stand as the judgment of the Convention, and not be drawn again into debate, except with the consent of two-thirds of the Convention: *Provided always*, that any member of the Convention voting in favor of any resolution, may, on the same day on which the vote is taken, move a reconsideration of said vote.

15. No member shall be absent from the Sessions of the Convention, unless he have leave, or be from sickness unable to at-

tend.

16. When the Convention is about to rise, every member shall keep his seat until the President leaves the Chair.

RESOLUTIONS CONTINUING IN FORCE,

ADOPTED AT VARIOUS SESSIONS OF THE CONVENTION.

Resolved, That with the consent of his Vestry, it be the duty of every settled Clergyman, not having more than two Congregations in his Parochial Cure, to devote one Sunday in every three months to Missionary labor, and that the Bishop have the power of regulating the time and place of service.—Adopted May 1832.

Resolved, That the Vestries of such Churches in this Diocese as may be destitute of Clergymen, be requested to forward to the Secretary, at least one month before the meeting of every Annual Convention, a report of the state and condition of said churches.—Adopted June 1835.

Resolved, That the Treasurer be requested to annex to his Report, the list of those congregations which have failed, or may hereafter fail, to pay the sums assessed for the Bishop's Salary and Contingent Fund, in the hope, that upon such deficiency being brought to their notice, they may transmit the same promptly.—Adopted May 1836.

[After the adoption of the following resolutions, by "the Bible, Prayer Book, Tract and Missionary Society of the Diocese," the Missionary operations of the Diocese were placed under the charge of a Missionary Committee, consisting of two Clergymen and three Laymen:]—

Resolved, as the sense of this meeting, that the Church of Christ is the only proper Missionary Society, being divinely instituted, and wisely adapted, for the conducting of all operations for the spread of the Gospel.

Resolved, That in accordance with the foregoing principle, the Convention of the Church in this Diocese be respectfully requested to take under its own immediate control all the Bible, Prayer Book, Tract and Missionary operations of the Diocese.

Resolved, That should the Convention accede to the foregoing request, and assume the existing responsibilities of this Society to the Missionaries and others, all the records, and the property of every description, belonging to the Society, be delivered to such persons as the Convention may appoint to receive them,—and this Society be then dissolved.

Resolved, That a Committee be appointed by this Society, to

communicate the foregoing resolutions to the Convention, and respectfully to request their adoption of the plan proposed therein.

Resolved, That a Committee of three be appointed to examine the accounts of the Treasurer, and to make out a list of all the property and of all the existing liabilities of the Society, and that the Committee report to this Society at its next meeting.—Adopted May 1836.

Resolved, That it be recommended to every Clergyman, to procure annually the sum of at least \$5, in money or books, for

the increase of said Library.

Resolved, That each Clergyman present the Librarian with a list of the Books in his own or his Parish Library, so that unnecessary duplicates may not be purchased, and that each may know where to apply for any needed set of books.-Adopted May 1841.

Resolved, That every Clergyman of this Diocese, having a Parochial Cure, be hereby enjoined to press upon his congregation, in a public discourse at least once a year, the high obligations under which we lie to contribute from our means, on the principle of Systematic Charity, as recommended by the Bishop and adopted by the Diocese.

Resolved, That each Clergyman having a Parochial Cure, or where there is no Clergyman, the Wardens of the Parish, be requested to transmit quarterly, to the Treasurer, the amount collected up to that time for Missionary operations. - Adopted

May 1844.

Resolved, That hereafter, the Constitution and Canons of the Church, and Resolutions of Conventions continuing in force, with the Rules of Order, shall be printed as an Appendix to the Journal of each session of the Convention.—Adopted May 1844.

Whereas, the General Convention of 1844 enacted a Canon, allowing to each Bishop, under certain limitations and restrictions, a due discretion in the calling, trial, and examination of Deacons, whenever he should be requested so to do by the Convention of his Diocese: Therefore

Resolved, That this Convention does hereby request the Bishop of this Diocese to use the discretion allowed in said Canon, so far as may seem to him for the glory of God and the

good of his Church.—Adopted May 1845.

Resolved, That hereafter it shall be the duty of the Secretary of each Vestry to transmit to the Minister of the Parish where the Annual Convention of the Diocese may sit, a certificate of the election of the Delegates to said Convention; and to furnish a duplicate of said certificate to some one of said delegates, whose duty it shall be to hand the same to the Secretary of the Convention in time for proper action thereon.—Adopted May 1847. Resolved, That a Committee, to consist of one Clergyman and two Laymen, be annually appointed by the President of the Convention, to be called "the Committee for the relief of disabled Clergymen, and of the Widows and Orphans of deceased Clergymen," whose duty it shall be to ascertain and report the amount of money which will probably be wanted during the succeeding year for such purpose, to make a definite appropriation in each and every case requiring aid, and to make a scale of assessment, upon the Parishes, proportioned generally to the existing scale of assessments for Bishop's salary and contingent fund. Provided, that in case there be at any time no proper objects, there shall be no call made.

Resolved, That the Treasurer of the Convention shall be the Treasurer of this Committee, that he receive the moneys contributed to this Fund, and pay them out on the receipt of the individuals, or their representatives, to whom the appropriations

may have been made.—Adopted May 1848.

Resolved, That the Treasurer be and he is hereby directed to pay the sum of \$50 to all Clergymen who may be appointed and attend as Delegates to the General Convention of the Church from this Diocese.—Adopted May 1848.

Resolved, That all sums received for Missionary purposes, by bequest or other extraordinary donation, shall, if consistent with the will of the donors, be paid over to the Treasurer of the Diocese, with directions to fund the same; and furthermore, that for the present, and until otherwise ordered, he be directed to add to the principal the interest as it may accrue.—Adopted May 1850.

Resolved, That the salary of the Bishop of this Diocese be increased, and fixed at Two Thousand Five Hundred Dollars.—

Adopted May 1853.

Resolved, That so much of the resolution, adopted May 23d, 1845, providing for the appointment of Trustees for the Church in this Diocese, under the Act of Assembly ratified the 8th day of January 1845, entitled "An Act to amend the Revised Statutes entitled Religious Societies," as appoints Levi Silliman Ives, lately Bishop of the Diocese, one of the Trustees, be and the same is hereby rescinded and repealed; and that hereafter the Bishop of the Diocese, when there is a Bishop, and when there is no Bishop, the President of the Standing Committee, ex officio, with the two Laymen elected or who may be at any time elected by the Convention, under the said resolution, shall be the Trustees for the Protestant Episcopal Church in this Diocese, for the purposes in the said Act mentioned.—Adopted May 1853.

Resolved, That a Standing Committee of one Clergyman and two Laymen, to be called the Education Committee, be appointed, of which the Bishop shall be the Chairman ex officio,

who shall receive, take charge of, invest and disburse any fund or funds that may be contributed, and take such steps as they may deem best to raise funds for the purpose of aiding young men who may be determined to enter the Ministry of this Church, and report their proceedings to the next Convention.

Resolved, It is hereby recommended, that a collection be made for the benefit of the Education Fund, in every Parish of this Diocese, on Whit-Sunday of every year.—Adopted May

1854.

Resolved, That from and after this Convention the Treasurer of the Convention be instructed to pay to the Secretary, whatever bill of expenses he may render, incurred by his attendance upon the Sessions of this body.

Resolved, That the Bishop be requested to appoint some one to preach before each Annual Convention of the Church, a

Sermon on the subject of Christian Education.

Resolved, That the Treasurer of the Convention be directed to pay annually to the several Clerical Members of the Standing Committee, any expenses necessarily incurred by them, in attending the meetings of that body.

Resolved, That the contributions to the Relief Fund be

hereafter distributed under the direction of the Bishop.

Resolved, That the recommendation of the Committee of Finance, in regard to Clergymen attending the Convention, be adopted, and that from and after the next Convention, the Treasurer be directed to pay such expenses out of the fund for the contingent expenses of the Convention.—Adopted May 1856.

Resolved, That in case it may be necessary to make any alteration in the Assessments from the different Parishes, the Clergymen, or the Delegates from the Congregations desiring the same, may appear before the Committee of Finance, whose duty it shall be to take action thereon, and report the same to the Convention.—Adopted May 1857.
