Robert-Lettis Hooper, Esquire, produced a Certificate of his being duly elected a Member of Council, for the County of Hunterdon, which was read; and he thereupon took and subscribed the Oaths required by Law before the Honourable Ephraim Martin, Esquire, one of the Members returned for this House, and took his Seat in Council.

John Peck, Ephraim Martin, John Mayhew, Peter Haring, Samuel Ogden, Abraham Kitchel, and Samuel Randolph, Esquires, severally produced Certificates of their being duly elected Members of this House, which were read; and they thereupon took and subscribed the Oaths required by Law before Robert-Lettis Hooper, Esquire, and took their Seats in Council.

Joseph Smith, Esquire, produced a Certificate of his being duly elected a Member of Council, for the County of Burlington, which was read; and he being one of the People called Quakers, took and subscribed the Affirmations required by Law, before the Honourable Robert-Lettis Hooper, Esquire, and took his Seat in Council.

‘ Whereas the Commissioners from this State have reported a Constitution for the future Government of the United States, agreed upon by the General Convention lately held for that Purpose, in the City of Philadelphia, accompanied by a Resolution, that it be submitted to a Convention of Delegates chosen in each State by the People thereof, under the Recommendation of its Legislature, for their Assent and Ratification: And whereas Congress have unanimously resolved, that the said Constitution be transmitted to the Legislatures of the several States to the Intent aforesaid; and it appearing to be the earnest Wish of the good People of this State, that early and immediate Measures be taken to assemble a Convention within the same, for the Purpose of deliberating and determining on the said Constitution;

‘ *Resolved unanimously*, That it be recommended to such of the Inhabitants of this State as are entitled to vote for Representatives in General Assembly, to meet in their Counties on the fourth Tuesday in November next, at the several Places fixed by Law for holding the annual Elections, to choose three suitable Persons to serve as Delegates from each County in a State Convention, for the Purposes herein before mentioned, and that the same be conducted agreeably to the Mode, and conformably with the Rules and Regulations prescribed for conducting such Elections.

‘ *Resolved unanimously*, That the Persons so elected to serve in State Convention, do assemble and meet together on the second Tuesday in December next, at Trenton, in the County of Hunterdon, then and there to take into Consideration the aforesaid Constitution; and if approved of by them, finally to ratify the same in Behalf and on the Part of this State; and make Report thereof to the United States in Congress assembled, in Conformity with the Resolution there-
 ‘ to annexed.

Resolved, That the Sheriffs in the respective Counties of this State shall be, and they are hereby required to give as timely Notice as may be, by Advertisements, to the People of their Counties of the Time, Place and Purpose of holding Elections as aforesaid.

The foregoing Resolutions were read, and ordered a second Reading.

The engrossed Bill, intituled, 'An Act to amend the fifth Section of an Act, intituled, An Act to raise the Sum of Twelve Thousand Five Hundred Pounds per Annum, for the Term of twenty-two Years, for the Purpose of paying the Interest on the Debt due from this State to the Inhabitants thereof, passed June seventh, Seventeen Hundred and Eighty-seven,' was read and compared; on the Question, Whether the said Bill do pass? It was carried in the Affirmative, *Nem. Con.*
