La Grange

A GRANGE is situated on the Chicago, Burlington & Quincy Railroad, on the first high ground west of Lake Michigan, being 80 feet above the lake level. It is twelve and one-half miles from the Union Depot and has most excellent train service, there being twenty-two trains daily each way, running at frequent intervals, the average time being thirty minutes. It is also the present terminus of the Suburban Electric Line, which connects with the Lake Street and Metropolitan Elevated, taking patrons to the business center of the city in one hour.

La Grange, with its 6,000 inhabitants, is the most completely finished resident town around Chicago, furnishing every advantage that a city could afford and the rest and quiet of the country. The elevation gives perfect drainage; the sewer system is complete, and there are well paved streets and cement sidewalks throughout the village, shaded by beautiful trees; it has the purest artesian water; gas, both for fuel and illuminating, and electric lights. The stores are most excellent, and fresh products are obtained from the surrounding farms. There are churches of every denomination, each owning handsome property. The schools are ranked with the best in the state, there being kindergartens, two grammar schools, Nazareth Academy, and the Township High School. There are various social, literary and musical clubs. prominent among them being the "Suburban," a gentlemen's social club, and the "Country Golf Club," each owning beautiful buildings and grounds. One of the notable features is that there are no saloons or places of like nature in the village.

In brief, if you are looking for a suburban home, and particularly if you wish to get away from the sudden changes of climate incident to living near Lake Michigan, you could choose no more home-like, attractive, highly improved suburb than La Grange.



No. 1-216 South Stone Avenue

This modern home is delightfully situated and is surrounded by beautiful trees; contains twelve rooms; hardwood floors and finish; electric light fixtures; gas; hot and cold water; laundry tubs in basement; steam heat; is two and one-half blocks from the Stone Avenue Station. Lot 100 feet front. See illustration on opposite page.

No. 2-201 South Waiola Avenue

Two-story and attic frame house on stone foundation; eleven rooms and reception hall; bath; hardwood floors; electric light fixtures; laundry tubs in basement; heated by furnace. This property is very desirably located and is three blocks from transportation and stores. Lot 100 feet front. See illustration on opposite page.

No. 3-137 South Kensington Avenue

This beautiful home is situated on one of the choicest corners in the village. It is a two-story and attic frame house on stone foundation, containing thirteen rooms and a very large pantry; electric lights; hot and cold water; hardwood floors; cypress finish; furnace heat. No. 4-236 South Kensington Avenue

Two-story and attic frame house on stone foundation; ten rooms; hardwood floors and finish; two modern bath rooms; hot and cold water; hot water heat; gas. Corner lot. Lot 50 x 150.

No. 5-102 North Spring Avenue

Two-story and attic frame house on stone foundation; nine rooms and bath; oak floor on first floor; downstairs finished in oak, second floor in Georgia pine; gas; electric lights; furnace heat; large reception hall and handsome oak stairway; large garden. Lot 50 x 139.

No. 6-28 South Waiola Avenue

Three-story and basement frame house on stone foundation; thirteen rooms; electric lights; furnace heat; hot and cold water; interior finished in quarter-sawed oak; one sitting room on second floor finished in bird's-eye maple; cedar closet; call bells; speaking tubes. Lot 91 x 136.

No. 7-Northeast Corner Elm and Stone Avenues

Two-story and attic frame house on stone foundation; seven rooms, bath and reception hall; hardwood floors throughout; first floor finished in hardwood; second floor in Georgia pine; electric lights; gas; hot and cold water; furnace heat. This is a new house and is two blocks from transportation and stores.

No. 8-329 Seventh Avenue

Two-story and attic frame house on stone foundation; eight rooms and bath; first floor finished in golden oak; second floor finished in hard pine highly varnished; hardwood floors; good furnace: electric lights; gas; laundry tubs and cement floor in basement. Lot 50×140 .



No. 3--137 South Kensington Avenue

Two-story and attic frame house on stone foundation; ten rooms; modern bath with new plumbing; electric lights; steam heat; hardwood finish; good basement; large barn in rear. Lot 100 x 125.

No. 15-228 South Fifth Avenue



Two-story and attic frame house on stone foundation; ten rooms; plumbing double, for hard and soft water; hardwood finish on both floors; all modern improvements. Lot $62\frac{1}{2} \times 150$.

No. 17-76 Sixth Avenue

Two-story and attic frame house on stone foundation; eight rooms; hot and cold water; eistern water in kitchen and basement; laundry tubs and cement floor in basement; furnace heat. Lot 75×150 .

Two-story and attic frame house on stone foundation; eight rooms; electric lights; gas; furnace heat; cement floor in basement; good barn. Lot 50 x 136.



No. 19—106 South Fifth Avenue

No. 27-222 South Kensington Avenue

Two story and attic frame house on stone foundation, containing twelve rooms. This beautiful home is situated in one of the choicest locations in the village and has all the modern conveniences. No. 28-111 Seventh Avenue

House is 36 x 60; twelve rooms; pressed brick with stone trimmings; stone basement; cement floor; laundry; steam heat. First floor has parlor, library, dining room, smoking room, vestibule, reception hall, coat room, conservatory, consol, mantel, sideboard, china closets, butler's pantry, kitchen and store room. Second floor has six large bed chambers with closets in each, two bath rooms, cedar closet, and reception room with window seats. Third floor can be arranged for billiard room, being full size of house.
