Dear Mr. Garrison,

I had recently a very kind note from Mary Grew, in reference to my father, - which, after a little unavoidable delay, I have just been acknowledging. At its close, ~~after~~ saying I had forwarded to S. J. May a letter she had sent to my care for him, I felt moved to add, as follows:

"I understand an effort is making to hold a special meeting of the "Antislavery Society" in honor of the adoption of the 15th Amendment; - Mr. Garrison having read to me a note he had rec'd. from Mrs. Mott, in which she kindly included my name. If the Society did not think the Amendment, abolishing & forever prohibiting Slavery, an occasion for its special commemoration, - a National Endorsement of its own Principle & Work, as it was, - it does seem to me superfluous for it to hold a special meeting for this latter Amendment, -

"which, quite as much as the former, leaves its practical application yet to be made.

The Society might more justly have laid claim to a large share of direct & indirect influence in bringing about the former amendment. No particular Society, or movement, can prefer any such claim in regard to this latter. The movement for that was, from the first, a far broader one than any society, or all societies together, could form. If any one set as body of the people can claim it as their own, it surely belongs to the Republican party; and the great body of that party, and of all who have acted with it ~~or~~ for righteous political reforms, it seems to me, should unite in commemoration of the gain of this amendment".

Of course M. G. won't agree to that view of it - though the Sun is right, now making me to write this, is not a surer fact to me, than the above. - I saw

S. J. M. briefly yesterday. He told me you had shown to him Mr. Mott's notes, but I had not time to ask any farther, - I hope he won't be inveigled into any such assembly.
