

The Concord (N.H.) Anti-Slavery Society,

was formed June 9. 1834.

Ms. B. 9. 1 (27)

June 3. 1834, on motion of Philip Watson, voted That a committee of three be appointed by the chair to draft a Constitution for said society.

On motion of Dr. Thomas Chadbourne, voted That a committee of five, three ladies & two gentlemen be appointed by the chair to obtain subscribers to the Constitution.

Messrs John B. Chandler, Elbridge G. Eastman, Miss Sarah Kimball, Mrs. Francis J. Murdock, Mrs Philip Watson were chosen. voted to add Mrs. George Kent to the committee.

At the adjourned meeting, over the bank, the Constitution was signed by 9 gentlemen & 16 ladies, & a committee of six, 3 ladies & 3 gentlemen appointed to report officers for the society. The committee reported Rev. Geo. Storrs, Pres; Albe Cady & Rev. Moses G. Thomas, vice Presidents; John Farmer Cor. Sec; John B. Chandler Rec. Sec.; Geo. Porter, Treas.; & Dr. Tho: Chadbourn, Charles Hoag, Geo. Kent, Mrs Philip Watson, Mrs Amos Wood, Managers.

Oct. 1. 1834. On motion of Dr. Chadbourn, voted That the Rev. Edmund North, Thomas Chadbourn, Rev. Geo. Storrs, John Farmer, Rev. Moses G. Thomas, Rev. Eben: E. Cummings, & Albe Cady be a committee to correspond with the several anti-slavery societies in this state, & with the friends of abolition generally, on the expediency of calling a deliberative Convention, similar to the one about to be holden in Maine, to afford opportunity for mutual interchange of views & feelings in relation to the great objects of our association & to adopt such measures for cooperation with the friends of civil liberty & equal rights throughout the country as may be judged best calculated to effect these objects; & that the committee be authorized with

the approbation of their societies, to call said Convention, at such time & place as they may deem expedient.

Voted That the above resolution be published in the newspapers friendly to the cause of abolition in this town.

Oct. 27. The Committee reported, their report was accepted, & voted, That, we now proceed to the choice of delegates to attend the Convention, called by the committee, to be holden in this town, Nov. 11. 1834, in compliance with the invitation contained in the report.

Voted That 15 be chosen. — These were, John Farmer Esq., Rev. Geo. Storrs, Rev. Moses G. Thomas, Benj^r. Damon, Rev. Nath^l. Bouton, Rev. Eben^r. E. Cummings, George Porter, George Kent Esq., Amos Wood, Elbridge G. Eastman, Rev. Edmund North, Edmund S. Chadwick, John B. Chandler, Albe Cady, & Nathaniel Abbot.

April 27. 1834. The same (Concord) Society, voted to proceed to the choice of delegates to the N. E. A. S. Convention, to be holden in Boston, May 5. 1834. — eleven men were chosen.

Voted That if any member of the Society is to be in Boston at the time of the Convention, the Secretary be authorized to give him a certificate as delegate to the Convention.

June 2. 1834, twenty three men were chosen as delegates to attend the annual meeting of the State Society.

Feb. 6. 1839 — twenty seven men were chosen as delegates to the annual meeting of the County Society. At the

same meeting, — Resolved That we approve the nomination recently made in the Herald of Freedom of the following named gentlemen as candidates for members of Congress.

— viz Joel Eastman, Conway; Peter P. Woodbury, Bedford, Joseph M. Hooper, Canterbury; Nath^l Southworth, Lyme, Daniel Witt, Sandwich.
