Historical

ON April 26, 1897, a meeting was held in Kenosha, Wis., for the purpose of organizing a Society of Colonial Wars in the State of Wisconsin. At this meeting a letter was read from the Secretary General of the General Society of Colonial Wars, authorizing the formation of a Society of Colonial Wars in this state, and acting upon that authority a preliminary organization was effected and the Constitution of the Society of Colonial Wars in the State of Massachusetts, with one or two changes, was temporarily adopted, and officers were elected to serve until the first General Court.

On July 28, 1897, the first Special Court of the Society was held in Milwaukee and Articles of Incorporation were signed, all the officers being re-elected to serve until the date of the first General Court mentioned in the Articles of Incorporation.

At a meeting of the Council held in Milwaukee on October 26, 1897, the By-Laws of the Society were adopted.

The first General Court of the Society was held on December 22, 1897, when officers for the ensuing year were elected. Immediately after the adjournment of the Court, the first annual dinner of the Society was held at Hotel Pfister, ten members being present and four guests of the Society.

At a meeting of the Council held January 14, 1898, it was unanimously voted to publish the first Year Book of the Society.

The History of the Society of Colonial Wars in the State

of Wisconsin is brief, but shows a steady growth and interest in patriotic research.

November 15, 1899. Resignation of William Lyman Mason, on account of permanent removal to Washington, was presented to Council and accepted.

December 21, 1899. The annual Court of the Society of Colonial Wars in the State of Wisconsin was convened at the Hotel Pfister, Milwaukee, and officers elected for the ensuing year.

November 7, 1901. Application of Mr. Paul Denison Sexton, now living in Chicago, to be transferred from the Wisconsin to the Illinois Society, granted.

December 21, 1901. Annual Court of the Society of Colonial Wars was held at the Milwaukee Club. Officers were elected for the ensuing year. On motion of Mr. Payne \$25.00 was appropriated to the McKinley Memorial Association. On motion of Mr. Camp the Governor appointed a committee to consider the advisability of requesting the co-operation of Societies of the state to endeavor to assist in the passage of a bill before Congress for the erecting of a memorial to President Abraham Lincoln.

April 30, 1902. Howard Greene tendered his resignation as secretary. Resignation was accepted, to take effect upon the election of his successor. William Stevens Brockway was elected to fill the unexpired term as secretary.

December 20, 1902. The annual Court of the Society of Colonial Wars in the State of Wisconsin, was convened at the Milwaukee Club, Milwaukee. The following resolution was unanimously adopted:

Resolved, that Article IV of the Articles of Incorporation of the Society of Colonial Wars in the State of Wisconsin be,

and they are hereby, amended by striking out the word "three" where it occurs in the fifth line of said article, as the same appears in the records of the Secretary of the Society; and inserting in place thereof the word "five"; so that said article when so amended shall read:

IV. "The general officers of such corporation shall be a governor, a deputy governor, a lieutenant governor, a secretary, a deputy secretary, a treasurer, a registrar, a historian, a genealogist, a chaplain, a chancellor, and a surgeon. Such officers with five other members of this corporation to be elected like them, annually, shall constitute the council, which shall manage the affairs of the corporation."

Officers were elected for the ensuing year.

The regular annual banquet followed the business meeting. The speakers were: Hon. Gerry W. Hazleton, Hon. George W. Peck, Capt. F. B. McCoy, Judge L. H. Bancroft and Harold G. Underwood.

December 21, 1903. The annual Court of the Society of Colonial Wars in the State of Wisconsin was convened at the Milwaukee Club, Milwaukee. Officers were elected for the ensuing year. The regular annual banquet followed the business meeting. Nineteen were present. Guests: Major L. W. Cooke, Captain David A. Hall; General Charles King and Captain A. B. Davis sent regrets.

January 13, 1904. Resolutions of sorrow adopted, relative to death of Bedford Brown Hopkins, copies of which were sent to the family of the deceased.

The Society gave \$50 to the George Rogers Clark Society Children of the American Revolution for a bust to be placed in the Public Library.

October 9, 1904. The Society sent a delegation to attend

funeral services of Henry Clay Payne, Deputy Governor General for Wisconsin, and afterwards adopted resolutions.

December 21, 1904. General Court and annual dinner held at Milwaukee Club.

A resolution was introduced authorizing the preparation of a new lineage book for the Society; the resolution was adopted and upon motion the Governor appointed Ellis Baker Usher, Henry Alvin Crosby and William Ward Wight as a Committee on Publication.

At this Court the Historian's report was in the nature of a sketch of the life of Deputy Governor General Henry Clay Payne.

At the dinner the speakers of the evening were Rev. H. H. Jacobs, Col. L. W. Cooke, U. S. A., Lieut. W. E. V. Jacobs, R. C. S., and the Chancellor of this Society, William Ward Wight.

May 14, 1905. A meeting of the Council was held to take formal action with reference to the death of Harold Green Underwood, a charter member and the Registrar of this Society.

December 20, 1905. General Court and annual dinner held at the Plankinton House. Principal speaker, Capt. William V. Judson, U. S. A.

Articles of Incorporation

THE undersigned, being adult persons and residents of the State of Wisconsin, and being desirous to form a corporation under Chapter 66 of the Revised Statutes of Wisconsin and of the laws amendatory thereof, do make, sign and acknowledge written articles as follows:

I.

They declare that they associate for the purpose of forming a corporation under said revised Statutes, and that the purposes thereof are to cultivate and advance literature and art and to foster and promote patriotism, by collecting and preserving manuscripts, rolls, relics and records pertaining to the history of the American Colonies; by providing suitable commemorations, or memorials, and by preparing historical papers relating to the American Colonial period; by perpetuating the names and services of those who, in military, naval and civil positions of high trust and responsibility, assisted in the establishment, defense, and preservation of the American Colonies; by inspiring in the members of this corporation the fraternal and patriotic spirit of the colonists and by increasing in the community respect and reverence for those whose public services made the freedom and unity of the United States possible.

II.

The name of such corporation shall be SOCIETY OF COLONIAL WARS IN THE STATE OF WISCONSIN. Its location shall be the City of Milwaukee, in the County of Milwaukee, in said State.

III.

This corporation is organized without capital stock and exclusively for benevolent purposes, and no dividends or pecuniary profits shall ever be made or declared by such corporation to its members.

IV.

The general officers of such corporation shall be a Governor, a Deputy Governor, a Lieutenant Governor, a Secretary, a Deputy Secretary, a Treasurer, a Registrar, a Historian, a Genealogist, a Chaplain, a Chancellor and a Surgeon. Such officers with five other members of this corporation to be elected like them, annually, shall constitute the Council, which shall manage the affairs of the corporation.

V.

The principal duties of the general officers shall be: The Governor, or in the case of his absence or other disqualification, the Deputy Governor or the Lieutenant Governor, shall preside at all meetings of the corporation and of the council. The Secretary, or in case of his absence, or other disqualification the Deputy Secretary, shall keep the records, conduct the correspondence and preserve the seal and the historical documents of the corporation.

The Treasurer shall collect and preserve the moneys of the corporation, lawfully disburse the same, and keep a true account of his receipts and expenditures.

The Registrar shall receive and preserve proofs of membership and other like documents.

The Historian shall keep a complete and detailed record of historical and commemorative celebrations of the corporation, edit such documents as the corporation shall publish, and prepare annually a necrology and biographies of deceased members.

The Genealogist shall investigate and pass upon all applications for membership.

The Chancellor shall pass upon all questions of a legal character affecting the corporation. All the principal officers shall perform such other duties as the By-Laws shall impose and such as appertain to their several offices respectively in like corporations.

The Council shall devise and procure a seal, prepare, amend and repeal By-Laws, provide and prescribe the duties of committees, fix the quorum of the council and of the corporation (which may be less than one-half of either body) and perform such other duties as the By-Laws may prescribe, such as appertain to such a body in like corporations and such as are necessary to carry out the purposes of the organization.

VI.

The following named persons:

VII.

The first meeting of this corporation for the election of officers shall be held at No. 272 Martin Street, in the said city of Milwaukee, at eight o'clock in the evening of the 28th day of July, 1897. The By-Laws shall make provision for the annual meeting and for other meetings, regular and special, both of the corporation and of the council.

By-Laws

SOCIETY OF COLONIAL WARS IN THE STATE OF WISCONSIN.

ARTICLE I.

Of Designations

The articles of association of the Society of Colonial Wars in the State of Wisconsin may be designated herein as the Constitution of the said Society; the annual meeting of its members, as the General Court, and Special meetings as Special Courts.

ARTICLE II.

Of Qualifications for Membership

Any male person of 21 years of age and above, of good moral character and reputation, shall be eligible to membership in the Society of Colonial Wars in the State of Wisconsin, who is lineally descended in the male or female line from an ancestor;

(1) Who served as a military or naval officer, or as a soldier, sailor or marine, or as a privateersman under the authority of the Colonies which afterward formed the United States, or in the forces of Great Britain which participated with those of the said colonies in any wars in which the said colonies were engaged or in which they enrolled men, from the settlement of Jamestown, May 13, 1607, to the battle of Lexington, April 19, 1775.

(2) Who held office in any of the Colonies between the dates above mentioned, either as;

- (a) Director General or Vice Director General in the Colony of New Netherlands.
- (b) Governor, Lieutenant or Deputy Governor, or Lord Proprietor in the Colonies of New York, New Jersey, Virginia, Pennsylvania and Delaware.
- (c) Lord Proprietor, Governor or Deputy Governor, in Maryland or the Carolinas.
- (d) Governor, Deputy Governor or Governor's Assistant, in any of the New England Colonies.

ARTICLE III.

Of Initiation Fees and Dues

The Initiation Fee shall be \$5.00; the Annual Dues, \$5.00, payable at the General Court of each year.

The payment at any one time of \$50.00 shall exempt the members so paying, from annual dues; or the payment at any one time, by a charter member, of \$25.00 shall exempt the said charter member from paying annual dues.

ARTICLE IV.

Of Admission of Members

Every application for membership shall be made in writing, on duplicate blanks furnished by the Secretary, subscribed and sworn to by the Applicant and approved by two members of the Society over their signatures.

Applications shall be accompanied by proofs of eligibility, and such applications and proofs shall be referred to the committee on membership, which shall carefully investigate the same and report as early as may be, its recommendation thereon.

Applicants shall be elected by a Council of the Society, duly called, but a negative vote of one in five of the ballots cast, shall cause the rejection of such applicant.

Payment of the initiation fees and dues shall be a prerequisite of membership. All elections to membership are subject to the approval of the National Society of Colonial Wars.

ARTICLE V.

Of the Declaration

The application of every applicant for membership shall contain, or be accompanied by, his declaration that he has not failed of admission in any other State Society of Colonial Wars and that he will use his best efforts to promote the purposes of this Society and will observe its Constitution and By-Laws.

ARTICLE VI.

Of Election of Officers

The officers and members of the Council and the Committee on Membership shall be elected by ballot at the General Court.

A plurality of the votes cast shall determine the choice for each officer and member of the Council, and such officers and members, together with the members of the committee on membership, shall hold office for a period of one year or until their successors shall be duly elected and qualified.

ARTICLE VII.

Of the Governor

The Governor, or in his absence, the Deputy Governor or Lieutenant Governor, shall preside at all Courts of the Society, under Parliamentary rules, subject to an appeal to the Society.

The Governor shall be *ex-officio* a member of all committees

except the nominating committee and the committee on membership. He shall have power to convene the Council at his discretion and shall so convene it upon written request of two members of the Council or upon like request of five members of the Society.

ARTICLE VIII.

Of the Secretary

The Secretary, or in case of his absence, the Deputy Secretary, shall keep a record of all meetings of the Society, and have charge of the Seal and Certificates of Incorporation of the Society, and documents other than those required to be otherwise deposited, and shall affix the seal to all properly authenticated certificates of membership, and transmit the same to the members to whom they may be issued. He shall notify the Registrar of all admissions to membership. He shall certify all acts of the Society, and when required, authenticate them under seal. He shall have charge of printing the publications issued by the Society. He shall incorporate in notices of the Council meetings the names of all applicants for membership to be voted on at that Council. He shall give notice to each officer, who may be affected by them, of all votes, resolutions and proceedings of the Society or of the Council, and at the General Court or oftener, shall report the names of those candidates who have been accepted and those who have been expelled for cause.

ARTICLE IX.

Of the Treasurer

The Treasurer shall deposit the funds of the Society in some bank in the State of Wisconsin, which shall be designated by the Council, to the credit of the Society of Colonial Wars in the State of Wisconsin, and such funds shall be drawn thence on

the checks of the Treasurer for the purposes of the Society only. He shall render a report of his receipts and expenditures at the General Court, and oftener, if required by the Council or by the General Court.

ARTICLE X.

Of the Registrar

The Registrar shall receive from the Secretary and file all proofs upon which membership shall have been granted, with a list of all diplomas countersigned by him. He shall also file all documents relating to memberships which the Society may obtain, and under direction of the Council shall make copies of such papers as the owners may not be willing to leave in the permanent keeping of the Society.

ARTICLE XI.

Of the Genealogist and of the Historian

The Genealogist shall investigate and pass upon all applications for membership and all supplemental applications, and shall report the result of his investigations to the committee on membership.

The duties of the Historian are sufficiently set forth in the Constitution.

ARTICLE XII.

Of the Chaplain

The Chaplain shall be an ordained minister of a Christian Church and it shall be his duty to officiate when called upon by the Governor.

ARTICLE XIII.

Of the Chancellor and of the Surgeon

The Chancellor shall be a lawyer duly admitted to the bar, and it shall be his duty to give legal opinions on matters affecting the Society when called upon by the proper officers.

The Surgeon shall be a practising physician.

ARTICLE XIV.

Of the Council

The Council shall have the power to call Special Courts of the Society and to arrange for celebrations by the Society. It shall control and manage the affairs and funds of the Society, but shall at no time be required to take action or contract any debts for which its members shall be personally liable.

Five members of the Council shall be a quorum for the transaction of business. It shall submit to the General Court a report of its proceedings for the year then closing. It shall have the power to drop from the roll of membership the name of any member who shall be at least two years in arrears, on account of dues or other assessments, and shall fail, on proper notice being given, to pay the same within 60 days. Any member dropped, may be restored to membership at any time by the Council upon a written application, and the payment of all the arrears to the date of such application.

ARTICLE XV.

Of the Committee on Membership

The Committee on Membership shall consist of three members, one of whom shall be the Genealogist. Two members

shall constitute a quorum, and a negative vote of one member shall cause an adverse report to the Council on the Candidate's application.

The proceedings of the Committee shall be secret and confidential, and the applicant who shall have been rejected by the Council shall be ineligible for membership for the space of one year from the date of rejection, except upon a unanimous vote of the Committee.

ARTICLE XVI.

Of Vacancies and Terms of Office

The Council shall have power to appoint a member of the Society to any office or to membership in the Council pro-tempore, to fill a vacancy which the Society shall not have filled by an election; provided, however, that the office of Governor shall not be so filled by the Council, when there shall be a Deputy Governor or a Lieutenant Governor to enter on the duties. Should any member of the Council, other than an officer, be absent from three consecutive Councils, his place may be declared vacant by the Council, and filled by appointment until the election of a successor. No resignation of any member of the Society shall become effective unless consented to by the Council.

ARTICLE XVII.

Of Disqualifications

No person who may be enrolled as a member of this Society shall be permitted to continue in membership, when his proofs of eligibility shall be found to be defective. The Council, after thirty days notice to such person to substantiate his claim, and upon his failure satisfactorily so to do, may require the Secretary to erase his name from the membership list. The said person

shall have the right to appeal to the Society at the next Court, or at the General Court. If the said appeal be sustained by a two-thirds vote of the members present at such Court, the said person's name shall be restored to said membership list.

ARTICLE XVIII.

Of Expulsion and Suspension

Any member, for cause, or conduct detrimental or antagonistic to the interests or purposes of the Society, or for just cause, may be suspended or expelled from the Society. But no member shall be suspended or expelled, unless written charges be presented against such member, to the Council. The Council shall give reasonable notice of such charges and afford such member reasonable opportunity to be heard. The Council after hearing such charges, may recommend to the Society the suspension or expulsion of such member, and if the recommendation of the Council be adopted by a majority vote of the members of the Society present at such Court, he shall be suspended or expelled and the insignia of such member shall thereupon be returned to the Treasurer of the Society, and his rights therein shall be suspended or extinguished. The Treasurer shall refund to such member the amount paid for the said insignia.

ARTICLE XIX.

Of the Courts

The General Court of the Society shall be held on the twenty-first day of December in each year, being the anniversary of the landing of the Pilgrims. When that date occurs on Sunday the General Court shall be held on the preceding Saturday. Special Courts may be held at the call of the Governor, and

shall be held at the written request of five members of the Society. All notices for Courts shall be sent out at least six days before the date of such Courts. Ten members of the Society shall constitute a quorum of the General Court and of Special Courts.

ARTICLE XX.

Of Service of Notice

It shall be the duty of every member to inform the Secretary of his place of residence, and of any change thereof, and of his post office address.

Service of any notice, under the Constitution and By-Laws, on any member, addressed to his last post office address, forwarded by mail, shall be sufficient service of notice.

ARTICLE XXI.

Of Certificates of Membership

Members may receive a certificate of membership which shall be signed by the Governor, Secretary and Registrar.

ARTICLE XXII.

Of the Nominating Committee

The Society shall, at some Court of the Society other than the General Court, elect by written ballot a nominating committee, of five members, none of whom shall be officers or members of the Council.

It shall be the duty of the nominating committee, to select the name of a candidate for each office to be filled at the ensuing

General Court, and to notify the Secretary of the Society of the names selected, at least fifteen days before the General Court.

It shall be the duty of the Secretary, to mail to each member of the Society, at least ten days before the General Court, a copy of the report of the Nominating Committee.

ARTICLE XXIII.

Of Alteration or Amendment

No alteration or amendment of the By-Laws shall be made, unless notice shall have been duly given in writing, signed by the member of the Society proposing the same, to the Secretary for presentation to the Court. The Secretary shall send a copy of the proposed amendment to the members of the Council, and state the date of the meeting at which the same will be voted upon.

No amendment or alteration shall be made, unless adopted by a two-thirds vote of the members present at the Council voting upon the same.

Constitution

GENERAL SOCIETY OF COLONIAL WARS.

PREAMBLE

WHEREAS, it is desirable that there should be adequate celebrations commemorative of the events of Colonial History, happening from the settlement of Jamestown, Vir., May 13, 1607, to the battle of Lexington, April 19, 1775: Therefore, the Society of Colonial Wars has been instituted to perpetuate the memory of those events, and of the men who in military, naval and civil positions of high trust and responsibility, by their acts of Counsel, assisted in the establishment, defense and preservation of the American Colonies, and were, in truth, the founders of this Nation. With this end in view, it seeks to collect and preserve manuscripts, rolls, relics and records, to provide suitable commemorations or memorials relating to the American Colonial period and to inspire in its members the fraternal and patriotic spirit of their forefathers, and in the community, respect and reverence for those whose public services made our freedom and unity possible.

ARTICLE I.

Name

The Society shall be known by the name and title of The General Society of Colonial Wars.

ARTICLE II.

Membership

Any male person above the age of 21 years, of good moral character and reputation, shall be eligible to membership in the Society of Colonial Wars, who is lineally descended, in a male or female line, from an ancestor

(1) Who served as a military or naval officer or as a soldier, sailor or marine, or as a privateersman under authority of the Colonies which afterward formed the United States, or in the forces of Great Britain, which participated with those of the said Colonies, in any wars in which the said colonies were engaged, or in which they enrolled men from the settlement of Jamestown, May 13, 1607, to the battle of Lexington, April 19, 1775, or

(2) Who held office in any of the Colonies between the dates above mentioned either as

- (a) Director General, Vice Director General, or member of the Council or legislative body in the Colony of New Netherlands.
- (b) Governor, Lieutenant or Deputy Governor, Lord Proprietor, member of the King's or Governor's Council, or legislative body in the Colonies of New York, New Jersey, Virginia, Pennsylvania and Delaware.
- (c) Lord Proprietor, Governor, Deputy Governor or member of the Council or of the legislative body in Maryland and the Carolinas.
- (d) Governor, Deputy Governor, Governor's Assistant, or Commissioner to the United Colony of New England, or member of the Council, Body of Assistants, or legislative body in any of the New England Colonies.

One collateral representative of an ancestor, such as above specified, shall be eligible to membership, providing there be no existing lineal descendant, and provided that such person be the oldest collateral representative in the male line of such ancestor, or has filed with the Secretary General of the Society, written renunciations from all other persons having nearer claims to representation.

No State Society shall adopt any rule of eligibility for membership which shall admit any person not eligible for membership in the General Society. But any State Society may, except as to members transferred from another State Society, further restrict at its discretion, the basis of eligibility for membership in its own Society.

ARTICLE III.

General Society

The General Society of Colonial Wars shall consist of the Societies now existing in the States of New York, Pennsylvania, Maryland, Massachusetts, Connecticut and District of Columbia, and such other State Societies as may from time to time be duly organized and authorized by the General Society.

Whenever the word "State" occurs in this Constitution it shall be held to include within its meaning the territories of the United States and the District of Columbia.

ARTICLE IV.

Officers

The Officers of the General Society of Colonial Wars shall be: A Governor General; a Deputy Governor General from each State Society; a Secretary General; a Deputy Secretary

General; a Treasurer General; a Deputy Treasurer General; a Registrar General; a Historian General; a Chaplain General; a Chancellor General and a Surgeon General.

With the exception of the Deputy Governor Generals, the above officers will be elected by a plurality vote of the delegates present at a General Assembly of the Society.

Vacancies occurring by death or resignation may be filled by the General Council for the unexpired term.

Each Deputy Governor General shall be elected by a plurality vote of the delegates present, in the General Assembly, from the State from which said Deputy Governor General is chosen.

The above officers shall serve until the next regular meeting of the General Assembly or until their successors are duly chosen.

ARTICLE V.

Meetings

The regular meetings of the General Society shall be termed "General Assembly," and shall be held once every three years, at such time and place as the preceding General Assembly may elect.

Special General Assemblies may be held upon the order of the Governor General, or upon the order of the Governors of three of the State Societies.

General Assemblies shall consist of the General Officers and five delegates from each State Society.

Delegates or General Officers, representing a majority of the State Societies, shall constitute a quorum for the transaction of business, and proceedings shall be in accordance with parliamentary law.

The order of business shall be:

FIRST. The calling of the General Assembly to order by the Governor General, or in his absence, by the Secretary General.

SECOND. Prayer by the Chaplain General.

THIRD. Reading of minutes of last General Assembly.

FOURTH. Report from Secretary General.

FIFTH. Report from Treasurer General.

SIXTH. Reports from Committees and Officers.

SEVENTH. Unfinished Business.

EIGHTH. New Business.

NINTH. Reports from State Societies.

TENTH. Election of Officers.

ELEVENTH. Benediction by the Chaplain General.

The Minutes of each assembly shall be read before its final adjournment.

ARTICLE VI.

State Societies

Each State Society shall annually transmit to the Secretary General a circular letter, stating the number of its members, general matters of interest, and any suggestions which may be deemed of advantage to the Society.

Each State Society shall in the month of January in each year, pay to the Treasurer General the sum of \$25.00.

ARTICLE VII.

Powers of the General Society

The General Society shall have sole power of action in the National as distinct from the State affairs of the organization. It shall have jurisdiction to pass upon all questions of eligibility referred to it by the Registrar General, but shall not otherwise

interfere in the regulations or government of any State Society, unless by a plurality vote of the General Assembly, when the surrender of a State Charter may be demanded, should an investigation show that such action is necessary for the welfare of the Societies at large. It shall have power to grant charters to States other than those in which the Society is already organized, provided, that at least nine persons duly qualified to be members, make such application. It shall issue the insignia and the diplomas of membership. It shall publish the Year Book with the co-operation of the several State Societies, and the cost shall be defrayed by the latter in proportion to their membership.

The General Council, which shall be composed of all the General Officers, shall exercise the powers of the General Society (except those of demanding State Charters and of amending the Constitution) between meetings of the General Assembly, to which latter body it shall regularly report all its transactions.

ARTICLE VIII.

Governor General

The Governor General, or in his absence, a duly selected temporary presiding officer, shall preside at all General Assemblies and meetings of the General Council of the Society.

ARTICLE IX.

Secretary General

The Secretary General shall be keeper of the Great Seal of the Society and of the General Society flag, and of the diploma. He shall conduct the general correspondence of the Society and keep a record thereof. He shall have charge of the printing and publications of the Society. He shall give due notice of the

time and place of the holding of all meetings of the General Assembly and of the General Council and shall keep full record of their proceedings.

ARTICLE X.

Treasurer General

The Treasurer General shall collect and keep the funds and securities of the Society and deposit and invest them subject to the direction of the General Council. Out of these funds he shall pay such sums as may be ordered by the General Council. He shall keep a full account of his receipts and payments and at each General Assembly or when required by the General Council, shall render an account of the same. He shall be Custodian of the die of the Insignia and may issue the Insignia and Rosettes. For the faithful performance of his duty he may be required to give such security as the General Council may deem proper.

ARTICLE XI.

Registrar General

It shall be the duty of each State Society to file with the Registrar General a duplicate of the application of each member. The Registrar General shall receive and file all duplicate applications upon which membership has been granted, with a list of all diplomas signed by him and all documents which the Society may acquire. It shall also be his duty to submit to the General Council any application for membership which in his opinion does not fulfill the requirements of Article II of this Constitution.

ARTICLE XII.

Historian General

The Historian General shall keep a detailed record of all historical and commemorative celebrations of the General Society

and shall edit and prepare for publication such historical addresses, papers and other documents as the Society may decide to publish.

ARTICLE XIII.

Chaplain General

The Chaplain General shall be an ordained minister of a Christian Church, and it shall be his duty to officiate when called upon by the proper officers.

ARTICLE XIV.

Chancellor General

The Chancellor General shall be a lawyer duly admitted to the bar, and it shall be his duty to give legal opinion on matters affecting the Society when called upon by the proper officers.

ARTICLE XV.

Surgeon General

The Surgeon General shall be a practising physician.

ARTICLE XVI.

Great Seal

The Great Seal of the General Society shall be: Within a beaded annulet, a title scroll, "1607, General Society of Colonial Wars, 1775;" and in base the motto: "Fortiter Pro Patria," surrounding diaper charged with nine mullets. Over all a shield, surmounted of the crown, bearing American Colonial Seals quarterly of nine; I. Virginia; Argent, a cross gules between four escutcheons each regally crowned proper, the first and fourth escutcheons, France and England, quarterly; second escutcheon,

Scotland; third, Ireland. II. New York: Argent, a beaver bendways proper on a bordure tenny, a belt of wampum of the first. III. Massachusetts: Azure, on a mount between two pine trees vert, an Indian affronté or, belted with leaves of the second, holding in his dexter hand an arrow paleways, point downwards, and in his sinister hand a bow paleways, of the third; upon a scroll proper, issuing from his mouth, the legend, "Come over and help us." IV. New Hampshire: Quarterly, first and fourth grand quarter of France and England; second, Scotland; third, Ireland; over all an escutcheon of pretence; azure billetée or, a lion rampant of the second, for Nassau. V. Connecticut: Argent, a dexter hand issuing out of clouds in dexter chief, holding a double scroll proper, fesseways, bearing the legend, "Sustinet qui transtulit;" in base fifteen grape vines, six, five, four, leaved and fructed proper. VI. Maryland: Quarterly first and fourth paly of six or and sable, a bend counterchanged, for Calvert; second and third, per fesse and per pale argent and gules, a cross bottony counterchanged for Crossland (seal of Lord Baltimore). VII. Rhode Island: Azure, an anchor in pale or. VIII. New Jersey: Quarterly, first, England impaling Scotland; second, France; third, Ireland; fourth, per pale and per chevron; first, gules two lions passant guardant in pale or, for Brunswick; second, or, semée of hearts, a lion rampant azure, for Lunenburgh; third, gules, a horse courant argent, for Westphalia; over all an inescutcheon gules charged with the crown of Charlemagne. IX. Pennsylvania: Argent on a fesse sable, three plates (Arms of Penn).

ARTICLE XVII.

Insignia

The insignia of the Society shall consist of a badge, pendant by a gold crown and ring, from a watered silk ribbon one inch and a half wide of red, bordered with white and edged with red.

The badge shall be surrounded by a laurel wreath in gold and shall consist of:

Obverse; A white enameled star of nine points bordered with red enamel, having between each star point a shield displaying an emblem of one of the nine original colonies; and, within a blue enameled garter bearing the motto, "Fortiter Pro Patria," an Indian's head in gold relief.

Reverse; The star above described, but with gold edge, each shield between the points displaying a mullet, and in the center, within an annulet of blue bearing the title, "Society of Colonial Wars, 1607-1775," the figure of a Colonial soldier in gold relief. The reverse of the crown of each insignia shall bear an engraved number, corresponding to that of the registered number of the member to whom such insignia has been issued.

The insignia shall be worn by the members on all occasions, when they assemble as such, for any stated purpose or celebration, and may be worn on any occasion of ceremony. It shall be worn conspicuously, on the left breast; but members who are, or have been Gentlemen of the Council of a State Society, may place a rosette of regulation pattern, upon the silk ribbon from which it is pendant.

Members who are, or have been General Officers, or Officers of a State Society, may wear the insignia with three jewels in a crown, and suspended from a regulation ribbon around the neck.

Members who are, or have been Governors, Deputy Governors, or Lieutenant Governors of State Societies, or Officers of the General Society, may, in addition to the insignia so suspended, wear a ribbon of the Society's colors, three and one-half inches in width, extending from the right shoulder to the left hip. The insignia shall be worn only as above prescribed.

ARTICLE XVIII.

Diploma

The Diploma of this Society shall bear the following words:

GENERAL SOCIETY OF COLONIAL WARS.

TO ALL WHOM IT MAY CONCERN:

Greeting: Know ye, this is to certify that on the day of, in the year of our Lord, and in the year of this Society, the Gentleman, was duly elected an Hereditary Member of the Society of Colonial Wars in the State of by right of his descent from

In witness whereof: We have hereunto signed our names and affixed the Great Seal of the General Society.

Officers of the General Society:

-, Governor-General.
., Secretary-General.
., Registrar-General.

And countersigned by the Governor, Secretary, and Registrar of the State Society.

Bordering the top and left side of the diploma is an ornamental scroll work containing within the initial letter "G" of "General Society," a representation of Captain Miles Standish and a band of Colonial Soldiery; the initial surmounted by the Imperial Crown of the British Empire and having below it the motto of the Society. Ranged along the scroll are shields bearing the arms of the original nine Colonies, as emblazoned in the Great Seal of the Society, and around these are emblems of colonial warfare with the flags of Sweden and New Netherland, and the rose, thistle, shamrock and corn-flower, badges respec-

tively of England, Scotland, Ireland and Germany. At the center at top, is a cluster of Indian weapons and the head of a Sachem charged upon the Fleur-de-lis of France.

ARTICLE XIX.

Flag

The flag of this Society shall consist of the red cross of St. George on a white field, bearing in the center the escutcheon of the General Society, surmounted by the crown and surrounded by nine stars.

ARTICLE XX.

State Secretaries

It shall be competent for the General Council to appoint State Secretaries in States where no State Societies exist, with a view to represent the interest of this Society, and if authorized to do so, to prepare for the organization of new State Societies. Such State Secretaries shall be subject to the direction and regulation of the General Council. Their appointment shall be for a limited time, not to exceed one year, but may be renewed. They may be removed for cause, and their office shall terminate upon the organization of, and grant of a charter to a Society in their State. They shall communicate with, and receive communication from the Society through the Secretary General.

ARTICLE XXI.

Members of State Societies

The General Council shall elect to membership only charter members of new State Societies, whose membership shall be ipso facto transferred to their own State Society with the grant of its charter.

No State Society shall elect to membership, persons resident within the territory of another State Society, except upon written consent given in advance, by the Council of the latter Society. But members changing residence from one State to another, or coming within the jurisdiction of a new State Society, may at their option, retain membership in the State Society in which they were originally admitted. A member of any State Society, may be admitted to membership, by action of the Council of another State Society, within the bounds of which he is resident, upon satisfactory proof of his membership in good standing in the Society from which he comes, and subject to the rules and regulations of the Society he enters.

An initiation fee shall not be twice required.

ARTICLE XXII.

Alterations and Amendments

No alterations of, or amendments to this Constitution shall be made, unless proposed by the Council of a State Society in writing. The Secretary General shall send a printed copy of the proposed amendment to each State Society, naming the time when, and the place where it will be voted upon, and the voting shall take place in the General Assembly.

Six months notice shall be given to each Society.

No amendment shall be made, unless adopted by a two-thirds vote of the State Societies, through their delegates in the General Assembly.

SIMON WILLARD¹ of Concord, Lancaster and Groton, Mass. One of the founders of Concord, Mass., 1630. Lieutenant, 1637. Captain, 1646. Major, 1653. Representative from 1636 to 1654. Was chosen Assistant in 1654 and held the office of Assistant to the time of his death, in 1676. His first military commission was that of Lieutenant-Commandant, March, 1637, in the Train Band of the Provincial forces of Massachusetts Bay Colony. Promoted Captain of the Colonial forces, 1646, and further promoted to Sergeant-Major in command of the Middlesex Regiment in 1653. He continued in command of that regiment for more than twenty-three years. In 1653 the Sergeant-Major was the chief military officer in his county and was next in rank to Sergeant-Major General, who had command of all the military forces in the Colony. The prefix of "Sergeant" fell gradually into disuse in the latter days of the Colony. Middlesex County then, 1653, included seventeen incorporated towns. Major Simon Willard served actively with the Provincial forces in the early Indian wars. Was Commander-in-Chief of the United Colonial forces against Ninigret, Sachem of the Niantics, in 1654-5. Commanded the Middlesex Regiment of Massachusetts troops in the war against the Sachem Philip of Pokanoket. Led the heroic relief at the battle of Brookfield, Mass., Aug. 2, 1675. Fought, defeated and dispersed the Indians who had attacked Groton, March 17, 1676. Was Deputy and Representative to the General Court of the Province of Massachusetts Bay Colony from 1636 to 1654. Chosen Assistant and Councilor under Governors Richard Bellingham, John Endicott and John Leverett, annually, from 1654 to his death in 1676. As a magistrate and judge, Major Simon Willard was a humane man. For his military services the Government made Major Simon Willard a grant of 1,000 acres of land.

Lieutenant, Dec. 28, 1720; Captain, March 4, 1722, Major, March 7, 1736. Major Ephraim Hildreth was town clerk of Dracut most of the time from 1713 to 1740. He retained the rank and title of Major until his death, Sept. 26, 1740. His grave-stone in the Hildreth burying-ground of Dracut, now Lowell, Mass., bears the inscription: "Here lies buried the body of Major Ephraim Hildreth," etc.

RICHARD HILDRETH¹ of old Charlestown Village, Cambridge and Chelmsford, Mass. Was of Cambridge, Mass., May 10, 1643. A grantee of Chelmsford in 1653, where he and his descendants lived from 1653, and in which vicinity his lineal descendants still live. Prior to March 3, 1663, was Sergeant in the Military Company at Chelmsford and served until 1664. In 1664 Sergeant Richard Hildreth, "being greatly disadvantaged of the use of his right hand, whereby wholly disabled," received, for the ninth time, an additional grant of land. He was noted in Chelmsford church records about 1670, kept by the Rev. John Fiske, as denying the right of the minister or church committee to compel his attendance at the Meeting House on Sundays and refusing to pay the fines sought to be imposed upon him by the Minister, or Deacon, Esdras Reade, or any other minister or deacon. The record shows that "Sergeant Richard Hildreth used reproachful speech and seditious language concerning the Church." He said that he, and others, had quit England to escape the assumption and interference of the clergy in matters not connected with religion. Their grave-stones are still in the old Chelmsford burying-ground.

He parted with his friends April 16th and marched as far as Mr. Kingman's tavern in Easton, the same day, and to Mr. Bent's tavern in Milton, April 17, 1759; arrived at Castle William April 18, arrived at the Shearley April 19, was turned over to Captain Glover in Col. Bagley's Regiment, slept that night in a cold meeting house without blankets, passed muster and embarked on board the "Wolfe," May 8. Sailed for Louisburg, May 15; arrived there May 24, disembarked May 27, 1759; embarked on board the transport "Squirrel" for Boston, Dec. 2, 1761, according to his own diary. This diary is now, in 1899, in the possession of Ruth Ann Low, residing at the old Burt homestead, Berkley, Mass., and contains this entry, "Oct. 9, 1759, James Paul got his discharge from the regiment."

In 1639 was chosen the first treasurer of the colony under the new constitution, and variously continued in this office until 1651, at which time on account of other duties, he asked to be eased of the treasurer's place and the request was granted. In 1641 was chosen secretary of the colony and held the office in subsequent years. In 1649 he was one of the commissioners of the "United Colonies." In 1654 Governor Hopkins, being in England, and Deputy Governor Haynes having died, he was elected by the whole body of freemen, convened at Hartford, moderator of the General Court, and this year was again appointed one of the commissioners of the United Colonies, but other duties prevented him from serving and this year he was also chosen Deputy Governor; in 1655 Governor and in 1656 and 1657, Deputy Governor; in 1658 again Governor and in 1659 again Deputy Governor.

DANIEL WETHERELL.² Captain and Commissary in charge of New London depot of supplies in King Philip's War. In the years 1675-6 Capt. Daniel Wetherell lived at New London; helped raise an army to go against the Indians. In the winter of 1675-6 an army of one thousand men was raised. In May the General Court at New London authorized the enlistment of 350 men as a standing army. These forces, which were under command of Major Talcott, were almost immediately ordered into the field. Mr. Wetherell and Mr. Douglas were the commissaries and New London the depot for supplies. Capt. George Denison had command of the company raised in New London.

Second in command to Major Treat in the Great Swamp Fight. Captured Indian Chief Canonchet. Chosen with Major Mason to assist the Pequot Chief to govern their tribes. He is said to have been the most conspicuous soldier of New London County, and distinguished himself in King Philip's War as a skillful and enterprising commander.

JOHN SEVIER.¹ Settled in the Shenandoah Valley when a young man and established there a village called Newmarket. This was a frontier line at the time and the Indians were numerous and given to encroachment and young Sevier was obliged to fight for his settlement. He became celebrated through his conflicts with the savages, conquering the neighboring tribes in a number of engagements. In 1772 he received the appointment of Captain in the Virginia line. In the same year he removed to Watauga, on the western slope of the Alleghanies. In 1773 Lord Dunmore began war on the Indian tribes and Sevier served through the campaign and distinguished himself at the battle of Point Pleasant, October 10, 1774. About the beginning of the Revolutionary War, the citizens of Watauga were desirous of being annexed to the Colony of North Carolina and John Sevier drew up a memorial to the Legislature making the request on the part of the citizens that they might so be annexed to the end that they might aid in the contest and bear their full proportion of the expense of the war.
