To the President :

SIR :

In response to your reference of the resolution of the House of Representatives of the 25th instant, requesting the President "to furnish this House with a list of all commissioned officers attached to and employed in the different Departments and Bureaux in the City of Richmond, showing their ages, and how many are fit for field service," I have the honor to report, that there are no commissioned officers attached to or employed in the Post Office Department, other than the Chiefs of the Contract, Appointment and Finance Bureaux, who are appointed by the President and confirmed by the Senate.

If the resolution is intended to cover these, H. St. George Offutt, Chief of the Contract Bureau is forty-three years of age, and would be able to perform military service in the field. B. N. Clements, Chief of the Appointment Bureau, is forty years of age, and is unfit for military service in the field. Alexander Dimitry, Chief of the Finance Bureau, is sixty years of age, and is unfit for military service in the field.

He is 29 years old, and is fit for field service, but is detailed as an expert for duty in that Bureau, his services there being deemed indispensable.
