MINUTES

Greensboro, N. C., Monday, October 6, 1913.

The Synod of North Carolina met in its One Hundredth Annual Sessions on Monday, October 6, 1913, at 7:30 o'clock P. M. in the First Presbyterian Church, Greensboro, N. C., and was opened with a sermon by the retiring Moderator, Rev. W. McC. White, D. D., on the text—"Neither can they die any more," Luke 20:36.

After the sermon the Synod was called to order and opened with prayer by the Moderator.

The Rev. M. McG. Shields of Orange Presbytery was elected Moderator, and the Rev. Messrs. E. L. Siler and J. E. Summers were elected Temporary Clerks.

The Rev. Messrs. C. W. Bird, and A. D. Betts of the M. E. Church, South, and Rev. R. A. Walker of the Baptist Church were invited to sit as visiting brethren and introduced to Synod by the Moderator.

The Rev. W. W. Moore, D. D. of the Synod of Virginia, Rev. L. W. Brown, D. D. of the Synod of South Carolina, and Rev. S. L. Morris, D. D. of the Synod of Goergia, were invited to sit as corresponding members and introduced to Synod.

The Rev. Melton Clark, D. D., acting Chairman of the Committee on Orders, made the following report which was adopted:

- 1. That the hours for the daily Sessions of Synod be from 9 o'clock A. M. to 1 o'clock P. M.; from 3 to 5 o'clock P. M. and from 7:30 o'clock P. M. to adjourn at will.
- 2. That the members of Synod be conveyed to Alamance Church tomorrow morning, leaving here at 9 o'clock A. M. for the Centennial Celebration.
- 3. That the Rev. L. S. Chafer conduct a Bible Study for twenty minutes each day, in connection with the morning devotional exercises.
- 4. That on the second day, Tuesday, at 7:30 o'clock P. M. the Rev. Dr. Morris be heard in connection with the report on Assembly Home Missions.
- 5. That on the third day, Wednesday, at 11 o'clock A. M., the Synodical Communion be observed, after which the Memorials of deceased brethren be read, and at 7:30 o'clock P. M., a popular meeting in the interest of Foreign Missions be held in connection with the report of the Committee.
- 6. That on Thursday, the program be as follows: At 9:30 A. M., Christian Education; at 11 A. M., Orphan's Home; at 3 P. M., Sabbath Schools and Young People's Societies; at 4 P. M., the Sabbath and Family Religion.

The Rev. Melton Clark, D. D., presented to the Synod a gavel, made from a remnant of the old Alamance Church, second building, in which the Synod was organized. The gavel was received with the thanks by the Moderator in behalf of the Synod.

The following report of the Special Committee, appointed last year, to prepare a program and arrange for the Centennial Celebration of the Organization of the Synod of North Carolina, at Alamance Church, October 7, 1913, was received and adopted.

Your Committee recommend the following program:

1. That the exercises at Alamance Church begin at 10:30

o'clock, A. M. and that the Welcome Address be made by the Rev. A. W. Crawford, pastor of the Alamance Church.

- 2. "The Beginnings and Development of Presbyterianism in North Carolina up to 1863"—Rev. W. W. Moore, D. D., L.L. D., President of Union Theological Seminary, Richmond, Va., and Rev. W. L. Lingle, D. D., Professor in Union Theological Seminary, Richmond, Va.
- 3. "The Personnel of the Presbyterian Church in North Carolina, up to 1863"—Rev. H. G. Hill, D. D., Maxton, N. C., and Rev. D. I. Craig, D. D., Reidsville, N. C.
- 4. "The Last Fifty Years—The Presbyterian Church an Evangelistic Agency"—Rev. R. F. Campbell, D. D., Asheville, N. C., and Rev. John M. Rose, D. D., Laurinburg, N. C.
- 5. "Presbyterianism in Educational Work in North Carolina During the Century"—Prof. C. Alphonso Smith, Ph. D., Professor in the University of Virginia.
- 6. That fifteen minutes before the Afternoon Session tomorrow, the Synod meet at the grave of Andrew Finley and be led in prayer by the Moderator.

SECOND DAY-Morning Session.

CENTENNIAL CELEBRATION

OF THE

ORGANIZATION OF THE SYNOD OF NORTH CAROLINA.

ALAMANCE CHURCH, Tuesday, October 7, 1913.

The Synod met in the Alamance Church at 10:30 o'clock A. M. together with a large congregation of people. The Moderator called the Synod to order, and the opening prayer

was offered by the Rev. J. N. H. Summerell, D. D. The Rev. A. W. Crawford conducted the introductory exercises, made an address of welcome, and gave a brief history of Alamance Church. He also introduced the speakers, those who were designated to speak in the church, in accordance with the program announced and adopted.

The first address was made by the Rev. W. W. Moore, D. D. on the "Beginnings and Development of Presbyterianism in the State up to 1863."

Dr. Moore was followed by the Rev. H. G. Hill, D. D. in an address on the Personnel of the Synod up to 1863, dwelling especially on the lives of those who lived and acted during the last half of this period.

At the school building, not far from the church, at the same hour, to an outdoor audience, addresses were delivered on the same subjects as above by the Rev. W. L. Lingle, D. D. and Rev. D. I. Craig, D. D., the latter dwelling specially on the lives of those who lived and acted during the first half of the period assigned.

The Rev. S. M. Rankin, Chairman of the Committee on the program had charge of the exercises, at the school building and introduced the speakers.

At the close of all these exercises, in the church and at the school building, the Synod took recess until 2 o'clock.

During the recess a bountiful dinner, most excellent and abundant for all, was served in the grove by the ladies of Alamance Church.

AFTERNOON.

The Synod assembled in the church yard at 2 o'clock P. M. and was called to order by the Moderator on the exact site of the Second Church Building where the Synod was organized one hundred years ago. The Synod then moved a little distance and surrounded the grave of Andrew Finley, the man who led the men in prayer before beginning the erection of the First Church building more than 150 years ago, and the Moderator led the Synod in prayer.

At the suggestion of the pastor and others and on motion of Dr. Anderson a collection was now taken for the purpose of erecting a monument on the site of the building where the Synod was organized this day one hundred years ago. The amount collected was about \$90.00, and it was ordered that the Moderator appoint a Committee to carry out this purpose, and to see to it that a suitable memorial is erected.

The Synod then reconvened in the Church, and on reassembling the Rev. Dr. Neal L. Anderson presented and introduced to the Synod, Master Henry Roan of Winston-Salem, N. C., about eight years old, a lineal descendant of Alexander Craighead in the fifth generation, and from Dr. David Caldwell in the fourth generation. He was unanimously received as a visiting brother.

The Synod, those assembled in the church, then heard according to the program the address of Rev. R. F. Campbell, D. D., on "The Presbyterian Church as an Evangelistic Agency, the last Fifty Years". Those assembled at the School Building heard the address of the Rev. J. M. Rose, D. D. on the same subject.

The Rev. Dr. Campbell, in the church, was followed by Prof. C. Alphonso Smith, Ph. D. in an address on "Presbyterianism in Educational Work in North Carolina during the Century."

At the close of this address, the Synod by a rising vote, extended its thanks to the speakers of the day for their excellent addresses.

The Synod then adjourned with prayer by the Rev. D. H. Rolston to meet again in the First Presbyterian Church, Greensboro, N. C., this evening at 7:30 o'clock.

SECOND DAY-Evening Session.

Greensboro, N. C., Tuesday, October 7, 1913.

The Synod met in the First Presbyterian Church, Greensboro, at 7:30 o'clock P. M. and resumed business with the

Rev. A. A. McGeachy, D. D. as Moderator pro tem, who also conducted the devotional exercises.

The report of the permanent Committee on Assembly's Home Missions was submitted and read by the Chairman. The report was received, and pending its adoption, the Synod was addressed by the Rev. S. L. Morris, D. D., Secretary of Assembly's Home Missions.

The report as a whole was then adopted—See Appendix—The following are the recommendations:

- 1. That the Synod endorse the action of the Assembly in apportioning \$287,282 to this work, which is 27 per cent of the amount apportioned to all the benevolent causes, and undertake to raise its proportionate part of it.
- 2. That we approve the plan of observing Home Mission week, Nov. 16-23, and pledge our support to make it effective according to the recommendations of the Executive Committee.
- 3. That our Churches bear in mind the Equipment and Semi-Centennial funds, and endeavor when possible to enlarge them by contributions made in connection with Home Mission and Thanksgiving Services.

The Synod then adjourned with prayer to meet tomorrow morning at 9 o'clock.

THIRD DAY-Morning Session.

GREENSBORO, N. C., Wednesday, October 8, 1913.

The Synod met at 9 o'clock A. M., and the devotional exercises were conducted by the Rev. L. S. Chafer.

The Minutes of previous Sessions were read, corrected and approved.

Letters from Dr. J. B. Shearer and Rev. Wm. Black giving reasons for absence from this meeting, were read and referred to the Committee on Leave of Absence.

A communication from the Rev. Dr. Shearer tendering his resignation as Chairman of the Permanent Committee on Schools and Colleges, and asking to be relieved of the work, was read and referred to the Committee on Nominations.

The Historical Committee made the following report which was approved:

HISTORICAL COMMITTEE.

Your Committee would report, that on the 3rd day of August, 1913, the 158th anniversary day of the first sermon preached in North Carolina by the Pioneer Missionary, Rev. Hugh McAden, a handsome Monument recently erected over his grave at Red House Church in Caswell County, N. C., by a few of his direct descendants, was unveiled with proper religious exercises.

The Rev. D. I. Craig, D. D., made an address, in the form of a sermon, touching the life and labors of the Rev. Hugh McAden.

The Monument was unveiled by Miss Sallie McAden Cothran, of Charlotte, N. C., who is a descendant in the 5th generation from Mr. McAden, and a sermon was preached by the Rev. John McAden Rose, D. D., of Laurinburg, N. C., who is a descendant of the 3rd generation,

The inscription on the Monnment is as follows:

REV. HUGH McADEN.

Pioneer Missionary to North Carolina in 1755, and First Missionary to settle in the State.

Pastor in Duplin County 1757-1768.

Pastor of Red House and other Churches from 1768 to the day of his death, January 20, 1781.

"The Righteons shall be in everlasting remembrance."

A large and appreciative audience was present, and everybody seemed to enjoy the occasion.

D. I. CRAIG, Chairman.

The Moderator appointed the Rev. Dr. W. D. Morton and Rev. R. A. Miller to conduct the Synodical Communion Service, and as assistants Ruling Elders A. F. Patterson, J. M. Belk, J. R. Patton, S. K. Fountain, William Cumming, A. C. McAllister, J. R. Jones, W. J. Martin, William Anderson, E. B. Neave, J. H. Currie and Edward Hines.

The Treasurer of Synod was instructed to pay the traveling expenses of Drs. Moore, Lingle and Smith, incurred in attending the Synod and participating in the Centennial Celebration exercises at Alamance Church.

The report of the Ad-interim Committee, appointed to reproduce a lost Overture from the last Synod to the General Assembly, asking that the Ecclesiastical Year be made to co-inside with the Calendar Year, was read and referred to the Committee on Bills and Overtures.

The following resolution offered by Rev. J. N. H. Summerell was adopted:

RESOLVED.—That it is the judgment of this Synod that no honorary titles shall appear in the Minutes of Synod after the first appearance of the name of the person.

The Synod receded from business for ten minutes.

The Synodical Communion was now observed. Rev. W. D. Morton and Rev. R. A. Miller conducted the services and presided at the table.

After these services the Memorials of Rev. B. L. Beall and Rev. L. M. Kerschner, deceased since the last meeting, were read. The Memorial of Rev. David Fairley, D. D., not being in the hand of the Committee was afterwards presented, but feeling remarks touching his life and labors were made by Dr. Hill and J. H. Currie.

These Memorials were adopted by a rising vote and ordered to be spread on our records.

They are as follows:

REV. DAVID FAIRLEY, D. D.

The Rev. David Fairley, D. D. was born in Jackson County, Miss., January 25, 1831. He was educated at Salem High School, Miss, and at Davidson College. His Theological Course was taken at Columbia Theological Seminary. He was licensed by Harmony Presbytery, South Carolina, October 7, 1858. He was received into Fayetteville Presbytery, at Lumber Bridge, April 9, 1859. He was called to Cypress Church March 25, 1859, and to China Grove, October 23, 1859. He served for years Galatia, Longstreet, Sandy Grove, McPherson, Shiloh, Church of the Covenant, and Phillippi.

He died in Fayetteville, N. C., October 22, 1912, and was buried in Cross Creek Cemetery of that city, October 22, 1912. His funeral services were attended by a number of his ministerial brethren, by many members of his various churches and by a large concourse of citizens.

He preached the gospel for 52 years to the same people and their descendants for five generations.

He was a man righteous before God and his fellows, genial in his disposition, humorous and attractive in conversation, modest and retiring in manner, and yet firm and courageous in publishing and upholding the truth. He was a diligent student of the Bible, and very earnest and

laborous in the preparation of sermons. He preached with fervor and unction, and was always gladly heard by those who sat under his ministry. He was popular with all classes of society and beloved by all who knew him. He traveled many miles to reach his scattered churches and was habitually punctual. As a witness bearer for Christ he was preeminently faithful, and was "a workman that needeth not to be ashamed." The fruits of his ministry are to be found in many converts, in intelligent stable Christians, and in a number of young men led into Christian service as heralds of the Cross. He has won a name more imperishable than brass or marble, which is written on the tablets of immortal souls, and we trust has received the Divine Master's approval.

REV. BENJAMIN LEANDER BEALL.

Rev. Benjamin Leander Beall, born in Lincolnton, Ga. September 18, 1827, died in Greensboro, N. C. February 14, 1913, was at the time of his death the oldest Minister in Concord Presbytery, in the Synod of North Carolina and in the General Assembly of the United States.

In 1843 he entered Oglethorpe University of Georgia. In 1846 he was graduated as the Valedictorian of his class with the degree of A. B. At the Commencement of the same institution in 1847 he was awarded the degree of A. M. In 1839 at the age of twelve years he publicly confessed his failh in Christ under the ministry of Rev. J. C. Reid, a Methodist preacher who was both his pastor and school teacher. In November, 1843 he united with the Presbyterian Church in his native town, entered Columbia Theological Seminary fall of 1846. After spending one year there he went to Greensboro, N. C. and studied Divinity privately one year under the tutorage of Rev. J. A. Gretta, pastor of the Greensboro Church. In 1848 he went to Princeton Theological Seminary New Jersey where he completed his course in Theology and was licensed by Orange Presbytery at the Spring Meeting of 1849. On October the 4th, 1851 he was ordained to the full work of the ministry at Philadelphia Church, then a church of Concord Presbytery. His first work after ordination was as pastor of Wilkesboro, Taylorsville and Salem Churches, all in Concord Presbytery. While pastor of Taylorsville Church, he and Ruling Elder A. C. McIntosh as a commission of Presbytery, organized the Lenoir Church July 31st, 1852 with only three charter members, one male and two females. The roll of communicants of this church now numbers nearly 300. In 1854 Mr. Beall removed to Salisbury and engaged in teaching and Missionary work in the surrounding vicinity until 1856 when he took charge of Mocksville and Franklin Churches

as Stated Supply for one year. From 1857 to 1859 he supplied the Church of Fishing Creek and other Churches in Chester district, South Carolina. In 1864 he was appointed by Presbytery to go to the Confederate Army as a Missionary Chaplain. He served in this capacity during those stormy days of war and blood-shed with the Army of General Lee in Northern Virginia, for a period of time not definitely known. From 1865 to 1868 he supplied New Hope and Dallas Churches in Gaston County. Near the close of 1868 he was elected Evangelist of Concord Presbytery and served as such four consecutive years, preaching mainly in the Mountains of Western North Carolina, in season and out of season, in log school houses, in store buildings and in private homes from house to house, the territory extending from Ashe County, (Virginia line) to Macon County, (Georgia line).

He and Rev. Jesse Rankin were the pioneers of Presbyterian Evangelism in western North Carolina. Eternity alone will reveal the full fruitage of the good seed he scattered in that large territory of Gospel destitution. To this day he is kindly and lovingly remembered by some of the older residents as the first preacher of the Gospel heard in those sparsely settled regions.

In 1872 we find him again in charge of the Taylorsville Church in connection with Catawba Station as a mission point. Early in 1879 he accepted work in Gainesville Texas, but before the end of the year he was called to the Pastorate of Lenoir Church and began his labors June 8th, 1879, and continued them until October, 1882.

During the years 1886-1888 he was engaged as a Home Missionary in Caldwell and Burke Counties. As one result of labors in Burke two Churches were organized. During this period, in 1888 Brother Beall was severely hurt in a Railroad accident while returning from an appointment at one of his Mission Churches in Burke County.

The nervous shock and other bodily injuries he received in this wreck proved to be so permanent that he was hence-forth laid aside from the active work of the ministry. He had the unique privilege of reading his obituary, written by Ruling Elder John McLaurin who was at that time Editor of the North Carolina Presbyterian. He felt authorized to do so as the report of the rail-road accident sent to him stated that Rev. B. L. Beall was killed. But while he was not killed nor fatally hurt, yet he never ceased to suffer bodily pain while he remained in the flesh as the effect of the fearful accident. But his mental vigor was unabated, and his keen interest in the welfare of the Church of Christ, his intense batred of every evil way, his love for the Brethren and lively interest he felt in the proceedings of the Presbytery, Synod and General Assembly continued years after he was too feeble to be personally present at the meetings.

He was loved and honored by the men of his generation.

He was more than once Moderator of his Presbytery and twice sent as Commissioner to the General Assembly. For a number of years he was a Trustee of Davidson College and Financial Agent of Statesville Female College.

He was twice married, first on Sept. 18th, 1849 to Miss Mary Paisly Rankin, daughter of Rev. Jesse Rankin of blessed memory. Of this marriage there were four children, viz: W. P. Beall, M. D., Mrs. J. M. Brown, deceased, H. W. Beall and Edward Beall. First wife died in Oct. 1859 and on July 29th, 1862 he married Miss Jane Elizabeth Alexander who is still living. Of this marriage eight children were born, viz: Earnest A. Beall, (deceased) Mary Beall, (deceased) Jessie May Beall, (deceased) Charles T. Beall, Robert Beall, Meta Eloise Beall, Geo. L. Beall and Louie C. Beall, M. D. Brother Beall was one among the able Theologians and Presbyters of his generation. He was thoroughly orthodox as an old School Presbyterian. He loved to "contend earnestly for the faith once delivered unto the Saints". He was perhaps the most conservative preacher on all points of Christian Doctrine and Church policy in Concord Presbytery.

In 1894 he moved with his family to Greensboro, N. C. where in the presence of the devoted members of his house-hold he fell asleep in Jesus while uttering in a whisper the following touching prayer, "Oh most merciful God, I humbly ask that my reason may continue to the last and that I may leave my testimony of thy faithfulness in fulfilling thy gracious promises, and when my spirit leaves this clay tenement Lord Jesus receive it. "Precious in the sight of the Lord is the death of his Saints."

REV. L. M. KERSCHNER.

L. M. Kerschner, the youngest of the eight children of David and Rebecca Kerschner, was born in Fairfield County. Ohio, July 29, 1844. He received his collegiate and Theological training at Heidelberg College, Tiffin, Ohio.

On the 15th of January 1869, he was licensed to preach and on March 28th of the same year, he was ordained to the full work of the Gospel Minstry in the First Reformed Church, Dayton, Ohio.

Mr. Kerschner's first work was Mission work under the Auspices of the German Synod of the Reformed Church in Illinois and Michigan.

For several years each, he served the Churches of Fort Wayne, Indiana, West Salem, Apple Creek, and Sulphur Springs, Ohio, and a Church in Eastern Pennsylvania.

Then acting under the advice of his physician he came South in search of health and located at McKee, N. C. where he served the lower Davidson charge of the Reformed Church for about three years.

He then removed to Lexington, N. C. and in April, 1900, was received into the Presbytery of Orange. During his stay within the bounds of this Presbytery, he had no regular charge but preached as occasion offered for the brethren or by appointment of Presbytery.

In October 1902, we find him at Spencer, N. C. in answer to a call to the pastorate of that church, and on the 1st Sabbath in December, following he was duly installed pastor by a Commission of Concord Presbytery. This pastorate continued until February 1904, when he had to give up active work on account ot ill health, but continued to preach occasionally as the opportunity was presented.

At the instance of the Synodical Committee of Home Missions, Mr. Kerschner preached at several points in Hyde County during the winter of 1905 and 1906. Here he was followed by the Synodical Evangelist, Rev. Wm. Black who was instrumental in organizing churches at some of these points.

Brother Kerschner is said to have been a good preacher and sound in the faith. His work seems to have borne fruit in all the different fields where he labored, judging from his record of the number who were received into church membership during his ministrations.

On May 14, 1913, the spirit of our brother went to God who gave it and three days later his body was laid in the Chestnut Hill cemetry, there to quietly sleep until awakened in the morning of the resurrection.

THIRD DAY-Evening Session.

Greensboro, N. C., Wednesday, October 8, 1913. The Synod met at 7:30 o'clock P. M. together with a large congregation. A popular meeting in the interest of Foreign Missions was held. The Rev. R. F. Campbell, Chairman presided, conducted the devotional exercises and read the report of the Committee on Foreign Missions. Pending the adoption of the report Dr. Campbell introduced the Rev. W. M. Morrison D. D. of the Congo Mission Africa, who addressed the Synod.

Dr. Morrison was followed by the Rev. S. R. Gammon of the Brazil Mission, who also addressed the Synod.

At the close of these addresses the report of the Committee was adopted—See Appendix.

The following are the recommendations:

- (1) That the Synod urge pastors to preach frequently on the subject of Foreign Missions, cheering and encouraging the people, as far as possible, by the optimistic aspects of the increasing gifts to the cause, and the steady progress of the work, as well as laying on their hearts, the solemn responsibility of the Church to give the gospel to the whole world:
- (2) That the Synod urge the organization of Mission study classes and the observance of the monthly concert of prayer for Foreign Missions.

The following report of the Committee on Special Orders was adopted:

We recommend tomorrow that the Committee on Religious Work among Students of State Institutions, be heard at 12 o'clock.

- 2. That the Permanent Committee on Systematic Beneficence be heard at 12:30.
- 3. That Rev. R. C. Anderson be heard at 12:45 in the interest of Montreat.

The Synod then adjourned with prayer to meet tomorrow morning at 9 o'clock.

FOURTH DAY-Morning Session.

Greensboro, N. C. Thursday, October 9, 1913.

The Synod met at 9 o'clock A. M. and was called to order by the Moderator.

The devotional exercises were conducted by the Rev. L. S. Chafer.

The Minutes of yesterday's session were read and approved. A communication from Miss Annie Wilson Mebane, in behalf

A communication from Miss Annie Wilson Mebane, in behalf of Evangelistic work among prisoners, was read and referred to the Committee on Home Missions.

The order of the day, "A Conference on Christian Education" was observed, and the Committee presented its report which was received and pending the adoption of the report the privileges of the floor were granted to all the educators present and a number of addresses were made on the subject.

The report of the Committee on Conference was adopted and the report as a whole is as follows:

The Educators of Presbyterian Schools and Colleges met in the Smith Memorial Building, Wednesday, 9 A. M., October 8th, 1913 and organized the "Association of Presbyterian Schools and Colleges of North Carolina," electing the following officers: Wm. J. Martin, President; C. G. Vardell, Secretary; and the following Executive Committee: W. J. Martin, Ex-officio; C. G. Vardell, Ex-officio; J. L. Caldwell, Geo. J. Ramsay, and T. E. P. Woods.

The object of this Association is to promote the cause of Christian Education in the Presbyterian Church. This Association memoralizes the Synod of North Carolina in assembly at Greensboro, N. C., October, 1913 as follows:

- 1. That the Synod approve of the organization of this Association and commends it to the Church and our people in its endeavor to arouse the Church to a greater interest and to a hearty support of the cause of Christian Education.
- 2. That the Synod recommend to its Permanent Committee on Schools and Colleges to work in hearty co-operation with this Association and its Executive Committee.
- 3. That Synod urges all its Presbyteries to hold open Conferences on the subject of our Schools and Colleges during their Spring Meeting of 1914, bearing in mind that the General Assembly to meet next May in Kansas City is to be an Educational Assembly.
- 4. That the Synod suggests to each Presbytery that once a year, either at the Fall or Spring Meeting, a Conference on Schools and Colleges be held and an address be delivered on the subject of Christian Education, incorporating this as one of their Standing Rules.
- 5. That Synod urge upon the Presbyteries the necessity for placing the same emphasis on the cause of Christian Education that they do upon

the other great causes of the church, and that this Synod put itself on record as doing so.

- 6. That Synod request the Presbyteries to place the cause of our Schools and Colleges on the budget of all their churches and in such proportion as will materially assist them in meeting current expenses and as will teach our people that this cause is equal in importance to any, as it is fundamental in importance to all the causes of the Church
- 7. That Synod recommend to the Presbyteries that they order funds so collected sent to the Treasurer of Synod's Permanent Committee on Schools and Colleges to be by him disbursed to the Schools and Colleges as each Presbytery shall direct.

The above paper was adopted. And on motion it was moved and adopted:

That the Moderator of Synod appoint an Ad-interim Committee of nine, a chairman and one member from each Presbytery to study the entire problem of Presbyterian Schools and Colleges regarding cooperation, co-ordination, equipment and financial support and to report its findings with recommendations, in these and other matters of interest to our system of education, to the next regular meeting of the Synod in 1914.

The Moderator appointed the following Ad-interim Committee called for in the above paper—W. J. Martin, Chairman; W. D. Morton, R. F. Campbell, W. S. Wilson, J. M. Rose, W. R. Minter, W. E. McIlwaine, A. W. McAllister, J. M. Wells. Subsequently the Moderator was authorized to appointed Alternates to the above Committee, and he appointed the following one to each, in the order above named, viz: Geo. Howard, Dr. S. R. McKee, Byron Clark, J. W. McLauchlin, J. H. Henderlite, Geo. E. Wilson, Neal L. Anderson, W. M. Cumming.

The Synod took recess for five minutes.

After recess the Synod heard the report of the Regents of the Orphan's Home. The report was read by Dr. Hill, President of the Board and pending action upon it, the Synod heard an earnest address by the Rev. Murphy Williams, special agent for the Home.

The report was then referred to the Standing Committee on Orphan's Home.—See Appendix.

The Committee on Religions work among students of State Educational Institutions, Rev. Melton Clark, D.D. Chairman, presented this work to the Synod through addresses made by Prof. A. C. McIntosh, Mr. Frank Graham and Rev. W. T. D. Moss, paster of the Chapel Hill Church. The financial part of the work presented, as it relates to the Chapel Hill Church, was submitted by Mr. A. M. Scales, Treasurer and is as follows:

The Synod met at 3 o'clock P. M. and resumed business, with Rev. C. M. Richard, D.D., Moderator pro tem.

The Standing Committee on the Presbyterial reports on Systematic Beneficence, Rev. Neal L. Anderson, Chairman, made the following report which was adopted:

While the grand total for all causes was \$11,079 less than the previous year, the grand total for the present year is \$303,733, or, including miscellaneous, \$361,038, this sum being \$97,395 more than contributed last year. Deducting the miscellaneous item from both years, the reports this year show an increase of \$56,390 over last year. 383 Churches reported, 165 contributed to every cause, 98 churches made no report. In Wilmington Presbytery every church sent in a report on Systematic Beneficence, and in Asheville Presbytery every church but one sent in such report. See the list of churches failing to report to their Presbyteries in the reports published in the Appendix. The Permanent Committee on Systematic Beneficence submitted their report through the Chairman, and pending its adoption the Synod was addressed by Prof. J. P. McCallie. The report was then adopted together with its recommendation.

—See Appendix. The following are the recommendations:

- (1) That Elders' and Deacons' Conventions be held at least annually in every Presbytery, at which special emphasis should be laid on the methods and advantages of the new plan. Where the bounds of the Presbytery cover a wide territory it is recommended that district conventions be held.
- (II) That the Presbyterial Committee on this subject should be authorized by Presbytery itself to secure wherever practicable a presentation of the new plan in every congregation where it has not been adopted, and that if necessary the expenses of such visitation should be met out of the Presbyterial treasury.
- (III) That Synod request the Presbyteries to instruct their Home Missionary Committees to notify churches receiving aid from the Home Mission treasury, that after the close of the present ecclesiastical year they should not expect aid from the Home Mission Committee until they have adopted and put into effect the plan for an Every Member Canvass for Beneficence.
- (IV) That Synod urge upon the Presbyteries the vital importance of adopting their tables of apportionments at the Fall instead of the Spring Meeting.

On motion it was ordered that in the future the blanks sent down to the Presbyteries for reports on Systematic Beneficence, shall omit the cause designated "Miscellaneous."

The Synod now heard the Rev. R. C. Anderson in the interest of "Montreat."

The Permanent Committee on Publication and Sabbath School Work submitted their report, which was received and pending its adoption the Synod was addressed in the interest of the work by Mr. W. C. Smith of Richmond, Va.—See report in Appendix.

The following are the recommendations

- (1) That the Presbyteries, through their Committees, make an earnest effort to hold one or more Sunday School Institutes during the next twelve mouths.
- (2) That an open conference on Sunday School Work be held from to-11 on morning of 2nd day of next year's session.

The Permanent Committee on the Sabbath and Family Religion made their report which was received, and pending adoption the Synod heard an address on the subject by Rev. R. A. White. The report was adopted as a whole.—See Appendix. The following declarations on recommendations are made:

We declare:-

- (t) The vital connection between the future well being of our church and State and a faithful Sabbath observance along with a pure Family Religion:
- (2) The mutual dependence of these two great matters, so that where Family Religion is preserved the Sabbath is also kept and where there is no Sabbath observance, Family Religion is impossible:
- (3) That the Sabbath, while always, and perhaps, first, a day of rest, is a spiritual ordinance and entirely above the thought of convenience, profit, or pleasure to those who keep it holy;
- (4) That the Fourth Commandment is of equal rank and interpretation with all others of the Decalogue, so that the man who disregards it, is as truly immoral, as he who violates the seventh or eight or of any other.
- (5) That in all our churches, where to sessions it seems practicable, there be held, during the Synodical year, popular meetings in the interest of these important factors in the life and work of the Church, when there shall be a full and free discussion of Family religion and Sabbath observance in the several congregations, with a view to our improvement in the matters which so intimately affect the life of our great nation and of our beloved Church.

The Committee on Special Orders recommended that the place of next meeting be taken up tonight as the second order of the evening. Adopted.

The report of the Permanent Committee on Schools and Colleges was presented and read by Dr. W. J. Martin. The report as a whole was adopted.—See Appendix.

The Synod then took recess until 7:30 o'clock P. M.

FOURTH DAY-Evening Session.

Greensboro, N. C., Thursday, October 9, 1913. The Synod met at 7:30 o'clock P. M. and resumed business, the order of the day being to hear the report of the Executive Committee on Home Missions

The Synod was led in prayer by the Rev. J. M. Rose. The Superintendent and Chairman, Rev. M. McG. Shields, read the report of the Committee, which was received. Pending action upon the report, addresses were made by Rev. Robert King and Rev. J. M. Wells.—The recommendations of the Committee were taken one by one and adopted. The report as a whole was adopted.—See Appendix. The following are the recommendations:

- 1. Cheered by the blessings of God for twenty five years, the Synod renews its resolution to prosecute with renewed vigor the Home Mission work within its bounds.
- 2. That every church in the Synod supporting a pastor for all his time be urged to establish this year at least one mission point in the country, in which a Sabbath School and regular services shall be held largely by the laymen of the church, under the direction of the pastor.
- 3. That Synod appoint a Committee composed of one member from each Presbytery to co-operate with the Assembly's Prison Evangelist while in its bounds.
- 4. In view of the increased obligations resting on the work, due to divine Providence, the members of this Synod be urged to make every possible effort to increase this year the contributions of his church to this cause by twenty per cent.
- 5. That the apportionments of the Presbyteries remain the same for another year.
- 6. That Rev. M. McG. Shields be re-elected Superintendent of Home Missions, and that Revs. William Black and Robert King be re-elected General Evangelists of the Synod. Also that this Synod elect Rev. R. G. McLees a third General Evangelist.

7. SUPPLEMENTAL:

The answers to the resolution sent down by last Synod to the Presbyteries contemplating a change in the method of doing our Home Mission work were referred to this Committee. These answers being in the negative, we would recommend that the said resolution be not adopted.

In order to carry out the provision in the 3rd recommendation above, it was ordered that the Moderator appoint the said Committee, and the following Committee was appointed:

Orange-Rev. S. M. Rankin.

Wilmington-Rev. J. M. Wells, D. D.

On motion the Rev. M. McG. Shields, Superintendent of Synodical Home Missions, and Rev. William Black, General Evangelist, and Rev. Robert King, District General Evangelist, were re-elected by a rising vote of the Synod.

The Rev. S. G. Hutton of the Synod of Georgia and the Rev. Mr. Blain of the Synod of Virginia were invited to sit as corresponding members and introduced to Synod.

The Synod now went into the election of the place for the next regular meeting of Synod, The First Presbyterian Church, Hickory, N. C. was elected as the place. The time being fixed by Standing Rule, the next Synod therefore, will convene in said church on Tuesday, October 27, 1914 at 11 o'clock A. M.

The Synod then adjourned with prayer by Rev. J. McI. Wicker to meet tomorrow morning at 9, o'clock.

FIFTH DAY-Morning Session.

Greensboro, N. C., Friday, October 10, 1913.

The Synod met at 9 o'clock A. M. and the devotional exercises were conducted by Rev. J. E. Ballou.

The Rev. J. M. Rose presided as Moderator pro tem.

The report of the Several Committees on the Records of the Presbyteries were heard and adopted.

The reports as a whole combined into one report is as follows:

- 1. The Records of Albemarle, Concord, Kings Mountain, Orange and Wilmington were approved without exception.
- 2. Fayetteville: Approved, accept. 1. Calls for Special meeting's January 7, 1913; January 13, 1913; February 4, 1913; were not found in order by the Presbytery. 2. The minutes of Commission to organize

Comfort Church not approved by the Commission, and the same is true of Commission in organizing West End Church.

- 3. Asheville: Approved, Except. 1. No Treasurer's report at either Stated Meeting of the year. 2 No record that a call for a special meeting was in order.
- 4 Mecklenburg: Approved, Except. 1. The examination of C. G. Lynch for licensure is accepted in full for examination for ordinaiton.
- 2. Presbytery gives notice to Z. W. Check that a call is placed in his hands and asks for answer, and no answer is recorded. 3. Two prorenata meetings are held, and the calls for the same are not recorded.

The Standing Committee on the Records of Synod, Rev. A. W. Crawford, Chairman, made the following report which was adopted:

Your Committee on the Records of Synod would make the following report:—

1st. We find the printed copy of the Records in good condition, and the written record most beautifully done, and we recommend their

approval

2nd. Inasmuch as the approved printed Minutes of the Synod are now recognized and passed upon by the General Assembly as the official records: And inasmuch as the approved printed Minutes are faithfully deposited in the principal libraries of the church and in our own archives, as the official records: and inasmuch as the printed Minutes contain all the reports and committees and everything done, while the written Minutes contain only the acts of the Synod: Therefore

We recommend

- a. That our Stated Clerk be relieved, hereafter, from the burden of writing the Minutes with a pen as heretofore, it being deemed a burden wholly unnecessary.
- b. That the Stated Clerk be instructed to have five copies of the of the Minutes of each meeting of Synod printed upon the best bond paper for permanent preservation, one of which shall be the official copy.

The following telegram from the Rev. Dr. L. McKinnon was read—"The affectionate remembrance of Synod is most highly appreciated."

Most appreciative letters also were received by the Stated Clerk, after the Synod had adjourned, from Revs. William Black and George Hudson.

The Committee on Special orders made a brief report which was approved.

The Standing Committee on Nominations, Rev. J. N. H. Summerell, Chairman made the following report which was adopted:

COMMITTEE ON NOMINATIONS.

Your committee respectfully reports nominating:

1. Rev. D. I. Craig to succeed himself as Stated Clerk and Treasurer for the next three years.

This recommendation was adopted by a rising vote of the Synod.

To the first class of Regents of Orphan's Home-D. I. Craig, John R. Pharr, A. M. Scales.

To fill A. M. Smyre's place, resigned-Dr. C. E. Adams.

The Ruling Elders, one from each Presbytery, now on the Synodical Home Mission Committee, were re-elected for the ensuing year.

The Committee on Bills and Overtures, Rev. W. McC. White, Chairman, made the following report which was adopted:

The Committee on Bills and Overtures submits the following report: It is recommended:

- 1. That the overture from Asheville Presbytery touching the employment of a Sunday-school Superintendent for the Synod be referred to the Synod's Committee on Sabbath-schools.
- 2. That, in view of the pending negotiations with the United Presbyterian Church, Synod do not adopt the overture of Rev. Dugald

Munroe proposing that we decline to enter into such an union, if consummated.

3 Concerning the communication from the Federal Council of the Churches of Christian America, we recommend that the Synod adopt the resolution proposed and direct the clerk of the Synod to forward same to the Secretary of the Exposition and the mayor of San Francisco.

The following is the resolution:

"Resolved, that we, the Synod of North Carolina, in accord with the action of the Federal Council of the Churches of Christ in America, do earnestly urge the city government of San Francisco and the Board of Directors of the Exposition to adopt every means to prevent the exploiting of the Exposition by commercialized vice and to protect the visitors to San Francisco from such influence as would tend to lower public morals and injure the good name of San Francisco in America."

4 That the overture from Fayetteville Presbytery to make the ecclesiastical and calendar years co-terminous, be adopted and forwarded to the General Assembly.

The Standing Committee on the Minutes of the Assembly, Rev. W. C. Brown, Chairman, reported that the Minutes had been examined and nothing found requiring the attention of the Synod, except such matters as are covered by other Committees. The report was approved.

The Standing Committee on the Address to the Churches made the following report which was adopted.

ADDRESSES TO THE CHURCHES.

Your committee on the Address to the Churches would respectfully report:

We have carefully examined the reports on the Narrative that have been sent up to Synod from the eight Presbyteries of our Synod. In most particulars these reports are highly gratifying. With very few exceptions, the churches of the Synod are supplied regularly with preaching. The attendance upon the services of the Sanctuary is in almost every instance reported as good, and in many cases on the increase, though some churches deplore the small attendance upon the evening services. The observance of the Lord's Day; the training of children in the Sabbath Schools; the fidelity of God's people in worshipping the Lord with their substance, are all spoken of in a hopeful and cheerful tone. Especially have our people been blessed with the grace of liberality, and the reports show a large increase in contributions to the causes of benevolence.

There is also an encouraging note in all the reports as they speak on

the subject of Worldly Conformity. Either the ideals and standards of our churches are low as to what constitutes worldly conformity, and our officers are becoming more lax in their views on this subject, or worldliness is not widely prevalent among our church officers and members.

Most of the Presbyteries report commendable activity on the part of their congregations in conducting evangelistic work outside of their own bounds, and there seems to be an earnest effort in all parts of the Synod to reach the destitutions within our borders.

Few of the Presbyteries report any diligent and systematic efforts on the part of pastors and sessions to secure recruits for the gospel ministry. The turning of the attention of Godly and gifted young men to the ministry, and impressing upon all our young people, God's claim upon their lives, is a matter of greatest and most fundamental importance, and is a duty which no pastor or session can afford to neglect.

As in most of the reports of recent years, the one discouraging note in all these reports is the sad and apparently growing neglect of family worship, and the training of children in the home in the scriptures and the catechisms of the church. This, which we regard as one of the most far-reaching of all Christian duties in its influence and efforts, seems to be neglected by the great majority of the families of our Synod. One church in Orange Presbytery, Elkin Colored, reports all its families holding family worship, and one other church in the same Presbytery reports that 90 per cent, of its members perform this important duty, but we estimate from a careful study of these reports that in not over 15 per cent of the homes of our Synod is family worship held. Does not this fact largely explain the insufficient supply of candidates for the ministry, and does it not largely explain the other facts gleaned from these reports, that there have been special manifestations of the Spirit's presence and power in very few of our congregations during the year?

After studying the statements of these reports on the matter of Family Religion and also in the matter of special evidences of the Spirit's presence and power, we are afraid that we are substituting activity for energy, and are satisfying ourselves with material evidences of growth and success, while lacking in spiritual life and power. The body without the spirit is dead. While rejoicing in the growth of our churches in liberality, and their increased activity in many departments of the work, let us not forget that we need above all else the outpouring of the Holy Spirit, without whose power and blessing all our activity and all our liberality will be wasted and fruitless. The revival most needed and for which we as pastors and sessions should most earnestly pray and labor, is a revival of family religion, and home training in the scriptures and catechisms of the church. The Standing Committee on Union Theological Seminary made the following report which was adopted:

REPORT OF COMMITTEE ON UNION THEOLOGICAL SEMINARY

Your Committee with deep interest and profound gratitude, has reviewed the progress and work of Union Theological Seminary during the past year. This first year of a second century of service has been marked, both by notable beginnings in enlarged and enriched provision for the proper equipment of students, and also by the largest number of students ever before enrolled in any of our Theological Seminaries—the total enrollment being one hundred and seven.

We deem the institution blessed of God, in securing Rev. D. J. Burrell, D. D. to deliver the first series of lectures on the James Sprunt Foundation and would further recognize a good Providence in securing engagements for further service from Sir Wm. Ramsey and Dr. Jas. Stalker.

In providing proper instruction for the students in respect to effective public speaking, another eminently practical and wise step has been taken.

The Synod would record its profound sense of loss in the death of Rev. G. B. Strickler, D. D., for seventeen years professor of Systematic Theology in the Seminary. He came to the institution in 1896 in his mature prime, as a wise pastor, prudent counsellor, and powerful preacher. He set the indelible stamp of his strong personality and his exemplary Christian character on the large classes of young men who sat at his feet during this period, and he taught the great doctrines of our faith with a power unsurpassed in his day and with unswerving faithfulness to the word of God.

The Synod most heartily approves of the election of Rev. T. C. Johnson, D. D. to the chair of Systematic Theology. Dr. Strickler's mantle has fallen upon a worthy successor. We fear no uncertain or false instruction from this stalwart teacher of divine truth.

We invoke the guidance of the Spirit upon the directors in the selection of a permanent professor of Church History.

In view of the fact that the number of students has about doubled within the past decade, it is self evident that the demands upon the resources of the developing institution are continually enlarging. The Board brings it to our attention that the Scholarship Funds are found inadequate.

Your Committee recommends:

1. That increasing the scholarship funds to help approved young men in meeting personal expenses while in preparation for the ministry be commended to the Christian liberality of our people.

- 2. That the Synod would not only approve of direct efforts from the Seminary to lay upon the hearts of our young men in institutions of learning the need of many more recruits for the Gospel Ministry, but would encourage them to assist in leading and directing the church in all legitimate efforts to meet this vital need.
- 3 That Mr. B. F. Hall, Rev. W. D. Morton, D. D. and Mr. Jas, W. Pharr be re-elected members of the Board for the regular term of four years.

The Permanent Committee on Woman's Work submitted their report which was received and adopted as a whole:—(See Appendix.)—The recommendations are as follows:

- 1. That the Synod express its appreciation of the efficient work that is being done by our women.
- 2. That the name of this Committee be changed from the Committee on Womans Missionary Societies to the Committee on Womans Work.
- 3. That the blanks on finance prepared by the Stated Clerk for the use of the Presbyterials enumerate all the causes for which contributions are asked—that there may be a definite record of what the women are contributing all along the line of church work.

The Standing Committee on the report of the Regents of the Orphans' Home, Rev. A. D. McClure, Chairman, made the following report which was adopted, except the last recommendation (6) This recommendation was referred back to the Board of Regents.

Your Committee on the Report of the Regents of our Orphans' Home, beg leave to report.

- 1. That Synod has heard with great gratification the Report of our Regents and recommend its approval and the thanks of Synod to the Regents for their diligence and skill in their work.
- 2. That Synod rejoices in the good success of our Superintendent of the Home and heartily commends his fine ability, faithfulness and good service in every department of his delicate and difficult duties.
- 3. That Synod approves the action of the Board in securing the services of Rev. R. Murphey Williams to raise the fund recommended by Synod for the equipment and thanks the Church of the Covenant for permitting their pastors to do this work and Rev. Mr. Williams for his services and success in securing more money than was asked.
- 4. That Synod authorize our Regents to prosecute further the plan of raising additional funds for Equipment specially from the churches which have not contributed to this.

- 5. That our churches contribute regularly to the support funds and that our Regents seek to secure contributions from all of our churches.
- 6 That Synod adopt the recommendations of the Sub-committee of our Regents, Rev. C. M. Richards and Rev. W. R. Minter, as follows:

That Synod authorize the Board of Regents to elect a Synodical Superintendent of Orphans' Work, and in addition to acting as field agents of the Home at Barium Springs shall, under the direction of the Regents, prosecute and develop Orphan Relief work along the following lines:

- (1) The finding of suitable homes for orphan children and bringing homes and children together. This not necessarily to involve the removal from our home at Barium Springs of any children already there
- (2) Its assistance and proper regulations of widowed mothers: that their children may be kept at home under the mother's training rather than consigned to the care of the institution.
- (3) The making of provision for Synodical care of needy illegitimate children.
- (4) The establishment at one or more Presbyterian centers, where good schools and church privileges are to be enjoyed of Homes, under the care in each case of an approved man and his wife, for children having lost one or both parents, but whose relatives or guardians are able and willing to pay for the support of orphan work.

The following Overture to the Synod, presented by Rev. R. F. Campbell, was adopted:

To the Synod of North Carolina:-

We, the undersigned, hereby respectfully overture the Synod to appoint an Ad-interim Committee, consisting of three ministers and two Ruling Elders, and to request the Synods of Virginia, Kentucky and Tennessee to appoint similar Committees, and that these Committees be instructed by the Synods to meet jointly in order to confer and report as to the advisability of overturing the General Assembly to erect a new Synod in the Appalachian Mountains for the more thorough and systematic prosecution of evangelization and Christian Education in that great Home Mission field now distributed among the four Synods. It is understood that this in no way commits either the Synod or the undersigned to this policy.

- 3. That pastors continue to keep before the minds of the youth of their congregations the urgent need for a large number of candidates for the ministry, and pray constantly "The Lord of the harvest that He would thrust forth laborers into His harvest."
- 4. That the Synod of North Carolina place itself on record as favoring the reading of the Bible in the State Educational System.

The following resolution offered by Rev. W. D. Morton endorsing the Presbyterian Standard was adopted:

The Synod of North Carolina desire to express their deep interest in the valued organ of our Synod, the Presbyterian Standard. Its accomplished Editor, J. R. Bridges, is conducting the paper with ability and success and the management of the paper is fortunate in having secured his services. We feel that this paper is essential to the work of our Synod and the Synod expresses its hope that the paper will receive the patronage of all of our families.

The following resolutions of Thanks were adopted by a rising vote, and the pastors of the Greensboro and Alamance Churches were requested to read the same from their pulpits:

The Synod of North Carolina in Session at Greensboro would extend to Alamance Church and her neighboring churches most hearty thanks for their abundant hospitality extended to Synod on the occasion of the One Hundredth Anniversary of the Organization of the Synod at this church.

RESOLUTION.

Resolved:

That Synod recommend to all its Presbyteries for their adoption the plan that has already been adopted by Wilmington Presbytery for the preservation of the history of our churches.

- Each Presbytery shall appoint one Historical Committee to secure and preserve historical material and to prepare a history of that Presbytery.
- 2. Each Session shall be requested to appoint for its church some person belonging to the congregation, whose duty it shall be to secure historical material and prepare a history of that church.
- 3. Of that history of the local church three copies shall be made. One of these shall be read to the congregation and preserved with the records of the church.

A second shall be sent to the Chairman of Presbytery's Committee to be used by him in preparing a history of the Presbytery, and preserved by him for the Presbytery.

A third copy shall be sent to the Librarian of Union Theological Seminary to be preserved in the fire-proof library building of the Seminary.

The Rev. James Lapsley, in behalf of Mr. J. M. W. White of the Rocky River Church Session, presented to the Synod a Gavel, made of maple wood cut from the site of the first Church building at Rocky River, built in 1754, and the first Church building west of the Yadkin River. The Gavel was received by a rising vote of thanks.

ANNUAL REPORT OF UNION THEOLOGICAL SEMINARY IN VIRGINIA.

The Board of Directors and Trustees of Union Theological Seminary in Virginia would respectfully report to the Synod of North Carolina:

- 1. That in point of attendance the Seminary has again broken all records, the registration for the session being one hundred and seven, the largest enrollment of theological students in the history of our church. Of the one hundred and seven students enrolled eighty-three are college graduates, eighteen have taken college courses in part but without degrees, and six have had no college course.
- 2. That the seven professors have done their work with fidelity and thoroughness and the students have applied themselves to their studies with commendable diligence and success. In addition to the work of the curriculum they have conducted among themselves seven Mission Study Classes, and have made immediate application of the principles acquired in active and well-organized missions in the destitute districts of Richmond and vicinity, including the State Penitentiary the State Reformatory, the City Almshouse, the Soldiers Home, and the Seventeenth Street Mission to Colored People. Twenty-six of the students are volunteers for the foreign field, including thirteen members of the graduating class.
- 3. That the Seminary has secured the services of Prof. Geo. M. Sleeth as Instructor in public speaking and that the students with one accord pronounce his instructions to be of the highest value to them in their training for their work in the pulpit.
- 4. That the first series of lectures on the James Sprunt Foundation was delivered by the Rev. David James Burrell, D. D., of New York, and the lectures published under the imprimatur of the Seminary in a volume entitled "The Sermon, its Construction and delivery;" that the second series will be delivered in October of this year by Sir William Ramsay of Edinburgh on "The Bearing of Recent Discovery on Trustworthiness of the New Testament:" and the third in April of next year by Prof. James Stalker of Aberdeen on "Religious Psychology."

- 5. That the Centennial Anniversary of the founding of the Seminary was happily celebrated in October by the two controlling synods, with a very large attendance of the alumni and other friends of the institution, and that the occasion was further marked by the gift of \$10,000 to the endowment by Mrs. Nettie F. McCormick in memory of her husband, Cyrus H. McCormick, Sr., and by the payment in full, far ahead of the time specified, of the balance of the fund pledged by Mr. George W. Watts, the President of the Board, for the establishment of the Walter W. Moore Foundation.
- 6. That an additional professor's residence has been erected on the campus, thus completing the group of ten substantial buildings devoted to the uses of the institution.
- 7. That the finances of the Seminary are in a thoroughly healthy condition, but that in view of the fact that the number of students has nearly doubled in the last ten years there is need of a large increase in the Scholarship Funds for the aid of worthy and needy students in meeting their necessary expenses.

REPORT OF COMMITTEE ON FOREIGN MISSIONS.

It is with profound gratitude to God, and congratulations to the Synod, that your Committee reports an increase of \$30,406 in the contributions to Foreign Missions over last year. The gifts last year aggregated \$82,653; this year they aggregate \$113,059. This represents a per capita of \$2.34, against \$1.78 last year. We recognize of course that this increase was occasioned by the debt resting on the work; but this fact should make us more grateful, rather than less grateful, for the result.

The contributions by Presbyteries are as follows:

Orange—\$34,127 against \$18,786 last year. Increase \$15,-341.

Wilmington—\$22,221 against \$23,718 last year. Decrease \$1.497.

Fayetteville—\$18,217 against \$11,431 last year. Increase \$6,786.

Mecklenburg—\$15,819 against \$12,731 last year. Increase \$3,088.

Concord—\$10,823 against \$7,829 last year. Increase \$2,-994.

Albemarle— \$5,191 against \$3,481 last year. Increase \$1,-710.

Asheville—\$3,725 against \$1,805 last year. Increase \$1,-920.

Kings Mountain—\$2,936 against \$2,872 last year. Increase \$64.

The per capita contributions by Presbyteries are as follows:

Wilmington-\$4.58 against \$4.97 last year.

Orange—\$4.48 against \$2.54 last year.

Asheville—\$1.99 against \$.95 last year.

Mecklenburg—\$1.86 against \$1.57 last year.

Fayetteville-\$1.65 against \$1.12 last year.

Albemarle—\$1.59 against \$1.17 last year.

Concord-\$1.35 against \$1.01 last year.

Kings Mountain—\$.93 against \$.94 last year.

Your Committee would call the attention of the Synod to the following findings and recommendations of the General Assembly at Atlanta.

- 1. After a thorough examination of the work and methods of the Foreign Mission management, the Assembly found that the business is conducted in a thorough and judicious manner, and that the financial administration is so economical that the expense of conducting the business is a trifle over 5 per cent of the moneys handled, the average cost of conducting such enterprises being 8 per cent, and our own being the lowest of which we have any knowledge.
- 2. The Assembly pronounced the past year the most remarkable in the history of our Foreign Mission work, as evidenced in The immense increase in the amount contributed by the Church for this cause over any sum heretofore given;

The abolition of a most distressing and disheartening debt which had been carried for years;

The beginning of the present year with a balance in hand;

The reorganization of the work in the interest of greater efficiency and economy;

The sending out of the largest number of missionaries ever sent out by our own Church in any one year;

The sustained blessing of God upon the work in the field, resulting in larger opportunities and the accession to the Church of 3,185 souls;

A gracious awakening in the Home Church to the joy of a greater ministry to the world.

3. In order to remove an erroneous impression on the subject, the General Assembly declares that its new financial plan neither necessitates nor contemplates the reduction of contributions heretofore made by societies, churches or individuals to any cause, but rather the enlistment in behalf of the other causes of our people heretofore unused means and energies.

Your Committee would also call the Synod's attention to the following warning recently issued by the Executive Committee in Nashville:

"In pursuance of a strictly conservative policy, the Executive Committee has sent out between April 1 and September 1, only six (6) new Missionaries. For the same period the regular expenses of the work have exceeded the receipts by about \$60,000.

"While nearly one-fourth of the year's income is usually received in March, and while there is always a large falling off of receipts during the middle half of the fiscal year, yet to begin the year, April 1, \$7,000.00 ahead, and find ourselves, September 1, \$53,000.00 behind, emphasizes the wisdom of the Atlanta Assembly in 'urging all the lower Courts, Synods, Presbyteries,

and Sessions, -to avail themselves of every proper means to guard against reaction."

Recommendation:

- 1. That the Synod urge pastors to preach frequently on the subject of Foreign Missions, cheering and encouraging the people as far as possible by the optimistic aspects of the increasing gifts to the cause and the steady progress of the work, as well as laying on their hearts the solemn responsibility of the Church to give the Gospel to the whole world.
- 2. That the Synod urge the organization of Mission Study classes and the observance of the monthly concert of prayer for Foreign Missions.

ASSEMBLA'S HOME MISSIONS,

Your Committee on Assembly's Home Missions would report as follows:

A detailed review of all the departments of this great work will hardly be expected in a reasonably brief report; nor is it necessary, inasmuch as the report of the Assembly's Executive Committee in pamphlet form has been sent to all of our ministers, and the same, together with the report of the Assembly's Standing Committee on Home Missions, has been published in the Assembly's Minutes.

These reports show that the past year has been the greatest in the history of this work, signalizing as it has been by the largest aggregate of money given, the deepest and most wide-spread interest of our people, and the greatest number of souls saved and added to the Church.

The cope of Home Missions has enlarged until now it includes eight important departments. Concerning these we remark: That the evangelistic and Mountain Work continue to be blessed, that the Frontier is shifting but maintaining its importance relative to the future of our whole country, that work among the Foreign Speaking continues to develop with the steady influx of foreigners: but not in support given to the work of sustentation, of Church Extension, of Colored Evangelization and of Mission Schools remains inadequate as heretofore. We recommend:

- 1. That the Synod endorse the action of the Assembly in apportioning \$287,282 to this work, which is 27 per cent of the amount apportioned to all the benevolent causes. Each to raise its proportionate part of it.
- 2. That we approve the plan of observing H. M. week in November—Nov. 16-23—and pledge our support to make it effective according to the recommendations of the Executive Committee.
- 3. That our churches bear in mind the equipment and semicentennial funds and endeavor when possible to enlarge them by contributions made in connection with Home Mission and Thanksgiving services.

SYNODICAL HOME MISSIONS.

After a quarter of a century of interrupted divine blessing on the Home Mission work of this Synod, your Committee, with profound gratitude to God, presents this the twenty-fifth annual report of the work committed to its care. During these years the Synodical workers have entered fifteen counties where the Presbyterian Church was unknown before, have been instrumental in organizing 81 churches and 115 Sabbath Schools, have witnessed 24,043 professions of faith in Christ and have received 12.966 members into the Presbyterian Church. Substantial aid has been rendered in support of the men in charge of Lees-McRae Institute at Banner Elk and Plumtree, Mast Seminary, Maxwell Home and School, Morrison Industrial School, Elise High School, and other mission day schools in different sections of the State.

During the past Synodical year the blessing of God has been no less manifest than in the preceding years. Thirty-two men have been employed for all or a part of the time. The full story of their self-denial, their labors of love will not be told till all the secret things are revealed, and the surpassing value of the precious truth spoken and the influence of their godly lives cannot be known until "the books are opened." But these invaluable results may be put down on paper: Three churches and eight Sabbath Schools organized, 1,337 persons led to Christ and 708 members received into the Presbyterian Church. For this work \$10,706.34 have been received from all sources, and the entire amount has been expended on the work, as will be seen in the Financial Statement of this report.

While the final purpose of all this Committee's activities is the salvation of the lost, the work, for convenience, may be dilided into four departments: Evangelistic, Sustentation, Educational and Church and Manse Erection.

I. EVANGELISTIC.

Two General Evangelists and the Superintendent engage in Evangelistic work, and every Presbytery in the state receives Synodical assistance in this department of its work.

REV. M. McG. SHIELDS, Superintendent, for five years past has discharged the duties of this office to the best of his ability, has given the work general superintendence, has kept

the churches informed of its needs and prospects through articles in the church papers and circular letters issued at intervals, has received and disbursed the funds contributed to this cause; and, in addition, as in the four preceding years, has made full time as an evangelist. He held during the year fourteen profracted meetings, preached 247 times in 36 different places, witnessed 125 professions of faith, about all of which joined the Presbyterian Church.

REV. WILLIAM BLACK completes with this Synod this twentieth year as General Evangelist. Since the first of last October he labored six and one-half months in the Synod, during which time he held eleven protracted meetings in which there were 661 professions of faith and 266 additions to the Presbyterian Church and \$710.14 raised for Synodical Home Missions. Three and one-half months were spent holding meetings outside the Synod, for which time he received no salary from your Committee. Including the work done in other Synods this Evangelist has preached 315 times in twenty different places, witnessed 1,058 professions of faith of which 365 joined the Presbyterian Church. He raised for congregational purposes and Church Erection \$1,575 and 150 persons promised to establish the family altar. He organized one Sunday School and perfected the organization of one church. Your Committee reports with profoundest regret that this faithful and Spirit-blessed Evangelist has, for two months, on account of impaired vision, been temperarily retired from active work, and is now under treatment by a specialist.

REV. ROBERT KING makes this year his second report as General Evangelist of the Synod. He has spent most of his time in Albemarle Presbytery, giving three meetings to Asheville Presbytery, two to Fayetteville and one each to Concord and Wilmington. He has been in labors more abundant, going from house to house and doing the work of an Evangelist in the truest sense. He has held 21 meetings, largely in mission territory. As a result of his labors 345 persons have acknowledged Christ as their Saviour and 215 have united with the Presbyterian Church. Plans are forming to organize three churches largely as the results of his activities. He has raised \$164.75 for Synodical Home Missions.

11 SUSTENTATION.

Five of the eight Presbyteries are assisted in their work of Sustentation. Space will not allow a detailed statement of the labors of each man. Suffice it to say that eighteen men have labored in the different Presbyteries as follows: In Albemarle, Revs. J. B. Black, Carr Moore, P. L. Clark, F. F. Jones, J. S. Kennison and J. M. Millard. In Asheville Revs. J. C. Brown, W. H. Davis, R. J. Hunter and E. H. Norwood. In Concord Revs. J. W. Rosborough and John McSween. Rev. C. C. Carson in Kings Mountain and in Wilmington Revs. J. M. Gibbs, W. M. Shaw, J. M. Plowden, James Thomas and L. E. Wells. These men have labored where the destitutions are great and where progress is naturally and necessarily slow. They have led to the Saviour 224 souls and received into the Presbyterian Church 194 members. They have collected \$215 for Synodical Home Missions. \$3,453 for pastoral support and \$2,407 for other purposes. Six students from the Seminary spent the summer on sustentation fields, and all did splendid work.

III. EDUCATIONAL.

This Committee has given aid to five men in three Presbyteries in charge of Mission Schools. They are Revs. J. Q. Wallace, Maxwell Home and School, C. B. Yeargan, Morrison Industrial School, Edgar Tufts and J. P. Hall, Lees-McRae Institute at Banner Elk and Plumtree, and R. S. Arrowood, Elise High School. No agency is doing more to transform communities and advance the cause of Christ than these mission schools, though the full report of their school work is made to the committee on Church and Christian Education. All these men preach regularly in organized churches and mission points, and their labors in this field have been abundantly blessed.

IV. CHURCH AND MANSE ERECTION.

At the meeting of the Synod two years ago this cause was placed in the hands of this committee. From the Permanent Committee previously in charge of this department there was received the sum of \$523.52. In the past two years nine calls were made on the subscribers to this fund, from which \$2.323.56 were received. Assistance was rendered in the erection of Mizpah, Fountain, High Shoals, Parker's, Black Mountain, Selma, Newland, Pageland, Lassiter's, Farmville, Spence Chapel churches, and manses at Brevard and Pittsboro.

Of this amount the Ladies Societies gave \$285.72, the Sunday Schools gave \$144.72 and the Young People's Societies gave \$66.02. Six of the Presbyteries Albemarle, Asheville, Concord, Fayetteville, Kings Mountain and Wilmington gave more this year than last, and two Presbyteries, Orange and Mecklenburg gave less. Kings Mountain for two years has been found in the climbing class.

WORK DONE BY THE PRESBYTERIES.

So much for the work done under the direction of the Synod's Committee. Our idea of the Home Mission work done by our church in the state would be woefully incomplete did we not get some glimpse of the splendid work done by each of the Presbyteries within its own bounds. The following table will show at a glance what has been done by these agencies:

The Permanent Committee on Systematic Beneficence note with gratification the increase in gifts to Benevolences this year as compared with 1912 of nearly \$60,000.00. While it would be too much to say that this is due altogether to the efforts to put rnto effect the Assembly's new Plan of Beneficences, it is a striking fact that such a remarkable increase should attend the attempt to introduce the plan in all the churches of the Synod.

Although the reports from the different Presbyterial Chairmen are not as complete as is to be desired, the following data will doubtless prove of interest to the Synod:

Orange Presbytery reports that the Every Member Canvass has been undertaken in 33 churches, or 44 per cent. of the churches of the Presbytery—these churches represent 72 per cent. of the membership enrolled in the churches of the Presbytery, and contributed the grand total of \$80,803, or 98 per cent. of the total gifts of the Presbytery to the causes of Beneficence. The total gifts of the Presbytery for these causes have increased by \$24,681 as compared with last year, being an average of \$10.82 per member. The number of churches using the new plan has increased 50 per cent. during the past year.

In Fayetteville Presbytery only 10 per cent. of the churches have adopted the plan. The Presbytery reports that the gifts to the causes of Beneficence have increased more than \$9,000 during the year as compared with last. A conference was held on this cause in August at Red Springs.

Concord Presbytery held a conference at Statesville in November, 1912. Thirty per cent. of the Churches, representing 80 per cent. of the membership have adopted the new plan, and the total gifts to these causes have increased by nearly \$2,000.

In Wilmington Presbytery only two churches had adopted the plan up to the last meeting of Synod. This number is now increased to 11 churches, or 20 per cent, of the churches, representing 50 per cent of the communicants, while there has been an increase in total gifts to Benevolences of more than \$30,000.

Meckienburg Presbytery reports that 21 churches, or 36 percent, of the churches have adopted the plan, and nearly \$1,000 more than last year have been raised. A conference on Evangelization and Stewardship was held last November, and an Elders' and Deacons' Convention is held every year.

The Presbyterial Committee plans to secure a presentation of the Every Member Canvass plan to every congregation where it is not in use.

Albemarle Presbytery reports that 29 per cent, of its churches have adopted the plan, representing 65 per cent of the membership, with an increase in gifts of more than 23 per cent, over last year.

Asheville Presbytery reports 25 per cent, of its churches as using the new plan, representing about 50 per cent of the membership. Conferences with elders and deacons on the Every Member Canvass plan were held during sessions of Presbytery. The Presbyterial Committee proposes to furnish envelopes for inaugurating the plan free to those churches that do not feel able to purchase them.

King's Mountain Presbytery reports that 20 per cent. of the churches, representing 50 per cent. of the membership have Introduced the new plan. An interesting conference was held on the subject, to which Presbytery devoted an entire afternoon at the Fall meeting. A Deacons' Convention meeting semi-annually has become a permanent institution in this Presbytery.

As many have feared the effect of the new plan on special interests of the Church, particularly on Foreign Missions It should be noted that in those Presbyteries in this Synod where the plan has been most vigorously pushed, and most widely adopted there is a marked increase in gifts to other causes, and particularly to the cause of Foreign Missions. To cite only four Presbyteries: The gifts to Foreign Missions in Concord Presbytery show an increase of over \$3,000 (33 1-3 per cent.) compared with last year. Mecklenburg Presbytery shows an increase for Foreign Missions of more than \$3,000, nearly 25 per cent. Orange Presbytery reports an increase of approximately \$16,-000 to Foreign Missions, or nearly 90 per cent, increase. etteville Presbytery shows an increase of nearly \$7,000, more than 60 per cent. It is not claimed that these increases are altogether due to the new plan, but it is insisted that the plan has not in any way injured this great cause in our Synod. it is universally acknowledged that in the long run it must prove helpful to this as to every other cause.

Your Committee believe that the facts presented in this Synod alone justify the hopes of the advocates of the new plan, and that in its universal adoption lies the solution of most of the financial problems involved in the great causes of Benefi-

cence. The problem facing the Church is How shall the Every Member Canvass be introduced into Every Church?

In answering this question your Committee would make the following recommendations:

(I) That Elders' and Deacons' Conventions be held at least annually in every Presbytery, at which special emphasis should be laid on the methods and advantages of the new plan.

Where the bounds of the Presbytery cover a wide territory it is recommended that district conventions be held.

- (II) That the Presbyterial Committee on this subject be authorized by Presbytery itself to secure wherever practicable a presentation of the new plan in every congregation where it has not been adopted, and that if necessary the expenses of such visitation should be met out of the Presbyterial treasury.
- (III) That Synod request the Presbyteries to instruct their Home Missionary Committees to notify churches receiving aid from the Home Mission treasury, that after the close of the present ecclesiastical year they should not expect aid from the Home Missionary Committee until they have adopted and put into effect the plan for an Every Member Canvass for Beneficence.
- (IV) That Synod urge upon the Presbyteries the vital importance of adopting their tables of apportionments at the Fall instead of the Spring meeting.

REPORT ON CHRISTIAN EDUCATION AND MINISTERIAL RELIEF.

To the Synod of North Carolina:

Your Committee would report that the number of candidates for the ministry under the care of our Presbyteries is as follows:

Albemaile, 5; Asheville, 0; Concord, 38; Fayetteville, 26; Kings Mountain, 15; Mecklenburg, 27; Orange, 22; Wilmington, 9; total, 142. We have therefore more than twice as many candidates as any other Synod in the Assembly, and more than one-fourth as many as all the other Synod's combined, the total number in the whole Assembly being 502.

Of our 142 candidates 84 received aid from the Assembly's Committee during the past year to the amount of \$8,110.00.

The Synod has 24 beneficiaries of the funds of Ministerial Relief, distributed among the Presbyteries as follows: Albemarle, 2: Asheville, 0: Concord, 6: Fayetteville, 3: Kings Mountain, 3; Mecklenburg, 2: Orange, 3: Wilmington, 5. The total amount paid these beneficiaries is \$3,865.00.

The contributions by Presbyteries to the Assembly's Committee of Christian Education and Ministerial Relief are as follows: A;bemaile, \$1,319.90; Asheville, \$311.06; Concord, \$1,104.64; Fayetteville, \$1,828.55; Kings Mountain, \$460.06; Mecklenburg, \$1,458.14; Orange, \$2,075.04; Wilmington, \$746.29. Total amount contributed, \$9,303.68. Our candidates and beneficiaries together received from the Assembly's Committee during the past year, \$11,975.00, which is \$2,671.32 more than we contributed.

We would call attention to the following actions of the Assembly in regard to this cause:

- 1. The Assembly recommended that the sum of \$154,280 be taised this year, which is 14 1-2 per cent, of the amount asked for the Assembly causes.
- 2. After calling attention to the increase in the number of candidates for the ministry and the great number looking to the Committee for aid, the General Assembly declared: "There is need for 250 ordained ministers to occupy the home field, in places where support is available, and a larger number for the regions beyond."
 - 3. The Assembly recommended that the last Sabbath in

February, and the preceding Wednesday, be re-appointed as a time of special prayer for youth in schools and colleges.

- 1. The Assembly declared that the endowment Fund of Ministerial Relief should be kept continuously before the mind of the Church, especially in view of the facts that no time is now, et for an offering to this fund, and it is not included in the percentage for the Assembly causes which have been requested for Ministerial Relief.
- 5. The Assembly also adopted a resolution urging all the Synods and Presbyteries to give earnest attention to the work of Christian Education using every endeavor to arouse our people to a deeper appreciation and a more liberal support of our educational institutions.

Your Committee would recommend:

- 1. That the Synod request the Presbyteries to hold a conference on Christian Education at their Fall Meetings.
- 2. That pastors be urged to preach at least once during the year on the fundamental importance of the work of our church schools and colleges.
- 3. That pastors continue to keep before the minds of the youth of their congregations the urgent need for a large number of candidates for the ministry, and pray constantly "The Lord of the harvest that He would thrust forth laborers into His harvest."
- 4. That the Synod of North Uarolina place itself on record as favoring the reading of the Bible in the State educational system.

REPORT OF COMMITTEE ON SYNODICAL SCHOOLS AND COLLEGES.

Synod's Committee begs leave to report:

- 1. Davidson College, in which all the Presbyteries of Synod are interested directly, was more prosperous the last year than ever before. She has been gathering up the last installment of her endowment of \$300,000, and is expanding her faculty and her plant as rapidly as her increasing revenues will justify.
- 2. The Female College and Institutes belonging to our Presbyteries or under their control directly and indirectly need only brief mention in this report. No doubt they will be granted by Synod the opportunity of presenting their claims. They are all prominently before the eyes of the Church and they all more and more deserve their increasing patronage. We enumerate:

Queens College, Charlotte, N. C.; Southern Presbyterian College, Red Springs, N. C.; Statesville Female College, Statesville, N. C.; Peace Institute, Raleigh, N. C.; Lees-McRae Institute, (girls), Banner Elk N. C.; James Sprunt Institute, Kenansville, N. C.; Normal and Industrial Institute, Albemarle, N. C. These report in the aggregate, 102 teachers, 1,147 pupils and property worth \$666,000.

3. We may also report the following schools "ranging In grade from primary to collegiate courses," and mostly co-educational:

Lees-McRoe Institute (boys), Plumtree, N. C.; Westminster School (boys), Rutherfordton, N. C.; Cedar Valley School, Hudson, N. C., Co-Ed.; Glade Valley High School, Sparta, N. C., Co-Ed.; Hughes School, Hughes, N. C., Co-Ed.; Stanley Hall, Locust, N. C., Co-Ed.; Maxwell Home and School, Franklin, N. C., Co-Ed.; Indian School for Girls, Franklin, N. C.; Porter Academy, Porter, N. C., Co-Ed.; Powder Mill Presbyterian School, Senia, N. C., Co-Ed., and a number of other mission schools not formerly reported.

These 10 schools report 33 teachers, 693 pupils and property worth \$127,000. We need not mention the Orphans' Homes and their rapid expansion in the past year.

4. Your Committee has made no effort to ascertain and report the moneys raised for sustaining all these schools during the past year, nor for improving their equipment, nor for paying debts contracted in their development. But the amount has been large.

- 5. The collection in the churches for Synodical Schools and Colleges continue small. This is not surprising nor discouraging when we consider the large amounts that have been raised for equiping and endowing so many enterprises, including Union Seminary. Davidson College and the Orphans' Home. Synod may well rejoice in the great work so successfully accomplished in and by all our institutions. Is not the way now open to greatly increase our church collections for this cause and to place it in the forefront along with the great causes of our church? Plans are on foot to unify the efforts of our church in education for a large success which it would be premature to discuss in this report.
- 6. We submit as a part of this report a statement of the collections and disbursements for this cause since the last meeting of Synod. It will be seen that three of our Presbyteries have sent no collections to this committee. Presumably they needed and used all they could raise to foster their own schools. Of this we make no criticism, except to say that the largest result would be secured if we all pull together. The disbursements have been made in accordance with the expressed wishes of the Presbyteries contributing.

REPORT OF COMMITTEE ON WOMEN'S MISSIONARY SOCIE-TIES.

Your Committee would report that it has been a great year's work by the women of our Church, and the women of our Synod have taken no small part in this advance. The Synod has been thoroughly organized. There is an active Presbyterial in each Presbytery, each of these holding its annual meeting and reporting much enthusiasm and a great deal of work done. We would note especially that the women have broadened their work so as to take in each department of the general work of the The name, therefore, of Women's Missionary Society should be stricken from our reports, because the women are now interested in all of the work of the Church. The North Carolina Synodical met at Montreat August 14th. All of the Presbyteriats were represented. Encouraging reports were made by all officers, showing great increase of interest in all branches of the work. We call attention of the Synod to the fact that the Assembly allows the Presbyterials to send their contributions direct to the different treasurers, simply reporting the amount sent to the clerks of Session or Presbytery, as it may be. This meeting at Montreat was a great success. Carefully prepared addresses were made. The business of the Synodical was gone into thoroughly, and large plans were laid for the future. REPORT OF COMMITTEE ON SABBATH SCHOOL AND PUBLICATION.

Your Committee would submit the following report:

Number of schools, 377, total enrollment, including cradle roll and home department, 37,961, an increase of 459 over last year. Pupils added to the communion from the Sunday School, 1,143, an increase of 328. Gifts from the Sabbath Schools, \$35,-140. This is \$10,541 more than last year. Orange Presbytery leads all others in total membership by 921, also in total gifts, while Fayetteville has the largest number of schools, 94. Three Presbyteries, viz: Fayetteville, Mecklenburg and Albemarle report all schools open 12 months in the year. This is much better than last year when no Presbytery made such a report. A number of schools report special religious interest. Fayetteville having as many as 27 and Concord 11. We recommend:

- 1. That the Presbyteries, through their Committees, make an earnest effort to hold one or more Sunday School Institutes during the next twelve months.
- 2. That an open Conference on Sunday School work be held from 10 to 11 o'clock on the morning of the 2nd day of next year's session.

REPORT OF THE COMMITTEE ON THE SABBATH AND FAM-ILY RELIGION

To the Synod of North Carolina in Session at Greensboro, October 6, 1913:

Your Committee on Family Religion and the Sabbath would respectfully report, that so far as we are able to judge, there has been, in the past year, no improvement over our church in these vitally important matters, but rather the contrary. It is true that there are indications, increasingly plain, that organized demand will secure to all laboring men, one day in seven of exemption from labor: but this rest day, which should be Holy, seems more and more, and apparently with the consent of many professed servants of God, to be used for convenience and pleasure, rather than for that quiet and devotion for which it was intended and which would result in the fullest renewal of strength and fitness for service. Wherever the Sabbath is desecrated or misused it cannot, of course, be expected that Family Religion will be more than a vanishing quantity.

Your Committee does not see the wisdom or profit of loading our Minutes with an essay on existing conditions as touching these most important matters, but would simply recommend that this venerable Synod as it begins its second century of witness bearing and service, put itself on record before all men as declaring:

- 1. The vital connection between the future well-being of our Church and State and a faithful Sabbath observance along with a pure Family Religion.
- 2. The mutual dependence of these two great matters, so that where Family Religion is preserved the Sabbath also is kept and where there is no Sabbath observance Family Religion 1s impossible.
- · 3. That the Sabbath, while always, and perhaps first, a day of rest, is a spiritual ordinance and therefore lifted entirely above the thought of convenience, profit or pleasure to those who keep it Holy.
- 4. That the Fourth Commandment is of equal rank and interpretation with all others of the decalogue, so that the man who disregards it, is as truly **immoral** as he who violates the seventh or the eighth, or any other.

5. That in all our Churches, where to sessions it seems practicable, there be held, during the next Synodical year, Popular Meetings in the interest of these important factors in the life and work of the Church, when there shall be a full and free discussion of Family Religion and Sabbath observance in the several congregations, with a view to our improvement in these matters which so intimately affect the life of our great Nation and of our beloved Church.

REPORT OF REGENTS OF ORPHANS' HOME,

The Regents of the Home can make a gratifying report to Synod for the year just closed. The buildings and grounds are in good condition, some important repairs and improvements have been made and the whole plant is becoming more attractive each year. We have received and maintained in the Home, 191 orphans during the year, which is six more than we have ever cared for before. Yet there are always more applications for admission than we have room for. The health of the inmates has been generally good, we have had no serious or fatal cases of disease, and the services of the physician, Dr. M. R. Adams, have been prompt and efficient. The support fund, though \$300 less in amount than last year, has by efficient management, judicious buying, successful labor in farm and garden, and a wise economy, been made adequate to meet expenses, and a small amount stands to the credit of the support fund at the close of the year. Our field agent for securing the \$50,000 for better equipment, Rev. R. Murphy Williams has prosecuted his canvass for this purpose from Jan. 1, 1913, to Oct. 1, with great energy He had some helpers and many hindrances, but has gotten some \$60,612.79 in pledges and cash from churches and individuals. Yet many of our smaller churches have not been visited and have contributed nothing to this worthy cause. During the year three bequests have been made to the Home. From Mrs. I. R. Alexander, of Mooresville, \$1,000. Polly Ann Southerland, of Rosehill, \$15, and from Mr. D. P. Mast, of Winston-Salem, \$100. The amount of the Endowment Fund invested and bearing interest is \$3,000. Mr. John F. Mc-Nair, of Laurinburg, has promised, included in \$60,000 mentioned, \$7,000, half or all to be paid this month to erect a Graded School building as a Memorial to his wife. The cattle barn, providing ample storage for feed stuff and forage, and 50 stalls for cows, has been built of brick with a metal roof. Beside it also two concrete silos have been erected, holding a hundred tons each of ensilage. The Dayvault property, adjoining our farming lands and embracing 42 acres of land and a two-story house, has been bought for \$3,500. The house is worth at least a \$1,000 and can be occupied by our farmer and the boys who cultivate

the land. The whole property of the Home is worth fully \$100, 000.

THE SUPERINTENDENT'S REPORT.

Our superintendent, Rev. W. T. Walker, presents in his report some interesting details as to some departments of the work of the Home, not hitherto mentioned. The farm has been efficiently managed and has rendered valuable aid in the support of the Home. The corn and forage crops have been good and will be adequate for feeding the stock. The fruit crop has been a failure and vegetables not so abundant as last year, so there has been less canned for Winter use. Yet 1,035 gallons of tomatoes and beans have been canned. The Dairy has been well managed by the man now in charge, has some 25 cows, and with a larger number gradually added and the increased facilities for caring for them furnished by the new barn and silos, will become more valuable. The Work Shop conducted by the mechanic and his boys has rendered efficient service in repairs and work on silos, barn and other improvements.

The Press Department is training some of our boys in the art of printing publishing the paper regularly every week, doing all the job work for the Home, and the paper now has 1,800 subscribers or 700 more than last year, and advertising which amounts to \$600, though the Press Fund is overdrawn \$488.98, yet \$425.29 of this was the shortage of last year, and the present overdraft includes some printing material bought and is offset by \$404.12 due for subscriptions and advertising.

The School. This department is well organized, has an efficient corps of teachers and renders excellent service. The children, who go to school half of each day, attend to their studies in a gratifying manner.

Religious Work. The children are regularly drilled in the Scriptures and in the Catechisms. Sabbath School is conducted every Sabbath afternoon, and there is a preaching service by the pastor. The children show an interest in the affairs of Christ's Kingdom. The church pays all church apportionments and sent \$335 for the Foreign Missionary debt. Donations in kind during the year amounted to \$1,358.70.

STANDING RULES OF SYNOD

Revised and Adopted October, 1905.

I.—GENERAL RULES.

(Pertaining to the Synod as a Body.)

- 1. The Stated Meetings of this Synod shall be held annually, and unless otherwise ordered, in the month of October, beginning on the Fourth Tuesday of said month at 11 a.m.
- 2. The Parliamentary Rules of Order, adopted by the General Assembly, and published in the Book of Church Orded, shall be the Rues of Order for the guidance of Synod.
- 3. The officers of the Synod shall be a Moderator, a Stated Clerk, a Treasurer, two Temporary Clerks and a Board of Trustees consisting of five members. The Moderator and the Temporary Clerk shall be elected at each Stated Meeting and the Stated Clerk, the Treasurer, and the Board of Trustees shall be elected every three years counting from 1886.
 - 4. The Synod shall elect annually:
 - (a) A Superintendent of Synodical Home Missions.
 - (t) A General Evangelist.
 - (c) Three Members of the Board of Directors of Union Theological Seminary, whose term of office shall be four years.
 - (4) *Four members of the Board of Regents of the Orp!:ans' Home, term of office shall be for four years.
- 5. The Synod shall elect triennially, counting from 1886, the following Committees which shall be known as the "Permanent Committees" of the Synod.
 - (a) On Synodical Home Missions, consisting of the Chairman of each of the several Presbyterial Committees on Home Missions, and one Ruling Elder from each Presbytery. The Superintendent of Synodical Home Missions shall be "ex-officio" Chairman, and the General Evangelist shall be "ex-officio" a member of this Committee and it shall be charged with the conduct of the work of "Synodical Home Missions" under the direction of the Synod and in harmonious co-operation with the several Presbyteries.

- (b) On Foreign Missions.
- (c) On Assembly's Home Missions, including Colored Evangelization and Evangelistic work. (1910).
- (4) On Christian Education and Ministerial Relief, including the Causes of Assembly Schools and Colleges and the Assembly 8 Home and School. (1910).
- (e) On Publication and Sabbath Schools.
- (f) On the Sabbath and Family Religion.
- (g) On the Bible Cause.
- (h) On Women's Societies.
- (i) On Synodical Schools and Colleges. (1911).
- (j) On Young People's Societies, Brotherhoods, Covenanters, etc. (1911.)
- (k) On Systematic Beneficence, (1911).

These Committees, except the first named, shall consist each of a Chairman appointed by the Synod, together with the Presbyterial Chairman of the Several Causes, respectfully. And it shall be the duty of the Committees to take into consideration everything bearing upon the Causes which they represent calculated to inspire interest to increase knowledge and to promote the growth and glory of Christ's Kingdom, and to report in writing through their Chairman at each meeting of Synodi.

- (1. A Historical Committee, consisting of three members including the Stated Clerk, who shall be "ex-officio" Chairman. It shall be the duty of this Committee to be a medium of communication and information with other like Committees or Societies, and to have a watchful care for the preservation of all records, documents and papers belonging to the Synod and, to collect and preserve all posssible material of historical value pertaining to the Synod, and report from time to time on all matters of historic value and interest.
- 6. The Stated Clerk, the Pastor of the Church in which Synod shall meet, and the Ruling Elder appointed to represent said Church, shall constitute a Committee on Enrollment. This Committee shall meet in the Church at a time appointed before the opening of Synod and prepare the roll of Synod, and to this Committee each member shall be required to report for enrollment. The roll thus prepared shall be called at the organization of Synod. Additional enrollment shall be made by blank slips dis-

tributed through the Synod and collected by tellers appointed by the Moderator.

- 7. The first half hour of each Morning Session shall be spend in devotional exercises conducted by the Moderator or by some one appointed by him, and the last half oour of each morning session shall be given to the hearing of a sermon, or of a public address on some cause of the church.
- 8. The Synod shall recede from business during the afternoon of the second day, in order that the various Committees may meet and prepare their work.

11.—SPECIAL RULES.

(Pertaining to the Duties of Officers and Committees.)

- 9. The Moderator. It shall be the duty of the Moderator, at an early hour in the proceedings of the regular meeting to appoint the following Standing Committees, which shall usually consist of not less than three members each:
 - (a) On Devotional Exercises.
 - (b) On Special Orders.—See Rule 14.
 - (c) On Bills and Overtures.
 - (d) A Judicial Committee.
 - (e) On Address to the Churches.
 - (1) On the Minutes of the General Assembly.
 - (g) On the Report of the Directors of Union Theological Seminary.

On the Report of the Regents of the Orphans' Home.

- (i) On the Presbyterial Reports on Systematic Beneficence.
- (j) On the Report of the Treasurer and his books—Auditing Committee.
- (k) On the Records of Synod.
- (1) On the Records of the Presbyteries—Eight Committees.
- (m) On Resolutions of Thanks.
- (a) On Leave of Absence.

To these Committees shall be referred without a vote, unless there is objection, all reports, documents, communications, and other matters pertaining to the several subjets upon which they are appointed, and it shall be their duty to formulate reports upon the matters referred to them and to present the same to the Synod for action.

It shall also be the duty of the Moderator, in the interim of the meetings of Synod when a vacancy occurs, in any offices of the Synod, by death, resignation, or removal from our bounds, to fill such vacancies by appointment, until the next meeting of Synod. And also, upon the occasion of the death of a minister, it shall be his duty to appoint a Committee of one, to prepare a Memorial sketch of the deceased, to be read in the Synod ensuing, and to be spread upon the Records.

10. The Stated Clerk. It shall be the duty of the Stated Clerk when he is elected and enters upon the duties of his office, at the opening of Synod immediately succeeding that at which he is elected to report to the Synod in writing and in full whatever he has received from his predecessor, in the way of Records, Books, Papers, Documents, Furniture, etc., and the condition of the same when received.

The Stated Clerk shall conduct the correspondence of the Synod and he shall be the permanent (ex-officio) Chairman of the Standing Committees on Special Orders and Statistics. shall publish a notice of the time and place of the meeting of Synod at least once month before the appointed day. He shall secure such reduced rates of railroad travel as may be possible. and he shall sign all necessary certificates for the same, or for other official purposes of the Synod or its members. prepare a detailed Docket of business for the next meeting, and cause the same to be published in the Appendix of the Minutes of the last meeting. He shall have at each meeting of the Synod accessable to the Moderator a sufficient number of Dockets, a copy of the last printed minutes of the General Assembly, and a copy of Alexander's Digest. He shall duly engross the Minutes of the Synod after their approval, and transcribe the same into a book to be known as the "Synod's Official Records," and he shall transmit said Records annually to the General Assembly for review. He shall cause to be published annually, in pamphlet form at least one thousand copies of the Minutes of each meeting, as soon as practicable after adjournment, and distribute the same among the members and Church Sessions. shall cause to be published in the Appendix of the Printed Minutes, the reports of the Presbyteries on Statistics and Systematic Beneficence, the reports of the Permanent Committees without their recommendations, the annual report of the Directors of Union Theological Seminary, a roll of the Ministers of Synod by Presbyteries, and a list of the Officers, Appointees and Permanent Committees, together with the Standing Rules. cause to be published every five years according to Rule adopted in 1874, but counting from 1896, the names of the Ruling El-

ders and Deacons with their respective postoffices, belonging to the churches composing the Synod, and the Stated Clerks of the Presbyteries shall be required to furnish the Stated Clerk of the Synod with the necessary information for the execution of this rule. He shall forward a copy of the printed Minutes, annually to the Librarians of Union Theological Seminary, Davidson College and the Presbyterian Historical Society, in Philadelphia. and he shall file at least three copies in the Archives of the He shall also from time to time have the printed Minutes bound in suitable volumes and deposited in the Archives of the Synod. The Stated Clerk shall be charged with the further duty of reporting to the Moderator any vacancies to be filled by him, and of any deaths in the Ministry that may occur, and of reporting to the Synod the expiration of the terms of appointment of its officers and committees according to the Standing Rules.

- 11. The Treasurer. It shall be the duty of the Treasurer to keep a strict and accurate account of all the funds received and disbursed, showing what Presbyteries have paid or have not paid their assessments, and for what purpose the funds have been disbursed. He shall submit to the Synod annually, his book, together with a report of the receipts and expenditures, presenting vouchers for the same.
- 12. The Trustees. It shall be the duty of the Board of Trustees, as the Synod's medium, or agency, in all matters requiring the use or aid of the Civil Law to receive, take charge of, and manage to the best advantage, and account to Synod for, according to law, all property and estate belonging, or which may accrue and enure to this Synod; and they shall hold in trust, subject to the order of Synod, the said property, and all legacies and bequests which may be willed to the Synod in behalf of charitable and other objects under its control, and they shall make a tull report, in the premises, whenever occasion or circumstances shall require.
- 13. The Permanent Committees. It shall be the duty of any or all of the Chairmen of the Permanent Committees, including the President of the Board of Regents of the Orphans' Home, if deemed advisable to arrange for, and to hold popular meetings in the interest of the respective causes they represent. These popular meetings, if held, shall be in connection with, and at the time of the presentation of the Report of the Committee, and they shall in no wise interfere with the Standing Orders of the Synod. And it shall be the rule, as far as practicable, to

hear in this connection and at this time the Secretaries of the General Assembly, and other representative brethren, in the interest of the corresponding cause which they may represent. And it shall be the duty of the Chairmen of the several Committees, in arraiging for the aforesaid meetings, to correspond with the representative brethren, who are expected to be present prior to the meeting of Synod, as to the time when they are expected to be heard agreeably to the Standing Rules.

- 14. It shall be the duty of the Moderator immediately following the selection of the next place of meeting to appoint a Committee of Arrangement whose period of responsibility shall extend from the close of the Synod to the close of the next and whose business shall be to arrange the entire program of business for the next meeting of Synod conformably to the Standing Orders of Synod. This committee to consist of five members one of whom shall always be the pastor of the church where the Synod is to meet and another the retiring Moderator.—1911.
- 15. It shall be the duty of the Standing Committee on the Records of Synod to examine the Official Records, and report with special reference to the condition of the same and as to the neatness and faithfulness in the execution of the work, and whether or not the records have been sent up and approved by the General Assembly.
- 16. It shall be the duty of the several Standing Committees on the Records of the Presbyteries to con fer with the Stated Clerks of the Presbyteries whose records they are appointed to examine before submitting their reports to the Synod in order that the Clerks may have opportunity to make explanation in regard to the records before the matter is brought before the Synod. And after the records are examined, the Chairman of the several Committees shall meet in Committee of the whole and compare, classify and adjust to a common Standard of Judgment their criticisms and exceptions. They shall then elect one of their number who shall act as Chairman of the Committee of the whole, and who shall submit the judgment or criticism of all the Committees on all the Records in his one report to Synod.
- 17. It shall be the duty of the Standing Committee on Leave of Absence to receive and pass upon, before presenting their reports to Synod for approval, all excuses for absence from the last and present meeting of Synod, for tardiness, for absence without leave from the last meeting, and for leave of absence from the present meeting. All excuses shall be rendered to this committee and this rule shall apply to all the members of Synod,

except Foreign Missionaries, and infirm ministers who are nor required to attend the meetings of their Presbyteries. It shall be the duty of this Committee to refuse leave of absence to any member, except upon urgent reasons.

18. It shall be the duty of the ad interim Committee on Memorials, to write simply and briefly a sketch, and not an extended history of the deceased. It is designed for obvious reasons, that shall in no wise interfere with the Standing Orders of the Synod, the sketch shall embrace only the chief dates and main facts in reference to the life, work and death of the deceased.

HL-MISCELLANEOUS RULES.

- 19. It shall be the duty of each member, unless released by a vote of the Synod, when providentially prevented from attending the Synod, to address a letter to the Moderator stating reasons for his detention.
- 20. It shall be the duty of the Stated Clerk of the several Presbyteries to furnish the Stated Clerks of the Synod, when applied to with all necessary information required, and with a corrected roll of ministers and their postoffices annually, and also a roll of the Elders, Deacons and churches, with their postoffices once every five years. The Stated Clerks are enjoined to be careful, accurate and punctual in filling out all blanks sent to them, and returning them to the Stated Clerk before the meeting of Synod.
- 21. It shall be the duty of all members of Synod, and especially the Chairmen of Committees in preparing written reports to be presented to this body, to write the same in a plain and legible handwriting, and it is desirable that the Chairmen of the Permanent Committees furnish the Stated Clerks with an extra copy, if possible, of their annual reports, respectively.
- 22. The roll shall be called at each meeting before final adjournment and those who are absent without permission shall be noted by the Clerk as "absent without leave" and they shall be required to report to the Committee on Leave of Absence at the next meeting and answer for the irregularity.
- 23. It shall be a Standing Rule, until otherwise ordered that the Treasurer of Synod pay the expense of the representative of Union Theological Seminary in attending the annual meeting of Synod.—1906.

24. It shall be a Standing Rule that the Devotional Exercises at the opening of each day's session of the Synod be put into the hands of the Standing Committee on Devotional Exercises. 1906.

IV .- STANDING ORDERS.

The following Standing Orders shall be observed by the Synod:

- (1) The Synodical Communion shall be held at eleven o'clock a. m. of the second day without a sermon.
- (2) The Memorials of the deceased Ministers shall be read immediately after the Synodical Communion Service.
- (3) The Popular Meeting in the interest of Foreign Missions shall be held on the evening of the second day.
- (4) The Popular Meeting in the interest of the Synod Orphans' Home shall be held at eleven o'clock on the morning of the third day.
- (5) The Popular Meeting in the interest of Assembly's Home Missions shall be held in the afternoon of the third day at three o'clock.
- (6) The Popular Meeting in the interest of the Sabbath and Family Religion shall be held in the afternoon of the third day at four o'clock.
